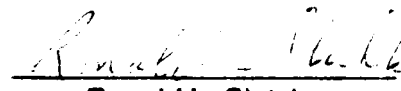
We have reviewed the books and records of the Southern California World Service of AFG, Inc. for the years ended December 31, 2006, 2005, and 2004. Our review was limited to the Balance Sheet accounts, which included bank reconciliation review of the Cash and Cash Equivalent Accounts. We believe the Balance Sheet accounts are fairly stated as of December 31, 2006, 2005, and 2004.

Due to the nature of the collections of the revenues, we were unable to perform testing of those Revenues as recorded in the books of account. We did limited testing of the disbursements (expenses) made through the checking account. Consequently, we cannot offer an opinion on the Statement of Revenues and Expenses, nor the Financial Statements as a whole.

We prepared a Statement of Cash Flow for the Years Ended December 31, 2006, 2005, and 2004. Due to the limited scope of our review, we cannot express an opinion in regard to the Comparative Statement of Cash Flow.

There were no irregularities discovered throughout our review. Our current recommendations are presented in a separate letter to the Treasurer and the Executive Committee.
