# Minutes

# Meeting opened at 9:00 am

# Chairperson's Report – Donna E.

- Serenity Prayer
- Introduced Past Delegates Jayme C. and Kay D. One new DR, Nancy W. from D12.
- Advised that we will be using Knowledge-Based Decision-Making (KDBM) Guidelines for this Committee Meeting. Refer to the *KBDM Quick Reference Tool* handout (which can be found on the SCWS website).

Traditions – Read by Andy T., D24.

# Group Records Coordinator (GRC) – Mary M.

Roll call: -- Not present: D6, D10, D30, D39, D42, D45, D51, D60, D75, Immediate Past Delegate, AIS Liaison, Archives, Area Alateen Event Coordinator (AAEC), LA County Liaison, San Diego County Liaison, Ventura County Liaison and Southern California Alcoholic Anonymous Coordinator (SCAAC). Arrived late: D6, D10, D60 and D75.

# Minutes – Jim B., Secretary

Reminded everyone that the February 17, 2017 Committee minutes were in the *Bulletin* for review. No amendments. Tracy G., D9 moved to accept Minutes as written and Libby A., D75 seconded motion. Unanimous approval.

**Treasurer Report** – Tarisa R. See Treasurer Report in *Bulletin*.

- Referred to handout which was colored coordinated and page numbered. The second Quarter is balanced.
- We are currently in the red in the amount of \$3,751.94 for the second quarter of this year. We spent more than we brought in because the H & I Conference and the Assembly expenses both occurred this quarter. The first month of the third quarter shows we are in the black.
- DRs were asked to review the Group Contributions for the second quarter to see if their contributions were accurate. Six groups which sent in contributions were unidentified. Treasurer asked DRs to remind their GRs to make sure that group Treasurers include the World Service Office (WSO) identification number when submitting contributions.

# **Questions:**

- Q. Libby A., D75– Where do we find the meeting contributions for our group?
- A. Tarisa It is in every *Bulletin* for the previous quarter.
- Q. Tracy G., D9 What is the Equalization Expense for The Delegate to attend the World Service Conference (WSC)?
- A. Marcia, Delegate WSO calculates the overall expense for the WSC and then breaks down how much each Area will pay for their Delegate to attend. Larger Areas pay more than smaller Areas as smaller Areas may not have the financial resources to send their Delegate to the WSC.
- Q. Allegra S., D3 If we choose to stay in a hotel overnight and not submit for reimbursement, can we record the cost of the hotel room as a 7<sup>th</sup> Tradition contribution?
- A. Eva, Past Treasurer No. You can only list an actual expense as a donation.
- A. Tarisa You could fill out the expense form and note on the form that you would like to donate the reimbursement to the 7<sup>th</sup> Tradition. That way, the expense is properly noted as an expenditure and the receiver of the reimbursement can contribute it to the 7<sup>th</sup> Tradition.
- Q. Suzanne, Area Alateen Communications Coordinator (AACC) – We used to pay the entire amount for the Delegate to go to WSC. Why are we only paying the Equalized Expense?
- A. Jayme C. Past Delegate We pay the Equalized Expense plus any additional expenses that are incurred by the Delegate to go to WSC. This was a motion that was passed several years ago.

## **Comments:**

Kay D., Past Delegate – In the past, we were trained to accept the reimbursement for service expenses. It makes it easier to get volunteers involved in service if they know they are getting reimbursed. You can always choose to take the reimbursement and then donate it to the  $7^{\rm th}$  Tradition.

Motion to Accept the Financials. Chris C., D40 made the motion and Nancy W., D12 seconded the motion. Motion passed unanimously.

Alternate Delegate Report – Eva B. See report in the *Bulletin*.

- Welcomed new DR Nancy W., D12.
- Sharing of Service (SOS) update. It will be held on January 19, 2019. Eva requested every DR get the word out regarding this annual service event. The main Speaker will be a former member of the Board of Trustees and Past Delegate from Hawaii, Judy P.
- Jayme C., Past Delegate Judy P. will be leading a workshop at SOS: *12 Steps in Fifteen Minutes*. This workshop was held at the International Convention in July and was a big success.
- The *Forum* can was passed around the room at this time.

**Delegate Report -- Marcia M.** See handout and full report in the *Bulletin* 

- Asked Committee members to put their names on slips provided in order to win a couple of door prizes: the 50<sup>th</sup> Anniversary Edition of *One Day at a Time in Al-Anon* and the new book *Intimacy in Alcoholic Relationships*. She thanked everyone for allowing her to attend the World Service Conference (WSC).
- Our Area has purchased a copy of the *WSC* Summary for each AWSC member and it will be given out at the next Assembly.
- Marcia shared information from the July WSO Chairperson of the Board (COB) letter. One notable item is that if an Area has created a "Do Not Refer" policy, WSO will support the Areas that have these policies in place by creating a "Do Not Refer" designation in their database. SCWS has not formally submitted our policy to WSO, but will do so once the Board of Trustees create criteria for evaluating those Area policies. Once our Area policy is approved by WSO, if after going through the entire dialogue and education process a group is found to be unwilling to follow our Traditions, it could be designated Do Not Refer by the WSO, the Area, and local AIS offices.

Winners of door prizes were Donna M., D57, and Tina N., D33.

# **Questions:**

- Q. Tracy G., D9 On page 1 of your report, what are the safety guidelines referring to?
- A. Marcia, Delegate The WSO is in the process of writing a Guideline regarding

safety issues within Al-Anon meetings. That Guideline is intended for Al-Anon meetings, but could be used in Alateen meetings as well.

## **Comments:**

Judy, Literature Coordinator – Witnessed an incident some time ago when a member was approached in a parking lot and felt unsafe. Hopefully theses safety guidelines will address situations like that.

**DR Reports**: All DR reports can be read in detail the *Bulletin*.

DRs reporting were; D3, D6, D8, D9, D10, D12, D17, D21, D24, D27, D33, D36, D40, D48, D54, D57, D60, D63, D64, D66, D69, D72 and D75.

Donna, Chair – Remember that when Districts host an event, you can send a copy of the flyer to her or Marcia, Delegate, and they will see that it gets posted on the Area's website.

# New Procedure for Votes at Assembly

The Chair reported that because of feedback from GRs on the Evaluation Forms, a new procedure will be in place for the next Assembly.

If an issue is brought before the Assembly for a vote, it will be presented in the morning, prior to our lunch break. The presenting body will be required to have posted on the SCWS website four weeks prior to the Assembly a report of their KBDM process and how they came to the recommendation they're presenting to the Assembly. After the presentation of that material to the Assembly, the question and answer portion of KBDM will take place. After lunch, here will be a brief time to ask any unique questions relevant to the issue. A vote will then be taken to see if the GRs are ready to vote on the issue. If the GRs are ready to vote on the issue, a vote will be held on the recommendation (which will require 2/3rds to pass). If the GRs are not ready to vote, the item will be tabled until the next Assembly. Any questions and discussion items will be added to the presentation on the Area website. The issue will be addressed at the next Assembly.

# Old Business:

# "Aging Out" of Alateens and Effective Date:

Donna, Chair –

The May Assembly voted to change the upper age of Alateen members from 20 (that is, they would "age out" on their 21<sup>st</sup> birthday) to 18 (they would age out on their 19<sup>th</sup> birthday). She reported that several DRs thought there was enough new information about this issue to re-open it for discussion. Using KBDM, the DRs proceeded to discuss the issue and vote on whether or not to add this to the November Assembly Agenda.

A discussion ensued regarding: Is there enough new information about this issue (changing the upper age of Alateens) to re-open it at the November Assembly?

Barbara V., D17 – The Area Alateen Task Force (AATF) did a terrific job, but they did not thoroughly think through the effect that this policy would have on several Alateens in leadership positions in the upcoming year. These Alateens would now "age out" before they could fulfill their commitments. Many Alateens look up to the older Alateens as mentors. At the RAD Alateen Event, many Alateens voiced their opposition to this new policy. They would prefer that there be a new vote to age out on their 20<sup>th</sup> birthday.

Donna, Chair – Clarified that Barbara requested a new vote to change the policy that an Alateen ages out on their  $20^{th}$  birthday and not their  $19^{th}$  birthday.

Andy T., D24 – Not contesting the vote as valid, but noted that very few Alateens gave their input prior to the Assembly vote. It was not until after the vote that several Alateens pointed out that this would affect their commitments in upcoming events and Alateen as a whole. He noted that there is no mandate from WSO to define a specific age for Alateens and that every Area has the autonomy to decide what is right for that Area. He expressed the concern that there was not enough information provided in advance about the issue, prior to the vote. When adults make decisions regarding minors, it important that the minors have a voice. He spoke with the mother of a 19-year-old Alateen member who is not going to Alateen any longer because she was "kicked out, so why go." Also, this could affect the transportation to events by Alateens as there will be fewer older Alateens who now drive younger Alateens to events.

Andy requested the DRs vote to add this issue to the November Assembly.

# Questions:

- Q. Tracy G., D9 Based on new information, can we find out how many Alateens this affects?
- A. Kat, Alateen Member Coordinator (AMC) We do not know how many this will affect, but it does affect Alateen as a whole.
- A. Andy T., D24 We can ask the DRs and/or DALs to provide the number of Alateens that will be affected in their district.
- Q. Donna M., D57 Are the Alateens aware of the Young at Heart in Al-Anon (YHA) meetings in Al-Anon?
- Q. Kay D., Past Delegate Could we make concessions to those Alateens that are on a Committee or Convention to grandfather them in until the end of their commitment?
- Q. Rob M., YHA Served on the AAFT. There was a lot of discord about aging out and how that would affect the age gap between being an Alateen and becoming an AMIAS. It will now be a six-year gap. It is frustrating to hear that some older Alateens do not want to transition into Al-Anon. Would like to see the AATF look into a procedure to help assist these teens who are transitioning.
- Q. Donna, Chair The current "age gap" is 4 years (Alateens age out on their 21<sup>st</sup> birthday and can become an AMIAS when they're 25). The new policy creates an "age gap" of six years. The policy could be discussed in the future and the age limit of AMIASs might be lowered, per the autonomy of the Area
- Q. Sam Y., D36 What is average age limit for Alateens in other Areas?
- A. Donna, Chair Presented the following table:

The chart shows that:

- in almost 50% of the Areas, Alateens age out on their 18<sup>th</sup> birthday
- 22% of Areas age out on their 19<sup>th</sup> birthday
- 22% age out on their 21<sup>st</sup> birthday
- the overall average is 18.9 years of age.
- Q. Sam Y., D36 Votes are taken at the end of the Assembly and many voting members have already left. We need to vote in the morning when all are present. Are we just bringing this back up to add three more years to the age limit? Also, is it okay for a 20-year-old to be driving around with a 12-year-old in their car?
- A. Donna, Chair Regarding the timing of votes and GRs leaving before Assembly is over: We all face the same traffic problems in Los Angeles, and while work or family responsibilities might occasionally conflict with our ability to attend the Assembly or stay the entire time, representing the voice and vote of our meetings is a central function of being a GR, per our Service Manual. Hopefully this new procedure (presenting issues in the morning, prior to the lunch break) will help, but when we have two voting items, it might not be possible to present both of them in the morning. We are

the largest Area and only meet twice a year, for one day. Therefore, it is the duty of GRs to plan to attend the Assembly for the entire day.

Bear, AASC: Regarding driving Alateens to events -- Area Alateen Event Plans address written permission for AMIASs to transport Alateens. Legal adults who have drivers licenses are required to follow the laws of the State of California when transporting teenage passengers.

- Q. Allegra S., D3 It feels like only the negative aspects of this policy change are being discussed. Are we able to evaluate the positive results of this change in policy?
- A. Nancy W., D12 We do not need to have Alateens vote on policy, but we need to allow them to have a voice as to the policy change. It also will make it more difficult for Alateens to get to Events if they are not old enough to drive.
- A. Donna, Chair It would be up to the AATF to give updated information on this policy at the Assembly.
- Q. Carol G., D60 Were Alateens consulted by the AATF? Why not have the age limit set at 18 when they become legal adults?
- A. Suzanne P., AATF Chair AATF was charged by the WSO in November of last year to report to the May Assembly. The AATF formed an Alateen Advisory Council of three Alateen members. It was difficult to communicate with them regularly because of their schedules and commitments.

Some members on the AATF wanted to change the age to 18 and while others favored 19. The final reason why they chose 19 was because most 18-year-olds are seniors in high school. This is a transition time into adulthood—after they graduate, they join the workforce or go to college. Teenagers begin to think of themselves as independent adults, not as children. Even though they become legal adults at 18, it seemed logical for them to stay in Alateen throughout their senior year and to begin the transition into Al-Anon in their 19<sup>th</sup> year, after high school, when they're increasingly functioning as adults.

# **Comments:**

Laura, AAPP – There are a total of 4 Alateen GRs in our Area out of all the 75 Alateen groups, therefore,

most of the Alateen groups do not have a voice and a vote at the Assembly.

Bruce, *Bulletin* Coordinator - When new rules are adopted in many organizations, they do not apply to those who hold current positions unless specifically stated.

Q. Vickie I., D72 – Became an AMIAS when she was a DR. If we have an age out limit, why not have a minimum age limit?

Kat, AMC – Attends many Alateen meetings and most Alateens have expressed their resentment toward this policy change. She is the Board's Alateen Member Coordinator which is a three-year term. How does this change affect this position?

Tarisa, Treasurer – We need to stay on track as to what we are here for. There was a rush in getting this presentation together and all prior information was not readily available. She has seen that Alateens have ideas that we as adults do not see. It is important that they be a part of this process.

Jayme C., Past Delegate – Thanked the AATF on taking on this task. She was not convinced that there was new information given today to reopen the age out policy. She hopes that we do not have to change the age limit to become an AMIAS due to this policy change. There were 111 who voted yes and 25 who voted no on this issue at the Assembly. This is what Tradition One is all about.

Bear, Area Alateen Sponsor Coordinator (AASC) – The Service Manual on Page 96 states "It is within the autonomy of each Alateen group to lower the age limit or divide into groups according to age. Whatever the decision, all such groups will be registered as 'Alateen' at the World Service Office. Members in their teen years who are legally adults agree to abide by the same requirements as minor Alateens when they attend Alateen meetings and events. Alateen members in the upper teen years are encouraged to begin attending Al-Anon as well as Alateen Meetings." Alateen is for teens, 13 - 19.

Micheila, AATF – It was a privilege to be on the AATF.

Donna, Chair- Vote was taken at the Assembly was based on the attending GRs's experience, strength and hope. Clarified that Alateens who are adults have to follow the same rules as Alateens who are minors. Alateens have a voice, but they do not have a vote on policy issues as they are minors.

# Old Business Continued:

# Aging out of Alateens and Effective Date Continued:

Marcia, Delegate – Recognizes that our Area is passionate about Alateen and is grateful to be part of this process. Requests that we "presume goodwill" toward the AATF and everyone in our Area.

Donna, Chair –There are two parts to this policy issue. One was setting the "age out" of Alateens on their 19th birthday, and the other was how to implement this policy. A grandfathering provision to include those already in Alateen was not discussed at the time of the vote but would address many of the concerns that arose after the vote.

Today's vote: Whether you heard enough new information to place the "aging out" issue on the November Agenda. If yes, the AATF would present the recommendation again at the Assembly. This vote on procedure (whether or not to add the issue to the Assembly Agenda) will be a simple majority since it is not a policy vote.

If the vote is "no," there could still be a grandfathering provision created before the next Assembly which would be an addendum to the original Motion, and on which the GRs would vote at that time.

Mary, GRC – There are 45 voting members.

Donna, Chair – <u>Motion is "Have you heard</u> enough <u>new information to place the aging out</u> issue on the November Agenda?" Clicker Vote – 59% no, 41% yes. The Motion failed.

Donna, Chair – An addednum will be created for current Alateens. She will ask the members of the AATF and the Alateen Resolution Committee (ARC) to get together to propose a solution.

Bear, AASC – The seven-person Committee is in place. It includes the Area Alateen Sponsor Coordinator (AASC), Area Alateen Process Person (AAPP), Area Alateen Communications Coordinator (AACC), Area Alateen Events Coordinator (AAEC), Area Alateen Member Coordinator (AAMC), Andy T., D24 (AMIAS Member-at-Large) and Jim B., Board Officer. They have met once and will be meeting next week again. They are reviewing and making changes to the Area Alateen Safety and Behavioral Requirements (ASBR) and revising SCAC documents and By-Laws.

# New Business:

# Changing procedures for the Assembly:

Donna, Chair – We will be presenting all voting issues in the morning. All relevant documents relevant to the presentation will be placed on the SCWS website four weeks prior to the Assembly. The documents should include the "framing" and background and history of the issue, along with an explanation of the KBDM process and the pros and cons of the recommendation that resulted.

Another issue is saving seats at the Assembly. Possibility would be to have those who get there early arrange the room for all districts or perhaps rotate districts from front to back. Maybe only the voting members get seated and others sit in the back.

## **Comments on seating at Assembly:**

Libby A., D75 - We contact D48 in advance and they saved the seats for our district since we have a long way to travel to the Assembly.

Frank C., D54 – Splitting the districts will not work. Possibility would be to move the meeting location to various areas or just get here early.

Tracy G., D9 – In favor of rotation of seating as a good solution.

Nancy W., D12 – Create a Thought Force to look into a new facility or facilities. We are the largest Area and need more time allotted to the Assembly. Andy T., D24 – Perhaps have a lottery to draw for seat location or allot the closest seats for the districts that stay for the whole Assembly.

Tarisa, Treasurer – It is a lot of extra work to take on this task. Maybe non-voting members or guests could sit in the back.

Carol G., D60 - If you are not a voting member, you need to sit in the back.

Donna, Chair – How long should DRs save seats? What is a reasonable time to save seats? Can we agree to say that the seats will be saved for 15 minutes after the meeting has started? We need a system to address this. Maybe pairing geographically closer districts with districts that are farther away.

Cathy, Public Outreach. If you are a new GR, you are here at 8:00am. If you are not here by 9:00am, you sit wherever possible.

Bruce, *Bulletin* Coordinator – Suggested that there should be no saving of seats.

Clicker vote was taken to see if the cut-off time for saving seats should be 9:15am and then seats will be released. 71% yes and 29%. No seats will be saved past 9:15am.

Jayme, Past Delegate – Perhaps have the districts register their GRs that are going to attend and get a more accurate count moving forward. Several districts regularly save many more seats than actually attend.

Jim, Secretary – Last Assembly we had a request for 311 clickers, but only 174 were issued that day.

Donna, Chair – We can revisit this again after we see how this solutions works: more accurate numbers of those attending, and not holding seats past 9:15am.

# Thought Force for the Assembly and Insurance liability issues:

Donna, Chair - Do we need to create a Thought Force to look into a new location for the Assembly? And, do we need a Thought Force to look into liability insurance for groups that would be added to the Area's insurance policy?

### **Comments:**

Kay D., Past Delegate – This was explored in the past and the work group couldn't find a location that was affordable that worked as well as this one.

Frank C., D54 – A Thought Force is a great idea. A second Thought Force addressing providing insurance for Area groups would also be a good idea.

Mark, Orange County AIS – We provide insurance for our districts in Orange County. Would we still need to have this insurance if the Area provides it in the future?

Micheila, D24 – Read the definition of a Thought Force from the *Service Manual*.

<u>Clicker vote was taken to see if we should establish a</u> <u>Thought Force for the Assembly relocation.</u> 68 Yes, <u>30 No, 3 Abstained. Motion passed</u>

<u>Clicker vote was taken to see if we should establish a</u> <u>Thought Force adding insurance for groups.</u> 88 Yes, 10 No, 3 Abstained. Motion passed

<u>Coordinator Reports</u>: See detailed reports in the *Bulletin*.

Shauna, Hospitality Coordinator – Districts 10, 27, 30, 45, 51 and 72 were asked to bring refreshments to the November Assembly. Alateens from San Fernando Valley and the AFG Convention would like to serve lunch at the November Assembly as a fundraiser.

Donna, Chair – Per the SCWS By-Laws, only conventions recognized by the Area are allowed to fundraise at the Assembly. Therefore, the San Fernando Valley Alateens cannot fundraise for their group, but AFG Alateens can.

# Chair

Greetings!

The focus of my report is the new procedure for voting at the Assembly.

We received lots of feedback from members on the Evaluation Forms at the May Assembly (and thank you to everyone who filled them out!), many of which were about the timing and process of using Knowledge-Based Decision-Making (KBDM) for voting on recommendations. Based on that feedback, the Officers and Board members discussed adopting the procedure outlined below, beginning with the November Assembly. We will refine the process over time.

- Any issues brought before the Assembly for a vote will be presented in the morning, prior to our lunch break.
- The presenting body making the recommendation will be required to have posted on the SCWS website *four weeks prior to the Assembly* a report of their KBDM process and how they decided on the recommendation they're presenting to the Assembly.

- After this presentation at the Assembly (which will include the "framing" or history and background of the issue, how the body answered the 5 KBDM questions, and the pros and cons of the resulting recommendation), the question and answer portion of KBDM will take place. As in the past, the time for members to ask questions and give comments will be timed-either one minute or two minutes at the microphone, with a half-hour set aside for each KBDM segment. The estimated time for a presentation will be  $1\frac{1}{2}$  hours.
- After lunch, there will be a brief time (5 to 10 minutes) for any unique questions or comments that came up during lunch which were not included in the discussion prior to the lunch break.
- A vote will then be taken to see if the GRs are ready to vote on the issue.
- If the voting GRs decide that they *are* ready to vote, we will then vote on the recommendation at that time.
- If the voting GRs decide that they are *not* ready to vote, we will table the motion until the subsequent Assembly. Any questions and comments relevant to the issue from that day's Assembly discussion will be added to the presentation on the Area website.
- The issue will be placed on the subsequent Assembly's Agenda. All of the background information from the website will be reviewed when it is brought up at the following Assembly. The GRs will be asked if there is any new information (unique and new questions or comments) to add to the discussion. We will then have a vote on the issue.

It is my hope that these changes in procedure will ensure that our members have the opportunity to learn about and become familiar with issues prior to the Assembly. It will also afford GRs the opportunity to talk to their group's members about such issues, to see if their members have opinions, feedback, or questions about the issues. It will help to ensure that GRs don't feel "rushed" into voting but will have the time to digest the presentation and discuss it over lunch. And they will get to decide whether or not they feel prepared to vote that day. It is our hope that this new procedure will encourage more participation and create more unity and harmony. I look forward to seeing you at the Assembly on November 17!

# Treasurer

I want to thank all of the groups, districts, and conventions that send contributions to Southern California World Service. Your contributions allow SCWS to carry the message of Al-Anon Family Groups throughout Southern California.

**Summary of Quarterly Financials:** The contributions for July-Sept 2018 decreased 5% compared to July-Sept 2017 contributions. Our total expenses increased 2% compared to July-Sept 2017. The total revenue decreased 12% *because we did not have a Longtimer meeting or TEAM event*, which resulted in our net operating revenue decreasing 40% compared to July-Sept 2017. We continue to maintain a reserve of \$35,000.

**To DRs & GRs:** Your meeting (for GRs)/district (for DRs) should reimburse you for up to 100 miles *roundtrip* to attend the Assembly. If you drive 101 miles or more *roundtrip*, SCWS will reimburse you \$0.40 for each mile exceeding 100 miles. Please submit your reimbursement request forms to the SCWS Treasurer at the Assembly.

If you travel 200 miles or more *roundtrip* to attend the Assembly, SCWS will reimburse \$100 per person for your hotel room. Your meeting (for GRs)/district (for DRs) should reimburse you the remaining amount. Please include this amount on the reimbursement form and provide a copy of the receipt.

**To Group Treasurers:** PLEASE, PLEASE, PLEASE write your group's WSO ID# on the check or money order when sending your contribution. This ensures that your group receives credit for the contribution on the quarterly report! If you do not know your Group ID#, write the Day, Time, City, Zip Code, and Group Name on the check so I can look through the database to find your Group ID#. In addition, please provide a LEGIBLE email address so your receipt can be emailed

It is greatly appreciated when you include a contribution form with your check or money order! It helps expedite the processing of your contributions

# **Alateen Area Processing Person**

Following the recommendation of the recent AATF (Area Alateen Task Force), SCWS changed our method of obtaining background checks on new AMIAS applicants to the more extensive format that requires SSN, and in order to offer optimal protection of that sensitive information we went to a "self-apply" format where the individual submits their information directly to Trak-1, our contracted agency for background checks. The transition happened in August and has gone without a hitch. Most of the time the background checks come back within one business week and the individual receives a copy of the report from Trak-1. The AAPP is notified by email when a new report is complete, making for an efficient process. We are able to save the reports as a PDF and they are stored in our AAPP Dropbox account, which has limited access, thereby eliminating the need for a physical file cabinet and shredding of paper documents.

# Al-Anon Information Service /Literature Distribution Center Coordinator

Since this is a new position I have been working closely with our Chair, Delegate and Alternate Delegate. We are working together to come up with an action plan consistent with our mission and stated goals for this position.

I am contacting the Chairs of the Area AISs and LDCs to begin a dialogue and to confirm all contact information is correct. I have spoken with several members and have gotten some excellent information and ideas. I have also learned that not all Districts have AIS and/or LDC components.

Meetings with each AIS and LDC are being set up. I plan to introduce myself and explain the role of the AIS/LDC Coordinator, to listen and to exchange ideas. Topics to discuss may include:

- How the Area can be of help.
- Arranging a GoToMeeting web-conference
- What works, what does not work, what issues are being faced, what solutions are being used and how the solutions were arrived at, and what Innovative methods and approaches are being used
- What Is being done when leadership is turned over and what written and oral information is being passed on
- What methods and systems are in place for record retention

This is my second written SCWS Board report. I feel very grateful and excited about my new service. I hope that my service is helping the Spanish community to feel more connected to the Area and Al-Anon as a whole. Any suggestions are always welcome.

1. On 9/8/18, I visited San Diego Spanish Intergroup/Oficina Intergrupal Hispana de San Diego, and met everyone there. They had several questions about my new service as a Spanish Coordinator. We had a fantastic chat clarifying some ideas about some Al-anon /Alateen groups. We received approval to visit the San Diego Probation Department (Centro de Detencion Juvenil) on Saturday 9/29/18 at 7AM, as Public Outreach.

That same day, 9/8/18, I was able to attend the AA Ventura Convention with Al-Anon Spanish participation. It was great to see some newcomers and see so many of our Al-anon members from different cities.

- On 9/14/18 in Chino Hills, D64 sponsored a Workshop on The Al-Anon 5 Warranties of the Conference /5 Garantias generales de la conferencia de Al-Anon. This was an excellent program, because many of our Spanish Al-Anon members do not regularly study the Traditions and Concepts of Service. We all learned a lot!
- 3. I got a phone call from someone looking for an Alateen member who would be willing to participate in a Spanish interview about Alateen's experience, strength and hope. I contacted several Alateens and one girl volunteered to participate in the interview on October 10. 2018 between 10 - 11 AM. The person who contacted me was knowledgeable about our policy of anonymity and they arranged to cover the Alateen's face so that she could not be identified. The interview will be retransmitted to 29 Spanish-speaking countries.
- 4. There are some Al-Anon members in the San Fernando Valley who would like to have a Workshop about The Al-Anon 5 Warranties of the Conference / 5 Garantías generales de la conferencia de Al-Anon. I'm hoping to be able to work with those members to hold a workshop next year.
- 5. On 9/29/18, we did Public Outreach at the San Diego County Probation Department in the Juvenile Detention Center. It was a great experience doing the service together with the San Diego Spanish Intergroup members. Many newcomers were asking for information about Al-Anon and Alateen. We a got a tour inside the Jail/Detention center. The boys and girls in the Detention Center are between 10 to 18 years of age.

6. On 10/6/18, I attended a public outreach workshop in Santa Maria organized by D64. I had the opportunity to meet new people, and it was very successfully event.
