Minutes

AREA WORLD SERVICE COMMITTEE

(AWSC) Meeting First United Methodist Church, Glendale, CA August 17, 2019

Meeting opened at 9:00 am

Chairperson's Report: Donna E.

- Serenity Prayer
- Welcome new DRs: Linda S., District 40
- Reviewed Guidelines for Participation

Traditions: Read by Nancy W., D12

Approval of February **16**, 2019 Committee Meeting Minutes: Sam Y., D36 made a motion to accept Minutes as presented. Darcy C., D63 seconded the motion. Motion passed.

Treasurer's Report: Tarisa R.

- 1. Reviewed financials (Balance Sheet). She said that our expenses for the AWSC meeting are greater than our contributions so the Committee meeting is not self-supporting.
- 2. Tarisa noted that it is helpful for groups to include their WSO ID number with their contributions. It helps when they use the actual form from the SCWS website. She must verify that the contributions are from Al -Anon groups, districts, conventions because it's a violation of our Traditions to receive funds from outside sources. Donna referenced *Service Manual*, (p. 34) about how WSO registers groups.
- 3. Tarisa explained the reimbursement policy for attending the AWSC. She explained if DRs travel over 200 miles roundtrip, they can be reimbursed up to \$100 for a hotel, and miles over 100 will be reimbursed by SCWS at 40 cents per mile; the remainder of the balance is paid by their District.
- 4. Asked for a volunteer 4 hours a week to help input contributions. Please take this request back to your Districts. She also highlighted that it is an excellent opportunity to be trained should that person be interested in becoming the next Treasurer.

Alternate Delegate's Report, Eva: She has confirmed the speaker for SOS in January, 2020. The flyer will be available electronically by Monday. She would like the DRs to email the flyers to their District's GRs. We would also like to increase readership of *The Forum* magazine. Please encourage groups to use it.

Observe 7th **Tradition**: Tarisa read the Seventh Tradition in *Service Manual*, "Passing the Basket" (p. 19).

Delegate's Report: Marcia discussed updates found in the WSO Chairperson of the Board (COB) July 2019 letter and highlights from other WSO Committees:

- Road Trip! "You and your Board Connect" in Seattle, Washington October 19, 2019.
- WSO will no longer host Together Empowering Al-Anon Members (TEAM) events after this year. They have new plans to connect Areas to WSO that will be shared at the next World Service Conference (WSC), April 2020.
- A.A. International Convention: July 2-5, 2020 in Detroit, Michigan.
- Trustees will be calling Delegates soon to ask these questions: How are your groups/Areas dealing with a cashless society? How will you, your groups, and your Area utilize the 2020 WSC theme? Marcia asked DRs to respond to these questions and to email her their responses since DRs represent the groups.
- Marcia is encouraging everyone in the Area to incorporate the 2020 Theme "Dreaming Big with 20/20 Vision." into things we do.
- Al-Anon International will be in Albuquerque, NM will be in July, 2023.
- Jayme C. referenced p. 31 in the *Conference Summary* for more details for the Al-Anon International.
- Marcia said she is collecting information ongoing, but her next call with WSO is in October.
- Extra copies of *Conference Summary* are \$5 and can be ordered on the WSO website.

Old Business:

1. Area Group and Member Concerns Resolution Team Update (Marcia, Delegate): the Southern California Policy for Resolving Group and *Member Concerns* was developed over time by a Thought Force, Task Force and was approved at the Nov. 2016 Assembly. The *Policy* is available online on the SCWS website.

Three groups in Orange County (OC) which were removed from the OC County AIS office directory in 2010, asked the Area to use the *Policy* to consider "relisting" them. Per the SCWS Area's *Policy*, a 3-person "Resolution Team" was formed to review the Policy in light of the three group's request, review documents related to the original "delisting" by OC, then read, analyze and categorize any communications from members regarding the groups. They also attended the three meetings. The Resolution Team members have met almost weekly, and are now in the process of writing a report.

WSO created materials to support an Area's process to "develop a fair and balanced policy" titled: *Area Meeting List Publishing Policy Development Resources.* After an Area has developed a policy, the Area can choose to send their policy to WSO for review. If the WSO believes the Area's policy is "fair and balanced", they will support the Area's policy and the Area's decision to determine if a meeting should be withdrawn from local directories. The meeting will be designated "Do Not Refer" by WSO and will not be listed on the WSO website's meeting search. The group will still be considered an Active Al-Anon Group, whose GR will have a voice and a vote at Area Assemblies.

Questions and Comments:

Sam Y., D36: Would these groups continue to be able to call themselves Al-Anon Family Groups?

Marcia: Yes.

Kim D34: If WSO does that, then would local AIS offices not include them in their directories?

Marcia: Yes. We would share the outcome of the review with the local AIS office so that their directory is consistent with the Area policy. Although the groups would continue to meet, newcomers would not be directed to those meetings.

Nancy D12: Summarized the above for clarification.

Marcia: WSO has been contacted by many Areas about group practices that are outside our Traditions and may negatively affect Al-Anon. The Board of Trustees has talked about this many times.

Bruce: Suggested that everyone with a question or comment come to the microphone. He doesn't think it's appropriate for the Area to make decisions that are different than what WSO does. For example, would WSO continue to recognize them as a group even if we do not.

Jayme, Past Delegate: Presented some history. The World Service Conference has continued this conversation year after year. SCWS doesn't publish a directory of meetings; we update group records. The local AIS/LDC offices publish meeting directories. Three groups were delisted by the local AIS, and they wanted to be relisted. The GRs from those meetings can continue to represent those groups with a voice and a vote at Assemblies, and their Information Service Reps (ISRs) may have a voice and vote at their local AIS/Intergroup meetings.

Marcia: The WSO website does not list international meetings. Each Area is autonomous. So, each Area has had the freedom to create its own Policy, and the WSO has encouraged every Area to create a Policy.

Laura: AAPP: Suggested the use of the word "unlist," not "delist," from the WSO website as well as AIS directories.

Marcia: WSO's terminology is "Do Not Refer." She will send the WSO announcement about the policy to all DRs.

Carol: We had a situation to deal with, and WSO let us know we had the autonomy to develop a Policy to deal with it. We are working within the guidelines of WSO.

Marcia: Several Delegates from other Areas would like to copy what we are doing in their Areas.

Micheila L, D27: Asked for examples of the kinds of issues that have come up in the Area.

Marcia: Examples: Not allowing A.A. members to share at Al-Anon meetings; using the Bible as the source of meeting topics and/or selling the A.A. Big Book at meetings, etc.

2. Thought Forces:

- a) Assembly: in the process of planning when they will meet. They will explore all aspects of the Assembly.
- b) Insurance for Groups: Asked if DRs sent questionnaires to all of their GRs, and requested that they do so if haven't yet. She will send out the request again. The Thought Force has received responses from 80 groups regarding prices, coverage and policy terms.

3. Area Alateen Resolution Committee Report

a) Updating the ASBR: Bear: Alateen Sponsor Coordinator: reviewed how these are Requirements that have been voted in and used at every District and Area as a whole. It is our guide in order to keep Alateen running and safe in the area. Once they are revised, they will go over them one more time.

4. Creating a Safe SCAC Task Force: Bear (Area Alateen Sponsor Coordinator) -- PowerPoint presentation

a) SCAC 501(C)(3) tax exempt status: exploring dissolving SCAC as a legal entity.

In his PowerPoint:

- i) History of when SCAC began and when and why it became a legal entity (a California Public Benefit Corporation and 501(c)(3) tax exempt entity per the IRS).
- ii) In 2019, how the policy is changing. Discussed the responsibilities of the Board of Directors of nonprofit entities: Duty of Care, Duty of Loyalty, and Duty of Obedience.
- iii) There are 7 Board of Directors per SCAC's Bylaws, 3 of whom are Alateens/minors
- iv) How policies have changed over time. SCAC Bylaws are not consistent with the Area's ASBRs and there are questions about how to move forward.

Questions and Comments:

Kim: Wants to know if SCAC is a 501(C)(3) or a nonprofit? She noted that all conventions create their own bylaws. Are conventions also 501(C) (3)'s?

Donna: There are WSO Guidelines regarding how to set up convention Bylaws. AFG, Inc. (WSO) is a 501(C)(3) tax exempt organization.

In California, an organization must first be recognized by the State of California as a nonprofit entity. SCWS of AFG, Inc. is a California Nonprofit Public Benefit Corporation. The organization then fills out the appropriate forms with the IRS to become tax exempt, and they receive a letter from the IRS granting them that status. SCAC went through that process in 2012/2013.

Jayme: Presented background and history of 2012/2013 when SCAC needed money after the theft

of funds took place. The incorporation and tax exempt process helped us to put guidelines in place to have accountability regarding funds and requirements so this wouldn't happen again. We needed a platform for creating requirements and at the time, it seemed that creating a separate nonprofit entity did that.

Nancy, D12: Do we have access to the original Articles of Incorporation? Based on the SCAC Bylaws, it is a separate legal and taxable entity. We (the Area) do not have the power to dissolve them legally. It's a legal issue that requires attorney guidance. In order to have SCAC, we would need to have new ASBRs and new Bylaws to be approved. Area Funds: Money was donated for the purpose of kids going to SCAC. Those funds are separate from any other Area funds and were intended to be used only for SCAC.

Donna: SCAC has been suspended for now. There is currently no active SCAC Board of Directors. Also SCAC's previous Bylaws are not consistent with our current ASBRs. Pointed out that we have on today's Agenda a discussion about seeking legal counsel. The groups in our Area provide the funds for SCAC. Clarified that minors may not be voting members of the Board of Directors on safety issues. It is complicated. Unfortunately, the way the problem at the time was solved by becoming a legal entity has created unforeseen problems.

Eva: SCAC has been suspended by the Tax Franchise Board. It cannot currently act as 501(C) (3) according to the Secretary of State California website.

Linda, D54: How long did it take to get tax exempt status? Alateens age out at 20. Will we realistically be able to have SCAC in 2020? Minors are under 18 so would need to go back to see who was or wasn't a minor. We do SCAC for the benefit of the kids. She also had a question about delisting meetings? It's been 16 years, 5 Boards that we've been discussing these issues.

Donna: Reminder that each person gets 2 minutes at the mic for comments.

Marcia: Did some research on AFG Connects regarding how they organize their Area's Alateen conference. We are not making any decisions today. Some of these questions need to be researched with the help of an attorney. Bear also has a handout that addresses the timeline of how many steps have to take place before we can plan SCAC.

Teresa, D30: Their District doesn't have tax exempt status and they've had some issues: they

can't use PSAs because local stations require that they prove they have nonprofit status. She would like some discussion re Districts and nonprofit status for this reason.

Donna: Individual Al-Anon meetings can't claim that they are nonprofits, but could show radio stations the WSO website to show that Al-Anon as a whole is a nonprofit.

Jocelyn, D8: She is on the Insurance Thought Force which is gathering information; please send information to her so they can use it to make decisions.

Bruce: Other Areas have Alateen conventions. He doesn't see the need for recreating the ASBRs. Why can't we use other Areas' ASBRs that are being used already that have been approved by WSO? He believes we are reinventing the wheel at the expense of our Alateens.

Tracy D9: Was the state's suspension of SCAC's status a punitive action?

Eva: No. The last statement of activity was not filed; therefore, the Franchise Tax Board automatically suspended it.

Nancy D12: Discussed law: form not filed. There's a way to rectify that by getting the proper form and paying a fee. There is some seed money. If they need help, she is willing to help.

Tarisa: Tax returns were filed. They are supposed to have Board Meetings. Board meetings were suspended.

Suzanne: AACC: Her research shows that SCAC doesn't need Guidelines or Bylaws.

Nancy D12: Corporations that are legal entities need Bylaws. SCAC has its own liability insurance.

Jayme: Once SCAC became a legal entity, insurance was purchased for the weekend of SCAC. It cost about \$5K. There was a lot of tension at the time between the Alateens and Al-Anons involved in restructuring SCAC.

Donna: The SCAC Task Force and Alateen Resolution Committee have been working on the ASBRs. The money in the SCAC checking account will only be used for SCAC. There are some structural issues to address so that SCAC or a new version of it would be a conference under the "umbrella" of the Area, with its own bank account and Planning Committee. One possibility might be having a SCAC Coordinator on the Board to help them move forward and oversee continuity from year to year. Alateens would make decisions about the program; adults would make decisions about safety issues, per the ASBRs. Kim S., D24: What do you want us to do?

Donna: What we are doing now, having a discussion. This is part of the process of "reasoning things out."

Bear: The current set of ASBRs on our website are the second set of ASBRs. We are now working on the 3rd revision, and are almost finished with it.

Jayme: In 2004 when the GRs voted, the Area agreed to adopt the minimum Safety Requirements, so they created the first ASBRs. Then it had to go to an attorney for review, and then to WSO.

Bear: We have been working on the policies in the ASBRs. We have a draft of requirements for reinstating SCAC. Now figuring out how to incorporate these into what we are doing. The goal is to send the revised ASBRs to WSO, hopefully in September. Will need legal counsel to review them first. Goal is to have SCAC no later than the summer of 2021.

Donna M., DR 57 Could the state revoke the nonprofit status of SCAC because of minors on its Board?

Bear: None of us are qualified to answer that question. We have to consult with an attorney about it.

Nancy D12: SCAC's option is either to adopt the ASBRs or to dissolve. This decision needs to include the Alateens. Maybe a provisional allowance can take place.

Darcy D63: SCAC fundraising is going on all the time in some meetings and in some Districts. He has a concern about Districts holding monies for SCAC. What to do with money building up? He doesn't believe there's any reason to hold onto it while SCAC is suspended.

Josie N., D42 (?): Question about District 64 Task Force.

Marcia: Currently putting together a questionnaire through Survey Monkey re: District 64 with Brissa's help to get information directly from D64 members about what is and is not working about the current structure of D64.

Old Business (Continued):

b) Restructuring SCAC with Requirements (vs. Bylaws) in accordance with ASBR

Marcia: What will be put on the Agenda for November Assembly? She is hoping to get input from the Area, plus we will need legal advice. Should we present what we have already for November Assembly to not further delay SCAC, or wait?

Bruce: We should have a discussion and vote at the November Assembly on whether or not the GRs support having an Alateen Conference. Feels fear is what is driving this issue.

Tracy D9: Will it affect the timeline of SCAC if it is not on the Agenda for the November Assembly? We need more information.

Jayme: Would this include needing legal counsel? Could the attorney we consult be available and willing to be present at the November Assembly?

Linda: It needs to be stated that we are asking for information and trying to be informed. Doesn't want to be rushed into making decisions quickly or unnecessarily.

Nancy D12: Legal issues need to be handled by an attorney. Maybe start down the path of a new convention and have a new Board of Directors for the new entity. Doesn't want to waste people's time at Assembly if these issues haven't been worked out.

Micheila D27: Referenced *Service Manual*, p. 90, "Conventions" and suggested reading WSO Guidelines. We need to include KBDM so we can have intelligent conversations with love.

Dan, Alt DR, D57: Complimented Bear's presentation. He thinks Bear's presentation should be presented at November Assembly. The ASBRs provide protection of the AMIASs, Alateens, and the fellowship.

Marcia: Clarified we want direction from the Committee as to what to present at the Assembly as well as how to move forward.

Kim, D24: Would rather see flow chart, stating here's where we are now, we need to do a, b, and c to get to the next step, not get into the issue of SCAC's tax exempt status. Then vote to approve the ASBRs in order to move forward.

Bruce: Clarified legal vs. traditional rights. There are no "have to's" in Al-Anon. There needs to be a discussion as to whether have a convention with current ASBRs or after they are done being revised.

Jayme: Who is going to oversee a new Alateen Conference? A new conference would have to follow our ASBRs, provide Guidelines and Bylaws, and include a safety requirements document.

Marcia: The main reason we are changing ASBRs is because of what we voted on already at Assembly: 18 years old as upper-age requirement, having 2 AMIAS Sponsors at every Alateen meeting, etc. We are close to being done. We cannot go to another Area to get their ASBRs, as those would still need to be looked at by WSO. Our Area is also larger than any other Area, and with many more Alateen meetings. ASBRs need to be completed, reviewed and accepted by WSO and by Assembly before we can plan another SCAC.

Suzanne: Referenced *Service Manual* (p. 137) regarding the Committee's role in planning the Agenda for the Assembly.

Eva: The names Alateen and Al-Anon are granted by the WSO. Part of that is making sure we put together a safe event.

Micheila, D27: Referenced *Guideline G-16*; all events should use and follow the Guidelines. Trust the process laid out in the guidelines.

Kay, Past Delegate: This issue came up in Panel 40 at World Conference. She met some resistance when she returned with this information then. She suggested that we refer to the "ASBR" as the "Alateen Requirements" whenever we discuss them so that our members understand that these are requirements.

Laura, AAPP: Half of all Alateen meetings have complied with the new policy of having 2 AMIASs per Alateen meeting. With knowledge comes responsibility. We have real safety issues we need to address in our Districts.

Carol, Archives: Asked for clarification: Are other areas getting their ASBRs being re-evaluated as well?

Donna: Yes. Whenever Areas revise their ASBRs, they must send them to WSO for review and approval.

Micheila, D27: It is necessary for us to talk about this since there are funds in the SCAC account. The two Alateen Roundups we've had, was there fundraising for those events? If so, will any leftover funds from those events be given to SCAC, when we hold it again?

Nancy D12: Asked for clarification regarding how and when ASBRs are going to be completed.

Marcia: As soon as we've completed this revision, which we anticipate will happen next month, they must be reviewed by legal counsel. Then the ASBRs will be sent to WSO, and we're hoping that they will approve them. Finally, they come to Assembly for approval (voted on). Then they will be ready.

Bruce: Made a motion to put on the Assembly Agenda to have an event even if ASBRs are not complete. Then we could have KBDM. Rob seconded the motion.

Donna: Legal consultation is necessary regarding the ASBRs and current SCAC. Approval and timing of ASBRs is tied to the next SCAC. History is that because our Area was not following our ASBRs, WSO rescinded permission to register new Alateen meetings in 2017. Now we are trying to follow what WSO is asking from the beginning. Current ASBRs have 2 policy changes we've made, however, there is still an issue of not having them completely done. We want to make sure we are acting under the clearest principles possible.

Bruce: The ASBRS don't apply to meetings and conferences.

Jayme: Not comfortable with Robert's Rules of Order being introduced into our discussion today, because it's not KBDM [a Motion with a second]. We need to ask: have we heard everything we need to hear?

Donna: Clarified we don't use Robert's Rules of Order, so we don't accept Motions from the floor with seconds. We present an issue, then follow the KBDM process before making an actual decision. Clarified that the SCAC 501(C)(3) issue is a separate issue that will be addressed separately, not at Assembly.

Bear: Just for everyone's information--we are very close to having the ASBR revisions completed.

Lynn, D40: Confused and concerned about it disregarding safety and liability issues.

Linda, D54: She thinks it's okay if it doesn't get done in November. It'll be ok to wait until the next Assembly. In God's time, not ours.

Micheila, D27: Asked about timeline. Will the SCAC Task Force continue to meet?

Bear: Task Force is not addressing ASBRs. Those are being looked at by the Officers and Board members on the Resolution Team.

Kat, Alateen Member Coordinator: Feels it's unacceptable to wait. Asked about the motion on the floor, also if Bruce could clarify his motion.

Donna: We are discussing whether to bring to the November Assembly that they vote on having an Alateen Conference whether the ASBRs are completed or wait until they are done?

Nancy D12: Is the Assembly willing to support an Alateen Conference under SCWS oversight?

Tarisa: There's a moratorium on overnight events. We haven't clarified all of the ASBRs yet. We need more discussion to clarify. We currently do have oneday Alateen Events--Round-up Alateen Day (RAD).

These are sponsored by a service arm, usually several Districts that work together to host it. RAD is what we are currently doing, and the kids love it.

Bruce: Can't do KBDM on whether or not to present something. Does this body support having an Alateen conference?

Judy, Literature: How would we structure these events? Thinks ASBRs need to be done first, before we have a weekend event.

Tracy, D8: Thinks Bear should do his presentation at Assembly. Doesn't think it's wise to rush to a vote.

Suzanne: Sponsor for RAD, and enjoyed seeing the event happen. Doesn't think we need to wait for legal counsel.

Marcia: Even if we don't get legal counsel now, we will need it later.

Micheila: Read from *Guideline* G-16 about Alateen Conferences.

Donna suggested that we vote on these items:

Motion: If the ASBRs are ready (30 days before the Assembly) to be presented to the Assembly in November, we will present it to the GRs for a vote at that time. Yes: 83%

Are we ready to vote on the following Motion?: If the ASBRs are *not* ready, do we want to put on the Agenda the discussion of supporting an Area Alateen Conference under the umbrella of the Area moving forward?

Tarisa: That is already happening [RAD]. Do we lift the suspension (of overnights)?

Donna: SCAC is a separate 501(C)(3) event. This would be a different event, separate from existing SCAC, the legal entity.

Judy: This event could not include overnights if those have been suspended.

Nancy, D12: When the ASBRs are approved, will the moratorium on overnights be lifted so we can have an Alateen Conference? This would help us shorten the time of getting things voted on and approved.

Micheila: Are we doing double-headed management? Are we encroaching on the SCAC Task Force's duties? What is their charge?

Bear: RAD is a one-day conference. SCAC is a Friday and Saturday conference. We can dissolve it or repurpose it. He's not concerned about that at all. The charge is to revise the SCAC Bylaws, nuts and bolts.

Bruce: Likes where it's headed. Doesn't believe that it is appropriate for others to get up and keep objecting to having a vote after the decision already was made to do so. Wants to change wording to include current ASBRs.

Jayme: Who is going to approve it at Assembly? There are 2 conferences. Why can't they be in tandem?

Donna: Want to make sure safety issues are addressed and we're legally moving forward. The new conference could be renamed, organized under the Area umbrella.

Jaymie: We're not putting a date on it?

Bear: All of these issues have been worked on in the ASBR process, now need clarification and approval.

Kat: Doesn't believe it's right to vote on something so controversial.

Donna: Do we put this on the Agenda? Do we have the permission to lift the overnight moratorium on Alateen conferences effective on the approval of the ASBRs?

Micheila: Doesn't understand why we are voting on this? Wouldn't this be the result of the Task Force?

Sam D36: Clarification that we will have a discussion and vote at the November Assembly.

Josefa, D64: What happened to SCAC?

Kay: Are we putting this on the Agenda after the ASBRs are being done?

Donna: Because we're not getting to a consensus on this, we will table this discussion for today.

5-minute break, followed by the Serenity Prayer.

Convention Chair Reports for YHA, AFG: *Please* see the written reports in Bulletin.

New Business

1. Presentation clarifying legal versus traditional rights. PowerPoint: Concept 6 and 7: clarified our Board is the Board of Directors. Also introduced the "minors statement" issue.

Micheila D27: We have an Alathon coming up in October. How might a minors statement affect the Alathon? We aren't having an Alateen program.

Donna: We can discuss specific registration details later. For now, looking for more feedback from DRs. The nonprofit lawyer we consulted advised that it would be prudent to include a minors statement. WSO staff agreed because we are responsible for the safety of participants at our events, overall. Need to make it clear that parents are responsible for their children/minors.

Bruce: Has this already been voted on, so is this a requirement?

Donna: No, it hasn't been voted on yet. The

Officers are going to talk to our Board members about making this Area policy.

Bruce: Not sure that this is required by law. Don't think we need this policy.

Rob: Field-tested these proposed policies at the YHA convention. When we hear the word "have to," we think that it is a legal issue. So, we contacted WSO and didn't hear back. We got our own legal counsel as a committee, who advised that having the statement opens you up to more liability than not having one. Plus it must be enforceable.

Linda D54: Do they have a policy with adults only, no minors included? Is there a way to not have it?

Sue, AFG chair: At our convention, they can be dropped off and they can sit in our meetings. We are taking away their rights of participation in Al-Anon.

Suzanne: There are real safety issues in Al-Anon regarding minors. WSO and Conference are trying to address them.

2. Affirming addition of Attorney-at-Large position to SCWS Board. Tabled this item until the February Committee meeting.

3. Creating an "Al-Anon Minors Statement" for Area-recognized conventions + "with Al-Anon participation." Tabled until February Committee meeting.

4. Considerations for recognizing new conventions in the Area--what we've learned and recommend for YHA Convention (and any new conventions) moving forward. Tabled until February Committee meeting.

5. "Liaison" position between the Board and all Area conventions: Want to add this to the Alternate Delegate's job description.

6. Create *Bulletin* Task Force--how to adapt the *Bulletin* to the digital age.

Bruce: Stressed the importance of getting reports to him in a timely manner. Questions have been asked which reports to give at which times. Also, doesn't think Agendas and Financials need to be put in *Bulletin*. Do we really need to provide printed copies?

Donna: Contact Bruce if you are interested in working with him on updating the *Bulletin*.

Tarisa: Thorn in her side how late *Bulletin* comes out. The next *Bulletin* is supposed to be about what we present today at the Committee meeting. Asked how many would like to have it within a month from today? Many raised their hands. Then we could have it on website and have a contact page provided at Area meetings.

Treasurer

Thank you to all of the groups, districts, and conventions that send contributions to Southern California World Service. Your contributions allow SCWS to carry the message of Al-Anon Family Groups throughout Southern California.

Summary of Quarterly Financials: The total revenue for July-September 2019 increased 9% *compared to July-Sept 2018*. The total expenses decreased 19% *compared to July-Sept 2018*. The net revenue for 3rd Quarter of 2019 was \$8,822.65. We continued to maintain a reserve of \$35,000.

To DRs & GRs: Your meeting (for GRs)/district (for DRs) should reimburse you up to 100 miles *roundtrip* to attend the Assembly. If you drive 101 miles or more *roundtrip*, SCWS will reimburse you \$0.40 for each mile exceeding 100 miles.

They get a packet at the event and distribute registrations, room keys, etc. Although there is still security, the sponsors work with committees for that task. The bottom line is that the sponsors are responsible for their teens.

In addition their election process is very different. They elect co's who step in the following year.

They have to be between 15-17 and their group sponsors can veto their nominations.

Hi everyone!

During the recent recertification cycle it came to my attention that many of our AMIAS are unaware of a particularly vital duty of the CMA (Current Mailing Address). Everyone knows that each AMIAS must recertify each year, but not everyone knows that each *meeting* must recertify as well. The way this happens is our WSO snail mails out a paper form to every CMA in March or April, asking them to verify that the address and time are correct, and to update the sponsors connected to that meeting. That form is then sent by email or snail mail to the AAPP (email preferred) who then updates the WSO database. The CMA should submit this form whether or not there are any changes to report. Is this another meaningless paper drill? NO!

Think about how large our Area is, and put that thought together with the fact that we currently have only 65 Alateen meetings (and only 5 of those are bilingual). Someone looking for a meeting in the <u>Find an Alateen Meeting</u> feature of the WSO website is *probably* in for a bit of a drive. What if you changed your meeting time from 6:30 to 7:30pm? That kid and their parents will find nothing but a locked door on an empty room. How many times do you suppose they are willing to have that disappointing experience before they just write off Alateen altogether?

Our Declaration states: Let the Hand of Al-Anon and Alateen always be there...the annual meeting

certification is the process for making sure that the hand of Alateen is reaching out exactly <u>where</u> and <u>when</u> we say it is.

When you update your meeting details with the Area and WSO, it is also good to check in with your Intergroup/AIS, whether you have any changes or not. Too much communication is better than not enough, eh?

To illustrate the way members' personal recollections and groups' records can enliven the Area's history as recorded in Archival files, new notebooks with members' "First Meeting" stories and Group histories are now being displayed at Area Assemblies and meetings of the Area Committee. (The Area Committee is composed of officers, Board members, District Representatives, Past Delegates, AIS liaisons and chairs of Arearecognized conventions.)

The purpose is to encourage more members to share their personal First Meeting recollections and to prompt more meetings to record their histories before vital details are lost as members move away or pass away.

To facilitate browsing through the First-Meeting stories and Group histories, there are two copies of each set of records.

The World Service Office has developed a form to guide members in writing their First Meeting stories. Members can treat the form as a fill-in-theblanks exercise or they can tell their stories in narrative form. For a copy of the form, email me at archives@scws-al-anon.org. Then, when the First-Meeting record is finished, email it to me at the same address. Members of some meetings that are celebrating 50, 60 or more years of Al-Anon recovery have reported that they can only go back 15 or 20 years for details about their histories. In some cases, information that members can recall is vague, as is the case with a meeting that knows the name of the church in which it first met 50 years ago, but cannot determine what city that church was in. One group has listed vital information—first meeting date, meeting location, changes of location and WSO number—on the top of the meeting format as well as on meeting records sheets in the secretary's book.

The whole point of recording information today is summed up in the lesson that—-"What happens today is tomorrow's history."
