

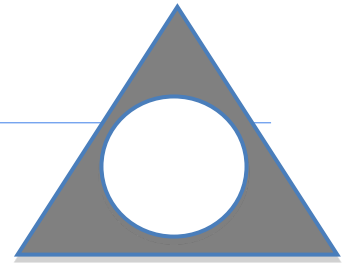

Area World Service Committee Meeting Minutes

for February 17, 2018 Glendale United Methodist Church

8:00 a.m. DR Orientation – Dining Room

9:00 a.m. Open with Serenity Prayer

Welcome to Past Delegates. Willie W., Panel 37;
Jayme C., Panel 52

Participation Guidelines. Donna read the Participation Guidelines (formerly referred to as the Conference Guidelines) that will be used for this Committee Meeting. She suggested that we not take an official break this morning due to the lengthy Agenda.

Jocelyn, D8 read the Twelve Traditions

Roll Call. Ana R., Group Records Coordinator

Secretary. Jim B. asked for approval of the Minutes from August 19, 2017 Committee Meeting.

Motion passed unanimously to approve the Minutes with no corrections.

Treasurer Report. Outgoing Treasurer, Eva B. detailed the 2017 year-end Financials which included a \$20,000 donation to WSO. See the Financial report in the Bulletin.

Q. Tracy, D9: Why is there a 200% increase in Bank Fees?

A. Eva: The fees included NSF charges and a payment of \$50.00 per month for a check scanner and remote deposit service.

Q. Jocelyn, D8: The Financials state that they are for 2018. Shouldn't it be 2017?

A. Eva: Yes, the date will be corrected.

Motion by Libby, D75 and seconded by Chris, D40 to approve the Treasurer Report.

Motion passed unanimously to accept the 2017 financials.

Tarisa R., Incoming Treasurer, gave the Auditor's Report for the year ending December 31, 2017. She will have the Auditor correct the year, (2017 not 2018) on the report. Auditor had gone over balance sheet as well as Income and Expenses. Random testing of cash deposits and disbursements were conducted. All were in compliance.

Noted: A delay in turning in expenses over the past two years was noted. Several Board members have not submitted their expenses in a timely manner, which resulted in year-end financials that were not exact. This policy will be addressed at the next Board Meeting to assure that all expenses are submitted in a timely manner.

Eva: Some of the expenses in question were turned in prior to the end of 2017, but the reimbursement checks did not clear until January.

Tarisa: Submitted the Financials for the month ending January 31, 2018. Some items in the balance sheet comparison do not align with the previous year. That is because SCWS changed from QuickBooks to online QuickBooks and some items now show up in a different category.

Q. Chris C., D40: Why did we change from QuickBooks to online QuickBooks?

A. Eva: Because we do not have an office, it is easier for those authorized to access our accounts to monitor them online. It made training of the new Treasurer easier as well.

Q. Tracy, D9: Why are we holding so much money in our account?

A. Tarisa: Our ample reserve is currently held in CDs, earning interest. What was left over from our reserve, or "profit," at the end of 2017 was donated to WSO. Our ample reserve is between 6-12 months operating expenses.

The Group Contribution form has changed. Group contributions will be listed within each District by the group's name, in alphabetical order. You will see this change in the next Bulletin. In order for group contributions to be credited accurately, the WSO ID number must be on the check or accompanying form. Contact your DR for that number if you do not have it. The Treasurer will try to find your meeting if your number is not listed, but it may not get properly credited.

Several DRs and Coordinators complained that the process of finding each group's WSO ID number is cumbersome and time-consuming, and they hope that there will be an easier and more efficient way for members to find those numbers themselves in the future.

Area World Service Committee Meeting Minutes (cont'd)

Jocelyn, D8: Each group's WSO number is listed on the Santa Barbara Meeting Directory. She suggested that each AIS office might publish the WSO ID numbers in their directories or online.

Libby, D75: Offered motion to approve the January 2018 Financials. Ana, D42: seconded the motion.

Motion passed unanimously to accept the January 2018 Financials.

Alternate Delegate Report: Eva B. is the new Alternate Delegate. 9 new DRs were present. Eva is the *Forum* coordinator. See her report in the *Bulletin*.

Q. Vicky, D72: Does WSO still send a free *Forum* to every group?

A. Eva: Due to budget cuts, no.

Ask-it-Basket was passed around.

Delegate Report: Marcia M. See Delegate report in *Bulletin*. Passed out flyers with the new Board member's contact information. The SOS Workshop Report, WSC Love Gifts and the International Convention information can be found on the SCWS website.

The Chairman of the Board (COB) Letter from WSO will go to the DRs and a link will be put on the website. You can find it on the homepage.

Alateen-AMIAS Task Force. Marcia read letter from Vali F., WSO Executive Director, on the status of Alateen in our Area. **Registering of new Alateen meetings has been re-instated.**

Sue P., WSO, will be here for our May Assembly and will hold a meeting after the Assembly to discuss any questions or concerns that you may have.

Q. Kathleen G.: What is Sue's official title?

A. Marcia: Associate Director - Group Services

Who has a voice and vote? See the *Bulletin* for detailed information.

District Reports: See *Bulletin* for Reports.

Reports given at the mic were D6, D8, D9, D10, D17, D21, D24, D36, D40, D48, D39, D42, D54, D57, D60, D63, D64, D66, D69, D72, and D75.

Tracy, D9 read a letter of concern from their District that was sent to the Board. It addressed the issue that SCWS has more meetings than any other Area, and maybe we have outgrown our ability to manage the Area.

7th Tradition:

Old Business:

Task Force Update: Donna E., Chair. See Report in the *Bulletin*.

The Redistricting Task Force is on hold until the D64 Task Force has completed their work and recommend that D64 be divided, remain the same or be absorbed within the existing Districts.

Another issue is whether our Area is too large and should be divided. Jayme C. referred to the *Service Manual* on Pages 142 & 173 which states that an Area can split once when they have more than 400 meetings. California split into "North" and "South" years ago. If an Area wants to split again, they could, but they would have to send a Delegate from that Area to the World Service Conference (WSC) for six years, during which time their Delegate would have no voice or vote. That Area would bear the total expense for the Delegate during those six years and would not benefit from the cost-sharing system currently in place which subsidizes Delegates. Bottom line, in order to move toward splitting our Area, we would have to create a Thought Force, then a Task Force, and then send a Delegate to the WSC for six years without representation or any subsidy for the expense.

D64 Task Force had been meeting regularly until March of 2017. Marcelino, D64: He was part of the Task Force and suggested that it be restructured.

Frank, D54: Suggested that the Redistricting Task Force proceed and make recommendations to the Area, even though the D64 TF has not presented their recommendations.

The D64 TF will give the SCWS Chair a written report of their progress. The Chair will assess their status and determine how to proceed.

SCAC Restructuring Task Force completed their procedures documents and a SCAC By-Laws revision that reflected those procedures. The SCAC Restructuring Task Force is on hold due to the creation of the Alateen-AMIAS Task Force (AATF) as some of the recommendations from this Task Force could foundationally change the SCAC procedures documents and By-Laws.

Alateen-AMIAS Task Force (AATF):

Suzanne P. (The Power Point presentation will be posted on the Area's website.)

AATF members: Bear, Micheila, Jan, Sandy, Stefanie, Jim, Rob and Suzanne

AATF team presented the history of why the AATF was created and the goals they are working toward.

Short-term goals: Address the AMIAS Certification and Recertification training as well as Items that may be included within our Area Alateen Safety and Behavioral Requirements (ASBR) document:

- Facility information/contact sheet
- Alateen Meeting behavior agreement/rules template
- Division of Area Alateen Sponsor Coordinator (AASC) and Area Alateen Process Person (AAPP) positions into multiple positions: Alateen Events Coordinator and Alateen Communications Coordinator.

Long-term goals:

- Review and revise ASBR for the possibility of changing age limit for Alateen membership
- Possible transition plan for "aging out" Alateens
- Develop DAL and District AMIAS backup/support lists for Alateen meetings

Q. What is the age requirement for Alateen?

A. Rob: The range of Alateens in our Area is 13 and they "age out" at 21. In the majority of states nationally, the upper age is 18 or 19.

A. Suzanne reported we currently have no *minimum* age requirement.

Q. Jocelyn, D8: It is suggested that the DR visit their Alateen meetings. Does this mean they have to be an AMIAS?

A. Bear: This is a grey area and the AATF will be addressing this issue.

Q. Tracy, D9: Has the AATF come up with target dates as to when some issues with SCAC might be resolved?

A. Suzanne: SCAC is not Alateen, it is only one

A. Suzanne: SCAC is not Alateen, it is only one Alateen event. Issues involving Alateen as a whole must come first. We are committed to restoring SCAC, but there are no guarantees as to when the issues will be resolved.

Donna, Chair, advised that the earliest possible date that SCAC could be scheduled, theoretically, would be 2020. All documentation for SCAC would have to be submitted and then approved by the members, *after* the AATF's recommendations have been made and voted on by Area GRs. This is a lengthy process.

Comment. Carol, D60: would love to see a Mission Statement for SCAC.

Comment. Vicki, D72: There are some members who appear to consider SCAC to be a right and not a privilege.

Comment. Frank, D54: reported that it was not feasible to be a DR and not be an AMIAS.

Comment. Ana, D42: It is a requirement for a DR to be an AMIAS in her District.

Q. Willie: Where is it written that a DR needs to be an AMIAS?

A. Stefanie, D69: Page 33 of the *2014-2017 Service Manual* states that an Area trusted servant may visit an Alateen meeting. It does not say they have to be an AMIAS.

Comment. Jayme: In our current requirements for District responsibilities, it is suggested that each District have a DAL to assist the DR and attend each Alateen meeting. A DAL has to be an AMIAS.

Q. Andy, D24: Would the proposed quarterly meetings requirement change the current certification process?

A. Bear: This could modify the certification and recertification process if there are additional requirements put in place.

Donna, Chair, advised the Committee on the proposed new Alateen Coordinator positions. There will be a financial impact to the Area due to additional Coordinator expenses. These new Coordinators would also be added to the Alateen Resolution Committee, increasing the membership of that Committee from 5 people to 7 people.

Area World Service Committee Meeting Minutes (cont'd)

Lunch Break.

Afternoon Session 1:00pm – 4:00pm

Donna added the AMIAS Background Check Task Force's presentation to today's Agenda.

AMIAS Background Check Task Force

Christy R. reported that this Task Force was formed not to look into Live Scan, but to compare Live Scan with Trak One. See handout provided.

Recommendations:

- Continue using Trak One as the Area's background check company
- Form 2 of the AMIAS application packet may be edited to require the applicant's Social Security Number (SSN) be listed on the form.
- All current AMIASs who did not previously submit their SSN must resubmit Form 2 with their Social Security number.
- All AMIASs will be required to be rescreened through Trak One every five years.

Christy R.: A cost comparison study showed there would be a severe financial impact on our Area if Live Scan were implemented. They had no recommendation as to how that cost would be allocated by the Area, Districts and individual AMIASs.

Tarisa: Live Scan only provides results on convictions. Trak One provides pending charges and convictions. This is an important factor to be aware of.

The Trak One California package is more thorough than Live Scan. Without a SSN, there is no guarantee by Trak One, even with a multi-state background check, that the information is accurate. Trak One will provide traffic violations, multiple use of your SSN, and many other inconsistencies.

Once screened through Live Scan, any update information will be sent to the AAPP. Trak One does not update information after screening, therefore, they are recommending that everyone be rescreened every five years.

Bear: If the applicants have to pay a portion of the Live Scan fee, could that deter some members from becoming an AMIAS? Some members might not be able to afford the

additional cost. The determination of the costs and who will pay to use the AI-Anon name. Nichole, D10 seconded for the background checks will be determined once the GRs vote on whether or not to move forward with the recommendation that we use Trak One and SSN's.

Q. Jayme C.: In 2013, we passed the Area Safety and Behavioral Requirements and voted that the Area institute a more stringent background check. Live Scan was the company, other than Trak One, that was proposed as a possible vendor to perform the background checks. The comparative cost of Live Scan and Trak One was a major question. A. Christy: With Live Scan and Trak One, the AAPP person will be responsible for the security of the information.

All information on the application form, including the SSN, will be provided to the AAPP and, once downloaded, the form will be deleted. The entire application packet will be stored in a locked cabinet and all files deleted when a person is no longer an AMIAS. This information is accessible only to the AAPP.

Q. Micheila, D27: Will it cost more for Trak One to process the info with a SSN?

A. Christy: There is an additional \$6 fee to process applicants using their SSN.

Q. Jan: Concerned about having SSNs on a form. What happens to the information provided by Trak One?

A. Christy: AAPP will download the information from Trak One and then print it out. The download is deleted and the printed forms are stored with the AAPP in a locked filing cabinet.

Q. Andy, D54: Could our SSN be accessed by someone else?

A. Christy: The system is secure.

A. Tarisa: Live Scan requires the Custodian of Records (COR) to keep the documents in a secure place. We could require that if we stay with Trak One.

Comment. Eva: The COR, our AAPP, has been cleared with the Department of Justice. The original charge was to find a more stringent way to conduct background checks.

A. Christy: By providing a SSN, Trak One will meet this requirement.

Q. Sandy K.: Will the forms go to the AAPP and

eliminate the DAL/DR?

A. Tarisa: On form 2, they will have options on how to provide their SSN. Form 2 does not need to go to the DAL/DR. The District only needs

Q. Jim: There is no way to assure that the person turning in the form is the person associated with that information. Live Scan uses a fingerprint to identify the person applying and matches the information to that person.

A. Christy: Someone would have to go to great lengths to scam the Area. Trak One identifies you by your address which makes it more likely that the person being checked is the person who submitted the application.

Donna, Chair: Since the GRs voted for the Area to employ a more rigorous background check, and only Trak One provides that (and Live Scan does not), there is no need to vote at the May Assembly on which company to use. There are two items regarding background checks that we need to vote on today, in order to decide whether they will be on the Agenda for the May Assembly: that a SSN will be required as part of the AMIAS application process, and that the Area rescreen all AMIAS's every five year.

Motion. Micheila, D27 offered the motion that we vote to place on the May Assembly Agenda that applicants to be AMIASs provide their SSN, that all records be secure, and that we rescreen AMIASs every 5 years. Frank, D54 seconded. 28 Yes, 1 no.

Motion passed to be placed on May Assembly

Donna, Chair: Recommend that the TF members explore safety measures on how the SSNs will be maintained and protected.

Young at Heart Al-Anon

Rob, Jasmine, Jesse and Cyndee are part of the workgroup to create a one-day event for the Young at Heart in Al-Anon. See the handout provided.

Rob, Chair for Young at Heart Al-Anon (YHA): This group of young Al-Anon members want to establish a one-day convention in our Area and would like to use of the Al-Anon name and be recognized by the Area. This will need to be voted on by the Assembly.

They cannot raise funds for this event unless recognized by the Area. A YHA person is anyone who is young at heart. There is no age limit. Anyone can attend. They would like to carry the

message to all young Al-Anons beyond the group level and this type of event could aid in that outreach effort.

Motion: Tracy, D9, offered motion to put this on the Agenda at the May Assembly, to recognize the Young at Heart Al-Anon convention and allow them the motion.

Motion passed unanimous with one abstention.

Micheila read the Concepts.

Donna, Chair. Discussed the addition of the two new Alateen Coordinator positions: Area Alateen Communications Coordinator (AACC) and Area Alateen Events Coordinator (AAEC). This increases the number of Board Members and increases the number of people on the Alateen Resolution Committee. The Area Alateen Sponsor Coordinator (AASC) and Alateen Member Coordinator (AMC) positions are still open. The current Area Alateen Resolution Committee (AARC) consists of the AASC, AAPP, AMC, an Elected Officer (Jim B.) and an AMIAS-at-Large; most of these positions are currently vacant. In the past, there was an additional "continuity" person on the Committee, but that position will not be filled on the newly constituted AARC. With the addition of the two new Alateen Coordinator positions the AARC will have seven members.

Currently, the Alateen holding the position of AMC is a member of the AARC. One of the possible recommendations from the AATF may be that minors (that is, Alateen members) would have a voice but not a vote on safety issues, as those involve issues for which adults bear the legal responsibility. Should the Assembly vote to institute that policy, the Board would propose creating an Alateen Advisory Council made up of Alateens who would offer their experience and input on safety and behavioral issues that would impact Area Alateens. All Alateens who are GRs would continue to have a voice and a vote at the Assembly.

Two other Coordinator positions will be added to the Board: an Al-Anon Information Service/Literature Distribution Center (AIS/LDC) Coordinator and a Spanish Coordinator. We will add these positions on a trial basis for three years. Should we find that these positions

are helpful to the Area's mission, the Assembly would vote to amend the By-laws after the trial period and permanently add these positions to the Board.

Q. How much would the addition of these positions cost the Area?

A. Donna, Chair: We are projecting that the budget would be no more than a \$1,000 per year, per position. The AIS/LDC Coordinator's primary expense would be mileage, as they are asked attend at least one meeting at each AIS Office per year.

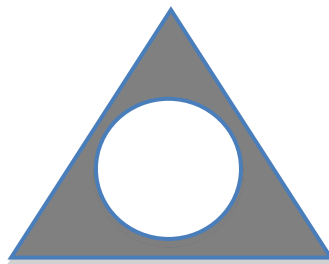

- Cooperate with Public Information, Cooperating with the Professional Community, and/or Institutions Coordinators to sponsor subscriptions or to distribute copies of The Forum to libraries, institutions, and professional offices.
- Encourage GRs to present The Forum so that others in the group will want to read and have their own issue. Create a list of ways the GRs or groups can introduce non-subscribers to The Forum.
- Use a Forum display board at conventions, health fairs, area assemblies, group anniversaries, and other events.
- Provide subscription order forms for distribution and make extra copies available. (The area may want to subscribe to multiple issues for this purpose. The Area Archivist may be of assistance preparing an effective display.)
- Encourage longtime members to sponsor subscriptions or donate past issues of The Forum to newcomers. (Some groups insert a copy with the newcomer's Packet.)
- Encourage members to access The Forum at www.al-anon.org/members to view the Table of Contents page with links to the three Internet articles, the front cover, "Inside Al-Anon," and the calendar).

From your Treasurer

I want to thank all of the groups, districts, and conventions that send contributions to Southern California World Service. Your contributions allow SCWS to carry the message of Al-Anon Family Groups throughout Southern California.

Summary of Quarterly Financials: The contributions for Jan-March 2018 are down 2% compared to Jan-March 2017 contributions. Our total expenses increased by 74% compared to Jan-March 2017 because SCWS is "busy" carrying the message. Additionally, there were 2017 expenses that were reimbursed in 2018 (this will be discussed further but I will be requesting that all reimbursement requests are submitted in the same quarter as the expense incurred in order to ensure an accurate reporting of quarterly expenses). We continue to maintain a reserve of \$30,000.

To DRs & GRs: Your meeting (for GRs) and district (for DRs) should reimburse you for up to 100 miles *roundtrip* to attend the Assembly. If you drive 101 miles or more *roundtrip*, SCWS will reimburse you \$0.40 for each mile exceeding 100 miles. Please submit your reimbursement request forms to the SCWS Treasurer at the Assembly.

To Group Treasurers: PLEASE, PLEASE, PLEASE write your group's WSO ID# on the check or money order when sending your contribution. This ensures that your group receives credit for the contribution on the quarterly report! If you do not know your Group ID#, write the Day, Time, City, and Group Name on the check so I can look through the database to find your Group ID#.

It is greatly appreciated when you include a contribution form with the check/money order. It helps expedite the processing of your contributions and makes this task so much easier for me. The Group Contribution Form can be downloaded from the Forms webpage of the SCWS website www.scws-al-anon.org). Districts and Conventions can use this form, also.

Ask it Basket

Is there a protocol for putting recorded Al-Anon Speaker on the "cloud", "dropbox" etc.? I am concerned about anonymity and propriety.

Provide speakers with information about ways the recordings may be distributed and tips on how to maintain anonymity. It is up to the speakers, when they consent to having their talk recorded, to protect their anonymity by using their first name only or a pseudonym and to maintain the anonymity of other Al-Anon, Alateen, and A.A. members in their talk. (Al-anon/Alateen Area Conventions, G20)

Regarding anonymity, Tradition Eleven gives a specific guideline: "we need always maintain personal anonymity at the level of press, radio, films and TV". It is Al-Anon/Alateen policy to interpret Tradition Eleven to include the internet as well as all forms of evolving public media. Personal anonymity in the media guards the fellowship from the Al-Anon/Alateen member who may be tempted to seek public recognition.

When speaking or writing as an Al-Anon/Alateen member in any form of press, radio, films, TV, internet or other evolving public media, members use only their first names and last initial or pseudonyms. Members can also speak without identifying themselves or sign articles "Anonymous".

On any website accessible to the public, whether an Al-Anon site or not, full names, phone numbers or other identifying information are not posted, if they are identified as belonging to an Al-Anon/Alateen member."

An organization required exhibitors at a health fair. How do groups/districts respond to entities requiring proof of insurance?

From time to time members may call SCWS and request a copy of the Certificate of Liability Insurance. Our insurance only covers SCWS. The insurance does not cover other groups or events. Venues will ask for the certificate and our insurance does not cover any other entity or venue. Groups and Districts may also ask their local AIS for an insurance rider.

Will the Spanish Group Registration Form added to the SCWS Website.

The SCWS website will be undergoing a "renovation". It is our hope to make all forms available to everyone.

What can groups do to increase forum subscription?

How to best encourage members to step up to serve at all levels.

Carrying the message can take many forms, from giving encouragement to a newcomer to participating in service at any level from the group to the World Service level. Many members share that they always seem to get back far more than they give to Al-Anon (Paths To Recovery, page 121)

Service and recovery, then, are not independent of each other. Both are part of the spiritual awakening that continues to guide us. The more willing we become to practice all of this program, the more progress we can make in recovering from the effects of another's alcoholism and in living our lives more fully. (When I Got Busy I Got Better, page 2)

Al-Anon is a program of attraction rather than promotion. Everything that we do "begins with me." By working my own program and "suing up and showing up", and "keep coming back," I am encouraging others to participate.

To encourage more convention participation, I ask that those who have chaired other conventions step aside and let others have the opportunity. My question is, when does rotation of leadership begin & ends?

SCWS has no opinion on our many Conventions and their Committees and/or election of Chairpersons.

Why is a former member of AA serving in the board?

Every SCWS Coordinator's Job Description states: "Members of Al-Anon in SCWS who also are members of A.A. are ineligible to hold any office beyond the group level." We were informed

an Al-Anon member that one of the candidates for a Coordinator Board position "was a member of A.A." We spoke with that candidate, who explained that s/he

- did attend A.A. meetings at the beginning of his/her recovery process for a short time,*
- never had a compulsion to drink, and*
- was not an alcoholic.*

The candidate assured the Officers that Al-Anon was the candidate's only program. It is up to each individual to determine whether or not s/he is an alcoholic. The Officers were satisfied that the candidate is solely an Al-Anon member and as such, was and is eligible to be a Coordinator.

Group Records

I am pleased to report I have processed changes from 186 different meetings and registered 11 new meetings. The previous Group Records Coordinator made my work easy and being a part of the SCWS Board is extremely pleasant and instructive.

I would like to share information that will help all southern California Al-Anon members and, as a consequence WSO, as keeping up to date group records is essential for all members and prospective members.

Below is a step-by-step reminder of the process to update group records. You can also find an Instructions form on the SCWS Forms page, which will give you an item-by-item explanation of each category of information needed.

To register a meeting

To register a meeting you need a location, a contact (first name and phone number) and a Current Mailing Address (CMA). The CMA needs to provide full name, address, phone number, and email address. WSO assigns each new meeting a WSO ID#. Each is unique, thus it helps WSO to know how many meetings exist any given place.

Whenever a group's Treasurer sends in a contribution, it is crucial that s/he includes the WSO ID# so that the group can be properly credited for it. Remind your GRs/meetings of that, please.

Instructions

3. Enter your meeting's WSO ID# *
4. Enter the information that needs to be updated/changed since the ID number provides all of the information needed to identify the meeting, there's no need to submit anything else
5. Press "send email" at the bottom of the page on the left

***Our members can now find their meeting's WSO ID number by**
1. Opening <http://al-anon.org/al-anon-meetings/find-an-al-anon-meeting/>
2. Entering the **location** of their meeting and in the result in the left-hand column, each meeting's **WSO ID number** is the number immediately below *Report Problem*.

Any time a meeting changes location, time/date, or any of its officers – contact, Current Mailing Address (CMA), or Group Representative (GR) - it needs to report the changes. The area's Group Records Coordinator (GRC) processes the changes, which WSO has access to.

Please note that both the CMA and the GR need to provide their first and last names, mailing address, phone number, and email address. Per our Service Manual, it is "practical" to provide our last names when we are in a service position to which postal communications are mailed. Rest assured that we do not share this information with other members or with anyone outside of our fellowship.

To help your members make the changes:

Many of the members in the area have been sending changes through our website using their WSO ID#. Please thank them all for me.

A few members send changes via our Al-Anon's WSO site, which works but takes a little longer. Please educate your members to use the SCWS' site instead.

A few send them via snail mail, using sometimes very old and confusing forms. Please provide only the current Registration/Group Records Change Form pdf downloaded from our SCWS website to the members who insists on using paper forms

Please ask your members to write the zip code whenever they add an address. It is a small thing for each person to do, but when I have up to 20 meetings to process per day, the time to check the zip code of each one adds up fast.

Last thing, I can only make changes to groups when provided with their WSO ID# so make sure your District is using them.

About Group, District, and Area Positions

Sometimes members send a submission about group service position called names I do not recognize and neither does WSO. Below are the positions recognized by WSO per the 2018-21 Service Manual that are submitted to SCWS and/or WSO.

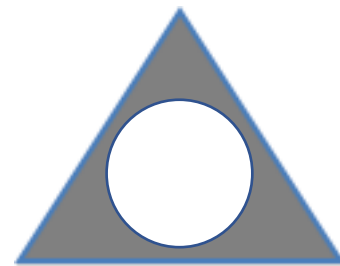

After launching a pilot outreach project for families of those whose drinking has resulted in involvement of the Fullerton Police Department, District 60 is preparing to move from pilot project to full-blown project.

We will do that by introducing the project to other law enforcement agencies in the District for their possible distribution of Al-Anon literature to families of people whose drinking has gotten them into trouble with the law.

The project has two parts: (1) informing law enforcement agencies of what Al-Anon is and how it helps families affected by drinking and (2) giving officers packets of information to give to families affected by someone's drinking. The packets include (1) a questionnaire for those who grew up in a home affected by drinking, (2) a questionnaire for those living with someone whose drinking is a problem and (3) the "Detachment" flier.

To expand the pilot to a full-blown project, we are surveying members to (1) find Al-Anons who have contacts at law enforcement agencies and (2) get volunteers willing to go to law enforcement agency roll calls and explain Al-Anon and the project to officers. (Willingness here may sometimes mean showing up at 5 a.m.!))

A parallel project in the planning stages involves families involved with the North Orange County drug and alcohol court. It is being patterned after a program in the Santa Barbara area where a judge requires offenders to read an AA magazine, then write an article about what the offenders have learned. Funds for up to a dozen copies of "The Forum" have budgeted for the project.

District Reports (cont'd)

These two targeted outreach projects have been balanced by distribution of more than 700 copies of "Help and Hope," Al-Anon's outreach magazine formerly known as "Al-Anon Faces Alcoholism." The copies have gone to community individuals and organizations that might refer people to Al-Anon.

District GRs and AGRs have voted to make last fall's Al-Anon/Alateen workshop an annual event, acknowledging that "Alateen Is Al-Anon." The workshop with an Alateen-Al-Anon focus will be conducted in the fall.

The eighth annual District 60 educational workshop has been moved from March 10 to May 12 at Trinity Episcopal Church, Orange. Among the speakers will be our new Alternate Delegate, Eva B., sharing her personal recovery story. Our Orange County AIS office coordinator, Julia T., will bring a selection of literature for sale. As she said at the 1987 World Service Conference, "Anybody can start something, but carrying it out is the real challenge. And all the rest of you are doing that job. You're all founders in your own right, carrying the message."

The other thing that seems to be happening within the three districts, 69, 72, 75, in our county & our Intergroup Board is better communication. We are reaching out to each other for ideas & suggestions. I am especially excited about this. And as we say, "more will be revealed". I think it's going to be a great year for San Diego County.

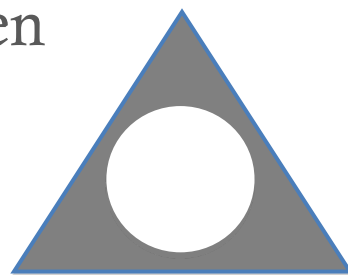



Subject: Annual Audit for the Year Ended December 31, 2016

We, Cathy S. and Laura H., completed our review of the books and records of the Southern California World Service of AFG, Inc. for the year ended December 31, 2017, on January 12, 2018. Our review covered the Balance Sheet accounts as well as a test of income and expense accounts. This included a reconciliation and review of Cash and Cash Equivalent Accounts and analysis of the remaining Balance Sheet Accounts. A random testing was conducted of the cash deposits and disbursements with satisfactory results.

The only item of note was the delay of submitting expense reports reimbursements by one board member. This delay could result in not supplying the Assembly with an accurate forecast of our financial situation. I suggested after the 2015 audit to make sure all board members (regardless of their position) submit their reimbursements requests no later than 60 days after their event.

A separate report of "Observations/Recommendations" has been submitted to the five elected SCWS Board members.

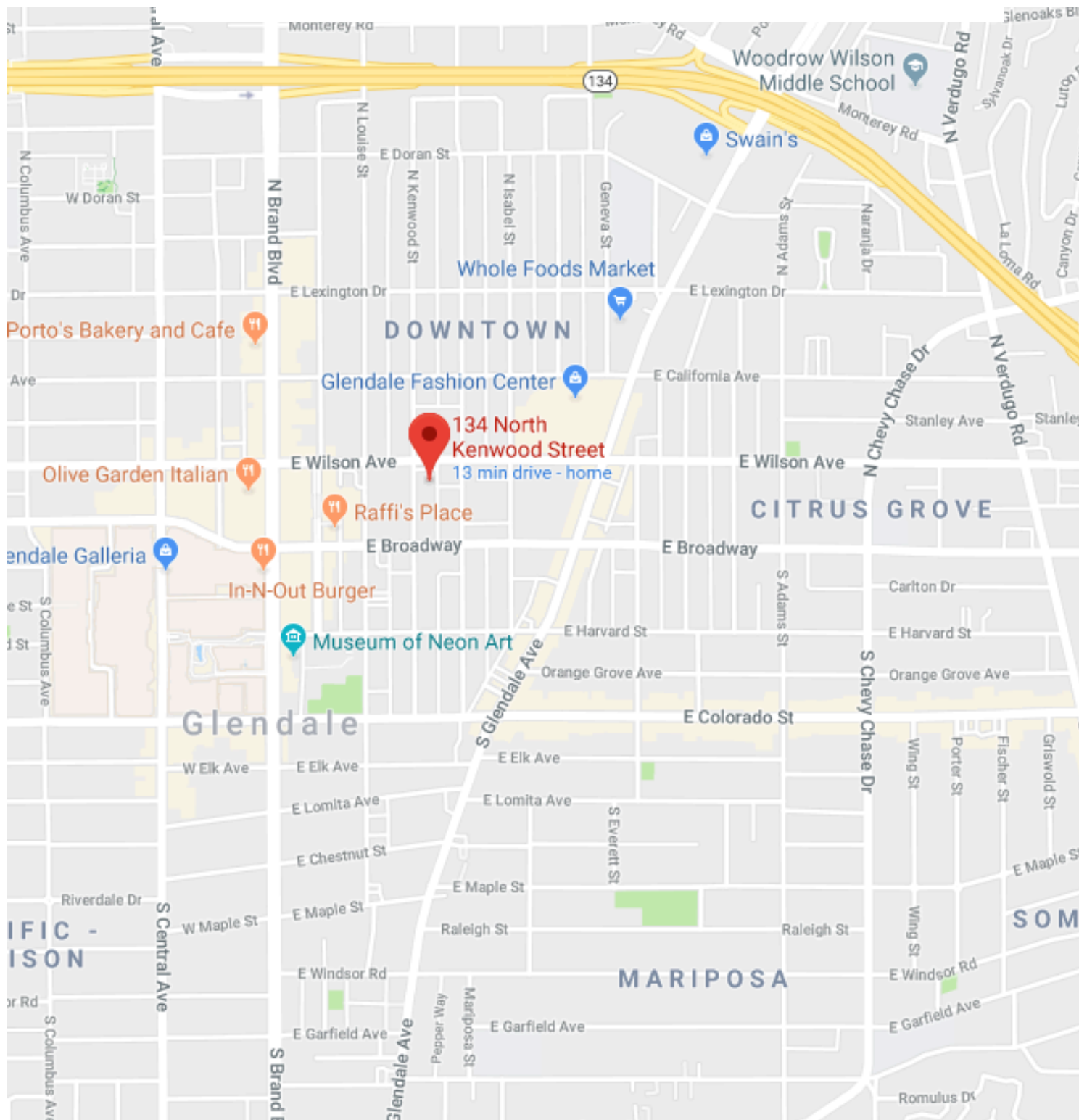
