

May 19, 2018, Southern California World Service Assembly

Welcome/Chair Donna E.-Recognition of New GRs and Past Delegates (Kate D. Panel 40; Willie W. Panel 37; Jayme C. Panel 52).

Donna went over KBDM Guidelines, and who has a voice and vote. Donna will be official timer. 2 minutes at the mic for questions or comments.

Traditions read by?

Evaluation forms have been provided. Please complete the form and turn it in when you leave.

Jayme, Group Records Coordinator. Jayme C. is substituting for Mary M., as Group Records Coordinator

Roll call was conducted in conjunction with clicker count by District. Absent are Laura H., AAPP; Gerald W., AASC; Mary M., GRC; Eugene C., (resigned), Bulletin Coordinator; Ben P., Webmaster; Nicole S., LA County AIS; Kathy G., San Diego County AIS; Gaby I., Spanish Intergroup Liaison; Steve F., AFG Convention Chair. Count of eligible voters (GRs) = 174.

Tarisa R., Treasurer (Read Report in Bulletin)

Treasurer reviewed Year-to-Date Financials which were approved. Yearly Audit was presented with one item of note: some Board member's expenses were not submitted until after the end of the 2017 fiscal year. \$9,000 did not get recorded and paid until the 2018 fiscal year. This effected the year-end financial statement and shows a loss for the first quarter of 2018.

Tarisa reported that the expense reimbursement procedures were discussed at the last SCWS Board meeting and measures are now in place rectify this. All expense receipts will be turned in no later than 60 days after the expenditure or by December 31 of each year.

Tarisa proposed that we not contribute to WSO at this time, but consider a contribution at the November Assembly, if we have excess funds at that time.

Questions and discussion

- Q. Ivette, D24 Is the yearly audit done by an outside company?
- A. Tarisa The audit is performed by Al-Anon members and the full report will be in the *Bulletin*.
- Q. John, D21 Balance sheet shows the Clicker purchase paid over a two-year period as an asset. Shouldn't it be a liability?
- A. Tarisa Yes. Will change the spreadsheet to reflect this.
- Q. Joyce, D69 The cost for insurance is way too high for

- SCWS. Compared to California North, which includes certificate of insurance to group events, we are over-paying. We need to look at other insurance companies and add the certificate of insurance for groups.
- A. Donna E., Chair We will look into this.
- Q. Tracy, D9 Why is there an increase of \$4,000 for literature purchased?
- A. Tarisa Our Public Outreach program is expanding this year and additional materials were needed.

Eva B., Alternate Delegate (Read report in Bulletin)

Eva passed around the *Forum* subscription can and the Ask-It Basket. She also asked that anyone having questions for our guest, Sue P., World Service Office (WSO) Administrator of Group Services, be placed in the separate container that will be passed around the room. These questions will be answered by Sue after the Assembly.

Marcia M., Delegate (Read report in Bulletin)

Marcia gave an overview of her experience at the World Service Conference and her trip to Stepping Stones. Her entire presentation can be found on the SCWS website. Skit – De Bono's Six Thinking Hats (not to replace KBDM, but to facilitate it).

Sue P., WSO Administrator, Group Services

Marcia M. advised that Sue will be staying after the Assembly and all are invited to meet with her in Carlson Hall. Sue will share her experience, strength and hope. Fill out an index card with any question you would like Sue to answer and she will get to as many as possible during that time.

Sue went over the new WSO website in detail:

- 1. How to register for the International Convention in Baltimore
- 2. Accessible in English, French, and Spanish
- 3. Newcomer tab
- Al-Anon Meeting anywhere in the country, just enter a city and state in the Search window
- 5. Alateen meetings online, and via Skype, chat and by phone
- 6. Prompts to edit incorrect Al-Anon meeting information
- 7. Find your Al-Anon Group's WSO identification number online. Donna submitted this idea via email and it was posted on the WSO website within a week.
- 8. Members Tab includes resources, *Service Manual*, Guidelines, the 2003 Alateen Motion, literature, Public Outreach materials and posters, and letters from the Chairman of the Board.
- 9. Event Calendar
- 10. Online store with credit cards and PayPal as methods of payment.
- Q. Jayme C. There are 13 Conventions in SCWS, but only 3 are recognized by the Area. Can all Conventions be posted on the WSO Calendar?
- A. Sue Only those recognized by the Area.
- Q. What type of security is in place for the WSO website?

- A. Sue If the URL for a website begins with https://, then this is a secure website.
- Q. Can any of the information in the website be altered by an outside agency or person?

A. Sue – No

Concepts read by Allen, D75

Task Force Updates - Donna, Chair

D64 Task Force - Donna E., Chair, advised the D64 Task Force is on hold and she will be contacting them in a couple of weeks to evaluate the status of their progress toward completing their charge.

Alateen Resolution Committee is on hold until the Area Alateen Task Force has presented their recommendations to the Assembly today.

AMIAS Background Check Committee – Tarisa R., Christy R., and Gerry "Bear" W. are on the Task Force team and will be presenting their findings today. Bear is out of the country and Christy has laryngitis. Tarisa R. and Jim B. presented the Committee's recommendations. The complete presentation will be on the Area website.

The Team compared Trak-1 with Live Scan and analyzed each program's level of security and the financial impact to the Area. The Team suggested the following:

- 1. Continue to use Trak-1
- 2. AMIAS Applications to be kept in a locked cabinet by AAPP
- 3. AMIAS Applications to be shredded by AAPP when they are no longer certified by SCWS
- 4. Form Two will be replaced with the Trak-1 online application, including the applicant's Social Security Number (SSN). AMIAS applicants will fill out the Trak-1 application directly on the Trak-1 website.
- 5. Certified AMIAS to be rescreened every 5 years.

Questions:

- Q. Casey, D27 If we shred documents, are we destroying legal documents that have to be retained?
- A. Tarisa No. Only the paper document gets shredded. The electronic version remains.
- Q. Tina, D21 What would be the cost increase to the Area?
- A. Tarisa Around \$2,000 per year increase over our current cost which would include the 5 year recertification background check.
- A. Christy There would be an additional one-time cost of approximately \$3,800 to cover the cost of researching the AMIASs who-have not been recertified in the past 5 years, and to cover the AMIASs who are currently certified without a SSN.
- Q. Linda Are paper documents being held today?

 A. Tarisa Yes, by the AAPP. Only current AMIAS documents

- will be retained and all non-current AMIAS documents will be shredded.
- Q. What about the AMIASs that were certified under Megan's Law? Will they need to be recertified?
- A. Tarisa Yes
- Q. Vicki, D72 If I have been certified with a SSN, do I need to get recertified?
- A. Tarisa No, unless it was more than 5 years ago.
- Q. Layla Many Al-Anon members in the Spanish community do not have a SSN. Therefore, they cannot be an AMIAS.
- A. Christy There are only a few Spanish AMIASs in our Area
- A. Tarisa The majority of AMIAS in D64 did provide their SSN so this policy may affect only a few current AMIASs.
- Q. Rose, D6 Why recertification every 5 years instead of every year?
- A. Tarisa The Team checked with multiple background check companies and most organizations conduct a recertification every 3 to 5 years depending on the level of security needed to meet their requirements.
- Q. Could the AMIAS pay for the cost of certification?
- A. Christy We do not want members to have to pay to volunteer their services.
- Q. Layla Was there an event that created this issue?
- A. Tarisa We needed to assure that our Insurance requirements are met.
- A. Donna We need to assure that the requirements in our ASBRs are met and that the 2013 Assembly Motion to enhance our background security measures are met.
- Q. Sylvya, D60 Can a hard copy of Form 2 be submitted instead of the online version?
- A. Tarisa Yes, the AAPP could accept a hard copy and then input the information online. At that time the hard copy would be shredded.
- Q. How do we check on those with emotional problems?
- A. Donna Prospective AMIASs have to been in Al-Anon for at least 2 years and another member of Al-Anon who knows them has to vouch for them. This could be the DR, DAL or they could ask for a referral.
- Q. Laura, D42 What if someone had an arrest record. Would that disqualify them from being an AMIAS?
- A. Tarisa Only those Al-Anon members who have been convicted of a Felony, charged with child abuse or inappropriate sexual behavior, or have demonstrated emotion problems are disqualified from being an AMIAS.

Comments:

- Comm. Kay I am one of the first people in SCWS to be certified as an AMIAS and I have never been rescreened.

 We need to make this happen.
- Comm. Casey, D27 If someone has emotional problems, it will show up on their record if severe.
- Comm. Amy, D6 5 years is too long between recertification.

Would like to see it happen every 3 years.

- Comm. Andy, D24 Agrees that an AMIAS should be required to submit their SSN and is comfortable with the proposed means of protecting an AMIAS's SSN.
- Comm. Laura, D69 Maybe we should eliminate the hard copy application and go to paperless, unless there is a legal issue with paperless documents.

Donna – Called for the vote. Jayme conducted the roll call. 170 voting members. Two-thirds majority ("substantial unanimity") required to pass.

Motion to approve the 5 measurers was made by Chris, D40, and seconded by Yvette, D24.

Motion passed: 135 = Yes, 11 = No, 5 = Abstained.

Area Alateen Task Force (AATF)

Suzanne P., AATF Chair, introduced the AATF members; Stefanie, Jim, Rob, Micheila, Jan, Sandy and Bear (who was not present). The entire presentation can be found on the Area's website.

Suzanne, Chair – The 8-member Task Force has been meeting since December, 2017. The AATF focused on the recommendations that were presented at the November 2017 Assembly. Procedural items that were discussed and/or will be implemented are:

- Strengthen and clarify the Area Safety and Behavioral Requirements (ASBR) to clarify that the ASBRs are requirements and not suggestions.
- 2. Alateen is part of Al-Anon
- 3. Training for DRs, DALs and AIS Liaisons
- 4. Revise the AMIAS Training modules
- 5. Better overall support and communication with all DRs, DALs and AIS Liaisons including quarterly meetings and an Area Newsletter.
- 6. Improve record-keeping within the Area, Districts, and groups which includes the new Alateen Meeting Information and Behavioral Requirements (AMIBR) form.
- 7. Addition of two new Alateen Coordinator positions.

The AATF will be recommending three policy changes that require approval from the members. They are:

- The age limit for Alateen membership be lowered from 21 to 19; that is, Alateens will "age out" on their 19th birthday.
- 2. Alateen Members will not vote on safety and policy matters except as a GR at Assembly.
- All Alateen meetings will require two AMIAS to be present.

Age out of Alateen at 19

Questions:

Q. Leala, Alateen GR – Are there any Alateens on the AATF?A. Donna, Chair – There are no Alateens on the AATF, but an Alateen Council was formed to provide input. All safety and

- security issues regarding Alateen are to be made by supervising adults.
- Q. Leala, Alateen GR Why can't Alateens who are legal adults be part of the AATF?
- A. Donna, Chair Alateens, no matter what their age, have to follow the ASBRs. Alateens who are legal adults agree to abide by the same requirements as minor Alateens. Alateens can, however, vote on procedures for meetings and conventions.
- Q. Nicole In California, the legal age is 18. If an Alateen is over 18, they are an adult. Wouldn't they need a background check to attend an Alateen meeting?
- A. Donna, Chair Good question. That will be brought up for further discussion.
- Q. Casey –Clarify the age limit to be 19.
- A. Donna, Chair On the day of their 19th birthday, they will age out of Alateen.
- Q. Laura, D60 I know three Alateens that are 20 years old. One is okay with attending Al-Anon, the other two are not and do not want to go.
- A. Rob, AATF Have them contact their AIS Liaison to help them find a Young at Heart Al-Anon meeting in their Area. The solution is out there.
- A. Micheila, AATF Our Service Manual encourages older Alateens to start attending Al-Anon meetings before they age out of Alateen.
- Q. Kathy, D66 Maybe work towards transitioning into Al-Anon with some sort of graduation.
- A. Donna, Chair We should look at creating a path for transition. All Alateens are Al-Anon. Let us look at changing the policy first.
- Q. Silvia, D33 Is there any reason to choose 19 as the age limit. Why not 18?
- A. Donna, Chair This is the AATF's recommendation, after considering all of the possibilities.
- Q. Maturity is not based on age. Schools have students of different ages in their classrooms and some are not as mature.
- A. (No answer needed.)
- Q. Rich, D27 What are the liability concerns if a legal adult does not follow the ASBRs?
- A. Donna, Chair Alateens, whether a legal adult or a minor, must follow the ASBRs. They are supervised at all times and it is the AMIAS's role to insure that all Alateens follow the ASBRs.
- Q. Kat, Alateen GR We need to show love and respect, but it's okay to disagree. We should not force anyone to join Al-Anon just because of their age. I am the Area Alateen Member Coordinator and will not be able to stay in that service position if the age is dropped to 19.
- A. Suzanne, AATF I am not comfortable with 19 and 20-year -olds in meetings with my 11 and 12 year-old grandchildren.

Comments:

- Comm. Tina, D17 We voted at the November Assembly to create a Task Force and to move forward. We need to trust their judgment. There has been trouble in the past with older Alateens.
- Comm. Lorraine, D69 I feel unprepared to vote today. Need to vote to see if we are ready to vote.
- Comm. Sue, AATF Remember Alateen is Al-Anon. You as a GR are here to vote on behalf of your group. We have worked diligently and put in many hours gathering the information that we can make a solid recommendation to this Assembly.

Donna, Chair – Let's take a vote to see if we are ready to vote on the maximum to change from 21 to 19 in Alateen. This will be a simple majority, not 2/3.

Motion to vote on age limit: 92-Yes; 41-No; 4-Abstained. Motion passed.

GRC, Jayme conducted roll call. Total of 144 voting. 2/3 = 96 to pass

Motion to age out of Alateen on their 19th birthday effective January 1, 2019 passed.

111 = Yes; 25 = No; 8 = Abstained

Alateen Members will not vote on Area Policies regarding safety and behavioral requirements (except as GRs at Assembly):

Donna, Chair – clarified this by restating that adult Al-Anons are ultimately responsible for the safety and welfare of Alateen children. An Alateen may be on a Committee, with a voice on programming issues and procedures, but children will not have a vote on safety and behavior issues (except as a GR at Assembly).

At least two Certified Alateen Group Sponsors (AMIASs) at every Alateen Meeting

Questions:

- Q. Kim, D24 Are they required to get a substitute if they cannot make their meeting?
- A. Micheila, AATF Yes. Someone will need to arrange for a substitute, otherwise, they cannot hold a meeting. There must be two AMIASs present at all times.
- A. Stefanie, AATF We had to close an Alateen meeting due to the absence of an AMIAS willing to take on the task. It did re -open later when someone saw a need to be that Alateen Group Sponsor.
- Q. Andy, D24 What if the AMIAS is running late? Can the meeting still happen?
- A. Suzanne, AATF It is our duty to see that we have two AMIASs for that meeting. If not, there cannot be a meeting.

Comments:

Comm. If there are not two AMIAS, the Alateens can go to the Al-Anon Meeting if there is one at the same time.

- Comm. Linda, D40 There have to be more guidelines put in place.
- Comm. We are coming from a loving and caring place. We all care about the safety of our Alateens.
- Comm. Bruce It seems that when critical comments are made, there is always a response to that comment. Haven't heard any responses to positive comments.

Donna, Chair - Call for the vote.

Motion to approve that at every Alateen meeting, there must be two certified Alateen Sponsors. Motion offered by Elaine, D75, and seconded by Margaret, D21.

Motion Passed by show of hands: 144 total vote count prior to vote. Yes vote = 120; No votes = 16; Abstained = 4

Young at Heart Al-Anon Convention: (see handout)

Rob, Jesse, Evan and Jasmine gave a presentation on their request to hold a 1-day Young at Heart Al-Anon (YHA) event.

Rob, YHA – Al-Anon meetings which focus on the concerns of younger members are currently held within various districts throughout SCWS. We would like to hold a 1-day event encompassing these meetings from around the entire Area. Therefore, we are asking to have this event recognized as an SCWS Al-Anon Convention.

Although the event will be geared to younger members of Al-Anon, all Al-Anon members, no matter what their age, will be welcome.

Donna, Chair – There would be no financial impact to our Area. The YHA Convention Chairperson would have a voice and a vote at the Committee meeting. If the GRs vote "yes," we would try this for a three-year trial period.

Questions:

- Q. When would you age out at the YHA Conference?
- A. Rob, YHA Everyone is welcome, no matter what their age.
- Q. Kaleah- Have you thought about Alateens attending this convention and just being dropped off without a guardian?
- A. Any and all Alateens at this Conference will abide by the Al-Anon event guidelines for Alateens.
- Q. Jida, D9 Is there a minimum age for this event?
- A. Same requirements as at any Al-Anon Convention.
- Q. Laura –How are you going to manage the cost associated to the Convention?
- A. If we are recognized by the Area as an Al-Anon convention, we can then seek funds and support from Al-Anon members throughout the Area.

Comments:

Comm. Nicole, Los Angeles AIS Liaison – It is important to support all branches of Al-Anon. Will donate to this Convention.

Comm. Bruce, D27 – The KBDM process is supposed to point out the cons as well as the positives. If someone chooses to donate to this Convention, they may decide to not give to one they have donated to previously. I will vote in favor of this Convention.

Comm. Laura, D42 – Very inspiring that you are the first to take on this type of event.

Comm. I don't see that there is a need for this separation in Al-Anon.

Motion to recognized the YHA Convention by SCWS on a three-year trial made by Marley and seconded by?

GRC, Jayme conducted a Roll Call. 96 voting members. 88-Yes; 4-No; 4-Abstained. Motion Passed.

Officer Reports

Delegate

First, I want to thank you for allowing me the opportunity to represent you as your Southern California Area Delegate to the World Service Conference held in West Harrison, New York, April 16-20, 2018. This was an incredible experience for me and I'm extremely grateful that I could attend. Your love and support before, during, and after this intense week meant everything to me. Thank you! I'm going to take the PowerPoint information that I presented at the Assembly, as well as additional material I received at the Conference, and attempt to condense it into this report.

Before I gave my primary World Service Conference (WSC) report at the Assembly, I created a condensed PowerPoint presentation that highlighted my experiences while visiting Stepping Stones, the Historic home of Bill and Lois Wilson. The A.A. tour guides were extremely well-informed and entertaining. You could hear the love they had for Bill and Lois and the A.A./ Al-Anon program! The privilege of visiting Stepping Stones with my fellow WSC members will be one that I fondly remember and cherish forever! If you are interested in learning more about Stepping Stones, there are great descriptions in Chapter 13 of *Lois Remembers* (B-7). There are also more details and pictures, as well as the ability to hear recordings of Lois and Bill speaking found at the Stepping Stones website, steppingstones.org My Assembly PDF presentation is on our SCWS website, scws-al-anon.org

The first World Service Conference (WSC) was held in April

1961 in New York City to coincide with the A.A. Conference. It is Al-Anon's largest group conscience, providing guidance to Al-Anon's Board of Trustees and the World Service Office (WSO). The WSC includes Delegates, Board of Trustees, Executive Committee members and some WSO staff members. This year International Representatives from Denmark and Mexico attended as observers. There were 92 voting members at this year's Conference.

The World Service Delegates are the primary communication link between the Al-Anon/Alateen groups in their Area and the WSO. They bring the perspectives of the Al-Anon/Alateen members in their Area to the WSC, and return with current information about WSO financial and policy reports, new/proposed Conference Approved Literature (CAL), implementation of new technology, Committee/Work Group/Thought or Task Force updates/recommendations and much more.

The new Panel 58 Delegates were given special orientation time together the first morning. Some of the feelings expressed by us were: "What am I doing here? I'm not good enough to be here!", "I might embarrass myself by saying something stupid!", "I'm worried I'll forget everything I know about Al-Anon", and "I'm not ready for this position." During the Orientation we had a great discussion about the differences between Al-Anon Family Groups—The Fellowship, and Al-Anon Family Group Headquarters, Inc.— The Organization. (The PDF copy given out at the May Assembly is on our SCWS website.) We discussed the different perspective each of the members bring while attending the WSC. It was fun to share information regarding our own Areas and how Areas conduct their Assemblies. One example: some Areas have 2-3 days for their Assembly, 2-3 times/year, and use this extra time for speakers, workshops, sharing a meal and more thorough new GR /DR orientations.

During the Conference the WSO Board of Trustees shared with us the "De Bono's Six Thinking Hats" approach while we discussed issues relating to translation of Conference Approved Literature. This strategy was introduced as another method to facilitate discussion, to work with KBDM, but not meant to replace KBDM. (The De Bono's Six Thinking Hats PDF and the script for the fun skit are on our SCWS website.)

This was the first year that first-time Delegates could submit a **Chosen Agenda Item (CAI)** topic. The purpose of the CAIs is to give Conference members an opportunity to select ideas and issues of concern that affect AI-Anon groups and members worldwide. We were asked to consider: Does the topic merit an in-depth discussion that could benefit AI-Anon groups and members worldwide? Is the topic somehow related to the 2018 Conference theme? "AI-Anon—There Is No Standing Still". Topics were submitted, compiled, fact-checked and combined with similar topics. There were 16 CAIs and the Conference members voted for their top five. Some of the CAIs were discussed in small breakout groups, and warranted full Conference discussion.

The topics were right on target for our Area and our members. Below are a few of the comments/ideas generated by Conference members for each topic.

CAI #1: Service Beyond the Group Level: Help younger Al-Anon members step into more Service; Connect DRS thru web meetings to provide more training, share information, brainstorming sessions; Service is attraction, we can demonstrate enthusiasm, be Service Sponsors, share service positions.; Have more discussions of the Links of Service (S-18) because members may not be aware of what's happening beyond their group.; Do an individual inventory on service for a group activity (such as the Service Journey Worksheet we did in our area).

CAI #2: Public Awareness: Our membership is aging. We need to attract younger members.; Connect with health fairs and health-related professionals.; Connect with emergency personnel. Provide Al-Anon "referral forms," easy to grab District/ Area Al-Anon business cards, outreach bookmarks.

CAI #3: Our Primary Purpose & Group Autonomy: A healthy Group centers on education. Open discussion, "reason things out" at District meetings. GRs bring Group's successes and concerns to District meetings; Autonomy can be misused, it shouldn't compromise our Principles; Let's not act out of fear, but act from our Principles; Encourage Group Inventories and empower Group members to speak up.

CAI #9: Reaching out to Groups in Rural America: Establish a "link" with the CMA and/or GR of rural meetings, especially if there is District Representative; Area members personally connect to these meetings and make sure the Group records are accurate; Use technology, conference calls, and "GoToMeeting" to provide info and have "virtual meetings"; Develop pamphlet that addresses rural meeting issues and add a feature sharing in The Forum about rural meetings and virtual meetings.

Education is the key. We have literatures that speaks to this issue. The Al-Anon Focus (P-45), Al-Anon Spoken Here (P-53), Cooperation Between Al-Anon and A.A. (G-3) and our 2018--to-one basis; At the Group level, make sure it's clear what

2021 Service Manual (pg. 86); We are all guardians of the legacies. We don't need to search for problems, but deal with them as they arise. Avoid controversy by approaching on a one positions Al-Anon members who are also members of A.A. can hold in the Group, and outside of the Group as an AMIAS. Bill Wilson spoke of problems that can arise by having A.A. members involved in Al-Anon service beyond the Group level. (Many Voices, pg. 184-185).

Being a Trustee

There were several short presentations throughout the World Service Conference that provided enlightening information about Being a Trustee, such as, "The Resume Form/Interview Process, "Trustee Travel," "Mentorship/Roommates," "Time Management" and "Having Different Roles—Including Legal Authority and Accountability." For more details, please see the 2018 World Service Conference Summary that will be posted

on the WSO website. NOTE: This information was not presented during the May Assembly due to time constraints. Our Area hosted the *Together Empowering Al-Anon/Alateen* Members (TEAM) event in September 2016 at which information about what Trustees do and how Trustees are elected and appointed was presented.

WSO Thought Force/Task Force/Work Group/Committee/ **Workshop Presentations:**

One of my favorite presentations was "Celebrating our Differences and Our Common Purposes."

This was first presented at the 2016 World Service Conference and was titled "Acceptance of Communities, Cultures and Beliefs." As a result of these presentations, Conference members requested additional ways to identify the spiritual principles that can be applied when looking at how our own biases limit our ability to accept and welcome all potential and current members, families and friends of alcoholics. This year the presentation included a fun skit, a PowerPoint presentation, and an Inventory exercise called "Facing our Biases." (PDF Copy is on SCWS website). The "Inventory" was especially eye-opening to many of us!

Reserve Fund Workshop

The World Service Office (WSO) has received questions from members related to the establishment, use, balance and investing of Area reserve funds. Even with existing resources (Reserve Fund Guideline, G-41, 2018-2021 Service Manual, P-24/27, the Legacies) questions remain about an appropriate amount, use and management of finances. There are also concerns about whether an Area's reserve fund is keeping with the spiritual principles found in the legacies. "Reserve Fund" was defined as any funds equal to six-months to a year of operating expenses, such as maintaining a significant minimum checking balance, "seed money," line item allocations in the budget, etc. During the workshop we discussed the purpose of a Reserve Fund (Current Service Manual, p. 214), then followed up with questions: 1. In what ways is our money essentially held in reserve? 2. When does a Reserve Fund become excessive? 3. Why is having an ample Reserve Fund considered a prudent financial principle? 4. Why was our Area Reserve Fund established? 5. What is/are the Area's current goals for the Reserve Fund? 6. How have Area Reserve Funds been utilized in the past? 7. How can we approach our Area's financial needs from a spiritual basis, stepping away from fear, practicing prudence, gratitude, generosity, etc.? Although the Reserve Fund Workshop was designed for Areas, we can easily substitute the words "District" or "Group" to make the discussion more relevant for ourselves.

Virtual Meetings Thought Force

This was an extremely informative presentation covering many types of "Virtual Meetings." Electronic meetings are not in competition with face-to-face meetings, they can supplement them. Al-Anon electronic meetings use different online platforms: discussion boards, email, chat, phone and Voice over Internet Protocol (VoIP), such as Skype. Each meeting is

autonomous in its style, format, and "entry procedures" (methods for accessing and joining the meeting). Like all Al-Anon meetings, participants agree to abide by the spirit of the Twelve Traditions. Meetings focus on Al-Anon-related topics, and participants are required to maintain their personal anonymity. Pictures of Al-Anon members and other personally identifying information are not posted in the meetings. Some participants may have email addresses specifically for the online Al-Anon meeting whereas some members use pseudonyms. Each meeting may have its own entry procedures. Some online meetings have an email contact where a "greeter" will provide the newcomer with specific directions to access the meeting. Meetings that don't list a specific meeting time are held 24/7. In 2001, the WSO started registering online meetings, and in 2007, added phone and other electronic meetings. Electronic meetings offered Al-Anon members a means of connecting and sharing the Al-Anon program regardless of location. By 2018 there were over 25,000 groups in 133 countries and 107 electronic (digital, social media and phone) meetings.

To find electronic/virtual (EVM) meetings—go to the Al-Anon website, under the "Find a Meeting" tab/Virtual Meetings. The internet and other electronic telecommunications media are tools for carrying and sharing our Al-Anon program of hope and recovery around the world. These electronic meetings occur globally as well as locally without geographic restrictions. Consequently, electronic meetings don't have a Group Representative and are not a part of any structure. They do, however, have a meeting contact. When electronic meetings form, they register with the World Service Office (WSO) in order to use the Al-Anon name. Upon registration, they receive support from and have their voices heard and represented through the WSO. Registered meetings may request a license from the WSO to use in text format the Steps, Traditions, Concepts of Service, Suggested Welcome, Suggested Closing and excerpts from Conference Approved Literature (CAL). The Virtual Meetings Thought Force presented other information comparing virtual meetings to face-to-face meetings, noting how they are the same and different, their advantages and disadvantages, and more questions to investigate in the future. This was just a beginning to the discussion. NOTE: This information was not presented during the May Assembly due to time constraints.

Literature Committee Discussion: "Just for Tonight" bookmark

During August and September of 2016, the World Service Office (WSO) received three written requests (as well as several phone calls) suggesting the WSO produce a new bookmark using the "Just for Tonight" article from the August 2016 issue of *The Forum*. Each member making the request described the article as very powerful, and that it could be a wonderful companion piece to the *Just For Today* bookmark (M-12). The WSO Literature Committee agreed that further discussion was needed and completed the five Knowledge-Based Decision-Making (KBDM) questions on this topic. They presented their findings to the WSC. We all had a chance to participate in the WSC discussion to share our opinions, pro and con. The biggest hurdle was in understanding that we were approving the "concept" where-

as the exact type of CAL (bookmark, wallet card) and the specific wording would be up to the Literature Committee. A Motion followed, "That the 2018 World Service Conference give conceptual approval to develop a bookmark based on an August 2016 *Forum* article titled "Just for Tonight" using inclusive language. (The motion carried!)

New Conference Approved Literature (CAL)

Conference Approved Literature (CAL) are books, pamphlets and service tools conceptually approved by the World Service Conference (WSC) and written by and for Al-Anon and Alateen members. Once developed, this material undergoes a rigorous process of review established by the WSC to assure it is identifiably Al-Anon in content and feeling, and consistently reflects Al-Anon's principles. CAL is identifiable by the CAL seal. (2018-2021 Al-Anon/Alateen Service Manual, pg. 76) There were three new pieces of CAL shared with the World Service Conference. Hope & Understanding for Parents & Grandparents

(P-94) is available in English, Spanish and French. *Intimacy in Alcoholic Relationships: A Collection of Al-Anon Personal Stories* (B-33) will be introduced in English at the Al-Anon International Convention in July for \$11.00 each. French and Spanish translations are expected to be ready for shipping by February 2019. *Fiftieth Anniversary Edition of One Day at a Time in Al-Anon* (B-6-50) will be available at the International Convention in July in English, French and Spanish for \$15.00 each. This limited edition is in celebration of this classic book's 50 years. The text of the book remains the same in this special souvenir edition that has a special anniversary cover, ribbon and commemorative bookplate. Any books remaining after the Convention will be sold while supplies last.

Executive Committee for Real Property Management (ECRMP)

In 1994, the World Service Conference passed Motion #12, which allowed the Board of Trustees to purchase property for Al-Anon Family Group Headquarters, Inc. This purchase of real property was for a trial period of fifteen years and contingent on several conditions. In 2011 the World Service Conference passed Motion #6, which ended the fifteenyear trial period and authorized the Board of Trustees to continue to own the current or subsequent property in the name of Al-Anon Family Group Headquarters, Inc. The ownership of property is contingent on conditions enumerated in Motion #6. One condition set forth in the 1994 Motion #12 and the 2011 Motion #6 was that the Board of Trustees "establish a separate Executive Committee for Real Property Management in order to ensure that the management of the real property be done in a prudent manner and not interfere with the day-to-day operations of the spiritual parts of the program, i.e., service to the groups, individuals, or Al-Anon as a whole." To fulfill that condition, a motion to create the Executive Committee for Real Property Management (ECRPM) was approved by the WSC in 1995. The Bylaws were amended in January 2012 to include the Executive Committee for Real Property

Management and the Amendment was presented to the 2012 Conference. The separate Executive Committee was preferred for its simplicity and the fact that it would eliminate the need to file additional forms annually with the Internal Revenue Service. This Committee was established to oversee the management of real property in order to separate property maintenance and management from the day-to-day operation of the Al-Anon fellowship. The Committee consists of three at-large Al-Anon members, the Chairperson of the Finance Committee, and the Director of Business Services. The Committee first met June 15, 1996 and has met twice a year since then. The 2018 ECRPM Chairperson reported "that ownership of property has been a very good step financially. A savings of approximately \$446,000 this year has been realized by owning property vs. leasing it in Virginia." "After reviewing the last 18 years of real property ownership, the Board of Trustees has no negative impact to report." "The ECRPM is a Committee separate from all other committees. It operates separately from the work and business of the World Service Office, allowing the WSO to focus on the primary spiritual aim of the fellowship." (NOTE: This information was not presented during the May Assembly due to time constraints.)

World Service Office 2017 Annual Audit

The Audit was conducted by Dixon Huges Goodman, LLP Audit Firm from January 22-26, 2018. When I looked at the Audit report, I was reminded that Al-Anon Family Groups Headquarters Inc. is a very large Non-Profit Corporation. This is what I call the "business end" of our Fellowship. In my mind I thought of a large organization such as the Boy Scouts of America. (I took a glance on line at their audit reports, etc. and there are many similarities.) The complete 2017 WSO Audit report is very long and complicated. Following is some of the information from the Audit report that I shared at our Assembly.

Revenue: The 2017 contributions reflected our second highest year of contributions. Literature sales reflected an increase of \$186,192 from 2016. *Expenses*: Actual operating expenses were \$5,276,835 for the year compared to \$5,143,217 in 2016 and slightly over budget. There were no surprises in any of the expense categories. Intense scrutiny of the expenditures throughout the year ensured that we would end the year close to budget. *Outlook:* Although we fell short of our budgeted amount for contributions, literature sales were unexpectedly strong and allowed us to end with a relatively small deficit.

Contributions from California South to WSO: The total contribution from Groups was \$114,612 (\$13,000 less than 2016). "Other Contributions" refer to individuals, AISs, and Area meetings. Total for "other" was \$102,831 (\$5,300 more than 2016). By the way, the average amount that WSO spends on each AI-Anon group is \$283 per group per year. Some AI-Anon/Alateen members are very interested in reading AI-Anon's WSO finances in detail. AFG Financial information can be found on the website at al-anon.org by navigating to Members/WSO/Financial Information. In the U.S. our WSO is a 501 (c) (3) non-profit corporation. In Canada it is a 149 (1) registered charity. The 990 tax form is a long form for U.S. non-profits. If you like reading pages of detailed tax returns, this is

the place to look! It includes the salary and benefit information for some of the Directors at AFG, Inc. Typically the last two years' Audits are posted on the website. Currently the Audit Reports from 2014, 2015 and 2016 are posted. 2017 will be posted soon.

Al-Anon Family Group Headquarters, Inc., 2018 Operating Budget

The 2018 Budget is the financial plan for AFG Inc. which has been approved by the Board of Trustees. One of the Conference presenters said, "Budgets are a good guess." They take a look at their Revenue and Expenses from the previous year and try to predict what might be happening this year. The 2018 Expenses are predicted to increase by approximately 5%. This is partly due to WSO being fully staffed, holding the World Service Conference in New York this year, moving forward with technology, adding an additional Public Service Announcement (PSA), and additional visits/outreach to Areas.

NOTE: Some of the financial charts shared with the Conference members were contained in the Delegate's Power Point. For more information please look at the Delegate's Report PDF on our SCWS website.)

Every quarter, the Treasurer includes a 'Finance Update' along the Chairman of the Board Letter. As of April, contributions are \$53,000 above budgeted projections. The Board is projecting that our literature sales will be strong this year, due to the introduction of new literature in April and July. *The Forum* subscriptions are being monitored to determine the effects of publishing in full color, which began in January of this year.

Regarding contributions, our WSO Treasurer stated that "We trust that members understand the need and will continue to support the efforts of the World Service Office."

There was much more information presented at the World Service Conference than I was able to cover in this report. I encourage you to read the 2018 World Service Conference Summary that will be posted on the WSO website, or order it for yourself (\$5), for your group, your District, or your "Al-Abuddies."

Thank you again for your support before, during and after the World Service Conference. It truly is an honor to be your Delegate!

Ask-it-Basket

1. Question: How can So-Cal members get The Board of Trustees to realize the need for help in protecting the Al-Anon Alateen name from those we do not consider Al-Anon as a whole? We don't think you hear us.

Answer: This topic has been discussed at the World Service Conference. In response to those discussions, several Areas (in addition to Southern California) have developed their own policies for resolving group and member concerns: Ohio, Missouri, Virginia, Tennessee, Idaho and New York South.

As more Areas create and adopt their own policies, there may be more discussion at the World Service level. Members are always encouraged to send their questions/concerns to the World Service Office at:

2. Question: How often does Al-Anon have an outside audit done? I noticed the audit done was done by 2 members of Al-Anon instead of someone independent of Al-Anon.

Answer: SCWS financial records conform to the General Accepted Accounting Principles and conducts yearly reviews of its financials by two experienced and knowledgeable members. (SCWS Bylaws, Article XI, Section 3, Item C. The Audit Committee to consist of two Area members who are not currently on the SCWS Board). The process consists of: checking for internal controls, sample testing of transactions and cash to cash reconciliation. The organization's yearly gross revenue is less than \$2M, therefore it is typically not subject to an independent audit by a CPA, per California statutes.

3. Question: How to address members who change God from "he" to "she," or another word, when reading the Steps?

Answer: Our 2018-2021 Al-Anon/Alateen Service Manual states the following: "No changes are to be made in the Al-Anon or Alateen Traditions, the Steps, the Concepts of Service (except the descriptive text), or the General Warranties of the Conference Charter (Item 12) without written consent of three-quarters of the Al-Anon Family Groups" (pg. 226). In addition, in 1962 and 1965, the World Service Conference voted unanimously to recommend to groups the exclusive use of Al-Anon Conference Approved Literature. This encourages Al-Anon unity and assures that the Al-Anon message at our meetings is clear and consistent.

Our First Tradition explains "Our common welfare should come first; personal progress for the greatest number depends upon unity." Therefore, to avoid confusion and to promote unity in the world-wide fellowship of Al-Anon and Alateen, all members and groups are asked to respect and honor the Legacies as written. If a member changes the wording of the Steps when reading them aloud, the group's Secretary might read that paragraph in the Service Manual after the member is finished reading. This will both educates the group's members about Al-Anon/ Alateen policies and it does not single out a member individually.

4. Question: What happened with the District 64 Task Force? What decision was made or who is the contact? Will the district be divided according to geographical district, will it remain the same, or dissolve? We are a Spanish Group that currently belong to our geographic district. District 64 is inviting us to join but we are staying until we hear an update.

Answer: The Area Chair is tasked with evaluating the status

of Thought and Task Forces when there is a new SCWS panel. The District 64 Task Force members are in the process of completing Feedback and Evaluation Forms regarding their completion of the TF "charge." We're hoping to have completed the evaluation process and announce the next steps in the D64 Redistricting process at the November Assembly.

5. Question: How might we motivate, inspire or encourage members to participate more actively in service beyond the group level?

Answer: Service involves attraction, enthusiasm and mentoring. We can encourage members to do service at and beyond the group level in several ways:

- a. Lead a meeting on Service using CAL as the foundation (using the quotes similar to those below). Include in the discussion the various types of Service positions in the group, at the Area level, etc.
- b. Offer to share a service position in the group informally or as an alternate to one member having the sole responsibility for the position (as with Alternate Group Representative).
- c. Invite members to "get in the car" and be a visitor at a District meeting, a Sharing of Service (SOS) Workshop, or an Area Assembly.
- d. Explain what a "Service "Sponsor" is using the Service Sponsorship pamphlet (P-88) and encourage members to be a Service Sponsor and/or find a Service Sponsor.
- e. Invite your District Representative or another member who does service at the Area level to speak at your meeting.

"Carrying the message can take many forms, from giving encouragement to a newcomer to participating in service at any level from the group to the World Service level. Many members share that they always seem to get back far more than they give to Al-Anon." (*Paths To Recovery*, page 121)

"Service and recovery, then, are not independent of each other. Both are part of the spiritual awakening that continues to guide us. The more willing we become to practice all of this program, the more progress we can make in recovering from the effects of another's alcoholism and in living our lives more fully" (When I Got Busy I Got Better, page 2). Service is a vital component of our recovery.

6. Question: Can an Alternate Group Representative also serve as a Group Representative for another group as long as she doesn't vote twice in the Assembly?

Answer: Our current Service Manual it states the following:
No member may, however, be Group Representative (GR)
of more than one group at the same time." This is not
encouraged because it removes the possibility of another
member participating in service and can create confusion.
If the two meetings represented are in the same District,

the Alternate GR could be in the position of representing two groups (in the absence of the GR for which the member is the Alternate), which means the member would have to choose which group would have a vote and which group would *not* have a vote. The same holds true for the Assembly. Which group are they representing, which group are they voting for. The unintended consequence might be that one of the groups would not have a vote.

7a. Question: One meeting in a District has one member that does not feel anyone should contribute to SCWS or WSO.

Answer: "The right of appeal found in Concept Five reminds us that we need to listen with consideration to everyone and encourage those with differing opinions to state their views" (*Pathways to Recovery*, page 278). Tradition Two also states, "there is but one authority, a loving God as He may express Himself in our Group Conscience." Using Knowledge-Based Decision-Making (KBDM), the group's members determine the allocation and frequency of contributions to the different service arms.

Annually, Southern California World Service (SCWS) on behalf of its groups contributes to an equalized expense fund for sending Delegates to the World Service Conference (WSC). This yearly conference is a gathering for the worldwide group conscience which unifies our fellowship (*Pathways to Recovery*, p 195).

The World Service Office (WSO) is a clearing house, supports the Al-Anon nationally and internationally in reaching out to family and friends who have been affected by the disease. The fellowship is self-supporting by the voluntary contributions from our members.

"The Seventh Tradition has taught me to be a giver instead of a taker. I ask my Higher Power where I can contribute each day." (Paths to Recovery, p 100)

7b. Question: My recollection is that Al-Anon 7th Tradition [funds] cannot earmark.

Answer: "Our Tradition of self-support suggests that the expenses for the group's operation such as rent, literature, insurance, public outreach, supplies, post office box rental, Group Representative and Information Service Representative expenses be met first. Funds in excess of an ample reserve are used to help support local and Area structures and the World Service Office." (2018 Service Manual, pg. 107)

Al-Anon contributions are given freely and without conditions. All monies given and received support the spiritual principle of self-support. There are occasions when, Groups, Districts, and Areas have a special project and with the approval of the entity, will have a collection or an event just to raise monies for that specific reason. Groups are encouraged to develop a budget. (Please refer to *Reserve Fund Guideline*, G-41)

WONDERFUL NEWS—The wonderful news is that the SCWS Archives has a treasure trove of Al-Anon history—a box of first-edition Al-Anon books, including one signed by Lois Wilson. Before Dan P., immediate past Archives Coordinator, completed his term, he did Internet research that determined an estimated value of \$6,000 for the books. One book alone is valued at \$1,000.

WORRISOME NEWS—-The worrisome news is that summer 2018 is predicted to be an exceptionally hot one. That does not bode well for the first-edition books, which need to be in a temperature-controlled environment. Dan was able to provide the proper environment in his home. I cannot. The books are now in a standard storage unit.

A SOLUTION?—-Although it has a money-saving, year-long contract with a storage facility, the Area is looking into consolidating or digitizing old records and moving all its materials into a temperature-controlled storage facility. (By prepaying storage costs, we get a nice discount.) It obviously will take time to arrange a proper environment for the books.

CAN YOU HELP?—-We are hoping that someone among our members has a temperature-controlled storage unit in which we could store our valuable box of books until the Area is able

- With the passage of Proposition 57, more State Inmates are attending Al-Anon meetings due to the early release credits
- Roughly 1412 Inmates attend Al-Anon meetings in 13 of the 36 State Prisons (All in Northern California)
- State Prison certification will soon be online with renewal every 3 year vs in person certification every year

County Correctional Facilities

Assembly Bill 109 allows non-violent, non-serious, and non-sex offenders to serve their sentence in County Jails instead of State Prisons

 Prisoners are being held in County facilities for longer periods of time (1-4 years, indefinitely)

What started last year as a pilot outreach program to the Fullerton Police Department has become a full-fledged outreach program now involving the Buena Park Police Department and the potential for including other North Orange County police departments.

The project is a two-fold one that first introduces patrol officers to Al-Anon and the help and hope it offers families of alcoholics, then provides them with packets of information to give to families in need of help.

Lucia M. initiated the program with presentations at roll call sessions—including one at 5 am.—first in Fullerton last year and later in Buena Park. District 60 GRs and AGRs, with the help of other members not involved in District service, have prepared packets containing three pieces of literature: *Are You Troubled by Someone's Drinking, Did You Grow Up With a Problem Drinker*, and *Detachment*. They also have prepared packets with the same pieces of literature in Spanish. The packets cost less than 40 cents each, including envelopes and large packets in which to carry envelopes in patrol cars.

Some funds for the project have come from the Eighth

Annual District 60 Workshop, which was presented on Mother's Day weekend in Orange. The workshop featured talks by three Al-Anon members, as well as presentations on Al-Anon tools by a panel of members. The District leadership team served as chair for the project, which involved a number of other members.

The next major project on the District calendar is a second annual Al-Anon/Alateen workshop designed to strengthen the bonds between both portions of the program in District 60. Belinda H., Alternate District Representative, will be cochair for the workshop she initiated last year and will be assisted by Daphne J., District Alateen Liaison, as well as other members.

In addition, Belinda is working with other Districts in Orange County and the Orange County Al-Anon Information Office Intergroup to begin an outreach program to family and drug and alcohol courts in the county.

Service Manual study continues at every District meeting, and members continue to order and distribute hundreds of copies of the Al-Anon Faces Alcoholism publication, "Hope and Help."
