

## [DRAFT] Minutes of Area Assembly

#### 9:00 a.m. -- meeting called to order

#### A) Chairperson's Report - Donna E.

- Moment of Silence -- Serenity Prayer and Welcome
- Welcome -- Past Delegates Jayme C——, Kay D——, Willie W——— and new GRs
- Donna: explained the purpose of the Assembly to the new GRs
- Guidelines for Participation & Who Has a Voice and a Vote
- Alateen Lunch Announcement: Mia., AFG Alateen Chair for AFG 2020. The money from the \$10 lunch ticket supports Alateens at AFG.

#### B) Traditions read by Elsa, District #21

After the Traditions were read, Donna: reminded members that the Assembly voted that we do not repeat/chant specific words from our Conference Approved Literature (CAL) so as to not elevate certain words to a higher status than others.

## C) Group Records Coordinator Roll Call – Mary M.

Registered GRs voting: 197

## D) Secretary – Marley D—— substituting for Laleña C——

- Approval of November 17, 2018 Assembly Minutes:
- Group Representatives (GRs) who attended the 2018 November Assembly may vote on the Minutes. One revision from Vicki D-72: 2nd and 3rd question "recertified" should be replaced with "resubmitted", "rescreened" not "resubmitted". Clickers were not working, so voting was conducted by a show of hands.
- Tracy G.,D-9: Motion to accept the Minutes with revisions, 2nd Donna M.,D-57. Unanimous approval of minutes.

#### E) Treasurer's Report – Tarisa R———

 Delay in screen presentation due to audiovisual equipment issues. Verbal report first.

- 1st quarter contributions to SCWS from individuals, Groups, Districts and AISs: \$22,170.94.
- The CA(S) group contributions to WSO from July Dec 2018 was \$52,598.35. The list is available on the table, if you want to see what your group contributed.
- 16 group contributions checks to SCWS were received without a group ID number. Some had "WSO ID" numbers with letters, which no Al-Anon WSO number has. Tarisa needs to credit the appropriate group, and in keeping with Al-Anon's Tradition of declining outside contributions - she needs to know that the contributions come from Al-Anon members ONLY and meetings with registered WSO ID numbers. Tarisa emailed the DRs of the 16 unidentified contributions in April – please respond. Contribution often gives address of a facility not in our database, the facility has numerous meetings, or meeting has moved but not notified.\
- Made a contribution form for every meeting. Please take back to meetings and include the form with every group contribution. The form is also on the SCWS website.
- Info needed: REAL WSO number, District number, email for receipts (NO mailed receipts) People have been putting home address. If treasurer doesn't have email address, put the email address of secretary or CMA. She sent receipts to DRs.
- (Financial information now on screen) Statement of financial position 1st quarter of this year, total in bank \$74,691.32.
- Accounting system on modified accrual basis not cash basis; for example, we paid rent for whole year – prepaid but haven't actually used. Reimbursements are on a cash basis.
- Page 2: one thing stands out 2019 financials compared with the same quarter of 2018: significantly more money in bank in 2019 because reimbursements of \$7000 were submitted and paid in 2018 after the

- 2017 books were closed. It's taken until last quarter to catch up. New procedure for Board members: all need to turn in receipts for reimbursement every 45 days. They can't wait until the end of the year.
- January had a profit but February and March had a loss. Overall, we brought in more than we spent for 1st quarter of 2019.
- Page 4, previous year comparison: 7th tradition at Assembly is up 337%. This increase was mainly due to new awareness from information presented last November about the average expense of an Assembly.
- District contributions are down Jan-March
- Convention contributions: SCWS is not receiving contributions from local Conventions that have Al-Anon participation. Convention Guidelines speak of contributing to Service Arms funds that are in excess of "Seed money".
- The increase in cost for background check is due to the May 2018 Assembly voting that all current AMIASs must have a complete background check and many longtime AMIASs have not had a full background. Funds from savings account that was set aside for this project will be transferred to the checking account to offset the increase.
- Comparison from budget to what actually spent. 112% We brought in more than expected but also spent more. Overall fine because balanced out.
- Reviewed how the 7th Tradition collection at Assembly is spent last Nov Assembly 1st time 7th tradition was over \$2362. Amazing. Expenses for Nov 2018 Assembly was \$6,690. Suggested donation \$20 per group: this is the group's contribution to the Assembly. Your meeting should have already discussed and decided how much to contribute to the Assembly. If every meeting put in \$20 the Assembly could be self-supporting. However this is not required and meetings are encouraged to contribute what they can.
- Group Representative Expenses AREA reimburses \$100/person for hotel if traveling more than 200 miles round trip. The amount over \$100 is paid for by your meeting or district. Double occupancy is encouraged. Mileage: if travel more than 100 miles round trip, group responsible for first 100 miles,

- (at .40/mile = \$40) The remaining miles are covered by the Area. GRs need to help educate their group by referring to Service Manual and GR Guidelines regarding necessary and acceptable expenses to attend District and Assembly meetings. Service should not cost money and groups can budget for these expenses. Mileage reimbursement can be completed, turned in, and pick up check from Tarisa TODAY at the Assembly.
- Dec 31st books closed. The audit was conducted and completed. The findings indicated that the Area's accounts were in order. Accounting shows surplus of \$5330.04, however, outstanding training expenses need to be deducted so surplus for 2018 is actually \$2530.04. Recommending to contribute surplus of \$2530.04 to WSO.
- QUESTIONS/Comments
- Micheila, D-27: Clarified that convention contributions were down 95% and also District contributions were down compared to last year's quarter. This applies to the first quarter ONLY. Reminder that the conventions are supposed to send surplus to service arms.
- Tim, D-27: revenue and expense report at bottom should it say "expenses" not "revenue" (Pg F6)? Tarisa: Yes that should be corrected. Will change total "revenue" to "expenses."
- Nancy, D-12: Pg. 1 under what is retained earnings "OE" what is it? Willie W. answered: "Owners Equity" is the
- Bruce, D-27: Raised this point before has an issue with the wording that Assembly meeting needs to be self-supporting. All meetings don't have to be self-supporting, only individual Al-Anon groups should be self-supporting. The Assembly should be paid for out of group contributions to Area.
- Tarisa: All events in the Area strive to be self-supporting. Group contributions pay for ALL Area expenses. 7th Tradition isn't intended to throw more money at the Area but to pay for this event/Assembly, in addition to other Area expenses. Her announcement is a way of raising awareness of the cost of the Assembly vs

- the past GR/group contributions at Assembly.
- Carol, D-60: Referred to *Service Manual* regarding conventions. Once a Convention meets its expenses and retains "seed" money for next year, surplus funds are to be distributed to the other service arms.
- Donna: Groups are within their autonomy to create their financial budget (pg. 55). Groups retain "just enough funds to pay the GR expenses to Assembly." Interpretation of the Area is that the Assembly is a business meeting, therefore, groups should contribute to the cost of hosting the Assembly via the 7th Tradition basket. Many conventions charge a registration fee for attending their Assembly.
- Also, being of service should not cost us money. Even if a GR can afford it personally, not asking for reimbursement from your Group's Treasurer sends the wrong message to the group and the next GR, who might not be able to afford to attend the Assembly without being reimbursed.
- Kay D——— / Past Delegate: Our group sends quarterly donations to SCWS. If we start paying a fee to send GR to assembly, you will lose. It's up to group autonomy how to support this Assembly. Our group has chosen to make a small donation today for Assembly, but we give a larger quarterly contribution.
- Liz, D-75: Second to last slide of presentation shows there is a surplus of \$2,000 for 2018 suggest not distributing until expenses from this Assembly be paid.
- Tarisa: This was surplus from last year, and we are starting another year. We distribute our surplus funds to the next level of service arms per Al-Anon Tradition. Will need to do hand count for approving financials with correction that Tim made.
- Motion to approve the first quarter financials as amended made by Enid, D-17; Second: Marilyn, D-66. All voting GRs please stand approved unanimous.
- Motion to send surplus of 2018 \$2,530.40 to WSO? Motion: Saadia, D-33; Second-Maureen, D-12.
- Casey, D-27: Wants to discuss that motion. We were just told we can't use surplus from

- previous year on expenses for the following year and that we have to use it in the current year. Is that correct?
- Tarisa: We have a prudent reserve of \$35,000. Plus we have money in savings account for on-going projects.
- Cathy, D-3: Is the prudent reserve specific to the Assembly?
- Tarisa: The reserve may be used for any expenses to the Area including all Area meetings.
- VOTE: NO votes 14; Abstentions 5; the rest of the voters: YES
- F) Observed 7th Tradition (Continued the meeting while baskets were being passed)

#### G) Alternate Delegate Report - Eva B-

- Sharing of Service (SOS): Jan. 18, 2020
- Ask-It Basket: Questions/answers will be published in *Bulletin*; talk with Bruce regarding subscriptions to the *Bulletin*.
- Forum Subscriptions can: put \$1 or whatever you can afford in Forum can, to be eligible to win a Forum subscription at the end of today.
- SWRDM Report: Southwest Region includes AZ, CA North & South, Hawaii, New Mexico/El Paso, CO & Utah. Was her 4th SWRDM: humbling and powerful experience. What attendees will see when they attend: the meaning of Big P, Little P, Big T, Little T. We are going to have these workshops for the Sharing of Service workshop January 18, 2020.

#### Delegate Report – Marcia M——

- For those districts that sent love gifts to the World Service Conference (WSC) for the Delegate to distribute thank you so much. The Love Gifts that were supposed to come back to our Area to share were lost, due to post office issues.
- To show appreciation for members attending the Assembly, there will be "Door Prize" drawings right after lunch. The "prizes" are CAL: Many Voices, One Journey; Intimacy in Alcoholic Relationships (New); When I got Busy, I Got Better; Courage to Be Me; Living with Alcoholism; and Groups at Work.

- This year's Delegate Report Powerpoint is different from last year's based on your feedback. Hopefully the font size is large enough to be seen from the back of the room.
- Every year Conference members make suggestions for the next Conference theme. The Conference Leadership Team reviews the suggestions and picks one, making sure the theme can translate well into Spanish and French. 2019 Conference Theme: "Action is Attraction There is No Growth in the Comfort Zone".
- Please see the complete Delegate's written Report in the *Bulletin* and the PowerPoint presentation on the SCWS website (scws-alanon.org).
- The Delegate is happy to attend a District meeting on a weekend. Suggested one-hour minimum for presentation due to travel time as she lives in San Diego. Unlikely to be able to attend a midweek District meeting.
- Shared information regarding using Conference Approved Literature (CAL), using current editions and copies of CAL.
  - Documents on this topic from Sue Perez (Associate Director-Group Services, WSO) are available on SCWS website.
  - Question: Using older editions of our Service Manual – "the new Service Manual REPLACES the old Service Manual" so the old versions are OUT OF DATE.
  - We no longer use hand-typed copies of CAL. Before our Service Manual was published, WSO originally gave a notebook with typed pages to registered meetings. There have been many changes/ updates since these notebooks were distributed many years ago. Some groups are still hanging onto those outdated notebooks or other old, typed copies. A hand-typed copy is not considered "CAL". When you use these materials for your Opening, Closing and other meeting format readings, our members have no clue where to find the actual CAL. New members may feel that the "notebook" is only for a select few who are in higher group positions, for those "in the know," and may not understand that the information is available for everyone to read/have. It is strongly suggested to have copies of Groups at Work available from which members can

- read during the meeting. Some groups purchase one copy per member. They are not expensive and some members prefer to buy their own copy.
- The 1960s edition of Living with an Alcoholic: There is no policy for using literature that's out of print. But why would you? Revisions reflect what's happening now in Al-Anon based on member feedback. There are great articles in the May and June Forum about CAL written by Tom Coffey, Associate Director- Literature, WSO.
- Making copies of CAL? Please refer to the Service Manual (starting on p. 108) and read information regarding CAL/ Copyright. You may download the Service Manual from the WSO website as an interactive PDF. Pages can be scaled up/enlarged then printed so the font size is larger, especially for meeting format readings. Or print out the page as is, and then increase the scale/copy size on the printer/copier. This way it is the actual CAL but increasing the font size makes it easier for visually-impaired members to read it.

#### I) Old Business –

- 1. Creating a Safe SCAC (Southern California Alateen Conference) 2020 Task Force Report: Changes to the Draft Area Safety & Behavioral Requirements (ASBR) Gerald [—————]
- The work of this Task Force has turned out to be much more complicated and required more detail than we originally thought.
- Appointed in February, 2019. First met March 24th and have been meeting almost weekly.
- Main objective: to revise SCAC Bylaws then to move forward into SCAC.
- The Area Safety and Behavioral Requirements need to be revised first, then incorporated into the SCAC Bylaws.
- The ASBRs need to be reviewed by legal counsel familiar with California laws regarding minors.

- The ASBRs are then sent to WSO for review/ revisions/approval.
- Then the ASBRs are submitted to the Area World Service Conference (AWSC), then to the Assembly for GRs approval. The earliest the ASBRs could be ready for Assembly approval would be November, 2019. That still leaves the process in which the ASBRs are incorporated into the SCAC Bylaws, and the Bylaws are approved by the Assembly. After the SCAC Bylaws are approved, a SCAC Committee is formed to begin preparations for SCAC, including the Alateen Event Plan, etc. There are timelines for all of these pieces.
- We wish could say when this will happen. It is highly unlikely that this process will be completed in time for SCAC to be held in 2020. We are sad to report this unpredictable turn of events, and are sorry that we could not meet the original timeline.

#### Questions:.

Kat, Alateen Member Coordinator: — How many members are on Task Force? Bear: Ten. Kat: How many are Alateens? Bear: 1. 10% are Alateens. Kat: Why is percentage so low and who made that decision? Bear: Board. Kat: I'm concerned about that. It's not from lack of willingness of Alateens to participate. We are used to feeling lied to by alcoholics — so we don't appreciate feeling that way in our program, from Al-Anons.

Leah, D17 — Last SCAC was in 2016. It's 2019. Three years for legal counsel to do all of this. Why did take this long to do this? Bear: A Task Force was formed immediately after SCAC was canceled. A Report was passed to the Resolution Committee. They worked on it. Plan for SCAC was written up by that Task Force, but it was not complete and didn't address the revision of the Bylaws. Leah: Do we have outside counsel and are they an Al-Anon member. Donna: We are in the process of engaging outside counsel for SCWS. It's not appropriate to comment on whether or not he or she is an Al-Anon member. Leah: SCAC such a big part of our program, so disappointed that it isn't happening yet after all this time.

Nia, D50 — If only 1% [of Alateens' behaviors] were unsafe but other 99% are safe, why do there have to be so many guidelines? The Alateen community is for making new friends. I expected to go to nine SCACs because my first SCAC was 2013. Not going to

happen. It's not going to be in 2020, we know that, so I won't be able to go to SCAC again. Obviously. It's for Alateens. I'll be aging out in 2021. As long as Alateen is here and I have a voice and vote, I'm going to fight for Alateen and SCAC. It doesn't feel like we're together Alanon/Alateen — so many rules but no outcome. I feel a part of my program is being taken away from me because it's such a fun thing. I've gone to two SCACs and I got to see everything. Now I'm not going to be able to go to another one ever.

Tracy, D9 — Thanks for the work and your genuine care, Bear. Question: why are we required to get approval from WSO? If we follow guidelines that have already been voted on? Marcia: background: We thought we would be ready to have SCAC for 2020. Please presume good will. I was at the World Service Conference and Sue Perez said from the podium: "and when there are revisions for ASBRs, they have to go back to WSO because WSO was the body that approved your requirements the first time." It's disappointing but WSO is the guardian the Alateen name. Because of poor communication issues in the past, WSO was informed that we were not following the Area's ASBRs. In 2017, WSO revoked our permission to register any new Alateen meetings because our Area had not been complying with our own ASBRs and WSO's requirements. They have a group of people working on these policy divisions. At the Conference, Marcia asked Sue P—— do we need to send the ASBR revisions to WSO? She said yes. When we change them, we have to go through this review and approval process. When we created the ASBRs originally, the process was different.

We recently sent them our latest revision, expecting WSO to approve them quickly. Instead, they came back with a number of questions and revisions, some of which cannot be resolved quickly. Another piece we were unaware of is that we have to have the ASBRs reviewed by legal counsel. These are things we did not know. We apologize for that. We are going to be working on all of this. Bear was the bearer of bad news. Awareness — We all now have awareness of the process we need to do. We're using the Alateen name that WSO allows us to use. So we have no choice but to follow the process they've determined. This has to do

with legally protecting minors and Al-Anon as a whole.

Sybil, D30 — Wanted to get more AMIASs in District so I registered as an AMIAS. Easy. Did it at my house. What can we do as groups or members to support this process in the meantime? Bear: good question. Important to remember that SCAC is not the Alateen program. It's an event that's historically been put on in Southern California so Alateens could get together for meetings, fellowship, and fun. It happens to have been a powerful event. But that's not the Alateen program. The Alateen program is the meetings, Alateen CAL, and outreach. Alateen meetings are closing because membership is dwindling. There are things we can do in our Districts, in our meetings, to support Alateens – increase sponsorship. It's fun.

Bruce, D27 — Is it correct that we do have an existing ASBR? Bear: Yes. Bruce: Does the convention have separate Bylaws. Bear: Yes. Bruce: I don't understand why there cannot be a SCAC or "ought" not be a SCAC. Bear: SCAC is its own 501(c)3 tax exempt corporation. The current Bylaws have no provision in it for the situation we're dealing with, which is to provide guidance from year to year, with no standing committee. We have to build it. No way to elect or select a SCAC Chair or Sponsor – all of that has to be put into new document. Bruce: There is no existing structure or Board? Bear: The way it used to work: there was a meeting after SCAC to form a new committee to meet with old committee. The former SCAC Chair usually aged out. There is no provision now to find a SCAC Chair. Bruce: This was an adult problem, but the kids were the ones who suffered the consequences.

Christina, D3 and Alateen Liaison (DAL) — Alateens can go Al-Anon meetings. Can they go to Al-Anon conventions?

Joyce, D69 — It's a legal issue. In 2003 the World Service Conference said that we legally had to change our oversight of Alateens but we didn't even start to try to change our structure until 2013. Threats of suits can harm Al-Anon as a whole.

Kat, Alateen Member Coordinator — Bear repeated that SCAC is not the Alateen program. Membership has dropped since it was canceled. Task Force members didn't find out this information until this morning. I don't

understand why there isn't better communications with those of us who are affected by this information.

Bear — That's on me. I found out 2 weeks ago.

Donna — We created the Task Force and named it Safe SCAC 2020 because we thought it would be a piece of cake, as most of the ASBR changes had already been voted on at our Assemblies. Marcia called me from the World Service Conference informing me that she'd just learned that the ASBRs had to be reviewed and approved by the WSO before the final version could be voted on at our Assembly. That day, I sent the changes to Sue Perez, at WSO, thinking this would be a" no brainer." Last week, we got them back from her and another staff member - with a lot of comments. Several issues were substantive that will require time to review and reason out, then determine a policy. We were as taken aback as you are. All of this was a shock.

Kat — What concerns me is all the false information given to Alateens just last week, since you've had this information.

Donna — This was a no-win situation. We didn't think sending an email trying to explain all of the ins and outs of these issues and ending with the message "no SCAC in 2020" was the right way to go. So we decided to wait until the Assembly, when we could talk to everyone and "reason things out" in person about this complex situation. Our Higher Power is in charge. I am really sorry, as are the Officers, the Board and the Task Force members. If we could talk to Sue Perez, she would probably say that she's sorry also, but we have to address all of these issues before WSO can approve the changes.

Willie W., Past Delegate — I've been very involved with SCAC. I've attended 25, 26 in a row. I was part of the group that originally incorporated SCAC. Two issues: The Al-Anon fellowship is one entity, SCWS is incorporated as a part of the AFG, and SCAC is a separate corporation with its own Board of Directors and Bylaws. SCAC is a separate corporation that sponsors an event that houses youth who happen to be Alateens. The issue that we are faced with, that AFG is faced with: WSO has the power to withhold the Alateen name. SCAC depends on funds from the Area, the use of the name, and kids that attend are from the Alateen fellowship. We have to protect the Alateen

name. If the Area's Al-Anon meetings withhold the funds and all that our meetings do to contribute to SCAC, SCAC can't support itself. How would they fund themselves? Who protects the kids?

2021 is still an optimistic date for SCAC. It's very complicated to merge these corporations which have separate Bylaws so can have a united community when it does happen.

Casey, D27 — Donna, I have noticed when someone says something you are not in support of, you are more likely to pull the mike or stop applause. I ask that you apply the rules fairly. Limiting Alateen participation in a conversation that affects Alateens is not okay.

Vanessa, D10 — Came into this room, no Alateens involved and not allowed to speak because they're not Group Reps. Last Assembly, there was a petition that they were all willing to be involved. Not allowing Alateens to participate even if they're willing is wrong. It's been this way in three Assemblies about this issue with no input from Alateens. They're trying to contribute voice, thoughts, energy. There's been no forward momentum. Upset with how my sisters and brothers in Alateen are being treated. They need to be respected and need to be involved. We are not being heard-saying that-but still not heard. How to change that? Bear: I am the Area Sponsor Coordinator and have a role interacting with Alateens. Aware of this situation for many years. Encourage Alateens to become Group Reps to have voice and vote at Assembly. That's the only thing I can think of to increase their participation.

Rob, Chair YHA convention, GR D17 — Interested in the motion to give a vote to Past Delegates at Committee meetings. Perhaps form a Task Force to give all Alateens voice and vote at Assembly.

Diane, D57 — Before I got here 32 years ago, chaperoned in public schools before Al-Anon. Overnight programs were coordinated through the public school. Substantial paperwork was required on each child. There were a lot of guidelines and rules to follow. I went to SCAC as a chaperone. I was pretty surprised at how few guidelines there were at SCAC. Thought: there is huge liability here. There had to be rules to protect children, chaperones, institutions. Going forward, everything must be done to protect the whole enchilada.

Tina, D21 — Alateen Sponsor for 14 years. Both churches where Alateen meetings were held required me to go through their class for protecting children. I've had to be fingerprinted at the facility. I don't want Alateens to have voice and vote at Assembly unless they're GRs.

Carol, D60 — I want our organization to be around. Boy Scouts may not be around because of abuse issues with children. It is critical not to jeopardize our program. If no Al-Anon, there won't be SCAC. The abuse of the people in these positions has to stop.

Chelsea, D\_ — How can we compare the large number of Al-Anons with the small number of Alateens? Only a few Alateens. You [Al-Anons] are responsible for us. Although we all want to participate and have a say in events that concern us, we can't have an impact. I get that you are concerned about our safety...and we acknowledge that safety is necessary. You are more the voice for us than we are for ourselves. We see all these people trying to have a say but we can't have an impact. Thank you for trying to bring back this event but you are responsible over us and it's annoying.

Leah — Something that happened the last Assembly. Presentation was made. We corrected some of the things. Someone said to her afterwards, "That was a comment not a question. Your people [Alateens] aren't doing it correctly." Alateens are not becoming GRs because we're afraid of coming here sometimes.

#### **K)** New Business:

1. Election of new Area Secretary – previous Secretary moved out of the Area. Resume presented for one candidate, Lalena C., who has been acting as the Interim Secretary. MOTION yes/no vote: Donna M., D57 made the motion, seconded by Larry. D8. 1 abstention, rest of votes: YES. Motion passed: Lalena C. is new SCWS Secretary.

7th Tradition Report, Tarisa: 7th Tradition today brought in \$2,698.26

Alateen Lunch Report: \$1,100 raised today. Remaining cookies are being sold for \$1 each.

- 2. Treasurer: Tarisa: Recommendation that Past Delegates (PD) be reimbursed for mileage and hotel for AWSC and Assemblies.
  - a. Recommendation would include PDs who still reside in CA South only. Reimbursement rate the same as for other Board members.
  - b. KBDM: They share knowledge of the Area, past World Service Conferences and history during meetings.
  - c. Members could benefit from their experience strength and hope.
  - d. What know about our resources relevant to this topic? Eight PDs living in our Area. Panel 52, 49, 43, 40, 37. Two might require hotel/overnights. Only 2 or 3 attend. \$90 if they are reimbursed.
  - e. Consulted other Areas via AFG Connects. 21 Areas responded. 13 Areas reimburse PDs to attend meetings. The Areas that don't are much smaller than others that do.
  - f. Groups support their GRs. PDs don't have any service arm to support their attendance.
  - g. PROS: PDs who may not have been able to attend would be able to come.
  - h. Demonstrates appreciation for their experience strength and hope.

- i. CON -- some financial obligation placed on our Area.
- j. What do we wish we knew but don't: Would this encourage more attendance from PDs? Could there be a time when there are too many who want to attend, and it would become too expensive?
- k. Area has invested in our PDs and have an obligation to support them attending. Tarisa called and asked several PDs who are not attending if the lack of reimbursement was the reason.
- 1. Five PDs are not regularly attending. Of those, 3 said that money was not the issue. If at the time when they stopped, if they had been reimbursed, would they have come? They said when you're of service at that level, you will spend your own money out of pocket to be of service.
- m. Question: What is the current reimbursement policy for Board members? Round trip mileage reimbursed and full cost of hotel (encourage double occupancy).
- n. Questions/Comments: Donna M., D57: Appreciate the experience strength and hope from PDs. They often brings peace to the conversations.
- o. Gail, D8: PDs said didn't need money to come. And you mentioned that we have a deficit. Tarisa: They would have come even if they hadn't been reimbursed, not that they didn't need the money.

MOTION: SCWS Past Delegates who attend the SCWS Area Assembly and Committee meetings to be reimbursed for mileage and hotel the same as Board members. Motion: Joyce D., D69. Seconded by Sam, D36. No votes: 11. Abstentions: 7. All others present voted Yes. Motion passed.

- 3. Donna Our SCWS Bylaws do not specify who has a *vote* at the Committee (AWSC) meetings. Our Bylaws state that Elected Officers, the Immediate Past Delegate, Coordinators, AIS and Convention Chairs, DRs (or their Alternate), and Past Delegates have a voice. (Article VII, Section 2).
  - a. Policy issues are decided by GRs at Assemblies, not by the members of the Committee.
  - b. The Committee members set the Agenda for the Assembly, which sometimes requires a vote. Past Delegates are members of the

Committee and will have a vote in the future.

EVA — *Forum* Subscriptions won by: Karen G., D17; Mary O., D39; Tina, D33. Winner of the fourth subscription wasn't recorded.

- 4. Tarisa Creation of a Finance Committee (Eva and Tarisa). See full Treasurer's Report in *Bulletin*.
  - a. Finances get audited every year by Al-Anon members.

2019 World Service Conference Theme

Action is Attraction – There is No Growth in the Comfort Zone

I arrived Friday afternoon April 12 and enjoyed a dinner with other Panel 58 Delegates. ("Panel 58-We Participate!") On Saturday I attended a WSO Literature Committee meeting, my first ever as a new member of this Committee. It was exciting to be part of a committee that I have great love and respect for. It's no secret that I adore our Conference Approved Literature (CAL) and refer to it both for my personal recovery, and also for researching questions that arise while being of service as your Delegate. This is where I'll stop and make an amends. During the Assembly I frequently referred to the WSO, Associate Director-Literature, Tom C——-. However when I spelled his name on the PowerPoint I gave, I incorrectly spelled his name "Tom C——". Oh my goodness, I can't believe I made that mistake! Please correct your copies, and your memory, so the spelling reads **TOM C**——. Thank you for your patience with me, and a **big thank you** to the member who kindly pointed out my error.

The first official/full day of the WSC was Sunday. French Translation was arranged for the new Panel 59 Delegate, Celine, from Ouebec East, and Spanish Translation arranged for the Panel 57 Puerto Rico Delegate, Mabel. This was the first time that simultaneous translation was ever provided at a World Service Conference! Voting members included: 67 Delegates, 17 Trustees, 3 At-Large members of the Executive Committee, and 7 WSO Staff members. Delegates, WSO Staff and WSO Volunteers (Board of Trustees and Executive Committee) bring various perspectives experiences to the vote on behalf of Al-Anon as a whole. Roll call the first day was taken through introductions. In attendance with Voice but no Vote: Nikita, Director of Finance and Operations, and Scott, Associate Director—Digital Strategy.

Not including meals, <u>over 45 hours</u> were spent in World Service Conference sessions!

#### **WSO Financial Information**

- For an easier comparison, I combined the information from the 16-page WSO Audit Report onto 1 page, and focused on items that were of greatest interest to me when I was a GR. Then I added the proposed WSO Budget for 2019. Please refer to "Financials Del Rpt."
- There was a large increase in Literature Sales Gross Profit, in 2018. The increase was mainly because of the introduction of the new Conferenced Approved Literature piece, *Intimacy In Alcoholic Relationships* (B-33). WSO's major sources of revenue were: 58% Literature, 35% Contributions, 5% *Forum* and 2% Investment Income.
- Forum Subscriptions and Contributions stayed about the same between 2017 and 2018.
- There was a large drop in our Investments income in 2018. It is highlighted in yellow with red ink. This was sad to hear about, but not a total surprise. (I know my personal investments took a big hit last year.)
- Delegates asked questions about these investments and what our future is looking like for 2019. "We continue to invest in conservative, mature and healthy equities and bonds. No one is immune to Market conditions." Nikita, Director of Finance.

- For those of you who live and breathe numbers, and want the details, more complete WSO Financial Information can be found on the al-anon.org website. From the Home Page, at the top click on "Members"> WSO > Financial Information. There you will find the Tax Returns and Audits from the past four years. The 2018 information will be posted soon.
- California South is the largest Area in the entire WSO structure. We contribute the largest amount when compared to other Areas. 71% of our groups contribute to WSO, with the average amount per group being \$144.56. Based on the 2018 Audit, the estimated Cost of Group Services was a total of \$4,254,541. Divide this by the number of US and Canadian Groups, 14,551, that gives us an average of \$292 spent by WSO per group.
- What Services does WSO provide each **Group?** The complete list is on the second page of the Quarterly Appeal. Examples are: 1. WSO answers phone/email questions about group issues. 2. Prepares and distributes Conference Approved Literature (CAL). 3. Produces the Forum. 4. Performs outreach to professionals. 5. Oversees Alateen Safety and Behavioral Requirements. 6. Supports International Al-Anon structures. 7. Provides the most current, searchable list of all registered Al-Anon and Al-Anon meetings. with directions, on the WSO website.
- What Special Projects does WSO Plan for 2019? Examples are: 1. Online store redesign. 2. Meeting search database upgrade. 3. Project management software implementation. 4. New Public Service Announcements (PSAs). 5. Interpretation at 2019 WSC in Spanish and French. 6. Develop Al-Anon mobile app. 7. Implement translation memory software. (These are all part of the Strategic Plan Initiatives.)
- Why does WSO predict a deficit budget for 2019? (\$178,956) Literature sales will likely drop to the lower 2017 levels, there will be an increase in general operating expenses, and the cost of implementing the Strategic Plan Initiatives will be incurred.
- How can groups help support our growth? If each group that is already contributing gives an additional \$8.00 in 2019, the goals will be met!

#### **Conference Approved Literature (CAL)**

- Intimacy in Alcoholic Relationships (B-33) was introduced at the 2019 Al-Anon International Convention in Baltimore. The "conceptual approval" for this book was given at the 2011 World Service Conference.
- At the 2018 World Service Conference (WSC), I was given the great experience of participating in the discussion of "conceptual approval" for the Just For Tonight (M-81) bookmark. The Literature Committee was very thorough with using Knowledge-Based Decision-Making (KBDM) to present the information about the suggested bookmark. At times, Delegates became focused on the actual wording of the bookmark, forgetting that we were simply giving approval to the "concept", and would be putting our trust in the Literature Committee to develop the piece of literature in the best interest of our fellowship. How exciting it was to be given a copy of the Just For Tonight bookmark at the 2019 WSC!
- The top selling book for 2018 continued to be *Courage to Change* (B-16), with *How Al-Anon Works* (B-32) and *Intimacy in Alcoholic Relationships* (B-33) following.
- Have you ever wondered how our Literature becomes "Conference Approved"? At the 1962 WSC there was a motion "That all literature recommended by the WSO be accepted and approved and called 'Conference-Approved Literature' and that all existing literature be so stamped."
- The complete CAL process is described in the May 2019 *Forum* by Tom Coffey, WSO Associate Director-Literature. There is a second article by Tom regarding CAL in the June 2019 *Forum*.
- For further information, please see our *Al-Anon/Alateen Service Manual*, 2018-2021, pgs. 110-116.

## Thought Force, Task Force and Policy Committee Updates Presented at WSC

Throughout the year there are smaller groups of Al-Anon members coordinated by our World Service Conference to research a particular topic that is relevant to members of Al-Anon. Sometimes these topics originate from individual members writing to the WSO with their concerns/suggestions. There are also ongoing committees specifically designed to review Policy portions of our *Service Manual*. The Policy Committees report progress on, and provide

information to, the WSC on topics that are generated by the fellowship regarding issues or concerns that need clarification or interpretation in light of the Twelve Traditions and Twelve Concepts of Service. The initial stage of information gathering is usually done through a "Thought Force", often followed by a "Task Force". A "Work Group" is formed if the work is ongoing. Please see our *Al-Anon/Alateen Service Manual*, 2018-2021, pg. 71 for more information about what is a Work Group, Thought Force and Task Force.

#### **Welcoming Potential Members Thought Force:**

- A skit was presented at the WSC (and at our May Assembly) on the topic of "Welcoming potential members whose loved one may be addicted to drugs." The setting of the skit was a Group's Business Meeting with members sharing their thoughts/feelings regarding welcoming all newcomers while maintaining our primary purpose.
- Information from the WSO 2018 Membership Survey was shared regarding "Members who initially attended Al-Anon due to a family member or friend's drug use."
- CAL was sited throughout the skit (Service Manual, How Al-Anon Works, p.110; Paths to Recovery, p.154) to support our principals of acceptance, compassion, and allowing members to decide for themselves if they have/had a friend/family member struggling with alcoholism, and if they believed they could benefit from Al-Anon. (The skit is posted on our SCWS website)

## Concept Five Task Force, World Service Handbook Task Force:

- The proposed changes were to the wording, not the content.
- Concept Five: Needed clarification of the appeal process
- Handbook needed clarification of the language referencing WSO staff, and to reflect new WSO reorganization.
- The amended revisions for both Concept Five and the World Service Handbook were approved at the 21019 World Service Conference.

#### **Alateen Policy**:

• The "Alateen Policy" section of the "Digest of Al-Anon and Alateen Policies" appears on

- pages 93 through 97 of the 2018-2021 Al-Anon/Alateen Service Manual (P-24/27).
- In February, revisions to this text that had been approved by the Board of Trustees during its October 2018 meeting were posted for comments and suggestions by members of the 2019 WSC.
- The suggestions and comments of the Conference members were considered by the Policy Committee. Further modifications to the text were made and then approved by the Board of Trustees at its April 2019 meeting.
- The amended revisions were approved by the 2019 World Service Conference.

#### The Electronic Meetings Work Group (EMWG)

- Developed new ideas about how to improve our understanding of the needs and wants of electronic meetings and the role the WSO can play in helping the members in these meetings achieve Al-Anon's primary purpose. The EMWG will continue its efforts to obtain information directly from the electronic meetings. The Work Group also prepared and delivered a presentation at the 2019 World Service Conference.
- The Policy Committee discussed the continuing efforts of the World Service Office to invite electronic meetings that use the Al-Anon name to register with the WSO in accordance with the following policy statement, on page 89 of the Service Manual: When electronic meetings form, they register with the World Service Office (WSO) in order to use the Al-Anon name.
- The Policy Committee then passed the following motion: "The Policy Committee recommends to the Board to direct the office to pursue all appropriate remedies to protect the Al-Anon name, pursuant to the electronic meetings policy in the Policy Digest." This recommendation was adopted by the Board of Trustees.

#### **WSO Updates**

#### **Electronic Meetings Updates:**

• A new community on AFG Connects was launched in the end of January for electronic meetings. The Current Mailing Address (CMA) for each meeting has log-on access to the community. The decision to create this online platform was made after the successful

- conference call that was held with the electronic meeting CMAs and members of the Electronic Meeting Work Group in November. Their discussion threads have included comments regarding service in meetings, displaying of meeting formats, dominance in meetings, and meeting autonomy.
- The number of electronic meeting registrations continues to grow. As of March 31, 2019, we have a total of 214 meetings, with 131 being phone meetings and 83 online meetings. Languages represented are: English, Spanish, German, French, Danish, Icelandic, Italian, Polish, Estonian, Portuguese, Farsi and Russian. The online platforms that are currently in use are: Bulletin Board, Chat, Email, Facebook Messenger, Free Conference Call App, Skype and Zoom.

#### **Open/Closed Meetings:**

- There was a follow-up to a policy discussion in January 2018 which found that the terminology "Open/Closed" was not consistent with our spiritual principles of confidentiality and anonymity, nor welcoming to newcomers.
- The Executive Committee approved a motion to use the wording "Families and Friends only" and "Families, Friends, and Observers welcome" to replace "Closed" and "Open," respectively, to identify meeting attendees on the AFG Electronic Meeting Registration/ Update Form.
- The change in wording was to be used on a trial basis for six months prior to making a recommendation to the Board regarding implementation of this change on the Group Records forms.
- After review of materials and discussion, the Policy Committee recommended to the Board of Trustees "to end the trial and update the language permanently sepon both the Electronic Meeting Registration/Update form and Group Records forms." This recommendation was accepted by the Board.

#### **Digital Strategy:**

• Scott is the Associate Director—Digital Strategy at WSO. He oversees Al-Anon's message online—on our website, social medial pages and email—and its public outreach at the national level, which includes PSAs, search engines and online billboard ads.

- PSAs: two new PSAs were developed and are available in English, Spanish and French.
- Face the Truth WSO Staff gave permission for the producers to use the Al-Anon logo in 4 episodes.
- Last year was a record-breaking year for the Al -Anon website, with over 3.5 million visits to al-anon.org and over 1.4 million people finding meetings using our online meeting search, with over 60% of the visits coming from first-time visitors to al-anon.org. These visits have led to over 540,000 meeting searches.
- The Digital Strategy Team is committed to help members and newcomers find meetings worldwide. To advance this Strategy, they are reviewing approximately 2,000 meetings that take place outside the WSC Structure but that are registered with the WSO for any number of reasons. Most of these are in countries that have evolving structures or that lack any structure at all. Once these meeting addresses are verified and their latitude/longitude is determined, they will be adding them to our online meeting search.
- They have kicked off a project to develop an official Al-Anon mobile app, which they plan to make available later this year.

#### **Group Services:**

- The "Let's Talk about Safety in Al-Anon Meetings" service tool has been extremely well received. The service tool is now posted in English, Spanish and French on the al-anon.org website, found on the Group Resources home page.
- The Starting an Al-Anon Group Guideline (G-12) was noted to have a reference to statistical data that conflicted with information shared in the 2018 Membership Survey. The purpose of the guideline, in general, is to provide a broad view of the information needed for a member seeking assistance when navigating within our Service Structure. As a result, the statistical reference was removed in the text under "Open Meetings" to reflect that "many members" are referred to Al-Anon by professionals.
- 2019 marks the 55<sup>th</sup> anniversary of the *Alateen Talks* newsletter and the 18<sup>th</sup> anniversary of the daily reader *Living Today in Alateen* (B-26). Alateen literature is Al-Anon literature. Consider having a discussion in your Al-Anon meetings about using Alateen literature. It may

provide a different perspective on how Al-Anon members can support Alateen.

#### **International Services**

- Kerri, Associate Director-International, is responsible for communicating with and providing guidance in 68 countries.
- Many countries have their own General Service
  Office (GSO) which is the term given to an AlAnon national service structure in a country
  outside of the World Service Conference
  Structure. Countries outside of our WSO
  structure have voice through the International
  Coordination Committee, and some have their
  own Conferences.
- Since last July, WSO has received four requests to reprint *Intimacy in Alcoholic Relationships* (B-33) (from Australia and South Africa [English], and Colombia and Mexico [Spanish]). They notified GSOs the *Just for Tonight* Bookmark (M-81) would be available in March in English, French, and Spanish, and let them know they could pre-order or submit requests to translate or reprint. So far, only South Africa has requested permission to reprint, but they expect more requests.
- The UK and Eire GSO recently used part of a bequest on an outreach project that led to an increase in literature sales from both groups and individuals. They are also using some of the bequest money to redesign their website and implement a new toll-free help line.
- Russia requested and was provided with copies of Finance, Executive, and Policy Committee Guidelines. They are considering creating these Committees in addition to their Service Board.
- In January, WSO processed a "rush" reprint permission order for South Africa for the S-20 pamphlet (Has Your Life Been Affected by Someone Else's Drinking? Alateen is for You!). They placed a local printing order for 3,000 copies for a public outreach project in schools.
- In January, the "Safety in Al-Anon Meetings" document was shared with the international community via AFG Connects; members responded well to it.

#### "TEAM"

• Together Empowering Al-Anon Members, "TEAM", began in 2009 as a collaborative effort between the WSO and an Area. Members of the WSO Board of Trustees (BOT) would

- join an Area for a full-day service event. 43 of the 67 Areas have held TEAM events.
- 2018, WSO created a Task Force to restructure and improve TEAM events.
- The Task Force found that having the WSO BOT members participate in TEAM was not the best use of their resources, mainly due to their workload and time involved.
- TEAM will be discontinued after 2019, however WSO is working on a new platform to reach wider audiences of Al-Anon members. Their new plan will be shared at the 2020 WSC.

#### What's Coming Next?

- 2020: A.A. International Convention, with Al-Anon participation. Detroit, MI. July 2-5, 2020. The theme for this convention, which will be celebrating A.A.'s 85<sup>th</sup> anniversary, is "Love and Tolerance is our Code." Registration opens September 9, 2019 at \$115.00 US and after April 2020 at \$140.00 US. Al-Anon meetings will be held in the Marriott Hotel. The Al-Anon program will be similar to Al-Anon's International Conventions, which are held separately.
- 2023: Al-Anon International Convention, with A.A. participation. Albuquerque, NM. June 29 -July 2, 2023. Located at Albuquerque Convention Center with two attached hotels. Attractions include Sandia Peak Aerial Tramway, Hot Air Balloon rides and Petroglyph National Monument.

Our Delegate has the opportunity to interact with the Conference's 92 voting members--all of the Delegates from around the country, the Board of Trustees, and a number of World Service Office (WSO) staff members—and ask questions, give a report about our Area, hear reports, and learn what's happening in our worldwide fellowship.

We all know that our literature is "Conference Approved"—and the World Service Conference that our Delegate attends each April is *that* "Conference!" I was in service beyond the group level for several years before I realized that this was the case!

In addition to the Delegate's Report, we will be hearing reports from our Area Alateen Sponsor Coordinator, Bear, who is chairing the Southern California Alateen Conference (SCAC) Task Force. We had hoped that the timing of all of the revisions, changes, and votes regarding the Area Alateen Safety and Behavioral Requirements (ASBR), SCAC Bylaws, and SCAC Requirements could have been completed in time to plan for SCAC in 2020. Regrettably, it appears that this is not going to be the case. That is the bad news.

The *good* news is that the Area Round-up Alateen Day (RAD) 2.0 *is* being planned by several Districts and it will be held on Saturday, July 20, from 11:00AM to 7:00PM in San Diego. We hope that our Area's Alateens will participate and enjoy fellowship and fun as they did at the first RAD. We will be sending out announcements asking our Area's AMIASs (Al-Anon members Involved in Alateen Service) to participate as sponsors. And we'll be asking our Al-Anon members to contribute financially, as they have so generously done in the past with SCAC.

We have received several emails from members who have questions, comments or concerns about their Al

-Anon groups at groupandmemberconcerns@scws-al-anon.org. Our first response to any concern is education: what does our *Service Manual* and CAL say about the issue? We have found that often, referring to our literature adequately addresses the problem and provides a clear solution. So please make sure that you have the current *Service Manual* and read it! It is the collective group conscience of Al-Anon's 68 years of "reasoning things out with one another."

#### Treasurer

Thank you to all of the groups, districts, and conventions that send contributions to Southern California World Service. Your contributions allow SCWS to carry the message of Al-Anon Family Groups throughout Southern California.

**Summary of Quarterly Financials:** The total revenue for Apr-June 2019 increased 7% compared to Apr-June 2018. The total expenses increased 11% compared to Apr-June 2018. The net revenue for 2nd Quarter of 2019 was -\$2,781.23 (negative means it was a loss of revenue). We continued to maintain a reserve of \$35,000.

**To DRs & GRs:** Your meeting (for GRs)/district (for DRs) should reimburse you up to 100 miles *roundtrip* to attend the Assembly. If you drive 101 miles or more *roundtrip*, SCWS will reimburse you \$0.40 for each mile exceeding 100 miles.

Please submit a mileage reimbursement form to the SCWS Treasurer at the Assembly.

If you travel 200 miles or more *roundtrip* to attend the Assembly, SCWS will reimburse a maximum of \$100 per person for your hotel room. Your meeting (for GRs)/district (for DRs) should reimburse you the remaining amount. Please submit a reimbursement form for mileage and hotel to the SCWS Treasurer at the Assembly and provide a copy of the hotel receipt.

**To Group Treasurers:** PLEASE, PLEASE, PLEASE write your group's WSO ID# on the check or money order when sending your contribution. This ensures that your group receives credit for the contribution on the quarterly report! If you do not know your Group ID#, write the Day, Time, City,

Zip Code, and Group Name on the check so I can look through the database to find your Group ID#. ### Ask-it-Basket

#### **Question 1:**

*Today's 7<sup>th</sup> Tradition is to pay just for today?* 

#### Answer 1:

The Yes, the 7<sup>th</sup> Tradition collected during Assemblies go towards: *rent for the venue, insurance, mileage and hotel reimbursements.* There are also administrative costs such as printing and office supplies.

#### **Ouestion 2:**

*To whom is the depreciation expense written?* 

#### Answer 2:

We believe this question is in regard to the electronic voting clickers and the depreciation expense: The electronic voting clickers were purchased a few years ago. Each year their "value" is less than the original purchase price and less than the previous year. This decrease in value is the amount depreciated and deducted or "expensed" from the books.

#### **Question 3:**

When the DR signed my receipt for the Area's 7<sup>th</sup> Tradition, she assumed I put the money in the basket. This is not a safe system, money should be always counted?

#### **Answer 3:**

Each DR has his/her own process for signing the 7th Tradition receipt. Perhaps your DR was

presuming goodwill. If you have a specific concern about a process, consider discussing this directly with your DR.

#### **Ouestion 4:**

Is it true that WSO is not going to send a free copy of the Service Manual to the groups?

#### Answer 4:

The decision to discontinue mailing *SMs* to groups was made by the Board of Trustees in 2017 before the most recent edition was available. Due to the number of books returned to WSO because of incorrect Current Mailing Addresses (CMA), the Board made the prudent financial decision to send *Groups at Work* to all registered meetings instead.

#### **Question 5:**

Can we designate where our group contribution is applied? For example, \$50: \$20 to conventions, \$10 to District, and balance as needed?

#### Answer 5:

"Group funds are used to support Al-Anon's purpose of carrying its message of help and hope to those who still suffer. Group contributions support all levels of Al-Anon service including the District, the local Al-Anon Information Service (AIS/Intergroup), the Area, and the World Service Office (WSO). "Conventions" are not considered to be a "service arm" of Al-Anon (such as a District, Al-Anon Information Office, the Southern California World Service -SCWS-Area and World Service Office) therefore a Group would not contribute to a convention. (SM, page 55).

#### **Question 6:**

Who takes priority in an Al-Anon meeting? An Al-Anon member or a "double-winner" who questions the actions of an Al-Anon member?

#### Answer 6:

No Al-Anon member takes "priority" over another member. The Third Tradition states: "The only requirement for membership is that there be a problem of alcoholism in a relative or friend." Members of Alcoholics Anonymous who identify as Al-Anon members are equal members of the Al-Anon fellowship. "We are a fellowship of equals and Al-Anon is a program of principles not personalities" (*SM*, p. 41).

The pamphlet Al-Anon Spoken Here (P-53) states: "Our meeting discussions do not include any other program or fellowship. . . Those of us who are members of other anonymous programs avoid openly revealing this at meetings, concentrating instead on the Al-Anon approach to the family illness of alcoholism."

In addition, "all Al-Anon discussions should be constructive, helpful, loving and understanding.

. No member of Al-Anon should direct, assume authority or give advice. Our program is based on suggestion, interchange of experience, and rotation of leadership" (*SM* p. 22).

#### **Question 7:**

How do we change the word "God" and "Him" to "Higher Power"?

#### Answer 7:

The words "God" and "Him" are the wording in Al-Anon's Conference Approved Literature. As stated in the "Al-Anon World Service Conference Charter" found in the Service Manual on page 226: "No changes are to be made in the Al-Anon or Alateen Traditions, Steps, the Concepts of Service (except descriptive text), or the General Warranties of the Conference Charter (Item 12) without written consent of three-quarters of the Al-Anon Family Groups."

#### **Question 8:**

What is the difference between an Al-Anon Conference and an Al-Anon Convention?

#### Answer 8:

Among common Al-Anon/Alateen events are Area conventions, bringing together members from across the Area to celebrate recovery, often for a weekend. Conventions hosted by Areas for Alateen are often referred to as conferences. (*SM*, p. 90). Conventions typically have many meetings, workshops, and activities occurring simultaneously and participants choose which one(s) they want to attend. Conferences usually have only one meeting, workshop, and activity at a time for all participants to attend.

#### **Question 9:**

How to deal with the progressive apathy in groups towards Al-Anon business?

#### Answer 9:

Some ideas that come to mind: 1) Have meeting on the topic of service. Find CAL quotes on service to share with the group. Talk openly about fears, joys, frustration, etc., and why service is so special/needed in our recovery. 2) Share about the "get in the car" concept of approaching service positions, inviting other Al-Anon members to join in going to a service-related meeting. 3) Have the GR use the "cliff-notes" version of the Assembly to share the highlights, and break off manageable chunks to read/share each week. 4) Have the group look at how often they rotate their positions. If they are changing every 6 months, consider changing them every quarter so no one person is in a position too long, and possibly encourage sharing a position. 5) Encourage your group to do a group inventory. Discuss the results as a group and follow through with needed changes.

#### **Question 10:**

Can we have a separate Assembly to discuss SCAC instead of taking up time at the regular Assembly discussing SCAC issues?


#### Answer 10:

#### **Archives**

While listening to an Al-Anon friend talk about the challenges of pulling together information on her group's history as the group prepared to celebrate its 50th anniversary, it occurred to me that one of my groups was approaching a 10th anniversary.

So I went to our group's collection of meeting records to begin pulling together some information we could use later on. And I was dismayed to find that a very efficient secretary had thrown out the accounts of our group's early days.

At that point, it dawned on me that today's activities are tomorrow's history and archives material.

So I would urge GRs to find a member or two in their groups willing to begin compiling group histories by consulting old records and interviewing long-time members.

Here are some guidelines:

- 1. Collect as much detail as possible, the name of the first (and subsequent) meeting locations, the cities in which meetings were held. For example: Some thoughts about the building....Was it a long climb upstairs? ... Was it a backroom of a club or AA facility? ... What time of day was the meeting?... What was included on the meeting format?... Were there special events?... Have locations and formats changed?... Include the names of early-day members, remembering to use only last initials with first names, including for members who are deceased.
- 2. Add some personal recollections, trying to use members' own language.
- 3. Keep updating the history, remembering: "Today's Activities are Tomorrow's History and Archives Material."
- 4. Send a copy to me for the Area Archives at archives@scws-al-anon.org.

# Area Alateen Processing Person ACTIVE AMIAS STATUS

We have around 327 active AMIAS at present. The end of the re-certification period is 31 May and we will have an accurate count of AMIAS by the end of June. We typically lose ~100 or so each cycle. A report pertinent to each respective District listing all active AMIAS and

Alateen meetings will be disseminated at that time.

#### **New AMIAS**

We have gained 24 new AMIAS since 1 Jan 2019, consistent with 23 in previous 6-month period.

Average attendance at monthly webinar is 10.

Special webinar was held in February by request of members from D6 and 24 which had 6 attendees, all of whom became certified AMIAS within the month.

#### **Background check**

There are still about 60 people who have not yet complied with the new Area background check policy. Many of these intend to retire from Alateen service and some never received notification due to spam settings on their email accounts. They are being addressed individually as some have attempted to recertify without the background check.

#### **Processing of new AMIAS applicants**

Per ex officio discussion between Board officers and AAPP, SCWS will continue to require a handwritten signature on AMIAS application and re-certification paperwork. This will require printing the forms in order to sign and subsequent scanning of the forms for electronic submission. Districts will maintain paperwork with original signature in their local records and forward only PDF documents to AAPP. I am working with individual Districts to help where there is a lack of scanning equipment and/or skills.

#### **New Meetings**

#### **Inactivated Meetings**

Per District Reps, Alateen meetings are closing due to lack of AMIAS support and lack of Alateen attendance.

#### **Alateen Group Representatives**

We have another new Alateen GR in Ventura, for a total of 5 GRs in Southern

California. DRs have been educated to communicate with meeting sponsors to prepare for making any Alateen GRs who attend Assembly ready to vote.

#### **Processing Changes to Alateen Meetings**

Meeting sponsors continue to attempt to process changes to Alateen meetings through the WSO website; these are forwarded by WSO or the SCWS Group Records administrator to the AAPP.

There is a widespread lack of knowledge on how and when to submit form GR-3, or that it is available on the SCWS website as a fillable PDF.

How to process changes to Alateen meetings and correct completion of the GR-3 might be a good topic for a workshop for AMIAS, DRs and DALs.

#### **Annual CMA Update**

As if we are not busy enough, now is also the scheduled Alateen Annual CMA Update. Forms were disseminated this month by WSO to all listed CMAs to complete and forward to AAPP and are already being submitted by CMAs.

#### **Bulletin**

This is the fourth Bulletin I have had the privilege and responsibility to assemble as Bulletin Coordinator. As a result of the work I have done in assembling the Bulletin, coordinating its publication on the SCWS website, obtaining printed copies for Bulletin subscribers, and mailing out the printed copies, I have identified some issues that I believe to be worthy of wider consideration for the possible improvement and modernization of this multifaceted process.

First, the greatest challenge to assembling the Bulletin is obtaining timely submissions from Officers, Coordinators, Convention Chairs, Area Information Services Liaisons, and District Representatives. I understand that preparing written reports is a time-consuming endeavor — especially for a group of volunteer Trusted Servants. It also is

an important responsibility that helps our fellow members of Al-Anon in Southern California to learn about Al-Anon in the Area beyond their individual Al-Anon Family Group(s). Insofar as the Bulletin is publicly posted on the SCWS Website, the Bulletin also serves as an informational tool for members of Al-Anon beyond our Area. I cannot over-emphasize the importance of the timely preparation and submission of written reports for inclusion in the Bulletin.

**Second**, I have received comments from a meaningful number of Officers, Coordinators, Convention Chairs, Area Information Services Liaisons, and District Representatives stating that they find the format of the Bulletin to be confusing.

The Bulletin is published quarterly in connection with the February Committee Meeting, May Assembly, August Committee Meeting, and November Assembly (each a "Quarterly Meeting").

Currently, the Bulletin for each Quarterly Meeting is published in the week or two prior to the next scheduled Quarterly Meeting and bears the title of the Quarterly Meeting that occurred prior to the Bulletin's publication. More precisely:

- 1. The "November Assembly Bulletin" is published in the week or two prior to February Committee Meeting.
- 2. The "February Committee Meeting Bulletin" is published in the week or two prior to May Assembly.
- 3. The "May Assembly Bulletin" is published in the week or two prior to August Committee Meeting.
- 4. The "August Committee Meeting Bulletin" is published in the week or two prior to November Assembly.

Currently, the Bulletin for each Quarterly Meeting contains the following material:

- 1. Agenda for the *next scheduled* Quarterly Meeting [which will occur in the week or two after the publication of the Bulletin in which they are included].
- 2. Draft Minutes from the *prior* Quarterly Meeting [which occurred nearly three months prior to the publication of the Bulletin in which they are included and will not be reviewed for approval until more than three months after the publication of the Bulletin in which they are included].

- 3. Officer, Coordinator, Convention Chair, Area Information Services Liaison, and District Representative Reports that were presented at the *prior* Quarterly Meeting [which occurred nearly three months prior to the publication of the Bulletin in which they are included].
- 4. Financials for the Quarter that ended most immediately prior to the *next* scheduled Quarterly Meeting.
- 5. Contact information that is the most current as of the date of the publication of the Bulletin [even if it has changed following the Quarterly Meeting].
- 6. Flyers for events that have not occurred prior to the *next scheduled* Quarterly Meeting (and omitting any flyers for events that were pending at the time of the *prior* Quarterly Meeting].

More specifically, and solely by way of example, the *first* Bulletin published in a given year is published a week or two prior to the *February Committee Meeting*, bears the title of "*November Assembly Bulletin*," and contains the following material:

- 1. Agenda of the *next scheduled* Quarterly Meeting (of a body that is different from the one that met at the *November Assembly*).
- 2. Draft Minutes of the *previous* Quarterly Meeting (of a body different than is meeting at the next scheduled quarterly meeting for which the Agenda is published).
- 3. Stale reports that were presented at the *previous* Quarterly Meeting (which means that the membership at large does not learn what is happening in the area until nearly three moths after it has occurred)
- 4. The most current financials.
- 5. The most current contact information.
- 6. Fyers for upcoming events.

Based on the foregoing, I believe that the format of the Bulletin could be improved upon by making the following changes:

1. Re-title the Bulletin to match the *next* scheduled Quarterly Meeting (which will occur in the week or two following the publication of the Bulletin) as opposed to the *prior* Quarterly Meeting (which occurred nearly three months prior to the publication of the Bulletin).

- 2. Include the Draft Minutes that will be reviewed and considered for approval at the *next scheduled* Quarterly Meeting (which will occur in the week or two after the publication of the Bulletin) as opposed to the *prior* Quarterly Meeting (which is a meeting of a different body and which will not be reviewed and considered for at the Quarterly Meeting in connection with which the Bulletin is published).
- 3. Include Officer, Coordinator, Convention Chair, Area Information Services Liaison, and District Representative Reports *to be* presented at the *next scheduled* Quarterly Meeting [which will occur in the week or two after the publication of the Bulletin in which they are included] as opposed to the *prior* Quarterly Meeting (which occurred nearly three months prior to the publication of the Bulletin and are, therefore, stale and of less utility to the membership at large).

If the foregoing changes were to be approved and implemented, then the Bulletin in which this Report is published would be titled the "August Committee Meeting Bulletin" (and not "May Assembly Bulletin"), and would contain the following information:

- 1. Agenda of the *August Committee Meeting* [which is the meeting in the title of the Bulletin]
- 2. Draft Minutes from the *February Committee Meeting* [which will be reviewed for approval at the *August Committee Meeting* for which this Bulletin is published]
- 3. Officer, Coordinator, Convention Chair, Area Information Services Liaison, and District Representative Reports *to be* presented at the *August Committee Meeting* [i.e., the most current and relevant reports]
- 4. Financials as of 6/31 [the most recent financials as of the meeting for which this Bulletin is published]
- 5. Contact information that is the most current as of the date of this Bulletin.
- 6. Flyers for events that have not occurred prior to the publication of this Bulletin.

Another alternative would be to publish the Agendas, Financials, and Draft Minutes exclusively on the SCWS website, and omit the Agendas, Financials, and Draft Minutes from the Bulletin. This would eliminate the most significant causes of the delay in

the prompt publication of the Bulletin in the week or two following the Quarterly Meeting with which the Bulletin is associated. Personally, I believe that this alternative would be ideal for two separate and independent reasons:

*First*, the alternative would permit the Bulletin to be published promptly following the Quarterly Meeting, which makes the most sense to me.

**Second**, eliminating the Agendas, Financials, and Draft Minutes from the Bulletin would streamline the Bulletin and potentially aid in the ultimate transition to discontinuing the paper publication of the Bulletin in favor of publishing the Bulletin exclusively in the website -- which is both (i) more economical, and (ii) more environmentally friendly (as discussed more fully below).

I understand that the alternative would require a technical amendment to the SCWS Bylaw.

**Third**, as a result of increased costs of printing and postage, SCWS now incurs out-of-pocket expenses to fulfill a subscription for the print version of the Bulletin that exceed the amount of the payment received for that subscription. Without an increase in the subscription cost, SCWS will be operating at a loss with respect to the Bulletin.

A One-Year Subscription to the Bulletin currently is \$15. As set out below, the out-of-pocket expense to SCWS of fulfilling a One-Year Subscription to the Bulletin is between \$17.20 and \$21.40. The out-of-pocket expenses are as follows:

Printing: The cost to print a single copy of the Bulletin ranges between \$2.25 and \$3.00 (depending on the number of pages of a given issue).

Shipping (to get the Bulletin from the Printer): The printer charges a flat rate of \$20, which equates to 25 cents per copy of the printed Bulletin (based on a current order of 80 copies).

Postage (to mail the Bulletin to the subscriber): Depending on the weight of the Bulletin (which varies from issue to issue), the current cost of postage ranges between \$1.60 and \$1.90 per printed copy of the Bulletin.

Envelopes: 19.25 cents per envelope

Mailing Labels: negligible, but not free

Based on the foregoing, the out-of-pocket expense to SCWS to obtain and mail a single printed copy of the Bulletin ranges between \$4.30 and \$5.35.

Because the Bulletin is published quarterly, SCWS's total out-of-pocket expense to fulfill a One-Year Subscription to the Bulletin is between 17.20 and \$21.40. Notably, this does not take into account the personal effort required to acquire materials, stuff and prepare envelopes, and mail out the envelopes.

Personally, I believe that SCWS could discontinue the printed version of the Bulletin in its entirety, and rely upon the SCWS website to disseminate the Bulletin.

I understand and appreciate that some Al-Anon members still prefer print over electronic copies. Any member who wishes to have a printed copy would remain free to print out a copy at the member's own expense — which likely would be less than the member is paying SCWS to print and ship the Bulletin to the member.

In addition to providing an economic benefit to SCWS, discontinuation of the printed version of the Bulletin also would be more environmentally-friendly, as it would cut down on paper usage, which requires the destruction of trees, and transportation for delivery of printed Bulletins to the Coordinator and then to each member, which requires fossil-fuel.

Absent some change in the format, the printed Bulletin also has personal contact information that is not included in the electronic copy. It seems to me that the personal information could as easily, if not more easily, be made available by individual email requests for "contact lists" that can be e-mailed back to those who desire such information. As it is, the information is only being made available to less than 100 people, and they could easily obtain the same information through an individual e-mail distribution.

For all of the foregoing reasons (and others that I am not bright and/or informed enough to think of), it makes sense to me to wind-down, if not, eliminate the subscription program in lieu of the e-version on the website. If, however, SCWS is going to continue to maintain the subscription program, it seems to me that the subscription price should be increased to \$25, to defray the cost of the print copies, which is now approaching \$22 per year, and will continue to increase as the cost of printing and postage increases.



### **YHA Convention**

After 3 years of painstaking work and spiritual transformation, we are finally on the cusp of Al-Anon's very first young people's convention. It has been an honor to serve a committee full of Al-Anon's brightest and most energetic leaders. In this final report, I want to bring attention to an issue which faces young people's groups as they continue to grow in our Area and across the globe.

(The following story is the shared experience of myself and other YHA committee members while attending individual Al-Anon groups. It does not reflect any policy or procedure of the YHA convention.)

Many longtime members feel the need to help establish or support a young people's group in its early stages. Experience from long-timers can vastly benefit young people in our fellowship. However, this support can cause harm to groups and newcomers when long-timers begin to outnumber young members in a young people's group. Some groups may justify this demographic change by naming their group "young or young at heart." Though all members are welcome to attend, "young" is still the primary focus (members anywhere from late teens to 30s and early 40s). For a group to use "young" anywhere in its name, it must be welcoming to all young people; transitioning Alateens, college students, new parents, and young adults all need a place to see others like them in Al-Anon. If a majority of regular members in a meeting are 50 years of age or older, the meeting should consider removing the term "young" or "young at heart" from its name.

Recently, a group of YHA committee members including myself attended a "young people's" group in our Area. The meeting was comprised of members

all over 50 years of age. A despairing newcomer in their early 20's showed up expecting a young people's group, but instead found a gathering of grandparents and senior citizens. The long-timers in the meeting tried to console the newcomer after the meeting, but the individual later remarked that they did not feel safe around members so much older, and had spent over a year searching for a group with someone their age. Sadly, this newcomer's spiritual state continued to worsen and they had to be admitted to the hospital later that evening, pending psychological treatment. This is the reality young people face when starting the Al-Anon program. This newcomer did not drink or use drugs. They suffered from the effects of another's drinking. After witnessing that evening's turn of events, I can't help but wonder if I would still be here today if my first young people's meeting was like that. Al-Anon is a program of honesty. Please consider the newcomer when deciding whether or not to attend a young people's group as a long-time member. YHA will continue to educate and advocate to ensure that the next generation of Al-Anon members will be loved, welcomed, and represented. Thank you for the opportunity to serve as YHA's first chair and thank you for my life.
