August 2003 Delegates Report

for the Southern California World Service (SCWS) Committee

I was so full of enthusiasm in May that I don't remember if I expressed my gratitude for the love gifts and cards you send me while I was at the World Service Conference (WSC). Today I'm still as enthused, but I'll start by saying **THANK YOU** for your love and for allowing me to grow in service as your Delegate. And thank you to for sending the newsletters that keep me informed of the events and issues within our Area. As your Delegate, I bring information to you from WSO and I also take your information back to WSO.

Today we have a lot to tell you, but we also want to hear what you have to say. I'll start with the **big news: our Area was drawn in the WSO Public Outreach (PO) contest.** Therefore, we will receive \$1,200 in free Al-Anon materials and two people from WSO will join us at our upcoming November Assembly. Our PO Coordinators, [formerly known as Public Information (PI), Institutions, and Cooperating with the Professional Community (CPC)] will have more of the exciting details for you. WSO wants me to get an estimate from you of how many members will come from your District for the special November Assembly because they will be bringing packets for everyone who attends. I'll send out a request in a few months and remind you to let me know about how many to expect. We may even have to rent extra chairs and forego the tables if there is a big response. This is a great opportunity for members to be inspired about service and about our possibilities for Twelfth Step work in Public Outreach (PO). It seems the excitement is building because I'm hearing great things about projects that have already begun.

The special project that your PO Coordinators are putting together is wonderful. It will be a coordinated effort to reach out to the spiritual leaders in our communities to let them know that Al-Anon is a resource for the families and friends of alcoholics. These leaders come in contact with many people who could use Al-Anon. Your PO coordinators have prepared an outreach package and will provide training and materials to in November. In addition there is a sample packet for each of the DRs and Intergroups liaisons here today. The full packets (one per District and per Intergroup) are planned to include:

- 1.Best of Public Outreach service packet
- 2. Sample letters to the Spiritual Leaders (English and Spanish)
- 3.Multiple copies both outreach pamphlets: for African Americans and Native Americans
- 4. Multiple Professional Packets, K-30
- 5.2 of new Al-Anon video, AV-31
- 6. How Al-Anon Works book, B-22 (for Districts only)

Copies of Sept. Forum focused on members who were referred by Professionals also available

WSO has stressed how valuable it is to include meeting schedules in the information we provide to professionals. We are asking that you plan to print (and purchase) extra meeting schedules to include in your PO work for this project. Those of you who are in the Public Outreach ACTION Committee will hear more

details today. Since we just found out this month that we were one of the 25 Areas who will be receiving this special PO help from WSO, we still have lots of details to work out and more information will be sent to you as it evolves. We hope to see LOTS of Al-Anons here in Nov. to get involved in this exciting mass PO project for Southern CA and to share their ideas and concerns with us and the WSO.

I also have a report I will present during the New Business portion of the meeting today, regarding Alateen (see the separate handouts).

CHANGE! Create New Possibilities is the Conference theme for 2003 and we're sure doing that here. It's my pleasure to tell you that we have a new Intergroup forming. Please welcome the Centro de Servicio Hispano Del Inland Empire. We also received a formal request from a group in Bishop who will be leaving us and going instead to the Area Assembly in Nevada since it is hours closer for them. Please sign the cards that are going around for both these groups. Also, welcome to our new Bulletin Editor, Nick.

The WSO wants to know if you are using the 2003/2004 District Game Plan (Service Plan – the fold out road map with ideas for PO). If so, please drop the WSO a note and let them know if Service Plans are a valuable tool that you want continued in the future or if they should stop producing annual Service Plans (if they don't hear from us, they'll likely stop producing a Plan).

Remember that the new poster "My Life" (M-61) is available and may be a great PO tool to post at your meeting facility and other locations. It's available in English and Spanish and is a good graphic to help reach out to a diverse population, including teens.

The WSO has an opening for a paid Assistant to Barbara O, in Alateen, in the Virginia Beach office. Check with Personnel at WSO if you're interested.

Have you used our Area website? http://scws-al-anon.org now has the Bulletin posted (less the pages with our personal names and addresses), events, meetings, bylaws, motions and more.

We received constructive suggestions for improvements to our ACTION Committees. As your new board and coordinators, we appreciate the input and the love as we adjust to our new roles and responsibilities. We've been using email as a way to connect with you between meetings. If we don't have your email, make sure to give it to Margie today. If you don't have email, we still use the US post office too, but you Committee members are welcome to find an email buddy who will let you use their email address to get your SCWS Area news. Just let Margie know.

I thought I'd have copies of the 2003 Conference Summary to bring along today but I haven't received them yet. You can order copies for \$3 from WSO or read the condensed version on the WSO website at http://www.al-anon-alateen.org/members, follow the instructions then go to Fellowship Communication, then to Newsletters, then to Conference Edition. At the same website you can also download Al-Anon/Alateen guidelines which can be found under Group Services.

WHO DO YOU KNOW? While WSO is here in our Area in November, they would like to meet with members involved in the media. If you work in the media or know someone who does, please fill out that information on Lil's PO form and return it to her so we can make plans for Nov. Please be sure to include how you're involved in the media and an email address if you have one. That form will also play an important role as we work together to find spiritual leaders in our Area. Please write down the spiritual leaders that know: clergy, tribal leaders, chaplains at jails, hospitals, colleges, etc., and any professional events that they attend together (joint ministry conventions).

As we work together to set the agenda for Nov., we need to think about how

will we structure our Nov. Assembly. It will be a busy day. Could we consider a working lunch with Alateen selling us sack lunches? WSO needs a 90-minute block of time to talk and to listen. Plus we want time to provide tips to GRs on the PO project, to continue our Alateen discussion and to gather in our ACTION Committees. WOW, can you imagine that some day we might want to have a longer Assembly so we can get more done. CHANGE! Create New Possibilities.

Alateen is part of Al-Anon Family Groups (from the SCWS Delegate's Report August 2003)

Each Al-Anon family group has but one purpose, to help the families of alcoholics (as part of Tradition 5). And Alateen is part of Al-Anon. Many of our children are families of alcoholics.

Alateen began in 1957 when 5 children of alcoholics started a meeting to help solve their common problems. Alateens 5th Tradition says that Each Alateen group has but one purpose, to help other teenage relatives of alcoholics." Alateen is Al-Anon and new literature will use the word "Al-Anon/Alateen" (note that there is no hyphen in Alateen but there is in Al-Anon).

Some think that Alateen is not working. The random group survey underway now may help show us trends. There are many children of alcoholics (some of us were/are), and our Al-Anon purpose is to help families of alcoholics. When I was at conference I heard talk about "viability of Alateen." That concerned me, but I thought perhaps I didn't understand the word "viability." As I asked for clarification, I found that there are people who question whether or not Alateen should continue. Since WSO is currently hiring an Assistant to the Alateen Director - I think Alateen will continue. In July, our Alateens at SCAC sent wonderful sharing to WSO to convey how important Alateen is.

Discussion of Alateen is close to many hearts (especially the teens) and our responses could become heated quite quickly. Perhaps it's because these are our children we are talking about and our natural instinct is to protect them. Let's remember that God is here with us, and ask that we try to keep open minds and to seek spiritual solutions in our discussion. Safety is the issue that I hear WSO talking about with regard to Alateen. This refers to safety of the children and safety of the sponsors. Not just physical safety, but safety from inappropriate behavior, sexual advances etc. Perhaps this concern about safety stems from the recent lawsuits and problems in the news regarding Catholic Church, Boy Scouts and other agencies who have contact with children. Perhaps some concern (fear) could be regarding legal liability and financial suits against Al-Anon. But overall I think we are loving people who want to do what we can to protect the children in Alateen.

At the Assembly I said that part of the new Sponsor's form that sponsors are required to sign, states that they agree that they will step down if there is controversy. In our Area this year, Kathi (Alateen Coordinator) and I have been involved in two instances where we have asked sponsors to step aside. This was not easy and does not mean that those sponsors are guilty of anything. Rather, that there was controversy and that for the good of the fellowship as a whole, they have stepped aside. These people are loving members of Al-Anon/Alateen. This issue has certainly not been easy for them, or for the Alateens in their meetings. However, this is our policy and therefore it's something that I am willing to try – and to try in the most loving way I can. I remind myself that I am not being a judge, or Al-Anon police, I am lovingly trying to find solutions that can work for us.

I am an Alateen sponsor myself. I love the children (my current group is younger members who are not yet teens) and the dedicated sponsors. Having to asking sponsors to step down may not be the answer – and in fact, there is no

answer that can prevent future bad things from happening. But I believe that my primary job as a sponsor it to be the adult who is there for the safety of the meeting. Even with the younger members in my Friday night group, ages 5 to 11, they run the meeting themselves. I'm there because it's a requirement that an adult be present in order to have an Alateen meeting. The fact that we have Sponsors says to me that Al-Anon recognized our (Al-Anon's) responsibility for the safety of Alateen and that it's good for us to think about it again today.

I want to clarity that for me, asking sponsors to step aside because of controversy refers to controversy that would appear outside our fellowship. It's not because I didn't agree with how they run a meeting or work their own program. Through the process of trying to apply this guideline, we learned that there are gray issues and that it's not going to be easy. But because I'm asked to consider children's safety, as your Delegate I would only be comfortable asking a sponsor to step aside if the controversy related to an illegal or dangerous activity - not because I didn't agree with how they worked the program or followed the traditions. In those cases I would feel like a judge, but in the cases that the controversy surrounded something potentially illegal, I could feel more comfortable that I was truly taking action related to the safety of the children. We need to avoid putting personalities above principles. We also must not turn a blind eye to issues that appear to have the potential to be legally inappropriate. Again, my personal guideline for the policy of sponsors stepping aside is related only to controversy surrounding possible illegal allegations, not a matter of internal application of the program.

OK, I've spent considerable time talking about the problem (or potential problem) but not about the solutions. Some simple guidelines are already suggested in G-34, *Alateen Safety Guidelines* and others are being considered:

- ■Sponsors are required at all Alateen meetings
- ■TWO adults at all Alateen meetings may be good safety step for the Sponsors and the teens
- Some sponsors even suggest two adults of opposite sex, and not just in meetings but in cars too
- ■Parental permission slips for transportation and for any overnight events are included in G-34
- ■Some Areas conduct background checks on sponsors to alleviate any sponsor with a criminal background

In our ACTION Committee breakout we will be taking about safety guidelines and we will try to provide a recap today of our discussions for those of you who are not in the Group Services ACTION Committee. Kathi and I may also try to follow up with a recap by mail.

One thing you can do now is to choose an ACTION for your District for Alateen Focus Month, which is in October. See the attached calendar of ideas. For example:

- •Invite Alateens to share at an Al-Anon meeting (or let them hold their meeting with you, the Al-Anons, as observers)
 - Give a subscription of 10 "Alateen Talk" quarterly newsletter to your group and also to a neighboring Alateen group or children's home
 - Ask Al-Anons with children why their children don't go to Al-Anon and listen for their answers (that may help us learn what it is that needs to change)
 - ■Bring an Alateen along to your next service meeting, etc.
 - ■Encourage each GR to have their group choose at least one Alateen ACTION for October

Areas have been asked by WSO to consider adopting Area Alateen Guidelines. The following are some things to consider. These roles correspond to ideas from other Area and Counties - see the handout information provided by the WSO, titled "Area Guidelines – Things to Consider."

- Roles of the Alateen Groups (and Conferences SCAC)
- ■Roles of the Al-Anon Groups (members, parents and Districts) Commitment of our Area
- ■Roles of Alateen Sponsors (and District Alateen Liaisons)
- ■Requirements for Alateen Sponsors (are these guidelines or requirements?)
- ■Who can be a Sponsor? How do we decide to accept Sponsors that volunteer?
- ■Who may ask Sponsors to step aside, and why?(from the SCWS Delegate's Report August 2003)

They are preparing to start selling Spanish literature from a small space, not really an office, more like a storage space. It is great to be able to talk with them about how they are getting started. And they have a lot of support from the other Spanish Intergroup office in Santa Fe Springs and the surrounding AA groups. As a fundraiser, they are putting on monthly Marathon meetings. I have a flyer if you'd like to copy the information down and go support this effort to carry the message.

Our Annual Sharing of Service Workshop is scheduled for Saturday, January 17th, 2004. Our afternoon speaker will be Mary Fran Walker from Pine,

AZ. She is a longtime member of the Arizona service structure as well as a past Chairperson of the Board of Trustees. The worksheet asks you to plan the Action to take, What Time Frame you'll need, An Approximate Budget to accomplish your goal. This is a great way for the Action Committee Chairmen/Facilitators to keep track of the various projects. If your District or Intergroup Group or Convention needs help from the expert coordinator, Just ask. Feel free to copy and use as you wish. A copy each to your Action committee chair and coordinator will be appreciated when we report to the Assembly and WSO later in the year. Lee, has made copies of the actual form we submitted for the Outreach to the Clergy, you may want to review.

Please notice the agenda today has the assignments for the your action committees on the back. It will really help if you attend the one indicated. Reportbacks will be made from the other Committees so you know what important Action happened.

The Restructure Committee will meet again in September to review your ideas and make suggested steps for proceeding in 2004. I would appreciate your evaluations returned today.

Minutes Southern California World Service Committee Meeting August 16, 2003

9:00 District Representative and Intergroup Liaison Training & Writing Workshop Information

9:00 Alateen Liaison Meeting

Chairperson Kary L. called the meeting to order with the Serenity Prayer at 10:00 A.M. followed by committee member introductions.

Traditions were read by Lucia C., District 64.

Minutes Secretary Shirley M. read February 2003 Committee Meeting minutes.

Treasurer Tom E. asked that committee please get the new treasurer's mailing address out to meetings. The past treasurer is getting about half of the contributions and the postage to date has been about \$100 to get them to Tom. He reviewed that SCWS will pay mileage for travel over 100 miles and reminded committee members to get reimbursement form. Meetings or districts pay expenses up to 100 miles. Tom reviewed 2004 budget and reported that we currently have three CD's (\$12,000, \$5,000, \$5,000). He recommended that SCWS invest in Treasury Bills because the return is a little higher. In answer to questions, he said that Treasury Bills can be cashed in after one year without losing interest the same as CDs and that the bills are backed by the government. This would not break Tradition 7 as we are not contributing. All levels of world service do some investing similar to this which is covered in Warranty 1.

Action to be Taken

2004 Budget to be presented at November Assembly.

A majority show of hands elected to have Treasury Bill recommendation brought before November Assembly.

Delegate Miriam M. announced that both Southern California and Northern California World Service outreach projects have been drawn by WSO. SCWS will receive \$1200 free materials and Mary Lou the Media Coordinator and Trustee from Ohio will be our World Service guest at the November Assembly. Districts and Intergroups will be asked to contribute meeting directories to the project. She asked everyone who has e-mail to give address to the Records Secretary in order to receive updates. (Group was shown new Public Outreach video and Lee T., CPC Coordinator reviewed guidelines for working in Public Outreach. Guidelines are available on line.) Project will be discussed further in Public Outreach Action Committee . A new Spanish Intergroup has been formed in the Inland Empire. Meetings in the Bishop area are moving to the Nevada assembly. WSO wants to know if districts are using the District Game Plan. If your district is using it, please let Miriam know. WSO has an opening for a paid assistant. Anyone interested is asked to contact the WSO office. Miriam has received a report concerning the \$500,000 loss shown by the WSO. Some of the loss was money for employee health insurance, part was paper loss from stocks, and the rest an actual loss. Anyone interested in seeing the report, see Miriam at break. Alateen information will be shared later in the Group Services Action Committee.

Action to be Taken

With a majority show of hands it was recommended that Public

Information Packets be mailed to Intergroup Chairs and District Representatives.

Records Secretary Margie L. suggested that groups use only WSO number for Records and Treasurer forms and asked for District Representative input. Discussion regarding this will be conducted in Group Services Action Committee. Roll call was taken.

Past Delegate Kay D. reported that the three outreach coordinators met in person and by e-mail. The board decided to have committee members experience another Action Committee Meeting in order to be more knowledgeable and comfortable before the full assembly does so in November and to receive input one more time from DRs and Liaisons. Project Worksheets and Evaluation Forms were distributed. Kay asked that Evaluation Forms and Action Committee minutes be placed in Shirley's (Minutes Secretary) box after the Action Committee sessions and report backs. Old Business:

* PRAASA Al-Anon Co-Chair Cherri C. announced that Delores M. from WSO will be the Al-Anon speaker. Registration forms for the March 3-5 event to be held at the Hyatt Regency in Irvine will be out in September. New Business:

Alateen Coordinator Kathi L. shared that WSO has asked the areas to consider the viability of Alateen. The number of Alateen meetings has decreased considerably. Al-Anon members are not sending their children to Alateen. There are legal concerns regarding sponsors, drugs, etc. Al-Anon is liable for the actions of Alateens and sponsors. Controversy could hurt the fellowship and its image. They are looking to California for help because California has the largest number of Alateen meetings and has experience, strength, and hope to share. Kathi suggested that SCWS form a committee to address the issues. Prevention and precaution is better than insurance. Group Services Action Committee will address the issue.

Hospitality Coordinator Martha M. announced that the following districts will be responsible for breakfast items at the November Assembly: 17, 21, 27, 33, 36, 54, 57, 64, 66, 72

Alternate Delegate Sue P. requested that Ask-It Basket questions be phrased as questions. She reminded everyone of Sharing of Service Saturday, January 17. Mary Fran W., Past WSO Chairperson of the Board will be the speaker. Flyers are available. Forum Can was passed around with a reminder to put name, address, and telephone number on drawing slips. Sue announced previous winners. Miriam asked whether Assembly should vote on SOS travel budget for speaker and anyone who travels over 100 miles to serve. Treasurer Tom E. reviewed SOS budget. SOS costs between \$1,700 to \$2,000.Last year \$632 was raised. Attendance was down with only 150 participants. It is hoped to raise attendance and \$900 this year. The minutes secretary reviewed decision by the Board that this was not necessary because the Board oversees this budget. The SOS Chairman will be given discretion to use common courtesy as a guideline to determine number of night, meals, etc. for the speaker. Normal mileage and room reimbursement generally apply to Al-Anon members who serve. The SOS Chairman will be given the discretion to determine if there is to be something additional. A show of hands by those present concurred and item will not be brought to full Assembly for approval.

Action Committees Breakout Sessions were held from 1:00 to 2:50 P.M. Chairperson Kary L. reconvened whole committee at 3:00 P.M. She asked for approval to pay the Action Committee Facilitators mileage. A majority show of hands approved. The Past Delegate noted that this was approved before.

Concepts were read by Christina S., Ventura County Intergroup Liaison. Ask-It Basket questions were answered.

Action Committee Report Back Summaries were given.

Full reports for Officers, Coordinators, District Representatives, Liaisons, and Action Committees are in Bulletin.

Coordinators' Reports

Alateen Sponsor

Hi, this is Kathi, your Alateen Sponsor Coordinator, and I must admit that I am still feeling a bit overwhelmed in this position. There's been a lot on our agenda today about Alateen. This morning I met with the District Alateen Liaisons to talk about their roles. That discussion included ideas about communication. Communication between Southern Cal World Service and the Liaisons, and Communication between the Liaisons and the Alateen meetings and sponsors in their districts. It also included discussion about SCAC scholarships and how that process worked, and how it could be improved. I handed out some ideas about the role of District Alateen Liaisons

I'm still receiving lots of correspondence regarding Alateen, and I'm still trying to figure out the best ways to keep up with it. I get communication about many thinas:

People wanting to start new Alateen meetings, people interested in Alateen and wanting to know what they can do, how can they become sponsors, people wanting to start meetings in institutions, etc. World Service in Virginia Beach (in the form of our own Barbara O., is working on sending these items via email, which is a much better forum for me. But I really would like to share the wealth. I think this correspondence should be forwarded to the proper district, because it is that district that will have more information to give these people.

As far as I know Molly and Willie are still willing to lead Alateen Sponsor Workshops, but we really haven't been asked to put any on. Please, if your district would like a workshop, you can contact me at email at kathilau2@aol.com and I will coordinate with them to set it up.

I'm still anxious to get an Alateen Newsletter going, and hope it will be in place by the November Assembly.

Since I started this job, some interesting challenges have appeared. As Miriam mentioned in part of her Delegate's report, we did ask two Alateen Sponsors to step down as sponsors because some things happened that could have created a controversy regarding our fellowship, outside our fellowship. The act of asking these sponsors to step down was not based on any investigation we conducted; it was not about deciding who was right or wrong, guilty or innocent. We simply followed the tenets set out in the latest sponsor registration form that says an Alateen sponsor will step down if there are any accusations, controversies, or threats, that interfere with the primary objective of helping Alateen members follow the Al-Anon program. The form clearly states that "stepping away from sponsoring an Alateen group is not an admission of guilt."

World Service in Virginia Beach is asking the areas that have not already done so, to prepare Alateen guidelines for their areas. It is suggested that these quidelines be concerned with Alateen Safety Issues, guidelines for selecting and keeping Alateen Sponsors, and guidelines regarding Alateen Conferences and their connection to the Area's World Service Assembly. Miriam has provided you with a recap of guidelines that are in place or are proposed for other areas. One of our ideas is to form a committee to put together a proposed set of guidelines.

World Service is asking what is happening in our area regarding these guidelines, and who is involved. Specifically are there Alateens and Alateen Sponsors involved in the process?

World Service also wants to know the top three "Alateen concerns" in our area.

October is Alateen Focus Month. Miriam has also included a copy of this calendar for each of you. This year is the end of the 3 year trial period for having an Alateen Focus month. What are our suggestions about increasing the awareness about Alateens? How do we encourage Alateen participation in the Alateen Focus month? How does our area encourage Al-Anon participation?

It is our hope that we can focus on some of these areas today and come up with some proposals for our area and some information to give to World Service.

Once again, thank you for allowing me to be of service. Alateen is very near and dear to my heart and I feel very privileged to be able to serve in this capacity.

2004 PROPOSED BUGET

For Discussion & Approval at the November 15, 2003 Assemly Mtg.

Budgets are "guestimates" based on history, projections and planning. The following are explanations of unusual or large proposed budget items for the 2003 SCWS Budget. The 2003 Budget requires the approval of the Group Representatives at the November 2003 Area Assembly. Please consider the following proposals offered by the Treasurer, based on input from the Officers and Coordinators:

Line 9) SOS Income: Costs continue to increase. The actual cost of SOS 2003 was over \$6.00 per attendee. Therefore, as was discussed at last year's assembly, registration will be increased to \$4.00 for January, 2004.

Line 13) Computer Hardware/Software: The budget includes a computer and printer for the Bulletin Editor. The computer software and hardware for the Records Secretary was upgraded in 2000 and for the Treasurer in 2002. The software used by the Bulletin Editor requires an up-to-date computer. The Bulletin Editor should be provided with a computer provided for SCWS use.

Line 18) Alateen Coordinator Expense: The costs of expanding communication with Alateens and Alateen Sponsors via Sponsor Workshops, a Sponsor weekend and more mailings will increase costs to at least the 2003 levels.

Line 28) Delegate Equalizer Fund: A letter was received from the WSO indicating the "full cost" for WSC 2004 at approximately \$1,556; the "equalized cost" is \$1,000. The 2003 budget is for the estimated "full cost" for the 2004 WSC. SCWS pays the "full cost" for a delegate to attend the week long World Service Conference, including airfare (1993 November Assembly).(See the Service Manual pg 115 for a further explanation)

Line 30) PRAASA (Pacific Regional AA Service Assembly): Four of the six elected officers, the Delegate and the Immediate Past Delegate, the Alternate Delegate and the Chairman, plus 3 to 5 of the other officers and Coordinators have been provided hotel, transportation and meals. (1989 May Assembly) The budget depends on the location of PRAASA each year.

Line 31) SWRSS (Southwest Regional Service Seminar): This event is planned only once each three years and was held in 2002. The entire Board of Officers and Coordinators is provided hotel, transportation and meals. (1985 May Assembly)

Line 32) SWRDM (Southwest Region Delegates Meeting): Four of the six elected officers, the Delegate and the Immediate Past Delegate, the Alternate Delegate and the Chairman are provide hotel, transportation and meals. (1984 November Assembly)

Line 33) DR/GR/Liaison Mileage/Hotel: The hotel budget is for members driving over 100 miles one way to a Committee or Assembly Meeting. The mileage portion is for reimbursement of any excess over 100 miles. The first 100 miles should be reimbursed by the meeting, district or intergroup.

Line 34) Officer/Coordinator Mileage/Hotel: This budget is for all mileage to all meetings including visits to Districts by officers and coordinators as well as hotel reimbursement of \$50 for officers or coordinators driving over 100 miles one way to a Board, Committee or Assembly meetings. The budget was reduced to \$5,000 for 2004.

Line 37) Delegate Expense: The budget has been increased to \$1,100 to include costs related to the restructuring effort. The estimates for various officers and coordinators have also been increased to provide for the increased costs for restructuring (primarily for copies and postage). The total in the whole budget is approximately \$1,100.

Line 43) Liability Insurance: The cost of insurance has continued to escalate. A modest increase is provided in the 2004 budget.

Line 47) Professional Translator: With the number of Spanish speaking attendees at the Assemblies, it has become necessary to have a professional translator. By continuing to include this budget item we hope to encourage our volunteers to focus on their Area positions as DR, GR or Intergroup Liason for the Spanish speaking Al-Anons

Ask It Basket

Q: Is there anything the SCWS can do or help the SCAC conference be more coordinated or better quided?

A: This would be addressed in Area Guidelines re: Conferences, in connection with the World Service Alateen conference guidelines.

Q: What is the age limit for Alateen? I have heard it is up to 21. See page 65 of the Service Manual. "As the name implies, Alateen is designed for members in their teens." "It is within the autonomy of each Alateen group to lower the age limit..."

A: Based on the Service Manual, it appears 20 & 21 year olds should attend Al-Anon, not Alateen. There is not set rule, but it is suggested that 20&21 year olds attend Al-Anon. 20&21 year olds can usually attend both Al-Anon and Alateen meetings while transitioning between the two.

Q: Can you let us know which districts need to get new addresses out by the ones that are coming in wrong? I've put it out at each district meeting OK, which meetings are still doing it wrong? (Sending contributions to the previous treasurer's address)

A: We share experience, strength and hope. We can't do it wrong, just more efficiently.

Q: Can you recommend strategies for getting the word out about local Alateen meetings to my local AA meetings? When I go to open AA meetings, the speakers are usually disparaging of Al-Anon and Alateen. Once I asked an AA meeting secretary if she would announce a local Alateen meeting. She flatly refused stating that it was an outside issue.

A: Al-Anon has in its Traditions that we cooperate with AA. AA does not have that in their Traditions. Therefore it is up to each AA group's autonomy if they are willing to make Al-Anon or Alateen announcements. All we can do is ask. Editor's note – It might be nice to share a copy of AA's Statement of Gratitude with AA folks who do not understand that we have a special relationship.

Q: Do Alateen meetings elect a GR who attends District meetings and Assemblies?

A: Yes, every Alateen meeting is supposed to have a group representative.

Q: Is it a violation of Traditions to collect money from an Al-Anon group to pay to an Al-Anon speaker from another country?

A: Service Manual p. 77 – "Use of Group Funds", 1st paragraph - "Rent and Other Expenses" and "Payment for Speaking" - "In keeping with the 8th Tradition, Al-Anon speakers are reimbursed for expenses only."

Q: If I'm a GR, can I do service as secretary, treasurer, etc.?

A: Although the 4th Tradition allow for group autonomy, it may not be a good idea because the 7th Tradition encourages us to be fully self-supporting. Every person

contributes. Also the 4th Concept encourages participation as the key to harmony.

Q: Can district funds be used to pay individuals (gas money) to drive teens to SCAC?

A: Do the groups that are contributing to the district know that parts of their funds are for this purpose? Our service manual does not mention that as a part of the usual expenses of a district. See pages 124 & 125. It would be within the districts autonomy to do so as long as it does not affect another group or AA or Al-Anon as a whole.
