

DELEGATE'S REPORT August 2014

Greetings CA(S), Area 04! I have been procrastinating doing this report. When I searched my heart I realize that it is because there is only one more report to do as your Delegate. As they say "I am in the twilight of my years as your Delegate". It saddens me and yet invigorates me. Rotation of leadership is part of being of service and a cornerstone for all positions, even the Delegate. I still have one more report so I will save those thoughts for the next report to be done while still serving as your Delegate!

World Service Conference 2015

The Conference theme for 2015 is "Living Our Spiritual Principles: Expanding Our Vision." The Conference will be held in Virginia Beach, VA from April 20 - 23, 2015. The trip to Stepping Stones will be April 25, 2015. The Stepping Stones trip is optional for all WSC Delegates. Our next Panel 55 Delegate, who will be elected in November, will attend the Conference.

Alateen 2014

The SCAC Web site was terminated immediately following SCAC 2014. A new SCAC Web site is coming and will be within the SCWS Web site. The Guideline (G40) states: "Alateen names, email addresses, and phone numbers should never be posted as contacts on flyers or Web sites. On sites open to the public, the exact day/time/location of Alateen events cannot be posted. On password protected Web sites, open to members only, the time and location of events can be posted." More information will be available as the Web site is developed.

The Area is requesting that SCAC use the SCWS permanent address for the 2015 SCAC registration. There was a huge issue with the mailing/returning of the SCAC 2014 registrations. Registrations were returned or never found. The problem unfortunately cost SCAC \$1500 in cafeteria expenses. We have started the conversation and hope the SCAC Committee agrees that it is the prudent thing to do for 2015.

The Area Alateen Requirements Task Force made three recommendations for continuing discussions. There are two Task Forces yet to be formed for Alateen. One Task Force will look at the background check company to determine if using another form of background check would be a better option. The other Task Force is to determine if the age of Alateen in the Area should be changed and whether the multiple overnighters held by the SCAC Committee should continue. No other Area has a conference where the Alateen Committee spends multiple weekends together to plan an event and/or the conference.

The Area is in the process of taking positive measures to educate and inform all Intergroups in CA(S) to understand the procedure of confirming that an Alateen Meeting is registered with SCWS and WSO prior to listing on a Web site or a Directory listing. An Alateen Meeting MUST be registered and have valid AMIAS(s) prior to any listing. Any District or Intergroup can confirm this information with the Area Alateen Process Person (AAPP).

Chairman of the Board Letter (COB)

The COB letter is on the members' Web site. It discusses the need of defining family recovery that could be universally understood outside the fellowship by professionals and during public outreach activities. The proposed definition was: "Family recovery is a process of healing and growth from the effects of living in a family affected by someone's problem drinking. This process helps individuals to make healthier life choices, and to develop relationships that are more www scws-al-anon ora





During the Conference discussion, a revised definition was proposed that had substantial support: "Family recovery is a process of healing and growth for family members affected by someone's drinking. This process helps these individuals make healthier life choices and

develop relationships that are more positive and supportive."

Delegates are asked to discuss both versions of the definition of family recovery in their Area and be prepared to discuss them at the 2015 WSC.

The Forum is continuing to celebrate its 60th anniversary this year. The new e-Forum annual and monthly subscriptions are available on the Nook. Forum subscription income decreased by 7.3%. Are you receiving the Forum? Is your meeting promoting The Forum or merely using it as a lending library?

Literature sales at the end of June 30 had increased 6.5%. The increase in gross profit was the result of the price increase effective May 1, 2013. Contributions have increased by 11% compared to last year at this time.

Concept One states: "The ultimate responsibility and authority for Al-Anon World Service belongs to the Al-Anon Groups." Part of that responsibility is for the groups to financially support the services they ask the World Service Office to provide. It is not what the group gets but what the Group is part of and what it costs for the Group to be a full participant in those efforts that is important. How do we put a price tag on what we have been given in this program?

New Daily Reader

Considerable discussion took place at the 2014 WSC before a motion carried to give conceptual approval "to develop a new daily reader that reflects diversity of the Al-Anon fellowship". The intent is that the book would share diverse experiences of the fellowship, as it is today.

The Literature Committee is currently developing a writing guideline with ideas and parameters for writing for this new daily reader. How can sharings that voice various perspectives reveal, where appropriate, the differences as well as what we have in common? How can we come up with ways to get writings that mirror the inclusiveness of the program? If we want this new daily reader to fulfill its potential, ideas are needed to make this happen.

Sharing of Service Workshop (SOS)

The Sharing of Service Workshop (SOS) will be held January 17, 2015 at the Glendale facility. A KBDM workshop will be presented that morning. How to use KBDM in your meetings and districts? (The KBDM quick reference tool is on the SCWS website). In addition, Judy Kirby, Trustee at Large, WSO, will be our guest speaker. A Conflict Resolution workshop will be held in the afternoon.

Pre-registration will be held at the November Assembly. Flyers will be available for distribution. We would like to see a huge turnout for this event.





November Elections

The Election Assembly is held once every three years. I recommend that everyone read Concept Nine prior to the Assembly. It is on page 248 of the Service Manual. Bill W.'s slightly modified essay on "Leadership" is included in that portion of the Concept. It was printed in the 1959 issue of the A.A. Grapevine. It considers specific personal qualities of a World Service leader.

Please also turn your attention to the SCWS web site and read the five job descriptions and the resumes of the nine individuals who have chosen to submit resumes for an officer position. I hope each of you take the time to read the job descriptions and resumes, as part of the KBDM process prior to coming to the Assembly in November. Assess the qualifications for the officer positions that these individuals stand for and pray to your Higher Power. Ask your HP for the wisdom and sound judgment to cast your electronic vote!

Report 8.16.14

I took advantage of my once-a-panel SCWS Area-sponsored World Service travel opportunity to spend the weekend of May 30-June 1, 2014 to attend the New Mexico-El Paso, TX Area General Assembly in Santa Fe, NM. This was the first time I attended an area assembly outside of California South and it was fascinating to see how other Areas organize their Assembly which in their case took two and a half days. Having served as coordinator of this panel's Thought Force on District 64, and having the privilege of continuing to serve on our current Task Force on District 64 with co-chairs Elizabeth and Lorena, I was curious to see how New Mexico-El Paso serves its Spanish-speaking meetings, both with the organization of its Districts and how they handle English and Spanish presentations at their weekend-long Assembly. I will report in more detail to the District 64 Task Force but here are a few highlights.

New Mexico has about the same percentage of Spanish-speaking meetings as we do in California South. However, at their Assembly everyone wears headphones, and I listened to several presentations that we made in Spanish and translated for me into English. It was an interesting experience wearing headphones at an Assembly. I felt I got to walk in our Spanish-speaking members' shoes for the first time. They also translated almost every document shared at the Assembly—even the financial reports! They have been working on creating more unity within their fellowship for about a decade so it made me excited for what we can do here in Southern California. In fact, at the next Assembly, the Officers decided at our last meeting that we are going to follow New Mexico's example and say the Serenity Prayer and the Al-Anon Declaration in both English and Spanish. I am grateful to New Mexico's Delegate Jud L and the New Mexico Board for their truly warm welcome.

Our Delegate Jayme will go into more detail on the SCWS Sharing of Service day we are planning for Saturday, January 17, 2015. It's going to be a fun day of fellowship and service. Our Al-Anon Trustee-at-Large from Nevada Judy K. will be our keynote speaker. We will also have workshops on Knowledge-based Decision-making (KBDM) that Al-Anon members can use with their groups or on service assignments beyond the group level. We are also going to have a workshop on Conflict Resolution, using our new Conference-approved literature on that subject. Please mark your calendars. We will send out flyers shortly and will have pre-registration at the November Assembly.

Thank you for all your Ask-It-Basket questions from the last Assembly. We had more than 50 questions and we hope lots of members have read these Questions and Answers in the Bulletin.

I hope you'll also thank all your GRs for their generosity during the Forum and Al-Anon y Alateen en Accion collection during the Assembly. We were able to give away 8 subscriptions to the Forum to GRs who were present. Please continue to remind all GRs that it is one of our important responsibilities to promote subscriptions to these Al-Anon magazines.

August Committee Meeting Chair Report

We are coming to the end of this panel; our terms will be up at the end of December. Elections will be held at the November Assembly. We are trying two new things to make our elections go smoother and be better informed: resumes and electronic voting.

Resumes

Look for candidate resumes in this Bulletin and on the Web. The resumes were submitted by the end of the day of the August Committee meeting.

The resumes aren't position specific. Candidates do not have to declare which position they are standing for until the November Assembly, and if they lose for on position, they can stand for another. Submitting a resume does not even mean the person will stand for office.

I found the resume form to be one of the hardest I've ever filled out. I'm pretty sure that means it is a good form with probing questions. Please be sure to read the resumes and share them with your group so that we can elect the most qualified candidates as officers for the coming panel.

Electronic Voting

We will be using clickers for the election. We will go over the procedures again at the Assembly and vote to approve them. If for some reason, the clickers do not work, there will be paper ballots as a backup.

The Elections and Voting Procedures Task force has done a terrific job working on the procedures. In particular our Immediate Past Delegate, Sandie, and our Secretary, Elizabeth, have worked very hard and spent countless hours. We owe them and the task force a large round of applause.

The November Assembly will start at 9:00 AM, with orientation for new Group Representatives at 8:00 AM.

Alateen Lunch

At the last Assembly lunch was delayed over an hour, which turned out to be a major inconvenience and source of irritation. We've had discussions with the SCAC Alateens considering alternatives and they asked to prepare lunch for the November Assembly. They have promised to be on time with a more substantial meal than in the past. They are aware that this is a trial run.

Spanish Coordinator

Our Spanish coordinator has stepped down. I am looking to appoint a replacement for the remainder of this panel. If you or anyone you know is interested please send me an email. This is a new position, so the duties are still being determined but we know we need the following three things:

(1) Translation. We need spoken translation at Assemblies and written translation of important documents. The Coordinator doesn't have to do the translation, just to arrange for it.

(2) Liason. The Coordinator is responsible for making sure SCWS information is communicated to Spanish speaking groups and to carry back information from those groups to the Area.

(3) Assistance to other Coordinators. Other coordinators need assistance with Spanish language related tasks. For instance there may be a request for Spanish speakers for a panel.

Past Delegate Report

To be of service is a gift of love that is given to our members and to the fellowship as a whole. I've always thought that the highest we reach in Al-Anon service is humble, and the experience of serving as Delegate and now Past Delegate is, indeed, humbling, but at the same time one of the most spiritual experiences I've had. I can't help but realize that as this Panel draws to an end this year, I'll have a new service opportunity waiting. The SWAT Team. That's "Service Without a Title."

Our Area has embraced many new things this Panel. KBDM, Thought and Task Forces actively working, courage to proceed with new ideas. One of those was creating a more comprehensive AMIAS and Alateen policy, and another has been revisiting our election and voting policy and the way we select our 5 Officers.

Last November, you gave us a resounding YES when we asked you to try new ways and standards for this election process. This lead to the acceptance of comprehensive job descriptions, standardized resumes, advance intent of those seeking office. All of this based on the spirit of KBDM to allow every member of the Assembly the same ability to be prepared to participate in an informed group conscience in selecting from the most qualified candidates. For the first time, we will be using electronic voting to speed the election process and provide accuracy. Our election procedure has been modified based on our Service Manual and standard definitions.

After almost a year of talking about it and preparation, we come to the election Assembly in November where we will test this. Following this plan new GRs must be registered with the Group Records Coordinator no later than the first Saturday (this allows us to have enough clickers on hand), serious candidates have become familiar with the comprehensive job descriptions and have declared their willingness and preparedness to serve at the August Committee meeting (today). Resumes of qualifications and candidates' statements have been posted on the SCWS website, available to everyone to see, not just voters. It's very important for all DRs to be sure to communicate this information to each meeting in their respective districts. You are the important communication link.

Also in November, the TF dealing with groups that do not adhere to Traditions and other Al-Anon principles will be presenting its findings. The framing document covering this topic is available online.

My personal thanks are due for you for your support all along the path of this most remarkable journey.

Two spiritual experiences I had this year as Area Secretary were to attend SWRDM and SCAC.

In April, I attended the **2014 SWRDM** (Southwest Regional Delegates' Meeting) and participated as an Area officer, paid for by me, not the Area. The purpose of SWRDM is to support the new delegates, provide current delegates an opportunity to share World Service Conference (WSC) practices and procedures, and help keep past delegates current, involved and informed. All discussions are designed to bring closer communication and understanding to our Southwest Region Al-Anon Delegates.

As an Area Secretary, I had no voice or vote in the 3-day Delegates' meeting except in the Coordinators breakout session and if reporting back from a session, which I did both years. This year the coordinators were asked to generate a list of Traditions consistent with the clarification of the existing policy on Al-Anon members who also are members of Alcoholics Anonymous.

We provided at least one reason for every Tradition, several with four to eight reasons. The group asked me to take the notes and report back to the Delegates, as they did last year. The Chairman of the Board of Trustees asked to have that list printed in the minutes. As seen on p. 57 of the 2014 World Service Conference Summary on the WSO Members' website, the 2014 WSC passed a motion (#6) to amend the text in the Service Manual.

SWRDM definitely is a working weekend, focused on material to be discussed by the Delegates at the WS Conference. It was a very stimulating and spiritual experience to participate actively and productively. Each time I was full of energy and ready for more when the weekend was over.

In June I attended **2014 SCAC** (Southern California Alateen Conference) as an AMIAS (Al-Anon Member in Alateen Service) and Area officer. Words cannot convey the tremendous feeling of spirituality and awe that came from the simple act of walking to the opening dinner. Our group walking from the girls dorm was joined by the group walking from the boys dorm. To suddenly be in the middle of a sea of 300 Alateens and 50 AMIAS was breathtaking. The magnitude of it was stunning. The entire Conference walked together to every event – every meal, every meeting, back to the dorms to rest or sleep. No one ever walked alone.

The cooperation, commitment, participation and peer support from the Alateens throughout the weekend was impressive. All the sharing at the meetings and talent show was done by the Alateens. The AMIAS were there to ensure the safety of the Alateens at THEIR awesome Conference.

The organization and logistics provided by the SCAC Committee (all Alateens) seemed to be at an adult level. The guidelines, rules and expectations were stated clearly to the Alateens AND to the AMIASs with certainty that ANYONE breaking the rules would be sent home, including adults. As an officer, I would have more awareness of incidents than most AMIASs present. There were ZERO incidents requiring any Alateen to leave.

The leadership from the SCAC committee and from the SCAC Sponsors provided a safe environment for all. There was an awe-inspiring number of Alateens present and the right number of AMIASs. This year there weren't any non-AMIAS adults under 25 present.

2014 SCAC might have been among the smoothest-run SCAC weekends ever. It was such a gift to have been present. Given the history of incidents and the sheer number of Alateens (300), one could not have anticipated such a tremendous incident-free outcome. It was an amazing spiritual experience and I am so grateful for the opportunity to participate in it myself.

Given the level of spirituality present at 2014 SCAC and the safe atmosphere provided, the future seems bright for SCAC!!

Note for the GRs: READ THE MINUTES. Each Assembly meeting approves the minutes of the previous Assembly, so the GRs will vote on approving the May minutes at the Nov Assembly. Read the May minutes in the May Bulletin (published in July because of processing time), and make a note of any corrections needed. Thus, the GRs present at both meetings (May and Nov) need to read the May minutes again prior to the Nov Assembly. Bring a copy of the May minutes with you to the Nov Assembly, in case corrections are suggested for approval. The same is true for Committee members in Feb and Aug. The minutes from the Aug Committee meeting will be approved at the February 2015 Committee meeting.

I am so grateful for this opportunity to be of service.

Treatment Facilities Outreach Project

The **Treatment Facilities Outreach Project** was designed by WSO to help members know what to do when reaching out to treatment facilities so that Al-Anon information can be available at treatment facilities (also shelters, correctional facilities and other institutions) whether or not services for family members are available. The four PowerPoint modules can be used for presentations to facilities as part of this vital public outreach activity. Our cooperation with these professionals helps bring our message of hope to the families or friends of alcoholics.

Planning the outreach project is the foundation of effective communications with treatment facility staff, and often can take more time than the actual activity. Members are also more likely to volunteer and remain actively involved in an outreach project when it is well coordinated. We can benefit from others who have shared their experience in planning such outreach activities. We do not have to reinvent the wheel!! The presentation modules are designed to support, expand, and strengthen project planning skills.

The modules are available on the Members' Web site, al-anon.alateen.org/members, in the "Public Outreach" section in *The Best of Public Outreach*, also in Spanish and French.

Stage 1, Assess. Feasible? Can it be sustained? Alternatives?

Stage 2, Plan. Form a public outreach committee to contact the facilities and subcommittees to identify more facilities. Project coordinator gets others to volunteer. Obtain background information about the facility, recommend activities to the facility. Target the message to the audience (staff, alcoholics, family, mixed). Unity among the volunteers is important.

Stage 3, Implement. This is about personal contact. Listen to facility's activities and goals. Provide a basic explanation (who can attend, anonymity, types of meetings, Al-Anon's purpose does not conflict with professional help). Keep it simple. Periodically contact staff for feedback, replenish CAL, update directories. Suggestions are provided for what to explain to family members transitioning from a facility to Al-Anon, before they attend their first Al-Anon meeting.

Stage 4, Evaluate. Inventory by us. Feedback by staff (which CAL is helpful or not, which information can be omitted, etc.).

Stage 5, Adjust. Evaluate adjustments too. What may be feasible today may not be tomorrow, and vice-versa. Celebrate! Hopefully we created an ongoing relationship with the Facility.

On Sunday, August 24, 100 attendees heard a beautiful presentation by the three SCWS Public Outreach coordinators of all four modules, well written by WSO, packed with interesting information and very helpful suggestions. Districts and intergroups can host presentations too. A presenter training module is provided by WSO. There were 100 attendees. Detailed questionnaires were completed.

These are only brief notes, with some material from p. 33 of the 2014 World Service Conference Summary.

ELECTION PROCEDURES

Introduction: The following functions and procedures are new in concept and specifically designed in the spirit of KBDM to have the most informed and prepared voters, candidates who are the most qualified for the 5 Officer positions, and to ensure consistency, efficiency and speed of voting, utilizing electronic voting equipment. **Trial** of new procedures for 2014 Election Assembly (requiring candidate resumes, due date is Aug Committee meeting, publishing resumes after Aug Committee meeting, GR/AGR registration deadline of 1st Saturday of Assembly month, using electronic voting with clickers) was approved at Nov 2013 & May 2014 Assemblies.

- 1. The Area Chairman serves as the "Election Chairman." In the event that the Area Chairman is participating in the election, the entire election will be conducted by the Immediate Past Delegate as the Election Chairman.
- 2. Current or Past District Representatives who have submitted a completed resume (form on SCWS website) by the posted deadline will be considered to be candidates for the election of Officers when they stand for a position at the Election Assembly, revealing position(s) sought by standing at Election Assembly. Submitting a resume is not binding: a candidate may withdraw simply by not standing at the Election Assembly. Candidates also may inform Immediate Past Delegate of their withdrawal prior to the Election.
- 3. The Election Chairman reviews the proposed election procedures, given below. It is important that everyone understands the method agreed upon for the election of Area Officers.
- 4. The Election Chairman asks for a vote of acceptance of the proposed method of election, below. If another method is considered, it should be clearly understood and agreed upon by 2/3 vote of the Assembly. [SM, p. 150*]
- 5. Election Chairman invites candidates who believe they are prepared and willing and who have submitted a resume to come to the dais, starting with candidates for Delegate. Each candidate will be given 2 minutes at the microphone to answer the following specific question from the resume form in their own words: "Describe why you would be an asset as an SCWS officer."
- 16. At the time the vote is called, voters will indicate their choice by clicking the appropriate button on their electronic 10-key voting device. During the voting period, no one may enter or leave the room until the vote result is declared by Election Chairman.
- Proposed Election Procedure
 - 1. <u>Confirming count of voters</u>. Group Records Coordinator takes roll call to obtain manual count. This number is confirmed by taking electronic count, where voters click on their electronic device to indicate their participation in the election.
 - 2. Election of Delegate, requires 2/3 vote
 - A first ballot is taken. The candidate receiving 2/3 vote is elected Delegate. [SM, p. 151*]
 - If first ballot does not elect the Delegate, the Election Chairman may ask candidates receiving the lowest votes to withdraw. If two candidates each receive at least 40% of the total vote, the Election Chairman may ask those two candidates to remain and the others to withdraw. Whether or not names are withdrawn, a second ballot is taken.
 - If still no election occurs, a third ballot is taken between the two candidates receiving the most votes.
 - If 2/3 vote still is not reached, the Delegate is selected by lot. The first name drawn becomes the Delegate.
 - 3. Election of Alternate Delegate

Follows same procedure as for Delegate.

4. Election of Chairman, requires Majority vote

Majority is 50% + 1 vote [Oxford Dictionary, 2014; Merriam-Webster Dictionary, 2014, etc.]

A first ballot is taken. The candidate receiving majority vote is elected Chairman. [SM, p. 152*]

- If first ballot does not elect the Chairman, the Election Chairman may ask candidates receiving the lowest votes to withdraw. If two candidates each receive at least 40% of the total vote, the Election Chairman may ask those two candidates to remain and the others to withdraw.
- Whether or not names are withdrawn, a second ballot is taken.
- If still no election occurs, a third ballot is taken between the two candidates receiving the most votes. The candidate receiving the most votes on the third ballot is elected Chairman.
- 5. Election of Secretary and Treasurer

Follows same procedure as for Chairman.

Processes expense reports/requests, issues checks and posts into checkbook as processed, weekly. These duties are necessary weekly to maintain accurate, current financial status. Reconciles bank statements monthly. Prepares monthly financial reports, submitted to officers within 7 days of month-closing. Reports include but not limited to Balance Sheet, Profit & Loss, Prior Year Comparison Profit & Loss, Bank Account Reconciliations and Prepaid Account Reconciliations. Produces other reports as needed. Submits listing of Group contributions and other reports to Bulletin quarterly. Facilitates annual audit by providing requested documentation and records to auditors. Attends all SCWS Area Assembly and Committee meetings, and board and officer meetings, as called by Area Chairman. Is an Officer of SCAC Board (Southern California Alateen Conference), has oversight of SCAC bank account and is part of Alateen Task Force (TF).

3. <u>BASIC SKILLS / PERSONAL QUALITIES / EXPERIENCE NEEDED</u> – Accounting background from high level professional / volunteer experience and working knowledge of professional accounting, spreadsheet, word processing and presentation software. Able to allot appropriate time to position and all it entails. Able to separate opinion from fact and to support and effectively communicate Area and WSC decisions and their implementation objectively, even if not in personal agreement with the group conscience. Having served on the Area Board, while not required, provides useful perspective on current Area policies and procedures.

 <u>ADDITIONAL SKILLS NEEDED</u> – Must have excellent time management and multi-tasking skills in order to be current weekly with accounting information. Has flexibility, objectivity, takes initiative.

 <u>EQUIPMENT / TECHNOLOGY NEEDED</u> – Access to computer, printer, Internet connection, email w/attachments, online banking, bank-provided check scanner.

<u>REALISTIC TIME COMMITMENT OF THIS POSITION</u> – Up to 8-12 hours weekly to stay current with everything – cannot be done only
once per month. This is a position that would be overwhelming if done only once a month. Three hours per month attending required
meetings and conference calls of SCAC Board and Alateen TF. Some time is spent researching unidentified group sending contribution
(Group Records database, meeting directories, DRs, etc.).

 PREPARATION – Configuring database for various new custom reports requested. If database setup is current, preparation time can be minimal.

 TRAVEL – Attends one service-related event outside of Area during 3-year term. Makes own travel arrangements, within budget guidelines.

<u>OTHER</u> – Must be responsive to requests of Officers and SCWS Board. The Treasurer must be willing to support the group

DISCUSSION

Question about the issue of registration of new groups. Where did policy of intergroups come from, that a group has to be registered with WSO to be put into a meeting directory? SM (Service Manual) says it's important for meetings to be registered. We haven't said it's a requirement or policy, but it IS an implication and it is good business practice. WSO owns the Al-Anon name and the Alateen name. You cannot put an Alateen meeting on the website unless they are registered with WSO.

For communication, representation and participation, you have to be registered. It's not a policy, but group records coordinator has worked hard with intergroups to make sure that all groups are registered. A meeting that isn't registered wouldn't get a Forum, each new Service Manual, etc.

There are intergroups that require a WSO number before they put a group in their directory. One intergroup will not put new meetings into their directory until they have existed for 6 months.

Why would a group not want to be registered?

I want to go to a registered mtg when I look one up in the directory.

p. 30, 31 of SM. How to start a group. Reasons for registration, describes the process for registration. "The WSO will register a group with the understanding that the group

abide by the Traditions and not affiliate or endorse any outside entity." Traditions do not say that a group must be registered. It only says that we don't have any other affiliation.

Tradition One, Six. Goal is unity, what is best for the most groups.

It's not a policy, but certainly it's been a practice. We've always had a records coordinator that intergroups are working with on matching their directories with the registered group list from WSO. SM p. 36, open and closed mtgs. A closed meeting should be open to all Al-Anon members. How could you be open to all members if you're not registered when someone calls WSO for a meeting location?

Alternate Delegate's Report – Tim P.

Past Delegate's Report - Sandie E.

<u>Cost of Background Checks for AMIAS applicants</u>, Framing document. Kathi M, **AAPP** –The insurance requires back-ground checks. Initially \$10, the price increased this year to about \$30, significant. Area pays for all background checks.

Annual recertification of AMIAS required since Oct 2004 passing of Area requirements. An additional requirement: attend a workshop to be recertified. As a result, in 2012 some chose not to recertify. Instead, they applied again to become certified, requiring another \$10 background check. Now it's about \$30.

For people who would not have needed an additional background check had they recertified by the deadline, in 2013 there was an additional \$256.44 **for repeat background checks**, and so far in 2014 an additional \$562.21 already paid plus an additional \$207.13 for a few more as-yet unprocessed ones, which is \$769.34 total in 2014.

Remember that when the Area pays for it, we ALL pay for it. The money comes from group donations.

DISCUSSION

There are additional reasons for not going to a workshop. Some picked a later workshop then missed the deadline when something prevented them from attending that workshop.

There were many workshops (22) throughout the year, at least one per district throughout the 3-year term. People HAVE traveled far just so that they can go to a workshop.

8:00am Group Reps/9:00am meeting

Suggestion: use different kind of background check where this doesn't have to be done annually. [Treasurer's comment in afternoon discussion: **background checks only are done once unless someone does not recertify**.]

It's hard for d9 volunteers to make it to workshops since they are so far away. How can we structure it without penalizing those who can't make it to a workshop?

Can AMIAS certifications be for 3-year term?

There is personal responsibility in whatever service we VOLUNTEER for and commitment that goes along with it. Service is a spiritual calling and much benefit to it. Maybe the District should pay for the background check. We are serving our teens. If you are serving the teens, I want to know that you are cleared by the background check.

AMIAS are extremely important. We pay for the first one, but if someone needs to repeat the cert, then the responsibility should go to the individual.

We're looking to going forward with using LiveScan, which continues to check. After you've done it once, they would report anything new that has happened. LiveScan includes fingerprinting, so individuals would have to be willing to be fingerprinted.

The board made a decision to form a TF to come up with the particulars of using LiveScan and to look at background checks. Look at what to do with these individuals from 2014, make a spiritual decision through group conscience.

For awhile now there's not been a lot of communication between the different entities that post Alateen meetings and the AAPP. L.A. County always checks before they post it, Orange County will now too. Any other entity, if you have a way that you are posting Alateen meetings, let's set up some kind of process to make sure that those Alateen meetings are registered.

Discussion continued in the afternoon.

SCAC report.

DISCUSSION

D63 handled bus contributions for SCAC this year, would like to be financially transparent, would like to see the accountability of where that money came from, which was from which groups and which districts (which means groups) and where the money was spent. Why isn't bus cost included in this financial report? Districts arrange for the buses, not SCAC. Tarisa has that info.

Tarisa. June 21 sent report out because that was the cutoff date for SCAC. There was a snafu on the registration form address, post office sent forms back to them, so no forms from 20 people, which caused an extra charge from the SCAC location. The accounting now is cleared up, new report will go out today. Bus surplus of \$1,070.74 goes to next year's bus, will be transferred to whichever district does it next year.

There is an additional expense for the bus on top of the registration, d40 teens are only 30 minutes from Redlands, so they didn't take the bus. There is no requirement to take the bus in order to go to SCAC. Did SCAC contributions from d40 go to pay for buses that Alateens from d40 didn't use? No, only if a donation indicated that the money was for the bus. Other than that, SCAC donations only go to pay for scholarships.

DR emphasized that she received constant updates from Tarisa and can't imagine how more doesn't come up, given the logistics of getting all these kids there. She thinks \$150 is an okay cost for SCAC.

Former SCAC sponsor, addressing why the bus funds are not included in the SCAC report. As a former SCAC sponsor, has signed those contracts. If you have a rock concert, you buy a ticket. If a group says let's rent a bus to go to the rock concert, that's a separate cost on top of the concert.

Continue discussion in afternoon.

<u>Alateen lunch in May</u>. May lunch was delayed more than 1 hour. Talked with SCAC committee, made them aware of how much this meant to us, will try again at Nov Assembly, they have promised to pay more attention to having a richer set of choices for a meal and to be timely, and food to be prepared in a location closer to the Assembly.

WSO workshop, Treatment Centers. Margaret S., Institutions. WSO created a series of modules, called Outreach to Treatment Centers, but also includes outreach to institutions, shelters, hospitals, detention facilities, etc., goes through organizing and reaching out to these facilities, how to do actual service and follow-up, having committees for this. The 3 public outreach coordinators will present the modules. The main purpose is for members of CA(S) to give feedback to WSO on the modules.

Thought Forces ThF and Task Forces TF. Sandie. Started term with 4 Thought and Task Forces. 1. How can WSO help districts and intergroups in working with groups that are not following Al-Anon policies, principles and Traditions. 2. D64. First had ThF that presented in May 2013, were to present ideas about how we can best work with the Spanishspeaking meetings, fostering the unity of Al-Anon as a whole, Tradition 1 is one of the key points. There is a TF, with co-chairs Lorena M. and Elizabeth K. named in May 2014, that is coming along next. 3. ThF on redistricting will report in next term.. Some districts are enormous, some small. 4. The 4th ThF already reported.

7th Tradition. Baskets pass.

<u>Elections and Voting</u>. Elizabeth, TF chair. Clicker handout for DRs to use when describing clickers in their next district meetings. We are using KBDM for the elections. The TF spent a LOT of time, took care developing the new procedures. DRs, please remind GRs to read all 5 job descriptions, all resumes and the election procedures prior to the Nov Election Assembly (all on the SCWS website). KBDM helps us vote on each position. The completed resumes are due by 11:59pm tonight and will be posted on the SCWS website. The directions specifically state not to indicate which position one is going to stand for in Nov. The position a candidate will stand for will be revealed at the Nov Election Assembly, when that
person stands for a position. Also, submitting a
resume is not binding, so someone who submitted a
resume can decide on the day-of not to stand, or
they can inform the immediate past delegate sooner.
Anyone who wants to be able to stand must submit a
resume by tonight.

One concern about posting in advance – stay away from popularity contest, from debate, from "electioneering".

A lot of people call WSO for meeting info, which is another reason why groups should be registered.

1219 active meetings.

Roll call, and today's estimate of how many GRs will be coming from each district. 3(abs), 6(7), 8(abs), 9 (10), 10(10), 12(15), 17(20), 21(15), 24(18), 27(19), 30 (12), 33(15), 36(7), 39(abs), 40(9), 42(8), 45(10), 48 (15), 51(6), 54(10), 57(13), 60(22), 63(15), 66(20), 64 (35), 69(15), 72(abs), 75(15)

That makes 341, with 3 DRs absent. We agreed in May 2014 to rent 300 clickers. Do we need to rent more? Please report any updates to Elizabeth.

Motion to approve minutes, with corrections. By Jessica d57, 2nd Nancy d66. Passed by show of hands.

Meet the Board?? July 2015. Opportunity for fellowship to meet 19 trustees and 3 executive committee members – and see that they are Al-Anon members. No cost to Area. WSO pays for everything for the event, their hotel, their airfare. Area provides transportation to and from airport and publicizes event. If we want to submit a bid for 2015, WSO gives us a basic list of considerations, plus proximity to airport, transportation, free parking, etc. Submit bid by Sept 15, WSO chooses site in Oct, Area is notified in Dec. In Feb the registration form is distributed by WSO.

What would be the advantage to the brand new SCWS board of officers and coordinators in 2015 to meet the Board of Trustees? It doesn't have to do with the board, but with the membership. <u>AMIAS background checks</u>, Who should pay for the repeat background checks? Continuation of discussion from this morning's Framing document presentation.

Investigate LiveScan to see cost and repercussions.

Track One only gets a "snapshot" at this moment. We get either an okay, or an exceptions report telling us what is at issue. LiveScan, on the other hand, keeps getting updates and lets us know when/if a problem has developed for someone.

We should continue to pay for it till we put it clearly on the application, "this is the cost, if you do not recertify in time, you may be asked to pay the repeat cost."

It shouldn't cost to be of service. In this discussion we are talking about people who did not meet a deadline that they knew existed, and so they created the problem that they are facing. We are guided by spiritual principles of the 12 Traditions, and this committee sometimes also has a fiscal responsibility to make difficult decisions. Sometimes we make different decisions later, after we get more information, e.g., a cost increase.

Part of being of service is taking responsibility. The deadline is out there from day 1. Cost should be handled by the AMIAS.

The Area should be responsible only for first time, then let it be up to the district for repeats.

How many AMIAS currently certified? 395. How many have not certified? 12 out of 125 in 2013, 19 so far in 2014, plus another 7 that are re-certs. Of 42 background checks run, 19 (+7) are repeats. Since 2012, 375 have dropped off.

I like the KBDM process, hoping that we're not expecting an answer today, would hope DRs will discuss this in their districts, come back to discuss it more. It's about educating.

Alateen service is a unique service that has certain requirements, deadlines. It is a choice to become an AMIAS.

Let's get a feel of where we are in this discussion. If someone did not recertify, ...how many think the AMIAS should pay some portion? The district? All 3 ...AMIAS + district + SCWS? No clear consensus. If we do nothing, then everything stays as-is and the Area pays the entire cost of the background check for someone who needs to repeat the certification Let district provide mileage for someone to drive a long distance.

Shift responsibility from Area to districts.

Cathy. Background checks done only once during the term, unless someone does not recertify and so if they must repeat the certification, this is the only time there is a repeat charge.

Ask-It-Basket

Ask-It Basket Questions from August 16 Committee Meeting

1.Q. Our Group Representatives have asked that SCWS consider changing the Assembly agenda to be reversed with Action Items in the morning and Officer reports in the afternoon, since these are published in the Bulletin. Would that be possible?

Answer- According to the Service Manual, page 65, "the Area Assembly is the business meeting where the groups send their representatives to express a voice and vote on behalf of the group. During an Assembly, the Delegate reports the activities of the World Service Conference." On page 72 we read: "The Delegate is the primary communication link between the groups and the World Service Office (WSO)." In the spirit of "First Things First" it makes sense for the Delegate to give this report early in the Assembly. The other Officer reports are much shorter and should not take up much of the morning.

- 2.Q. Can we order SCWS Bulletins in advance and have copies at the Assemblies and Committee meetings at a cost? They are expensive to print on home printers.
 - *Answer-* The purpose of the SCWS Bulletin going electronic was to save printing costs for the Area. The expense was \$10,000 per year. The Assembly voted to have the Bulletin go electronic in 2012. It would be impossible for the Area to target how many Bulletins to print for an Assembly and it would require the Bulletin Editor to service the Assembly by selling Bulletins. The cost for a subscription is \$15.00 per year and it is mailed to your home. The Group Rep can be reimbursed for the subscription cost from the Group.
- 3. Q- I understand that the WSO discourages chanting at meetings. However, if I hadn't heard "Keep coming back" at my first meeting, who knows where I'd be. Saying this once at the end of a meeting doesn't seem to be much of a violation. Am I correct?
- Answer-In the proposed Al-Anon meeting format on pages 10-22 of the Service Manual, nowhere does it mention chanting at meetings. Chanting is a custom that developed at treatment and rehabilitation centers. It is possible that some newcomers might find the chanting of "Keep coming back" somewhat cultish. On page 22 the Service Manual suggests that a group might recite the Al-Anon Declaration at the end of a meeting. Imagine if you had heard your group reciting in unison at the end of your first meeting:

Let It Begin with Me.

When anyone, anywhere, reaches out for help,

Let the hand of Al-Anon and Alateen

Always be there, and-Let It Begin with Me.

4. Q. May a District Representative serve as a Group Representative at the same time?

Answer—There is nothing in the Service Manual that prohibits a DR from also serving as the GR for a meeting. However, the principle of rotation of leadership suggests that it would be a good idea for the DR to allow another Al-Anon member the opportunity to serve as GR for their Group.

5. Q. We have heard it mentioned that the insurance company which SCWS uses for liability insurance could also provide insurance for individual Al-Anon groups whose meeting places require insurance. Can you give us the name of this insurance company?

Answer- Please contact the SCWS Delegate who can share this information with you.

6. Q. What are the responsibilities of the Spanish Group Coordinator on the SCWS Board?

Answer—At this time we do not have a complete job description. However, we will have such a job description before the next SCWS panel convenes on January 1, 2015. Hopefully potential coordinators will have time to see this job description and apply to the SCWS Officers to be considered for this position. In essence, the person in this position will foster communication between the SCWS Board and the Spanish-speaking groups in Southern California. An important part of this job will be finding volunteers to provide interpretation into Spanish at all SCWS events and to arrange translation of all important documents presented at SCWS events

C.P.C. Cooperating with the Professional Community

Hi, I'm Sandy P., your CPC Coordinator.

Last month, I had the privilege of being part of an Al-Anon panel at the Child Signature Program through the Orange County Children's Hospital and "Help Me Grow" program. This facility works with low income families that have children in various state preschools in Orange County. Their focus is to provide resources and referrals to families and children in those preschools. Domestic violence, mental health and substance abuse issues are reoccurring themes they are dealing with.

The presentation was in front of 30 "facilitators" who counsel from 2-3 families, so Al-Anon information will reach over 100 people as a result of this single contact. I love this commitment because the people are requesting info about Al-Anon and are interested. My first few years in Al-Anon were spent trying to give information about Al-Anon to people who weren't interested.

September is National Recovery Month. We currently have 1217 Active Groups in Southern California. There are 47 groups listed with "No Mail" as their addresses are not current and they are not receiving "The Forum" magazine or group information via mail or email updates as well.

All of the Intergroup offices have agreed that each meeting needs to be registered with WSO prior to being listed in the local directory.

With reference to the 47 "no mail" meetings, each DR now has the capability to access their District's Group Records through WSO e-communities. a

Please note that it is the responsibility of the Group Representative to update the Group Records Coordinator with the current information. I would like to encourage everyone to go to the SCWS website <u>http://scws-al-anon.org/send_mtg_record_updates.php</u> to update your meeting or to register a new meeting. update the information. This way you save yourself the cost of the stamp and the WSO Office in Virginia Beach is updated as well, so there is no longer a need to notify WSO in Virginia Beach, VA as we work on the same database Going online to update information or to add a meeting is the quickest and easiest way to.

When completing the Information form, please make sure to add your **full name and address including your zip code**. This information is very important, in that the database can only assign you to one meeting as a Group Representative. I have had to spend many hours making phone calls and sending emails just to find out the Group Representative full name and address.

I take this commitment to my heart and want to do the best job I can. However, when I only receive half of the information I need, it is very frustrating on my end in that I cannot complete my job. If I do call you and leave a message via voice mail or email, please be courteous enough to return my call or email.

Verification of e-mail addresses has become essential and should be accomplished on a regular basis since the WSO and Areas are increasingly communicating electronically with the groups. WSO has requested that members **not** use their work email address for their group. It was suggested during a recent telephone conference with other Group Records Coordinators that a group can have their own email address through gmail.com or yahoo.com. If a birthdate is needed for the application of the email address, it was suggested to use Lois birthdate of March 4th and the year 1951 for year Al-Anon started, ie, the birthdate would be 3/4/1951.

Please make sure that your Current Mailing Address (CMA) for your meeting is updated. The CMA receives all mail from WSO as well as the "Forum".

Hello everyone,

As I mentioned in my May Assembly report, SCWS is helping WSO to evaluate and get feedback regarding a four module workshop on Al-Anon Outreach to Treatment Facilities. It will be presented by the three SCWS Public Outreach Coordinators, Sandy P., Cooperating with the Professional Community (CPC), Richard R., Public Information (PI), and myself, the Institutions Coordinator. Besides helping WSO evaluate the modules, it is a great opportunity for anyone interested in doing service, it is a great training tool for how to go about it from the planning stages and first contact with the facilities to the actual panels or meetings at the facilities. It will be held Sunday August 24,2014, at Hoag Conference Center (at the Main Hospital Campus), 1 Hoag Drive, Newport Beach 12:30 PM. I hope many of you can make it. World Service received a letter from an inmate at Ironwood State Prison in Blythe who would like to start an Al-Anon meeting in the prison. I referred his request to District 42 and I have sent him the WSO Guideline G-12, "Starting an Al-Anon Group", to help with starting a meeting on their own and the District DR has passed along his request to District 42 members in the Blythe area who may be interested in getting into service in the prison.

I also received an inquiry from a treatment center in Culver City and passed that along to Jim, the Institutions Chair at Los Angeles County Intergroup. He is putting together a list of service opportunities at facilities that have inquired through SCWS or the Intergroup for panels or meetings.

I will be getting organized shortly to start getting Al-Anon Faces Alcoholism to the waiting rooms in the Los Angeles County jails again as we approach the holiday season in the fall, when many of our families are in crisis. Maybe you can think of a way that you can practice Step 12 and carry the message to those in need as we approach what I know was a chaotic time of year for my family when we were living with active alcoholism.

I'm approaching the end of my service in this position and I've learned a lot along the way. I had been out of service beyond the group level for several years and I felt like my program needed a kick-start. This service got me involved again in Al-Anon as a whole and gave me opportunities to feel that what I did helped someone find Al-Anon. WSO will be posting job descriptions for Coordinator positions. Think about volunteering to be a Coordinator when our service is up in January.

Public Outreach and Hospitals & Institutions: Early this year, we provided 200 English and 200 Spanish *Al-Anon Faces Alcoholism* pamphlets to Kaiser-Permanent's Social Services Department for distribution to their northern L.A. County members. We also donated Alateen literature to the Teen Medical Center, at their request. Claire R. at WSO asked us to write about the process we went through so that it can be shared with other members around California and the U.S. This is one of the ways that Al-Anon is a "we" program—we help "spread the message" by sharing our outreach experience at the Area level, and also at the national level.

Tina is enthusiastic about doing Alateen service and wants to encourage any Al-Anon member interested in Alateen service to "go for it" because it's such a joy.

One of the Alateens' most successful projects was recycling cans and bottles to raise funds to attend both the San Fernando Valley A.A. Convention (with Al-Anon/Alateen participation) and to collect for SCAC. Although the Alateens don't do the actual collecting because of logistics, they do the "heavy lifting"—literally and figuratively. They go to Tina's, they put the bags of cans and bottles in the truck, they weigh everything, they empty the bags into bins, and they count the money they earn. One thoughtful Al-Anon member donated a box of plastic gloves and shoe covers for this very messy endeavor.

This made the total incoming funds equal \$7606.74. On 6/14/14 a check was issued to Liberty Charter, Inc. for \$6536.00. This left \$1070.74 excess funds to carry over for the 2015 SCAC buses.

The number of groups served by the Intergroup and the Al-Anon Information Service it operates was tallied at 230 when a new Meeting Directory was printed.

Staff and Board members are focusing on streamlining record-keeping with the implementation of Quick Books use and study of linking the cash register and computer.

To make literature purchases and other business more convenient for members, the Board has extended office hours by an hour and a half on the first Friday of the month. Traffic will be monitored to see if that day or another one is most helpful for members.

In the Intergroup's 39th year, a committee has been formed to again review bylaws to see if updates or other changes are required to reflect operational needs.

To help emphasize the importance of restricting material used in meetings to Conference-Approved Literature (CAL), the Board will provide copies of the Al-Anon pamphlet on CAL at Intergroup meetings.

In its discussions of making both "Orange Blossom" newsletter content and newsletter distribution more helpful to members, the Board is looking at including more information on the Alateen conference (SCAC) and the benefits reported by teenagers attending.

Reports from District 60 (North Orange County) and District 63 (South Orange County) show that those districts are working to ensure that their records are the same as those of the Southern California WS Area. Both are working to ensure that all meetings in their areas are registered with World Service . They also are contacting groups without GRs to explain the importance of the position and urge that all groups fill the position. District 63 is preparing for its annual workshop October 4. District 60 hopes to have at its October meeting a draft of proposed content for the Web site that it is creating.






