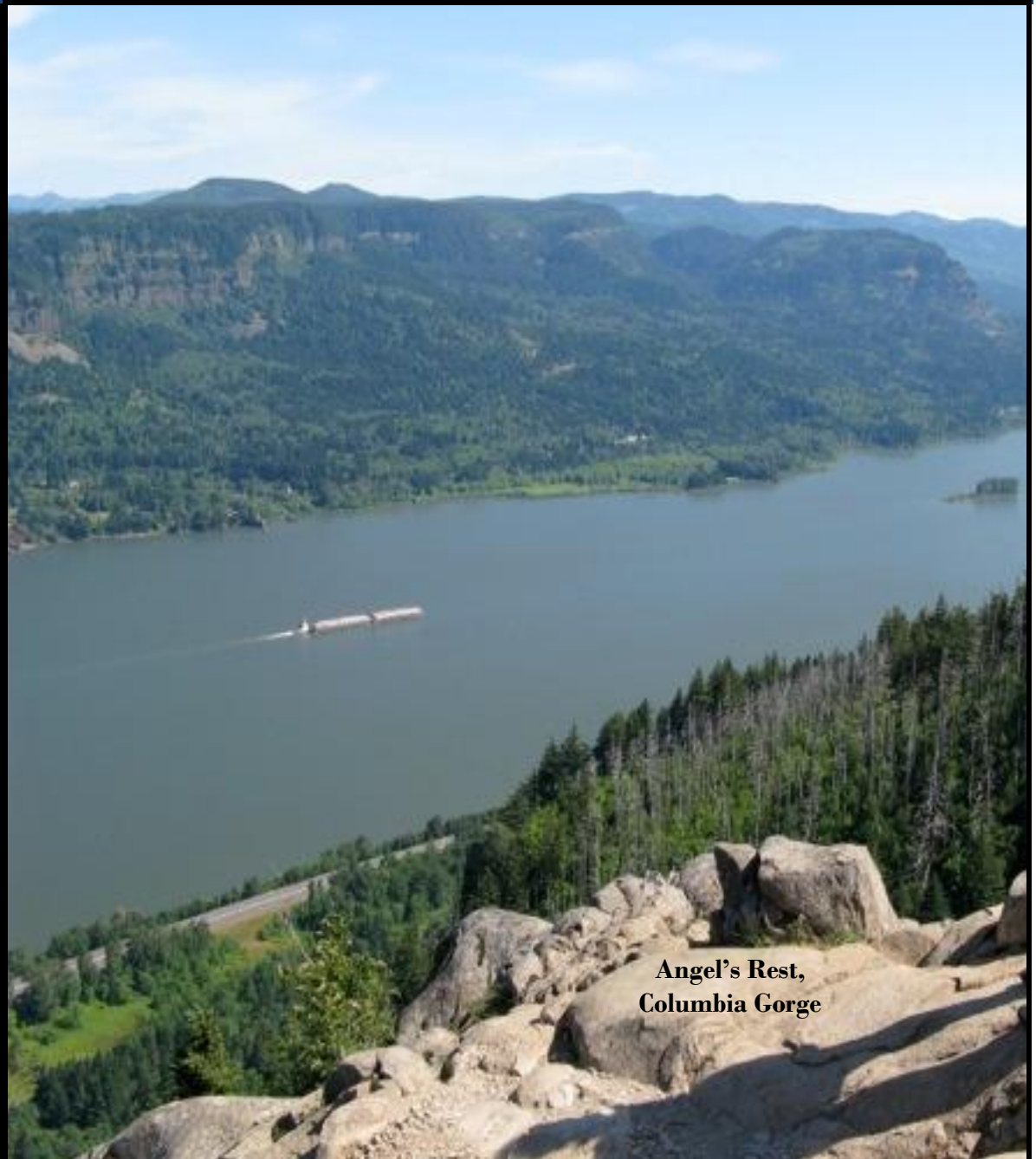

Saturday, August 15, 2015

Past Delegates present: Jayme C. (Panel 52); Willie W. (Panel 37) arrived later.

Roll Call – Donna E.

Officer's Reports (See Bulletin for all Reports.)

Alt. Delegate, Kathi (absent - Jayme C. read report); **Immediate Past Delegate**, Jayme C.; **Treasurer Report**, Eva B. - Question about contributing to WSO. Eva projecting \$10,000 be sent to WSO. Discussion about SCAC funds. Question: If there are any additional monies to SCAC where do they go? Answer: Scholarship Fund or General Operating Expenses. Andrea, DR69, made motion to approve financials; Kathy G, Literature, seconded motion to accept financials. **Motion passed; Secretary**, Sandy P. – Motion to approve the minutes with correction made by Maria, D40; Marilyn, D66 seconded; and **Motion passed.**

Coordinator's Report (See Bulletin for all Reports.)

Records, Donna E.; **Hospitality**, Judy P.; **Website**, Irene C.; **Bulletin**, Christy R.; **Public Outreach**, Rose; **CPC Coordinator**, Melva – absent.

Institutions Coordinator – CB announced Kelly moved to New Mexico and had to resign her commitment as Institutions Coordinator. CB said we had to step back from the grant opportunity because as we gathered more information we learned that this would be breaking the traditions (accepting money from an outside source) and we declined the grant. The invitation to come into the facilities is still open even though we did not take grant. Kelly set the groundwork. Request for Al-Anon meetings in the beginning came from a prison inmate who specifically asked for Al-Anon meetings. An appointment to replace Institutions Coordinator will be made. **Discussion and Clarification that we will not be receiving \$10,000 grant for literature.** Willie emphasized 7th Tradition (funds did not come from an Al-Anon source). Jayme clarified that it is Institutions and not H&I.

Elizabeth clarified that there was concern about receiving the money but we misinformed by another area.

Alateen Coordinator, Sean M; **Alateen Sponsor Coordinator**, Cathleen. (**Read Addendum following Minutes; Literature**, Kathy G.

Delegate, Elizabeth – presented Finance Discussion Workshop. Committee members chose a Service Leadership Topic to meet with group at breakout session during lunch.

12:00 Lunch/Breakout Session with group

1:00 p.m. Delegate resumes Finance Discussion: (a) pick a service leadership topic; (b) pick your group's Area Dream; (c) activities needed to achieve the Area Dream; (d) resources needed to complete activities; and (e) time needed to complete the Activity. Breakout Session continues.

1:30 p.m. Breakout Session continues – Delegate asks who is a first, second and third year DR and poses some questions: How did you decide to stand for DR? Were you the ADR before? Did you fill in for a DR who left the position? (If you are a liaison, apply it to your position.)

Discussion continues.

2:00 p.m. Delegate wraps up the Area Dreams breakout sessions.

Delegate Report – Elizabeth. (See Bulletin for Report.)

Forum Collection \$27.65 - Michelle McCabe and Martha Zepeda won Forum subscriptions.

7th Tradition \$108.00

New Business/KBDM

Electronic Voting Presentation – Jayme C., Immediate Past Delegate. Jayme reminds everyone correct spelling of Al-Anon is "Al-Anon." Institutions is Institutions and not H&I. Public Information is now Public Outreach. Jayme gave history of voting. Discusses changing ByLaws to reflect changes in clicker voting. Questions and answers about presentation. Price contains non-profit discount. More information to be gathered about lower costs for schools. Clicker voting is much faster. Jayme asks Committee if this presentation is ready to take to GRs at assembly. The Committee unanimously agreed the Clicker Presentation is ready to take to the GRs at the November Assembly.

ADDENDUM

SCWS AREA COMMITTEE MEETING

August 15, 2015

Area Alateen Sponsor Coordinator Report

SCAC:

- SCAC was held on June 26-28, 2015 with 241 registered Alateens (i.e., 127 girls & 116 boys) and 50 registered AMIASs (i.e., 35 women & 15 men).
- 2 CA(N) Alateens accompanied by 1 CA(N) AMIAS attended SCAC. Worked with WSO to determine process to approve on a one time only basis. Discussions with WSO revealed need for Area to develop a policy for future requests for other Areas to attend our Alateen Events and vice versa. The G-16 – Alateen Conferences (Revised 2014) states, “.... All Al-Anon Members Involved in Alateen Service (AMIAS) are required to have their Area’s approval prior to taking Alateens to Conferences or other Alateen events within or outside their Area” and “As stated above, all Alateen Conferences must be connected to the Area in which they are held” (page 1; paragraphs 5-6).
- Currently, SCAC 2015 Committee members have requested to attend Arizona’s Alateen Conference in September 2015. Have initiated contact with counterpart in Arizona to discuss.
- Final financial report on (1) total scholarship donations received; (2) total scholarships awarded; and (3) scholarship balance forward for SCAC 2016 is not available at this time due to illness of Alateen Sponsor Coordinator and some scanned registration forms not legible. Have received the original registration forms from the 2015 SCAC Sponsor to compare to scanned registration forms. Final report to be presented at November 2015 Assembly meeting.
- **Elected 2016 SCAC Chair** – Angela (D54 but currently attending college in D66 and SCAC Treasurer 2015) and **elected 2016 SCAC Sponsor** - Matthew M. (D12 and SCAC Male Co-Sponsor 2015).
- **SCAC Turnover meeting** held Sunday, July 26, 2015.
- SCAC 2016 – **Save the Date flyer** for schedule of SCAC Monthly Fundraisers to be posted on Alateen Events

page on Area’s web site. Only date and type of event to be posted. Location, time, other details, flyer, and permission & medical consent will be posted **when each Event Plan is approved. Announcements about events, including handing out flyers, is prohibited until the Area approves the Event Plan.**

- SCAC Work Group Meeting scheduled for Sunday, September 27, 2015.

CERTIFICATION TRAINING & RECERTIFICATION WORKSHOP - CALENDER for 2015-2016:

- Deadline for districts to submit requested dates for Recertification Workshops was June 30, 2015. Received only 13 requests from districts & OC Inter-group. Requested additional dates by July 31, 2015 and received 4 additional requests for a total of 17 Recertification Workshops for 2015-2016. These numbers do not include Spanish language workshops in D64 which is assessing its needs. The Area usually averages 20-24 workshops each year.
- **Every current AMIAS must plan to attend one of these 17 Recertification Workshops to be eligible to maintain his/her certified status for 2016-2017. There will be no last minute, make up workshops scheduled!**
- Recertification Workshop is being redesigned to focus on the 12 Traditions as applied to the AMIAS role and to develop competency in Event Plans completion.
- Online Certification Training for New Applicants (90minutes): **New information** includes: (1) session not held in July due to Alateen Sponsor Coordinator’s illness; (2) **effective August 2015 start time one hour earlier 7:00 pm;** and (3) **training is held year round ... Feb, Apr, Jun, Aug, Oct & Dec (i.e., even numbered months) on 2nd Sunday and Jan, Mar, May, Jul, Sept, & Nov (i.e., odd numbered months) on 2nd Wednesday.** Currently reviewing training to revise, update, and/or expand, as necessary.

ALATEEN TASK FORCE:

- In process of selecting regular meeting date and time. Goal is to meet weekly beginning in September 2015.
- Will first address issue of **overnighters** (i.e., Should the Area allow sleepovers for Alateen events? What additional requirements are necessary?); then **upper age limit for Alateen membership** (i.e., at what age does an Alateen “age out” of the Alateen fellowship?); and finally, does the Area need a policy to address the issues related to **Alateen members with Special Needs?**

EVENT PLANS:

- There is a need for additional education of the fellowship on the reasons, process and importance of Event Plans and when Alateen Events may be announced.
- Have had some success working with Convention Committees. Some Convention brochures do not state Alateen participation in name of the convention, but Alateen registration fees, Alateen schedules, etc., are still being listed within the brochures. Also announcements about Alateen participation prior to an Event Plan approval continue being made at Al-Anon and Alateen meetings. Need to continue educating all Convention Chairs and every member of all Convention Committees on Area and WSO requirements regarding when Alateen Events may be announced.
- “An Alateen Event is defined as any Alateen activity other than a registered meeting” (SCWS Area Alateen Safety & Behavioral Requirements; page 7; revised June 2013).
- “The Event Chair or other responsible party must submit a completed Alateen Event Plan to the Area Alateen Sponsor Coordinator at least 30 days before the event (60 days before overnight events) for approval Any event without an approved Event Plan will not be able to use the Alateen name in conjunction with the event” (SCWS Area Alateen Safety & Behavioral Requirements; page 7; item #7; revised June 2013).
- “In order to use the Alateen name, any event or gathering with Alateen participation (including Alateen conferences, Al-Anon/Alateen conventions, Area Assemblies, multi-Area events, and A.A. events with Al-Anon and Alateen participation) must be in compliance with the Alateen Safety and Behavioral Requirements of the Area in which it is held” (Service Manual 2014-2017; Events with Alateen Participation; page 90).
- “Only those Alateen events and conferences approved by the Area are announced at Al-Anon/Alateen meetings” (G-16: Alateen Conferences; page 3; Additional Safety Tips; Bullet 7).
- “.... Since most Conferences (or any Alateen event) are held in locations accessible to the general public, only the conference (or Alateen event) name, city, state, date, and an Area-certified AMIAS first name contact, conference (or event) email address, and number should be provided. (Email addresses should maintain personal anonymity.) For safety reasons the address of the conference (or Alateen event) and name of the facility (hotel, college, campsite, etc.) should NOT be listed on the Web site.

Names, phone numbers, email addresses or resident addresses of Alateens are NEVER provided” (G-16 Alateen Conferences; Revised 2014; page 4; Letting Everyone Know; Bullet 5).

- **“ Alateen names, e-mail addresses, and phone numbers should never be posted as contacts”** (G-40 Guideline for Al-Anon Web Sites; page 2; Setting Up The Site; paragraph 4).
- **“ For safety reasons, never post identifying Alateen information”** (G-40 Guideline for Al-Anon Web Sites; page 2; Safety and Anonymity; paragraph 2).
- **Flyers and Permission & Medical Consent forms posted on the Area password protected Alateen Events page may include the conference (or Alateen event) address and name of the facility (hotel, college, campsite, etc.). Intergroup, district, and convention (A.A., Al-Anon or Alateen) web sites, newsletters, event flyers, or brochures (electronic or paper) are prohibited from posting the address or facility name for Alateen events or Conventions with Alateen Participation which are available to the general public.**
- **Flyers publicizing Alateen speaker(s) at Al-Anon or A.A. meetings may be listed by first name only with no additional identifying information** (i.e., last initial, city where lives, name of Alateen home group, district number, contact information, years in fellowship, service position held, etc.).

OTHER PROJECTS & GOALS:

- Currently reviewing Intergroup and district web sites to ensure compliance with Area Alateen Safety & Behavioral Requirements.
- Design a workshop for AMIASs (and other interested parties) on roles, responsibilities, and process of being an Event Sponsor for Conventions and other large Alateen events.
- Review and update Area Alateen Safety & Behavioral Requirements (WSO annual requirement).
- Develop a newsletter for AMIASs to keep informed of new information or changes and improve communication.
- Develop a communication vehicle with DALs (i.e., conference calls or online meetings) to share information and educate.

2015 SCAC

First a BIG THANK YOU to everyone who helped to plan and carry out this year's SCAC, Southern California Alateen Conference, held at the end of June on a university campus for approx. 300 Alateens, chaperoned by approx. 50 AMIAS. Thank you, Bruce G., 2015 SCAC sponsor, who gave so much of his time for the entire year. Thank you, Brandi S. and Matthew M., 2015 SCAC co-sponsors. Thank you, Briana, 2015 SCAC Chair, and Angela, 2016 SCAC Treasurer and elected to be the 2016 SCAC Chair. (Recall that we cannot print the names of Alateen members.) Thank you to all of the Alateens on the 2015 SCAC Committee. Thank you to the AMIAS who attended 2015 SCAC.

Talk with Each Other: the next District/Area leaders

Each WSC (World Service Conference) consists of 3 panels of Delegates: one-third are in year 1, one-third in year 2, one-third in year 3. Here at the Area, we have the same structure among the DRs. Let's have all the DRs stand with the other DRs from: Year 3, Year 2, Year 1. Thank you, all, for your service to the Area and to the groups in your district.

How did you decide to stand for DR? Were you the ADR before becoming the DR? (not required) How did you know what to do as DR? Did the previous DR continue coming to the district meetings to be a support, in the same way as the Immediate Past Delegate continues to be a support for 3 years to the SCWS Board? As a GR, did you observe a previous DR, with the thought that perhaps some day you might become a DR? Did anyone here today step in for someone who stepped aside before their term ended? Did anyone here become the DR at their very first district meeting as a GR?

Hope For Today, p. 101: God doesn't call the qualified, God qualifies the called. — refers to the MEETING LEVEL. Yet, we also get to learn new skills when we accept service positions beyond the group level.

The Year 3 DRs are about to rotate out of their positions, as are the other officers in their districts and possibly all the GRs. Are there GRs in your district who seem like they might stand for DR in this year's election? What characteristics/qualities/skills does the district need for the DR? How does one develop those skills? What new skills have you learned in these nearly 3 years as DR?

Resources: eCommunities (soon to be upgraded to AFG

Connects) provides a site for online discussions with others holding the same service position in a different Area. What are some discussion threads that really stood out for you?

Did any of you step in for a DR who stepped aside in the middle of their term? What year were they in? That is your year. You are completing that person's 3-year term. When that 3-year term is up, you may stand for your own 3-year term.

We have an excellent set of Committee members, who have made a commitment to attend all of the meetings and perform all of the duties that come with our individual positions, whether as an officer, coordinator, liaison or DR.

Yet, it always is possible that someone's life could change in a way that affects their ability to fulfill their duties, including the delegate! Sometimes asking for help for a short period is all that's needed to get us through the event. Sometimes that might not work for various reasons, to the extent that stepping aside seems to become the best solution. That's okay! This already happened earlier this year among more than one category of Committee members.

If something changes for you and you are considering what to do, make use of the Area leadership resources and call us: Let us talk to each other and reason things out with someone else.

I. 2014 Annual Report and Policy Discussions in 2014

Meditation meetings. On p. 19 of the 2015 Conference Summary, the Executive Director answered questions about the 2014 Annual Report, which the Delegates read and submitted questions about, prior to the WSC. One of the questions was to explain why having meditation in meetings is not within our Traditions. See also p. 115, Group Services Department, for information about calls with questions from Areas about meditation meetings.

II. Finances, 2015 Budget

Competition between Areas. How are the meetings in your district doing with increasing their contributions to the World Service Office? The 2015 WSO budget was approved by the Delegates and other voting members at the 2015 World Service Conference with a projected 8% increase in contributions (\$1.7 million in 2015 compared to \$1.5 million in 2014), and with a shortfall of \$52,000 projected in January after the budgeted operating expenses are subtracted from the budgeted estimated revenue. The other sources of revenue are \$3.05 million in Literature sales (after costs are subtracted), \$250,000 in Forum Subscriptions, and \$65,000 investment dividends/transfer from Reserve Funds.

Please remind the GRs in your district that we are having a friendly competition with regard to bigger contributions. Please ask them at your next district meeting to find out how much more their group has donated to the WSO in Jan-Oct this year compared to the same time last year. The Delegates at the WSC are having a **friendly competition between Areas** to see who can increase their contributions and Forum subscriptions the most.

How much did a dollar buy in the 1950s? That was the typical amount put into the basket then. Let's look at how much a meeting meant to those members, relatively speaking, by comparing prices with today.

Gas was 18 cents per gallon. So, to them, going to a meeting was worth 5.5 gallons of gas. At today's price of \$4, that would be \$22 per meeting. OR, Movie tickets were 48 cents, now they are \$15, so at today's prices, those members in the 1950s felt that a meeting is worth \$30. OR, A pack of chewing gum was 10 cents, now it is a dollar, so that would be \$10 nowadays. Wow. Each comparison shows that members were willing and found a way to contribute a LOT in the 1950s.

Tradition 7: there are no dues or fees, but we do have expenses, which includes \$250 spent by the WSO per meeting, whether the meeting contributes or not (and only 60% contribute, with an average of \$119 each). No one is required to contribute any particular amount, but we contribute what we can so that we can be fully self-supporting of our meeting and of the service arms. We give in gratitude for what we have received. We participate so that we can feel a part of rather than apart from.

III. 2018 Al-Anon International Convention

The GRs voted at the Nov 2009 Assembly to send the

Delegate to the International Convention occurring during their term. During my 3-year term, this is the AA International Convention held in Atlanta, GA, on July 4 weekend this year. I am grateful that the Area sent me to represent the Area at the AA International Convention. I spoke with several different Trustees and WSO staff members throughout the weekend, asking questions emailed to me by members in CA(S).

All Trustees and many WSO staff were on site and available to all Al-Anon members throughout the Al-Anon part of the Convention to discuss any topic brought to them by a member. They were positioned all day in highly visible, key locations in the convention center on registration day and in the lobby near all of the Al-Anon meeting rooms on Friday and Saturday.

All the sharing I heard in meetings meant so much to me, including the AA speakers at the opening AA meeting, at the AA longtimers meeting, and at the AA closing meeting. Clearly they wanted Al-Anon members to attend those 3 meetings in particular, because there weren't any Al-Anon meetings at the same time. A pretty amazing coincidence occurred at the Longtimers meeting. First, I have a question: What are the first names of the two co-founders of AA? Bill and Bob. Those were the first two names drawn out of the hat for a 1-minute share at the longtimers meeting. What a thrill.

Every Al-Anon member was so passionate about the topic they were assigned to speak on. I was so touched by it that I bought a lot of the CDs for the other meetings that I couldn't attend because they overlapped with the ones I attended. I found such inspired sharing on all of the CDs. After each session and during meals, I had wonderful conversations with Al-Anon members I met at those meetings, including a couple who approached me, who were from Canada and have a special needs Alateen. All I had done was to go to the microphone at the open Alateen meeting and shared about how I could have been an Alateen, had I taken action on my teacher's information about a program that helps families of alcoholics. That couple from Canada and I spoke quite a bit about Alateen, and I ended up being able to tell them about an audio book I found in the public library a few years ago written by someone with the same special needs as their Alateen child.

I recommend so highly that you try to **attend the next Al-Anon International Convention, which will be in Baltimore, MD, in 2018, July 5-8**. At the time of the Conference, that was in 167 weeks. With that many weeks in advance, it wouldn't take very much per week to save for the trip!

Area Dreams Workshop

The **2015 World Service Conference Theme** was **Living Our Spiritual Principles, Expanding Our Vision**. In the Area Dreams Workshop, we are going to expand our minds to the limits of our dreams, to achieve the **Board of Trustees' vision: "All people affected by someone else's drinking will find help and recovery in every community."**

"For the past several years, the Finance Committee has developed a presentation that the World Service Conference (WSC) members could take back to their Areas to increase members' knowledge and understanding of Al-Anon money matters." Treasurer, Jennie M., Trustee, p. 51 of the 2015 Conference Summary. [Go to WSO Members website, click on Service Structure tab, then click on Area Resources (or District Resources), and finally click on the dark blue cover of the 2015 Conference Summary.] The following workshop was done at the WSC and with the SCWS Board. **We will do this workshop with the Committee members today and with the Assembly members in November.**

We are going to split into groups according to the Service Leadership Topic each person selects, and each group is going to choose an Area Dream for that topic, then begin to plan the process, identify the necessary resources, both human and financial, to achieve that dream, and consider how to make those plans come alive. We will start today and continue in future Area meetings. We CAN make these dreams come alive in California South, by providing the resources needed, both human and financial.

We each have a part to play in these exercises – some of us are visionary, others are more experiential. Let your particular talent guide you in the discussion. Don't let the voices in your head tell you that you are lacking in any way. Don't let yourself think that because you are not good at everything that you have nothing to offer. We can't all be dreamers – some of us have to be planners.

You have the abundant ability to bring the right contribution to the discussion at the right time. Just keep telling yourself, "It's possible, if it is something I really believe can happen." And, as always, none of us are in this alone. We all want each of you to succeed. Share your hope with us as we share our experience and strength.

In this process of expanding our thinking to think beyond where we have dreamed before, **see the Traditions as expansive rather than restrictive**. If an idea later is judged to violate any spiritual principle, we will go back and see what is possible within our principles. Today, we are going to go forth without prejudging what can or cannot work.

A. Service Leadership Topics

Choose your favorite topic to discuss at the Committee meeting:

1. Relying on the ideas in Concept Nine (Service Manual), especially the "Essay on Leadership" as a guide, what can Areas do to inspire members to grow and develop as future leaders?
2. What is our vision of an Assembly embodying spiritual principles that meets the needs of all Assembly members?
3. What skills, talents and abilities will SCWS need of its GRs, DRs and Coordinators?
4. How can service leaders use technology to link members together at all levels of service, strengthening communication and inspiring spiritual connections within the service structure?
5. What is our vision of an attractive and dynamic Alateen program that would meet the needs of today's young people affected by someone's drinking?
6. How can we as leaders encourage individual Al-Anon members to personally expand public outreach efforts?

B. Group's Area Dream for that Service Leadership Topic

Meet with other Committee members choosing the same service leadership topic.

1. Group scribe records each person's Area Dream for that service leadership topic, one Area Dream per page.
2. Each member votes with \$1 worth of post-its, casting their \$1 divided into up to three ways, up to three dreams. (50¢ + 20¢ + 30¢ on 3 different dreams or \$1 all on one dream,or, 80¢ + 20¢ on 2 dreamsor, 30¢ + 30¢ + 40¢.... etc.)
3. The total \$\$ is tallied and the Group's Area Dream is determined.

C. Activities needed to achieve the Area Dream

1. Create list of possible Activities needed to accomplish the dream (can think of more along the way)
2. One Activity written per notebook page
3. Order the pages (activities) in time, first activity on the left, final activity on the right

D. Resources needed to complete Activity

1. What does it cost?
2. Who are the people needed to make it happen?

E. Time needed to complete Activity

1. Weeks? Months? Years?

As of July 31, 2015, SCWS "net income" is \$12,353.72. Group contributions show a 4.7% decrease compared to last year.

District/Intergroup contributions show a 75.8% increase compared to last year. Convention contributions are up by 60.2% compared to last year.

Overall income is down by 4.4% compared to last year. However, YTD expenses are down by 38.4% compared to last year (but there are pending expense reports).

An additional \$5,000 was transferred into Savings. A projected year-end contribution to the WSO for \$10,000 will be recommended at the November Assembly.

From January 2015 to July 2015, the SCWS treasurer processed 1,087 checks – an average of 155 checks per month.

Ask-It Basket

These Questions are from the August 15, 2005
Committee Meeting

1)A member wants to include “drug addiction” in our Al-Anon welcome. Is that appropriate?

On page 172 of the Service Manual it states the following: "No changes are to be made in Al-Anon or Alateen Traditions, the Steps, the Concepts of Service (except the descriptive text), or the General Warranties of the Conference Charter (Item 12) without written consent of three-quarters of the Al-Anon Family Groups". Adding the words “drug addiction” to the “Suggested Welcome” constitutes a change in Tradition 3, Tradition 4 and also Tradition 5. Therefore, it is not appropriate.

2)What do we say to the newcomer when they only have “Drug Addicts” in their lives?

Part of Tradition 3 states “The only requirement for membership is that there be a problem of alcoholism in a relative or friend”. In Paths to Recovery (page 156) it is explained that newcomers “decide for themselves whether or not they belong”. It is important to let the newcomers know the structure and principles of the program in a loving and caring way. However,

the recent Al-Anon 2015 Membership Survey stated that “40% of respondents initially joined Al-Anon because a person with a drug problem was negatively affecting their lives”. "On Page 124 of the Service Manual it states the following: "Drugs/Narcotics/Prescription Medications. A symptom of alcoholism in the home may be the abuse of drugs by family members. Occasional discussion of this topic is acceptable at an Al-Anon or Alateen meeting as it may be one of the results of living with alcoholism. However, our responsibility is to ensure Al-Anon's survival as a resource for families and friends of alcoholics. By focusing on these drug-related problems, we risk being diverted from the Al-Anon primary aim. Referral to appropriate sources of help may be suggested to those in need."

3)How to handle groups who do not follow Traditions?

At this time SCWS has a Task Force on “Groups That Do Not Consider Al-Anon as a Whole”. Some Intergroup offices/meetings/service boards have taken the action of removing these groups from their meeting directory since groups are listed with the understanding that they will abide by the Al-Anon Traditions. SCWS is not part of any local Intergroup. SCWS, and WSO, approach this issue from a different direction. On page 31 of the Service Manual, it states: "The WSO will register a group with the understanding that the group will abide by the Al-Anon Traditions and not affiliate with or endorse any outside entity or practice." Lois W. is quoted using the phrase “obedient to the unenforceable”. Warranty 4 states “that no Conference action ever be personally punitive or an incitement to public controversy”. Hence, we ask for groups, and members, to be “obedient to the unenforceable”. It would be presumptuous to try to have a definitive answer here to a question that has been under discussion by both SCWS and by the WSO for some time. One of the most basic principles of Al-Anon is to work on ourselves, to make sure we are “keeping our side of the street clean”. Sometimes the best we can do as individuals, as groups, as districts and as areas is to make sure we are being the best examples of Al-Anon we can be.

4)Is the newcomers welcome in the Service Manual?

There is no official CAL Al-Anon “Newcomers Welcome”. However, there was a “Newcomers Welcome” published in the 1990 April/May issue of Inside Al-Anon, but this reading has not been through the CAL process.

5)What can we do about aggressive past DRs?

Our Tradition 2 speaks of “rotating leadership”. Page 146 of *Paths to Recovery* says “Members accustomed to dominating may be unhappy when reminded that we rotate leaders and that we are to serve, not govern”. Perhaps taking some time during a district meeting to study Tradition 2 would be helpful. In addition, the status of past officers may also be a useful discussion. In many Al-Anon service arms some past officers can still have voice but no vote. Is the past DR now a GR? What is the purpose of their presence at current district meetings? As a district, decide what is the status of past officers? On the other hand, is the current DR being open to feedback from and experience of the past DRs?

6)What do DRs do about GRs who leave early on a regular basis from district meetings? I have requested many times they get an Alternate GR.

Our Service Manual (page 63) says “GRs and other officers are leaders and trusted servants who perform their duties in keeping with the Traditions and Concepts of Service, yet have no authority over the group”. Our Tradition 9 states “Our groups, as such, ought never be organized; but we may create service boards or committees directly responsible to those they serve”. Are they being “leaders and trusted servants who perform their duties” when the leave early? Are they being “responsible to those they serve”? The real issue is that the group they represent may not be well represented if they leave early and possibly miss important District issues, discussions and votes. It may be more of an issue for the group they represent rather than a District matter.

Coordinator Reports

Area Alateen Sponsor Coordinator

Alateen: “Keep It Safe & Serene” or KISS May 2015 (Volume 2)

An ongoing series dedicated to increase the knowledge and understanding of how Alateen works.

“As Tradition Four states, ‘Each group should be autonomous except in matters affecting another group or Al-Anon or AA as a whole.’ The Board of Trustees has determined that issues of safety and behavior by Alateens and individuals involved with Alateen service do affect every group and Al-Anon as a whole.” (Alateen Motion from the Board of Trustees – December 8, 2003)

KISS Topic: Alateen Event Plans & Publicizing Events with Alateen Participation

“Much of the information in this Guideline applies to Alateen participation in Al-Anon events and to Al-Anon/Alateen participation in A.A. events. For Alateen participation in an A.A. event, Al-Anon must be participating. All events with Alateen participation must comply with the Alateen Safety and Behavioral Requirement of the Area in which the event is held. The Area has responsibility for use of the Alateen name in the Area, and must be made aware of all proposed Alateen events (G-16 Alateen Conferences; Revised 2014; page 1; paragraph 2).

When is an Alateen Event Plan Required?

An Alateen Event Plan is required for Alateen participation in any activity other than the regular, weekly meeting of a registered Alateen meeting, including but not limited to Alateen conferences, Al-Anon/Alateen conventions, fundraisers for Alateen/Al-Anon conventions or conferences, Area Assembly and Committee meetings, multi-Area events, and A.A. events with Al-Anon and Alateen participation. Bottom line ... when Alateen is participating in any event or activity, an Alateen Event Plan is required.

Alateen Event Plan Requirements – SCWS Area Alateen Safety & Behavioral Requirements – page 7:

1. There must be at least two certified AMIAs who serve as the Alateen Event Sponsors. Overnight events must have at least one male and one female Alateen Event Sponsor.
2. In addition to the two Event Sponsors, there should be an adequate number of AMIAs officially committed to serve as Event Chaperones. WSO suggests one AMIAS for every five Alateens.

3. Each Alateen member attending an Alateen Event is required to provide an Event Permission/Medical Consent form signed by their parent or guardian. In addition, an SCWS Travel & Treatment Authorization form is always required when transporting an Alateen, including for to/from Alateen meetings.
4. Remember that Alateens who are 18 or older agree to participate as minors. However, since the age of legal majority is 18, an Alateen who is of legal age may sign the Event Permission/Medical Consent form and the SCWS Travel & Treatment Authorization form for him/herself.
5. In order to use the Alateen name, the event must be in compliance with the SCWS Area Alateen Safety and Behavioral Requirements.
6. The Event Chair *or other responsible party* must submit a completed Alateen Event Plan to the Area Alateen Sponsor Coordinator **at least 30 days before the event (60 days before overnight events) for approval.**
7. Any event without an approved Event Plan will **not** be able to use the Alateen name in conjunction with the event.
8. **No Alateen event may be publicized** (i.e., flyers handed out or announcements made at Al-Anon/Alateen meetings and events) **until the Area has approved the Event Plan.** This includes convention brochures (A.A., Al-Anon or Alateen) – with Alateen participation mentioned in the title or within the body of the brochure – **until the Event Plan has been approved.**
9. If an Alateen event fails to comply with the SCWS Area Alateen Safety and Behavioral Requirements, the Area Alateen Sponsor Coordinator will attempt to work with the Alateen event to resolve compliance issues. **Continued non-compliance, prior to the event, will result in the event's inability to use the Alateen name. Failure to comply with the SCWS approved Event Plan during the event could result in the loss of the Alateen name for subsequent events** (Ibid, page 9).

When completing the 2015 Area AMIAS Recertification with the WSO, it was discovered that the AMIAS certification expiration date is incorrect in our Area Safety & Behavioral Requirements on Page 3, Recertification, it states:

"Any current AMIAS not in compliance with the recertification process by May 31st, will automatically lose their certified status on July 1 and will have to reapply as a new applicant."

The **correction** is that any AMIAS who does not attend an Area AMIAS Recertification Workshop by May 31st will have their AMIAS certification expire on May 31st (not June 30th). This correction will be made to the Area Safety & Behavioral Requirements document.

If there is neither a CMA nor a GR for a group, they go into *No Mail* status.

Inactive -- 280

After 2 years, of *No Mail*, a group becomes *Inactive*. They stay *Inactive* for 3 years, if there are no financial contributions made to or from the group. If there is a financial contribution made, the group may be *Inactive* for up to 7 years. After those lengths of time, a group is *Marked for Deletion*.

Marked for Deletion -- 66

These meetings will soon be deleted from the WSO database. Their identification numbers are retired and cannot be re-used.

#2: Where to submit Group Updates/Registrations

Please use our SCWS website to fill out any group records changes that pertain to the SCWS/WSO information flow: DR, Alternate DR, GR, and Alternate GR, CMA, and up to 2 Contacts. Most of the forms on the site are now "fillable".

#3FAQs

Why do we ask DRs, CMAs, and GRs to use their last names?

Please see the *Service Manual*, pgs. 91-94, for the explanation of why it's practical for members to use their last names when they are sent postal communications in their service position.

What are some considerations regarding using and distributing email addresses in AI-Anon?

- Care and common sense should be taken, particularly regarding forwarding messages. Use of "blind copies" protects the anonymity of the addresses.
- It is recommended that members not use their full names in their email addresses. This protects members' anonymity.
- Business* email addresses might not provide privacy and could imply affiliation. (p. 93)
- When the district or individual meetings collect and distribute our members email addresses for communication between members, it is *crucial* that members be reminded that they *should not use emails provided for AI-*

Anon communications for any other purpose than AI-Anon business. Members should not use these email lists to promote their non-AI-Anon concerns: businesses, social events, hobbies, etc. If they do this at the district level, the DR can address this privately with the GR. If members of an individual group do this, any group member can address the person privately and request that she/he refrain from doing this in the future.

What to do if active meetings don't have a Current Mailing Address (CMA)?

A group must have a Current Mailing Address (CMA) to be considered "Active" The person who serves as the CMA can be the GR or it can be a person who consistently comes to that meeting. This person will be mailed the group copy of the *Forum*, the quarterly fundraising letters and the revised *Service Manual* every four years to bring to the meeting, and the WSO Annual Update.

The GRs and other members can volunteer to go to the meetings in the district for which there are no CMAs. The information that SCWS/WSO needs from members who volunteer to be CMAs is found on the SCWS Registration form (GR-1), Section 6. If a member goes to a meeting without a CMA and finds someone who will be the CMA, have that person complete Section 6. Bring it to your next district meeting so your DR can register them, or go onto the SCWS website and register the person yourself:

Public Outreach and Institutions:

Schools

We are spending the year gathering information about school outreach: what other districts have done, what schools might find useful, and what our members and our district have the capacity to give. Right now, we are doing more work to determine who our intended audience for this outreach should be and, once that is clear, evaluating what our outreach to that audience might be. We have determined that we will confine our first efforts to high schools and any colleges in our district, private high schools, and are considering approaching community organizations that work with students as there is some concern about the difficulties of reaching out to the Los Angeles public schools in our district as it might require a more comprehensive effort with the central administration downtown and, therefore, might be beyond our capacity. We are still researching these various potential outreach opportunities. Additionally, in our last district meeting, we determined we might need a broader approach. 1) Given that our Alateen meetings are severely limited by the fact that we only have five AMIASs, the GRs in our district have asked that we formally request that the subject of recruiting and retaining AMIAS be on the agenda for a future assembly. 2) And we are leaning towards reaching out to the adults in schools – teachers, administrative staff, parents, counselors – instead of starting with students for three reasons: a) our district has only five AMIASs so couldn't support an onslaught of new Alateens should our outreach be successful, b) the counselors and health class teachers we contacted during the course of our initial research had never even heard of Al-Anon....not one. And these are people charged with aiding kids and sometimes staff in need. And c) these are places likely to be filled with people, both as a workplace and a gathering place for families, who might find the Al-Anon message of help

and hope useful. We did look at the literature available to hand out and were pleased to find draft letters to teachers (OT-5) and to student assistance professionals (OSP-7), among other resources that we can adapt for this effort. We formed a task force charged with conducting more research and further refining a proposed outreach plan.

Outreach to Spanish language meetings

After listening to a member of District 17 talk about their outreach efforts to the Spanish language meetings in their district, we began to think that, rather than just inviting members of those meetings to our district meeting, it might make sense to find projects to work on together. Now we just have to figure out what! If members of any of those meetings (currently in District 64) have any ideas, please contact us!
