Welcome. Reminder to pre-register for TEAM Event.

Welcome to Past Delegates. Jayme C., 2012-2014 Panel 52; Sandie 2009-2011 Panel 49; Kay D., 2000-2002 Panel 40; Willie W. 1997-1999 Panel 37.

Roll Call (Jayme C. substituting for Donna E., Records Secretary Coordinator). DR and ADR were not present for D69. Suggestion to allow District Treasurer to have a voice and vote in place of DR and ADR. A Motion was made and seconded to allow District 69 Treasurer, to have voice and vote in place and instead of DR and ADR. Unanimously passed. Roll Call continues. Motion made and seconded to allow Emily to have voice and vote in place of Valerie N., SCAA Convention Chairperson (2017). Motion made and seconded. Passed unanimously.

Elizabeth, Delegate (Read Report in Bulletin.) Skit. Clarification about process revising SCAC Guidelines.

Marcia M., Alternate Delegate. (Read Report in Bulletin) Remember to register for the upcoming TEAM Meeting on September 16! Reviewed clicker voting. Voted for last day to submit resumes (Dec. 1, 2017). Voted for topic we would like at next SOS: Conflict Resolution: Dealing with Dominance won the most votes. Suggestions about streamlining voting in November.

Jayme, Immediate Past Delegate. (Read Report in Bulletin) Update on Task Forces.

Sandy, Secretary. Marley, D21, read several revisions to February 18, 2017 Committee Meeting Minutes, attached to the end of these minutes. Tracy, D9 made motion to approve Minutes with revisions and Andrea, D12 seconded. Motion passed. Marley will email revisions to Secretary for the record.

Jayme, Immediate Past Delegate - Revised By-Laws of SCWS. (Read Report in Bulletin). The Bylaw changes were reviewed. These Bylaw changes will be presented and voted upon at the November Assembly. Jayme asked for feedback and suggestions on how to present the revisions to the Bylaws at the Assembly. There were many pros and cons considered, but there was a unanimous vote for the Bylaws to be presented comment by comment. Additionally, a straw vote was taken whether the AWSC approves the revisions. It was another unanimous yes!

Eva, Treasurer. (Read Report in Bulletin). Review of financials. Contributions have increased! Discussion about a fraudulent check that cleared the bank. Eva researched online and called

the bank. The bank transferred her to the loss prevention department. After a series of questions, it was determined our account was compromised. Loss prevention suggested we freeze and close account which is what Eva did. We were reimbursed that same month from Chase. Eva considered going to SDPD, but she was advised it was a waste of time for such a small sum. The Check sequence went back two terms ago. As technology evolves, it is important that we have internal controls in place to safeguard our financial data. We will continue to work on improving our policies and procedures. (Who is doing what will be determined after the November election)

CB Responded to Suggestion that the upcoming Assembly date be moved to second week in November because of Thanksgiving. CB explained that it is not an option this year as the room has to be reserved a year in advance. Perhaps the next panel could take it under consideration.

Lunch 12:00 Noon

Afternoon Session resumes 1:00 pm

Ana, D42, reads Traditions.

Open with the Serenity Prayer.

Tarisa, Alateen Sponsor Coordinator. (Read Report in Bulletin.) Live Scan Presentation. Flier distributed. Jayme clarifies that we can discuss this, but we cannot make an impact financial decision, only the Assembly can do that. Questions and discussions:

- Clarification if you are already a certified AMIAS and have gone through LiveScan, you do not have to do it again.
- If you fail to recertify as an AMIAS, you will have to have another background check.
- Discussion about districts deciding on what policy they will have on an individual basis by district or making this a uniform policy throughout the districts.
- Clarification that the \$20,000 is a one-time cost, and that it will be approximately \$8,000 annually to maintain.
- Comment that if AMIAS let their certification lapse, they should be obligated to pay a portion of the cost to recertify.
- Tarisa clarified she is asking for a recommendation from the Committee about what they recommend be asked of the Assembly.
- Comment that the Area, District & AMIAS should share the cost of LiveScan.
- Clarification regarding DOJ check.
- Sandie E. provided information about past decisions regarding being an Alateen sponsor and cost; specifically, Alateen Sponsors would share partial cost because it is a privilege to be an Alateen Sponsor.
- Suggestion that some of the cost should be on the AMIAS to show they are dedicated.
- Suggestion that initial cost be paid by the Area, rolling fee be paid by AMIAS.
- Clarification and encouragement that the Committee decides on what kind of plan to present to the Assembly to avoid lengthy discussion.

- Tarisa discusses subsequent notifications – notifications that alert AAPP if an AMIAS commits an act of questionable behavior that may change their status after they have cleared background check.
- Jayme suggests this be a shared cost between AMIAS's, district and Area.
- When asked her opinion Tarisa suggests that the Area, District and AMIAS share the cost.

Vote taken regarding who should bear the cost of LiveScan. Area, District and AMIAS together received the most votes. (Tarisa suggests that homework for DRs is to decide on how this cost is shared.)

Tarisa checked with the Committee members to see if they thought only new AMIAS's should be processed using LiveScan, or if we wanted to catch up all existing AMIAS's and require LiveScan for them too. Suggestions and discussion followed, with members favoring **all AMIASs** (new and pre-existing) complete the LiveScan process.

Tarisa's report was extended 5 minutes to discuss suggestions on who pays for recertification if AMIAS does not recertify and then expects area or district to pay cost.

- Comment that district pay recertification once for AMIAS who lapses their recertification.
- Comment that we need to recertify AMIAS's at least every 5 years.
- Comment that AMIAS should pay for recertification if they lapse since they have many opportunities to recertify.
- Comment that it should be up to the District and the AMIAS regarding paying for recertification.

Marcia, Alt. Delegate (Read Report in Bulletin.) In preparation for SCWS Assembly on November Elections, Marcia suggested a 5 minute break to discuss with your neighbor their journey with service and future goals. After five minutes, those who wanted to, shared about what they learned:

- Service helps get you out of isolation.
- Service helps you prioritize helping yourself v. helping others.
- I'm a better DR because of the people I sit next to.
- I aim for the best now.
- I've learned so much more about Al-Anon by doing service.
- When I Got Busy, I Got Better.
- I feel like I belong more in Al-Anon doing service.
- Service helps me set my boundaries.
- Service has exposed me be with people who are doing it with love, hope, trust.
- Service is my Higher Power working through me.
- The more varied the experience, the greater the strength.
- Service has shown me I am capable.
- It's a loving and growing commitment.
- Service keeps me coming back.
- Being of service helps me with dealing with people and conflict resolution.
- I am a product of getting in the car.

- Service has helped me realize I am enough.
- Suit up and show up and God will take care of the rest.
- I learned to take criticism.
- Encourage others to do service.

New Policy

Review and implementation-Southern California Policy for Resolving Group and Members Concerns

Marley- Dist. Rep-21/Task Force Member reviewed Policy Preamble and The Policy.

~~We were the seventh area to make a policy. Where does this policy come out of? The results coming from this group was from 18 months of reviewing all literature for information on this topic.~~

We were the seventh area to make a policy. How did we develop this policy? We began our 18 months of work by reviewing all of the other Areas' policies and all of our literature and guidelines that pertain to this topic.

Mary-Dist. 57- Task Force Member reviewed "How the Policy Works"

~~Situations covered by this Policy include remarkable instances of dictatorial, as well as therapists who charge for meetings.~~

Situations covered by this policy include remarkable instances of dictatorial sponsorship as well as therapists who charge for meetings and/or sponsorship.

Note that it seems that education is what will be needed in most cases to abide by these policies.

Billy M. – District 36 – Task Force Member reviewed "How to report a concern," including the email address and the physical address.

~~If the resolution committee cannot complete this process, it will go to the Delegate, Alternate Delegate and Immediate Past Delegate in the next term.~~

Most concerns will be reported and resolved at a local level. If questions or concerns cannot be solved at a local level, members can email or contact the Area. Those questions or concerns will end up with the Delegate, Alternate Delegate, and Immediate Past Delegate. They will determine if there is an issue that requires gathering more information. If it does, they have the ability to appoint a "Resolution Team" who will begin by talking to all members involved in the situation.

The Task Force has completed their task. They were charged with nothing more than creating the Policy.

~~Not all group concerns need to go to the Area Resolution Committee. Steps to be taken are laid out in the Policy. If that does not resolve the concern, then the Area Resolution Committee would be contacted by email or my sending a concern to the permanent mailing address for SCWS (in Cypress, CA).~~

Members with questions or concerns can send in an email or regular mail to the SCWS address in Cypress. (Sandy: the rest of this paragraph can be deleted because it's already been

addressed previously)

Task force members have been to San Diego, Inland Empire and OC AIS to cover this policy. L.A. is in the near future. Spanish had to be translated and will be brought to them soon. Ventura County is March 16th.

Comments/Discussion

Q. If an issue is brought forward and it is deemed educational, is there any follow-up and by whom??

A. The panel envisioned archiving the issues as issues come in.

Q. When a group gets to the place where you have to delist or relist? How is it going to be communicated to the members and the different areas?

A. The Implementation of this Policy is up to the SCWS board. Using the flowchart as a guide, the groups are only listed in one AIS and the task force felt all who would be affected by this would all be kept in the loop. It was not built into the policy to address this, so the issue will be addressed as the implementation happens in the future.

~~Q. His Dist. felt like their GRs present at the Nov 2016 Assembly did not get a KBDM format to understand this policy. They felt rushed into making a decision on the Policy for Groups Who Do Not Consider Al Anon As A Whole because they wanted to bring it back to their groups to discuss it first. A District Representative said their GRs felt they were not able to adequately prepare for this vote, did not get the information in advance to discuss, and felt rushed into making a decisions on the policy. They would have preferred to bring back the information they were given at the meeting to discuss with their members.~~

A. Please see page 63 in the Service Manual. Also see the GR role and the delegate role on Pg 172.

The letter was not actually a "minority appeal" because that point already was brought up in the discussion at the Nov 2016 Assembly. The vote to approve the Policy came out with a vote large enough to pass. There was no new information presented in the appeal, so it actually is not a minority appeal. Simply disagreeing with the outcome of the vote does not make it a minority appeal. There must be new information in the appeal that was not part of the original discussion in order for it to be a minority appeal.

A. The right of decision making makes effective leadership possible. The GRs are the trusted servants who have been elected by their group to make a decision as their trusted servant, based on the information presented.

~~Q. The first vote was the vote spoken of. That is the one where the GRs in our district felt like they were being forced with no clear message of the reason for the vote. The DR clarified that they were unhappy about the vote that was taken about whether or not the GRs felt ready to vote on the policy at this meeting.~~

New Executive Director

The new Executive Director is Vali F. Her term starts Sept 5, 2017. Mary G., the Interim Executive Director since April 2016, will work side by side with Vali until the Oct 21 Board meeting, or sooner.

A. The point that was not clarified before the first vote is that the vote on whether the Assembly is ready to vote is approved only by simple majority (not 2/3 vote), whereas it is the vote on approving the policy that is approved by 2/3 vote.

Q. Felt unclear on what the vote was about and abstained. We did not have enough information at our disposal

A. Sometimes the discussions at Assemblies and the Conference are less than perfect. Over time, the process will be better defined.

Q. When a meeting prefers to use the older versions of literature, rather than current literature. Past DR’s have said it is group autonomy.

A. This Policy is about not referring newcomers and members to meetings.

A. ~~We can use any literature we choose in our own lives outside of meetings. In meetings, however, the latest versions of CAL is used, including pamphlets.~~ ***We can use any literature we choose in our own lives, outside of meetings. During the 60 or 90 minutes we call an “Al-Anon meeting, however, the latest versions of Conference Approved Literature (CAL) is used, including pamphlets, per the Al-Anon/Alateen Service Manual.***

Vali is from the Southwest Region, from Arizona, Panel 53 Delegate. She overlapped with Jayme at the World Service Conference by two years and with me by one year. Vali also has been Area Chair, Area Treasurer, Area Secretary. She has been active in Al-Anon for more than 15 years. For her business experience, she has been in management for an international company, managing teams of staff throughout the world. She has more than 20 years of business experience.

All of the updates to the Service Manual that were approved at the 2017 World Service Conference now are available in the online Service Manual, on the members website. Please go to the members web site to *download, print, trim, and insert replacement pages over current pages* in your 2014-2017 Service Manual. They will be incorporated into the new 2018-2020 Service Manual, which will be available for purchase in January 2018.

Updated sections of the Service Manual:

1. **Financial Matters.**

Changes to Policy pages 95-99, 128-130. Updated to reflect the spiritual principles of self-support

2. **Membership and Group Meetings/Conventions.**

Changes to Policy pages 85-86, 127-128. The new text was created by the Policy Committee to clarify several issues that have come up in regard to what could be announced at meetings, and event flyers being distributed at meetings when the event does not abide by Al-Anon's Traditions.

-Core spiritual principles that characterize Al-Anon and Alateen events

-The philosophy and criteria for identifying events and activities as Al-Anon and Alateen

3. **World Service Handbook.**

Changes to Handbook pages 131-170. Extensively updated, explains our Service Structure and how our trusted servants can best function within our Structure. Updated to reorganize information and make it easier to find, as well as to clean up text and reflect current activities for various service positions. It is important to note that the changes were related to clean up and not to procedures.

Remember to update your Service Manual by printing those pages and the following pages from the members website and tape them into your Service Manual. They will be printed in the next SM, 2018-2021, and are in the online Service Manual.

Concept One: Groups Decide

Concept One: *The ultimate responsibility and authority for Al-Anon world services belongs to the Al-Anon groups.*

The Groups Decide.

Recall the Area World Service Committee meeting in Feb 2015. The Delegate brought copies of the suggested updates to the descriptive text for Concepts 8 and 11 to gather Area feedback in terms and questions and suggestions. Every Delegate did the same thing.

Through this process, there were many more eyes looking for holes in the updates.

We rolled up our sleeves and put on our thinking caps. We worked HARD!!

All Delegates sent feedback from their Areas to the World Service Conference Task Force on updating the descriptive text for Concepts 8 and 11.

This feedback also was consolidated and distributed to all Conference members (Trustees, Delegates, World Service Office Staff) for discussion at the World Service Conference (WSC). At the April 2015 WSC, we went line-by-line through all of the suggested updates.

After the Conference Chairperson confirmed that all questions have been answered, the Conference voted to approve these updates, approving the Concept 8 text updates at the 2015 WSC, and Concept 11 text updates at the 2016 WSC.

SCAC 2016: What happened?

At SCAC 2016, drugs were brought and 911 had to be called to bring an Alateen to the Emergency Room.

We don't ever want a repeat occurrence.

Whatever paperwork was supposed be in placewhat happened?

Was it not followed?

Was it not enough?

All agreed that restructuring of SCAC is needed. "All" is the Area Alateen Resolution Committee, the Area Officers, the SCAC Work Group (consisting of members of the 2016 SCAC Committee and Area Board members).

The restructuring is proceeding in phases.

Phase 1: input from SCAC Restructuring Work Group 12 members: 6 AMIAS, 6 Alateens.

All members of this work group attended 2016 SCAC. Work began in Sept 2016, weekly 3-hour meetings.

As of Dec 31, 2016, this Work Group generated 6 pages of outline for safety concerns and program content.

Phase 2: input from Alateen Area Alateen Resolution Committee, 6 members: Alateen Sponsor Coordinator (chair), AAPP, Alateen Member Coordinator, AMIAS At Large, Delegate (Area Treasurer as of June 2017), Immediate Past Delegate

In Jan-May 2017, 49 pages of specific procedures were generated.

The Alateen Sponsor Coordinator contacted an attorney, who advised us to have 2 AMIAS per dorm hallway for nighttime supervision.

The Area Alateen Resolution Committee still is working on questions and procedures now, as of Aug 2017.

As much as anyone would have wanted 2017 SCAC to happen, the restructuring document was not ready, and it still is not ready. See additional details about the process, below.

Until June 2017, it was our working process that of these 6 members, a quorum of only 4 is required to conduct a meeting, and passing a motion requires $\frac{3}{4}$ vote. Therefore, we effectively were working with the presumption that it was possible for only 4 members to approve the restructuring document for the Area.

Thus, even if there were lingering safety concerns about any particular issue, it still was possible to pass the document since unanimity was not required among the 6 members.

However, on a call in June with the Associate Director - Groups about another Alateen matter, the Alateen Sponsor Coordinator and the Delegate were reminded about how Concept One applies to this matter, and the need for the Groups to decide. This means that the GRs at the Assembly will give the final approval of the restructuring of SCAC, not 4 out of 6 members of the Area Alateen Resolution Committee. Prior to bringing the document to the Assembly, it first will be brought to the Area World Service Committee for discussion, evaluation and input.

Phase 3: input from Area World Service Committee
Approx 60 members: DRs, Liaisons, Coordinators, Officers, Past Delegates (voice but not vote).

More eyes looking for holes.

AWSC members will look at the draft document prior to the AWSC meeting to allow sufficient time/conditions to truly evaluate the safety of the procedures.

Principles Above Personalities: "If so-and-so approves it, then it must be okay." Right?on the contrary:

Do YOU think it is safe?

All AWSC members must feel safe asking questions, so allow for questions and comments to be submitted anonymously on paper, if needed.

Are all questions answered?

Is the document ready to go to the Assembly?

Send back to the Area Alateen Resolution Committee, if needed. Repeat Phase 3 if necessary.

Phase 4: input from the Assembly

>200 members: Group Representatives, Area World Service Committee members, Past Delegates (voice but not vote)

Assembly members will look at the draft document prior to the Assembly meeting to allow sufficient time/conditions to truly evaluate the safety of the procedures.

Principles Above Personalities: "If so-and-so approves it, then it must be okay." Right?on the contrary:

Do YOU think it is safe?

All Assembly members must feel safe asking questions, so allow for questions and comments to be submitted anonymously on paper, if needed.

Are all questions answered?

Is the Assembly ready to approve the document?

Send back to the Area Alateen Resolution Committee, if needed. Repeat Phases 3 and 4 if necessary.

Phases 3,4: input from AWSC and the Assembly

Do these phases need to be repeated?

We are done when we are done.

There is no deadline.

We have to do this right.

Phase 5: input from CA attorney

Before implementing the Area SCAC Safety and Behavioral Requirements, all documents will be reviewed by a California attorney, selected by the Area Officers.

Other considerations?

Review by the WSO?

As many Sponsors have said to sponsees,more will be revealed.

WSO Financials

The 2016 WSO Budget, revised by the time of the April 2016 World Service Conference, had an anticipated deficit of \$125,000. See circled number in figure on page 12.

Thanks to the generous contributions of so many members, \$15 at a time, members contributed nearly \$2.1 million, giving us an actual net increase of \$88,153. See circled number in figure on page 12.

The budgeted total expense was just under \$5 million.

Literature sales were \$2.7 million

Forum subscriptions were nearly \$252,000

The actual expenses were \$43,000 less than what was in the revised budget.

Given these numbers, the preliminary budget for 2017:

-is based on total expenses of just over \$5.2 million

-has the same total estimated revenue as the actual 2016 revenue, giving a net budgeted increase of \$10,500. See circled number in figure on page 12.

Remember to maintain the same level of contributions in 2017 as in 2016.

Jennie M., Trustee and WSO Treasurer, informed us at the 2017 WSC that the plummeted value of literature sales is still with us, so to remain fully self-supporting, we need to maintain the increased level of contributions. **Please continue your increased contributions. Thank you.**

We will be doing a lot of voting during our November Assembly. Below are the latest "Clicker" instructions. Please let me know if you notice anything in the directions which is unclear, etc. We will practice using these instructions today when voting for the Coordinator Resumes due date, (Dec. 1st was picked) and your favorite SOS topic ("Dealing with Dominance" was picked).

Instructions for Voting Clickers

1. The items to be voted on will be displayed on the screen with numbers next to each possible selection. (EX: 1. YES, 2. NO, 3. Abstain ; or 1. Ted, 2. Mary, 3. Joe)
2. There will be a verbal alert, "Ready, set, GO" when the voting begins. You will see the 20 sec. countdown to "0" on the screen.
3. Members push the number button for their selection during the 20 sec. countdown. Green light shows it's working. (NOTE: Pushing "SEND" does nothing)
4. If you change your mind, you can push another number selection before the voting timer is completed. (Countdown displayed on screen). *Only the last # button you selected is recorded & counted.*

Your DR is responsible for collecting the Clickers if you leave for lunch and at the end of the Assembly. (If you **must leave** for the restroom during a vote, give your Clicker to your DR. However, **your DR cannot/will not** vote for you.) You are repre-

senting your Group with your vote and are their “*trusted servant*”. You vote as best you can given the information presented.

The “Service Journey Worksheet” is posted on our SCWS website under “Assembly and Committee Meeting Presentations”, then under “The latest Election Procedures”. I encourage all of you to complete the worksheet alone, with your Sponsor, maybe with your group, and to think about the upcoming open positions on our SCWS Board. Immediate Past Delegate

I have given my report some thought and have decided to discuss the Election Assembly in November.

This election only happens every three years. It is a very exciting day and this is the Assembly you don't want to miss! Everyone needs to take the time to review the resumes. Get to know the candidates as best you can from their resumes. You can contact them personally if you have any questions. We evaluate candidates in light of past performance, ability to work with others, and the qualities cited in Bill W.'s essay on leadership.

Many of us have read Bill W.'s essay on leadership in the *2014-2017 Al-Anon/Alateen Service Manual* pp.199-202. He speaks to the attributes of a leader -- vision, responsibility, stability, flexibility, and good judgment. “A leader is a person who can put principles, plans, and policies into such dedicated and effective action that the rest of us want to back him up and help with his job.” My favorite quote from Bill's essay is this one: “Leadership is often called upon to face heavy and sometimes long-continued criticism -- an acid test.” This might be a great time for everyone to read Bill W.'s essay.

Because of our service structure and the way Al-Anon rotates service positions, members have many opportunities to develop leadership skills and qualities. On page 152 in the *2014-2017 Al-Anon/Alateen Service Manual (World Service Handbook, new version on Members' Website)* it does state this: “In order to draw on experience gained in service, an Area may choose to permit anyone who has served a three-year term as DR, *has remained active at the Area level*, and regularly attends Al-Anon meetings to stand for the office of Delegate. It is recommended that Areas have a process or procedure for handling this possibility.” (*This was new information for me*).

All of the SCWS Officer and Coordinator positions are important to our Area. Some service positions require experience and expertise, and natural leaders are people that we want to follow. They have vision and enthusiasm. They also need to be responsible, tolerant, stable, flexible and of good judgment. We want members who will serve the Area with integrity and a strong work ethic. Members who live according to the

principles of the program and are worthy of our trust. For the position of Delegate, we hope to have someone with an effective voice for Southern California at the World Service Conference.

Concept 3: The right of decision makes effective leadership possible. In November, eight members will stand for the five officer positions. These members will be elected to the five officer positions for SCWS and we trust that these five individuals will not only get the jobs done, but they will be ready to serve in these positions. This concept is about giving dignity to the person doing the job. Before Al-Anon I didn't trust anyone. I grew from making small decisions in my personal life and in service work and then being able to make more wide-reaching decisions. I recognize that trust is always a privilege. Our leaders must always be accountable to those they serve. However, with wise choice of our leaders and mutual trust between us, we will be worthy of each other's confidence. This concept is about mutual trust.

Concept 9: Good personal leadership at all service levels is a necessity. In the field of World Service the Board of Trustees assumes the primary leadership. This is my favorite Concept.

When we follow this Concept we are choosing trusted servants with good personal leadership skills. “*Personal ambitions must be set aside, antagonisms and controversy forgotten. Who are the best qualified people we can name?*” should be the sole thought.” *Service Manual, Page 199.*

What are the qualities of good personal leadership? Concept 9 tells us they are: responsibility, tolerance, stability, flexibility, judgment, and vision. If we act responsibly, we inspire confidence. Our family, friends and co-workers respect us. Being responsible includes being motivated by principles, never passing the buck, and setting an example that inspires others to follow.

When selecting our leaders, members have a responsibility to evaluate these leadership traits in the candidates. Since each member in service is a world servant, not a popularity contest winner, there is no room for personal ambition or self-glorification.

This Concept also speaks to holding our trusted servants accountable, practicing rotation of leadership, keeping past trusted servants (past Delegates) involved and principles above personalities. We lead by attraction rather than promotion. Good leaders are those that people willingly follow. A good leader has vision and cultivates a new generation of leaders. A good leader knows that this is very important for Al-Anon to survive.

“Our structure can be no better than the personal performance of those who serve and make it work. Good leadership cannot function well in a poorly designed structure. Weak leadership can hardly function at all, even in the best of structures. Furnishing our service structure with able and willing workers is a continuing activity.”

As the GRs meet in November at our Assembly to name a Delegate, an even greater degree of care and dedication will be

required. Who are the best qualified people we can name, should be the sole and only thought.

Have you looked at the resumes of the individuals who will stand for the five officer positions? Have you thought about the candidates that will stand for Delegate in November? Do you know their capabilities? Do you know if they are trustworthy? Do you know if they are accountable? Do you know if they are open-minded? Do you know if they are a good listener? Do you know if they are truly prepared for the job ahead? Do they have an agenda? Are they standing for Delegate because they think they deserve it? No one deserves it.

In conclusion, I would like to leave you with a unique story regarding geese flying south. To me, it surely demonstrates leadership in the most primal state. I am sure that you have at some time or other seen a flock of geese flying from the North to the South for the winter. They fly in a “V” formation.....the leader in the front. The leader takes the turbulence and the wind for the group. While in flight, the other geese “honk” to give the leader encouragement. When the leader gets tired, he moves to the back of the “V” formation allowing someone else to take the position of the leader. In the field of Zoology the technical term for the leader would be called the “head honker”! In Al-Anon we call this Leadership!

Ask-it-Basket

1. Q: How is World Service tracking digital book sales? What books are offered, when, and how are financials being funneled back to the regions?

A. For the first question, we asked the WSO Treasurer, Jennie McC., Trustee (volunteer), who replied:

The Finance Committee, Executive Committee and the Board of Trustees all receive sales data on e books. This includes the book title and comparison to prior years. It allows us to have information about the fellowship's response to the various electronic pieces and guides us in the future, should we want to consider offering other literature in this way. We also had heard a concern prior to implementation about e-books negatively affecting LDCs, which would be an unintended negative consequence. Sales are small enough (fortunately or unfortunately) that we are not seeing that impact on LDCs. There is some interest in e-books and those who have purchased are very happy to have added to their literature collections in this way, but it has by no means replaced the purchased of print books.

In your second question, are you asking about how does the information about the sales get back to the Areas? (If you are asking something else, please clarify.) The WSO financials that are sent to the Delegates prior to the World Service Conference contain the overall literature sales, without breaking it down into printed vs digital literature.

About the first part of your second question, please look at the Al-Anon World Service website, in the Al-Anon Online Store section, “Electronic Literature” to see the Al-Anon Conference Approved Literature (CAL) that is offered electronically. (al-anon.org, “Al-Anon Store” tab” in the upper right side, then click on “Electronic Literature” from the list of Categories for details and links to the vendors who sell them.) Currently there are four e-books, and The Forum offered electronically. There also are three audio books (click on “AV/Audio for details and vendors). There are over 50 “Free Downloads” including all of the Guidelines and “Open Letters” to various professionals.

2. Q: We have many members who want to include more electronic communication including Facebook and Instagram

by individuals – Please advise how/if this affects anonymity.

A. This question, “Technology and Anonymity”, was a well received topic at our Sept. TEAM event in Glendale. Please refer to the handout which is now posted on our SCWS website. Other resources include: “Electronic Al-Anon Meeting Guideline” (G-39), there’s a section on Anonymity; “Fact Sheet for Electronic Meetings” (S-60); “FAQ for Al-Anon Web Sites (S-66);

3. Q: Will the same SCAC restructuring task force continue on into the next panel?

A. The SCAC restructuring **Work Group** will continue on until the new safety and procedures guidelines are complete, voted on & accepted by the Assembly. The individual members on the - Work Group may change during the next term. **For example, the new Area Alateen Sponsor Coordinator, the next Immediate Past Delegate, the newly elected Area Officer assigned to the SCAC Restructuring Work Group all will change. The members/officers named will be up to the newly elected Area Chair.**

Note this definition, Work Group: A unit of people established to meet an ongoing need of the originating body. It can be considered a permanent part of the organization which has formed it. (Page 68 – 69 Al-Anon/Alateen Service Manual)

4. Q: In May the Spanish Interpreter was not very good, actually skipped a lot of the info.

A: The District Representative for D-64 (they are the custodians of our translation equipment) is collecting names of bilingual members who would be able to provide appropriate translation as an interpreter. The list now has names of several willing/able members who could be available to interpret during an Assembly, etc. If you know of someone with the skills to handle such a task, please contact D-64’s DR.

5. Q: It is my understanding that SCAC & other special events cannot be funded through the 7th Tradition. But if a group insists on doing so, should the funds be taken from 7th Tradition collected after the vote?

A. SCAC, AA conventions with Al-Anon Participation, etc., are outside events and not considered part of the Group’s usual expenses. Service Manual, pg. 9 “The basket is passed to cover group expenses, including rent, purchase of literature, and support of trusted servants and Al-Anon’s service arms.” Members who have donated to their group’s 7th Tradition may have an expectation that their donations will be used according to the descriptions of the 7th Tradition such as in the pamphlet S-21, “Seventh Tradition.”. “Our financial support provides the group with rent money for its meeting place, literature, information for newcomers, reimbursement or payment for the Group Representative’s expenses to the Assembly and District meetings, and other group expenses.” If a group wishes to contribute to another Al-Anon/Alateen event, a separate envelope/basket can be passed around clearly delineating what the individual contributions are for.

Area Alateen Sponsor Coordinator

Alateen Conference Restructuring Workgroup:

The Area Alateen Resolution Committee (AARC) is nearing completion of the SCAC Procedures. I previously stated that the Officers would review it and upon their approval, the suspension would be lifted. I received the following written statement from the WSO:

“The purpose of the 2003 Alateen Motion by the Board of Trustees is to bind Al-Anon and Alateen in its legal responsibility to ensure Alateen’s future. As such, Al-Anon and the Area it serves must abide by the Safety and Behavioral Requirements it sets up to ensure the safety of Alateens anytime and anywhere the Alateen name is used. This means that all events using Alateen’s name must be under the approval of the Area. Alateen is not a “stand-alone” entity. We encourage and welcome participation in discussion and vote by Alateens in the capacity of GR as part of Area-wide decision-making. Task forces or work groups can include Alateen participation but that participation unfortunately is not equal to the final decision that an Area needs to make in order to set up events and activities using the Alateen name. The Area is fully and solely responsible for all Alateen activity. Before any decisions can be made, **there must be approval from the AWSC and then the Assembly for any Alateen requirements or guidelines to be put into effect.**”

Therefore, the SCAC Procedures will be presented at the February 2018 AWSC. If the document is approved by the AWSC Committee members, it can be presented at the May 2018 Assembly for approval from the GRs.

The suspension can be lifted after the GR’s approve the SCAC Procedures. Unfortunately, this time frame will not allow sufficient time to hold SCAC 2018.

Alateen Task Force:

At the May 2013 Assembly, the GRs voted to have a task force created to discuss the following and report back to the Assembly with their recommendations:

1. Should the maximum age of 20 for Alateen members be changed?
2. How can the Area support meetings that have Alateen members with special needs?
3. What safety measures need to be put in place in order for the Area to support overnight Alateen events?

Eight (8) AMIAs were selected to be on this task force. The eight members are current *or past* Alateen Group Sponsors, have experience with Alateen Events, and represent different

regions of CA(S). Starting September 2017, the Alateen Task Force will meet on Sunday evenings.

Background Check Task Force:

Information pertaining to Live Scan was presented at the February 2017 AWSC meeting with a consensus of moving forward with Live Scan. Discussion was held at the August 2017 AWSC meeting regarding the financial and logistical impact on the Area, Districts, and AMIASs. Discussion ensued as follows:

- 1) Who should be financially responsible for the cost of Live Scan?
 - A. The consensus was that the Area should not be burdened with the entire cost. It should be shared with the District and/or AMIAS. More discussion will follow at the February 2018 AWSC.
- 2) Should current AMIASs be required to complete the Live Scan process or should we just move forward with new AMIAS applicants?
 - A. Unanimous decision was that all AMIASs (current and future) complete the Live Scan process.
- 3) Who should pay the Live Scan fee for AMIASs that certify after their original certification has lapsed?

AMIAS Recertification Workshops:

I will be sending out an email to all DRs and DALs to request if and when their district is interested in hosting a 2017-2018 AMIAS Recertification Workshop between October 2017 and May 2018. The schedule will be created and posted by the end of September 2017. *Reminder that if your district has not hosted an AMIAS Recertification Workshop this panel, you are required to host one this year.*

The AMIAS Certification Training webinar will continue to be held on-line from 8:00 pm – 9:30 pm on the second Sunday of even months and second Wednesday of odd months.

SCWS Alateen Event Plan Form:

Based on input from Area members, the form has been revised for clarity and simplicity. It is still in draft format but will be available once it has been reviewed by past Event Sponsors.

Alateen Participation at Conventions:

It is important to include Alateen participation when planning a convention. If an Alateen member is unable or unwilling to step up as the chair, an AMIAS can do so. Reminder that the procedure for Alateen Events must be followed.

An Event Plan must be submitted to the Alateen Sponsor Coordinator (alateen@scws-al-anon.org) and approved before publishing “Alateen Participation” on the convention flyer or distributing a flyer for the Alateen event. You can submit the Event Plan months in advance of the event. You do not need to wait until the deadline of “30 days before the event, 60 days if it is an overnight event”.

Research and reference from our Service Manual will be of utmost importance to solving on-going issue. **(pg. 104 of Al-Anon Alateen Service Manual)** is very clear about A.A.'s literature is not used at Al-Anon meetings because it is written for and from the viewpoint of alcoholics and is not Al-Anon/Alateen CAL. This CAL issue might exist because the Traditions are not being practiced. Tradition 3 helps us to guard against the confusion results, when we allow our program to be diluted, **(pg. 99 Al-Anon's Twelve Steps & Twelve Traditions.)**

I continue to be most grateful for the Al-Anon Program. The last few months I've had somewhat of a set-back on my recovery. But like the booklet says "When I got Busy I Got Better." This year's commitment has been a God send for me. Thank you Al-Anon Family members everywhere.

The District also is launching a pilot project through the Fullerton Police Department to provide Al-Anon introductory literature to families of individuals involved in alcohol-related incidents. The Fullerton Police Department has about 500 such incidents a year. If the project proves effective, the District will broaden the outreach to other law enforcement agencies within its geographic area.

At its seventh annual educational workshop—which focused on Conference Approved Literature—the District raised more than \$100 for the World Service Office and sold \$400 in literature. Preparations have already begun for the eighth annual presentation of the educational workshop, which is scheduled next spring.

District meetings include short study sessions on the Al-Anon "Service Manual," as well as discussions of problems and concerns that arise in group meetings. To keep identification of groups and individuals anonymous, the Alternate District Representative collects and presents information for discussion. Members—male and female—are preparing one-paragraph biographic statements to paint a more realistic picture of the average Al-Anon than that provided by the WSO annual survey, which describes the typical member as a 65-year-old white woman.

After distributing 400 copies of "Al-Anon Faces Alcoholism (now titled "Help and Hope") early this year, the District has ordered another 325 copies to distribute this fall.

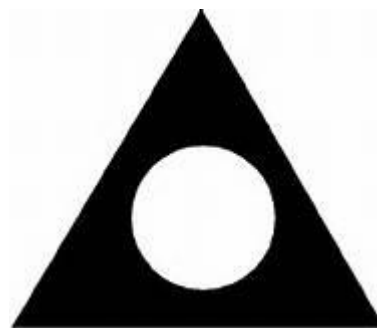

ELECTION PROCEDURES

1. The Area Chairman serves as the “Election Chairman.” In the event that the Area Chairman is participating in the election, the entire election will be conducted by the Immediate Past Delegate as the Election Chairman.
2. Current or Past District Representatives who have submitted a completed resume (form on SCWS website) by the posted deadline will be considered to be candidates for the election of Officers when they stand for a position at the Election Assembly, revealing position(s) sought by standing at Election Assembly. Submitting a resume is not binding: a candidate may withdraw simply by not standing at the Election Assembly. Candidates also may inform Immediate Past Delegate of their withdrawal prior to the Election.
3. The Election Chairman reviews the proposed election procedures, given below. It is important that everyone understands the method agreed upon for the election of Area Officers.
4. The Election Chairman asks for a vote of acceptance of the proposed method of election, below. If another method is considered, it should be clearly understood and agreed upon by 2/3 vote of the Assembly.
5. Election Chairman invites candidates who believe they are prepared, willing and who have submitted a resume to come to the dais, starting with candidates for Delegate. Each candidate will be given 2 minutes at the microphone to answer the following specific question from the resume form in their own words: “Describe why you would be an asset as an SCWS officer.”
6. At the time the vote is called, voters will indicate their choice by clicking the appropriate button on their electronic voting device. During the voting period, no one may enter or leave the room until the vote result is declared by Election Chairman.

Voting Procedure

1. Confirming count of voters. Group Records Coordinator takes roll call to obtain manual count. This number is confirmed by taking electronic count, when voters click on their electronic device to indicate their participation in the election.
2. Election of Delegate, requires 2/3 vote. A first ballot is taken. The candidate receiving 2/3 vote is elected Delegate.
 - a. If first ballot does not elect the Delegate, the Election Chairman may ask candidates receiving the lowest votes to withdraw. If two candidates each receive at least 40% of the total vote, the Election Chairman may ask those two candidates to remain and the others to withdraw.
 - b. Whether or not names are withdrawn, a second ballot is taken.
 - c. If still no election occurs, a third ballot is taken between the two candidates receiving the most votes.
 - d. If 2/3 vote still is not reached, the Delegate is selected by lot. The first name drawn becomes the Delegate.
3. Election of Alternate Delegate follows same procedure as for Delegate.
4. Election of Chairman, requires Majority vote. A majority is 50% + 1 vote.
 - a. A first ballot is taken. The candidate receiving majority vote is elected Chairman.
 - b. If first ballot does not elect the Chairman, the Election Chairman may ask candidates receiving the lowest votes to withdraw. If two candidates each receive at least 40% of the total vote, the Election Chairman may ask those two candidates to remain and the others to withdraw.
 - c. Whether or not names are withdrawn, a second ballot is taken.
 - d. If still no election occurs, a third ballot is taken between the two candidates receiving the most votes. The candidate receiving the most votes on the third ballot is elected Chairman.
5. Election of Secretary and Treasurer follows same procedure as for Chairman.
6. No Candidate
In the event there is no candidate for a position, it will be treated as if a vacancy has occurred. (Reference: SCWS Bylaws; Article VI)
7. One Candidate
In the event there is only one candidate for a position, there will be a yes or no vote. (Reference: SCWS Bylaws; Article VIII)
