



Officers' Reports

Delegates

God willing, I will serve as your voice and your ears at the annual World Service Conference (WSC) April 18 to 22; bringing information back to you at the May Assembly.

- The WSC has again asked that I come to the Spanish luncheon prepared to share about what is happening in our Area with our Spanish language members.
- My committee assignment at the WSC is the Conference Committee on Trustees and I will be reviewing applicant's resumes again this year. Rotation of leadership occurs at all volunteer service levels and each year there are 3 new Trustees At-Large and one member elected to the Executive Committee for Real Property Management. In addition, the World Service Office (WSO) appoints 15 At-Large Committee members and 21 Advisory Committee members.
- We have had members from our area serve on past WSO Advisory committees. The committees include Alateen, Forum, Public Outreach, Literature and others. I brought resume application forms for the committee positions (contact me if you want a resume for Trustee). Descriptions and qualifications are given on the back of the form. I encourage you to discuss these positions at your District meetings and to encourage Al-Anon members to apply. If possible, I will add copies of all the resume forms to our website: scws-al-anon.org. WSO requests that forms be used exactly as is.

Committee applications (Alateen, Forum, etc.) are due April 15 to the WSO.

Trustee and Committee on Real Property resumes are due to by August 15.

(We elect our Regional Trustee once every 3 years and that position will not be open until another year from now, but Trustee At-Large positions open every year).

- WSO Board rotations occurred after the January meeting and our new Chairperson is Judith Philson from Hawaii. Some of you met her when she was our speaker at last year's SOS. She is a wonderful Al-Anon member with a strong service background.
- The Board also announced that the year-end budget had excess income of \$99,600. Literature sales, Forum income and contributions were down slightly. Contributions for 2003 were \$1,003,200. Expenses were also down, in part because of the change in shipping charges and because this was not the year the Service Manual got reprinted. The reserve fund 2003 market value is \$4,915,000.
- The Board voted at their January meeting that the regular update to the **Service Manual (originally scheduled for 2004), not be printed in 2004**. (Perhaps this provides more time for the WSC to decide on significant revisions required to some of the descriptive text regarding Concept 11 that addresses the new Action Committee structure.)
- The maximum annual individual contribution to Al-Anon has been revised from \$10,000 to one percent of the last audited WSO annual budget per year. Likewise the one-time legacy bequests from a member is now up to ten percent of last annual budget. The last budget was about \$4,000,000.

Perhaps the most pressing issues for us today is the motion passed in Dec. by our Trustees at the WSO. I mailed a copy to each of the District Reps at the end of December and also brought copies today. WSO is now requiring every Area to have Alateen Safety requirements in place by the end of 2004. Rather than Guidelines, as we've been discussing, they are now requirements and the Area must certify each individual meeting's compliance every year. We will discuss the motion and our Guidelines more today and at May and November Assemblies. I agree that as adults, we need to be responsible for the children – to me that's why Alateens are always required to have an adult sponsor present at their meetings and at events. The part that I'm having difficulty with is that I see this motion as a change from our spiritual principal of guidelines, to now having requirements that must be certified annually, no longer adherence to the unenforceable. In Al-Anon I learn to trust the process and that there is a spiritual solution. I look forward to hearing more of the thoughts and suggestions of our members here in Southern California.

When we look at the motion timeline set by WSO, we need to make significant progress to meet their deadline of having guidelines and a mechanism for annual certification in place by the end of this year. In addition, the WSO has a requirement that we have our Alateen Safety requirements reviewed by a legal council (= lawyer). To meet the Dec. 2004 schedule, it may be best to have a recommendation to present to the GRs at the May Assembly so that they have time to discuss it with their groups before they vote at the November Assembly. The legal review could be done between now and May or May and Nov, (or never). WSO has made these requests but it's up to our Area to decide how we move forward. The Trustees feel that this is a matter that affects Al-Anon and Alateen as a whole and they have decided to make this a true requirement. WSO says they will not allow an Area to use the Al-Anon name if we don't respond to this motion. This also makes me concerned that the motion is strongly slanted toward decreasing liability, not just Alateen safety. The motion may put more liability on Areas.

My feelings are just that, my feelings. As your Delegate, I am your voice to and from the WSO and I need to know how you feel, not just how I feel. My gut reaction to the motion is that we are reacting to an outside issue: the possibility of lawsuits in the future. I understand that the Trustees must consider such things and that lawsuits would affect Al-Anon as a whole. Just as drunk driving citations affect families as a whole. My Al-Anon program tells me to accept reality, but not to fear the future or try to control the uncontrollable. A local Al-Anon member who grew up in Alateen also reminded me that Al-Anon helps us learn that the more we try to control things the more out of control they become. Motions cannot prevent bad things from happening, but we can take reasonable precautions. I don't want to see us set a precedent to "regulate" meetings. WSO and logic says that safety requirements are necessary because adults are held responsible for minors (Alateens). Hopefully we can find a balance.

There are many ways in which we can take more active roles in Alateen safety. I'd like to be involved in a discussion of those and I think that the motion has pushed us into that much needed discussion. I hope that the motion serves that purpose but that the motion can be revised so that we don't have to give up our wonderful spiritual principles in reaction to outside pressures. I want you to know that the motion is not "up for discussion." The Board of Trustees, prior to the Conference has already passed the motion. At the WSC in April, we may discuss it and could even ask the Trustees to reconsider but my guess is that is not likely to happen. At this time, I think that I have a minority opinion and I'm not shy to let it be heard. And I want to hear your ideas and I need to be willing to accept what is, even if it doesn't change.

■ I encourage each of you to think about the Alateen motion, talk to each other, reason things out, pray and ask our Higher Power for knowledge of His will for us

Today we hope to discuss not just the motion, but also the proposed guidelines. For me, I see that we have two issues: developing Guidelines to propose to the GRs, and deciding if our Guidelines will be requirements in agreement with the Board's Alateen Motion. I'd like to see us include the local Intergroups in our discussions. The Motion will affect them also because it states that any Alateen meeting or event that the Area determines is not in compliance with Area safety requirements will be removed from meeting listings and asked to stop using the Alateen name, to protect Al-Anon as a whole.

The SOS Workshop has always been done as a service to the area, so tell us how we can better serve you!

I am looking forward to attending the Pacific Region AA Service Assembly in two weeks and the South West

Regional Delegates Meeting the following week. It is a busy time but the learning experience is amazing. I get to learn from Alcoholic Anonymous and Al-Anon members who are involved in service from other areas, which I find really opens up my otherwise somewhat closed mind.

February 20, 2004 Past Delegate Report Southern California World Service

As your Immediate Past Delegate I have the privilege of continuing to serve the Area Committee by facilitating the Restructure of the Southern California World Service Assembly. We hope to perfect" our unique plan into Committee-based action rather than Officer-based direction. We will take this up further under Old business. At the January Board meeting I presented a complete summary of the Evaluation Forms from the November Assembly. We review the consensus of the membership in this way. (I can e-mail you a complete copy if you request.)

For today, I've summarized the evaluation forms received from the attendees at the Assembly in the interest of time and the expense of copying. There were Six Questions:

Districts and Intergroups on actions and projects and *Who Do You Know?*, *What Did You Do? Did it work?* so we can report back to the Assembly. There is enthusiasm for the action out there now.

The Conference Theme will be about having Dynamic Groups.... Today. I will be chairing a panel at the southwest Regional Delegates meeting in early March asking the current and past Delegates the question? What is your role in Dynamic Groups Today?"

May I ask your help in letting me know how you see using your past delegates to help a group be dynamic? At the area level? At the District level? Intergroup/AIS level? Home group level?

Old Business:

You will see in the Board Minutes from January 2004 the recommendations from the three ProTem Action Committee Pro-tem Chairs (Rita, Willie and Kay) recommended:

- 1. Action Committee Chairs remain in position for one more year and be considered members of the SCWS Board.
- 2. Action Committees elect a recording secretary at the next assembly Break-Out Sessions in order to provide consistency and unity.
- 3. Action Committee Break Out Sessions not be held at the Committee Meeting in keeping with the Service Manual's description of the Area Committee Meeting as the place where District Representatives, Intergroup Liaisons, and coordinators share their full reports and voice concerns in order to set agenda for Assembly meeting.
- 4. In addition to the Coordinators, Action Committee Chairs should also receive *coordinator mailings* from the WSO.
- 5. The Restructure Committee remain in place and meet as an ad hoc committee at least once a year to report to the Board. (DURING THIS TERM)

Minutes of Southern California World Service Committee Meeting held at Fullerton Senior Center, February 21, 2004. Kary L., Chairperson, called the meeting to order at 10:00am with the Serenity Prayer.

Traditions: Read by Jerry W., Ventura Intergroup Liaison

Chairperson, Kary L. welcomed new group reps, district reps, visitors and past delegates.

Minutes Secretary: In the absence of Shirley M., Helen C. read the minutes of the August 16, 2003 Committee Meeting.

The minutes stand approved as read.

Treasury Report: Tom E. announced the new permanent mail address for SCWS. He recommended our annual contribution to WSO be \$8,700. Discussion was heard regarding possible new expenses for Alateen. Committee recommended the contribution be put on agenda for May 2004 Assembly. The report is printed in the Bulletin

Delegate Report: Miriam M. – report printed in the Bulletin.

Alternate Delegate Report: –Sue P. - report printed in the Bulletin

Past Delegate Report: Kay D. – report printed in the Bulletin

Records Secretary: Margie Llinas reminded the Committee that she needs WSO group number on contributions. If the group has trouble finding them, email her, call her or check new bulletin. Margie told the Committee that by vote of 1992 November Assembly, group reps can have voice at the Committee Meeting, if the DR and Alt. DR are absent. Margie recorded the roll call.

Alateen Sponsor: Kathy Launius reported on the teleconference with other Alateen Sponsors, Coordinators and WSO. Questions:

- 1. Why Urgency? Answer Since the year 2000 Alateen safety has been discussed on the floor of the Conference. Legal Council looked over "requirements" and suggested they be put in place ASAP.
- 2. How will the "requirements" be put in place?
- 3. How will meetings be certified?
- 4. Will each member be certified? (What is the certifying process?)
- 5. Will certifying apply to members who volunteer at meetings and at SCAC?

Old Business:

- 1. Committee voted no Action Committee breakout at the Committee Meetings.
- 2. Committee voted no "Action Item" be proposed for DR's to take back to their meetings.
- 3. Committee recommended Action Committee meetings at the Assembly be limited to 90 minutes and to be held after lunch break
- 4. Committee recommended Action committee facilitators (Chairpersons) be full members of SCWS Board for remainder of trail period through December 2005.
- 5. Committee recommended approval of restructuring recommendations.

Convention Chairperson Reports: Printed in the Bulletin

Coordinator-Cooperating with the Professional Community: Lee Tsao reported the need for evaluation forms to be returned to assist WSO in planning future projects.

Ask It Basket – Q's & A's – Alternate Delegate, Sue P. - Printed in the bulletin New Business:

- 1. Districts to host May 15 Area Assembly 9, 10, 24, 30, 39, 45, 63, 64, 69, and 72 Hospitality Coordinator Martha M. asked each host district to send a volunteer to assist in set up and tear down need to arrive at 8am for set up. Does not need to be the same people for tear down.
- 2. "Love Gifts" for Delegate Miriam to take to 2004 WSC. She will be leaving April 18. They can be sent to the hotel after April 13. See her report for details.
- 3. Auditors' Report Given by Ron Sl. on behalf of Mary M. and himself.
- 4. 2003 Contribution to WSO Treasurer Tom Emanuel recommended \$8,700 which is the excess over ample reserve. Discussion was heard regarding Alateen expenses that may be incurred while complying with WSO requirements. The Committee voted 24 yes, 10 no and 0 abstaining to recommend our contribution for 2003 be \$8,700.
- 5. P.O. Box for Treasurer and Group Records Secretary was announced: P.O. Box 350, No. Hollywood, CA 91603 (one Address for Both).
- 6. Committee recommended approval of the appointment of Barbara W. to complete the remaing term as Chairperson for Membership Communications Action Committee.

As has been reported by our delegate, the Al-Anon World Service office Board of Trustees issued an approved motion last December requiring all areas to have behavioral and safety requirements for Alateens and adults involved in Alateen service. These requirements are to be in effect by 12/ 31/04. They must include certain items that were set forth by the Board of trustees.

Our area voted last fall to implement a set of "guidelines" concerning Alateen behavior and safety. A committee was formed and that committee met a few weeks after this Motion was forwarded to us from World Service. There was much discussion at this meeting regarding the Motion itself and how it aligns with Al-Anon as we know it. We also discussed the items included in the motion and asked our Delegate to try and get some clarification when she attends the World Service Conference.

In the meantime, things are moving forward. I have brought with me a draft of proposed requirements for our area. This is simply a place to start.

The last few months have been busy in other ways. District 66 hosted an Alateen Sponsor Workshop in January. It was the first one we have put on, and it went quite well. District 66 also invited me and Andy (the Alateen Coordinator) to attend their District meeting and discuss the Alateen Motion. This was done in February. We are certainly open to attending other District Meetings whenever requested.

On 2/21/04 I will be participating in an Alateen Coordinator Teleconference hosted by the World Service office. Since that teleconference happens the same day as our Area Committee meeting, I am unable to include information about it in this report, but will be reporting the highlights when I give this report.

There are a number of other events coming up in the next few months. I look forward to visiting with South Bay, Palm Springs and San Luis Obispo...

Important Information Regarding Al-Anon/Alateen

The following information is in response to a letter the Delegates and Alateen Coordinators received from the World Service Office (WSO) in December 2003. The WSO announced that the Board of Trustees passed a motion on Dec. 8 regarding requirements for Area Alateen Guidelines. The motion is attached. It introduces significant changes to our program that we will want to talk about. We will discuss it at the Southern California World Service (SCWS) Committee meeting Feb. 24 and at our May and November Assemblies too.

Please read the attached information from the WSO. You may share it with your groups and please share it with all Alateen Liaisons and Alateen meetings in your District/Intergroup. This motion may prompt many questions and discussion. This can be good. Let's use our Service Manuals, Guidelines and our Higher Power to help us learn and grow through this situation. No doubt, we will not all agree in our initial responses to the motion, or in the next steps we should take. Use our program; talk to each other; reason things out.

The first meeting of our Area Alateen Guidelines Committee was held Jan. 10. If you or other members (who had not already signed up to be part of the Guidelines Committee) want to participate on the committee, please call our Alateen Sponsor Coordinator, Kathi at. Our Area Alateen Guideline Committee was set up as a result of our Aug. and Nov. SCWS meetings so that the committee could make guideline recommendations to our Area. This motion affects our Area and Al-Anon/Alateen as a whole and we will be discussing it together at the upcoming SCWS Committee and Assembly meetings, and hearing suggestions from the Guideline Committee. Dear Conference Members.

For the past several years, the issue of safety for Alateens and Al-Anon members involved in Alateen service has been very much in the forefront of discussions. The Alateen Advisory Committee and Group Services Committee have had lengthy discussions on the subject. At the 2002 WSC, it surfaced as one of the most important issues facing Al-Anon. At the 2003 WSC, the entire session of "Talking to the Delegates" was devoted to Alateen. The Policy Committee has been constantly examining current policies and guidelines as they relate to Alateen, and the Board of Trustees has discussed this issue in depth at its quarterly meetings.

It became apparent that it was time to do more. The time has come for all areas to have safety and behavioral requirements that meet minimum requirements for Alateens and Al-Anon members involved in Alateen service. WSO registration procedures and policies will support the requirements developed by each area.

On December 8, 2003, the Board of Trustees met by conference call and passed the attached motion. The motion explains the Board's thinking; what the Board now expects from the areas; and what the areas can expect from the WSO. While this is quite a step forward for Al-Anon, I am sure you will all agree that it is a necessary one. Our common goal is what is best for our Alateens and Al-Anon members involved in Alateen service. The Board's motion speaks to that goal.

Please feel free to distribute my letter together with the Board's motion and minimum requirements, as you deem necessary.

Also attached is a memo from the Executive Director dealing with the impact of this motion on existing literature. In fellowship,

The Alateen Advisory Committee, the Group Services Committee, the World Service Office Policy Committee, and

the Board of Trustees of Al-Anon Family Group Headquarters, Inc. have studied the issues concerning the safety and behavior of Alateen members and individuals involved with Alateen service. The Board has reviewed the documents and actions of previous Conferences, previous Committees, and the World Service Office correspondence with legal counsel, individual members, Alateen Sponsors, Coordinators, as well as area and district officers.

The Board of Trustees has determined:

Not all areas have written safety or behavioral requirements for Alateens and individuals involved with Alateen service.

The WSO registration procedures and policies should support areas that have developed safety and behavioral requirements.

The Al-Anon fellowship should take all necessary steps to provide a safe environment for Alateens and the Al-Anons involved with Alateen service.

As Tradition Four states, "Each group should be autonomous, except in matters affecting another group or Al-Anon or AA as a whole." The Board of Trustees has determined that issues of safety and behavior by Alateens and individuals involved with Alateen service do affect every group and Al-Anon as a whole.

The Board of Trustees, under Concept Seven and Warranty Four, is entrusted with the authority and responsibility to protect the Al-Anon and Alateen names and the organizational identity.

Now, therefore, the Board of Trustees resolves:

- 1. As soon as possible, but in any event, no later than December 31, 2004, if an area within the World Service Conference Structure uses the Al-Anon or Alateen name in conjunction with any meeting(s), group(s), convention(s), or any other gathering(s) in the area where Alateen participation is offered, the area must have safety and behavioral requirements for all Alateen members and Al-Anon members involved in Alateen service. These safety and behavioral requirements must meet the minimum requirements of Al-Anon Family Group Headquarters, Inc.
- 2. Al-Anon members involved in Alateen service and all Alateen members must adhere to the area's safety and behavioral requirements, or the area will notify the WSO that those members are prohibited from participating in Alateen service.
- 3. As soon as possible, but in any event, no later than December 31, 2004, and for each succeeding year, each area must have a process to certify, and must so certify to the WSO annually, that each Al-Anon member involved with Alateen service has met the area's safety and behavioral requirements and has agreed to abide by them.
- 4. The World Service Office will register only those Alateen groups whose registration it receives through the area's registration process. The WSO will remove from its registration list any Alateen group that the area determines does not comply with area safety and behavioral requirements. The area's request for removal of an Alateen group must be stated in writing to the Associate Director/Alateen. This applies to all Alateen groups, whether currently registered or not.
- 5. If the area states in writing to the Associate Director/Alateen that a group, meeting, convention, or gathering is failing to meet the area's safety and behavioral requirements, prior registration or interaction with the World Service Office shall not constitute any continuing right to use the Al-Anon or Alateen name.

Minimum Safety and Behavioral Requirements

- 1. Every Al-Anon member involved with Alateen service must:
 - a. be an Al-Anon member regularly attending Al-Anon meetings.
 - b. be at least 21 years old.
 - c. have at least two years in Al-Anon in addition to any time spent in Alateen.
 - d. not have been convicted of a felony, and not have been charged with child abuse or any other inappropriate sexual behavior, and not have demonstrated emotional problems which could result in harm to Alateen members
- 2. There must be at least one Alateen sponsor at every Alateen meeting.
- 3. The area requirements must prohibit overt or covert sexual interaction between any adult and Alateen member.
- 4. The area requirements must prohibit conduct contrary to applicable laws.
- 5. The area requirements must contain procedures for parental permission and medical care when applicable.
- 6. The area requirements must be reviewed by local counsel.

Other points for the areas to think about in developing their requirements:

Requiring two Alateen sponsors at every Alateen meeting.

Having background checks.

Considering behavior before, during, and after any Alateen meeting or activity of Alateens and adults involved with Alateen service.

Connecting Alateen conferences to the area structure.

Forming an Alateen meeting that meets at the same time and place as the Al-Anon meeting.

Being gender conscious.

Avoiding one-on-one interactions.

Having an appropriate ratio of adults to Alateens at all times.

Transporting Alateens to and from events.

Educational training and awareness programs.

RE: Moratorium on sale/distribution of specific Alateen books, pamphlets, booklets, and other service material. On December 8, 2003, the Board of Trustees passed a motion requiring areas to create area safety and behavioral requirements that meet minimum requirements set by the Board. A copy of this motion was mailed to all Conference members. I have placed certain materials listed below on a 30-day hold. During the hold, the World Service Office will not sell, ship, or distribute any of the identified materials. Concurrently, the World Service Office will check the identified pieces to be sure that they do not contain information that would contradict the Board's policy. As soon as each piece can be cleared, we will restore it into the order/entry system and the on-line shopping cart, and notify you. By the end of the holding period, those pieces that are identified as requiring revision will be kept on hold and will be revised on a priority schedule.

During this period and in the spirit of cooperation and unity, I am asking all members and distribution arms of the fellowship not to sell, give, or distribute any of the following pieces in English, French, and Spanish:

Ask It Basket

Q:In the Alateen Newsletter, my district is listed as having an Alateen Liaison however, since I have been going to District meetings I have not met that person nor have they been mentioned. How do I find out who that person is, is there a list of who the Alateen liaisons are?

A: We have a list of Alateen Liaisons. The list will be provided to all DR's. Please contact Kathi L. if your liaison is not listed or if the one listed for you is not accurate.

Q:If the Bulletin is going to be sent out as it was presented today, does it break anonymity by saying "Al-Anon" on the front?

—and—

Q:The November Bulletin has "Al-Anon" and "Alateen" mentioned on the cover. Per the manual, bottom of p .72, letters including the return address to an Al-Anon member should never have the name Al-Anon or Alateen on the envelope. What's up? Also-why was the last Bulletin not bulk mailed? Wasn't the last mailing costly?

A: The Bulletin was sent First Class only to the committee members, which ended up being 94 Bulletins for a cost of \$102.02. The rest are going out bulk mail shortly. The mailing was done and Nick, the Bulletin Editor, realized it should have been stapled. He will have envelopes printed with the bulk rate postage for future mailings.

Q:What month is the Bulletin printed?

A:There are a total of four a year. It is printed following the Assembly meetings in May and November and after the Committee meetings in February and August.

Q:An Advisory Board was set up by the prior (members of the?) district for the purpose of making suggestions from district meeting agendas and minor financial decisions and to make suggestions to the GR's at the district meeting. The Advisory Board voted to allocate \$150 for seed money for the 9th Annual Alathon in our district and when it was brought to the GR's at the regular meeting; a motion was made to vote on this issue by the GR's. As the new DR, I tabled the motion until I could research the matter, telling the GR's that his undermined the authority vested in the Advisory Board and concerned that this represented double headed authority. Input?

A: Several Al-Anon principles were mentioned such as "Letting Go", control, rotation of leadership, trusted servants, the purpose of GR's and DR's. Also shared was a section of the Service Manual, p. 25, "Structure of the Al-Anon/Alateen Fellowship.", 2nd paragraph. "The group's operations are the responsibility of a set of officers who are elected by the members. Officers are usually changed so that everyone has an opportunity to serve the group." Also – p.176 "Concept Ten – Service Responsibility is balanced by carefully defined service authority and double-headed management is avoided." (Possibly study Concept Ten at district meeting?) At the end pf paragraph one on p. 177, "In short, such a misuse of ultimate authority would add up to a dictatorship, in which nearly every classification of Al-Anon servants would have large responsibilities but no definite authority and hence no capability of effective decision and leadership." A suggestion was made that the Advisory Committee might consider becoming the Alathon committee to avoid double-headed management.
