

# Officers' KEPOTTS

Once again I have been privileged to visit some of our So. California Area's districts. I want to thank all of you who have requested me to come and share. Again I would like to encourage all Districts in our Area to invite your So.

California World Service Officers and Coordinators to share with your District or at your meeting, sharing the program is the most important service opportunity we have.

The Conference (WSC) theme for this year (2007) is "New Thinking – New Energy – Abundant Outlook." I have submitted two questions (only allowed to submit two) to the Conference for the Agenda; these questions were from those turned in to me at the Assembly in November that fit WSO's requirements... They had to be pertinent to Al-Anon as a whole. Brainstorming the question "What are the most important issues facing Al-Anon in the future?"

The questions I submitted were:

1. "How can we encourage participation of Alateen sponsors (new and current) in light of a litigious society and growing number of sexual abuse cases?" 2. The second one was "Since there is so much misinterpretation on the purchase of property, (who decides to keep or sell), could a pamphlet or other piece be created to explain these decisions and what happens after the trial period?"

As most of you know I am on the Admissions and Handbook Committee. I brought up the discussion at last year's Conference regarding a petition to divide an Area. Currently a state or province can only divide once and must have at least 400 groups to do so. We have over 1000 groups as does Northern California. I have been talking to the Delegate from Northern California as well and if we are to pursue this matter, both Areas will have to submit a petition which outlines where the division would be geographically and how many groups would be involved. We will have to contact the districts in the Central part of the state to see if they feel this would be an appropriate division for them. I will be contacting Sandi the No. CA. Delegate when I attend SWRDM next month to see if we can find a workable solution we can present to our respective Areas.

The WSO has two new job openings available. They are Associate Director Group Services (Alateen and Special Services) and the other is Information Analyst. The Associate Director's deadline for resume is April 30, 2007 and the deadline for Information Analyst resume is March 15,

**2007.** If you are interested in either of these positions I do have job descriptions available or you can contact WSO directly and either speak to or email Barbara Leach, the Personnel Manager.

I would really like to have our Districts send "Love Gifts" to me at the Conference, the Delegates enjoy receiving different Al-Anon tokens of love from other Areas to take back to their own Areas. Our Area always has such unique and interesting items to be shared at the Conference. The address to send them is: Mary Morrison,C/O Ramada Plaza Resort Hotel, 5700 Atlantic Av, Virginia Beach, VA 23451-2236, these should arrive by April 20<sup>th</sup> and not before April 15<sup>th</sup>.

I will be discussing our view (So. California Area) on the **Alateen Traditions** at the Conference, our response seems

to be that they should remain the same as currently written. The discussion will continue and I would be surprised if a decision will be made this year but be assured I will let our opinion be known.

Just this past week we had the opportunity to order the **Public Outreach** magazine "Al-Anon Faces Alcoholism 2007". What a tremendous Public Outreach tool this has been. Hopefully all of you have taken advantage of this and I am hoping that this is the beginning of a new publication each year. Delivery of your new orders should be completed by April 1st.

I am looking forward to using the **KBDM** (Knowledge Based Decision Making) process once again at the Conference as it has had such a great impact not only on the Conference but here in Southern California at our Assembly and Committee meetings.

Just a reminder, make plans to attend the 2008 International in Pittsburg, PA. **There will be service related workshops** at the International since there will be no RSS' in 2008. The next **RSS** is for the **US Southeast Region** and will be held at Charleston, West Virginia on March 16-18 2007, the RSS, **Canada Central Region**, will be August 17-19 in Sault Ste. Marie, Ontario and the third one for the **US Northwest Region** will be held on September 14-16, 2007 in Minot, North Dakota. I do have information sheets from WSO as to cost and it does seem very reasonable.

Another reminder, we will need to nominate a **Regional Trustee from our Area by August 15<sup>th</sup>, 2007 for submission at the 2008 Conference**, since this will be prior to our August Committee Meeting we will have to nominate someone from our Area at the May Assembly, if you have someone in mind be sure to ask them if they are willing before submitting their name for nomination.

One more item, the **e-CAL** is live and operational on the Al-Anon Members' Web site right now. I would like to invite all Al-Anon members to inform and inspire each other by submitting their original e-CAL sharings. You can share so much with others, your personal story, poetry, even multi-media are welcome. The site is located at www.al-anon.alateen.org/members. Be sure to use the name of your group, or any Al-Anon/Alateen group, followed by the letters AFG to gain entry. Seven at-large members and 11 delegates have been selected as members of the e-CAL committee. WSO has a new server with key security precautions to keep e-CAL separate from other WSO networks.

**WSO** literature sales were about 10% more the first three quarters of this year than last. Forum income is down about 3%. Operating income was \$143,300 for the nine months ending September 2006 as compared to income of \$32,300 in the prior year. Overall income and expenses were generally in line with budget projections. This year (2006) we have received \$128,000 in contributions through September. Shipping is higher; telephone expense is down due to a change in service providers. Office services is also less due to lower consultant charges this past year.

The WSO goal for the **Web Site** for this year was to see a 100% increase from our members. Be sure to log in to the members website (see above paragraph), the goal thru

February 3 was just over 50%, log in, and see what WSO has for us!

Thanks again to all of you for allowing me to be of service to you in this worldwide program of recovery, Al-Anon Family Groups.

### Chair

Good Morning and welcome to the first Committee Meeting of the second year of this panel. Are there any new DRs here today?

As most of you are aware, the purpose of this meeting is to keep abreast of things going on within the area, and to set the agenda for the May Assembly. As most of you are also probably aware we had a very active and productive Assembly last November, so many of the issues that have been coming up each Assembly have now been decided and need not be brought up any more.

There is only one item that still remains in old business, and that is the proposed expansion of the May Assembly. This item will automatically carry over to the May Assembly, so unless there is some new information, we probably won't need to discuss it at length today.

Also, if there is some business that has not come before the Assembly before, and any of you DRs believe it should be addressed, you should raise that issue under New Business. The Committee will discuss the matter and if there is consensus, it will be placed on the agenda for the Assembly.

Part of the reason that we are set up to consider these things in this way is to make sure that the GRs have some information about issues to be discussed at the Assembly before they actually arrive at the Assembly. I mention this as a reminder to DRs that our hope is that any item that we decide to place on the agenda for the Assembly is something that we hope you will then discuss at your District Meetings. Tell the GRs what happened here. If there were two strong opinions on an issue, see if you can explain impartially what those two sides were, and what points each side made. That way the GRs will have some information on the issues that they will have to vote on in Assembly.

One of the more common complaints I hear at every Assembly is that the GRs had no prior knowledge of the issues at hand, and felt they were rushed to make a decision. The process I have just described may never eliminate those complaints, but it should reduce them substantially.

You should also be aware that any member of the Assembly with Voice and Vote, that is to say any GR, can have any issue considered under New Business at the Assembly simply by making a motion on that issue. But those issues are not exactly what we are here to consider today. We are here today to consider issues that the DRs believe should be considered. The GRs will have their turn in May.

Lastly I think I should mention that it is perhaps fortuitous that we have so little to discuss for this Committee Meeting and Assembly. As you know our Delegate Mary will be attending the World Service Conference in April and so will be presenting her report at the May Assembly. If we have fewer items to address under New Business that should leave us with ample time to have full discussions of the topics that Mary will bring back from the Conference. The Board will be looking at innovative ways to present that information to the Assembly.

We'll try to mix up the presentation a little, so that the members of the Assembly can participate in the discussions, and be more involved in the Knowledge Based Decision Making that happens at Conference, and that we try to mirror here.

I'm looking forward to the May Assembly. Let's get started. Love In Service, David B, Area Chairman



### Minutes of Area Committee Meeting – 2/17/2007

David, the Chairperson, opened the meeting at approximately 10:15 a.m. (allowance for unusually heavy traffic). New District Representatives and Alternates were introduced: Carmie D40; Mary (ADR) D40; Lea D12; Truck D60; Mary Carmen (ADR) D64; Linda D54. Melissa (D72) read the Traditions.

**Reports:** See the Bulletin for complete committee member reports. The minutes contain only new or unreported information.

**Treasurer:** Y/E (year-end) reconciliation is complete and books are balanced. See treasurer report for full report. Suzanne requested that an agenda item be added to the May Assembly to reconsider the amount of our reserve and to set aside additional money for "educational purposes" due to higher expenses that may be incurred when sending board members to the various service functions available (in place of the nonexistent 2008 SWRSS). The following questions were asked and answered regarding the prudent reserve:

Q1: Linda D54 - What is the prudent reserve used for?

A1: Prefer "Ample" Reserve, which is like a savings account for the Area Assembly

Q2: Holly D21 - What is the prudent reserve amount?

A2: \$25k Reserve but today it's closer to \$23k

Q3: Mary (Delegate) - asked about certificate #3

A3: Loan officer encouraged Suzanne to change the CD from 2% to 4%. New account is an 11 month liquid CD.

New contribution forms are available which includes a spot for the treasurer's email address. Groups need to use their WSO group ID numbers in order to get recognition for contribution.

New mileage reimbursement forms are available. District reimburses up to 50 miles each way. Area will reimburse mileage after the total of 100 miles.

Suzanne suggested a donation of \$2,000 to WSO based on the following: Currently our checking account has \$9,000, would like to hold \$5,000 for additional "educational purposes", keep \$2,000 as operating funds, which leaves an excess of \$2000 for WSO.

Q: Holly D21 - I understand we have not paid for our new Insurance coverage. Does our budget cover it?

A: David has the bill for the insurance. Budget for Liability insurance for the yr is \$3k and is covered by budget.

Other comments:

Kay – trust that the Board is prudent.

Ron (auditor): The current is really holding only 9 months worth of expenses. An increase to one year of expenses would

make the reserve around \$30k. Sending \$2k to WSO is a good idea and will allow us to get to a 1 yr reserve, eventually, since the groups will see that they do need to keep sending  $7^{th}$  Tradition donations.

The auditor, Ron, read the findings from the audit of our books, which will be included in its entirety in the Bulletin. One recommendation (or plea) that he made was that reimbursement checks to members should be cashed as soon as possible (within a few weeks), as this affects P&L statements. Checks that are held for awhile before depositing make the Treasurer's job (and Auditor's) much more time-consuming than necessary.

<u>Delegate's report:</u> see Bulletin for full report. Request made to let Mary know how Districts and Groups feel about the topic of splitting our Area. One reason for considering a split is because of the number of members/groups in our Area - we have more groups in SoCal than in all of Canada. However, Districts may not want to start their own Assembly. <u>Comments:</u>

Miriam – split can happen in a number of ways, i.e., Orange County divider, where there is a huge number of groups with enough people to take on commitments.

Santa Barbara feels more connected to SoCal vs. NoCal.

Julie D3 – it's a long drive to Fullerton. Not sure what it takes to put on Assembly. Would like to see rotating locations for Assemblies.

Myra D9 – we rotate district meetings between Antelope Valley and Santa Clarita – find that attendance is low from those that must do the traveling but like the idea of rotating Assembly locations.

Lea D12 – think we may be underserving our groups due to distance.

Mary (Delegate) – at one time we did try to move Assemblies and Committee meetings around to different locations but found it was very expense.

Amanda (Public Outreach) – No. Calif. has all their districts with the number of meetings listed on their website.

David summarized the discussions by stating that most folks were not interested in splitting the Area but were interested in doing something with the Assembly to draw in more people.

Lea D12 – not sure that it really is about enthusiasm. Starting another Area is scary.

Adrienne D57 – what problems are we trying to solve? We need a specific problem statement.

David – So. Cal. is a huge geographic area to cover. People have to travel great distances, therefore, groups are underserved. Assembly is underserved because we're not hearing from all the Groups in the Districts.

Holly D/21- maybe we should have the Districts state where they are from so that we have an idea of how dispersed we are. We could also "Pen Pal" with those Districts that aren't represented to brief them on the discussions at Assembly.

Mary (Delegate) – outlying Districts can call the Board and request someone to come out and visit.

Cindy – MCAC Chair – If we open this question up to the Assembly we will have a 2 hr discussion with the same things

being brought up over and over. How about putting a survey out on the website? (All agreed that this was a great idea).

David – the idea is to bring the Area together, not to split it up.

Alt Delegate's Report: Sandie put in a plug for the Forum. There was an article recently that discussed introducing ourselves as members of the Al-Anon Family Groups – using whole name not just Al-Anon. Also reiterated that the Board is here to serve you – please call and invite us to your District meetings. "The road to the home of a friend is never long."

Carry the message of service with joy and enthusiasm. Your thinking will change with your good actions.

DR orientation is turning into conversations between DR's about problems and the sharing of ideas. Want it to be a place where DR's can talk about common issues and solutions.

GR orientation/talking session will be held just before the May Assembly.

SOS – thanks to those who attended and those who were of service. Our goal is to make it informative. Start carrying the message of 2008 SOS, which is scheduled for the 3<sup>rd</sup> Saturday in January (1/19/2008). We will have timely topics.

The Forum magazine basket was passed around for the drawing of a subscription to the magazine.

<u>Minutes Secretary:</u> Cathy asked if anyone had any corrections to the minutes for August 19<sup>th</sup>. Minutes approved as written.

**Records Secretary**: Was not aware that I needed to send changes for Area 4 to WSO. I will do so immediately. My sincere apologies to those CMAs who aren't receiving the correspondence from WSO. Roll call was then taken.

Expansion of May Assembly Meetings: Sandie (Alt. Del.) conducted some research on longer Assemblies. The room in Fullerton is available at same cost ~\$55/hr so it is feasible to extend the Assemblies longer into the day. Another idea is to expand only the May Assembly because it is the day that the Delegate gives her report from the World Service Conference.

Myra D9 – keep an open mind for other options. I agree that we should keep the Area together. The cost of rotating the location of the Assembly may be cheaper in outlying areas. I would much prefer a longer Assembly in one day rather than doing an overnight. Could consider modifying start and end time to avoid traffic.

David – there is an ad-hoc committee looking at options to present to the Assembly. Keep in mind that any decision made would not affect us until the May 2008 Assembly.

Linda D54 - does not understand the breakout sessions. Believe that lots of people leave. Confusing...can we explain them a little better?

David – Did not find a drop in attendance in the afternoon at last November's Assembly.

Lea D12 –Break out session I went to was well attended but organization needs improvements.

Sandie – slightly different view of breakout sessions. In morning we get informed on topics we are voting on in afternoon. Gives us time to talk to others during lunch. At the breakout sessions we come up with ideas and solutions for our different

topics/areas. Extending our Assembly just by adding a couple of hours may solve the problem.

Robin – action committees do not solidify things on the agenda.

Holly D21 – break out session is still new. I think it will get better – how exciting. I would like to see more chairs and less repetition.

A report from each coordinator follows or is included in the Action Committee Chair's report.

### Public Outreach Chair

The Public Outreach Action Committee has found a great number of Al-Anon members enthusiastic about sharing what has been given to them. It has been exciting to see people hungry for ideas and, even more exciting, to learn from others

who have had experience in a wide range of Public Outreach service. While there is a seemingly never ending supply of great ideas, there also is a lot of outreach work that has been on-going that we can share with one another.

Let us not overlook the abundant supply of literature already available for our use in Public Outreach – from pamphlets covering everything from "Members Interested in Speaking" #G-1 to the many "Open Letters" to various professionals, our Rolodex telephone referral card #M-46, the Outreach Bookmark #M-76 to name a few. For more helpful literature suggestions, contact any of the Public Outreach Coordinators or Chairman listed in our World Service Bulletin.

Amanda, Public Information Coordinator, has been filling up her calendar of requests for our tri-fold Display to be used in health fairs, general fairs, schools, and a variety of events. If you are currently scheduled to bring the Al-Anon message somewhere, contact Amanda for further information. If you are not currently involved in this area of service but have ideas of places that might benefit from hearing our "voice" – share your thoughts and suggestions with any of us on this Committee. It is easy to think, "that probably has already been done" – or "my idea may seem irrelevant" or any of the thoughts that can so easily discourage us. Try telling that little inner voice "thank you for sharing – and now, please be quiet". Your idea may be one never thought of – and the very one that could change someone's life – forever!

Some ideas currently being explored are flyers in places of worship, public libraries, school libraries, Public Service Announcements (PSAs) at local movie theaters, police stations, local jails, small blurbs in local newspapers listing your local meeting time and place, leave a bookmark or small piece of literature in your doctor's or dentist's office. The list of possibilities is endless.

Shirley, Institutions Coordinator, has a list of local jails and penal institutions where we may find people in great pain searching for what we have. While those currently incarcerated may or may not be enthused about our program, their family members and loved ones who come to visit them may not have heard of Al-Anon. Shelters, either domestic violence, homeless or transitional housing generally have residents who qualify for our program. After checking your local areas to determine that a panel is not currently going there, you may find great satisfaction in sharing the Al-Anon message. It's a good idea to remember that most of these people are in crisis and may not "jump at the chance" to attend one of our meetings. However, they may remember in the future and find the help and hope always available in our rooms. Sometimes the real gift of carrying the message lies in the fact that we may never know if we made a difference or not. With love and gratitude, Robin J

Hi, my name is Arlene R. and I am a grateful member of Al-Anon, and the new Liaison from the Los Angeles Intergroup. I just began in this position as liaison, following my year as the Chairperson for Intergroup. Our service positions on the Board last only a year, and by the time we become competent at them, they seem to end. But I'm really glad that G-d is in charge, because only He knows what is in store for each of us

as we live, One Day at a Time. I must add, that if it weren't for LA Central Office (Intergroup), and one of the wonderful volunteers who answered the phone when I felt desperate, "unwanted, unloved and alone," and, seeking a meeting for some relief from the dreaded disease of alcoholism (while I was living with a sober alcoholic), guided me to my first Al-Anon meeting. I will be forever grateful to that unnamed soul who touched my life in a very special way, and saved me from homicide or suicide.

For those of you who don't know, Los Angeles Intergroup consists of over 400 registered meetings covering all of Los Angeles County. The Intergroup Reps meets the third Friday night of odd months in North Hollywood, while the Service Board meets the fourth Saturday of even months in the morning. All of our meetings are open to any Al-Anon member.

Our new Board was elected in November of 2006 and installed at the first Intergroup meeting in January of 2007. There were over 30 new Intergroup Reps at the January meeting, as well as over 100 continuing IRs. The program of the first IG meeting of the year is to install the new officers, while the first Board meeting is to read the by-laws and approve them. Our first Board meeting will be at the end of February. The Program Chair of IG provides a speaker for the bi-monthly IG meetings. We have lots of business to attend to, reports from all of the Board members, as well as announcements from the floor.

LA Intergroup is also a Literature Distribution center, which provides thousands of dollars of literature for individual members, groups and professionals in the Los Angeles area. They also have their own website, www.alanonla.org, which furnishes a partial directory, as well as giving other important information about the Intergroup and Central Office. Our bulletin, the Al-Anoncer is published monthly and sent out free to all registered Intergroup Representatives. A paid subscription is also available for members. An important feature is the Chairperson's monthly Message, which usually sets the tone for the month.

The Board consists of several standing committees, such as Institutions, Public Information, Alateen, Historian, Nominations, etc., which carry on their business by working on specific projects, such as providing panels for Institutions, setting up tables for Health Fairs, sending our traveling Archive display to Conventions or Alathons, as well as cooperating with SCWS wherever they can. The new Board is very enthusiastic and ready to work hard.

The Directory, of over 400 registered meetings is updated quarterly, in January, May, and September. The dynamic duo, as our office staff is affectionately known, does a phenomenal job in making sure updates are input and changes are reflected in each new directory. The fine work that they perform is often overlooked because they make it appear so effortless. They always have a small army of volunteers who take the hundreds of Twelve Step calls.

I feel very fortunate to belong to an efficiently run Central Office (Intergroup) which takes care of volumes of Twelve Step calls, fills literature orders and does so much more so that the hand of Al-Anon and Alateen is always there. When Central Office is closed, the Vice Chair makes sure that the after hours service is in place. This service gives those Al-Anon members the opportunity to receive Twelve Step phone calls

All members of Ventura County Al-Anon/Alateen Family Groups can be proud of the great service work accomplished in 2006...l'd like to share that with you today. During this past year, two key principles were foremost in our minds - the first being that we are self supporting through our own contributions and second, our primary focus is to help families of alcoholics. One way we did this was by providing vital outreach services throughout our community such as...

- •Al-Anon 's 24/7 answering service we estimate that over 1,000 family members or friends found the help they needed by calling our answering service obtaining meeting information and/or reaching other members who make themselves available to speak with those who seek help awesome and we thank Jemma W for her willingness to coordinate this effort.
- •Al-Anon 's web site www.alanonventura.org handled on average 18 "hits" every day, resulting in over 5,000 "hits" to our web site over the course of the year. A "hit" is someone/ anyone accessing the information posted on the web site to include Meeting List, Intergroup Events, The Forum Magazine, Alateen and Young Members, District 12 Events, local Conventions and Round-Ups, Calendar, Spanish Information, Institutions and Professionals, Intergroup Scoop Newsletter, and lots, lots more our gratitude to Anton C and a big welcome to Jennifer G.
- •Intergroup Scoop Newsletter Our newsletter is filled with members' experience, strength, and hope and gads of local happenings and activities. It is a terrific newsletter and is also available as a personal subscription at our cost of only \$7.00 per year. We published approximately 750 newsletters last year with complementary newsletters for the Al-Anon and Alateen meeting groups (via IGRs), Southern California World Service, other Intergroups and Information Service Centers within Southern California, and the World Service Office Tracy L does an incredible job!
- •Public Information New last year was the placement of paid advertising in the Verizon yellow pages. Later this year, we will discuss the feasibility of increasing the use of Public Service Announcements via TV, radio, and newspapers as suggested in our service manual pages 91 and 92.
- •Also under the purview of Public Information (but printed by the web site coordinator) we updated and printed over 7,000 directories and made them available to local meeting groups at our cost of \$5.00 for a packet of 25 directories I think we all agree, newcomers should not leave a meeting without a directory and phone numbers. Additionally, we printed over 4,250 flats for the special outreach project; altogether we distributed 10,250 directories.
- •Institutions 2006 was a banner year for the distribution and placement of 955 pieces of conference approved literature (CAL) to 25 Ventura County Public Libraries, 70 Middle Schools and High Schools, 25 Private Schools, 5 Colleges, (3

Community, 1 Public, 1 Private), and 2 Military Bases (meeting schedules and counselor and teacher letters from WSO Web Site were included. Additionally, our meeting groups donated hundreds of pamphlets and booklets to local shelters as part of the SCWS outreach project. All meeting groups participated to get the word out to families and friends in need – bravo to Shirley M.

•Additionally, in cooperation with District 12, Ventura County now has a bimonthly panel at Genesis, Thousand Oaks; an on-call panel at Genesis, Ventura; a monthly panel at Khepera House, Ventura; a monthly panel at Prototypes, Oxnard; and we're now approved to serve in women's jail as soon as we've received the special training—fantastic and we are grateful to Shirley M and Judy D!

•Cooperating with the Professional Community (CPC) – Also new this past year was the special project that encourages members to provide a special Forum magazine "Al-Anon Faces Alcoholism" to a professional (doctor, chiropractor, dentists, and we didn't forget the hairdressers). Obtaining their business card and forwarding it to Kay D provides us with an opportunity to follow-up and to receive other conference approved literature – a great way to reach out to people (like you and me) who have been affected by the disease of alcoholism – wonderful and thank Kay D for her leadership.

It was only through the generous contributions of Ventura County Al-Anon members that we were able to do this wonderful service work...and I am truly proud to be a part of Ventura County Al-Anon/Alateen. One member said "I contribute the cost of one Café Au Lait every week for this great service work — I feel so good and I don't miss the extra caffeine either!" Our beautiful declaration says it all...When anyone, anywhere, reaches out for help, let the hand of Al-Anon and Alateen always be there, and — Let It Begin With Me.

# Ask-It Basket Questions

ASK IT BASKET February 2/17/07

Q1: Why can't Assemblies be more active like S.O.S.?

**A1:** Thank you for your question. We are always looking for ways to make our meetings more valuable for everyone who attends. The major difference is that the S.O.S. is an educational (and hopefully fun) workshop and the Assembly is the SCWS's Area business meeting. Definitions of the Area Assembly are located on pages 60 and 107 of the Al-Anon/ Alateen Service Manual.

**Q2:** District 57 is currently split between the Los Angeles and Orange County Intergroups. What are the considerations for drawing district boundaries? Are districts typically wholly contained within an Intergroup?

**A2:** As written on page 108 in the Service Manual: "Districts are convenient segments into which an Area is divided by the Area World Service Committee, with the approval of the Assembly". Its boundaries are established for a variety of reasons (i.e.: number of meetings, geographic proximity, etc.) The SCWS Area is not affiliated with any Intergroup (each is a separate entity) and the reasons for their jurisdictional boundaries are not the Area's concern. However, if a meeting's being "a part of" a District in a neighboring county becomes a matter of conflict, it may change Districts if the group conscience votes to do so.

**Q3:** One of my GRs has a concern of religion [being discussed] at her meeting. Certain members insist on identifying themselves as Christians and saying they've been saved, etc. When the GR has reminded the group that we are not affiliated with any religious denomination, she has received comments from some of those people saying they can't share because

of so-and-so or they're sad that they can't hear so-and-so share because the GR won't let them. Any suggestions on how to handle this?

A3: In the "Three Obstacles to Success in Al-Anon" (under the heading "Discussion of Religion") it clearly states: Let us not defeat our purpose by entering into discussions concerning specific religious tenets. It is very informative to read this page at each meeting and refer to it when the meeting deters from the Al-Anon focus. The meeting should perhaps also have a business meeting where this can be discussed by all members. Another point of reference is located on page 99 in the Service Manual states: Al-Anon is a spiritual program; thus the discussion of specific religious beliefs may divert members from Al-Anon's primary purpose. Our meetings are open to all who are affected by alcoholism, whether the member has a religious belief or not.

**Q4:** Is the Lord's Prayer anywhere in Al-Anon literature?

**A4:** No. However, it has been discussed at the World Service Conference, ad infinitum, and the discussions are printed in many WS Conference Summaries (if interested, check with current and/or past Delegate[s] for obtaining the Summaries for research)

**Q5**: How do you handle a situation when the GR is going against the Traditions?

**A5:** As the DR, first establish if the specific situation does indeed violate a tradition. Refer to page 52 of the Service Manual, "Group Problems and Solutions". Speaking to the GR directly may take care of the situation. If it does not, you may speak to a Board member for further guidance.

**Q6:** In the Conference Summary last year there is a statement that WSO supports each group with over \$200 worth of materials. What are these items? When I go the meeting to ask for financial support for SCWS and WSO, I would like to be able to illustrate this.

**A6:** The actual statement is that the WSO spends approx. \$200 on services for each meeting (not providing each meeting with actual items costing \$200.) WSO provides a binder for each meeting with helpful information, prints the Service Manual, provides a copy of the *Forum* for each group, maintains and updates group records, keeps meetings informed with "Area Highlights" and Regional Service Seminars. Also a toll-free telephone number is maintained and referrals to meetings can be made by WSO Staff. The WSO website was created and is maintained and provides many, many materials which can be downloaded for free.

**Q7:** Why doesn't WSO have a notebook/ packet and free Forum for DRs?

A7: There isn't an official packet for DRs although all of the pertinent information is contained in the *Service Manual* and Guidelines for GRs (G-11) and DRs (G37) and District Meetings (G15) are available free on the WSO website. Free copies of *The Forum* are currently being sent to all registered meetings, not to any individual person. Any District expenses are to be reimbursed from the District's treasury, not by the WSO.

Q8: What does SCWS suggest our District do about a longtime Alateen sponsor who has been told and asked and prodded to go through the certification process but still refuses to do so. Do we ask him to leave? We have been suggesting [this] to him for over a year now. Members are becoming upset that their children do not have a certified Alateen sponsor for their Alateen meeting.

A8: Refer to the Service Manual page 59 "Basic Terms Used in Al-Anon Service: 'An Alateen Group Sponsor is an Al-Anon member who is *currently certified* by their Area as an 'Al-Anon Member Involved in Alateen Service' and who has made a commitment to be of service to an Alateen meeting on a regular basis."

The fact is that the World Service Office of Al-Anon does not recognize an Alateen meeting that has not registered or reregistered under the Alateen Safety Requirements. The ramifications of this are: The meeting may not use the Alateen name and thus, its members may not call themselves "Alateen" by virtue of their attendance at that meeting. By allowing the un-certified sponsor to continue puts our Area in jeopardy of not being in compliance with the Alateen Safety Requirements. which can have further ramifications.

It is possible that the members of the group do not realize that their meeting is out of compliance. The District Representative may visit the group, ask the sponsor to step out, and speak to the members directly, explaining the situation to the members and what it means to them personally and to the Area and Al-Anon as a whole.

The District within which this meeting is located is the first line of communication and that communication needs to be very direct (not suggesting or prodding). Please check with the SCWS Area's Alateen Sponsor Coordinator for further guidance.

Q9: I was somewhat surprised and upset to see flyers at the January, 2007 SOS advertising a retreat. On page 99 of the Service Manual, it explains that Al-Anon is not affiliated nor endorses these retreats. So why are they allowed at SOS? Please explain because it dilutes Al-Anon and some want to use and interpret the Service Manual to their own desires. In addition, the flyer stated to contact a SCWS Board member. This gives the appearance that SCWS is sanctioning this type of function.

A9: The Service Manual addresses "retreats" specifically on page 99. They are not to be announced at meetings because that can be confusing to newcomers. It also states "Area Newsletters or local Al-Anon/Alateen Bulletins should not be used....nor should retreats be promoted before, during, or after Al-Anon/Alateen meetings by the use of leaflets or announcements. SCWS does not support any gathering other than the AFG Convention, Southern California AA Convention with Al-Anon and Alateen participation, and the Southern California Alateen Conference (SCAC).

Q10: Is there a guideline or suggestion for giving up a commitment at the group level? Can this be done over the phone? Asking another member to announce it to the group

A10: There isn't a guideline on this other than to use common courtesy. It is up to the group or individual how to handle resignations.

Q11: What can and cannot be accepted as gifts for fundraisers? And from whom?

A11: Pages 77-78 address fundraising and the "Avoiding Commercialism" paragraph on page 78 makes suggestions on what types of items may be appropriate.

Q12: Many groups in our area are buying every piece of literature and have small groups and are not giving donations. Any suggestions?

Q13: Can someone give a guideline on splitting contributions of money? We used to have a pie [chart].

A12 and 13: Page 79 of the Service Manual suggests that expenses be met for the group's operation (with, at least, a one month's surplus) and remaining funds may be used to support serviceentities. In the recent "7th Tradition" pamphlet it is suggested that the larger part of the "pie" should go to the local service arms, such as the local Service Center (Intergroup office), District and Area. The WSO receives donations from the largest number of groups as opposed to the District, which is supported by the smallest number of groups. It is up to the meeting's group conscience as to what percentages of the remaining funds to donate to these service arms.

Q14: At the Assembly meetings, what is the purpose of the breakout sessions?

A14: The ACTION committee format (break-out sessions at Assembly) were initiated to increase participation and encourage communication in the SCWS Area as we carry the message of hope and help to families and friends of alcoholics. Each committee has developed a mission statement. They are:

**Membership Communication ACTION Committee** Mission Statement: To encourage participation and enthusiasm by carrying the message of Al-Anon/Alateen recovery, unity, and service to the membership in a timely and informative way.

**Public Outreach ACTION Committee Mission Statement**: To increase public awareness of Al-Anon/Alateen and coordinate this effort by carrying the message through public information, cooperation with the professional community, institutions and the media.

**Group Services ACTION Committee Mission Statement:** To facilitate the flow of group services communication and create interaction between the groups, Southern California World Service (SCWS), and the World Service Office (WSO). (Q14 answered by Past Delegate)

Report From the Pacific Region Alcoholics Anonymous Service Assembly (PRAASA) held March 2-4, 2007, Portland, Oregon.

I arrived in Portland after long day of travel, specifically two cancelled flights, long waits and lots of Friday night traffic getting from the airport to the hotel. It was around 40 degrees and raining when I got to the headquarters hotel for the AA activities. This is where registration was taking place and I had to go there first in order to pick up my badge and paperwork. The Al-Anon HQ hotel was across the street and was the venue for all of the Al-Anon meetings and fortunately that was where I was staying. The Al-Anon activity for Friday night was a roundtable for GRs. Unfortunately, I was unable to attend that meeting due to the extension of my schedule.

Most of the Al-Anon attendees were from Oregon but there was representation from Utah, Idaho, Washington, Alaska, Northern California and a few from Southern California. Bob L. was in the area on a speaking engagement and came, the Vice Chair from Los Angeles Intergroup Board attended as well as a few individuals. And me. (Actually Miriam M. was going to come as well, but became ill and wasn't able to go.)

Saturday morning, however, we were off. The first panel's topic was "Acting Your Way to New Thinking." Panel members shared about Service Sponsorship, Public Outreach and Living in the Solution Through Service.

The next was a participation meeting entitled "Just Get in the Car." Attendees shared about ways they were introduced to service. Much discussion came from deaf and hearingimpaired AA members who were interested in learning more about Al-Anon but were hampered due to the lack of ASL translation. These members were allowed to share. Also discussed was the difficulty in starting Alateen meetings due to lack of participation by the kids. Is the problem lack of trust?

Zelda R., Board of Trustees member and Treasurer from Nebraska was scheduled to be the luncheon speaker but was not able to be there due to weather. Cathy, former Northern California Delegate who now resides in Oregon, substituted for her and told her story of service.

The afternoon Panel #2 was called "Charging Your Batteries." Ways to do that include Conference Approved Literature, Finding Solutions Through the Traditions and Let it Begin With Me. Attendees were then invited to share their service experience.

The AA Banquet was Saturday evening back at the AA HQ

Sunday morning, the program concluded with a participation meeting and Ask It Basket session followed by a speaker. Many of the AIB questions were very basic and have been asked at our Area meetings a number of times. I jotted down the questions asked, which were answered by past delegates: Explain Intergroups. Is a dual member an Al-Anon who also belongs to AA or OA, NA, etc. also? What is the purpose of PRAASA? Why do we affiliate and cooperate with AA? (Interesting, the past delegate answering this question did not

clarify that Al-Anon does not <u>affiliate</u> with AA.) What is the age requirement of Alateen? Can you close a meeting with the Lord's Prayer? Who can be a GR? Can the Area Information Service office close a meeting? What is an Area?

Sunday March 4<sup>th</sup> (Lois W.'s birthday) featured cake and the reminder to "forget" a piece of Al-Anon literature somewhere in hopes that someone who needs or wants the program will find it.

The 2008 PRAASA will be held in Anchorage, Alaska.

I found the weekend most interesting and want to share a few observations with you. I was particularly struck with the separation of AA and Al-Anon here. Although the committees must have communicated in the planning, it was as if these were two separate conferences, not a sharing of ideas, not cooperation. Al-Anon members were allowed to sit in on certain of the AA Roundtable meetings (only those marked with an asterisk in the program) and were not allowed to share. We could observe them but not participate in any way. Hospitality and literature were separate. There was very little Al-Anon presence in the HQ hotel at all although the Al-Anon Luncheon was held there. Unless I missed it, there were no "delegations" from any Area, however, there was substantial attendance by the Oregon members and those from nearby Washington communities who were a wonderful support for the event. Meetings, although interesting and informative, were more generic rather than having sessions geared toward specific service positions.

Although I strongly believe there is value in having our Area represented, and I think we should always be, I do not think it would have been of value to send all of our officers and 1/3 of the SCWS Board here. Thank you to the voting members of SCWS Area for allowing for change in its policy of wide-scale attendance at PRAASA.

# Sharing of Service Reports

### Exploring the Service Manual 9:15 workshop Cindy R.

First I want to thank Elizabeth K for asking me to be of service in this area. And a big thank you to my friend Marcia W. for acting as secretary and her minutes of the workshop below. Time went too fast as we did not get to go through all the proposed questions but the enthusiasm from all that attended was great. You are the ones that made this happen.

**Q1**. A member insists on giving gifts to the speakers attending her group's anniversary celebration. The gifts will be purchased with the group's funds. Is the OK?

**A1**. pg 79: Payment for Speaking – In keeping with the Eighth Tradition, Al-Anon speakers are reimbursed for expenses only. When a member is speaking to an outside organization, the speaker may suggest funds in excess of expenses be used by the organization for the purchase of Conference Approved Literature (CAL) for distribution by the organization as an educational service.

**Q2**. When it comes to 12th Step work – how do we help insure that we are ATTRACTING and NOT PROMOTING?

A2. pg 90: definitions of these terms:

to attract: to draw by other than physical influence; to invite; to draw to; to cause to approach

to promote: to push forward; to further advance, as in a business venture (implies "hard sell," advancement for profit)

**Q3**. Are there any rules or guidelines governing the hiring of baby sitters at meetings?

**A3**. pg 79 Baby-Sitters – Some meetings are attended by members who must bring children. Using group funds or taking a special collection to pay for a baby-sitter at the meetings is within a group's autonomy. Paying for this type of service does not violate Traditions, since avoiding disruption of a meeting benefits the group as a whole.

**Q4**. Is it acceptable to promote and utilize the 3rd and 7th Step prayers? Are these Al-Anon approved?

**A4.** pg 84: Use of Material – To keep Al-Anon's message in focus, it is suggested that only Al-Anon/Alateen Conference Approved Literature and Al-Anon/Alateen service tools be displayed, distributed, and used at Al-Anon and Alateen meetings, conferences and conventions. These items reflect an informed group conscience. Conference Approved Literature provides a unified view of Al-Anon/Alateen to professionals, other individuals, and outside agencies.

### Exploring the Service Manual 10:20 workshop Tarisa R.

The 10:20 Workshop on the Service Manual at SOS 2007 worked on 20 questions but we only had time to complete the following with responses. Some of these responses are quite similar to those entered into the Bulletins while others are completely different. Page numbers refer to the Service Manual.

**Q1.** What are acceptable fundraising items and what items break Al-Anon Policies?

### \* SOS 2007 Response: Pgs 78-79

Group funds are used for group purposes not for personal gifts. Contributions to any outside agency, activity, or program are to be made from group funds which are to be used for Al-Anon/Alateen purposes only. Al-Anon Speakers are reimbursed for expenses only.

Acceptable items include Collections at District meetings, potluck, raffling (use Spiritual and Program items for raffle baskets). Items not acceptable: jewelry and trinkets not program related may divert us from our primary purpose. Outside Contributions: WSO does not provide lists of supplies for articles associated with fellowship (i.e., plaques, jewelry). WSO also does not stock or offer program related items.

\*\* Nov 2005 and Nov 2006 Bulletin Responses: Pgs 75, 77
Fund raising activities such as potluck suppers, dances, or other social events are considered only within the fellowship and in agreement with the groups directly involved. Commercialism should be avoided thus donations should not be such that permit publicity to any company or individual. Suggested donations are: Al-Anon/Alateen literature, forum subscriptions, and hand-crafted items not displaying any logos. Services at a commercial establishment promote commercialism (e.g. a massage, yoga lessons, dance lessons, etc.).

Q2. Dual Members (members of both Al-Anon and AA) are not allowed to fulfill all service positions. What positions are they allowed to fill and why are they not allowed to serve in the other positions?

### \* SOS 2007 Response: Pg 69

They may not fulfill service positions beyond the group level because of the unique nature of each program. Positions beyond the group level could lead to positions at WS Conference. The need to focus on Al-Anon/Alateen could lead to conflict.

### \*\* Nov 2006 and May 2006 Bulletin Responses: Pg 70

Because of the unique nature of both programs, dual members do not hold office beyond the group level since these positions lead to membership in the World Service Conference. The need to focus on the Al-Anon program, and the possibility of a conflict of interest at Assembly and World Service levels, led the WSC to its decision not to seat dual members. This policy was developed in 1967 at a meeting between Al-Anon and AA regarding Guidelines for Separation of AA and Al-Anon and was originally suggested by bill W. Any member who is not also a member of AA is eligible to hold service positions at any level.

Q3. What should I do when a "trusted servant" insists on sharing their opinions in meetings rather than just reporting the facts about group conscience issues?

### \* SOS 2007 Response: Pgs 173, 132, 11, Concept Four

Pg 173 - Concept 9: Bill W's Leadership Quote

Pg 132 - last line

Pg 11 - Tradition 2

Concept Four - What do I do?

### \*\* May 2005 Bulletin Response: Pg 163

Concept Five mentions "minority opinions". You can also speak to the trusted servant about your personal discomfort.

**Q4.** Are there any rules or guidelines governing the hiring of babysitters at meetings?

### \* SOS 2007 Response: Pg 79

**Babysitters** 

### \*\* Nov 2006 Bulletin Response: Pg 79

Some meetings are attended by members who must bring children. Using group funds or taking a special collection to pay for a babysitter at the meetings is within the group's autonomy. Paying for this service does not violate the Traditions since avoiding the disruption of the meeting benefits the group as a whole.

Q5. How do we encourage people to take group service commitments and make our recovery attractive to newcomers?

### \* SOS 2007 Response: Pg 50, Concept Four

Helpful ideas for group growth participation of members in group activities is important. Bring refreshments. "Participation is the key to Harmony." If I am enthusiastic about being a part of, it will carry over to the newcomers.

### \*\* Nov 2006 Bulletin Response: No page listed

Share the personal joy in recovery that service brings. Bring new people along with you. Be an example of service as a way of giving back to the program. Be enthusiastic. Be positive. **Q6.** When working the 12<sup>th</sup> Step, what can we do to help insure that we are not breaking the 11th Tradition and are "attracting" rather than "promoting"?

### \* SOS 2007 Response: Pgs 69, 90

The 12th Step suggests that part of our recovery is sharing our experiences, strengths, and hopes. The 11th Tradition reminds us that our actions above all are what speaks the loudest. Keeping our opinions (like Religions) separate from our program in the 12th Step when sharing is avoiding an obstacle to our success as well as those we share with. Refer to: Step 12, Tradition 11, Obstacles to Success in Al-Anon, Paths to Recovery, and Al-Anon 12 & 12.

### \*\* Nov 2006 Bulletin Response: Pg 90

Definitions are provided for "attract" and "promote". Attract - to draw by other than physical influence, to invite, to draw to cause approach. Promote - to push forward, to further advance, as in a business venture (implies "hard sell" or "advancement for profit").

Q7. Is the "Lord's Prayer" an acceptable closing prayer at an Al-Anon meeting?

### \* SOS 2007 Response: Pg 74

Yes. The closing in the Service Manual says, "Will all who care to join me in closing with (blank) prayer? Close the meeting in a manner agreeable to the Group Conscience.

### \*\* Feb 2006 Bulletin response: Pg 47

It is suggested that the groups close in a manner that is agreeable to the group conscience. Some groups close with the Serenity Prayer, the Lord's Prayer, or the Al-Anon Declaration.

**Q8.** Is it acceptable to promote and utilize the 3<sup>rd</sup> and 7<sup>th</sup> Step prayers in an Al-Anon meeting? Is it acceptable to use the AA Big Book as a reference in our meetings?

### \* SOS 2007 Response: Pgs 85-86, 90

Pgs 85-86: "All AA Literature....."

Pg 90: promote - "to push forward."

It is important to let Al-Anon members know that we are referring to AA literature and prayers when we reference the 3rd & 7th Step prayers.

\*\* Nov 2006 and May 2006 Bulletin Responses: Pgs 84-86

### No. These prayers are not Al-Anon approved because they come from AA literature. To keep Al-Anon's message in focus, it is suggested that only Al-Anon CAL and service tools be displayed, distributed, and used at Al-Anon meetings. It is

well to remember that all AA literature is written for and from the viewpoint of alcoholics and is not Al-Anon CAL. Reliance on opinions expressed in AA and other publications can distort the Al-Anon approach, particularly for the newcomer. It is breaking Traditions to promote the sale of outside literature, therefore, by promoting the AA Big Book we are not selfsupporting.

**Q9.** My meeting has been passing around an AA can for contributions to support an AA fundraiser. Does this break Traditions and, if so, what is my responsibility as a GR?

### \* SOS 2007 Response: Pgs 46, 51, 78, 100

Yes. It violates Tradition 7. See the last and second to the last paragraph on page 46 and Professional Therapies page 100. Page 78 "Refrain from....."

\*\* Nov 2006 Bulletin Response: Pg 100

**Southern California World Service** 

It is not appropriate to participate in AA fundraising during a meeting as it implies affiliation. This can be confusing for the newcomer and can distract members from our Al-Anon focus. Outside the meeting, individuals may contribute if they wish. Publicizing other organizations' activities creates an appearance of affiliation. As Al-Anon members, we cooperate with AA but do not affiliate with them. As a GR, it is your responsibility to inform your group of this information by citing references from the Service Manual.

**Q10.** Can a GR be absent for 6 months and then come back and still consider themselves the GR?

### \* SOS 2007 Response: Pgs 124, 132, 171

Pg 124: If the GR resigns or proves to be inactive, the alternate completes the term and may then be elected for a three year term of his/her own.

Pg 132: ...from the home group....

Pg 171 - Concept Nine: The principle of turning over a position when unable to complete their term.

### \*\* May 2006 Bulletin Response: Pgs 124, 171

Part of the GR's responsibility is to represent their group at the District Meeting as well as the Area level. IF the GR is not attending these meetings and/or bringing information back to the group, then the GR is not keeping up with the most basic of the responsibilities to the group. If the GR resigns or proves to be inactive, the Alternate GR completes the term, however, such a decision is up to the autonomy of the group.

**Q11.** How much program time is required as an Al-Anon member in order to be eligible to fulfill the service positions of a GR and Alternate GR?

### \* SOS 2007 Response: Pgs 132-133, 172

Pgs 132 and bottom of pg 133 - Read from the Service Manual Pg 172 - Concept Nine

### \*\* May 2006 Bulletin Response: Pgs 132-135

There is no designated amount of time. It is suggested that the GR has an understanding of the 12 Steps and Traditions. The GR is a vital link in the continuing function, growth, and unity of Al-Anon. The Alternate GR is elected to cover for the GR if they cannot attend a particular function, therefore, they have the same requirements as the GR.

**Q12.** A professional therapist has been attending our Al-Anon meeting and then AFTERWARD is soliciting to newcomers. Is this acceptable since it is not occurring during the meeting?

\* SOS 2007 Response: Pgs 100, 78

No. Read from the Service Manual

### \*\* Feb 2006 Bulletin Response: Pgs 98, 100

Tradition 6 states that there be no promotion or endorsement of any outside therapies. Tradition 8 states that Al-Anon 12<sup>th</sup> Step work should remain forever nonprofessional. Individuals who are professionals should not use their titles in conjunction with the Al-Anon name. A group conscience or steering committee should decide the best way to handle this. It can be read in the Secretary's report or even be included in the Group's Guidelines that this behavior is not allowed or acceptable.

**Q13.** How do I know when I have crossed the boundary between "sponsorship" and "dictatorship"?

Page 59 - Personal Sponsorship addresses both personal and services.

Page 49 has two paragraphs on Sponsorship.

A sponsor shares their experience, strength, and hope of the Al-Anon program. Al-Anon members learn that they are powerless over alcohol (people, places, things, etc), not to practice being powerful over others. Our fellowship can be affected if dominance becomes pervasive.

Be available, shape my world.

Service sponsor kept me coming back.

Ready to walk away when commitment is up, always someone else's turn.

Don't have to rush to make a decision, give time to express ideas.

Giving others a chance (home, meeting, etc.).

Letting God take charge.

Refer to the Concept pamphlet.

Lead by my practice (making it applicable to everyday life).

What can I learn from this?

Ways to be of service without a specific title or position: sharing, greeting, cake, etc.

Doesn't have to be done perfectly.

Share experience, strength and hope.

Sense of responsibility, knowledge.

Trust in a Higher Power.

Be enthusiastic – spiritual rather than task.

Every voice counts.

Someone suggested leaving a small piece of literature (pamphlet) in a grocery cart for the next person to discover. he list is seemingly endless.

### Alateen Sponsorship workshop, 9:15 Lisa B. and Bart S.

W. Covina Alateen meeting has 4 sponsors, 2 at any one time. There is a rotation. Always need 2 sponsors in a meeting. How young? As young as 4 years old, as long as the child is not disruptive.

Suggestion to assign child to feel comfortable: in W. Covina they have a tool called "Happy & Crappy." They go around the room and say what they are happy about.

One guideline for their meetings: It's important to respect each other. No one can criticize each other. For example, a child talks about his purple elephant.

Suggested meeting format: Start meeting with opening prayer to bring in the Higher Power. Read a daily reading out of one of the Alateen daily readers.

A great ice breaker is charades – they are all able to participate.

If there aren't enough sponsors, then one sponsor might be a parent – but kids generally won't talk if a parent is a sponsor. Kids need a safe place where they can share.

Kids need to set up and run their own meeting.

Alateens at West Covina meeting have God cans instead of God boxes. The message is "God can." They end up giving someone their can.

What about when parents drop off kids early and don't pick up their child on time after the meeting? The Sponsor is not there to be babysitting. Parents are responsible before and after the meeting. When a child is not picked up, both Sponsors have to drive him/her home. It's suggested that Sponsors arrive 15 minutes early to meet the parents. Parents should not just drop their child off. Sponsors should set boundaries.

To attract Sponsors, have Alateens share at Al-Anon meeting. Preteen shares are very emotional. You can ask for an Alateen panel to speak at Al-Anon meetings. Call Daniel K., the SCWS Alateen Coordinator (listed in the SCWS Bulletin), or call your Central Office. Also, an Alateen meeting could have an open house.

District 33 invites Alateens and their sponsors to District meetings. District 33 invited a young brother and sister to their District meeting. The brother read the Steps and the sister read from the ADAT (Alateen A Day At a Time).

Alateens need guidance and need to be stimulated. Charades with slogans is great.

Kids have a lot of issues with males, which is why male Sponsors are so important for their growth.

Are you thinking of becoming a Sponsor? Don't short-change yourself if you don't have children. That's not a requirement for Sponsorship.

Subscribe to "Alateen Talks", a quarterly newsletter. The Alateen writings are powerful. You could read from it an Al-Anon meetings to attract new Sponsors. Where do you learn about sponsoring an Alateen meeting? Attend the SCWS

Alateen Sponsor Workshop, Saturday April 14 here at the Senior Center, 10am-2pm.

### Alateen Sponsorship workshop, 10:20 Yolanda W., Rosa A., and JR D.

Yolanda described how she became an Alateen Sponsor and talked about the difference between Alateen and "Alatots" (not an official term). There is value in having separate meetings, and also in combining meetings when attendance is low. There is great value to the individual sponsor. Challenges to being a sponsor: persistence, distance, appreciated?, drivers, attendance varies, keeping the doors open.

Rosa: We Need Sponsors!!! Rosa is the sponsor for a bilingual group. 2 meetings closed last year. Let us all be responsible for passing the message that We Need Sponsors. One person cannot bring the message to everyone. In talking about "where I was", Rosa said she didn't speak English AT ALL!! But she heard "Service!!!" Peace was given to her. She started Al-Anon with anger, which led her to peace, which brought her to Service, and that is where she is now.

Years ago, her (Rosa's) kids didn't want to go. She made the point that fear prevents action. The children made suggestions to get sponsors. The group took a group conscience and found a sponsor.

The Alateen Sponsor needs support, but the Sponsor also needs to be healthy mentally and physically.

Kids need encouragement. They learn so fast and they need creative things to do. In her Alateen group, they created memorabilia, created bookmarks, created and laminated the Serenity Prayer in Spanish. The Alateens are hungry for love and need a Sponsor in order to have a meeting. They cannot have a meeting without an Alateen Sponsor.

Rosa shared that in Mexico, people people study for one week to prepare. Maybe we need that kind of sponsorship workshop here too, with one week of study.

JR grew up in Alateen program. At age 14, he "was hogtied" and came to Alateen kicking and screaming. Later "my mom came kicking and screaming to Al-Anon and I encouraged her!!" The hardest part for him was transitioning from Alateen to Al-Anon. JR's mom was an Alateen sponsor for that meeting. His mom went to a school and they were looking for a Sponsor. JR helped at that time, and now it's 14 years later and he still is here. He met so many people in Alateen and associated with so many people in Alateen that he would not normally have associated with. JR says he still has his own insecurities.

This year JR is the SCAC Coordinator (Southern California Alateen Conference). Last year he slept in his car – never again!!

What do the Alateens need? Be there!! Care!!

For the first 5-6 years, JR says he couldn't get recognition, but when he let go, then he realized how valuable his Alateen work is/was. He is a Co-Sponsor for SCAC. There are misconceptions about Alateens – that they all smoke, etc. We get to see the Alateens as they really are when we are of Service to the Alateens.

It's so important to <u>keep Alateen alive</u>. Being able to attend their meeting every week is the best situation, but if that is not possible and the two sponsors alternate every two weeks, at least that will keep their meetings going. I am a big part of my

kids' lives (the Alateens). It is important to them that I am there consistently.

Unity week...

We celebrate birthdays every year for each group. There is sharing, birthday cake, etc. They create memorabilia, the Sponsors serve food (pizza and salad) to the Alateens. The Alateens love being served by the Sponsors.

Some tools to get the Alateens to share what's going on with them: Happies & Crappies, 2 for one, etc.

JR has had one suicide in his group. ... are we going to focus on one person lost, or on how many we can affect positively? When in doubt, remember that God must be everywhere and we can only do what we can do.

### Alateen Sponsorship workshop11:25 Sarah C. and Willie W

Opened with the Serenity Prayer.

Willie - how he became an Alateen Sponsor. It happened at a meeting in the San Fernando Valley. A couple he sponsored asked him at that meeting if he could be an Alateen Sponsor, so he asked his own sponsor about the idea and his sponsor said he should do it. The people he has asked for guidance have not been wrong. Originally he came into Al-Anon to help with his then-wife's drinking. Kay and Mark sponsored him and took him to SCAC fundraisers. His indoctrination was helping at SCAC conference. While in the rooms of Al-Anon and Alateen, he remarried and his new wife had children in Alateen.

Life today is a direct response to being an Alateen Sponsor and that his sponsor told him it's something he could do. The shame of giving a child up in adoption was healed by being an Alateen Sponsor. We ourselves are helped when we receive unconditional love from the children because we are being of service to the children. We become close to the parents as well.

At one time there was talk about rotation of leadership – to limit the amount of time someone could be an Alateen Sponsor, but the consistency and unconditional love form a consistent bond of trust.

Willie's family background ... the men in his family lived only till their early 50's. At a recent reunion, he is now the eldest. Life has evolved – life, wife, family, mother-in-law, Alateens that still call him Sponsor. Graduations, elation, life is full. He has seen young kids grow into older young adults. He has been a part of helping and has played different roles with young men becoming parents. He has found worth and value in being in the Alateen Program. He is grateful!!! He has been in a Jewish wedding - one Alateen Sponsee now is a pharmacist and his wife is a stay-at-home mom. "Alateen has done more for me than I have done for it."

Sarah listed to a young man (16 years old) speak at an Al-Anon meeting. He inspired her – he knew where he was going and she knew she wanted her children to be in Alateen. Suggest to your meeting's program chair to have an Alateen speak at your meeting.

It was Sarah's idea that he children go to Alateen, not their idea. "You guys are going." He little one was hanging onto a tree trunk when 8 or 9 or 10. Sarah took them because she knew what she saw from that 16-year-old.

Alateen is like taking a vaccine – they cried and didn't like it, but it is necessary for health. All 4 of Sarah's children went for varying lengths of time. Her daughter said that she learned in Alateen why Dad drank and why Mom stayed with him. All her kids went, and they now are in their 40s. They have a unified family. None of her kids are users or abusers but are married to untreated... They all are raising their children much better and with stability.

Ruthie told her "you will be such a good Sponsor." Meetings are like a clown wagon - you never know how many kids are coming out. Sarah participated with Alateens at conventions, Al-Anon meetings and Alateen meetings.

The main things her children learned are that we are not alone, alcoholism is a disease, not to be hateful, understand that it's a disease and what are the symptoms of the disease. After her kids "graudated" from the Alateen group, a lady asked her to Sponsor because she knew all about it. Sarah did not want to be a sponsor because a previous experience had nt worked out.

Being an Alateen Sponsor is doing Service work for Service work's sake. It is a commitment to the Alateens, and it is not a place to find your own inner child.

Al-Anon needs to support Alateen. Sarah did it because no one else was showing up. Lots of her sponsees stay in touch. One who hasn't had the best of boyfriends still calls her. Another sponsee is in college and Sarah can give her encouragement even it the parents cannot.

Don't judge a book by its cover! Kids that had no discipline have grown up to be a doctor with a wife and children.

You make great friends in Alateen, among the other Sponsors and among the Alateens.

When you go to the Alateen camp, you don't sleep, you get dirty, you get crabby, and the kids still give you unconditional love. You know they love you for the inside, not for the outside. Sarah can see beyond the outside.

Gifts Sarah has learned: real meaning of the Traditions, Unity of the group, interfacing with others, seeing past the obvious. Sarah learned from a small child Ruthie, who would go up to unapproachable people and give them love.

In Alateen sponsorship, you never know after driving to the meeting how many kids will be there. Once there were 2 girls at a meeting who shared so much of what they had gone through. They felt comfortable sharing, and they were survivors.

It is a difficult time to be a teenager today. They live in a rough world. They need a pat on the back and for us to acknowledge and appreciate them. They need attention and encouragement - that they don't get at home. The kids grow up to be better parents, go to college, thrive.

To be a Sponsor: be familiar with the 12 Steps and 12 Traditions, bring the key to the meeting (open the door), know how to appeal to kids on a reasonable level and not get hysterical. Sarah learned how to stand up for herself by standing up for the Alateens.

Meetings close when no one will sponsor. Need to have 2 Sponsors per meeting.

Sarah feels that she cannot begin to tell you how rewarding it is. The Alateens just need someone to encourage them and acknowledge them. You don't have to accept unacceptable

behavior, just like any Al-Anon meeting. There is literature about sponsorship.

Meetings close because of lack of sponsors, not lack of kids wanting it. A lot of Al-Anons don't support Alateen because of denial about how their own children were raised.

Q&A:

What if we have Sponsors but don't have Teens? Sarah: try taking The Forum and other Alateen literature to the schools. Willie: I sponsored because of my sponsor, and the sponsor encouraging parents to have the kids attend a certain amount of meetings. Sarah: Alateen Sponsors should encourage their Sponsees to be of Service – hearing an Alateen speak at Al-Anon meetings will encourage sponsorship.

Some schools have successful Alateen meetings. Are any school districts able to allow meetings? Willie: School districts are mandatory reporters, so there is a question of being able to maintain Anonymity.

### When it goes Awry: Al-Anon Sponsorship, Meeting formats, etc. 9:15 workshop

Sharing of Service (SOS) Workshop: When it goes Awry: Al-Anon Sponsorship, Meeting formats, etc. (9:15 AM session)

The topic was introduced by session leader, Miriam M. She said that our area, Southern California World Service (SCWS), submitted a question for discussion at the World Service Conference (WSC). The question was, "In what ways can we support and/or protect those members affected by the increasing number of high-pressure groups (Dictatorship rather than Sponsorship)?" Because this issue is also affecting other areas in the US and Canada, the Conference (WSC) members voted to discuss this at WSC as a "Chosen Agenda Item."

Copies of the resulting discussion at WSC were distributed from the 2005 and 2006 World Service Conference Summary (2005 page 41 and 2006 pages 37-39). In addition, a copy of the Jan 2006 Forum sharing on sponsorship that felt like dictatorship was also made available (pages 26-29). The sharing exposed cult-like control. Al-Anon reminds us that we are powerless over others and we need to behave in that way in our sponsorship too. Step 12 tells us to carry the message, and there is a difference between carrying the message and giving advice. In "Paths to Recovery" pg 120 it says, "12th Step work may have tempted us to give advice or over-manage another person's situation."

Discussion included:

We are responsible for our own recovery and need to take care of ourselves.

Encourage those (all) meetings to get GR.

Lead a meeting on the 3-As. Awareness, talk about the problem of domination, Acceptance and embrace the fellowship as a whole.

Today may be our awareness. Good not to deny a problem we've had for years.

Questioned if members in cult meetings are allowed to go to service functions (like SOS) – response that local members

have been very active in SCWS service (reminder not to use names and to keep discussion today to principles above personalities).

Controlling groups pressure members to stay within their group and not mingle.

Someone present at today's workshop said she has sponsored members who have left those groups and encourages us to share experience, strength and hope with those members without judgment.

Someone today suggested that the only way to get rid of a cult is to join it.

Someone at today's workshop said that she knows members in high-pressure groups that have grown, each group is autonomous.

During meetings, formats should be read from the Service Manual.

Read lots of literature.

Remind newcomers that there are no musts in Al-Anon.

Take what you like and leave the rest.

Concept 4 our deep desire to belong motivates members in high-pressure groups.

Good to talk about the existence of high-pressure groups to build awareness, not denial.

Dictatorship rather than sponsorship affects Al-Anon as a whole.

Sponsors use tools of the program and not their own opinion. Add to Sponsorship pamphlet that we keep name (identity) of our sponsor anonymous (confidential).

Use of AA prayer in Al-Anon meetings. Not conference approved but group autonomy.

Sponsorship pamphlet (bookmark) being worked on by World Service Office (WSO).

# When it goes Awry: Al-Anon Sponsorship, Meeting formats, etc. 10:20 workshop Robin B.

This is a topic that stirs passion for many of us. What comes with knowledge is responsibility. We are here today to talk about the "elephants in or living rooms."

This will be a discussion of the mechanics of high pressure groups, not about the individuals. Al-Anon can be diluted without practicing the principles. There are no must's or should's or have to's in Al-Anon, yet these groups teach that there are.

Here are some sharings from members who got away from a high pressure group:

First Sharer. Courage is needed to talk about this topic. I wanted strong service ties, which this group encouraged. But this group begins with a seduction ... a loving invitation, friends seemingly in abundance. One of the problems that developed is that the amount of money given by a person for 7th Tradition donations (supposed to be private) were posed on a master board. Another problem is that when people stood in line to get their food, they had to stand in line in the order of length of time in the program. Despite all the reasons that finally drove me to leaving that group, there was some good in my having been there – I learned how to get a commitment and how to keep it.

Second sharer. Principles above personalities. Thanks to all those where are here to share the Al-Anon Principle in such abundance. Things didn't seem right in the group so I

called Al-Anon Central Office in LA for help. They said that there is no oversight of groups and each group is responsible for following Steps, Traditions and Concepts. What she heard is that she wasn't going to get help. Someone even told her group that I had called the office to complain and that point was made public in the meeting, humiliating her. It seems like it should be easy to leave those controlling meetings, but it is no. What can we do to help those members caught up in controlling meetings? Talk to them. Go and visit their meetings

Third sharer. After 20 years I left a controlling group. SCWS can continue to welcome members still in those group to all our functions and events. That is the Al-Anon message; welcome and give hope. We do not all get here as "well" people. Character defects in groups can grow and thrive. We need to remember to show that the World Wide Fellowship is here for every single one of us.

Fourth sharer. The program in this group is diluted so much that many people leaving have no concept of the true Al-Anon program. There is no unconditional love and acceptance was not available without strings attached, ever.

Fifth sharer. I had a sponsor in my first group. After 4 I met up with a controlling group and was there for 5 years. Al-Anon Fellowship is Worldwide get in this group I was made to feel wrong to go outside these meetings. I was not encouraged to grow through outreach to make new friends to share and grow with on my journey.

Collectively they shared on Sponsorship. We find them as we go to meetings. In these groups sponsor are chosen, "shopped," you might say. Your sponsor chooses you. We are all a family, all of us.

Others in the workshop shared.

Sponsorship, what is the middle ground? Giving advice was expected. Told to call at certain times and go to specific meetings.

Courage, we are all here because we're not all there. To have knowledge is to have responsibility. A person does not run this program, it is God. Learning how to stand on our own feet with the love and support of people on the same journey is our message. Healing wounds.

The experience of those that were in this group and their being in our SCWS Area lent itself to have this topic in our SOS workshop. Knowledge, hearing direct experience today allows for a candor not known to all.

Having knowledge and not doing anything for a long time. It is just time. The message of what Al-Anon is for all of us to carry and use ourselves.

Three obstacles says not to gossip.

Concepts say every person in the minority has a right to be heard.

Often I have been a volunteer. Suffering is optional.

When I feel the group is going awry, I ask God to muster up the courage for me to say what I feel.

Opportunity abounds for us to help one another. Practice the principles each and every one. We must be diligent ourselves.

All of us here are fabulous. It is working to go outside the group.

Those that go (away from controlling groups) first have the responsibility to reach back and pull with them those that follow.

We must reach out. Nationwide, the number of meetings are not growing. What can each of us do? Put our hand out and welcome oldtimers and beginners.

# When it goes Awry: Using Conference Approved Literature (CAL) & High Pressure Groups/Pyramid Sponsors. 11:25 workshop Amanda C

The meeting began with the Serenity Prayer.

The group discussed briefly the need to use Conference Approved Literature (CAL). We played the game "telephone" to illustrate the need for using the same literature. The members whispered from person-to-person the phrase as they heard it to the next member. The phrase that started was "I love eating pizza with sausage, pepperoni, and anchovies." What the last person heard and repeated to the group was "


We next went onto High Pressure Groups/Pyramid Sponsors. A brief description was given about what a High Pressure Group/Pyramid Sponsorship might look like. The first two sessions had distributed the Forum Article *I Felt Abandoned* and the Conference summaries from 2005 and 2006 sharing about these groups. Some had also shared their personal experiences.

We wanted to make sure that members don't feel that meetings have an "us" and "them" feeling to them. Awareness, Acceptance and Action are our responsibilities as members.

The following tools were brought up for members to share with each other and to take back to their groups:

- —Place the Sponsorship pamphlet in all newcomer packets. It is not currently part of the newcomer packet.
- —Use the "Three Obstacles to Success" as a reading at the meeting.
- —Do a "Group Inventory"
- —In the meeting format, state to newcomers to try Al-Anon for six months, if they are still not happy, we'll refund their misery.
- —Encourage use of the phone list.
- —Promote participation at the business meetings.
- —Encourage newcomers read Al-Anon literature.
- —Welcome newcomers and make sure we welcome those from High Pressure groups.
- —Encourage dual members to read the Al-Anon Spoken Here pamphlet.
- —Once a member volunteers for service above the group level, welcome them by making
- —Offer hugs/handshakes.
- —When something doesn't sound right to you, speak up.
- —Own your own power as an Al-Anon member.
- —Have your group own a copy of the current Service Manual, read and refer to it.
- —Put a quarter and your name in a can, pass around your meeting until you have \$11 saved then draw from the can to have a Forum subscription winner.
- —Make sure groups do weekly reading of the Steps and Traditions.

The workshop then closed the meeting with the Al-Anon Declaration.
