

Delegate's Report:

Officer Reports

I am still pinching myself! I cannot believe that I am actually the Delegate of CA(S) for Panel 52. I look forward to the next three years with anticipation, amazement and excitement. It is such a privilege to be of service to you the Al-Anon fellowship as your Delegate. I take this position and my responsibilities seriously and will do everything I can to be a humble, willing servant to all of you.

I have received all of the Conference Material this past week and let me tell you my printer was on over drive. This is the first time that the conference material was not mailed through the Post Office. Instead we were instructed to download everything from the Delegates'

e-communities and to print it. <u>The Conference</u> <u>Theme this year is: "Our Spiritual Journey – we</u> <u>get as we give".</u>

I made my travel arrangements this week. This year the WS Conference will be held in Stamford, CT instead of Virginia Beach, VA. The Conference dates are: April 15 – 19, 2012. Once every three years the conference is held in Stamford, CT in order for the Delegates to visit Stepping Stones in Bedford, NY. This is the year! I am looking forward to not only the WS Conference but to visit the historical site of our co-founder Lois Wilson and her husband Bill Wilson, the cofounder of Alcoholics Anonymous.

Chosen Agenda Items: Delegates are requested to submit two agenda items from a list of nine topics. The two Chosen Agenda Items (CAI) that receive the highest number of votes will be the CAI. The first Chosen Agenda Item is: How do we empower the average Al-Anon member to speak up at meetings when someone else's sharing is not Al-Anon? Tradition Five states that "Each Al-Anon Family Group has but one purpose: to help families of alcoholics." However, many newcomers to Al-Anon have family members with multiple additions and/or mental disorders. This is not a new issue: however, the percentage of multiple addictions seems to be increasing each year. How do we ensure the Al-Anon message remains clear as we continue to expand our membership both within our Conference structure and within other service structures as well? How do we lovingly encourage members to only use our Al-Anon language when sharing their Al-Anon spiritual journey?

The second CAI was: How does WSO see social networks, such as Face book and YouTube, as a way to attract and retain new members to our fellowship? What are the ways in which social networking can aid in attracting and retaining members into our fellowship and retain our anonymity and keep within the understanding of our Traditions? After 60 years of Al-Anon we are still not well known. How can we get Al-Anon and Alateen "out of the closet"? There is a statistic that states every alcoholic impacts eight or nine people. Given those numbers, our rooms should be overflowing; however, they are not. What do we need to do in order for the programs of Al-Anon and Alateen to be as well known as AA? The most important thing is for people to be aware of the benefits of Al-Anon and Alateen.

I am scheduled to participate in a Conference Call on Saturday, February 25. This conference call is designed to prepare the new Delegates for the Conference and to allow us to ask questions. I look forward to participating in this call.

All Delegates are assigned to serve on a Task Force. The Task Force I have been assigned to is: The Importance of CAL in Meetings. This Thought Force will work on supporting Areas in dealing with groups whose activities fail to consider Al-Anon or Alateen as a whole and identifying the issues that lead to this problem and developing strategies that will assist the Areas in dealing with these groups in a positive and productive manner.

Another assignment that I have been given to do prior to the WS Conference is to do Area Highlights. I must be prepared to give a 300 word presentation on one success of the Area and one challenge of the Area. There were many successes but the one that stands out and created much enthusiasm was the Thought Force and then turned into a Task Force of the rewriting of the Area Alateen Safety and Behavioral Requirements Document. That was an enormous task and additionally we traveled to 22 districts out of the 30 districts in the Area.

I believe the biggest challenge of the Area this past year has been the theft of the money from the SCAC bank account from an Alateen Sponsor and handling the repercussion of that situation. There have been some positive things that have come from that challenge. The Area now has oversight of the checking account for SCAC. The SCAC Committee realizes that they are part of the AWS Committee and is working very hard with members of the SCWS Board to keep the communication open and to assist them in the success of SCAC 2012. There are always silver linings!

I have included a flyer for your LOVE GIFTS. These are small tokens of friendship extended from our Area to the rest of the members of the Conference. Alternate Delegate Report 2/18/12

We conducted our first DR orientation at 9 am on Saturday, February 18, 2012 before the Committee meeting. We introduced new DRs to their duties and responsibilities as outlined in Al-Anon Guidelines G-37 and covered other aspects of the job as they have traditionally been carried out in our Area.

Sharing of Service North event, fall 2012. What made the SOS North event in Ventura this fall such a huge success was the partnership between District 12 and SCWS. I have discussed a similar partnership with District 8 in Santa Barbara for next fall's event. The district is not able to host in the fall but might be able to do so in January 2013. We will have details for the fall 2012 SOS available to share with the May Assembly.

The Board has had some preliminary discussion about possibly scheduling another TEAM event with WSO for next January 2013. However, we want to discuss this in more detail at the next board meeting. World Service has not yet committed to doing any TEAM events in 2013 because of the Worldwide Convention in Vancouver in July 2013.

Part of my job as Alternate Delegate will be to promote subscriptions to the Forum. According to World Service, the two areas in California currently have 1,571 groups and members in these groups have 2,674 subscriptions to the Forum—an average of 1.7 subscriptions per meeting. Only 6 areas in the US and Canada average 2 copies per meeting. I would like to brainstorm with DRs and GRs to move our average to more than 2 per meeting. I look forward to working with you to increase our subscriptions.

Officer Reports

Frank Leone, DR for District 8, just published an article in the March issue of The Forum on pages 18-20. It's an inspiring story of what happened when a group had to cancel a meeting because their church meeting site was closed for a holiday. Frank decided to show up for the meeting "just in case." A woman, Jeanie, did indeed show up and Frank was able to share the Al-Anon message with her, which she describes in the article as "an awakening that I will never forget."

Thought and Task Forces. (Let me be the first to say, "May the force be with you" and get that out of the way.) Thought Forces are investigational and Task Forces are the ones who come up with recommendations for action.

We already have five Thought Forces and one Task Force in operation. The five Thought Forces are:

How can the Area support Districts and Intergroups in dealing with groups whose activities do not consider Al-Anon and Alateen as a whole

The growing diversity and relationship between the Spanish overlay District and the Southern California Area structure

How to meet the changing needs of Districts and groups as it relates to Area structure

A review of Area elections and voting procedures to see if they can be made more efficient

A review of our Hot Topics procedures. And the one Task Force is:

Review of the Area Alateen Safety Requirements

At the Committee meeting we had commissioned one more Thought Force, on how to deal with meetings who use outside literature, but that has been rolled into the first task force.

The Southwest Regional Delegates' Meeting (SWRDM) will be held in Los Aptos (No. Cal.) this March and it should be very exciting and informative. Its purpose is to welcome and acclimate new Delegates to their new roles. Our Area also sends the Chairman, Alternate Delegate and immediate Past Delegate to further our experience in World Services. Information is shared as these officers meet and learn from counterparts from HI, CA(N), CA(S), AZ, UT, NV, NM, and CO (the Southwest Region.)

Please use Past Delegates, as our Area has invested a lot in us—both financially and emotionally, spiritually, and historically. - Thought Force on the growing diversity of our Area and relationship between the Spanish overlay District to the Southern California Area's structure
- Thought Force on how to meet the changing needs of Districts and groups as it relates to Area structure
- Thought Force on Area elections and voting

The target is to have the charge for each group clearly defined, members of each ThF put together, Chairs appointed, and training on the full use of Knowledge-Based Decision Making be completed before the May Assembly. New and additional Thought Forces will be appointed as our panel progresses.

- <u>Treasurer</u>. Cathy S. Checks from Treasurer will be mailed by bank, AND contribution receipts will be emailed, avoid postage. Send email address with contributions (anyone's from your group). The \$5k contribution to WSO from the 2010 budget excess that was approved by the May 2011 Assembly never was sent. We will have to do budget again because it was based on only 2nd quarter numbers, not 3rd quarter.
 - •<u>Audit Report</u>. Christy R. Corrections to the books need to be made, \$19k difference. Recommendation: treasurer report to Assembly the largest corrections.

•Truck. We are not in the hole for \$19k. We are NOT in trouble! The ending balance is \$37,068.64 Records Secretary. Chris C. Roll Call.

- Minutes Secretary. Elizabeth K. Minutes of Aug 2011 Cmtee mtg read in brief then approved with one correction the minutes approved at Aug Cmtee mtg actually were those from the Feb 2011 Cmtee mtg. <u>Motion</u> by Tarisa Area Alateen Sponsor Coordinator, 2nd by Michelle D72. 1 Abstention.
 - •<u>Motion form</u> has been posted on SCWS website (see FORMS link) to be used by GRs at Assembly meetings and a Suggestion Form to be used by DRs, Board members, Liaisons at Committee meetings. Note that the form asks for background information and for 2 copies to be completed -- one for the Minutes Secretary and one to be used at the microphone. Forms will be available at all Area meetings (Assembly and Committee).

•Truck. Please invite Delegate Jayme to come to your group and District mtg so that she can find out what is your opinion. Really important for our Area! Gives better informed group consciences, plus she brings your opinion to the WSC World Service Conference.

- <u>Past Delegate</u>. Sandie E. Invite Immediate Past Delegate Sandie to your District mtgs so YOU can hear how to use KBDM. A Thought Force only investigates issues, makes strategies for the next phase. Only a Task Force makes recommendations. Need volunteers for four Thought Force topics on:
 - 1. how can Area support Districts and Intergroups in dealing with groups whose activities do not consider Al-Anon and Alateen as a whole (a.k.a. groups that violate the Traditions).
 - 2. the growing diversity in our Area and the relationship between the Spanish overlay District and the So Cal Area's structure (how to meet needs of Spanish-speaking and also any other languages).
 - 3. how to meet the changing needs of Districts and groups as it relates to Area structure (a.k.a. restructuring).
 - 4. Area elections and voting (smoother, less time-consuming).

- 1. Update on Task force on Alateen, Jayme
- Suggested update of Area Alateen Safety and Behavioral Requirements were brought to Nov 2011 Assembly but no time to discuss it or vote. At Nov Assembly, Truck sought individuals who would want to serve on a Task Force, some signed up. Ben P. (current Chair of Task Force on Alateen Requirements) sent 2 email requests to those who signed up: 1. to review existing comments on blog on SCWS website, then either email Ben or add to the blog. 2. Plotted a google map of Districts visited by Task Force, sent 2^{red} email. Only 3 responses total for both.
- Help Truck be pro-active on this issue. The Alateens is one of the very most impt topics we will deal with in this 3-year term, need discussions in person. WE WANT TO HEAR FROM YOU!! Kathi L. (on Task Force) has a small committee who would go to any groups to have a discussion, not a presentation. Back and forth discussions in person are vital, easier, more effective than a blog. Any Districts interested in having town hall mtg (joint mtg between 2 or more Districts), contact Truck or Kathi L.

2. Update on theft, SCAC, Jayme

Discovered the loss in mid-Dec. Final bill of approx \$23k for 2011 SCAC was not paid because of the theft from the bank account by a SCAC Sponsor or AMIAS. Debt is a SCAC debt, not an SCWS debt, not an Al-Anon debt. SCAC Alateens requested help from SCWS. Mtg held in Dec (6 ½ hrs) among outgoing and incoming SCWS officers, and 2012 SCAC sponsors, brief visit from five 2012 SCAC Alateens. All worked hard to get this going –officers, SCAC Alateens, SCAC Sponsors. All professional

advice/consultation was free of charge from Al-Anon members (law enforcement and attorney). Consulted past Delegates Sandie, Mary, Willie. One more mtg in Jan, then formed smaller <u>Task Force on SCAC</u>, 10 members plus chair: 5 SCAC members (2 SCAC Sponsors Linda T. and Danny H., 2012 SCAC Chair Josh S., 2011 SCAC Chair Robert D., 2012 SCAC Treasurer Sam S.), 5 SCWS members (Kathi L., Tarisa R., Cathy S., Mary M., Pat H.) and Task Force Chair (Jayme, neutral).
Where we are today with this situation.

- a. SCWS now has oversight of the SCAC bank acct (not control). Cathy S. now is on SCAC bank acct, can log into the acct any time of day, sends reports to Alateen SCAC Treasurer Sam, SCAC Sponsor Linda, Truck, and Jayme.
- b. Setting up a Pay Pal account (small service fee) on SCAC website (for contributions to repay the debt) so the money will go directly into SCAC bank acct. If any member/group wants to donate to repay the SCAC debt (for money owed to University of Redlands for 2011 SCAC), use the Pay Pal acct on the SCAC website (#3 below).
- 3. <u>For contributions to debt and to scholarships</u>, write checks to Southern California Alateen Conference (spelled out). Where the money is sent determines what the contribution is for.

For 2012 SCAC donations give check to the DR of your District, because DR distributes SCAC scholarships among the District's Alateens. **Deadline: Give scholarship donations to your DR prior to June 9.**

For 2011 SCAC debt mail check to SCWS PO Box or use SCAC website: SCWS, PO Box 350, North Hollywood, CA 91603. Checks will be forwarded to 2012 SCAC Sponsor Linda T. or Liz E. for deposit into SCAC bank account.

- Fundraiser event started by some Orange County Alateen Sponsors ("SCAC pac attack"), called the "<u>event/non-event</u>". Cost is \$20. Originally had their own website and pay pal account, but discussed it with Task Force and past Delegates, now it has been corrected now using the SCAC Pay Pal account on <u>SCAC</u> website **www.scac.ws** so that the money goes straight to the SCAC bank account, not to any other account. The way it works is that you buy tickets to this event/non-event on the SCAC website (for a small service fee), but there isn't any physical place or event to attend. 100% of the donations (after the service fee) go toward the debt. It's ok to donate because the money IS going to go into the SCAC bank acct.
- 4. <u>SCAC does not have a 501c3</u> SCAC is no longer a corporation, discovered because of this debt so <u>currently any checks</u> <u>written to SCAC are NOT tax deductible</u>. Willie W. is helping with re-establishing a 501c3 so donations to the debt or to scholarships can become tax-deductible again.
- No one can attend SCAC from now on who is not certified. Former Alateens can come to the Open AA/Al-Anon Meeting on Sat night and to the dance. After the dance they go home. If you want to go to SCAC, then get yourself certified. Also, no walk-ins (Alateens or adults).
- 6. Further discussion.

Ask-It Basket Questions

• Q. What can I do when two uninformed AI-Anon members are taking over decisions in a meeting and all other members are complaisant and agree (vote yes) without understanding what they are voting on?

A. There are two issues raised in this question: information and dominance. With respect to information the use of Conference Approved Literature (CAL), particularly the Service Manual, can be your starting point. A list of Al-Anon guidelines and other service materials can be found on pages 56 and 57 of the Service Manual.

As far as dominance, there are two basic ideas: rotation of leadership and participation. Rotation of leadership means that all members should serve in positions of authority and that older, more experienced members are consulted on decisions but should not dictate. The reading Three Obstacles to Success (Service Manual page 24) suggests that "No member of Al-Anon should direct, assume authority, or give advice."

For participation, Concept 4, "Participation is the key to harmony", states the basic rule. Participation goes both ways, we must make efforts to include all group members in our decision making and we need to participate ourselves. Concept 4 is discussed on pages 180-182 of Service Manual. Although the discussion is phrased in terms of World Service, the principles are applicable at all levels.

A Group Inventory (Service Manual pages 50-51) may be one way to bring this issue to the attention of the group. At other times, as specific issues come up, you can say, "Let's see what the Service Manual or other CAL, says about this issue."

Q. Please summarize the response to the family counseling "newcomer survey" that has been sent to random groups.

The WSO is neither endorsing nor affiliating with the VA and Stanford researchers, nor are they spending money or earning money on this project. The questions have been reviewed in the survey to ensure that all the questions are directly related to the newcomer's experience with another's drinking problem and the effect it has had on their lives.

Groups are not being asked to determine if they think newcomers would want to participate in this study. Newcomers can make this decision themselves. Groups are being asked if they are willing to ask newcomers if they would like to participate. Many newcomers have already participated in the project and have found it beneficial. Newcomers should not be pressured to participate or made to feel the survey is mandatory.

Participant contact information is carefully maintained. Each group is assigned a code and responses are never connected to a participant's contact information. The Social Security number is only requested if the newcomer chooses to receive the \$25.00 incentive offered and is used only for the purpose of payment. Nothing about Al-Anon would be stated in connection with the payment.

The \$25.00 is a thank you for participating in the survey and is for the individual not payment for the Al-Anon group. Therefore, taking the money is not a violation of the Legacies. This type of incentive is traditional with most surveys and not unique.

Some have been fearful that offering a survey to newcomers would be overwhelming and/ or perhaps a turn-off to the Al-Anon Family Groups. The survey does address some sensitive topics, however it is really for the newcomers to decide if they want to take the survey or not. It is the group's job to decide if they want to hand out the surveys to newcomers. When a group makes the decision not to hand out the surveys simply because it thinks newcomers can't handle it, or won't want to participate, they are taking that choice away from the newcomer. Many newcomers who have taken the survey actually expressed gratitude for the opportunity to participate in the survey.

Even if your group decided to request the surveys, your group is not obligated to pass the survey packets out. If your group changes their mind after reviewing the packets simply notify the researcher. There is no need to explain your decision.

Q. Where would I go to find a definition for "Cross Talk?" I would like to put the definition in our meeting format.

A. There is no definition of cross talk in the Al-Anon Service Manual. However, some meetings include in their meeting format an admonition not to engage in cross talk—which generally discourages members from interrupting other members during their share or addressing part of their share to a particular person. There is no mention of cross talk in the Suggested Meeting Format Outline on page 8 of the Service Manual.

Here is some information from a World Service Memo which addresses "Crosstalk."

TO: Conference Members FROM: Executive Director DATE: February 26, 2010 RE: Recurring Question: "Crosstalk"

The WSO was asked at the 2006 WSC to send a copy of questions it receives from Conference members and our responses to all Conference members so that they can share leadership by responding to recurring questions in their Areas. The WSO believes that the following questions and our response might be one of those topics.

What is the Al-Anon policy on crosstalk?

- What is the crosstalk statement that we can read at the beginning of the meeting?
- Please clarify the term "crosstalk."

ANSWER: The word "crosstalk" has crept into our Al-Anon vocabulary, but there is no standard definition of the word within our fellowship. The Al-Anon/Alateen Suggested Welcome tells us, "The loving interchange of help among members…make[s] us ready to receive the priceless gift of serenity." The subject of "crosstalk" has been discussed at several World Service Conferences. Each time, the consensus has been that Al-Anon has no official definition of this term, and that what is important in each group is that we maintain a loving and welcoming environment for those who attend our meetings. Each group can discuss how to approach maintaining a "loving interchange" in their group meetings.

Al-Anon members are each at different stages of recovery, and experience suggests that the well-meaning actions of a member could be interpreted as "crosstalk." Whatever the intent, it is the disruption of group unity and harmony that could give a newcomer a negative view of Al-Anon. Discussion of religion, gossip, and dominance are pointed out in the pamphlet Alcoholism, the Family Disease (P-4) as the "Three Obstacles to Success in Al-Anon." Along with the Three Obstacles, "Group Problems and Solutions" are mentioned in the "Groups at Work" section of the Al-Anon/Alateen Service Manual (P24/27). A discussion of these topics could provide insight and solutions to issues that a group might interpret as "crosstalk" but may be a different problem.

Groups are encouraged to take a periodic review and discuss matters of concern in light of the Traditions. Many groups have found this process to be beneficial in determining the will

of the group. The Guideline for Taking a Group Inventory (G-8) is a useful service tool that can aid in this process. It can also be downloaded from the AI-Anon Members' Web site under the "Group Services" tab.

The autonomy of groups allows each group to determine the format of their meeting by making an informed group conscience decision that abides by the Traditions. A group might hold a meeting on the topic of "loving interchange," or contact the District Representative to discuss at a District meeting the topic of how to maintain "loving interchange." Other groups may have experience, strength, and hope they could share on this matter.

Articles from The Forum about crosstalk/loving interchange are available on the AI Anon/ Alateen Members' Web site (<u>www.al-anon.alateen.org/members</u>) under the "Publications" tab/ Forum. These sharings might offer some insights for group discussion.

Q. There are a lot of unauthorized 12-Step Workshops. Does Al-Anon have any publications/information on authorized 12-Step Workshops?

A. On page 116 of the Service Manual it states: The Al-Anon/Alateen name cannot properly be used to identify or publicize retreats or activities sponsored by others. This applies when most or even all of the participants are members of Al-Anon/Alateen. Otherwise there could be a misunderstanding of Al-Anon's purpose and function. In order to avoid any appearance of Al-Anon/Alateen affiliation, it is important to keep promotion of such events outside of Al-Anon/Alateen meeting locations. Our experience suggests that confusion arises when such events are announced in Area newsletters, Al-Anon/Alateen local bulletins and at group meetings.

Q. What is the relation between Intergroups and the World Service Office?

An Al-Anon Information Service, also known as an Intergroup, is a local service established and maintained by one or more districts or by groups located close enough to one another for easy access and communication. (See page 59 of the Service Manual.) Generally Intergroups maintain a listing for those seeking information about Al-Anon, keeps a list of local meetings, serve as an avenue for Public Outreach and may maintain a stock of Conference Approved Literature. Although Intergroups send a liaison to the Area Committee and Assembly meetings, they are separate and distinct from the Area in which they are located. However, since Intergroups and Areas serve the same meetings and the same members, it is important for them to work together.

See also page 67 of the Service Manual where it is written: "An AIS Liaison Member links the AIS to the Area. Al-Anon Information Service Liaison (AISL) members are appointed or elected by the Intergroup to serve as the communication link between the Information Service and the Area Assembly/Area World Service Committee.

Q. My meeting has a phone list with a long excerpt from Conference Approved Literature (CAL) on top. On page 103 of the Service Manual it states that CAL is copyrighted. "The WSO does not grant permission for substantial reprints of CAL in Area, district or other service arm newsletters, or to outside publications in the US and Canada.

A. The operant word here is "substantial." It seems unlikely that excerpting a few sentences


or even a paragraph would violate CAL copyright.

In addition, a phone list is not a document that is "published," that is, made public. In fact members should be encouraged to respect the privacy of those members who make their phone numbers available to other members.

Q. I'm seeing at my meetings there is a lot of chanting such as repeating as a group "principles before personalities." Is this discouraged or encouraged by World Service?

A. In the "Suggested Meeting Format Outline" beginning in the Service Manual on page 8, there is no mention of group chanting of parts of the Traditions or other Conference Approved Literature. Nor does WSO encourage members to chant affirmations at the end of meetings such as "keep coming back".

Generally such "chanting" has become habitual at a meeting and members are accustomed to it. However, there is nothing to stop you from calling a group conscience and pointing out to your group that such chants are not "Conference approved."

Group Records Coordinator

My name is Chris C. and I am your newly appointed Group Records Coordinator. This is a very exciting adventure for me to be able to connect meetings and people together. Effective March 28, 2012, District Representa-

tives will have read-only access to view the Al-Anon groups information in their district and run reports for those groups. This new tool will help DR's keep their group's information up-to-date in their district. It will allow them to notify the Group Records Coordinator of any discrepancy between the Area and WSO Records. The WSO has notified the DR's on e-Communities and provided instructions to access the application. Since only 1/3 of the DR's have accessed e-communities to date the WSO is asking you to pass this information to all DR's so that they can benefit from this new tool.

I have discovered that the most important issue is that each and every meeting needs to be registered through World Service Office and not just your local Intergroup Central Office or Service Center. I am discovering that some meetings that thought they were registered, actually were not registered with WSO. Also, once you receive your WSO ID number, please contact your local Service Center or Central Office to let them know of your new meeting.

During a telephone conference with other group coordinators, it was strongly suggested by the WSO that all groups update their records, even if the information has not changed.

Verification of e-mail addresses has become essential and should be accomplished on a regular basis since the WSO and Areas are increasingly communicating electronically with the groups. WSO has requested that members not use their work email address for their group. It was suggested during a recent telephone conference with other Group Records Coordinator that a group can have their own email address through gmail.com or yahoo.com. If a birthdate is needed for the application of the email address, it was suggested to use Lois birthdate of March 4th and the year 1951 for year Al-Anon started, ie, the birthdate would be 3/4/1951.

Please make sure that your Current Mailing Address (CMA) for your meeting is updated. The CMA receives all mail from WSO as well as the "Forum".

It is also very important to log onto <u>http://scws</u> <u>-al-anon.org/</u> when you have a location or time change of your meeting or any other changes.

We have currently updated our records and are working from only one database through World



We discussed the proposed new AMIAS guidelines. I found more than a dozen ambiguous or vague statements in an initial reading. As proposed, I cannot support the new guidelines. An Al-anon member suggested to me that the vagueness would not be a problem. After all, an Al-anon trusted servant would understand and follow the intent of the rule. I disagree. We are trying to develop a set of

requirements because some of these trusted servants proved unworthy of our trust.

• Fourth Step Workshop

On March 17, District 60 is hosting a 4th Step Workshop called "Taking the Fear

Out of the Fourth" in Fullerton. Although we will pass a basket for a 7th Tradition, the event is free, including lunch and parking. Our Workshop committee has the speakers, location and logistics planned, with just a few things left to do before the day of the workshop.

• Survey Issues

We discussed the issues relating to a survey regarding newcomers being pushed

Hot Topic

KBDM

For your review

KBDM stands for Knowledge Based Decision Making. It is the way Virginia Beach and the Annual Conference reach an informed group conscience. We are implementing it in Southern California World Service.

KBDM is based on five principles:

- Open communication
- Dialogue before deliberation
- All decision makers have access to all information
- We are all Trusted Servants
- We operate in a culture of trust presume good will

The process of KBDM begins with gathering information. A "thought force" is a small group formed to gather information on a particular issue and present it to the group. The thought force researches and answers six questions:

- 1. What do we know about our member's needs, wants, and preferences that relate to this issue?
- 2. What do we know about our resources that relates to this issue.
- 3. What do we know about our "culture" or "environment" that relates to this issue.
- 4. What are the implications of our choices? (pros and cons)
- 5. What do we not know about this issue that we wish we knew?
- How do Al-Anon's legacies (Steps, Traditions and Concepts) apply to this issue?
 7.

The thought force then prepares a "framing" presentation of the information it gathered. This is distributed ahead of time to all participants and presented to the group.

The thought force does not make any decisions or present a motion. It does not do any work to implement processes or procedures.

The group begins discussing the issue. The thought force may be requested to provide more information. The group reviews and discusses possible solutions.

Once all participants are ready for a decision, then a motion is made, seconded and voted on.

The panel discussed three examples of KBDM. (1) Another area used KBDM to decide whether to purchase an LCD projector, (2) Southern California World Service used KBDM to decide on how to replace an Alternate Delegate who resigned, and (3) District 42 gave an example where KBDM would have been useful in dealing with the sale of the answering service they used. In the second example, no motion was needed, because there was a consensus.

In conclusion, the panel noted that the principles of KBDM are spiritual principles to remember and to remember patience when trying to introduce KBDM to your District or Group. Education is necessary, since most members are familiar with the process Motion-Second-Discussion-Vote from Robert's Rules of Order and may feel uncomfortable with the KBDM process where the motion comes after the discussion in the order Discussion-Motion-Second-Vote or you may not even need a motion or vote.
