DELEGATE'S REPORT February 2013

Greetings CA(S), Area 04! I am so glad that I waited to write my report until after the Area World Service Committee Meeting (AWSC) which was held on Saturday, February 16! There was lots of dialogue and information provided at that meeting and I would like to mention some of it in this report.

A past CA(S) Delegate was talking to me recently and I was telling him how much has changed since he was a Delegate. I told him that the technological advancements have facilitated the flow of information to the Delegate almost instantaneously. I also told him how most days are spent on the computer doing "Delegate" work. He made a statement that will resonate with me the rest of my panel as Delegate. He said "remember that you are not here to fix Al-Anon, Al-Anon is here to fix you"! My response is "thank you, HP, I needed to hear that". Yes, there are moments that I lose sight of the fact that this is a spiritual journey, but just when I do I get reminded. What a gift it has been to be your Panel 52 Delegate!

Let's begin with the report of the Alateen Task Force: The Articles of Incorporation have been sent to the State of California. Form 1023 has been filed with the IRS for a 501(c)3. The SCAC By Laws have been revised by the SCAC Committee. The By Laws contain all that is necessary to be in compliance with the Area's Safety and Behavioral Requirements. The revised By Laws now also reflect the needs of the Corporation. The SCAC By Laws will be voted on at SCAC 2013. We continue to educate the Area and the Alateens that the By Laws must pass at SCAC 2013 in order to be in compliance with the Area's requirements.

It is important for us all to look at the way in which the Area responded to the theft from the SCAC account. The Alateen Task Force helped establish a recognized connection/link between SCAC and the Area. The money was raised and the debt was paid in full. The Area now has financial and operational oversight of SCAC. There was no drama, very little gossip, the person's anonymity was protected and the Area has grown in understanding the "spiritual principles" of the Al-Anon program. The Area is much more unified!

When the 7th Tradition basket was being passed at the AWSC on Saturday a District Representative raised the question "why doesn't each District Rep bring a donation from their district for the 7th Tradition rather than put a few dollars in the basket and then get reimbursed?" Wouldn't it be easier to bring a larger donation for the Committee Meeting and Assembly from your District and Groups ahead of time?

We don't talk much about contributions to SCWS, but when you look at all the services that SCWS provides to the Area it is mind boggling. Here are just a few of the unforeseen services provided: rent for the use of the facility, the mileage for the SCWS Area Committee Meetings and SCWS Assemblies, the background checks for the AMIAS's, printing and facility fees for the Recertification Workshops, Bulletin production, public outreach services, Delegate's expenses ~ the list goes on and on. Are you aware that any contribution to SCWS is tax deductible? Yes, SCWS is a 501(c)3 corporation with the IRS. To quote from our pamphlet "Seventh Tradition" (S-21) "If you have received help, and you no doubt have, why not give to further the cause for the peace and serenity of future members." Anne B., Cofounder of Al-Anon, 1958.

I would now like to report and explain the topic of Conference Structure. A Thought Force is looking into Conference Structure for this Area. The charge for this Thought Force is: "Is the current Area structure providing the spiritual bridge we need to expand into the future in order to meet the needs of the Area"? The Thought Force met for the first time in early October. Members for this Thought Force consist of GRs, District Reps, past Delegates and members at large. We have met almost every Sunday night for one hour via telephone conference call.

We each answered the KBDM (Knowledge Based Decision Making) questions individually. This KBDM document will now be framed and presented at the May 2013 Assembly with the summarization of each question. Our goal is to start the conversation and our next step must come from the discussion at the Assembly.

The Thought Force will probably recommend that a Task Force is formed to develop a survey to distribute to the Groups. A Yahoo Group or a Blog could also be formed for a discussion group. Perhaps the Groups believe we do not need to change anything, but whatever the outcome it must come from the Groups.

A Thought Force on Conference Structure has been formed in CA(N). We realize that one of the possibilities could be a central California Area. I am maintaining close contact with the Delegate from CA(N) knowing that whatever each Area decides could affect the other.

To see that we are at the point of some sort of action (or no action) after all these years is really exciting and relevant to how slowly and thoroughly ideas are vetted. What we learned from all of our discussions is the idea is good, but implementation (if that is what our Area would want) will also need to be very slow and carefully thought out. There are so many unknowns and so much to learn from others that this will be a focus of CA(S) for a long time.

I am very busy preparing for the WS Conference which will take place in Virginia Beach, VA from April 13-19, 2013. I have been asked to give a 4 minute talk on our status of Conference Structure. I will also be participating in a Shared Leadership workshop with another Delegate and two Trustees. I am also part of a Task Force on Conference Approved Literature (CAL) that will be presenting at the Conference. Lastly, I have been chosen to be on the Conference Committee on Trustees. This is a committee that evaluates resumes submitted for Trustees at Large openings. As you can see in addition to my Delegate's work in the Area I am also very involved in preparing for the WS Conference.

Juvenile Hall. When I was first approached by Kathi A., (former DR of District 75) to come to San Diego to participate in an Alateen meeting held in Juvenile Hall I said yes without giving it another thought. Kathi also stated that she wanted me to give voice to what San Diego is doing in the Juvenile Halls. In a short period of time I received a mountain of paperwork to fill out for the County of San Diego. Once done and mailed in I forgot about it. Then one day I received an email inquiring of my availability to attend a mandatory workshop in San Diego in order to obtain entry into the Juvenile Hall Alateen meetings. I attended that workshop last week and was later given a tour of Juvenile Hall that same day. Next week I will attend my first Alateen meeting held in Juvenile Hall in San Diego. I am so impressed with what has been started in the San Diego Juvenile Halls.

Bringing an Alateen meeting each week without fail into Juvenile Halls tells these kids that they matter and that someone is there for them. It says this is your meeting and we are here for you. Each teen is given a soft cover Alateen book for them to keep. The fellowship of San Diego through their generous donations provides the money necessary to purchase the Alateen literature.

I continue to see over and over that this is a family disease and children are affected at every age. This experience has touched my heart beyond what I ever thought possible.

KBDM. Knowledge Based Decision Making. A very spirited and necessary conversation took place at the AWSC Meeting on Saturday. The Committee discussed either using KBDM emulating the Conference or using Robert's Rules.

KBDM was adopted at the WSC starting in 2006-2009. KBDM is a process to reach an informed group conscience. Knowledge Based Decision Making has four essential elements: (1) a philosophy of open communication between leadership and membership, (2) dialogue before deliberation, (3) common access to full information for all decision makers and (4) a culture of trust.

Robert's Rules of Order or other parliamentary procedures first poses a motion and then debates that motion's pros and cons in a win - lose style; in contrast KBDM first discusses an issue and ensures that all decision makers are fully informed. Then, only after the group has clarity would a motion be made, in the spirit of win-win. According to this approach, the quality of mutually respectful and informed discussion is more important than one opinion prevailing over another in a vote.

At the end of the conversation a vote was taken for the Area to go completely with KBDM starting at the May Assembly and all motions must come after discussion. We may continue to struggle with the learning curve but once again our HP has spoken through our group conscience.

Chair Report February 2013

We are entering the second year of our three year term and it has started to get exciting. We are going to have a presence at the LA Book Fair thanks to our, we are interviewing candidates for a Spanish Liason, and, starting with the May Assembly, you will begin to actually see KBDM applied. We've had KBDM Thought Forces in action and some of them will have results to present. We've also pledge to give early notice of decisions that we need to consider so you can discuss them in your groups before coming to the Assembly.

Concept 12 is among the driest of the dry concepts. Basically it says, "we have warranties." The five warranties talk about things like ample reserves, reaching decisions by discussion and vote, and being democratic in thought and action among others. In the December issue of the Forum, the article on Concept 12 summarizes the warranties as being about prudence.

One quote from the article, "To me, prudence means to be careful, not to rush, and to look at things from all points of view."

At first, I thought it was talking about patience, but when I checked back it was only talking about prudence. The difference, I think, is that prudence means taking action even if it is slow, where patience may mean just having to wait.

The Service Manual on page 264 says, "..., prudence is a middle ground, a chan nel between fear on the one hand and recklessness on the other."

We take our time making decisions. This frustrates most of us, me included, even though I'm generally on the side that wants more time to consider things.

On the one hand there are decisions that need to be made "right now" because
 they are so important the world will end...

Or so we think.

On the other hand there are decisions that the group makes that are clearly going in the wrong direction, and if they would just listen, we could convince them of the danger of their position...

- Or so we think.
 - "You may be right" also means "I could be wrong."

I could be wrong means that maybe I could spend a little time listening to your opinion.

Sometimes the right way lies between our two opinions, sometimes the right way is in another direction entirely, and sometimes we have no idea what the right way is. If I've learned anything in Al-Anon, it is that I don't have to be right all the time, or even much of the time. I only have to reason things out with someone else and to take considered action. I can change my mind if things don't work out, because the world really hasn't ended, contrary to my fears.

- And when I look at the world that way, it really is exciting.

SWRDM presents vital information to new Delegates, but also keeps Past Delegates updated on some of the issues and topics to be discussed at the World Service Conference. The Regional Trustee's report gave us information about Al-Anon worldwide and issues facing WSO.

The spirit of KBDM is to presume good will and for everyone to know the same amount of information, to have the same facts. We cannot make a motion when we do not have all the information. The motion at the November Assembly seemed to have been premature since a Task Force (TF) was/is still in the middle of doing their work. How to have all members have all the same facts: an idea will come from the Area, if the group decides to talk about it further, then a ThF is created, a question is framed.</u>

When the ThF has finished and is ready to talk about the ThF results at the Assembly, first the framing of the question is given, followed by a period of asking questions. The framer is going to tell you what it's all about, history, pros, cons, any facts they know, referencing the WSC summary, service manual, etc. If the framing is done correctly, then the questions that would have been asked would be answered during the KBDM process. The framing sets the stage for what the issue is that we're going to talk about. We take questions first, so that everyone's questions can be answered. After that is done, everyone's knowledge base has improved.

There also is time for discussion – not to push any one thing, but to consider possibilities. The Assembly could ask for more info/questions, could ask for a TF or a secondary ThF, or could decide nothing needs to change. If it turns out that the Area likes one of the things that the ThF came up with (such as perhaps a workshop we can develop or present), then there is a place for a motion to happen. The way we subsequently conduct a vote is first to give everyone a chance to discuss further before proceeding to a vote. When the questions & discussion has been completed and thus the group is ready for a vote, a motion is made with the wording that is the natural consequence of all that discussion, the motion is seconded, there might be more discussion, and then the vote happens. Sometimes during the process, the group might decide that a vote is not necessary.

Roberts' Rules says that we cannot talk about something until a motion is made, but in KBDM the order is reversed. The component of Robert's rules that is used is only in the actual vote, but not for someone to "call for a vote" in the middle of discussion, which would stop discussion in a controlling way, and instead a motion can be made and the vote can occur only after the group is satisfied that all questions have been answered and opinions and input have been considered. KBDM determines WHEN the group is ready to take a vote, and then the motion-second-discussion-vote takes place – R's rules is used only when the KBDM process leads naturally to a motion, and R's rules are not used to cut off discussion.

Comfort level: we've been using Robert's Rules since that's what we're familiar with. It's about being fair, first. If we need to discuss then we discuss first. Having a motion at the Assembly helps us to keep the focus of the discussion on a particular topic and not on a smaller side point, but how do we do that with KBDM? We do have to specify how we make decisions, which is not specified by KBDM. What does "when all participants are ready" mean, for a group this large?

KBDM is about having enough discussion to make a sensible decision. When you know what's being voted on, it makes such a big difference. We come up with a resolution that works for everyone and not end up divided. Unanimity with KBDM vs. majority rule when the vote is called with Robert's Rules of order. Printed information vs. the strongest emotional plea. Timeliness of the Bulletin.

We are doing KBDM right now on doing KBDM

When we make a motion at the beginning of a discussion, it points us to one little area and doesn't allow for free discussion. That brings up the topic of how much time we have at the Assembly.

Some Areas have an Assembly that is 2 days (NoCal, etc.), some 3 days (Alaska, etc.). Right now, this must be discussed at the District meetings because we don't have time at the Assembly and then everyone at the Assembly doesn't get to hear everything that was discussed in the other Districts.

People need to know that they can abstain, and if lots of people ever do abstain, we can take it to mean that the group isn't ready to vote.

- 1. The Nov motion would have been made even if we say that it must be 6 weeks ahead he would have followed the 6-week rule and would have made the motion 6 weeks ahead of time.
- 2. Presume good will. On the other hand, what if all board members want to manipulate? Should the board be the ones to decide which motions can be made?
 - 3. Any GR must be able to bring up a topic.
 - 4. Sometimes there will be things that have to be decided right now.

How can we speed up the process to get it out sooner? The information should *not* be sent out ahead of the Assembly so that it keeps the discussion among those who have the same knowledge base. KBDM is all about giving the same complete information to everyone making the decision. By having it out beforehand, we would be encouraging debate among those who won't be getting all of the information.

After the vote, we support the Group Conscience decision.

The timing and the function of the motion is critical. Sometimes a motion is premature, and sometimes it's controlling

<u>Let's take a vote</u>. Shall we go completely with KBDM starting at the May Assembly, and all motions must come only after discussion? <u>Procedure accepted by Committee</u> members, by show of hands.

Ask-It Basket Questions

Ask It Basket February 16, 2013 Committee Meeting

- **1.** *Q.* Is it possible to advertise a monthly meeting that is AA and Al-Anon and Alateen? Is there a special format for a "double winner" (dual AA-Al-Anon members) meeting?
- A. On page 77 of the 2010-2013 Al-Anon/Alateen Service Manual it states "The WSO cannot register any group that is solely for Al-Anon members who are also recovering alcoholics and members of A.A., because it does not qualify to have a Group Representative."

In the "Digest of Al-Anon and Alateen Policies" section of the 2010-2013 Al-Anon/Alateen Service Manual (P-24/27) is published in the section "Outside the Fellowship," under "Retreats." This particular event is not labeled as a "retreat"; however, the policy applies to all similar events that are not put on by an Al-Anon service arm. Our shared experience suggests there are many worthwhile activities in which members participate to enhance their recovery; however, they are not all "Al-Anon events"; many are outside events attended by Al-Anon members.

The following questions may help you determine if an event is an Al-Anon event:

- Does the Area or District support the event?
- •Is there accountability for funds received?
- •What is done with any remaining funds after expenses are paid?
- •Who is liable if something happens?
- 2. Q. Could the agenda at the Assembly and Committee meetings include a note on who has voice, and who has vote that day?
- A. This information is included in the Bulletin for both Assemblies and Committee meetings. You can find it in the Table of Contents under "Voice and Vote." However, we will consider putting this information on the agenda as well.
- 3. Q. To whom at SCWS do we bring problems with Intergroups? Can we have District contact information included on AIS websites?
- A. On pages 59-61 of the Service Manual, it is noted that "Al-Anon Information Service, also known as an Intergroup, is a local service established and maintained by one or more districts." These AIS/Intergroups perform functions such as: Setting up a local phone number for meeting information, publishing and updating a list of group meetings, serving as an outlet for Public Outreach and maintaining a stock of Conference Approved Literature. They may register with World Service as a Literature Distribution Center (LDC.) Our local Southern AISs send a representative, called an Al-Anon Information Service Liaison (AISL), to Southern California World Service Committee and Assembly meetings. These liaison coordinators would be good people to contact if you have questions about or issues with a particular local Intergroup. However, SCWS has no direct influence or authority over what goes on within the various Intergroups.

SCWS has Intergroup information listed on our web site. However, we have no authority to ask southern California Intergroups to list District Representatives or other SCWS contacts on their web sites.

- 4. Q. Our previous District Representative (DR) took the responsibility of assigning Alateen sponsors to meetings, often moving them around when teens did not want this. The rationale was to give sponsors experience by having them work with younger Alateens and with older Alateens. Is this the DR's responsibility?
- A. In the Service Manual pages 149-150, which talks about the DR's responsibilities, there is no mention of this being a DR duty. On pages 84-85, which discusses Alateen Group sponsors, there is no talk of Alateen sponsors being assigned to groups. Our experience suggests that Alateen groups benefit from long-term, consistent sponsors.
- 5. Q. Is it necessary to be a past or current Group Representative (GR) in order to serve as a secretary or treasurer of a district?

On page 140 of the Service Manual we read: "The election of the DR and the Alternate DR (ADR) [is] from among the incoming, outgoing, or active past GRs, none of whom are members of A.A." So DRs and ADRs must be either past or current GRs. However, any Al-Anon member can serve as a District treasurer, secretary, Alateen coordinator or Public Outreach coordinator without having served as a GR.

- 6. Q. According to G-37 Al-Anon Guidelines concerning District Representatives it states that the Alternate District Representative (ADR) may be a member of the Al-Anon Information Service (Intergroup.) The guidelines also recommend that the ADR attend Committee meetings with the DR. So why isn't the ADR invited to sit at the Committee table with the DRs?
- A. If both a DR and ADR attend the SCWS Committee meeting, only the DR has voice and vote because each District has one vote. However, if the DR cannot attend, but the ADR attends, then the ADR has voice and vote and will be seated around the table. The custom of seating the voting members around the table is to help the SCWS Chairman recognize easily who has voice and vote.

We, Christy Reilly and Mary Morrison, completed our review of the books and records of the Southern California World Service of AFG, Inc. for the year ended December 31, 2012 on January 25, 2013. Our review covered the Balance Sheet accounts as well as a test of income and expense accounts. This included a reconciliation and review of Cash and Cash Equivalent Accounts and an analysis of the remaining Balance Sheet Accounts. A random testing was conducted of the cash deposits and disbursements with satisfactory results.

The following are items of special note:

1) The results for the year ended December 31, 2012 was income of

\$17,315.67. \$10,000 of income was contributed to the WSO in 2012. The remainder of income after the contribution is \$7,315,67.

2) The \$5,000 contribution to the WSO, approved by Group Representatives at the May, 2011 Assembly, was contributed in 2012. The \$5,000 contribution to the WSO, approved by the Group Representatives at the November, 2012 Assembly, was also contributed in 2012.

A separate report of "Observations / Recommendations has been submitted to the five elected SCWS Board members.

I am also in need of participates who would like to help with the interview process, help with story transcribing to paper, and interview call backs if the stories submitted need further follow-up.

In 2014 SCWS will have a Longtimer event which happens every 3 years. In acquiring names and numbers today, this information would be used in the future to invite each to the Longtimer event in Glendale.

My mission is to ensure that all of the Alateen meetings in our Area are safe, remain focused on the Steps & Traditions, and are being run by Alateens (not dominated by Alateen Group Sponsors).

Here are a few of the projects that I have been working on:

(1) AMIAS New Applicant Certification Training (on-line and face-to-face sessions)

One of the requirements passed at the May 2012 Assembly is to attend a workshop before being considered for certification. Even though workshops are spread throughout Southern California, it still posed a difficulty for new applicants to attend a workshop in a timely manner without having to travel great distances.

At the request of our fellowship to remedy this situation, monthly on-line Certification Trainings were implemented. Currently, new applicants can attend an on-line session in the comfort of their own home *or library*. Face-to-face sessions are also available for new applicants at many of the Conventions in our Area.

Certification is valid through May 31. In order to remain certified past that date, an AMIAS must attend a Recertification Workshop. New Applicants that certify between February 1 and May 31 do not need to attend a Recertification Workshop before June 1.

(2) Alateen Sponsor Recertification Workshops

Workshops are used for Recertification only. There has been much support for workshops so that AMIAS's can get together and share their problems and solutions (pertaining to Alateen service) with each other. These have proven to be successful and beneficial.

(3) Alateen Sponsor Recertification Workshops for June 2013 – May 2014

In August 2013, I will be training six AMIAS's as Recertification Workshop presenters. The six AMIAS's represent different regions within our Area (San Diego County, Orange County, Inland Empire, San Fernando Valley, Ventura County, and Los Angeles/Spanish).

This will allow all districts the flexibility to schedule workshops when and where it is convenient for them.

The Certification Training & Recertification Workshop schedule for June 2013 – May 2104 will be distributed at the May 2013 Assembly.

(4) Amendments to the SCWS Area Safety & Behavioral Requirements

I am currently chairing a task force that was created to review the document that was passed at the May 2012 Assembly. We have been asked to "suggest amendments which incorporate the comments received from the fellowship to clarify, streamline, remove inconsistencies and/or otherwise improve the Requirements, keeping in mind the ultimate goal of Alateen safety."

We reviewed the written & verbal comments from the May 2012 Assembly and postings from the SCWS Alateen blog. The revised SCWS Area Safety & Behavior Requirements will be presented at the May 2013 Assembly. This document also notates where each requirement originated from (Service Manual, Guidelines, etc).

(5) Alateen Transportation Form

Any Alateen minor being transported to and/or from an Alateen meeting or event must have an Authorization Form filled out and signed by the Alateen's parent/guardian.

Further information about this requirement can be found on page 7 of the WSO Alateen | Safety Guidelines (G-34).

Previously, our Area used the WSO Form A (permission) and Form B (medical) found on pages 3-6 of the WSO Alateen Safety Guidelines (G-34), which is a four-page document that requires a notary stamp.

SCWS has adopted a one-page Alateen Travel and Treatment Authorization Form which replaces Form A and Form B. The new transportation form was distributed at the February 2013 Committee Meeting and emailed to all DR's, DAL's, and AMIAS's.

(6) Detailed Plan for Alateen Events

According to the SCWS Area Safety & Behavioral Requirements, page 13, item #7: "Prior to any program-related event involving Alateen participation, the responsible committee must submit in writing a detailed plan of how the Alateen participation will be conducted and how this plan will keep the Alateens safe, including the names of the current year's Alateen Committee Sponsors. This must be submitted to the SCWS Area Chairman."

SCWS allowed a one year grace period in order to inform all AMIAS's (Al-Anon Members Involved in Alateen Service) about this requirement during Certificate Trainings and Recertification Workshops. Effective June 1, 2013, any Alateen Event not in compliance with this requirement will be in violation of the SCWS Area Safety & Behavioral Requirements and will not be allowed to use the Alateen name in conjunction with the event. A template of a detailed plan was distributed at the February 2013 Committee Meeting and emailed to all DR's, DAL's, and AMIAS's



An excerpt from this issues delegate report- Jayme C,

KBDM. Knowledge Based Decision Making. A very spirited and necessary conversation took place at the AWSC Meeting on Saturday. The Committee discussed either using KBDM emulating the Conference or using Robert's Rules.

KBDM was adopted at the WSC starting in 2006-2009. KBDM is a process to reach an informed group conscience. Knowledge Based Decision Making has four essential elements:

- (1) a philosophy of open communication between leadership and membership,
- (2) dialogue before deliberation,
- (3) common access to full information for all decision makers
- (4) a culture of trust.

Robert's Rules of Order or other parliamentary procedures first poses a motion and then debates that motion's pros and cons in a win - lose style; in contrast KBDM first discusses an issue and ensures that all decision makers are fully informed. Then, only after the group has clarity would a motion be made, in the spirit of win-win. According to this approach, the quality of mutually respectful and informed discussion is more important than one opinion prevailing over another in a vote.

Group Records Report

My name is Chris Crawford and I am the Group Records Coordinator.

We currently have 1169 Active Groups in Southern California. There are 62 groups listed with "No Mail" as their addresses are not current and they are not receiving "The Forum" magazine or group information via mail or email updates as well. Currently there are 305 meetings marked as "Inactive" and 40 meetings that are marked "for deletion" by WSO in March 2013.

I have updated quite a few Group Reps and District Reps as well since the beginning of the year. Please note that it is the responsibility of the Group Representative to update the Group Records Coordinator with the current information. I would like to encourage everyone to go to the SCWS website http://scws-al-anon.org/send_mtg_record_updates.php to update your meeting or to register a new meeting. Going online to update information or to add a meeting is the quickest and easiest way to update the information. This way you save yourself the cost of the stamp and the WSO Office in Virginia Beach is updated as well, so there is no longer a need to notify WSO in Virginia Beach, VA as we work on the same database.

When completing the Information form, please make sure to add your **full name and address including your zip code**. This information is very important, in that the database can only assign you to one meeting as a Group Representative. I have had to spend many hours making phone calls and sending emails just to find out the Group Representative full name and address.

I take this commitment to my heart and want to do the best job I can. However, when I only receive half of the information I need, it is very frustrating on my end in that I cannot complete my job. If I do call you and leave a message via voice mail or email, please be courteous enough to return my call or email.

I have discovered that the most important issue is that each and every meeting needs to be registered through World Service Office and not just your local Intergroup Central Office or Service Center. I am discovering that some meetings that thought they were registered, actually were not registered with WSO. Also, once you receive your WSO ID number, please contact your local Service Center or Central Office to let them know of your new meeting.

During a telephone conference with other group coordinators, it was strongly suggested by the WSO that all groups update their records, even if the information has not changed.

Verification of e-mail addresses has become essential and should be accomplished on a regular basis since the WSO and Areas are increasingly communicating electronically with the groups. WSO has requested that members **not** use their work email address for their group. It was suggested during a recent telephone conference with other Group Records Coordinators that a group can have their own email address through gmail.com or yahoo.com. If a birthdate is needed for the application of the email address, it was suggested to use Lois birthdate of March 4th and the year 1951 for year Al-Anon started, ie, the birthdate would be 3/4/1951.

Please make sure that your Current Mailing Address (CMA) for your meeting is updated. The CMA receives all mail from WSO as well as the "Forum".

2/20/2013 Committee Report

I participated in a conference call with Public Outreach coordinators from all over the country before the holidays about ideas for Public Outreach during the holiday period when alcoholism can create so much difficulty for family members. There were many exciting ideas and it got me really motivated. I have a supply of Al-Anon faces Alcoholism and I decided that they could do some good in the visiting room waiting rooms to visit at the County jail. I made a contact with the Sergeant in charge of the front counter at the visiting room at the Los Angeles County Men's Central Jail and delivered a box of Al-Anon Faces Alcoholism. I put some out on the tables by the line for visitors and the Sergeant offered to hold the box and replace them as they ran out.

Since the Los Angeles Jail System is the largest in the country, and with realignment of inmates from the State prison system to the Counties, the system will have to accommodate more needs, I realized that it will take a large supply of Al-Anon Faces Alcoholism to carry the message to these Institutions. I had only supplied the Men's Central Jail, and there, only the waiting room for visits and nothing for inside the Institution. There are two other facilities' waiting rooms at the Twin Towers at the same site as well as other facilities in Los Angeles County and facilities in the other counties in Southern California. Al-Anon Institutions in Northern California has taken an idea from AA in Northern California. They raise funds in pink cans to supply literature for Institutions work that Al-Anon does inside the prisons in Northern California. I brought the idea to my home group and the group conscience decided to start collecting for Institutions in a pink can to purchase as many copies of Al-Anon Faces Alcoholism as we can to for distribution to Institutions. We've made our first small order of AFA for the April printing. I am hoping that my group can be an example and get groups all over South-California to start putting a pink can in their group collection basket to fund outreach to jails, prisons, hospitals, youth facilities and treatment centers in their districts and Intergroup areas. I would welcome coordination with any other groups in Los Angeles County to help supply the huge County jail system.

Not every good idea is a success. I contacted my local police station thinking that AFA could reach a lot of people at a moment when they are most immediately affected by the disease, by supplying them to the waiting rooms at the police stations. Unfortunately, I learned that the LAPD does not allow us to leave literature in the waiting rooms. It was explained that some other groups wanted to leave literature and, in order to avoid controversy, no groups could now leave literature. The officer offered to put me on a distribution list of community outreach meetings we could attend (I'll pass that info along to our Public Outreach Coordinator when I receive some info.) Unfortunately, that won't reach directly to the people out there who are suffering the most but will reach other people who also are trying to help.

As the Al-Anon Co-Chair, I have been attending the planning meetings for the 32nd AA Southern California Hospitals and Institutions Conference with Al-Anon Participation. I encourage you to attend. Our Al-Anon luncheon speaker will be Yvonne de G from Pleasant Hill, CA and the Al-Anon panel will be "Getting Al-Anon into Institutions; Successes and Challenges". The panelists will be Yvonne de G., David B., Monterey, CA and Tina S, North Hollywood. You'll get to hear about the amazing Al-Anon meetings that Northern California has pioneered in the State prisons. The Conference is April 12-14, 2013 at the Anaheim/Orange County Doubletree in Orange. I hope to see you there.



She has filled practically all of the Board positions, a feat that has not been accomplished in a number of years. We do still have a few vacancies, however, if anyone is looking to be of service.

The LA Intergroup has quite a few initiatives we are looking at this year, the most important of which is securing the financially stability of LA Central Office. Unfortunately, the LA area has not been self-supporting through our own contributions over the last few years and we have experienced a record shortfall. The Service Board and the Central Office staff have taken measures to reduce costs wherever possible, but we are still losing money. As such, the Service Board has approved a motion that will reduce the operating hours of Central Office. Starting Friday, April 6, LA Central office will be closed on Fridays through Spring and Summer until Labor Day. We understand that this may be an inconvenience for some Al-Anon members, but the Board decided that this was the best possible option for getting Central Office financially solvent again. We truly hope that with the reduction in costs along with additional fundraising efforts, and increased contributions and literature sales that Central Office will return to standard operating hours in the Fall.

So please, support LA Intergroup and Central Office by attending our Spring Spaghetti Dinner Fundraiser on Sat, June 1 at the Covenant Presbyterian Church in Westchester. In addition, please remind your LA meetings how crucial it is to purchase their literature from our LA Central Office.

We discussed the possibility of GR's suggesting to their groups that information on the Beginner Meetings be incorporated into their meeting's format.

We examined group finances by referring to our service manuals and Guidelines 41, which included a financial inventory questionnaire. We reviewed annual SCWS, Intergroup and D57 contributions by groups. We created a contribution form now available to all our groups. The form has the current mailing addresses, along with the identification information needed, for the four service arms. We discussed autonomy as stated in Tradition 4 when deciding the amount of a group's contribution. However, a group decision not to support a specific service arm, after all group expenses have been paid, would affect Al-Anon as a whole and therefore is not a matter of group autonomy.

Our Public Outreach will be participating once again at a local school district Transition Fair, providing literature and information on both Al-Anon and Alateen.

We have now established district guidelines on SCAC scholarship funds and have asked our GR's to survey their meetings on member's needs and, interest in sponsoring, an Alateen meeting in the city of Long Beach.




