Alternate Delegate's report Committee Meeting February 15, 2014

The lion's share of effort I've made since the November Assembly was the TEAM event which was held at the Glendale United Methodist Church on Saturday, January 18, 2014. We had three people from World Service come help us with presentations: Ric B., Executive Director, WSO and Patrick Q., Public Outreach. We also had Marilyn M., Trustee from Western Canada present several sessions. In addition to thanking our delegate, Jayme C, for her help I would also like to thank Mary C. and her registration team and Cathy L. and her team who supervised catering and served the fantastic lunch we had at the TEAM event.

We had 365 Al-Anon members attend. According to our Hispanic Coordinator, about 90 of these members were Spanish-speaking—roughly 25% of the audience. About 50 of these members used the translation headphones and 40 listened in English.

Of those who attended, about two-thirds (roughly 240 people) filled out questionnaires. Reactions were overwhelmingly positive with 208 respondents checking "yes" for a favorable review of all sessions. Only 20 questionnaires had any "no" checked. Of this small minority who checked a "no," 15 of them were for the session on the Trustee Search. Interestingly, 10 of those respondents said that they could not be trustees—which might explain their lack of interest--but 5 said they could. However, it is important to note that among all 20 respondents who checked at least one "no" box, every single respondent also checked the boxes that indicated "it was worth their time and money" and that they "would attend another team event."

Here are some comments taken from the questionnaires:

A significant number of attendees commented that the day could have been shorter because there was so much information to absorb. Others mentioned that they would have enjoyed break-out groups. A number of people found the seats uncomfortable and some asked for more stretch breaks. Several people thanked us for the vegetarian lunch option. One member suggested that we note on the flyer that all Al-Anon members are invited, not just GRs. Another member suggested that the Spanish speakers using the headphones sit in one section because it was distracting sitting next to them and hearing the translation.

A significant percentage of respondents did not fill out the demographic information. However among those who did, except for the fact that 25% of attendees were Hispanic, the demographics of attendees closely reflect what we see in the Member Study on our WSO web site.

The majority of attendees—at least 80%--were women. The majority of attendees—women, men, English speaking and Spanish speaking—were over 50 years old. There were many centuries of Al-Anon experience, strength and hope in the room. The majority of people who attended had 5 years or more of membership in Al-Anon. There were very few newcomers but there were more than 40 Al-Anon members who had 20 or more years in the program. Perhaps at future TEAM events we should recognize these long timers in order to give encouragement to other attendees.

Thanks to those new District Representatives who attended the DR orientation before the Committee meeting. Thanks also to the Board members who attended and talked to our new DRs about Alateen requirements, finances and record keeping at the District level.

We will pass the Ask-It Basket around at this time. You'll see in the latest Bulletin that we had 11 pages of questions from the November Assembly. Now that the new Service Manual has been published we look forward to diving into the book to answer your questions.

We will also pass the Forum can around. Please put a dollar or more in the can, along with the form that has your name, address, and phone number or e-mail address. We need these filled out completely for the Forum subscription drawing. Please, as you meet with you GRs at District Meetings, impress upon them that the Forum is not just a magazine subscription that the meeting shares. GRs should encourage all Al-Anon members to buy their own subscription to the Forum.

## Treasurer Report

I want to continue to thank all the groups that are consistently sending in group contributions to Southern California World Service. Your group contributions allow SCWS to carry the message of Al-Anon Family Groups throughout Southern California.

Our 2014 contributions are up by 21.8% compared with 2013 YTD group contributions. I am I in the process of creating our budget for 2014 and will have it available at our May Assembly.

Reminder to all DRs & GRs: If you are driving over 100 miles to attend the Assembly, your meeting or district will reimburse you for the first 100 miles and SCWS reimburses you for miles exceeding 100 miles at forty cents a mile. All reimbursements are processed through our bank's bill pay system where the bank sends the reimbursement directly to the DR or GR at no cost to SCWS. Note the checks are only good for 90 days.

Reminder to Group Treasurers: When sending in your contributions to SCWS, please use the same Group ID assigned by WSO, versus the old numbering system. If you are not sure of your Group ID, contact our Group Records Coordinator, Chris. I have created a group contribution form, where the treasurer can download on to their computer and type directly on the form versus having to hand write the form. The form is also located on our SCWS website under "Forms."

Reminder: SCWS is no longer mailing receipts for Group Contributions. We are only sending them via e-mail. If your Treasurer is unable to provide an e-mail address, please have someone else be the recipient or create an free e-mail account for your meeting.

As we begin the final year of our Panel, it is still amazing to me how quickly the time has flown by. What a life -changing experience this service path has been for me. I'm so grateful that my Higher Power opened each door and because of your support I was able to go through at exactly the right time in my life. What a gift, for which I thank you.

Welcome to all the new Group Representatives here today. You have accepted one of the most important roles in your recovery in Al-Anon, which will change the way you see our program. Your group is part of a District, which is part of the Area, which is part the World Service Conference of the United States and Canada, which is the largest group conscience on the world.

As members, we have the responsibility to do our best to see that our program is not distorted or diluted by outside influences or perceived affiliations. The November 18 page in our book, *One Day at a Time* talks about this very thing.

It has been a privilege to be able to work with many of our Thought/Task Forces as we have learned the benefit of Knowledge-Based Decision Making (KBDM), where everyone has all the same facts and understands the issue before a vote is taken.

As a result of the ThF on Elections and voting we will be attempting to make the voting process much more efficient than in the past. You have given us permission to explore electronic voting, Officer job descriptions which provide a better understanding of each of the 5 Officer a positions including time commitment, clear descriptions of responsibilities and expectations. Also, standardized Officer Resume forms will be available on line. So if after becoming familiar with each position, and you think you are eligible and qualified, complete the resume form and submit it to the Immediate Past Delegate at or before the August Committee meeting. In the spirit of KBDM, the resumes will be posted online so that all voting members can have the opportunity to "meet the candidates" before the actual election.

## Online district records

DRs, please access your district's group records online via e-communities. Get id# and PW from WSO as a new DR ...WSO sends to all new DRs. Look at complete details. If you use the print icon, it only prints front sheet (so use File – Print instead). Export = same as download.

Save it as an excel file or word file or pdf. Give each GR a copy of their group's record to see if everything is correct. Does the group have a CMA? There are 57 meetings marked for deletion.

### **Resume form**

Why a reference to one's profession? First, the form is modeled after the Trustee resume form. Second, this (one's profession) is particularly relevant to the Treasurer. Most Areas have a resume form. Some Areas ask: "Does anyone know why this person should not be the delegate?," ...after candidates leave the room. They discuss whether the candidate is capable.

Anonymity of the person? Personal info will be removed before being posted on the website.

How can we provide the same information about a candidate that the Assembly is hiring to serve as an office of our non-profit corporation. Everything was phrased as-is, intentionally. The officer positions require so much more energy, time, commitment, skill, knowledge. Purposely wrote those questions so that applicants will think.

Submitted resumes will be posted before the election so that you will have the opportunity to contact that person if you want, and ask them some questions. "The first time I voted for a delegate was because I had seen her in a meeting. That's it." We were aiming to allow the Area can get to know the candidates better prior to the election. An officer candidate should be able to do most things in a competent way. The resume form was very well thought out, looks thorough, to the point, understandable. It's about Al-Anon first, it's about what we bring to Al-Anon.

Would you recommend working with a service sponsor in filling this out? Yes, it's a good idea. "When I was new, I voted for someone who was in my district just because I knew them, but I didn't know whether they were qualified.

One concern about posting in advance – stay away from popularity contest, from debate, from "electioneering".

## Electronic voting, demo.

Elizabeth, TF chair, ran a demo of an email system for electronic voting. Concensus: this system works well for everyone who could access their email, but 10% present could not access their email (could not get into WiFi or does not have a device with them for getting email).

What does a well-served group look like? Is your group well served?

## Ask IT Basket



Ask It Basket from the SCWS Committee Meeting February 15, 2014

- 1. Q. My service as a District Representative (DR) is about to end. Can I still attend Assemblies and Committee Meetings?
  - Yes, you may attend both events. However, unless you are a Group Representative (GR), you have no voice or vote. With a new Southern California World Service (SCWS) panel starting January 1, 2015, this would be an ideal time for you to consider serving on the SCWS Board either as a coordinator or an officer.
- 2. Q. Are we allowed to read the Al-Anon promises from our literature and "Letter from the Alcoholic?" Is it permitted to read the "12 Promises of AA" from the Big Book at our meetings? Our meeting does this before the closing. Does World Service have any other optional readings to recommend at the end of the meeting?
  - Al-Anon does not list anything in our literature as "promises", because the World Service Conference, Al-Anon's largest group conscience, has not designated anything as such. In recent years, some individual members have titled and labeled one such passage without permission as "The Promises of Al-Anon". This is a violation of the copyright. This action on the part of a few has given some members the mistaken impression that our fellowship as a whole has elevated this except to the level of importance accorded our Steps, Traditions and Concepts of Service. A request was submitted a few years ago for the Policy Committee to consider this sharing as the Al-Anon promises. After much thought and thorough discussion, it was the consensus of the Policy Committee that Al-Anon has no "promises".
  - The "Letter from the Alcoholic" is from our Conference Approved Literature. It is in the pamphlet "Three Views" (P-15). Conference Approved Literature (CAL) can be read at any Al-Anon Meeting. It is not permitted to read A.A. literature or any other outside literature at Al-Anon meetings. On page 104 of our "Al-Anon/Alateen Service Manual 2014-2017" it states: "To keep Al-Anon's message in focus and encourage unity, only Al-Anon/Alateen Conference Approved Literature (CAL) and Al-Anon/Alateen service tools are displayed, distributed, and used at Al-Anon and Alateen meetings, including meetings at conferences and conventions."

If you have any questions you need answered, bring them to the Committee meeting in Feb. or May at the assembly. They will be "answered possibly at the meetings, and always all are included in the bulletin. (Printed and online)."

## Ask IT Basket —-page 2



Conference Approved Literature came about from discussions held in 1961 at Al-Anon's very first World Service Conference. At the time, groups were using whatever material they considered helpful. Many local groups and service structures were writing and distributing their own literature, which varied widely in quality and content. Other groups were using more and more outside literature, much of which did not reflect Al-Anon philosophy. These pieces were sometimes religious in tone, or one person's opinion of what to do to "fix" the alcoholic. As a result, great disparity existed from meeting to meeting.

At that first Conference, our cofounder, Lois W., described why we needed a process for Conference approval:

You see, this whole idea of the Conference is to continue Al-Anon into the future, in usefulness and in unity. The matter of unity is why we should have Conference Approved Literature, so that sometime one part of the country doesn't get a particular slant and go off on its own way while another section goes another way—all under the name of Al-Anon.

A motion to have Conference Approved Literature was **unanimously carried**, so that Al-Anon literature would consistently reflect Al-Anon principles.

In 1962, the existing literature at Headquarters was reviewed by the Literature Committee and unanimously grandfathered by the Conference as Conference Approved Literature. A motion was also unanimously carried that year "that all present urge groups to follow the original Twelve Steps and Traditions and to use Conference Approved Literature."

The suggested Al-Anon Closing which is listed on page 22 of the Service Manual is the recommended closing at Al-Anon meetings.

- 3. Q. Use of last names seems to have become the default at Committee meetings and Assemblies. Isn't it better to let each individual use or not use their last name but for us to remember not to divulge someone's last name, for example, when reading winners of the Forum can subscriptions at the Assembly?
  - A. The new 2014-17 Service Manual discusses Al-Anon member anonymity in depth on pages 91-94. They start off by distinguishing three elements: "anonymity as it applies outside Al-Anon/Alateen, governing our contacts with the general public, the media, and professionals; anonymity within the fellowship; and anonymity as it contributes to our personal growth."

Your concern here is with the second element—anonymity within the fellowship. On page 92 we read: "Members use their full names within the fellowship when they wish. The degree of anonymity a member chooses (first name, pseudonym, or full name) is not subject to criticism. Each member has the right to decide."

## Ask IT Basket—-page 3



- 4. Q. How do we get people to stop knitting at a meeting?
  - On page 54 of the Service Manual it states: "Groups are within their autonomy to establish group behavioral guidelines in a manner that reflects their group conscience and abides by the traditions." If some members find another member's knitting distracting, the Group can have a group conscience to discuss the issue. Also on page 54 we read: "This can be an exercise in applying Al-Anon principles so that the message is not a personal attack, but rather a request based on what is best for the Al-Anon group."
- 5. Q. How do meetings get support for panels at facilities when Intergroup won't support us with literature?
- If a group wants to participate in Al-Anon panels at a rehabilitation facility, it is up to the Group Conscience to approve spending the Group's surplus money on literature. Intergroups cannot afford to provide free literature for individual Al-Anon group public outreach work.
- 6. Q. How do we support our Literature Distribution Center (Intergroup) when their books are outrageously expensive? We can't buy Courage to Change for less than \$20. We go to neighboring areas to keep it reasonable.
  - Intergroups buy Al-Anon Conference Approved Literature and sell it at a modest mark up. Any profit they make goes to support office rent, employee salaries and other expenses. If groups go to other Areas, or buy literature from other countries, the local Intergroup loses its primary source of revenue and its very existence may be endangered. We need to support our local Intergroups so that they can continue to provide literature to groups, publish meeting directories, operate Al-Anon information lines and perform various public outreach activities to carry the message to people in our neighborhoods who need Al-Anon.
- 7. Q. Is WSO working on a process to provide liability insurance for individual groups? More and more facilities where groups meet are requesting liability insurance.
  - This issue is addressed on page 59 of the new Service Manual. We read there that "The US and Canadian laws do not allow for the WSO to provide blanket insurance coverage for groups and service arms." The paragraph goes on to say: "Paying for insurance should not jeopardize the group's ability to fulfill the spirit of the Traditions and support the Al-Anon and Alateen services arms. If a group is not able to take care of its immediate needs, it may need to reconsider its choice of meeting location.
- 8. Q. A person in our meeting wrote slogans and what they mean on the back of our group phone list. Some of the slogans are sayings that she picked up from other sources and are not Al-Anon slogans. What do we do?

## Ask IT Basket—-page 4



This Al-Anon member should not be printing out and distributing slogans that are not Al-Anon Conference Approved Literature. And she absolutely should not be adding her own commentary. The best approach would be for your group to have a Group Conscience and point out that only Al-Anon slogans should be used at Al-Anon meetings. The Al-Anon members should be told, kindly, that members, while free to talk about their thoughts and feelings about particular Al-Anon slogans during meetings, should not be writing them down and sharing them with other members. Please also read the answer in question #2 above regarding the use of Conference Approved Literature (CAL) in our meetings.

- 9. Q. What can be done about chanting at meetings? Our GR has told the group that the WSO discourages chanting at meetings but our group continues to do it.
  - A. There is no official policy regarding chants; how groups close their meetings is the decision of an informed group conscience. The only reference to the closing at the end of a meeting in the *Al*□*Anon/Alateen Service Manual* is the **Suggested Al**□**Anon/Alateen Closing** on page 22 of the new Service Manual. It also states at the end of the **Suggested Closing**: "It is suggested that groups close in a manner that is agreeable to the group conscience. Many groups say the *Al-Anon Declaration after their closing*."

Some additional things to think about regarding "chants":

Chants are not part of Al-Anon and came into the program from treatment centers and other 12 Step programs.

When looking at the faces of newcomers when members are chanting and pumping their arms, they are clearly left out of the process.

Such chants and behaviors may reinforce the idea that Al-Anon is a cult when we know that it isn't nor do we want it to be perceived to be.

Alateen, a part of Al-Anon, is for young people whose lives have been affected by someone else's drinking. Every Alateen group needs an active, adult member of Al-Anon to serve as the sponsor.

Alateen is a fellowship of young Al-Anon members, usually 12 to 21 years old, whose lives have been affected by someone's else's drinking. In Southern California you can also find young Alateen meetings usually for Al-Anon members aged 6 to 12.

## WSO- Tips on how KBDM works

# **Knowledge-Based Decision-Making KBDM Quick Reference Tool**

The essential elements of the KBDM process are:

- Open communication between all members
- Ask questions & gather information
- All decision-makers have common access to full information
- Dialogue *before* deliberation and decision
- Process can take more than one session. It may span over several meetings,
   Assemblies or other gatherings with discussions and questions continuing until everyone has the information they need to move forward.
- We exist in a culture of trust.

#### How It Works (What do we actually do?)

The issue is first "framed" or introduced by someone familiar with the topic. Then we thoroughly explore the topic *prior* to deciding what to do about it.

- 1. Information Exchange—everyone has access to the same:
  - Printed material (e.g. Service Manual, past motions, archives from meeting, etc.), and
  - Together, we answer the 5 KBDM questions (below) (or this can be assigned to a Thought Force)
- 2. Discussion
  - Discussion and opinions are based on information and on experience.
  - Additional questions may be asked at this time.
- 3. Summarize the discussion—assure that information, concerns, and opinions have been aired and heard, including minority opinions.
- 4. Make a Decision (3 possibilities)
  - a. Further research may be needed about the issue.
  - b. Suggestion/Motion may be made (e.g. informal show of hands, or motion/second, if large group)
  - C. Status Quo (leave as is).

(After our best efforts to answer these questions, and through listening with open minds and hearts, we make a decision and trust in ourselves and our Higher Power.)

## WSO- Tips on how KBDM works

### **Five KBDM Questions**

The answers to the questions below can provide a basis for discussion. They provide common information so everyone can be on the same page.

- Gather information to these questions
- Everyone can add to them
- Opinions are backed up by experience, principles or knowledge.
- 1. What do we know about our members' (and prospective members') needs, wants and preferences that relate to this issue?

(What purpose would this serve? Is it necessary? Is it helpful?)

2. What do we know about the resources and our vision for Al-Anon and our meetings that are relevant to this issue?

(What are our resources? Can we afford it? Do we have enough volunteers to make it happen? Do we have any background information in our archives that can help us answer this question?)

- 3. What do we know about our "culture" and "environment" that is relevant to this discussion? What are the implications of our choices: the pros and cons? (How would this affect our meeting? How would this affect our fellowship? Newcomers? Al-Anon(and A.A.) as a whole? The advantages of this change might be... The disadvantages might be...)
- 4. What are the ethical implications of our choices? In other words--Will our decision be consistent with our spiritual principles, policies, and the Twelve Steps, Traditions, and Concepts?

(What are the ethical implications of our choices? Is our decision legal? Are our decisions within our spiritual principles, policies, and legacies? Does our Service Manual provide any guidance about this issue? Will our decisions help us fulfill our primary purpose? If we decide to take an action, will it be the "right" thing to do?)

5. What do we wish we knew, but don't?

(We might need to do some additional work or research to help us make a sound decision.)

(After our best efforts to answer these questions, and through listening with open minds and hearts, we make a decision and trust in ourselves and our Higher Power.)





#### (3) AMIAS Contact List



#### **Group Records Report**

My name is Chris C. and I am the Group Records Coordinator.

We currently have 1236 Active Groups in Southern California. This is an increase of 6 new meetings since January 2014. There are 38 groups listed with "No Mail" as their addresses are not current and they are not receiving "The Forum" magazine or group information via mail or email updates as well.

All of the Intergroup offices have agreed that each meeting needs to be registered with WSO prior to being listed in the local directory. This may have something to do with the fact that we have registered over 60 new meetings this year!

With reference to the 38 "no mail" meetings, I have sent an email to several of the groups with a very limited response to my request. This is down from I believe 67 meetings!

Please note that it is the responsibility of the Group Representative to update the Group Records Coordinator with the current information. I would like to encourage everyone to go to the SCWS website <a href="http://scws-al-anon.org/send\_mtg\_record\_updates.php">http://scws-al-anon.org/send\_mtg\_record\_updates.php</a> to update your meeting or to register a new meeting. This way you save yourself the cost of the stamp and the WSO Office in Virginia Beach is updated as well, so there is no longer a need to notify WSO in Virginia Beach, VA as we work on the same database going online to update information or to add a meeting is the quickest and easiest way to update the Group Records.

When completing the Information form, please make sure to add your **full name and address including your zip code**.

This information is very important, in that the database can only assign you to one meeting as a Group Representative. I have had to spend many hours making phone calls and sending emails just to find out the Group Representative full name and address.

I take this commitment to my heart and want to do the best job I can. However, when I only receive half of the information I need, it is very frustrating on my end in that I cannot complete my job. If I do call you and leave a message via voice mail or email, please be courteous enough to return my call or email.

During a telephone conference with other group coordinators, it was strongly suggested by the WSO that all groups update their records, even if the information has not changed.

Verification of e-mail addresses has become essential and should be accomplished on a regular basis since the WSO and Areas are increasingly communicating electronically with the groups. WSO has requested that members **not** use their work email address for their group. It was suggested during a recent telephone conference with other Group Records Coordinators that a group can have their own email address through gmail.com or yahoo.com. If a birthdate is needed for the application of the email address, it was suggested to use Lois birthdate of March 4<sup>th</sup> and the year 1951 for year Al-Anon started, ie, the birthdate would be 3/4/1951.


Please make sure that your Current Mailing Address (CMA) for your meeting is updated. The CMA receives all mail from WSO as well as the "Forum".

#### 2/15/14 Committee Report – Institutions

Hi all,

Since I last reported, I got to participate in the TEAM event in January. The three local Public Outreach Coordinators got to share about Public Outreach projects which were successful and projects we would like some assistance with. The project I would like assistance with is something I started at the holidays in 2012 and continued during the past holiday season. With the help of District 27 and two of the meetings I attend, we ordered Al-Anon Faces Alcoholism to distribute in the waiting rooms for visiting at the Los Angeles County Jails. LA County has the largest local jail system in the country, with 18,000 inmates at any given time. With many of those inmates stories involving the disease of alcoholism, and with every alcoholic's behavior affecting ten other people, imagine the number of people passing through those visiting rooms who have been affected by the disease of alcoholism.

I made trips to LA Men's Central Jail and the Twin Towers each weekend during the holiday season and each week, those rooms were more and more crowded. Another member who visits the jails on a regular basis, distributed AFAs to some of the other five facilities in LA County. The Area Board decided to help out and contributed to the February order of AFAs for this purpose. We will need volunteers to help distribute them after they arrive sometime this spring. Volunteers signed up at the TEAM event to help in the distribution and in other Institutions service. If you are looking for an outreach project to further your personal recovery, perhaps you would like to initiate a similar project in your county's jails or with the advocates in your county's victims' assistance program, or a treatment program that helped get you to Al-Anon?

If your group or district wants to get involved in service at Institutions, which could involve jails, prisons, hospitals, or treatment facilities, one of my meetings and the district simply had a group conscience to use some of our resources to order AFAs, my other group is following the lead of Northern California, and passing a "pink can" for Institutions with the seventh tradition basket that goes around each week. When the order deadline comes in February and July, we order whatever the collection will buy. I brought a couple of examples of the "pink can" with me. If there is interest, I can try to bring a supply of these to Assembly for groups to collect for Institutions Outreach. If you wonder why you don't see more newcomers at your meeting, remember that newcomers need to be introduced to Al-Anon and that's what Outreach is for. What introduced you to Al-Anon?

I have been attending the planning meetings for the 2014 AA Hospitals and Institutions Conference with Al-Anon participation to be held April 25,26 and 27 at the Holiday Inn, La Mirada. Our luncheon speaker is scheduled to be Rafael M. from Santa Ana. Rafael found Al-Anon at the Al-Anon meetings inside Folsom State Prison. You may have read a share from him in the Forum a couple of years ago. We are hoping to have some counselors from one of the "co-dependent" treatment centers and a judge on the Al-Anon panel. Please come join us and get inspired by the experience, strength and hope of other members in Institutions service and by the many panels on the AA brand of service, which we can learn from and tailor to our primary purpose. I've put fliers for the Conference in the District Rep's envelopes.

I recently was contacted by World Service re a call they received from Charter Oaks Hospital in Covina. They would like an Al-Anon panel on an on-going basis on Tuesday and Thursday evenings. I am trying to coordinate with the district and the LA County Intergroup to find members who would like to coordinate and/or participate in these panels for Charter Oaks.


As I go into my last year of this commitment, I want to thank the Board for giving me this opportunity. It's been very rewarding and, as every service commitment, a great learning and growth experience.


