

SCWS Committee Meeting Minutes

Saturday, February 21, 2015

9:00 am – 4:00 pm

**Chair**, CB S. read from pg. 162 of the 2014-2017 Al-Anon/Alateen Service Manual that the World Service Committee's purpose is to plan for the Area and the general improvement of both the Assembly and the Groups.

**Delegate**, Elizabeth K.

**Treasurer**, Eva B. and Christy R. did audit report; motion to approve audit made by Marlene M. from District 60 and Michelle M. San Diego Liaison seconded audit motion; motion passed. Bruce G. DR 24 made motion to accept Treasurer's report; Sandy M., DR 51 seconded and motion passed.

**Secretary**, Sandy P. Approval of August 2014 Committee meeting minutes with motion made by Marie T., DR 40 and seconded by Richard R., DR 27. Motion passed.

**Immediate Past Delegate**, Jayme C., talked about being in charge of all the Thought Forces (ThF) and Task Forces (TF). See Bulletin for full Report. Jayme asked for a consensus about using clickers at the May Assembly. The vote was unanimous.

**Chair**, CB – Reminder to DRs to check the folders on the long table by the window for flyers to share with their GRs

**Chair**, CB – Announcement to DRs to let their GRs know that the placement of chairs will be different at the May Assembly. Chairs will be set theatre style, making easy access to mic (like November 2014 Assembly).

**Break**

**Discussion Items/New Business**

**Records Secretary**, Donna E. – Talked about the idea of creating a Universal Group Update Form which is essentially the GR-1 form on the website.

**Alternate Delegate**, Kathi M. discussed Ask-It Basket – The Area often doesn't have time to respond to Ask-It Basket questions during Committee and Assembly meetings. They are in the Bulletin; however, some people don't read the Bulletin. Kathi M. polled other Areas to find out who is still using Ask-It Basket questions: Eight of them are using Ask-It Basket Questions and two are not. All eight read the questions at the Assembly but not the Area Committee meetings. Some Areas answer the questions orally at the meeting and five print out the answer; they have different ways of doing it. Kathi M. wanted feedback from the DRS, so she polled the DRs. Susie E., DR 9, loves the Ask-It Basket; she passes it around in her district meeting. Blanca M., ADR 48, does the same thing. Marlene M., DR 60, reads the questions to the district during their meeting. DR 69 has Ask-It Basket at their district meeting and thinks the questions and answers are very useful. Michelle M., S.D. Liaison, says it provides an anonymous way to get answers. Dan P., Archives, thinks the questions should be interspersed throughout the day. More prefer the Ask-It Basket in writing. Do you like the idea of answering orally interspersed?

Those who like to hear them prefer the questions and answers interspersed.

**Secretary**, Sandy P. presented framing document regarding proposed motion to audio tape record Committee Meetings and Assemblies (see Bulletin for entire context of Framing Document). She emphasized the recording would be used solely to create more accurate minutes and after the minutes were finalized and approved, the tape would be erased. The cost would be minimal and under \$200. Discussion ensued. The majority of members liked the idea and there were no oppositions. Christy R. made the following motion: That we audiotape the Committee meetings in the future according to the framing document presented by the Secretary. Bruce G. seconded the motion. Motion passed unanimously. CB S. asked those present how many agreed to recommend to the Assembly that the Assembly be recorded and that was also unanimous.

**Past Delegate**, Jayme C., presented updated information about Thought Forces and Task Forces in CA South: There are many responsibilities yet to be accomplished and conversations to continue in the next three years. These are the current forces: (1) Bylaw Changes Task Force; (2) Task Force on Live Scan; (3) Task Force on Changing the Age of Alateens, Over-nighters and Special Needs in CA(S); (4) District 64 Task Force; (5) Task Force on Groups Who Do Not Follow Traditions; (6) SCAC Work Group; and (7) Election Procedures/Electronic Voting. (See Bulletin for details of Jayme C.'s Report).

**Discussion:** There was discussion, questions and comments that ensued. Cathleen C. says there is good representation for special needs Alateens and explained that special needs could mean autism, hearing difficulty, multiple possible reasons for needing an aid, and that it's a work-in-progress. Christy R. was concerned about anonymity if aids go to SCAC. One member wanted to know if anything is going to go to vote at the Assembly in May and what is likely to go forward; Jayme C. will get back to that member. Dan P. pointed out that we must respect the Americans with Disabilities Act.

**Kathi M. addressed Live Scan** – our Bylaws don't designate how we do a background check. We are moving forward in the direction of Live Scan. Not necessary to come to the Assembly for vote unless budget is impacted. Eva B. reminded the Committee that Live Scan is overseen by the Department of Justice and involves filling out many forms – a layer of regulatory requirements. Dan P. says government has very tight regulations.

**Discussion Continued:** Jayme C. mentioned that the District 64 Task Force is in progress and not yet ready to present to the Assembly. Regarding Task Force on groups that do not abide by traditions: Christy R. is concerned about it being weighted toward OC. Sandie E., Chairman of Thought Force clarified that it is weighted toward groups with practices that are not consistent with Al-Anon traditions. Jayme C. mentioned that the SCAC work group is always full and well attended. A question came up about redistricting– has it fallen by the wayside? Jayme C. explained it has been delayed because of the District 64 Task Force.

The answers varied: Scan and shred; don't know; send to AAPP for confirmation, then shred; forward to AAPP and then they are

shredded; processed and held in confidential file; give to DAL; scan and send by email, then keep in hard copy file.

## **Question Proposed to DRs by Tarisa R.:**

**What is your district's process in order to sign off the AMIAS documents if you don't know the applicant?**

One-third of DRs are new, so Tarisa R. wanted to clarify the process for them. Each district is autonomous. If you don't know the applicant, how do you sign off the applicant? One DR talked to applicant and asked who sponsor was; another DR talked to sponsor, signed off form with asterisk to indicate they had talked to sponsor; Alateen Coordinator meets with them or gets a reference; another DR said DAL takes care of everything; some did not know and need to check; call delegate; talk to person; one DR doesn't sign off if she doesn't know the applicant; one DR goes to meeting where applicant says they attend and asks for reference; ask for a reference; meet them for coffee; Elizabeth K. suggests not asking Applicant directly who their sponsor is, as it is private information – it is sufficient to ask someone for a reference and they can choose whomever to list, without specifically asking them who is their sponsor.

## **Break**

**Delegate. Discussion about service participation by members of Al-Anon Family Groups who are also members of Alcoholics Anonymous.** Updated wording on p. 82 and 126 in Service Manual, approved by the 2014 World Service Conference, clarifies existing policy and does not change existing policy. In *Many Voices, One Journey*, Lois W. quotes Bill W. about the source of this policy. On p. 184 it says: "Lois Wilson made one of her most forceful comments on this issue at the 1976 World Service Conference. 'Although I've said a lot about how much Al-Anon owes to AA, and how our principles have really been copied from AA... one of the things that Bill said was, "Be sure to not let the

AAs get into your service structure, because they will take over, and we would have two AA service structures.'" – which isn't what we want.' See Delegate's report.

**Added Agenda Item – Delegate, Elizabeth K – Updates to the descriptive text on Concepts Eight and Eleven in "Al-Anon's Twelve Concepts of Service" in the Service Manual.** (See Bulletin for full Report)

Elizabeth K. read the proposed changes to Concept Eight and Concept Eleven sent to her from the WSO. The Policy Committee wants our feedback on their proposed changes, to be included in discussions at the 2015 WSC – this is how we become part of the worldwide group conscience on changes to the Service Manual. Elizabeth K. will email all suggestions and questions to the WSO for inclusion in material to be discussed at the WSC

## **Forum and Ask-It Basket questions**

**Kathi M. and Forum winner.** Elizabeth K. drew name. The winner was Christy R. Kathi M. read Ask-It Basket questions.

## **Bits and Pieces**

**SCAC fundraising.** Cathleen C. discussed bus transportation to SCAC and funding for SCAC and for the bus. Meeting at lunch at the Assembly. (See Bulletin for full Report).

**Past Delegate.** Jayme C. stated that if we were to use theatre style seating, perhaps we could have a friendly competition among the districts for outstanding signage (signs, hats, colors, etc.) in order to let the GRs easily find the district when they come into the room.

Clarification that when the AA H&I Conference is on the same day as the May Assembly, SCWS therefore would do not participate, as is the case this year.

# Delegate's

# Report

Greetings! This is year 55, "Panel 55," of the continuing conversation at the World Service Conference (WSC). Lois and others in the Al-Anon Clearinghouse (later also called the World Service Office, the WSO) had been polling groups for years and there came to be so many groups that polling wasn't working for them any more. To have a more effective conversation among the groups, they started the World Service Conference. Panel 1 started in 1961 with the 3 most populous states in each of the 4 quadrants of North America. Each year 3 new states were added to each quadrant until there came to be 67 Areas in the U.S., Canada, Puerto Rico and Bermuda represented by a Delegate.

I am on Panel 55, Jayme was Panel 52, Sandie was Panel 49, ...etc., all the way back to Panel 1. Thus, California is one of the first 12 Areas to be represented by a Delegate at the WSC in 1961.

By gradually adding Areas and splitting 6 of them into 2 Areas each, we now have 1/3 of the Delegates in their first year, 1/3 in their second year and 1/3 in their third year. They give the first-year Delegates plenty of excellent training for the WSC.

1. Lots of emails with files to read, including the Executive Director's Annual Report, 44 pages, which will be discussed at the WSC.
2. Conference call for new Delegates with WSO staff member and Trustees
3. Call from my Conference Mentor, a third-year Delegate
4. Call with a Trustee, the same Trustee this year that Jayme had last year; which Trustee is paired up with me rotates each year
5. SWRDM, Southwest Regional Delegates Meeting in March
6. A 3-hour Conference Orientation meeting on Day 1 of the WSC, with 5 intense, 12-hr days of business at the largest, worldwide group conscience in Al-Anon.

We work on Thought Forces (ThF), Task Forces (TF), Committees and/or Work Groups. We read about each ahead of time and submit our requests for which to be on. We do lots of KBDM (Knowledge-Based Decision Making) on the issues studied by each ThF or TF.

At the WSC, Delegates discuss and give traditional approval of policy in the Service Manual, with the statements of policy having been made by the WSO Policy Committee (see the description in Concept Eleven, Service Manual p. 209) and the Board of Trustees gives legal approval at their Annual Meeting. Note that the WSO implements Policy, but does not make Policy.

**This year's Conference theme** was provided in the header for the article on p. 18 of the January Forum magazine: **Living Our Spiritual Principles: Expanding Our Vision**. In this article, the Chair of this year's World Service Conference, relates this year's theme to her personal Al-Anon story.

I am so excited to be going to the World Service Conference, to pay attention all week, Sun – Thurs, April 19 – 23, to participate in KBDM as we all look out for the good of Al-Anon.

You can help me to give SMALL tokens of love from CA(S) to the other WSConference members by sending **Love Gifts** to me at the Conference address in Virginia, to be distributed to the other 105 WSConference members. PLEASE SEE THE FLYER ON THE SCWS WEBSITE FOR ADDRESS AND DETAILS ON MAILING THEM TO THE CONFERENCE LOCATION. Packages must arrive between April 15 and 22. They do not accept packages prior to the 15<sup>th</sup> and they will send packages back if they arrive after we have left (so put the Delegate's address as the return address).

The **AA International Convention with Al-Anon Participation will be in Atlanta, GA, this year, July 2-5**. The Convention registration fee is \$100 now, goes up in May. The Area Delegate attends the International Convention that occurs during her/his term, therefore I will

attend the 2015 AA International Convention. Jayme attended the 2013 Al-Anon International Convention. The next Delegate will attend the 2018 Al-Anon International Convention in Baltimore, MD.

Did you complete the **2015 MEMBER SURVEY**? The Member Survey occurs once every 3 years. The deadline is tomorrow, Sunday Feb 22, 9pm our time. Please email all of the GRs in your district TONIGHT, asking them to complete it if they haven't done so already.

Did you print the **updated pages 82, 83 and 126 of the 2014-2017 Service Manual** from the Members Website and tape them into your Service Manual? Please ask the GRs in your district to do that if they haven't done it already, and to announce it at their Al-Anon groups. The Delegates at the 2014 WSC voted to approve this policy, which was *after* the Service Manual was printed. Having the technology of the Website allows us to incorporate the official updates into our own 2014-2017 Service Manual NOW, the old-fashioned way, by cut and paste, with an arts and crafts project!

Let us read together the new descriptive text on p. 82, 83 and 126, projected on the screen for us from the Members Website at today's Committee meeting.

Naturally, during the KBDM process that resulted in the updated descriptive text, there is a reoccurring question that came up (like an FAQ). I will read out loud today the answer to the following **reoccurring question** from December 6, 2013, which Jayme also read to us at the August 2014 Committee meeting:

**Question: A member wants to serve as Group Representative (GR), and says they are no longer a member of A.A. The policy is that members of Al-Anon who are also members of A.A. are not to serve as GR, District Representative (DR), Delegate, etc. Is this person considered a dual member?**

Please also read the KBDM material that went into the decision-making process. See the Conference Summaries from 2011, 2013, 2014 on

the Members Website to see the progression. These Summaries show how much KBDM was done on this topic.

2011, p. 49-51, ThF on How to Include Dual Members in Service Work While Maintaining Our Policies

2013, p. 65-66, TF on Piece with Criteria to Help Service Arms Identify Service Jobs for Dual Members.

2014, p. 53-57, Policy Discussion – Dual Members. Included is discussion about if an Al-Anon member, who is no longer a member of A.A., seeks or is holding an Al-Anon service position that votes in matters affecting another group of Al-Anon or A.A. as a whole. It also discusses where the Policy or idea came from ("Bill W. was concerned that having A.A. members in two fellowships could bring A.A. into controversy and having A.A. members voting on positions that might put Al-Anon in opposition to A.A.'s policy could leave or give the appearance of conflict in A.A. and he asked that a member of Al-Anon who is also a member of A.A. not be allowed to vote in the Al-Anon structure in ways that could create conflict"). See also WSC Motion #6 on p. 90 of the 2014 Conference Summary.

All who attend the Southwest Regional Delegates Meeting (SWRDM) participate in detailed discussions in breakout groups by service position. In 2014 the breakout groups were focused on the Policy Discussion of Dual Members policy that was to be held at the 2014 WSC. CA(S) was represented at all four 2014 breakout groups: Delegate, Alternate Delegate, Chair and Officer/Coordinator. The Delegates wanted the policy text to be positive, clear, and conveyed in a spiritual manner. The Alternate Delegates saw the language as inclusive and encouraging to Al-Anon members who also are members of AA to bring the Al-Anon message to situations (i.e., closed AA mtgs) where non-AA members cannot go. The Area Chairs discussed policy voice with regard to dual members. As an Area Officer (Secretary) in 2014, I went to SWRDM at my own expense and

participated in the Officer/Coordinator breakout group, in which we generated a list of how each Tradition applies to the proposed modified text. Our list was sent to the Board of Trustees for their consideration in the KBDM for the Policy Discussion.

The Board of Trustees approved the clarifications to the descriptive text on Concepts Eight and Eleven in "Al-Anon's Twelve Concepts of

Service" given in the Service Manual. The text was updated to reflect the current World Service Office structure while preserving information that is helpful to Area and international structures that continue to use the former structure. Delegates are asked to discuss the motion text in their Areas and send any questions or comments to the Board of Trustees by March 27, 2015, so we will spend time this afternoon going over the changes, one by one, line by line. In this manner, the SCWS Committee can generate questions and comments as part of the KBDM process.

The Policy Committee and the Board of Trustees WANT OUR FEEDBACK! All of the questions and comments from Committee members today will be sent ahead of time to the Board of Trustees for consideration in the KBDM discussion at the WSC, and then voted on by the Delegates at the 2015 WSC. ...This is how WE DO HAVE AN IMPACT ON POLICY. Policy does come from the groups through input from you whom the GRs elected and input from the GRs. The groups elect trusted servants, who in turn elect other trusted servants, who themselves elect other trusted servants. ...and ALL of them can be recalled if the groups believe that they are not doing their jobs properly.

Thank you, everyone, for your kind attention to all the material in this report and especially your focused attention to the discussion of the clarifications to the descriptive text on Concepts Eight and Eleven that were approved by the Board of Trustees at the January 2015 Board meeting, that we will be discussing for a possible final approval by the Delegates at the 2015 World Service Conference.

# Alternate Delegate's Report

## Greetings

I am very happy and grateful to be addressing you as your new Alternate Delegate.

All Districts were emailed the information regarding the first new DR orientation for panel 55. This Orientation was conducted this morning before the Committee Meeting. We were lucky to have our new Delegate, Elizabeth; our new Area Alateen Process Person (AAPP), Tarisa; our new Alateen Sponsor Coordinator, Cathleen; our new Group Records Coordinator, Donna; and our New Treasurer Eva to present information and to answer questions from all 10 new DR's.

One of my primary jobs as Alternate Delegate is to be the Forum Coordinator for our Area. This is a job I share with all the GR's who are the forum representatives for their meetings. The total number of Forum subscriptions for the United States and Canada for 2014 was 20,269.

The total number of Forum subscription for CA for 2014 was 2512. Unfortunately WSO doesn't separate CA (S) and CA (N). But this number still shows that CA as a whole represents 12.39% of all subscriptions in the US and Canada for 2014. The 2<sup>nd</sup> place state has only 5.6%. It's nice to know that our state is still leading in Forum subscriptions but when I looked back at previous reports I realized that the total subscriptions for California have dropped by more than 100 over the last three years. I'd like us to find a way to increase those numbers once again.

Forum can was passed. Received enough money for one subscription. Christy R won the subscription.

I'm also responsible for the "Ask It Basket" Questions and we will be discussing that more

later. See "Ask It Basket" question presentation and discussion following.

"Ask it Basket" was passed. We received 5 questions. One question fell under the jurisdiction of the Alateen Task Force and was handed over to that group to include in their discussion. The other four questions were read at the Assembly, answers will appear in the Bulletin.

And let's not forget our annual SOS. That also falls under my responsibilities. Tim and the Districts did an outstanding job last month and I want to thank all of those who participated. I thought it was a huge success and a great way to start off the year and our new panel. Over the next three years we hope to have another TEAM event, possibly in 2017. I'm open to hear topics you'd like to have presented at the SOS next year. And of course I'm open to districts that want to volunteer to participate.

*Let's talk about it: Is answering "Ask-it Basket" questions still valuable to SCWS?  
Valuable to SCWS ...*

Here in CA(S), we've been using Ask it Basket Questions for a lot of years. Looking on the SCWS Website, I found Ask It Basket Questions in the Bulletin back to May 2003. I personally remember answering Ask It Basket Questions in 2000 and 2001. Back then the questions were usually answered at the Assembly. In more recent years, because of time constraints, the answers are researched and then included in the

Bulletin. It was suggested at the Board Meeting that we bring this item to the Committee Meeting for discussion. Are we happy with the process we've been using or is it time to consider if we want to continue using Ask it Basket Questions and if we do, do we want to consider different possibilities for answering them?

In light of this suggestion, I reached out to Current and Past Delegates in other Areas.

10 Areas responded. 8 continue to use Ask it basket, 2 areas do not. The 8 areas that continue to use Ask it Basket questions, do so at Assembly. Only 3 areas use them at AWSC. 7 Areas present the Ask it basket questions orally at the meeting and 5 print the reports. Only one Area prints the answers to the questions without having given the answers orally at the meeting. There are a number of different ways the questions are answered: One area has their districts take turns answering the questions at an open mike at the Assembly. They use any CAL that they can find the answer in. Several areas uses their Past Delegates to answer the questions, one uses their current delegate to review the questions and ask the most relevant person to answer and one uses their Alternate Delegate (much as we do) to review the questions and assign them to Officers or Coordinators to answer. Generally all areas stated they use the Service Manual to assist in answering the questions.

There are also different ways the answers are presented orally: Most areas used time near the end of the meeting, but one answers questions throughout the meeting. Most areas print the answers in their area newsletters, but one simply includes them in their minutes (which may or may not be printed in the

newsletter) and another sends the answer by email directly to the individual who asked the question.

The two areas that answered and no longer use Ask It Basket questions stated they refer people to their Service Sponsor, DR, Coordinators, Officers to ask questions directly.

So, now I would like to open up the discussion and see what you have to say....

Is the "Ask It Basket" still valuable?

*Who questions the previous AA member about their history to serve in Al-Anon? DRs, GRs, Dist Officers, SCWS Officers?*

The updated policy states: "Accordingly, Al-Anon's policy is that members who are also members of A.A. do not serve as Group Representative (GR), District Representative (DR), Area Delegate, World Service Conference member, alternate to any of these service positions, or on any committee of the World Service Office. Filling service positions is a matter of district and Area autonomy, within this policy and the spiritual principles that form its basis. Tradition Four grants autonomy to local service arms, except in matters affecting Al-Anon or A.A. as a whole. Al-Anon members who are also members of A.A. participate fully in all group activities, including group conscience decisions. However, they do not hold Al-Anon service positions that vote in matters affecting another group or Al-Anon or A.A. as a whole..."

## Knowledge-Based Decision-Making *Background and Rationale*



**Summary:** Knowledge-Based Decision-Making means information gathering and discussion *before* a possible solution is crafted and a decision is made.

### The essential elements of the KBDM process are:

- Open communication between all members.
- Dialogue *before* deliberation and decision.
- All decision-makers have common access to full information.
- The idea that everyone participates is a spiritual principle. The KBDM process models this principle.
- Opinions are backed up by experience, principles, or knowledge.
- We are all equal and everyone is valuable. We respect all ideas and do not tolerate domination.
- We speak and listen in a culture of trust and good will.

### Why it is a good model (from *Conference Summary*, 2006).

- It allows thorough examination of issues without an end in mind.
- It is not necessary to choose sides or develop evidence with an end in mind.
- It allows those who make the decision to become far less important than the fact that a good decision is made.
- The outcome is not as important as the way we got there (discussion and an environment that encourages healthy thinking).
- It provides for open dialogue, so everyone's needs are heard, expectations and preferences are acknowledged, and ethical dimensions are considered.
- How we talk and listen to each other is more important than the decision we come to. Our Higher Power is present in the process of speaking and listening.

### KBDM alignment with Al-Anon Principles

- Tradition #1: Our common welfare comes first; personal progress for the greatest number depends upon unity.
- Concept #4: Participation is the key to harmony.
- Concept #5: The rights of appeal and petition protect minorities and insure that they be heard.
- General Warranty #3: All decisions be reached by discussion, vote, and whenever possible, by unanimity.

### The benefits for our groups

- Group members are more likely to support the decision made.
- Group effort is more likely to yield better results.
- Participants become part of the process, more voices are heard, and more solutions are generated.
- There is recognition that responsibility for action rests on everyone.
- Actions tend to lean toward the greater good for the organization.
- Negativity is diffused.



# Knowledge-Based Decision-Making

## KBDM Quick Reference Tool



The essential elements of the KBDM process are:

- Open communication between all members
- All decision-makers have common access to full information
- Dialogue *before* deliberation and decision
- We exist in a culture of trust.

### How It Works (What do we actually *do*?)

The issue is first “framed” or introduced by someone familiar with the topic. Then we thoroughly explore the topic *prior* to deciding what to do about it.

1. Information Exchange—everyone has access to the same:
  - a. Printed material (e.g. *Service Manual*, past motions, archives from meeting, etc.), and
  - b. Together, we answer the 5 KBDM questions (below)
2. Discussion
  - a. Discussion and opinions are based on information already exchanged and on experience.
  - b. Additional questions may be asked at this time.
3. *Summarize* the discussion—assure that information, concerns, and opinions have been aired and heard, including minority opinions.
4. Make a Decision (3 possibilities)
  - a. Further research may be needed about the issue.
  - b. Suggestion/Motion may be made (e.g. informal show of hands, or motion/second, if large group)
  - c. Status Quo (leave as is).



# Knowledge-Based Decision-Making

## KBDM Quick Reference Tool



### Five KBDM Questions

The answers to the questions below can provide a basis for discussion. They provide common information so everyone can be on the same page.

- Gather information to these questions
- Everyone can add to them
- Opinions are backed up by experience, principles or knowledge.

- 1. What do we know about our members' (and prospective members') needs, wants and preferences that relate to this issue?**  
*(What purpose would this serve? Is it necessary? Is it helpful?)*
- 2. What do we know about the resources and our vision for Al-Anon and our meetings that are relevant to this issue?**  
*(What are our resources? Can we afford it? Do we have enough volunteers to make it happen? Do we have any background information in our archives that can help us answer this question?)*
- 3. What do we know about our “culture” and “environment” that is relevant to this discussion? What are the implications of our choices: the pros and cons?**  
*(How would this affect our meeting? How would this affect our fellowship? Newcomers? Al-Anon (and A.A.) as a whole? The advantages of this change might be. . . The disadvantages might be. . . )*
- 4. What are the ethical implications of our choices? In other words--Will our decision be consistent with our spiritual principles, policies, and the Twelve Steps, Traditions, and Concepts?**  
*(What are the ethical implications of our choices? Is our decision legal? Are our decisions within our spiritual principles, policies, and legacies? Does our Service Manual provide any guidance about this issue? Will our decisions help us fulfill our primary purpose? If we decide to take an action, will it be the “right” thing to do?)*
- 5. What do we wish we knew, but don't?**  
*(We might need to do some additional work or research to help us make a sound decision.)*

*(After our best efforts to answer these questions, and through listening with open minds and hearts, we make a decision and trust in ourselves and our Higher Power.)*

The SCWS Area Safety & Behavioral Requirements state, "An Alateen event is defined as any Alateen activity other than a registered meeting .... There must be two certified AMIASs who serve as the Alateen Event Sponsors. Overnight events must have at least one male and one female Alateen Event Sponsor .... The Event Chair *or other responsible party* must submit a completed Alateen Event Plan to the Area Alateen Sponsor Coordinator at least 30 days before the event (*60 days before overnight events*) for approval .... Any event without an approved Event Plan will not be able to use the Alateen name in conjunction with the event." This also means that the event cannot be publicized at Alateen/Al-Anon meetings or functions. Clarification: The Event Chair responsible for completing the Event Plan should be the Alateen Chair or Alateen Committee member in charge of the planning the event. Event Sponsors should oversee the process, but, rather than create the Event Plan, should work with the Alateen Chair and Committee to "coach" on how to properly complete the plan.

**Alateen Event Plans, including SCAC events, must receive approval prior to being posted on the Area's Alateen Event Page.** Once approved the flyer and permission & medical consent form will be posted to the Alateen Event page. Once approved and posted on this page, the Alateen Event may be publicized. This

includes handing out flyers at Alateen/Al-Anon meetings/events. FYI – I am willing to create the Permission & Medical Consent form for any Alateen Event because I have software which allows me to do so easily. I can take the information from the completed Event Plan to create this form. I am currently working with Alateen Committees to streamline and expedite the approval process without jeopardizing safety factors.

**Area Alateen Task Force:** The Area is currently finalizing members to be a part of this task force. The Task Force will have representatives who are either AMIASs or Alateens. The charge for this Task Force is: “Look at the age of Alateens in CA(S) and the overnights.” This charge was a recommendation from the Area Alateen Safety & Behavioral Task Force. The new Area Board decided to add an additional charge to this Task Force during their January 2015 meeting due to inquiries made from several Alateen meetings or districts. This additional charge is: “Should SCWS Area allow non-Al-Anon and non-AMIAS individuals to be present at Alateen meetings/events for the sole purpose of providing aid to a special needs Alateen member?”

These groups have a Current Mailing Address (CMA) and/or a Group Representative (GR).

"No Mail" - current number: 76

If there is neither a CMA nor a GR for a group, they go into *No Mail* status.

"Inactive" - Currently 253

After 2 years, of *No Mail*, a group becomes *Inactive*. They stay *Inactive* for 3 years, if there are no financial contributions made to or from the group. If there is a financial contribution made, the group may be *Inactive* for up to 7 years. After those lengths of time, a group is *Marked for Deletion*.

"Marked for Deletion" - Currently 66

In the first quarter of the year, these meetings are deleted from the WSO database. Their identification numbers are retired and cannot be re-used.

#### **#2: SCWS Website for Forms**

*Please use our SCWS website to fill out any group records changes that pertain to the SCWS/WSO information flow: DR, Alternate DR, GR, and Alternate GR, CMA, and up to 2 Contacts. Most of the forms on the site are now "fillable".*

#### **#3 Creating a Universal Groups Update Form**

We're at the beginning stages of creating this form so that our members will have one form to fill out for *all* of the service positions listed above. It will be the responsibility of the entity that receives the form to route it to the appropriate service arm (the local AIS or SCWS). We've contacted all of the Intergroups, which have expressed an interest in doing this. The next step is creating a committee from among Intergroup webmasters or others to research how other Areas with several Intergroups/AIS' have solved this problem. Therefore the Al-Anon member who is, or was also a member of AA, could be approached by anyone who is aware of his/her membership. That could be a member at a meeting, a GR or DR or any District Officer at a District Meeting, or one of the SCWS Officers at an Assembly. And certainly help addressing the individual can be requested from any of those positions.

### Question/Answer #2:

*2a) Can WSO delist an Intergroup when it is not following the 12 Traditions?*

*2b) How do WS Districts support LDCs or Intergroups not practicing Traditions?*

*2c) What recourse do the groups have when the Traditions are not followed by Intergroup?*

Service Manual pg 64. "Any local Al-Anon or Alateen group may agree to support an Information Service, but joining is purely voluntary. The Information Service is supported by the groups it serves within its geographical boundaries; ...." Through Tradition Two the groups, through their representatives use the group conscience to keep "Intergroup" following traditions. Districts and Intergroups are parallel entities. In some instances Intergroups/LDCs are composed of more than one district. In other Intergroups/LDCs – there is only one district involved. In other Areas, some districts are not part of any Intergroup. There are not specific requirements for how districts support or interact with Intergroups or LDCs.

It is the responsibility of the members to hold the Intergroup to the requirement of following the Traditions.

## **Public Outreach and Institutions:**

*Institutions:* Two years ago we circulated a questionnaire asking our members about outreach at the district level. Our members ranked outreach to hospitals and institutions as one of their two highest priorities (along with outreach to schools in our district.) Although our members consider hospital and institutional outreach important, we have not found a way to provide consistent outreach to these facilities in the past.

Our attempts to provide panels at several treatment centers were suspended because of low

member participation on a regular basis.

So we're trying a different approach. Starting on Friday, March 20<sup>th</sup> from 6 – 7:30pm, we will launch a literature-based Al-Anon meeting with a special time set aside for beginners at CRI-Help, a treatment center in North Hollywood.

In addition to addressing our interest in serving one of the institutions in our district, this meeting also fills another gap: we currently have no beginners meeting listed in our district. By providing a regular meeting with a time for beginners in this location, we hope to serve the needs of both current and prospective members and provide a more reliable and consistent way of reaching out to this treatment center. Given this, our district decided to provide start-up funds for the purchase of literature for this meeting.

*A District Map Challenge:* We decided we needed to compile a list of hospitals, institutions, and schools in our district as a starting place for organizing our outreach work. That meant we needed an easy-to-use map of our District. So far, we haven't found one. The map on the SCWS website cannot be printed out as just a map of District 21 and getting the accurate boundaries is a time-consuming effort. It would be great if these district maps could be in a more user-friendly – and perhaps printable form – on the website.

*Schools:* This is the other form of service our members asked that we focus on. We are starting to compile a list of schools and colleges in our district. Our next step will be information-gathering to find out what, if anything, schools might want from Al-Anon members willing to do t

this kind of service. We figure this phase will take the rest of the calendar year.

*Organization of public outreach to hospitals & institutions:* We have decided to restructure the coordination roles of our outreach efforts in the quest to make these commitments “right sized.”

We now have a Public Outreach Coordinator overseeing all of our outreach efforts and we soon hope to have coordinators for each of our areas of concentration: schools, hospitals & institutions, & events. We'll let you know how this goes. progresses.

### **A requests from our groups:**

A couple of our meetings are balking at reading directly from the *Service Manual* and/or *Groups at Work* (P-24 – the “small” *Service Manual*). They find that photocopied versions of CAL in handout form makes leaders less nervous as they don't have to go searching for page numbers.

We have communicated that:

a) the *Service Manual* specifically forbids the reprinting of CAL for anything other than one-time use (page 106 - so the meetings that use photocopied or typed handouts appear, technically, to be in violation of copyright law) and

b) Ric B. (WSO Executive Director) gave a longer and more detailed commentary on this issue at this link <http://www.al-anonuk.org.uk/faq-frequently-asked-questions-wso-world-service-office-cal-conference-approved-literature/reprint>

c) There are many solutions other meetings have found (like putting the page numbers in the leader's format, tabbing and labeling the pages in the books, etc.)

However, one meeting has asked if we might initiate the request for new CAL to be created that might specifically and constructively address this issue: one-sheet versions of the suggested opening, closing, Steps & Traditions – printed with the Al-Anon logo, perhaps on the back side, so it is clearly identified as CAL. The request is that it be in a form that could fit easily in a 3-ring binder and hold-up better than the *Service Manual* when handled by many people over time, meaning perhaps on heavy stock or plastic laminate or suitable for a plastic cover sheet. It was further suggested that this could be an additional source of revenue for Al-Anon as a significant portion of our revenue comes from literature sales. This might be quite a popular item if offered for sale.

As the representative of our District, our next step will be to find out how to advance this request.

**Alateen:** (from Tina S. DAL—Dist 21)

Within the geographic area of District 21, there are 4 Alateen meetings but two of those meetings have chosen to be part of District 64 as the Al-Anon meetings they co-exist with are in that district.

Of the two remaining meetings in District 21, the Saturday 11:30 North Hollywood meeting has seen a big drop in attendance in the last few months due to a few Alateens aging out and some families moving out of the area. We intend to ask our new Public Outreach coordinator to help us reach out to local schools near the meeting location. We'll report back on the results of this.

Our Sunday 5:00pm Young Alateen meeting is

alive and growing. They're about to change up their format, "to make it more interesting."

Alateens in our district continue to collect recyclable plastic, glass, and cans to raise funds for SCAC 2015. District 21 members are regularly dropping off bags of cans and bottles. Since August 2014, our district has collected over \$600. We had carried over \$500 from SCAC 2014 so we already have over \$1100 for SCAC scholarships and transportation.

A challenge: my term is up as DAL but, so far, no one has stepped up to fill this critical position. We have decided to add an Alternate DAL so someone can have time to get comfortable with the position before stepping into the DAL. We have yet to fill either position but we are hopeful!

The duties are: 1) to recruit new AMIASs, 2) to keep accurate lists of current certified AMIASs, 3) to support our current sponsors and substitutes by keeping them informed especially about certification and recertification workshops, 4) to work with District 17 and District 24 to support and organize the AMIAS Recertification Workshop and to organize yearly "Meet and Greet" get togethers for sponsors so they can share their experience, strength and hope and get to know each other better and, finally, 5) to be available should any of the Alateen meetings or their sponsors need to reason any issues out.

### **Change of Service:**

## **Orange County Intergroup Liaison Report** Serving Orange County and Greater Long Beach

**INSURANCE** — The Intergroup has been able to arrange for meetings to be covered by the Intergroup's insurance policy, subject to such policy restrictions as the serving of alcohol. The coverage is at no cost to the meeting, unless the meeting requires a document verifying that it has coverage. When such proof is required by

a meeting, the meeting is charged a \$50 fee. The policy does not cover retreats or non-Al-Anon meetings in which Al-Anon members participate.

The coverage resulted when a meeting was facing loss of its meeting place because insurance was required as a condition of rental. A task force was formed, options were studied, and coverage was put in place.


Subject: Annual Audit for the Year Ended December 31, 2014
