

Welcome/Chair Report-CB S.-Recognition of New DRs and Past Delegates.

Roll Call - Jayme C., Immediate Past Delegate (in absence of Group Records Coordinator)

Officer Reports:

Secretary - Approval of Minutes 8/20/16 XXX made the motion to approve the August 20, 2016 minutes: seconded by XXXX. Minutes Approved unanimously.

Alternate Delegate Report:

Ask-It-Basket/Forum Can - Both to be passed.

Treasurer:

Annual Audit for the Year Ended December 31, 2016 Christy R. read her Auditor's report.

February 1st.

Balance Sheet as well as Income and Expenses. Random testing of cash deposits and disbursements. All looked good. Reconciliation- Furniture listed – All is available in her report. Results have been given to all officers and Immediate Past Delegate.

The Treasurer presented the 2016 year end financials, which were reviewed in detail: Reconciliation, Balance Sheet, Profit and Loss, Income/Expenses.

Questions:

- Q. What are the SCWS monies being held for? We need to ensure that the SCWS committee knows the projects our body is committed to and ensure that we not hold extra monies beyond ample reserves.
- A. Point of order to address that all questions/comments be brought to the mic.
- A. The three CD's comprise the ample reserves of our budget, \$30,000. The checking account covers all the current expenses and costs of running SCWS

Motion by Lalena Dist. 12, to accept the budget and to accept the final report for the 2016 Financials.

2nd- Dist. 42- Ana. Unanimously approved/ No abstentions

Immediate Past Delegate:

Reviewed the "World Service Conference Rules"

Gave an update on Task Forces.

Task force on Groups not serving Al-Anon as a whole was brought up by a District's letter that was sent to SCWS.

- Q. What is the update on SCAC? Is it going to happen this year?
- A. The Alateen Resolution Committee is looking at the 6-page document produced by the Alateen Restructuring Work Group to be sure that details of all prudent safety aspects have been considered and included. We do not know how long that process will take. Reminder that all fundraising and preparations for SCAC may not occur until the suspension has been lifted.
- Q. The district has been determining which groups are part of D64, which turns out to be far less than previously stated. It is likely to be more like 60 groups in D64 rather than 150. They are contacting all the groups in Spanish to evaluate this.
- A. Contact the Group Records Coordinator to find out which meetings are officially listed in D64.
- Q. Will the new DR for D64 be added to the TF on D64?
- A. This will be determined at the next meeting of the TF.

Delegate Report:

Drawing for Conference Summary among the 8 first-time AWSC members here today, to be held at the end of the AWSC meeting.

Comments and questions:

- Q. What are the reasons for declining literature sales?
- A. It began in 2014 and we are not sure yet why. All authorized online sales of downloadable CAL bring some income to the WSO. Buying from another country brings us no income, nor do discount resale shops, whether online or in person. Membership is holding steady. Do newer members have a library? Do meetings have an array of CAL for members to see and consider buying, or only the daily readers? There are small meetings with only 5 regular members that have built up a collection of CAL for sale at their meeting. It is possible.
- Q: You visited many districts last year. Do you want to do that again this year?
- A. Invite me!
- Q. How to address a member who brings a topic to the district meeting with little facts, just opinion. For example, the handout about the wages of the Executives at the WSO, which came more as an attack than as a point of conversation for the GRs.
- A. At the 2016 World Service Conference, they provided us with a report from an independent consultant that provides current WSO wages and how those salaries compare with comparable positions in the area.
- Q. Can we get a printed report at the Committee meeting, so we do not have to go to the website and print it ourselves?
- Q. Courage to Change, page 103. Will the prayer be removed from this book?

- A. No decision has been made. Whatever is decided (leave it as is, change some wording, remove it completely, replace it with something else) would be done in all pieces of CAL in which it appears.
- Q. Our AIS/LDC is redoing the website. Can we sell CAL from our website?
- A. Yes. You are part of the service structure as an approved LDC. It is in the autonomy of the LDC to arrange a mechanism for paying for online purchases.
- Q. Our district is very close to Mexico, where the cost of literature is about half. Members go across the border to buy their CAL there.
- A. Each country that has a legal agreement with the WSO to reprint and sell CAL, is allowed to sell only to members in that country. If members here go to another country to buy literature, then they are not supporting our own service structures, which is not being fully self-supporting. Defending our copyrights is an important function of a department in the WSO. Any GSO (which is the WSO in any other country) signs a legal agreement indicating that they understand that if they sell to others who are not citizens of their country, that their license to reprint and sell CAL is at risk.
- Q. If the prayer on the Just for Today bookmark is removed, will God and other religious references be removed?
- A. The suggestion by the Literature Committee is specifically only about the Prayer for Today that some members believe contains specific religious tenet. The Serenity Prayer is general and does not contain specific religious tenet and is not part of that suggestion. Removing the word God is not in question and is conjecture by some members. In fact, since this word is contained in the Steps, which only can be changed by written vote of ¾ of registered groups worldwide, this does not seem to be a realistic possibility.

Alateen Sponsor Coordinator Tarisa-

KBDM- Live Scan

Discussion:

AMIAS- Alateen Members Involved in Alateen Service.

- There is ongoing training and all must attend a 4-hour session annually. Networking and information is presented and conveyed in small groups. May 31st is the deadline for each year.
- IF you do not attend one of these workshops, you need to be certified all over again. If so, then as of June 1 you cannot sponsor a meeting any more or do any of the AMIAS duties until you go through the background check again and certify again.

Discussion:

- Q. Does live scan ask for a SSN? Also, she said most medical professionals must have live scan. Isn't it more in depth and avoids the fake driver's license or fake SSN?
- A. Some locations require it.
- Q. How many AMIAS do not provide SSNs?

- A. At least ½ do not provide it.
- Q. Where do I find Form 1?
- A. Only those who attend the training get one.
- Q. I do not like giving out my SSN.
- A. 4 digits cannot be used, must be complete number.
- Q. His members want to know what SCWS will do with the SSN.
- A. Only the AAPP person sees it. The AAPP processes it and it is kept in a file in their possession.
- Q. Argument is that the SSNs are going to the Department of Justice. We have members who are worried about that their anonymity is at stake.
- Q. Feels more is needed. How are we verifying that the matching ID and SSN are the same? What is our incident rate?
- A. The insurance company requires a thorough background check
- Q. I would like my children to have an AMIAS serving the group who has had a relevant background check completed.
- Q. If we use live scan, then all my records and info comes back to SCWS AAPP. It is updated as I live.
- Q. We could have periodic fundraisers for live scan fees. Our goal is to keep our Alateens safe. Believes the individual needs to pay for the new background check if their certification lapses and they have to go through the certification again. For those who do not have SSN, there are other service positions they can hold. It is important to know who our children are being supervised by, and for them to have the correct level of background check. We do not need to accommodate every person.
- Q. People buck the system. The recertification workshop is 4 hours. People who want it badly enough, will show up.
- Q. I have been in the program for 20 plus years. My 3rd-7th year I was an Alateen sponsor. The SCWS board today is addressing the board's need to factor in social media that did not exist in my early years. It is all about the protection of our young people in this fellowship.

Conclusion: use Live Scan

\$49.00 per person plus the rolling fee. Certifix is the company chosen so far.

New Policy

Review and implementation Southern California Policy for Resolving Group and Members Concerns

Marley- Dist. Rep-21/Task Force Member reviewed Policy Preamble and The Policy.

We were the seventh area to make a policy. Where does this policy come out of? The results coming from this group was from 18 months of reviewing all literature for information on this topic.

Mary-Dist. 57- Task Force Member reviewed "How the Policy Works"

Situations covered by this Policy include remarkable instances of dictatorial, as well as therapists who charge for meetings.

Note that it seems that education is what will be needed in most cases to abide by these policies.

Billy M. – District 36 – Task Force Member reviewed "How to report a concern," including the email address and the physical address.

If the resolution committee cannot complete this process, it will go to the Delegate, Alternate Delegate and Immediate Past Delegate in the next term.

The Task Force has completed their task. They were charged with nothing more than creating the Policy.

Not all group concerns need to go to the Area Resolution Committee. Steps to be taken are laid out in the Policy. If that does not resolve the concern, then the Area Resolution Committee would be contacted by email or my sending a concern to the permanent mailing address for SCWS (in Cypress, CA).

Task force members have been to San Diego, Inland Empire and OC AIS to cover this policy. L.A. is in the near future. Spanish had to be translated and will be brought to them soon. Ventura County is March 16th.

Comments/Discussion

- Q. If an issue is brought forward and it is deemed educational, is there any follow-up and by whom??
- A. The panel envisioned archiving the issues as issues come in.

- Q. When a group gets to the place where you have to delist or relist? How is it going to be communicated to the members and the different areas?
- A. The Implementation of this Policy is up to the SCWS board.

 Using the flowchart as a guide, the groups are only listed in one AIS and the task force felt all who would be affected by this would all be kept in the loop. It was not built into the policy to address this, so the issue will be addressed as the implementation happens in the future.
- Q. His Dist. felt like their GRs present at the Nov 2016 Assembly did not get a KBDM format to understand this policy. They felt rushed into making a decision on the Policy for Groups Who Do Not Consider Al-Anon As A Whole because they wanted to bring it back to their groups to discuss it first
- A. Please see page 63 in the Service Manual. Also see the GR role and the delegate role on Pg 172. The letter was not actually a "minority appeal" because that point already was brought up in the discussion at the Nov 2016 Assembly. The vote to approve the Policy came out with a vote large enough to pass. There was no new information presented in the appeal, so it actually is not a minority appeal. Simply disagreeing with the outcome of the vote does not make it a minority appeal. There must be new information in the appeal that was not part of the original discussion in order for it to be a minority appeal.
- A. The right of decision making makes effective leadership possible. The GRs are the trusted servants who have been elected by their group to make a decision as their trusted servant, based on the information presented.
- Q. The first vote was the vote spoken of. That is the one where the GRs in our district felt like they were being be listed with the WSO. They can be an Al-Anon member to serve in any position. The WSO will be covering this in 2017 at the Conference. forced with no clear message of the reason for the vote.
- A. The point that was not clarified before the first vote is that the vote on whether the Assembly is ready to vote is approved only by simple majority (not 2/3 vote), whereas it is the vote on approving the policy that is approved by 2/3 vote.
- Q. What does Do Not Refer mean? How are they still with a voice and vote at the Assembly and the committee meeting?
- A. The only autonomy the area has is to put them in a directory or not. The WSO is the only one who can assign the name "Al-Anon" to a meeting.
- Q. What does Do Not Refer mean? How are they still with a voice and vote at the Assembly and the committee meeting?
- A. The only autonomy the area has is to put them in a directory or not. The WSO is the only one who can assign the name "Al-Anon" to a meeting. They will still be listed with the WSO. They can be an Al-Anon member to serve in any position. The WSO will be covering this in 2017 at the Conference.

- A. Sometimes the discussions at Assemblies and the Conference are less than perfect. Over time, the process will be better defined.
- Q. Felt unclear on what the vote was about and abstained. We did not have enough information at our disposal
- Q. When a meeting prefers to use the older versions of literature, rather than current literature. Past DR's have said it is group autonomy.
- A. This Policy is about not referring newcomers and members to meetings.
- A. We can use any literature we choose in our own lives outside of meetings. In meetings, however, the latest versions of CAL is used, including pamphlets.
- A. Any changes in Literature content requires a 2/3 vote by the WSO Literature Committee or Conference.

Q. The vacancy for CPC. Is it to be brought to a vote? A. The position is appointed.

Questions asked on Alateen

- Q. How do we know if Alateen has been approved for participation at a convention or an event?
- A. The indication that the event plan for a convention or event has been approved is that the permission form is posted on the SCWS website. Misunderstanding for SFVAAC: Fundraiser approval does not mean convention approval. The brochure for the SFVAAC Convention brochure should not have had "Alateen" printed on the cover because the Event Plan had not yet been approved, only the fundraiser had been approved. Specific wording FOR THE INSIDE OF ANY BROCHURE has been approved (available from the Alateen Sponsor Coordinator). Convention chairs should be sure this wording is used, and that "Alateen" should not be printed on the cover.
- Q. Has the SCAC committee met yet and how can groups get prepared?
- A. They have met twice. Once in January and once yesterday. An answer may come in April.
- Q. A flyer was sent from San Marcos. Are they holding a fundraiser for SCAC?
- A. No. They want to have an Alateen event in San Diego in case there isn't SCAC this year. They are having a fundraiser workshop on May 6 in Carlsbad.

The links of service give us a mechanism for observing Traditions One and Four, Unity and being careful not to make decisions in an Al-Anon group that affect Al-Anon as a whole.

Special Election May 2017

The original Alternate Delegate of this term was elected in Nov 2014. She stepped aside and an Interim Alternate Delegate was appointed. A second Alternate Delegate was elected at the Assembly in May 2016, and he stepped aside a few months later. A second Interim Alternate Delegate was appointed and a third election for Alternate Delegate will be held at the Assembly in May 2017.

We use Knowledge-Based Decision Making in the elections. The candidates and the voters (the registered Group Representatives) have a responsibility to become informed about the job description. The candidates have a responsibility to be honest with themselves and the Area about their qualifications and willingness to serve.

The voters have a responsibility to become informed about the candidates via their posted resumes. There is a requirement to have been a DR to stand for Alternate Delegate, which includes current DRs. For past DRs, how recently would we like them to have been a DR? The GRs will decide with their vote among the candidates. Candidates will submit a resume by 5pm on Sun Mar 19 to the Immediate Past Delegate and the Delegate. The resume form is on the SCWS website, in the Assembly presentations section.

WSO Budget

When we consider the WSO budget, members are interested in how their contributions are spent. This is found in the <u>Financial Information section on the WSO tab on the members website</u>. This page has the following several links.

- "How your \$15 is used." This shows relative expenses for: Volunteers, Member Services, the phone numbers, Communication Services, the World Service Conference, Public Service Announcements.
- "How the WSO Serves Your Group & You." This lists the many services provided by the 5 departments within the WSO: Group Services, Member Outreach, Public Outreach, Fellowship Communications, Administration and Business Services. The August 2016 and October 2016 Quarterly Appeal Letters also provided a listing of services provided by the WSO on the back of the letters.
- "Budget." On this link, we will find the 2016 budget for the WSO, listing all of the categories of expenses, including the total salaries of the 43 paid workers. The 2015 World Service Conference asked whether the paid workers are earning a fair wage. Consequently, the WSO hired an outside consultant, who provided the salary ranges of comparable positions in the Virginia Beach area. At the 2016 World Service Confer-

ence, we received these salary ranges for 3 different groupings of workers:

- 3 Executive / Directors / Professional
- 21 Supervisors / Associate Directors
- 19 Support Staff

So, there are 43 paid workers at the WSO. They receive voluntary benefits of health, dental, life insurance, pension, and long - and short-term disability. They also receive mandatory benefits of social security, unemployment insurance, and worker's compensation. Also included in benefits is the cost of post retirement health care for retirees.

Recall that Virginia Beach was one of several areas identified 20 years ago by a Task Force for the relocation of the WSO as affordable and otherwise suitable. At the 65th Anniversary Banquet, they reminded us that all the suitable cities were put into a hat, and Virginia Beach was pulled out of the hat. Virginia Beach is in the "Hampton Roads" area in Virginia, which also includes Norfolk, Newport News, Hampton, Portsmouth, Suffolk and Williamsburg.

• "U.S. Tax Returns." A member asked where can the salaries of the executives be found on the members website. These salaries for all corporations are required to be reported on the Tax Returns. The WSO Tax Return is found on the Financial Information link of the WSO tab on the members website.

The Executive Director retired early in 2016 after more than 20 years of service to the fellowship. An Interim Executive Director was hired on a part-time basis while the WSO is being reorganized. One example of some of the reorganization that already is in place, is that when the Director of Business Services (nonmember) retires, the person already hired to fill that role will be the Director of Finance. This is noted, with names, later in this report.

• "Audit." There is a lot of detailed financial information contained in the Audits. It has been such an education process for the Delegate to read every word and every number presented in the Audit each year. Among the many files sent by the WSO to the Delegates in Jan – Apr each year in preparation for the Conference Is the Audit. We are asked to submit our questions to the WSO by Mar 31. Answers are provided in writing on the day before the Conference starts. ...more homework after we arrive in Virginia Beach!

The Director of Business Services fully explains every paragraph of the Audit in a session of the Conference. He gives us such easy-to-understand explanations in these sessions each year. For example,

- •ASSETS = things of value LIABILITIES AND NET ASSETS = things we owe
- •UNRESTRICTED NET ASSETS = value of the organization
- •ACCRUAL BASIS = gets accounted for when transaction occurs, not when paid
- •REALIZED LOSS/GAIN = what happened when an investment actually was sold

- •UNREALIZED LOSS/GAIN = only on paper since the investment hasn't been sold; what the loss/gain would be if it were sold at the current market value
- "Audit." Click on that link. As of today, the 2016 Audit has not yet been sent to us, so let's look at the 2015 Audit. Page 13 provides the operating expenses for the services provided by 4 categories of services: Member Services, Communication Services, Literature Distribution Services, General Administration.

As you can see on that page, the <u>operating expenses</u> includes the salaries of the 43 paid workers, occupancy costs, packing and shipping, postage, telephone, stationery and supplies, outreach activities, office services and expenses, repairs and maintenance, travel and meetings, direct conference costs, professional fees, printing, Canadian office, office volunteers, public service announcements and miscellaneous expenses.

I wrote questions on these pages in Feb/Mar, made comparisons between pages, cross-referencing the same values when they appeared on multiple pages, answering many of my own questions. I submitted more than a dozen questions to the WSO. I added more notes during the Conference from the explanations by the Director of Business Services. In my first year, I was not experienced with these financial documents, but that is changing!

Answers to all questions submitted by all of the Delegates were provided upon our arrival in the registration room at the Conference. Answers were provided by staff and/or Trustees, depending on the question.

- 2015 WSO Budget. To understand what happened in 2016, let's look back to the 2015 WSO budget. We anticipated a decrease of \$10,000 in literature sales, but it turned out to be \$237,000 less. That is essentially a quarter of a million dollars less revenue in 2015 that continued in 2016 and into 2017.
- 2016 WSO Budget. The 2016 WSO budget had adjustments in it, based on what happened in 2015, to accommodate continuing trends. We expected the same level of decreased literature sales, and it turned out to happen. We planned to transfer a large amount, \$184,000, from the Reserves. The WSO Treasurer told us in each COB letter (Chairman of the Board) that transfers were made in the early part of the year to pay expenses. The 2016 WSO budget anticipated \$1.8 million in contributions, based on the increased contributions in 2014 and 2015.

Remember, sending smaller contributions to one service arm in order to send more to another is not an overall increase in donations.

• 2016 Contributions to the WSO. The exciting news is that our members responded to the information about decreased literature sales and inflation. [Inflation? It takes approx. \$9.73 to buy something today that cost only \$1 in the 1950s.] The WSO received \$1.6 million in contributions in 2015. The 2016 budget asked for \$1.8 million.

Members/groups/service arms/conventions contributed \$2.1 million in 2016. That is about \$300,000 more than the budget

asked for, and it is nearly \$450,000 more than in 2015.

Good work!!! We were fully self-supporting in 2016. This allowed us to pay back some of the transfers from the Reserves.

Analysis of CA(S) Group contributions to the WSO showed the following:

2014: \$93,406.43

2015: \$97,861.12 (That is \$4,400 more.) 2016: \$127,853.17 (That is \$30,000 more!!)

The groups in CA(S) donated \$30,000 more in 2016 than in 2015. In addition, because of generous contributions to SCWS from the groups, SCWS was able to send \$25,000 to the WSO in 2014, 2015 and 2016.

Further detail of analysis of the group contributions shows that approx 800 groups contributed to the WSO each year:

794 groups contributed in 2014 785 groups contributed in 2015 792 groups contributed in 2016

What is the frequency of contributions from each group? 588 groups contributed all 3 years.

204 groups contributed 2 years.

(Of these 204 groups, 80 contributed in 2014+2015. 124 contributed in 2015+2016 or 2014+2016.)

196 groups contributed 1 year.

(Of these 196 groups, 77 contributed only in 2014, 39 contributed only in 2015, and 80 contributed only in 2016.)

So, <u>588+204+196 = 988</u> groups contributed at least 1 of those 3 years and, 588+24+80=792 contributed in 2016

2017 WSO Budget. Literature sales are expected to continue at the lowered level in 2017 since they continued in 2016. We will expect this trend to continue until we see otherwise. As far as we know, we will need to maintain this increased level of contributions to pay for all the services that we ask we the WSO to provide.

Please remember that saying about,robbing Peter to pay Paul. All four service arms need us to continue contributing, to support the services they provide.

For many years the WSO income has been 2/3 from literature purchases and 1/3 from contributions. With *literature purchases continuing to be severely decreased*, so, too, do *contributions need to continue at the increased levels* in 2017 and beyond, to compensate for the substantial decrease in a major source of our self-funding.

Jan 2017 COB Letter

Chairman of the Board letter. •Members website • WSO tab • Board of Trustees • COB Letters (look for the hands typing on the keyboard to find the COB letters). There are four sections to the COB letters: 1. Board meeting 2. Policy Committee 3. Finance Committee 4. Conference Leadership Team (details about the Conference, mainly for the attendees)

• 1. Board Meeting. The current position of Director of Business Services will become Director of Finance. Both are required to be filled by a nonmember. The transition from one to the other already is in progress. Niketa B(CPA, Masters Degree in Accounting) was hired in the fall and started in Nov. David Zach will retire on Feb 24, which is this coming Friday.

Board week at the WSO in Virginia Beach started the day after we held the SOS here in Glendale. The Committees of the BOT (Board of Trustees) are described in the Service Manual in the text of Concept Eleven. The following Committees met in the Jan 2017 Board week: Nominating, Int'l Coordination, Finance, Executive, Policy, Conference Leadership Team, other Board Cmtees, Thought Forces, Task Forces. There was a strategic planning session with staff.

The Future: A major task of the Trustees is to think ahead to and plan for the future.

Convention. Al-Anon 6th International Convention in Baltimore, Maryland. July 6-8, 2018. Convention theme: "Celebrating One Day at a Time". 2018 is the 60th Anniversary of the ODAT book.

TEAM. Together Empowering Al-Anon Members. TEAM Events are partnerships between the Area and the WSO, who co-create and co-present topics that the Area requested. A maximum of 9 TEAM Events occur every year, and CA(S) was approved for Sept 16, 2017 in Glendale, which is the 3rd Saturday.

Road Trip! You and Your Board Connect. Sat Oct 21, 2017 BOT mtg (Board of Trustees) in Aurora, Colorado. This used to be called "Meet the Board". Both events (TEAM and Road Trip!) give members, Trustees and WSO staff a chance to meet and directly interact with each other.

Interim Actions of BOT. 1. Complimentary copies. In a costcutting action, the Board of Trustees voted to suspend complimentary copies of the Conference Summary and complimentary copies of the Service Manual. Service Manuals always will be provided free of cost to new groups. Both will remain available for purchase. 2. How Al-Anon Works, softcover version, was being produced on a trial basis. It was designed to be an outreach tool, but all members bought so many copies that it also became a real contributor to revenue. Therefore the trial has ended and the softcover version will continue to be produced.

Trustee selection process. The Board of Trustees (BOT) consists of 9 Trustees at Large and 9 Regional Trustees. There are 9 Regions: Canada, 3; U.S. West, 2; U.S. Central, 2; U.S. East, 2. Each year 3 Regions (on a schedule) elect a new Regional Trus-

2017: U.S. SW, NW and So Central. 2016: U.S. SE, NE and No Central.

2015: Canada West, East and Central.

Also, every year we elect 3 new Trustees at Large, the 3 Board officers, and 1 new member of the ECRPM, Executive Committee for Real Property Management.

The (CCT) Conference Committee on Trustees (Delegates) and the Nominating Committee (Trustees) evaluate the candidates' resumes, providing a score, comment and rank. The Nominating Committee consolidates the results and invites 2 candidates for each position to interview at the January BOT mtg. The entire BOT participates in selecting one candidate for each position, who are forwarded to the Conference for Affirmation (or not). The Board of Trustees elects the new Trustees in their Annual BOT meeting, held on the day after the Conference closes. All Conference members are invited to attend this meeting.

• 2. Policy Cmtee. The Policy Committee is updating 3 sections of the Policy Section of the Service Manual. We will discuss them at the Conference. At the end of each discussion, as with ALL discussions at the Conference, the Conference Chair will ask, "Are we ready to vote? Do we need more discussion or shall we stop discussion? More discussion this year or in the future?"

Financial Matters. The Policy Committee was asked by a previous Conference to edit the text in the Financial Matters section of the Policy section in the Service Manual, in order to incorporate spiritual principles.

Conventions and Other Events. A member (in CA-S) requested clarification of the Conventions and Other Events section because members are announcing events that are not sponsored by any service arm, and therefore they are not "Al-Anon" events" and thus they ought not to be announced. Just because an event is put on by Al-Anon members for Al-Anon members, it does not mean that it is an Al-Anon event. There must be accountability for the money raised and spent for the event. The Policy Committee is aiming to provide spiritual principles that characterize Al-Anon events, the criteria by which activites would be recognized as Al-Anon, and Guidelines for announcing conventions and events.

Open and Closed Mtgs. The Policy Committee has been researching the used of "open" and "closed" as meeting designations, and whether these terms have relevance today. They have been considering Tradition 5 (welcoming new members) and Tradition 11 (anonymity). These designations originated with AA when the non-member wives were attending the AA meetings, and AA members felt a need to have some meetings to themselves, without spouses.

3. Finance Cmtee. In 2016, the gross profit on literature sales was down from 2015 by \$108,000. The big news is that 2016 Contributions of \$2.1 million exceeded 2015 Contributions of \$1.65 million by \$449,000 which allowed money previously transferred from the Reserves to be returned. In 2016 there was an overall net increase in the General Fund of \$78,824.

Your announcements and the quarterly appeal letters really seem to have helped. Thank you!!

4. CLT. The Conference Leadership Team Update contains information that is of use mainly to the Conference members (Delegates, Trustees, WSO Staff), and of course all members are welcome to have this information. All 3rd-year Delegates will give a 3-min talk and the opening and closing speakers' talks all are based on the Conference theme. All of these talks will be printed in the Conference Summary. Previous issues are on the Members Website.

The WSC. The five days of the 2017 World Service Conference are April 24-28, Mon-Fri. The open Annual Board of Trustees meeting is Sat Apr 29. Meals are on a "regular" schedule with very nutritious food at all meals. Years ago, the SCWS Assembly very generously voted to allow the Delegate to arrive early and return later. This helps so much: it takes 12 hours door to door (no nonstop to the Norfolk airport). The current Delegate has her own body/brain requirements beyond those generous allowances, so she will be there even more days than that, at her own expense. We all get to take care of ourselves while being of service, but Trusted Servants are reimbursed only for reasonable expenses.

I carry all the meetings and members in my heart and mind, while at the Conference, being a part of making decisions that affect Al-Anon as a whole.

Districts Invite Delegate.

Thank you to all the districts who invited the Delegate to bring information from the Conference to your neck of the woods, and thank you to all the members who attended. All members of the fellowship were invited and many non-GRs attended. Most present at each workshop had not been to the May Assembly. The next (and final) Delegate workshop prior to the 2017 Conference will be in District 10 on Sat March 18.

We participated in knowledge-based decision making by hearing the views of the members who attended. First we "performed" the presentation and skit written by the Conference Task Force (TF) on Acceptance of Communities, Cultures and Beliefs. The discussions were lively and members expressed being very supportive of those from different backgrounds than theirs.

We also read and discussed the KBDM material provided by the WSC Literature Committee that they considered in making the suggestion to the Conference that it consider removing the Prayer for Today from CAL (in Just For Today bookmark and wallet card and in How Al-Anon Works). Then, breakout groups read answers to all five questions of KBDM written by the members of the Literature Committee, and discussed those responses and their own thoughts.

There were 3 categories of responses: 1. Leave it exactly as it is; 2. Remove it completely; 3. Remove only the words that indicate a specific religious belief: "and it is in dying that we are born to eternal life."

Recall that there was an attempt at a vote about these words at the Assembly in November, and the Assembly vigorously did not want to vote on it since we were talking about religion.

All the Delegates will bring the views of members in their Areas back to the Conference. We will discuss the topic again. We won't know till then if we will vote on it, or what the motion would be.

Immediate Past Delegate

Report for February 2017

Greetings Southern California Al-Anon and Alateen. I am very grateful to serve as your Immediate Past Delegate. In November the Group Representatives will be electing a new Delegate for CA(S) and our current Delegate, Elizabeth K. will be the next Immediate Past Delegate.

At all Assemblies and Area World Service Committee Meetings (AWSC) a status report will be provided of the on-going Task Forces in the Area. Currently, there are three Task Forces, one Work Group and we do not have any on-going Thought Forces.

The Task Force on the SCWS Bylaw update has begun. It is comprised of all the CA(S) past Delegates who are currently active. They are: Jayme C., Sandie E., Mary M., Miriam Mc., Kay D., Willie W. The charge is to assure that the SCWS Bylaws are current. The Task Force meets weekly via telephone conference calls. The updated SCWS Bylaw will be brought forward at the November Assembly for a vote of the Group Reps.

The Task Force on Live Scan has completed its charge. A recommendation from the Area Alateen Safety and Behavioral Guidelines Task Force was to consider other background check processes. Prior to August 2012, SCWS was using Megan's Law for background checks. Megan's Law only provided information if an applicant was a registered sex offender and no other felony convictions. Currently, we are using a background company called Trak-1. If a potential AMIAS provides their social security number an in-depth report is given to SCWS from Trak-1. If the potential AMIAS does not provide a social security number, the in-depth report is not provided.

SCWS has been approved by the Department of Justice (DOJ) for the use of Live Scan Background Checks. Many options have been researched and the discussion will occur today at the Area World Service Committee (AWSC) Meeting.

The Task Force on Changing the Age of Alateens, Overnighters and Special Needs was another recommendation of the Area Alateen Safety & Behavioral Requirements Task Force. This Task Force has not started yet.

The District 64 Task Force is an active working Task Force and they are working very hard toward a recommendation to the Assembly. This Task Force was initiated from the District 64 Thought Force. Their charge is to evaluate the 3 possibilities brought forth by the Thought Force. Those three possibilities are:

- 1 leave District 64 as is.
- 2 Have several overlay Spanish districts.
- 3 Have all the Spanish speaking Groups in District 64 aligned to their respective geographic districts.

This Task Force is on-going and has not made any recommendations or decisions yet. That information will be presented at a future Assembly.

The Task Force on Groups Who Do Not Consider Al-Anon as a Whole has completed their charge. The charge was to create a Policy for Groups who do not follow the Traditions or consider Al-Anon as a whole. Today we will review and help clarify the Policy to the District Representatives. We will discuss the infrastructure that has been put in place since the November Assembly. We will also discuss the following:

- 1 Role of the District Representative, Group Representative, AIS/Intergroup in resolving group and member concerns.
- 2 Types of issues that have been raised to date and how they have been dispositioned.
- 3 Answer District Rep, Group Rep, AIS/Intergroup role clarification questions .
- 4 Open additional policy related questions.
- In March the Southwest Regional Delegates Meeting (SWRDM) will be held in Denver, Colorado. The Area will send the Delegate, Alternate Delegate, Area Chair and I, the Immediate Past Delegate. We look forward to this meeting every year. The purpose of SWRDM is to bring together the Delegates of the Southwest Region preceding the World Service Conference to:
- 1 Welcome and support the new Delegates.
- 2 Provide current Delegates an opportunity to share Conference practices and procedures.
- 3 Help keep past delegates connected, involved and informed.

All discussions are designed to bring closer communication and understanding to our Southwest Region Al-Anon Delegates. I look forward to providing the highlights of SWRDM in my next report.

Ask-it-Basket

1. Q: Please explain the financial status of groups and districts. Are we non-profit? Do we need to file taxes of our income?

A: Service Manual p. 58 "It's important to note that individual Al-Anon and Alateen groups are not considered to be nonprofit organizations and they are not branches or chapters of the World Service Office. The WSO cannot give its non-profit number to local groups because the WSO has no authority over local group funds. Al-Anon and Alateen groups are autonomous in their financial matters. (See "Incorporation and Taxes" in the "Digest of Al-Anon and Alateen Policies section of the Al-Anon/Alateen Service Manual [P-24/27].) This is the same for SCWS and Intergroups. U.S. regulations do not contain provisions under which SCWS/Intergroups could apply for a blanket exemption for the individual Groups. SCWS/ Intergroups have no knowledge or control over Group funds and is not in a position to furnish the financial statements required to be filed annually with tax authorities in order to maintain tax-exempt status for groups.

Al-Anon groups and districts do not generate an "income" and do not file taxes. We are supported through donations from our members. We take care of the group's/district's expenses first and maintain an ample reserve. "Most groups do not accumulate money beyond current needs and a small reserve, with just enough funds to pay the GR expenses to Assembly and group expenses for a couple of months. This can be decided by making an informed group conscience

decision." (Service Manual p. 56) "Our Tradition of self-support suggests that the expenses for the group's operation such as rent, literature, insurance, supplies, post office box rental, Group Representative, and Information Service Representative expenses be met first. Remaining funds may be used to support local and Area structures and the World Service Office." (Service Manual p. 99) Please see Reserve Fund Guidelines G-41 for more information regarding ample reserve.

- Q: Please give suggestions about how to handle a member on a team obsessed about an issue even after the District's GRs either decided that they didn't agree or the service manual says it's against policy... or it's about WSO.
 - A. Gentle reminders such as Tradition One (Our common welfare should come first...), could be shared. Was there a discussion with a group conscience taken afterwards? The section on Group Conscience" in the Service Manual says (p. 53) "By sharing information as equals, taking time for discussion, and maintaining principles above personalities during the discussions, groups are often able to reach unanimity in their decisions. ... Once a group conscience decision is made, the entire group supports the decision. Concept Five tells us that members have the right of appeal. If a member disagrees with the outcome of a group conscience decision, they have the right to submit an appeal for reconsideration back to the body that made the decision. After an appeal is heard, regardless of whether the decision is maintained or altered, the individual accepts the group conscience." The "Group Problems and Solutions" section (Service Manual, p. 54) has more information, as well as the Conflict Resolution materials (S-71, S-72, S-73). The District Representative or chair of the meeting may need to remind the individual that this item was discussed and that it's time to move forward. If the team member is still having trouble accepting and letting go, they could write about their issue to their Delegate or directly to WSO & ask for clarification.
- 3. Q: RE: Dual membership and service commitments outside the group level. Our district has not addressed this issue. How do you bring it up after GRs & others have been serving?
 - A: The conversation could be started by saying "It's come to my attention that.....". There was a Policy update to our Service Manual April 2014 that is specific to this question. Check the WSO website (al-anon.org; members section Service Manual) to download/print these pages. (See: Service Participation by Members of Al-Anon Family Groups Who are Also Members of Alcoholics Anonymous, April 2014 changes to pages 82, 83, 126.) There is a "Full version interactive" Service Manual that can be downloaded, which includes all updates since the last printing. The explanation of the Policy is thorough and presented in a kind way. This could be a topic at the next District meeting, providing copies of these pages for discussion. It's helpful to stress the types of Al-Anon service that can be done by members of Alcoholics Anonymous
 - P. 126 "Al-Anon members who are also members of A.A. participate fully in all group activities, including group con-

science decisions. However, they do not hold Al-Anon service positions that vote in matters affecting another group or Al-Anon or A.A. as a whole." (As a GR, ISR their vote could affect another group.) "This policy on service participation by members of Al-Anon who are also A.A. members protects Al-Anon's viability as a program dedicated to helping the families and friends of alcoholics. It ensures that Al-Anon's service structure represents the unique perspective of families and friends of alcoholics, recognizing that the alcoholic's perspective is represented in A.A.'s service structure. Members honor this policy out of respect for Al-Anon unity and the group conscience process, in accordance with Tradition One and Tradition Two."

After this information is shared, the DR needs to ask the Al-Anon member who is also a member of A.A., to step down from their position beyond the group level.

- 4. Q: a. How best to encourage members to get into service?b. Best way to attract and encourage newcomers?c. "Adult only" meetings vs Al-Anon Family Groups?
 - A: a. "Service" is a great topic for a meeting. There are numerous references to "Service" throughout our literature, as well as "When I Got Busy I Got Better" (P-78). Rotation of leadership is vital to Al-Anon ("Three Obstacles to Success", Service Manual, p.24). "Rotation" can be discussed at a Business Meeting with experienced members offering to share a position with a new member while they are learning the job.
 - b. Some meetings have an advertised "Newcomer" time slot each week that is devoted to welcoming new members & providing basic Al-Anon information. Other groups take a few minutes during their meeting to focus on a piece of literature (such as "Al-Anon Is/Is Not" bookmark M-44) when there are newcomers. Having Newcomer Packets available to personally hand a new member, inviting them to ask questions after the meeting & to call members on the meeting's phone list is beneficial.
 - c. Is this question referring to adult children of alcoholics meetings? In the index of "Many Voices, One Journey" (B-31) under "Diversity" there are numerous pages referring to members who grew up in an alcoholic home. "The first Al-Anon adult children group registered in 1974, adding to a growing list of 'specialized groups'. (Many Voices...p. 175). In late 1976, early 1977 a separate organization specifically for adult children of alcoholics was formed. "Their autonomous choices would not affect the unity and integrity of Al-Anon as a whole because they did not identify themselves as an Al-Anon Family Group. However, as more independent groups for adult children formed, while others remained affiliated with Al-Anon, there was some confusion among members who did not know the difference." (Many Voices... p. 195-196) In the upcoming years there were many open discussion sessions at the World Service Conference on "Group Specialization-Children of Alcoholics' Groups" (Many Voices, p. 222) Conference Approved Literature was written specifically for those mem-

bers who grew up in alcoholic homes. (Al-Anon Sharings from Adult Children, P-47, Did You Grow Up with a Problem Drinker? S-25; From Survival to Recovery B-21, Hope for Today, B-27) to help better address the needs of adult children. Unfortunately there is still some confusion between Al-Anon meetings that are specialized for members who lived in an alcoholic home (which follow the Al-Anon principles and use only CAL), and meetings that are separate from Al-Anon and use their own literature.

- 5. Q: The secretary of the meeting lost all the materials, including the banners. Is this person responsible to buy the replacement materials?
 - A: Unfortunately this happens in meetings, & sometimes it's with the group's treasury funds. The phrase that comes to mind is "Presume good will". It is likely that this loss was not intentional, and is an example of "life happens." Your group could discuss how to replace the materials at it's next business meeting. The secretary may offer to donate all or some of what is missing, with the 7th Tradition used to cover the balance. There could be a discussion regarding requirements for the group's service positions. Some groups have developed written policies about each position and the length of time a member attends the meeting before being eligible for the position.
- 6. Q: The secretary of a meeting brought her drunk husband to the meeting. People were upset and left. The alcoholic participated in the meeting as an alcoholic. What could have been done at the time of the meeting?
 - A: It could have been appropriate for another member to first approach the secretary one-to-one to say that "you individually are welcome to stay, however it's not appropriate for someone to attend an Al-Anon meeting while intoxicated." and suggest that the husband could instead go to an AA meeting. The pamphlet "Al-Anon Spoken Here" (P-53) could be available to hand the husband/wife or read during the meeting. It can be very difficult for a member to step in and help set boundaries for the group. However Tradition One speaks of "Our Common Welfare" which is primary to the group. There is more information under Group Problems and Solutions (Service Manual, p. 54): "Al-Anon and Alateen members expect a safe and pleasant environment when they attend a meeting, and when one member causes unrest due to inappropriate or intimidating behavior, the entire group could be affected. Groups are within their autonomy to establish group behavioral guidelines in a manner that reflects their group conscience and abides by the Traditions.

When the behavior of any member impacts the group, members apply the Traditions to the problem, and determine how best to approach the individual(s) involved, to ask the member to change the behavior in question. This can be an exercise in applying Al-Anon principles so that the message is not a personal attack, but rather a request based on what is best for the Al-Anon group."

- 7. Q: Is the D-64 still under a test mode? What's it's status under the SCWS?
 - A. See our Immediate Past Delegate's Report for details.
- 8. Q: A question regarding the use of the word "Qualifier". Please speak to this as it has come up in my district. Can this word be used? If not, what can we use instead?

A: The term "Qualifier" is not a word used in Conference Approved Literature (CAL). The term came from outside therapy/treatment facilities and is used to refer to the person who is the alcoholic in their life. In our Service Manual (pg. 124) there is reference to "Labels" Focus on the Al-Anon interpretation of our program is strengthened when we avoid using professional terms and labels since they may confuse members by implying affiliation with certain persons or specific therapies.

As we grow in Al-Anon we gradually learn to shift the focus off of the alcoholic in our life, and focus on ourselves. In the meantime a member might refer to the person as the alcoholic in my life, or that they came to Al-Anon because _____ has a drinking problem. Some members have said that their son/wife/mother, etc. was the person 'motivating' them to come to Al-Anon. We cannot control what words other members use while sharing, however some may choose to change their vocabulary with education. The June 2014 Forum has further discussion in the "Talk to Each Other, Members respond" section, pg. 16-18

- 9. Q: Someone brought to AIS a plea for funds for AFG Convention from another District Rep saying they were in the red. Is this true? What is the protocol? Is there a more formal plea so KBDM can be utilized rather than a sense of urgency?
 - A: SCWS has no information regarding the fundraising practices for the AFG Convention. Please submit this question to the AFG Convention Chair.
- 10.Q: I am a new DR and have not received any links or flyers for events in other districts. Would it be possible to receive that via email instead of having to click the SCWS website?
 - A: What about directly connecting with the District Representatives in neighboring districts? Sending them an email requesting to receive notices of their events.

Alateen Conference Restructuring Workgroup:

The Area Alateen Resolution Committee, which is the decision -making entity pertaining to Alateen, suspended Area support to the Alateen Conference (SCAC) due to non-compliance over the past several years. The Restructuring Workgroup was formed in an effort to restructure SCAC so that it can become compliant. The workgroup consists of 6 Alateens and 6 AMI-ASs. They met weekly from September 25 – December 31, 2016. Their purpose was to create an Alateen Conference that is program-based, safe for all attendees (including sufficient sleep time allotted), and consists of supervision by AMIASs at all times throughout the event. They have presented their plan to the Area Alateen Resolution Committee (AARC) for review and approval. Starting next week, the AARC will meet weekly to review the document. Once the Restructuring Plan has been approved by the AARC, the suspension will be lifted. The fellowship will be informed at that time.

Alateen Task Force:

At the May 2013 Assembly, the GR's voted to have a task force created to discuss the following and report back to the Assembly with their recommendations:

- 1. Should the maximum age of 20 for Alateen members be changed?
- 2. How can the Area support meetings that have Alateen members with special needs?
- 3. Should the Area support overnight events for Alateen?

At the Nov 5 Alateen Forum, 54 people signed up as willing members of this task force so there will be a vetting process to determine which members will be chosen. The Task Force will not begin until after the SCAC Restructuring has been completed.

Background Check Task Force:

This was presented today to the AWSC Committee members. Consensus was to go forward with Live Scan.

More research will need to be done on Live Scan background checks. The Task Force will research the financial and logistical impact on the Area, Districts, and AMIASs. When the research is completed, this topic will be presented to the AWSC Committee Meeting and then to the Assembly for discussion.

Alateen Participation at Conventions:

Reminder that the Alateen Program Chair can be an AMIAS, per G-20 (Guideline for Area Conventions). *Actually, this guideline states that an AMIAS should be designated as the Chair and an Alateen member can be the Co-Chair.* It is important to include Alateen participation when planning a convention, however, the procedure for Alateen Events must be followed.

An Event Plan must be submitted to the Alateen Sponsor Coordinator (alateen@scws-al-anon.org) and approved before publishing "Alateen Participation" on the convention flyer or distributing a flyer for the Alateen event. You can submit the Event Plan months in advance of the event. You do not need to wait until the deadline of "30 days before the event, 60 days if it is an overnight event".

Young Al-Anon meetings:

Young Al-Anon meetings are meetings designed specifically for members between the ages of 18 and 30. These are also used as transitional meetings for Alateens moving on to Al-Anon.

These meetings are NOT to be held in lieu of Alateen meetings to avoid abiding by the Area Alateen Safety and Behavioral Requirements. It is requested that we honor the age requirement for young-person focused Al-Anon meetings and not use them as a loophole to impede safety measures for the minors in our program. Conventions may include Young Al-Anon to their program but need to run concurrent with an Alateen program.

AMIAS Recertification Workshops:

18 AMIAS Recertification Workshops will be held the before May 31, 2017 deadline.

There have been revisions due to rotation of service positions at the end of December 2016, so I have provided the revision today and will request to have it posted on the Alateen Sponsorship webpage of the Area website. Please let all Spanish speaking members know that there is only one workshop scheduled in Spanish and it will be held in Orange County on May 6th. This year's workshop will introduce the Alateen E-Service Manual, include self-reflection, and consist of Case Study discussions.

Reminder that the host District reserves the location, creates and distributes the flyer, and provides the snacks & beverages. The Area will provide all of the workshop materials.

The SCWS Treasurer will pay a maximum of \$100 for the rental fee of the facility. The responsible party from the host district should send a reimbursement form directly to treasurer@scws-al-anon.org so that a paper-trail of expenses can be maintained for auditing purposes.

Area Alateen Process Person (AAPP)

My name is Gerry W from District 12, but everybody calls me "Bear".

I am still getting my feet wet as I learn my role but am grateful for the opportunity to be of service.

The paperwork from the previous AAPP was transferred to Tarisa and myself on Dec 31, 2016, Therefore, no AMIAS applications were processed between September and December. We were able to process all of the "September through December" applications during the first week of January 2017. If you have Prospective members on your AMIAS Roster who claim

they turned in their paperwork, please have them resubmit it because I have not received it.

AMIASs:

- There were 356 certified AMIASs at the end of Fourth Quarter 2016 minus 2 that stepped down plus 12 that were processed in February 2017. That makes a total of 368 currently certified AMIASs as of today.
- There are 4 applications that are marked as "unable to process". Please check your report and assist the applicant to provide the missing information so their application can be processed.
- There are 29 applicants who have attended an AMIAS Certificate Training but have not yet submitted their paperwork for processing. Please check with the Prospective members on your AMIAS roster to remind them to submit their forms to their DR or DAL for signature and then submit them to the AAPP so the certification approval process can begin.

Alateen Groups:

- There were 82 Alateen meetings registered at the end of Third Quarter 2016.
- 2 Alateen meetings were registered and 2 disbanded during Fourth Quarter 2016.

This results in a total of 82 registered Alateen meetings in our Area at the end of 4th Quarter 2016.

AMIAS Certification Training (for new applicants only):

90 minute on-line webinars are held once each month – second Sunday on even months and second Wednesday on odd months at 8:00 pm. For those members that are technically challenged, face-to-face sessions are held at various conventions. This year, the only conventions that have requested this are: SFVAA (January 28th) and AFG (April 1st). If you are a convention chair and would like to have an AMIAS Certificate Training scheduled during your convention, please contact aapp@scws-al-anon.org

AMIAS Applications and GR-3 forms:

Please send all AMIAS applications and Alateen Group Records (GR-3) forms via **email** to aapp@scws-al-anon.org. Emailing documents provides you with a submission copy for your records and allows me to expedite the processing of new AMIAS applications and new Alateen Meetings within one week of receipt. If you snail mail forms to the AAPP, they do NOT get mailed directly to the AAPP and may take several weeks for the AAPP to receive it.

Alateen Meeting GRs:

Alateen GRs are registered through the AAPP (NOT through WSO). Section 7 on the GR-3 form has a section for this information. Please make sure all Alateen GRs are registered at least 10 days prior to the Assembly so they can have a voice and vote during the Assembly.

Reminder that the GR is an Alateen member of the meeting. The GR can NOT be an AMIAS!

WSO Annual Recertification:

It's that time of year again! Our Area must submit our AMIAS Recertification records to WSO in June. I will be emailing an AMIAS Recertification Roster to all DRs and DALs at the beginning of March. It is the district's responsibility to return that document to me with any corrections on or before the May 2016 Assembly so I can submit the Area Recertification report to WSO during the first week of June.

On pages 157-158 of the current Service Manual, it states the following as "Duties of the DR":

- Bullet 4- To visit all of the groups in his district, particularly new groups, to make sure they are getting necessary information and help.
- Bullet 6 To prepare and update a mailing list of the GRs in his district for the Area World Service Committee (aka SCWS Area Assembly).
- Bullet 7 To urge every group to complete and promptly return the group data sheets sent out annually by the World Service Office.
- Bullet 8 To check the group's Current Mailing Address (CMA) with each GR in the district to determine if it is correct (for Alateen meetings, this refers to the AMIAS Group Sponsor - not the Alateen GR).
- Bullet 9 To make sure mail from the WSO is reaching the groups and being shared with the members (for Alateen meetings this is; Alateen Talk Newsletter, Annual Group Update form, Quarterly Appeals request from WSO, etc).
- Bullet 11 To notify the Area World Service Committee and WSO of groups that have disbanded.

This is an optimal time to have the DAL visit the Alateen meetings in your district!

#2 Group Updates/Registrations Form on SCWS Website

Many of our members are using the SCWS *Registration/Group Records Change — On-Line* form to update their meeting information.

It is helpful for members who update their records to use their group's WSO ID number, as that is the most efficient way to find a group in the WSO data base. If you don't know your group's number when you fill out the form, please be sure to enter the name, location, city, and zip code of your meeting's address on the proper lines so I can find the meeting in the data base.

#3 FAQs

Over time, it will be helpful to all of our members to call our "beyond the group" representatives by the names that are the most accurate. Those positions are the GR and the ISR (and their Alternates).

The Group Representative (GR)

According to our *Service Manual*, the GR is the elected member of the group who attends District meetings and Area Assemblies, and represents the voice and vote of the meeting at District and Area Assemblies. Some Districts mistakenly refer to the GR as the "World Service Rep."

The Information Service Rep (ISR)

The Information Service Representative (ISR) is the member who oversees the administration of their local Al-Anon Information Service (AIS) office. The name of the group that oversees the AIS is the Intergroup. However, the *individual members who performs this service is the Information Service Rep* not the "Intergroup Rep". In the Service Manual, there is no designation for an "Intergroup Rep."

In addition, because the name "Group" and "Intergroup" are so similar, it is confusing to our members to use those names. If we all use GR and ISR, everyone will become educated to that fact that these are 2 distinct service positions, serving 2 different service arms.

Cooperating with the Professional Community (CPC)

January 17, 2017

I received an email from an Al-Anon member in December requesting help finding 15-25 members to volunteer for a sponsorship study she is conducting for her doctoral dissertation. She needed people with over ten years in the program who have had a sponsor for at least eight years, and who have had a sponsee for at least one year.

After consulting with Elizabeth, Jayme, and Claire of the WSO, I learned about the problem of pyramid sponsorship, which isn't the kind of sponsorship that Al-Anon practices, according to our literature. Claire sent the student the conference-approved "Sponsorship, What It's All About" (P31), "Sponsorship – Working Together To Recover" (M78), and "Service Sponsorship" (P88), and also referred her to the books How Al-Anon Works, Discovering Choices, and Paths to Recovery. When I spoke to the student, she was aware of the problem of pyramid sponsorship and will take note of this while conducting her study.

Jayme provided me with email contacts of people she thought would be good possible participants and I emailed them with information about the study. Several people responded and a few offered to volunteer. I sent a copy of the study information to SCWS board members and to my home District 27's DR. Elizabeth is sending some of her contacts directly to the student, who is also looking on her own for more study subjects.

As of this date, the student has interviewed five people. I volunteered to participate in the study, and will be interviewed this week.

Two outreach projects targeting different audiences for the Al-Anon message of hope and help are being explored by District 60. After development of proposed budgets and use of the KBDM process, the projects will be presented for a vote.

One audience is the families of those whose alcohol problems require police intervention. The District is working with a local law enforcement agency to develop a pilot project that would equip police officers to inform families about Al-Anon. The hope is that the project could be expanded to involve several other police agencies in the District.

The second audience has two components: (1) First, people who seek information from their local libraries about alcoholism's effects on families and (2) Second, Al-Anon members whose financial circumstances prevent them from purchasing books of their own. A District 60 Alternate Group Representative has completed a survey of District libraries to see what books are not yet available for checkout. The District will consider adding books to each library and will make the survey available to members who may want to donate books in celebration of specific events and friends.

Two educational projects for Al-Anon members also are on the District calendar: (1) the 7th annual workshop May 13 that will focus on how Al-Anon principles can be used at home and work and (2) an ongoing "Service Manual" study conducted at District meetings for GRs, AGRs, and other interested members. The "Service Manual" study resulted from an Area Thought Force's finding that many group and member concerns arise from lack of knowledge about Al-Anon's principles and practices.


