# Officers' Reports

# **Delegate**

World Service Conference April 2003 VirginiaBeach

Theme: Change! Create New Possibilities

The room was filled with love as approximately 100 members discussed the worldwide business of Al-Anon/Alateen. This report is only a summary of the highlights. The next issue of "Inside Al-Anon Xtra" will include more, as will the Conference Summary (see below to order a copy). But these are all just a short summary of the early morning to late night discussions of the WSC. I wish every one of you could have the opportunity to experience the Conference (WSC) because words can not describe it. I thank you for delegating me to represent you this year, Miriam

Following key WSC votes were either unanimous or nearly so; clearly the voice of the majority:

- Change the pamphlet Al-Anon is for Adult Children of Alcoholics (P-52)
  from a piece of "recovery literature" to a "Public Outreach tool" (note:
  cover page with circle symbol designates that it's a recovery publication
  or a triangle designates it's a public outreach tool).
- Clarifications and correction to text in Service Manual (P-24/27) regarding Raffles, Locating meetings and Symbols/Logos.
- Future revisions to Al-Anon Sharings from Adult Children (P-47), How Al-Anon Works (P-22) (to add discussion of Concepts), Al-Anon's 12 Steps and 12 Traditions (B-8).
- Conceptual approval to develop a piece (could become a pamphlet or a book) on grief and loss as they affect the families and friends of alcoholics.
- Future printings of the Legacies (12 Steps, Traditions, Concepts and Warranties) return to the text as originally printed.

Policy Committee: currently 3 versions of "Welcome" to become 1 "Anonymity is an important principle of the Al-Anon/Alateen program." instead of "Al-Anon is an anonymous fellowship."

Background: The World Service Office (WSO) and Trustees are in the process of drafting revisions to our Service Manual so that it includes description of the new Committee Structure that was voted on by last year's WSC (2002). During their research, they found that the original wording of Concept 11, included the word "selected" committees, rather than the word "standing" committees that we're accustomed to reading today(that is for anyone who actually reads the Concepts).

It was in 1970 that the WSC adopted our 12 Concepts of service and the Warranties. But in 1973 and subsequent printings of the Concepts, the word "selected" was changed to "standing" and that has been maintained ever since. However, no record could be found in WSO archives or WSC motions or notes, regarding a decision to change to the word "standing" committees.

As a way to protect our Legacies (meaning the 12 Steps, Traditions and Concepts), we require ¾ of all worldwide groups to agree and vote to make any change in the Legacies. Therefore, the WSO wanted us to return to the original wording. Our motion was worded such that we did not have to vote to change the wording, rather to return to the original wording.

In fact, our Committee structure now is more correctly described by the term selected committees(the original wording). I'm quoting from the Webster's Unabridged Dictionary's description of a standing committee; "... a permanent committee of a society intended to consider all matters pertaining to a designated subject." Whereas a selected committee is "formed to examine and report on a specific issue." The difference being that a standing committee is permanent while selected committees can be formed and ended.

That is just what occurred over the past 7 years; starting discussion in Rita's term to change our WSO committee structure, voting to continue the trial structure in Willie's term and deciding to make the change permanent last year when Kay was there. Since Rita, Willie and Kay experienced the change in WSO Committee structure; they are acting as the leaders for our breakouts in the 3 Action Committees we'll participate in after lunch today.

OK, back to discussion of our motion. WSC did vote to return to the original text forour12 Steps, Traditions, Concepts and Warranties. Over time there were a few commas that got deleted in the Steps, Traditions and Warranties and the word "the" was dropped. The only other change, and only significant change was the word "selected" got reprinted in 1973 as "standing." Therefore, future printings will revert back to the original wording andConcept11will read, "The World Service Office is composed of selected committees, executives and staff members."

Whew . . . Because the motion got complex for us, and we talked about it over a period of several days, I've typed up this summary of what occurred and copied it in on the back of the motions page so that you can look at again later if you have questions. You can also call me. You will also see the motion and perhaps some discussion of it in the Conference Summary.

Change doesn't come easy, yet is seems most everything does change. This was a big deal, but yet it wasn't a big deal. This year's WSC theme of "Change" was very appropriate and I think that today, here in our Southern California Assembly, we're embracing change too. I learned early in Al-Anon service that there are no big deals in Al-Anon, That principle sure was useful as I was asked as your Delegate to cast a vote regarding something as big as apperceived change in our Legacies, (meaning the 12 Steps, Traditions, Concepts and the Warranties). I'd also like to report that the Monday Night Gardena Podium Participation Al-Anon meeting sent a letter to WSO years ago suggesting that "They became sick too" be reinstated. WSO agreed and in 2003 printings it will be added to Understanding Ourselves and Alcoholism, How Al-Anon Works and Service Manual. Article in the Forum (Inside Al-Anon) will discuss history of the Understanding . . . pamphlet.

It is you the members who are Al-Anon. Speak up and share your thoughts with me and with others. Thank you for letting me serve as your voice at the Conference.

Isn't that why we "talk to each other, reason things out with someone else?" (Al-Anon Closing)

The Forum can has almost enough money to fund one subscription, so let's see how many we can give away today. I always feel like someone wins on this gamble so I am not just giving my money away, and I might someday (sad look) win!

One of our most exciting events, the SOS Workshop is scheduled next January 2003 for Saturday, January 17, 2004. How many of you have been to an SOS in the past? Did you love it? Want to do it again and bring someone new? The morning sessions are wonderful, then we have the best little potluck in Southern California and in the afternoon, we will have at least one speaker from nearby who will share their experience, strength and hope in service, as well as a bit about themselves.

Then your past delegate, current delegate, chairperson and I ran off to Denver for SWRDM (South West Regional Delegates Conference) There were a lot of has beens, ares, wannabees and other interested parties there to discuss more about Al-Anon as a whole. This is a great place to bring up topics that might be discussed at the Conference, learn more about our structure, get to know other service folks in our region and just have a ball doing what we love! I think this time probably because I am more directly involved. I heard the information from different areas in a different way. We, as an area, have our own unique ways needs. Other shared about their efforts and successes at restructuring, but I heard that thought we could certainly use their ideas. we are unique. Because we have had our Intergroup structure in place for so long, we run the risk of double headed management. We do not rely on our districts in the same way as smaller areas, with the exception of our more outlying areas, like the deserts and the far reaches of our area. There is a suggested method of creating alternates for GR. DR and IGR. If this is too much for you, ask someone else if they can help. Meetings need representatives who get all of the information, and participate in the decision making process. That's how it works!

For the DRs it is four times per year (two Committee plus two Assembly meetings) and for the GRs it is twice a year (two Assembly meetings). Please write the following dates on your calendar for 2003: August 16 - the next Committee meeting and November 15 - the next Assembly meeting. The Committee and Assembly meetings start at 10:00A.M. and end at 4:00P.M. (at the latest) - since you have the privilege of serving your District or Group we request that you plan to stay through the day. If, for any reason, vou are unable to attend one of these meetings or need to leave early, please arrange to have an Alternate DR or GR be present. This is where we share Area experience, strength and hope and learn from each others' trials and tribulations, some of the ideas that were shared are being used today. What an absolute privilege it is to have attended both events – I, personally, thank our Southern California Al-Anon fellowship for this opportunity to grow in service. We will hear more about these events in reports from Sue and Martha a little later on.

In keeping with our Concepts of Service, at our first officers' meeting, we chose a theme to adapt to during this 3-year term. It is our 4<sup>th</sup> Concept: **Harmony** is the Key to Participation" – this applies to all of us in service as we continue to carry the Al-Anon message of hope and recovery to the families and friends of alcoholics.

# **Past Delegate**

Trial Restructure Plan

We have been planning and practicing the principles of using action committees for the past six years. An ad hoc committee of past delegates, coordinators and GR's has been meeting to plan an initial roadmap for re-aligning the way we operate this Assembly to best comply with the successful restructure within our World Service Office in Virginia Beach.

We've learned the successes and glitches from the smaller assemblies: but overall, everyone says it's working and that there is more participation from the members and that more gets done to follow our fifth Tradition to most effective.

During the February Southern California World Service Committee meeting, the Committee broke cut into the suggested action committees and barnstormed. They formed preliminary mission statements for each committee and suggested the Distr1ct Representatives have the District vote on choice of Action Committee assignments. They chose to have Past Delegates Chair to Action Committees for this first trial year. But we don't govern: we listen to your ideas and vote.

Later today you Group Representatives will have a chance to vote on whether to proceed with re-structuring Assembly for a three year trial period. The three committees made up great mission statements:

**Group Services:** To facilitate the flow of group services communication and create interaction between the groups, Southern California World Service and the Word Service Of f ice.

**Membership Communication:** To encourage participation and enthusiasm by carrying the message of Al-Anon/Alateen recovery, unity, and service to the membership in a timely informative and effective way.

**Public Outreach:** To increase public awareness of Al-Anon/ Alateen and coordinate this effort by carrying the message through public information, cooperating with the professional community, institutions and the media.

In Area restructuring: we are concerned with the serving of our own groups better and interacting with the WSO. As you can see from the Restructuring Chart. Each Action Committee will have Group Representatives, active past delegate members, and District Representatives, along with and liaisons from the AIS/Intergroup's and convention committees.

After lunch we will act our "action committees" where our coordinators will have a chance to give a more detailed ideas and the working committee can. Reprioritize on possible actions through this year.

Consensus from the previous meeting was for DRs assigned an Action Committee in February. DR's were to go back to their Districts with the GRs determine a method of how the GRs will participate.

We ask that Members stay on the same action committee through the November Assembly. This will give the coordinators a sense of a real committee to contact. Until the GR's have had a chance to experience being the process and you vote how the rotation and committee assignments will be handled.

Area Coordinators will give their reports within the Action Committee and may suggest items for projects. We will also give report backs at the end of the day today and have them printed in The Bulletin.

I believe you will find the Action Committees lively today. We will:

Form an active committee roster for the coordinators

Brainstorm to develop action items

Prioritize the action items

Create goals and agendas

Report back to the Full Assembly

As Group Representatives, you will have action items to carry back to your group with ideas and possible projects for them to work on, get involved and enthusiastic about.

If you vote to proceed with the trial period you will have an opportunity to evaluate the process in May 2004 and in November 2005 for possible changes modifications, or to forget it.

I am really enthusiastic about the committee-based way of carrying our message to our groups and to the public.

Participation is the key to harmony. (Concept 4)

# **Minutes Secretary**

Minutes Southern California World Service Assembly May 17, 2003 Fullerton Senior Service Center, Fullerton, CA

**Chairperson**, Kary L., convened the meeting at 10:00 A.M. with the Serenity Prayer and Welcome. Twelve Traditions were read by Lydia L., District 21. Kary acknowledged new Group Representatives and announced the theme for the following three years (4th Concept: Participation is the Key to Harmony). Kary reviewed the day's agenda, and after polling coordinators, announced that coordinator reports would be given in the afternoon Action Committee meetings. Maria P. was assigned Timer for the day.

**Minutes Secretary,** Shirley M., read minutes from the November 2002 Area Assembly Meeting. Those submitting reports are reminded that a media (disc) copy goes to the Bulletin Editor and a hard (paper) copy comes to Shirley. She explained that she sends a copy of each report she receives to the Bulletin Editor. This way, if someone cannot submit a disc copy the report will still appear in the Bulletin. Eventually copies of reports are given to Archives Coordinator.

**Chairperson** Kary L. reviewed who has voice and vote adding that California is probably the only area that holds a one day assembly and stressed the importance of every Group Representative staying until the end of day so that decisions made are truly reflective of the membership.

**Records Secretary,** Margie Llinas, thanked the DRs for their update work. Keeping the groups registered with a Group Representative or Group Contact is vital. Any meeting which does not have a GR or a contact to receive WSO mailings is dropped from World Service. Roll call was taken with 169 voting members present.

**Treasurer,** Tom Emanuel, reviewed reimbursement procedures and emphasized that to get proper credit, the contribution form should be filled out. Checks (no cash) should be made out to SCWS and mailed, along with the form, to: Thomas A. Emanuel, 2945 Harding Street #110, Carlsbad, CA 92008. Tom announced that SCWS currently had a budget of \$38,000 and after holding a prudent reserve of \$25,000, has approximately \$2,200 to donate to WSO. He explained that it was decided several years ago to donate to WSO each year instead of waiting until the end of a three-year delegate panel. Max S., District 21 moved that \$2,200 be donated to WSO. Danielle 0, District 27 seconded the motion. After discussion, with 169 GRs voting, the motion passed with 163 yes, 5 no, and 1 abstention. **(Group Contributions & Financials** printed in Bulletin)

**Delegate,** Miriam McKenna, highlighted her WSC experiences and thanked the assembly for delegating her to represent them. WSO is sponsoring a Public Outreach contest. The winning area will receive \$1,200 in materials from the WSO and a visit from two members of the WSO staff. WSO is accepting Forum Committee nominations now and Trustee-atLarge nominations due August 15. Anyone interested in serving as Trustee-at-Large is asked to e-mail Miriam at Miriam2003scws@aol.com. Our request to change our bid from Pasadena to Long Beach for the 2008 AFG International Convention was denied. Pasadena would not commit the Rose Bowl so California withdrew its bid. The convention will be held in Baltimore, MD, Pittsburgh, PA, or Vancouver, BC (decision will be made in fall 2003). Group Representatives are encouraged to order 2003 Conference Summary. Cost is \$3.00 with a request to WSO. (Full Delegate Report printed in Bulletin)

Alternate Delegate, Sue Picott, reviewed Ask-It-Basket procedures and introduced the Forum Can. Place twenty-five cents along with a name and telephone number in the can. When there is enough money in the can to fund a subscription, a name will be drawn from the can. GRs are asked to mark calendars for the Annual SOS (Sharing of Service) which is scheduled for January 17, 2003. Kay and Sue traveled to SWRDM and have brought back ideas for restructuring. (Full Alternate Delegate Report printed in Bulletin).

Past Delegate, Kay Dornbusch, referred those present to the Restructuring Diagram in their packets, explaining that those present will have a chance to participate in one of three action committees:Group Services, Membership Communication, and Public Outreach. At the end of the committee sessions, Group Representatives will be asked to vote on whether or not to proceed with restructuring. (Full Past Delegate Report

printed in Bulletin)

#### **Old Business:**

## **Ask It Basket**

- **Q.** An Al-Anon member who has an answering (phone) business has donated a line to our district. This number is published in our local papers and provides a toll-free number along with our area service center number. We feel this anonymous contribution is not in conflict with Traditions/Concepts.
- **A.** See page 78 of the 2002-2004 Al-Anon Alateen Service Manual re: Answering Services
- **Q.** Bulletin! Bulletin! Where art thou Bulletin? How about increasing internal communication to help us with external communication. Does the process need changing? I need help the Bulletin is a great vehicle for getting info to groups. .....and...What has become of the <u>Bulletin???</u> Haven't got but 1 or 2 in my three years as GR.
- **A.** We were not able to retrieve the software and scanner from the past bulletin coordinator. The new bulletin editor then had communication problems with the printing company. She resigned and we now have a new bulletin coordinator. Hopefully, this problem has been resolved. Group representatives can also check with their district representative or the record secretary to make sure your registration is current.
- Q. As a very new Al-Anon member and group representative, I will be doing a verbal report on our meeting to my group. I thought I would follow it up with a written report. Is it appropriate to hand out copies to each member or to leave a stack of copies for people to pick up, if they are interested? Thanks!
  A. See pgs. 44, 132 & 133 of the Service Manual regarding duties of the group representative. It is within the autonomy of the GR to follow-up verbal reports with a written report. Do what works best for you and your group!
- **Q.** In "Area Highlights" Winter 2002, p.3.,re: the bullet suggesting creating group business cards as a way to keep a meeting healthy isn't this a conflict with using CAL (Conference Approved Literature) only?
- **A.** Pages 87-88 in the Service manual have a good definition of attraction. Business cards that can be handed out to let people know when and where your meeting is can help invite new members. We wouldn't publish literature but we can publish meeting information.
- **Q.** Why do we not begin the meeting (the Area assembly) at 9:00 or 9:30 am? Reports could be more concrete with information such as Miriam provides.
- **A.** There has been no request to do so. The Group Representatives can chose to bring it to a motion and vote.

- **Q.** Why do SC WSO committee members take attendance?
- **A.** Roll call is taken (by our Records Secretary) to determine the number of voting members in deciding motions. Roll call of committee is taken to determine who will be giving reports or is available to give information in that area of service. See p. 137 of the handbook, item #3
- **Q.** There is a chronic problem of crosstalk (the leader comments on each share, comments from the group unasked for during sharing) at my home group. My sponsor gave me a suggested paragraph to read when I am the leader for the day. It was quiet only on that day. I have proposed adopting the paragraph, but nobody know where it's from, perhaps adopted from AA? Would the World Service Office consider writing up something to be part of standard Al-Anon meetings to state that crosstalk is not acceptable unless the meeting decides that is what they want?
- **A.** Pgs. 33-34 of the service manual suggests a general format for Al-Anon and Alateen meetings. P. 50 suggests that a group inventory may help. The pamphlet, **Alcoholism The Family Disease** suggests that "a mature person listens courteously to the opinions of others", p. 30, #12. See also p. 353 in the **One-Day at a Time In Al-Ann.** 131 & 308 in **Courage to Change**, p. 122 **Al-Anon Family Groups**, Tradition 1
- **Q.** What gives World Service authority to change words/phrases in our literature without a vote from all Al-Anon groups? Specifically, "they became sick too".
- **A.** Please see Concept 11, page 185 regarding the Literature Committee and it's responsibilities. Don't confuse these changes with the wording in the Steps, Traditions or Concepts. For information on changing the wording on these items, see p 144 of the Service Manual. Al-Anon World Service Conference Charter. #3d.
- **Q.** There is an Al-Anon group that we believe violates our core principles in that it denies any group member who is also a member of AA from participating in the discussion. They may listen but not share. Is this not an exclusionary practice that goes against Tradition Three, if nothing else, "The only requirement..." What about the impact on the newcomer who may feel singled out and judged? What about the core principle of anonymity? If such a group exists, we feel it should be "de-listed".
- **A.** How do they know that the person is in AA who's breaking that person's anonymity?

Anyone can be in Al-Anon, share in Al-Anon, serve at the group level and reach out to newcomers. Are you saying an alcoholic can't be an Al-Anon member? Who decides that? Isn't that the job of the service manual? So a sober member of AA is not allowed to share but if a person goes back to drinking, that person is allowed to share. This is an odd way to cooperate with AA.
