

<u>Delegate</u>

I stand in awe over the 55 years of progress this fellowship has made and continues to make in this 21st century.

What a privilege it is for me to have attended the World Service Conference (WSC) for this first year as your Delegate. I would like to thank those Delegates that went before me for their dedication, long hours and hard work on our behalf.

I went with an open mind but I did have many questions to ask at the Conference. The benefits given to me as your Delegate were immeasurable. I witnessed unity in action, not just with the Delegates but all members of the Conference. We worked together, we shared together, we reached a consensus on all topics.

I would like us to try to use the same ideas as introduced to the Conference for the Assembly: share on each topic, let everyone talk for 2 min. We are showing this presentation today.

Shared Leadership – Moving Forward with Confidence, Collaboration and Clarity was the theme of this year's Conference. Having been involved in service since my early beginnings in Al-Anon I am here to express just how inspiring this conference theme was and how it strengthened our unity of purpose. All members of the Conference; Delegates, Board of Trustees, Executive Board and Staff supported each other and united us all. The new process KBDM (Knowledge Based Decision Making) surfaced as a unique new way to reach collaboration and clarity and to be confident in what we were all doing. Each day we had a "focus for the day" and each evening we all evaluated how we met that challenge. Participation in this gave us a new way of forming our ideas and bringing us all together. This is evidenced in our schematic (circle) presentation. The WSO Board and Staff are always willing to answer your questions. Give them a call or email them.

KBDM works since we discuss the subject with an open mind before deliberation and decision making. It presents these ideas: 1. Open communication. 2. Dialogue and deliberation. 3. Access of all information and, 4. Trust in the process.

In relating to our Concepts, KBDM outlines the following:

1. Responsible – share the knowledge.

2. Accountability – take and give information.

3. Mutual Trust - give information and give out for decisions.

4. Participation – Listening and sharing, not taken for granted.

5. Listening and Speaking up – eliminates control, shows trust, have the right to be heard, we are not always right.
6. Relationship – Trust, know and share.

7. Balance – Legal rights – all rights respected.

8. Delegation – Trust for others thru information.

9. Leadership – Good knowledge, communicate facts, insights.

10. Trust and Delegation – one good choice, giving responsibility without what and how.

11. Committees – Everyone belongs to share knowledge and information.

12. Spiritual – Prudence (attraction vs. promotion) we are better informed when sharing knowledge.

Delegates shared on how they used KBDM. My first time at the mike was on this subject (was I nervous!). I shared how our ad hoc Committee on PRAASA sent out a letter to all Districts to inform them and to get their input prior to a motion being made that we have to vote on.

It is important to have everyone's input and to invite all (including GRs) to be a part of our meetings. We all need to be informed and to bring our ideas to the Assembly in order to have joint understanding and be able to articulate it. We all need to be clear in our roles as far as leadership characteristics, vision and flexibility.

We discussed "framing" an idea or motion before presenting it to be voted on. This worked very well and all motions were passed with an overwhelming majority thru the week. We had 95 total votes this year and all motions passed with over 90 except one which was 88 (about adding electronic meetings to the Policy Digest) and one with 85 (which was to reconsider which literature should be used as public outreach service tools). These motions (14 in all) will be in the Conference Summary.

One of the important motions was to have (E-Cal) on a threeyear trial basis. This is the worldwide outreach for our worldwide program. I have asked Alvar to show all of us the website presentation. 60 of our 67 areas now have websites. Can use the Web for our special needs members also, deaf, paraplegic, blind (with a converter to audio). I'd like to challenge our Area to look up the WSO website, use a signup sheet to see which Districts get the most names (only sign once per person). Another motion was to approve the new trial implementation of the Regional Committee on Trustees. As a note, I was not in favor of this when I came to the Conference but after viewing the process and understanding how Trustees are nominated and chosen I believe that this new process will help clarify these choices. All Trustees are ultimately chosen by the Executive Board. There was a great deal of discussion on this topic and the motion was carried (94, ... yes out of 95). Using the KBDM process (talked to each other, reasoned things out prior to the motion) really made the difference. We did use Roberts Rules some but most of the decisions were made thru mutual respect and substantial unanimity (Warranty #5). We strived to answer all questions until all were satisfied.

Our elected Regional Trustee is Winnie S. from New Mexico, it was a very close race but one that brought out the importance of changing how we select our Regional Trustees. More than ever the use of KBDM helped us to reach a consensus that brought about a change in the process of nominations and we all felt that the new Regional Trustee plan should be implemented on a three-year trial basis.

One of the presentations was particularly interesting and that was from the Public Outreach Committee and the DVD on our new PSA in all 3 languages. We were presented with the disk and we are showing it to you today. "What It's Like," the DVD with the new PSA, can be purchased through the WSO for TV and radio.

We have distributed more than 700,000 of the Crying House Bookmarks and are in reprint on the referral pads. The Conference audio reels from 1961-71 have been converted to CD. There is going to be a new index in the Service Manual. On page 83 "Service Tools," deleted in error, will be back in the new printing and online. Also I have brought back order blanks for the new Public Outreach Magazine "AI-Anon Faces Alcoholism" These must be ordered by prior to July 14th in order to be processed by September. You can also find order blanks in the Forum. These will be in French and Spanish also. There is a new pamphlet coming soon on Grief and Loss. Also our new WSO database should be completed in the next few months and we will then get automatic renewal notices for the Forum and subsequently an acknowledgement card that our renewal has been received. I also have the new Service Manuals in French and Spanish. Lucia also has "In Action" booklets and Service Manual order forms.

A skit was presented on Anonymity and Myth Busters. My personal notes and questions were:

1. How can we show full face and remain anonymous?

2. What about our alcoholic's Anonymity?

3. Money, Property and Prestige, is this what we want?

I believe our PSAs and Public Outreach projects bring in new members all the time. Perhaps have, on a trial basis, a Trustee that is not a member (AA has several of these). Perhaps we need to hire a consultant as we did for this Conference to represent us to the media or as in the newspaper article for the 55th Anniversary showing one of our employees that is not a member. Elizabeth (Bulletin Coordinator) has copies of this article. She also has some newsletters from other areas.

The Chosen Agenda items were:

1. Spiritual Principles and Good Business Practices - It was stressed that the WSO has a responsibility to all of us, that we have comfort in our three Legacies. It was stated that we have to have trust; trust in our leaders, trust in the process, reminded that Tradition 2 and the Concepts provides for balance between our entities (trust, spirituality, authority). These can be found in Concepts 1,2,6 & 7. The importance of unity was stated by several members that went to the mike. Ruth from Washington said we get into service to see how we grow even though sometimes dissenting. Carol from CO referred to Trad. 5, one purpose, etc. etc. Have we done these things for this one purpose, for the good of our one purpose? Did we reach out with our purpose in mind? Mike from MI - Spirituality thru respect. To do assigned task takes courage to change. If not moving forward, we're moving backward. Calgary - Re protecting money and property – trust in our HP. Patricia – WY Learned from oldtimers to trust in our HP. ARK - without our spiritual progress we would not have the tools of business. Betsy, agree to disagree. WSO are real people working hard. AK - What are your motives? Motive to spread the word not make more money can't be anything but spiritual. Our entire Al-Anon program rests squarely on the principle of mutual trust. Pg. 160. The WSC makes the group conscience available and effective for all Al-Anon, etc. pg 116. Never be afraid of conflict because to just sit there is complacency!

2. Controlling groups and sponsorship – This agenda item was of special interest to me and I prepared a 2-minute talk that I would like to share with you all. After I read my sharing at the mike several other members came forward and shared their experiences. It was overwhelming to see how many controlling groups have sprung up all over the US and Canada. Here are a few sharings: We need to have increased awareness to resolve this problem. Speak up if not Al-Anon. One Delegate shared that she was hit by a group leader that was in "charge". She had to go to court, was even threatened by a billy club! Another Delegate suggested using the Sponsorship pamphlet. Silence is enabling. Another Delegate said to be aware of who are your speakers. Discuss sponsorship once every quarter in meetings, etc. WSO suggested calling your Delegate if there is a problem. It was suggested that we keep showing up, also could send members of WSC, i.e., Gen B. and Mary G. to share at our Assembly. One Area had a conference and asked speaker to come (she was one of these so called sponsors); she told that conference that only sharings would be from her group. THIS IS NOT HOW AL-ANON WORKS! The good news is that WSO is developing a bookmark on this topic and also looking into publishing a pamphlet with this focus in mind.

I was assigned to the Admissions and Handbook Committee. It was so informative and I thought it would be quite different. We all participated and decisions on changes to the Handbook were discussed and recommended. Also it is this committee that recommends whether an area can divide. We have in the past discussed having a 3rd or even 4th area in California. The Committee challenged me to put together reasons why we should divide again. So I am asking all of you to think about this and come up with your thoughts and ideas on what would be best for our Area. Should we divide? How would we divide? Where would the boundaries be? We would have to have clear and concise decisions on this topic. I emphasized that we had 1000 groups and they could not be represented as well as other Areas with a few hundred meetings. I also emphasized the distance in servicing our Area. I learned that this was not necessarily a valid reason, as many other areas have more distances to cover than we do (e.g., North Carolina and Bermuda are one Area!). Think this over, talk it out and perhaps we can discuss it again at our November Assembly. More than likely we will need to keep in contact with California (N) on this. If we do petition to divide it will affect all of California. If our fellowship adds more Board Members then would this open the path for additional Areas with Delegates? If we are to reach out, we need to grow at all levels.

More observations on the second day at the WSC: use KBDM, don't hurry with decisions. We all truly felt equal, - inclusive. Presume goodwill.

We still need more stories for the Forum. Our Area was well represented in the Forum as well as in some of the online stories. Check this out. All groups will be getting a monthly copy of the forum free from WSO and it will go to the CMA for your group, so be sure that the CMA is someone who still is a part of your group. A reminder that the Forum will now be \$11.00 per year starting this next month, also our literature will be going up 20% to cover costs. It was last increased on 4/1/98 and only for 11 of our books. Shipping and handling will be more also.

There is going to be a job opening at the WSO. Mary Ann K our longest employee is retiring and her position as Director of Member Services will be posted on the web sometime in June. Resumés should be sent in to the WSO Office Manager. I will have more info on this from them soon. Mary Ann was the speaker at the 55th Anniversary party on Saturday, April 29th. She was very inspiring.

Some of the WSO went to Poland, Austria, Hungary and Romania. Mary Ann and Marsha were the ones that went. Poland has 400 groups. Their Executive Director does not get paid. There are 32 groups in Austria. They were so grateful for our presence as they wanted to learn more about how AlAnon works. In Hungary they did not have Service Manuals. Romania had very poor conditions. Their oldest Al-Anon meeting is 10 years. They cannot print literature as they have no money. Mary Ann and Marsha shared that in Poland they stayed in an unheated room and slept on bunk beds! That is dedication to our program! Eventually they were moved to a heated room.

The Alateen Traditions are still in the discussion phase. We are looking for more info for next year when Alateen will be 50 (wow) years old! Hopefully we will get input from groups so that we can get their Traditions decided on. Some questions to ponder: If Alateen is Al-Anon do we want separate Traditions? How to spell Teen-ager (teenager)? Do they need to be Conference approved? Do we amend the Charter to include Alateen Traditions? We need to encourage Alateens to come to our Assembly so we can get their shared conversations. It should be noted that the WSO apologized for the manner in which the Alateen Requirements were presented. I would like to add that I firmly believe after listening to others share from other Areas that we definitely do need these guidelines. We do have forms for Alateen for their trial website signup.

Be prepared for the Al-Anon International in Pittsburgh, PA in 2008. They are planning a big celebration. Thinking ahead, the next International will be in 2013 (*Join the Dream in Twenty Thirteen!) If we would like to bid for one of our cities we need to start preparing now; the bid forms will be out next May. We have to decide on which city as only one bid per Area.

We talked about catching the vision and I believe I am. This wonderful process has made me able to speak out more, discuss and clarify my opinions and to listen to the message of worldwide AI-Anon. What a growing experience this has been. Don't be afraid to speak up, raise your hand, and be a part of! I am confident that we can come together to move forward. Use collaboration to work out our issues and obtain clarity by asking questions and receiving the answers.

I have a copy of the contributions from all meetings to WSO and have given to Suzanne and I am sure she will be glad to have you browse through it (Suzanne - hold up). Our groups donated over \$61,000 to WSO this last year. Also I have the graph on our occupancy costs as compared to being in New York. If you would like a copy just let us know, we do have a few here today.

What an experience the 55th Anniversary was for all of us attending. Mary Ann K was the speaker as I mentioned before. The theme was "55 Years of Passing it On". Signs were given out for all the countries where Al-Anon is represented and then all those with the signs were announced and then they marched around the banquet room. It was quite moving. I brought the Scotland one home for us.

Thanks to all the various groups for the "Love Gifts" that I shared at the Conference and for all the wonderful cards and letters. I have brought back many "love gifts" from other Areas and please help yourselves to any item or items you might like.

We had two international members present. Julia from Mexico said they have 3200 groups and 36 Areas in their GSO. Emily is the General Secretary of the GSO in UK/Eire; Belfast was first meeting in 1951, by 1983 groups had grown to 673, by 1992 – 1000 groups.

I would like to thank the committee that did PRAASA this year. They did an outstanding job and the program topics were

great. Thanks to Carol L, Shirley M and Kay D for all their hard work in putting this together.

I would also like to thank all of you for allowing your officers to attend SWRDM (Southwest Regional Delegates Meeting). I have attended SWRDM in the past as your Alternate Delegate and Chairperson; however, I cannot explain the impact that this weekend (March 10-12th) had on me. It was an entirely different experience and to be able to share with most of the current delegates in our area and to exchange ideas with them and the past delegates was humbling. What an honor it is to be your Delegate and to share this honor with those that have gone before me. The interaction between all was so informative not only as a taste of how the Conference would be but how important the little ideas are (i.e., label your camera, mail your dirty clothes back so you don't have so much luggage to carry, etc. etc.).

Thanks to Kay B and her committee for the wonderful AFG Convention this year. The speakers were outstanding!

It is my hope that the coming years of SCWS will be focused on unity, at our Assembly, at our Committee Meetings and at all levels. It is important that all GRs and all Al-Anon members feel a part of and have a voice in our Area. Without their contribution we cannot continue to be a forward-reaching fellowship. With this in mind, I would like to see us adopt the KDBM system on a trial basis and also try using the rules (2 min. at mike, stay on topic, if someone has expressed your same opinion sit down, etc.) that we saw earlier, so that all members that wish to, can participate.

While in Virginia Beach there was a little saying in the local paper which sums up who I am, and I quote: "Giving for me is like exercise. It releases endorphins, increases the oxygen to my brain and raises my energy. I will find many occasions to be generous now." Thanks to all of you for your continued support and participation in our fellowship. My journey has just begun.

Past Delegate

As Immediate Past Delegate, my role is to support the current Southern California World Service (SCWS) Board and to share history from the previous board. Three years ago at the Assembly in May 2003, the Group Representative (GRs) voted to begin a 3-year trial Restructuring of our SCWS into an ACTION Committee format. Now, 3 years later, we need to decide how to move forward with that restructuring. The following is a brief summary of the history of how our SCWS Restructure began by following the Restructure of the World Service Office (WSO):

- At the 1995 annual World Service Conference (WSC), a unanimous motion was made for World Service Office (WSO) departments to be restructured to improve communications.
- In 1998, the WSC voted to continue the restructure with an additional 3-year trial period.
- In 2002, the WSC voted to accept the restructure as their constant committee format.
- Between 1999 and 2003, here in Southern California, an SCWS Restructuring Ad Hoc Committee brainstormed restructuring the SCWS board to align with the WSO.
- At the May 2003 Assembly, the GRs approved a motion "That SCWS implement a three-year trial restructuring period" (wording taken from the Aug 2003 Bulletin).
- During the past 3 years SCWS worked within this new format, although our ACTION Committees were unable to meet at several Assemblies because their scheduled time was used instead to discuss the motion and implementation for the new Alateen requirements.
- At the Feb 2006 SCWS Committee meeting, we discussed how to proceed with the ACTION Committee restructure. Following the meeting, a summary from the Past Delegate, Kay D, who headed the Restructure Ad Hoc Committee, was emailed to the District Representatives (DR). That summary recommended that SCWS continue to use and improve the new ACTION Committee format. The following

are the initial purposes determined by each of the ACTION Committees:

Membership Communication ACTION Committee Mission Statement: To encourage participation and enthusiasm by carrying the message of Al-Anon/Alateen recovery, unity, and service to the membership in a timely and informative way.

Public Outreach ACTION Committee Mission Statement: To increase public awareness of Al-Anon/Alateen and coordinate this effort by carrying the message through public information, cooperation with the professional community, institutions and the media.

Group Services ACTION Committee Mission Statement: To facilitate the flow of group services communication and create interaction between the groups, Southern California World Service (SCWS), and the World Service Office (WSO).

During the turnover meeting between the outgoing and current SCWS Board members in Jan 2006, they formed a consensus to present a policy for Removal of an Elected Officer or Coordinators as follows:

1. Concern should be brought to the Area Chair and Alternate Delegate regarding attendance at required meetings and fulfillment of responsibilities of the service description.

2. The Area Chair would then be responsible to discuss the concerns with the member in question to assure fairness in dealing with the member.

3. The Area Chair would act in accordance with the general consensus of SCWS Board prior to removal.

4. Removal consideration would be appropriate under the following conditions:

A. Failure to attend two meetings as listed in the Service Position Description, without advance notice or reasons according to the Group Conscience of the SCWS and/or

B. Failure to carry out the responsibilities as listed in the Service Position Description.

Both of the above items are on the agenda for discussion at today's May 2006 Assembly.

Miriam M, Immediate Past Delegate

Chairperson

Welcome to the first Assembly of the new 3-year term. We have a lot scheduled for you today, as well as a few changes in how we do things. First and most importantly, we have our Delegate Mary, who will present her report of this year's World Service Conference.

Before we begin that, I would like to take a few minutes to tell you about some of the procedural changes that we will be trying out today. The first change to mention is that we have slightly changed the order of the agenda from what you received in your Bulletin. We did this to facilitate some of the other changes we felt were necessary. The new Agendas are these buff colored ones which you will find on your tables, or up here at the front of the room.

One of the more regular complaints that we hear has to do with how Assemblies are conducted. GRs often don't feel that they have adequate time to discuss matters before they vote. We believe that we have found a creative solution to that.

There are also complaints about the voting process. We're going to streamline that, too. We hear that the process is too

one-sided, that's it's all about people stepping up to a microphone and talking at you. So we're going to try to involve you in the process in a way that you may not have been involved before.

We believe these changes will provide us all with a greater opportunity to participate and make informed decisions, which is, after all, why we're here. We are also fairly certain that some of these changes will provide us all with a greater opportunity to grow spiritually, as we learn which changes work in this context, and which do not. We are as open to discarding those that don't work, as we are open to trying new ideas.

That being said, here's what we are doing today. In our old way of doing things, we only considered items for discussion once a complete motion had been made and seconded. This often lead to motions which were not well thought out, and confusing discussions as we all tried to "fix" the motion and get it passed.

Today, we have set aside a special time between about 11:30am and 12 noon to preview and discuss the agenda items listed under "Old Business" and "New Business". All of these items have been discussed by the Board (Officers and Coordinators) and the Committee (Board + DRs). I will briefly explain what is before you, and why. I will explain what the Committee recommends, and why. If a minority viewpoint was expressed in our discussions, it will be expressed to you here also. If time allows at this point in the day, I will ask for any questions from the GRs about the agenda items. (If time does not allow, we will do that later.)

After that discussion, we will go to lunch. That would be the ideal time to discuss the agenda items among yourselves. When you return from the excellent lunch that the SCAC Committee is preparing, we will go directly into our breakout Action Committee Sessions. These may also be a good place to discuss the matter that you will vote on later. We do ask, though, that you be sure that discussions are specifically relevant to the purview of the Action Committee to which you are assigned. That is to say, it would not be appropriate to discuss Item #3 under New Business, the elimination of the Lone Member Coordinator and the creation of the Website Coordinator in the Group Services Action Committee. It would be appropriate to discuss it in the Membership Communication Action Committee, where it belongs.

If all goes according to plan, when the time comes to make motions, discuss the issues, and vote, you will feel more able to make an informed decision. That brings us to the next change, voting. It has been our practice to "stand and count" virtually every vote. There is nothing in the by-laws that requires this, and frankly, it's usually unnecessary. I will call for a voice vote initially on all, or nearly all, votes. Only if a clear majority is not discernable by the voice vote will we go the "stand and count". This should speed things up considerably.

It is important to note that you all have certain rights and responsibilities in this area. If you believe that I am mistaken, and that the majority status of the voice vote was not clear, you have the right and the responsibility to bring it to my attention. The way that you do this is simple. Before we move on to the next item, stand quickly and call out "Point of Order!" (By the way, this is just about the only time you have the right to interrupt proceedings this way.) When I hear you say "Point of Order!" I will recognize you and ask you what your point of order is. You tell me that you do not believe that the vote was a majority, and I will go to the "stand and count" method.

Most of you probably recall that I came to this service position after having served as this body's parliamentarian. Let me assure you, I will never use my knowledge of Robert's Rules as a weapon, or to accomplish any personal agenda. If you don't know how to phrase something, just tell me what you're trying to accomplish, and I will try to advise you on the proper procedure. It is my role here to make sure your voice is heard.

Which brings me to the final point: making your voice heard. Any Assembly such as this is naturally somewhat limited. We have a lot of people, and not much time. So we ask that you be careful to use this time wisely. Please limit your statements at the microphone to only that which is relevant to the issue being discussed, and hasn't been said by someone else. Please don't speak for more than 2 or 3 minutes, we do use a timer. I will establish which microphone is to be for "Pro" comments, and which is for "Con". Please respect that.

I may limit debate further if I see that everybody is speaking for a motion, and nobody against. In that event, I will ask the Assembly if anyone will speak against the motion. This is the opportunity for anyone who holds the minority viewpoint to speak up. It is said in Al-Anon that the most important voice in the room is the minority. If you haven't discussed your beliefs with your tablemates, but you're sitting quietly in the back of the room, and you believe that everybody else in the room is wrong, you have a responsibility to speak up at this point.

If nobody speaks at that time, we may suspend debate and vote.

It is clear that we are trying a number of time-saving measures. We are not doing this so that we can all go home early. I'm sorry. We're doing this so that we will have more time to perform the tasks our groups sent us here to perform. We're here to learn more, participate more, to grow and change Southern California World Service into a more responsive and active organization so that it will be available to more people who, like us, have been deeply affected by another person's problem drinking.

Al-Anon saved my life. It has also saved the lives of untold thousands, perhaps even millions, worldwide, in part because of what we do here. But there are more out there who are in desperate need of this program, and do not even know that we exist. It is to carry the message of hope to those families and friends of alcoholics that we are here today. Let us remember that when we disagree. Let us remember what holds us together when we feel divided. Let us put aside any petty differences for the greater good, for the unity of the program, so that we can show by example, the unconditional love and peace of the program of Al-Anon.

<u>1. PRAASA</u>: Saadia, D33, moved that Board Members attend another RSS (Regional Service Seminar) in close proximity to our Area each year rather than PRAASA. Seconded, voice vote, motion failed. Aggie, D9, moved that Board Members attend PRAASA if invited by AA only when in Southern California. Seconded by Saadi, D33. Voice vote, motion failed. Peter, D27, moved that if invited by AA to attend PRAASA Board Members not attend in official capacity. Seconded by Carolyn D27. Voice count, motion passed. Point of order called for standing count. Contributions

Our mailing address is still the same - SCWS, PO Box 350, North Hollywood, CA 91603.Checks and money orders should be made out to "SCWS.

Check with your group's Treasurer to make sure they are using the WSO ID# and our SCWS contribution forms. This will help get your contribution correctly posted in the group contribution report. The WSO ID numbers can be found on the Bulletin label (the one with no letters, just numbers), your Group Reps and District Reps will have this number, and, if all else fails, you can check with the WSO directly.

A copy of the WSO contribution report has been passed on to me by Mary, so you can check it at the break if anyone wants to have a look.

Reimbursements

SCWS reimburses Officers, Coordinators, District Reps, Group Reps and Liasons for mileage and lodging according to the following guidelines –

•Mileage

Officers and Coordinators – \$0.30 per mile for all miles driven to districts, board, committee, assembly and special committee meetings.

Liaisons, Group Reps and District Reps – \$0.30 per mile for every mile over the first 100 miles driven (November 2000 Assembly)

Hotel

\$50 for hotel reimbursement for all officers, coordinators, group reps, and liaisons who commute over 100 miles one way (November 1998 Assembly)

Page 11 of our Bylaws outlines an Accounting Review Procedure for our Area, which includes our Audit Committee, Chairman and Treasurer. The Audit Committee requires receipts for reimbursement. To be reimbursed, you must submit ALL the receipts - unclear requests will be returned for clarification. Mileage is paid only to the driver, on the honor system. Alternates are reimbursed if they are serving in a voting capacity re: as GR, DR, etc.

Our Service Manual has guidelines for expense reimbursement for mileage as well. Please take a minute to review them on p. 125 and 126.The 7th Tradition may be reimbursed by your group as well, check with your meeting Treasurer or ask in a group conscience meeting.

•World Service Handbook p. 125

"Each group provides its GR with sufficient funds to fulfill the GR duties including participation in the Assembly. Expenses may include meals, transportation, accommodations, and registration fees. Overhead expenses of the Assembly and the cost of sending the Delegate to the World Service Conference are paid by the Assembly with contributions from the groups within the Assembly area."

•World Service Handbook p. 126

"The DR's expenses to attend Assemblies and Area World Service Committee meetings are shared by the groups within the district. When the DR is also a GR, the Assembly expenses are normally paid by the group he represents."

Now that I have copies of all of the 2006 bank statements so far, I can report to you that our total assets (cash & 3-Certificates of Deposit) as of 4/28/06 are \$28,764.01 .Our target reserve is \$25,000. It increased from \$15,000 and approved at an Area Assembly in 1996 and was reaffirmed by the May 2001 Area Assembly.We are about \$1500.00 short of that \$25,000 goal.

History and Background of PRAASA

The following document is provided for informational purposes only.

DEFINITION

PRAASA = Pacific Region A. A. Service Assembly.

PRAASA is held annually in early March and invites AI-Anon participation (it has a separate AI-Anon committee creating its own program; however, it is not self-supporting).

BACKGROUND

•The November 1972 Assembly sent our Delegate only.

•In May, 1979 the boundaries for our Area changed and we became part of the Southwest Region. At that time SCWS voted to still attend the 1980 PRAASA as it was in Anaheim and to send our Delegate to the SWRSS in Albuquerque, NM. At that time (1980) we decided that we would not attend PRAASA any longer.

•In 1982, if invited by AA, we voted to send the Delegate and Chairperson, however the chair could not attend so another board member was pulled from the "hat."

•The February 1984 Committee voted to contribute \$500 initial funds for Al-Anon portion of the next PRAASA. In the November Assembly of that year we decided not to attend the 1985 PRAASA due to distance.

•November, 1985 send to PRAASA number of Coordinators as finances permit.

•August, 1986 send as many as we can afford. November of that year we decided to participate in PRAASA once again.

•The November 1986 SCWS Area Assembly voted to send some of the SCWS Board members to PRAASA.

•May, 1987 recommend that next years Officers determine whether to participate or not. In November of that year it was recommended to participate.

•August, 1988 Assembly to decide re PRAASA.

•November, 1988 Committee to decide who goes, same decision reached at the February, 1989 meeting.

•The May 1989 Assembly voted to, each year, send the Delegate, Alternate Delegate, Chairman and the Immediate Past Delegate as well as 1/3rd of the other Officers and Coordinators thus enabling all the SCWS Board members to attend PRAASA, at least, once during the current term.

•In 1992 contributed \$500 to PRAASA once again for start-up fund.

•Aside from working in cooperation and maintaining Al-Anon's ties with Alcoholics Anonymous, prior SCWS Boards, Committees and Assemblies have considered PRAASA to be a means of training for the SCWS Area's trusted servants by attending Al-Anon workshops (as well as the AA ones).

•However, in the last <u>+</u> 6 years the other Areas in our SW Region ceased sending its Area's trusted servants to PRAASA. Instead those funds are being used to send these members to the SW Region Delegates' Meeting (SWRDM), the SW Region Service Seminar (SWRSS) and to other Region's RSSs aside from the SW Region.

Note: With this in mind please review the Recommendation made by the AD Hoc Committee which follows this page.

PRAASA Recommendation from Ad Hoc Committee

PRAASA AD HOC COMMITTEE RECOMMENDATION FOR MOTION

The PRAASA Ad Hoc Committee requests the SCWS Area Assembly to consider the following:

We recommend the following motion:

That the SCWS Area send one-third (chosen by lot) of all the Board members to other service functions rather than PRAASA each year.

- --The Board members will be chosen by lot each year and once their position has accepted this choice, they will only attend one function during their three-year term.
- --It is further recommended that each year, those that have been chosen by lot attend one of the following events during their three-year term:
- 1. an RSS (Regional Service Seminar), outside of our Southwest Region
- 2. an Area Assembly Meeting in another World Service Area in our SW Region
- 3. PRAASA or another Al-Anon service function deemed appropriate by the Board

During the three-year term of serving the SCWS Area, the Board will make the decision as to which function to attend each year - taking into consideration the financial feasibility of attending said functions.

The covered expenses to be paid by the SCWS Area will include:

- 1. airfare or mileage (whichever is less),
- **<u>2.</u>** registration, event package price (room and meals) or, two nights stay at a hotel (with two Board members sharing a room whenever feasible, or ¹/₂ rate only if one chooses not to share a room and pay other ¹/₂ at one's own expense),
- 3. two days' reimbursement for expense of meals (must submit receipts).

(FYI – The SCWS Area sends the Delegate, Alternate Delegate, Immediate Past Delegate and Chairperson to SWRDM [Southwest Region Delegates' Meeting] each year during their 3-year term.)

Board members assigned to this Action Committee are Group Records Secretary (Jayme P.), Minutes Secretary (Marge V.), Treasurer (Suzanne P.), Alateen Coordinator (Daniel K.), Alateen Sponsor Coordinator (Ajit S.), and Archives Coordinator (Martha M.). A report from each coordinator follows the Action Committee Chair's report.

Group Services AC Chair

Greetings from the Group Services Action Committee. This Committee includes the Archives Coordinator, the Hospitality Coordinator, the Alateen Sponsor Coordinator, the Alateen Coordinator, the Treasurer, the Minutes Secretary and the Group Records Secretary.

At the May Assembly Break-Out Sessions, we heard a brief report from each of these Coordinators. In addition to that we broke into smaller groups, with each member choosing to be part of a smaller committee headed by one of these coordinators. Website Coordinator

Much of the action committee meeting was spent answering questions regarding the website, the WSO web site and websites in general.

POSSIBLE ACTION: Searchable area of the web site to post questions and answers regarding WSO & SCWS web sites.

There seemed to be a lot of acceptance of the idea that information could be e-mailed or available on the web site instead of traditional mail or waiting for the Assembly. Specifically, the Bulletin was mentioned.

ACTION TAKEN: A new SCWS Blog has been created called Bulletin Reduction. Notes from that topic of the meeting have been put in to that Blog. Please review and comment. An adhoc Bulletin reduction committee could be formed to come up with some conclusions.

There were questions regarding whether we could transfer the operation of the website to another person besides Alvar. One of this panel's goals is to ensure that we can transfer to another by moving the site to purchased hosting and training others on content management. A question was also asked about don't we need to pay for the professional services?

ACTION: Technologies and features are being added with easy-to-use, standard commercial methods with separate support so that a layman can operate the site. We have used the same method to transfer the content management of the Orange County Intergroup website to a non-technical content manager volunteer and it has been a successful effort.

Currently most all the volunteer time is spent in modifying and updating content. There are some fees in the website that are paid by SCWS which are for the domains and website hosting. There will be a cost of \$20 a month for hosting the Blogs without advertising.

We brought up that we have a hard time getting critical content for the website such as meeting listings for all the districts. Some DRS suggested they could be involved in retrieving this information. There were a few suggestions of using the SCWS meeting list to post meetings on the website. There were questions/requests to be able to update meeting information using Internet technologies. Some considerations:

-Updating meeting records on a password protected webpage -Being able to email a meeting change into the records secretary

ACTION: The website coordinator is researching the viability of integrating the existing records technology and list into a web page.

Mary, our current Delegate, had presented that we had a goal of increasing the use and awareness of the WSO Members web site at http://al-anon.org/members/. Some methods were discussed.

 \cdot Create a printable flyer / ad for Websites to increase awareness

• Add SCWS web site address to the meeting phone list The topic of facilitating On-Line Meetings was raised. Such as providing chat or other Internet meeting tools and techniques.

 \cdot Chat can be an expensive technology

 \cdot We should prioritize needs so we get some actions completed

• Anybody is welcome to start their own on-line meeting, using 7th Tradition funds to pay for a commercial chat solution

· There is an existing list of on-line meetings in Mary's Delegate report

I am looking forward to comments and questions.

Public Information

Board members assigned to this Action Committee are Cooperating with the Professional Community (CPC) Coordinator (Sandra W.), Institutions Coordinator (Shirley M.), and Public Information Coordinator (Amanda C.). A report from each coordinator follows or is included in the Action Committee Chair's report.

Public Outreach AC Notes

Robin J., Chairperson, opened with the Serenity prayer. Agendas and a sign-in sheet were passed out to all attendees. Coordinators were introduced.

Amanda – Public Information Coordinator began with her vision of Public Outreach actions for the remainder of this three-year period. She said that she believes it to be the best committee because we are helping people. Amanda discussed her view of her role as coordinator. She would like the members to all participate in taking information to health fairs and the like, to let her know a month or so in advance would be helpful. She is working with the web people as well. She suggested we check with the northern California website which she feels is light years ahead of us. There is a district (#78) in Imperial Valley that is not a part of any intergroup and Amanda is currently reaching out to them – again, overlapping and coordinating with the website committee.

Some areas pass out business cards at health fairs with local telephone numbers. Another district passes out old schedules with a disclaimer that the information may be outdated and to call the Information Office number for current updates.

Sandra – Cooperating with the Professional Community Coordinator passed out Sign-Up Sheets for a base of people willing to participate in any panels or requests for information. She told us that she receives emails saying that a school needs a speaker and she cannot personally meet all those needs, but with a base of willing volunteers she can then coordinate an Al-Anon (or several Al-Anons) with those making requests. Sandra also put in each DR's packet a pamphlet (P-90) about Attracting and Cooperating. She suggested that each district have their own coordinator. She also introduced us to the Best of Public Outreach packet available from WSO. Further mentioned was Prescription Al-Anon (#M77) available for the professional community also available from WSO.

We were reminded that the September issue of the Forum might be ordered for mass distribution during September, which is National Recovery Month. A number of groups verified that they had done that in past years with very good response.

Also introduced was the "Crying House' bookmark (#M-76) available in quantities of up to 1000, free of charge except for \$3 shipping fee.

Shirley – Institutions Coordinator told us that she had put her Institutions coordinator report in each DR's packet. She is seeking out information on the California Governor's Advisory Committee, which includes people from AA. She believes there are 2 "chairs" available at this Committee, which could be, used AI-Anon. She is ambitiously seeking information/inclusion in that arena.

Katherine asked if there is a time required for people to speak on panels. Robin suggested that we use common sense requirement of at least a year in program.

Finally, Amanda suggested the group break into smaller groups to decide on a project for the coming term. There were approximately 10 people per group discussing their ideas. Time constraints limited group discussion on ideas/plans that they had come up with.

Evaluation Sheets were collected at the close of the meeting. Due to the entire Assembly voting to complete the AM agenda before breaking for lunch, there was a bit of confusion as to start and stop time for the breakout groups. In spite of some confusion, it was a wonderful head start for Public Outreach Action Committee.

Institutions Coordinator

Survey. I am trying to determine the scope of our Area's Institutions work. I have sent survey forms to Area Intergroups, placed one in each District Representative's file today, and given a copy to each action committee attendee to take back to their groups. I will report back when I receive sufficient information. This will give us the knowledge to decide what

action our Area might want to pursue during this panel. Also, if one group is looking into a area of service and another is already doing it, the active group could serve as a resource.

Form for Local Use. I also serve as Institutions Coordinator for Ventura County Intergroup. The District Coordinator and I work as co-chairs and also work with the other outreach chairs. A copy of a form we used to get a list of volunteers interested in service is provided for action committee attendees to take back to their groups.

<u>H&I Conference.</u> As your Institutions Coordinator, I attended the 25th Annual Southern California AA Hospitals and Institutions Conference. One purpose of the conference is to improve understanding and cooperation between Alcoholics Anonymous (and Al-Anon by virtue of AA¹s invitation to us to participate each year) and hospitals, correctional, and treatment facilities. Speakers and panelists include AA and Al-Anon members and professionals from the treatment and correctional institutions.

A thank-you goes to Danelle Murray who has served as Al-Anon's program chair for the past three years and to MaryLou V, outgoing Institutions Coordinator who served as Chairman. Al-Anon speakers this year included Nancy and Scott R., Los Angeles, Brian W., Lori M., MaryLou V., and Randy T. from Orange County, and Holly O. from San Diego. AA speakers included members active in H&I service and members who came into AA via a treatment facility. Several came to AA in prison and are returning to prisons to carry the message.

California facilities have been given \$31,000 per year to facilitate volunteer services for inmates. Federal, state, and local facilities' speakers provided information about the various volunteer programs. AA is an important one. Having the funding may help Al-Anon to be able to enter the facilities.

Facilities speakers included Hector Lozano - Coordinator of Sierra Conservation Center Prison Facility, Ray Guerrero -Deputy Sheriff, Orange County; Gregory Dorst - former Deputy DA and now Treatment Center Consultant, Diana Gelletien -Program Coordinator FCC Lompoc, and Kevin McCauley, M.D. - Director of Medical Education at Sober-Living-by- the-Sea.

Mr. Lozano has established the first faith-based program utilizing the steps. He mentioned that they spoke to visiting families about an inmate's need to continue going to meetings when released. After the meeting I asked him if he had considered having an Al-Anon panel or program for the family visitors so that they could find recovery also. This might be an area for Al-Anon groups who live near prison facilities to consider working with prisons and jails to establish (as well as continuing to try to get Al-Anon meetings into jails and prisons). Even if we can not get meetings into these facilities, we may be able to provide information about meetings in California or contact numbers and literature for family members to help them find meetings in their home area.

At the Conference last year and this year one could sense a change for the better in the corrections institutional arena as they seek to improve the recidivism rate in California. AA members can now arrange to meet a released prisoner at the gate or arrange a meeting with inmates after they leave prison which was not allowed in the past.

Any Al-Anon member is welcome to attend this conference and I hope this overview will entice you to attend next year and to consider this area of service. <u>PRAASA</u>. is the Pacific Region Alcoholics Anonymous Service Assembly. Alcoholics Anonymous usually invites Al-Anon to participate by presenting a service program for Al-Anon members. It was held in our local area this year. Most of our Board members participated in the Al-Anon program. Delegate Mary M. shared a "What's on Your Mind" session with Jack S., Past Al-Anon Trustee on Sunday morning. Jack was also our luncheon speaker.

Al-Anon members were invited to participate in the evening AA Round Tables. I attended the AA Treatment Round Table and my co-chair attended the Institutions Round Table. AA has a program called "Bridging the Gap" (between a treatment program and AA) which includes a Temporary Contact Program designed to help clients make the transition. I know that Al-Anon has a presence in treatment facilities. I am wondering how the action committee members feel about Al-Anon doing something similar to help the family members with whom we come in contact make the transition to Al-Anon. AA has a pamphlet "Bridging the Gap". Members might want to pick one up to get an idea how the program works.

At the Institutions Round Table the AA chairman said that there is a Govenor¹s Advisory Committee on which AA, NA, Nar-Anon, and Al-Anon are invited to sit. Al-Anon has not attended. I did make contact with the current AA person from Southern California. The committee has not met for a year. He will let me know when the committee resumes meeting. I would like to attend to see if it is something that will allow us to speak for the families and maybe open more doors for us in state institutions.

Any Al-Anon member is invited to attend PRAASA, also. Next year it will be held in Portland.

Action Committee. In our Action Committee small groups time, each group was asked to come up with a project that could be done by groups all over Southern California. Our group suggests that Al-Anon groups place literature in Women's Shelters. One of our group members said that location information could be obtained by visiting a Domestic Violence Center.

I am willing to be of service so let me hear from you. I am pleased to be a part of Public Outreach. We have a great area Public Outreach committee.

We want to write and submit an article about the project to the Forum.

Annual fundraising event: Marion has agreed to chair the annual fundraiser. It is scheduled for Sat. Sept. 30th.

GR Outreach: We currently have 9 GRs in a district with 44 meetings. So we are in the process of attracting new GRs. We have a committee of three working on a welcome memo, collating materials to give new GRs and visiting the groups. So far we have attracted 3 new GRs: two of whom are attending the Fullerton assembly this May. Jayme Parker has been super helpful in updating our records.

Alateen: Our Alateen Liaison has found it challenging to keep up with the duties of the position, so we have formed a committee of three to work on Alateen issues in our district. We have significant communication problems right now and hopefully this will improve with the committee structure. Perhaps other districts are experiencing this also with all the changes in Alateen.

All in all, we are growing and becoming more organized and we have a good spirit.

Ask-It Basket Questions

ASK IT BASKET May 20, 2006

Q1: Can a group open a checking or savings account as a non-profit organization?

A1: Non-profit status is awarded to organizations and/or corporations which meet specific requirements. Please see pp 93-95 in the Service Manual re: Incorporation of WSO, Assemblies, Intergroup. Individual groups usually do not incorporate; incorporating is done by businesses to protect physical assets, including office equipment. Achecking account may be opened using one member's information. As there is no interest earned, that member will not have any tax ramifications.

Q2: As a District Representative how do I get GRs from my District to join me in going to Assembly when we have to drive over 300 miles roundtrip and they don't want to go to "LA".

A2: Refer to the Group Rep. Guidelines (G-11 – can be obtained from the WSO website) – it states the GR's duties including attending Area Assembly meetings. Attending the twice-annual Area Assembly meeting is one of the items on the Group Representative's job description on p.109 of the Service Manual. You could also hold a training session for GRs using the information from the Service Manual and Guidelines.

Q3: Can you put the mileage reimbursement form in the Bulletin to eliminate confusion and time spent?

A3: (From Area Treasurer) No, because mileage and other reimbursements are for the trusted servants of SCWS, I prefer to keep those forms available only at the SCWS Area Assembly and Committee meetings.

Q4: One of our meetings that meets at a local church has been asked by the church for some liability insurance. What are our options, if any?

A4: There is nothing in the Service Manual that addresses this issue other than Tradition 4 "Each group should be autonomous, except in matters affecting another group or Al-Anon or AA as a whole. Some suggestions are as follows: <u>1</u>. Ask the church if they can have a rider on their policy or <u>2</u>. Ask the church officials if they can include a "hold harmless clause" for the Al-Anon meeting in their policy

3. Obtain quotes for purchasing your own policy.

4. Move to another location.

Q5: Can a DR be involved in Alateen without being qualified? [note: We assume this member means "certified".]

A5: Any Al-Anon member (including a DR) who wishes to be of service to Alateen in any way must meet the requirements as outlined in the Alateen Safety Requirements and be certified.

Q6: I need better clarification as to who is authorized at the District level to certify or sign off for Alateen sponsors.

A6: The SCWS Minimum Safety and Behavioral Requirements for Alateen Group, Alateen Sponsors, and Al-Anon Members Involved in Alateen Service states, "The two signed forms must be submitted to Southern California World Service Alateen Sponsor Coordinator or other designated individual by the local District Alateen Liaison or District Representative, if there is one...." (p.2, #2.)

Q7: Why doesn't a DR have to be certified? Don't they have to deal with Alateen in their position, especially if they have Alateen GRs?

A7: Neither the Service Manual nor the Area Safety and Behavior Requirements list certification as a prerequisite for the District Representative. However, because of the fact that there may be Alateen GRs and the DR may be called upon to have direct contact with the Alateens in their district, he/she should <u>consider</u> certification. There may be more specific information about this in the near future.

Q8: As an Alateen sponsor, I brought an idea to the Al-Anon meeting that meets at the same time as the Alateen meeting. I asked the Al-Anon meeting to make an announcement for parents to pick up their Alateens soon after the meeting because the church has received complaints from neighbors of loud talking, trespassing and trash. In recommending this announcement, the Alateens voted me out as an Alateen Sponsor saying that I violated the Traditions by "trying to govern." Did I break the Traditions, or was I acting as a trusted servant? Could I have handled this differently?

A8: According to the first part in Tradition One, our common welfare should come first; apparently that is what your intention was when notifying the parents. Neighbors' complaints can lead to a meeting being discontinued. As an Alateen Group Sponsor, the safety and appropriate behavior of Alateens is one's concern. However, in order to build trust, it is important to maintain open discussion of such issues with the Alateens at the meeting. Perhaps this type of situation may be addressed in one of the Alateen CAL reading materials; there is no reference to this in the Service Manual.

Q9: I would like guidelines on the appropriate means for handling contributions and scholarships for Southern California Alateen Conference. Specifically: <u>1</u>. Is it appropriate for the District treasurers or individuals to collect the funds? <u>2</u>. Is SCAC part of Al-Anon, Alateen or is it an outside function? I ask only because this is a major controversy every year.

A9: <u>1.</u> 1. According to the Service Manual on p.51, Financial Policy, "the group does not provide financial aid to members in need. Individual are free to help others in need as they choose." Many times, in order to coordinate the donations from the individual members of the meetings within a District, the District Treasurer or its Alateen Liaison keeps the donation and then forwards it to the SCAC committee. Group funds are to be used for group purposes only, not for personal gifts to members (p. 79 in the Service Manual). <u>2.</u> SCAC is a "stand on its own" function as is any other convention even though it is recognized by the SCWS and its Chairperson becomes a member of the SCWS Committee. SCAC is the annual conference of Southern California Alateens. Alateen IS Al-Anon and its conference does not limit participation of Alateen members because of geography.

Q10: Can a GR be absent for 6 months and then come back and say, "I am the GR."

A10: Please refer to Tradition Four. Such a decision is up to the autonomy of the group. Part of the GR's responsibility is to represent his/her group at the District as well as the Area level. If the GR is not attending these meetings, nor bringing back information to the group and vice-versa, the GR is not keeping up with the most basic of responsibilities to the group. On page 124 of the Service Manual it states, "If the GR resigns or proves to be inactive, the Alternate completes the term." Refer to Concept 9 also, (p. 171, SM), which states, "Good personal leadership **at all service levels** is a necessity."

Q11: Our meetings use a blue sign-in sheet on which we write our names and note expenditures and collections. Originally members listed their phone numbers on the sheet. Now, however, we have separate phone lists. People sign their names on the list and tend not to look at other announcements clipped underneath them. Have other groups stopped using this signin sheet? Have groups considered the question and decided to keep using it?

A11: Page 26 of the Service Manual has suggestions of duties for the Group's Secretary (including: keep an up to date list of members and their telephone numbers) and on page 27 there is an outline for the Treasurer's duties (including: keeps a record of all receipts and expenditures).

Q12: Are we going to discuss the article from the Forum magazine, "I Felt Abandoned" at this meeting?

A12: The agenda for each Assembly is set up prior to each meeting and in order to accomplish the business that must be addressed, we adhere to the agenda as presented in the Bulletin as closely as possible. There are several sharings about high-pressure groups in the May, 2006 *Forum* and also look for replies on the WSO website (www.al-anon.org/members). Many people asked about this *Forum* article and it appears it is a topic that many people want to discuss. Next year's Sharing of Service (SOS) will incorporate many of the topics discussed as reported in the Conference Summary. One of those topics for discussion will be about high-pressure groups and controlling sponsorship, and it is hoped that those who attend that workshop will have the opportunity to discuss this topic.

Q13: How is Al-Anon's time counted? Is it from the first meeting? If someone leaves meetings for 2 or 5 years, do they start over?

A13: There is nothing in any of our CAL that addresses this. This is the personal choice of the individual in question, it is wise to confer with one's sponsor before making the decision.

Q14: Can a GR appoint an Alternate GR?

A14: See Service Manual p. 124, which says that the alternate group representative is *elected* by the group/meeting.

Q15: As the group rep, how do I respond to a long-time member who says that having members fill out the Group Inventory form (G-8), would just open up a "whole can of worms."

A15: If doing an inventory would open a "whole can of worms," then it's definitely time to do one! Al-Anon Guideline (G8) says, "Taking a periodic group inventory helps keep your group healthy and invigorated. Members use the inventory to discuss new service opportunities and address major or minor concerns before the group's unity is disrupted." Also, the group conscience should decide to hold this inventory, not a long-time member.

Q16: Is it possible to get the agenda for Assembly meetings to the Group Representatives sooner so items can be more thoroughly addressed by the group?

A16: The Assembly agenda is formulated at the Committee Meeting preceding it. (The committee consists of officers, coordinators, district representatives, information service reps., and convention chairs.) The setting of the Assembly agenda is the purpose of the Committee. District Representatives may bring the proposed agenda items back to their districts and help the Group Representatives understand each issue. The formal agenda is printed in the Bulletin preceding each Assembly.

Q17: When giving my report to my group as a GR, another member who is a GR for another group talks over me to fill in any gaps she feels I've left out. How can I handle this with love?

A17: The best way to resolve this is to talk about it. As its GR, you are the group's trusted servant trying to do your best. Ask the other GR to meet with you after the meeting to inform you if you have missed anything, if so, you will announce it next week.

Q18: Why does it take so long to resolve issues in Assembly? When I was group rep <u>last</u> year, we were voting on PRAASA. Why? When we vote and pass or not pass something, why do we vote again and again?

A18: According to Concept 5, "The right of appeal and petition protect minorities and insure that they be heard". This allows the pros and cons to be heard – it is often said that decision making, within the Al-Anon service arms, takes a long time. At the World Service Conference, Delegates often face motions that have surfaced time and time again that may need further clarification. If a motion is unclear, the usual procedure is to defeat that motion and make another. When no decision can be made, or it seems that the issue would take over its share of time, the motion can then be tabled. This is what happened with the PRAASA motion. The ad hoc committee on PRAASA has prepared its recommendations and will present them to the SCWS Committee in August.

Q19: Re: PRAASA—can we vote on item A.1 and B. combined?

A19: The motion is voted on as proposed by the GR making the motion - unless it is amended.

Q20: Has there been a change in Conference Approved Literature (CAL) to include the AA Big Book? Some old timers claim it is OK in meetings to refer to the Big Book, saying that is what Al-Anon springs from.

A20: No. Under "Outside Publications" at the bottom of page 85 in the Service Manual, it states, "In the spirit of unity, it is suggested that only Al-Anon and Alateen Conference Approved Literature be used and displayed at meetings. It is well to remember that all AA literature is written for and from the viewpoint of alcoholics and is not Al-Anon and Alateen Conference Approved Literature. Reliance on opinions expressed in AA and other publications can distort the Al-Anon approach, particularly for the newcomer." Also, in the middle of page 86 it states, "It is ignoring Traditions to promote

the sale of outside literature". By promoting the AA Big Book we are not remaining "self-supporting".

Q21: Many groups are not contributing to World Service Office right now because they feel the WSO has misappropriated funds. They are also withholding the appeal letter because they feel strong about this topic. 1. Is this act against the Traditions? 2. Is it time to form a committee to discuss this ongoing issue?

A21: Tradition 1 addresses unity and our common welfare. Tradition 12 reminds us to place principles above personalities. The "Three Obstacles to Success in Al-Anon" encourages us to avoid gossip and to talk to each other to reason things out. Therefore, it would be good to talk openly with our Delegate if you have concerns regarding withholding funds from WSO. It is important to gather the facts from those who have the knowledge. If the quarterly Appeal Letter is being withheld from the group, it is depriving the individual member from making their own individual contribution.

Q22: What can a group do about a member who is reluctant to give specific parts of a service commitment long after their term is up? The context is that this person is of service in many meetings in several capacities and continues to have their home address as the contact to WSO, etc.

A22: Using the principle of rotation of leadership, the group has the right to appoint someone else to be the Current Mailing Address (CMA). Many groups choose to establish the GR as the CMA as their term is for 3 years. The group Secretary should fill out the registration change form and send to WSO and SCWS.

Q23: Mi grupo quiere saber que se nesecita para ser un RG y alterna.

Q23: My group wants to know the requirements to be a GR and GR alternative.

A23: En el Manual de Servicio paginas # 132-133-134-135, describe los deberes de un RG como eslabon vital en el funcionamiento continuo, crecimiento y unidad de Al-Anon en el mundo, El RG es la voz del grupo, vota en los asuntos de las Asambleas, participa en la eleccion del Representante de Distrito, Delegado de area y oficiales del Servicio Mundial Sur de California. Al no tener RG se priva el grupo de estas oportunidades. Un RG alterno es electo para cubrir al RG en sus funciones.

A23: Pages 132-135 of the Service Manual describes the duties of the GR as a vital link in the continuing function, growth and unity of world Al-Anon. The GR is the voice of the meeting, votes on issues at Assemblies, participates in the election of the District Representative, the Area Delegate and officers of SCWS. Not having a GR deprives a group of these opportunities. An Alternate GR is elected to cover for the GR in the event that he/she cannot attend all functions.

Q24: Puede un pasado RD en la junta de distrito tomar la palabra y quitar la agenda del RD presente?

Q24: Can a past DR take away the agenda of the present DR? **A24:** Mirar la pregunta # 25. La rotacion de liderazgo es importante aqui, el nuevo RD necesita tener la oportunidad de aprender y crecer como la tuvo el pasado RD. La mejor manea de tratar estos asuntos es la comunicacion con la persona envuelta. Se recuerda que la 1ra y 2da. Tradicion, aplicada aqui, nos regresa a la solucion ESPIRITUAL del problema.

A24: See answer to Q. 25. Rotation of leadership is important here. The new DR needs to have the opportunity to learn and grow just as the past DR did. The best way to deal with most issues is to communicate with the person involved. Remembering that the 1st and 2nd Traditions apply here bring a SPIRITUAL solution to a group problem.

Q25: Can a past DR come to a District meeting and take the group's inventory and also take over the present DR's agenda? **A25:** When you're done, you're done. Concept Ten refers to "service responsibility is balanced by carefully defined service authority and double-headed management is avoided". It is important to remember the principle of rotation of leadership. The new DR is elected by the GRs of the district and is a trusted servant who is learning and doing the best he/she can. Speak with the former DR, asking that these interruptions stop and if there is a problem, bring it to the District's group conscience. No one is in authority over another.

Q26: We are dealing with a controlling, micro-managing DR controlling the floor on issues.

A26: The language of Concept Nine can help us identify the qualities that our leaders should possess and members of the group need to be aware of these as they choose their trusted servants. Tradition 1 says that our common welfare comes first; and Tradition 2 states that we do not govern, that God is the only authority. If the group is unhappy with the DR, they should speak to him/her or call a group conscience to discuss this at a District Meeting.

Q27: We are often reminded about who has voice and who has vote at Assembly and Committee meetings. A topic was brought up at the last Committee meeting by an Al-Anon member who did not have voice. Shouldn't the Committee decide on whether or not they want to do that? Doesn't this set a precedent that our officers can decide to ignore the by-laws?

A27: This is not stipulated in the By-laws; the determination on who has voice and/or vote was established during past years by the Area Assembly via motions and voted on by the GRs, thus making it policy. (These motions are listed on the SCWS website.) This may be answered in the text of Concept 5 in the Service Manual in the discussion of our Right of Appeal. The gist of the text of Concept 5 is that "a person may petition for the redress of a personal grievance, carrying his complaint, if desired, directly to the Board of Trustees (in our case, the SCWS Board members). He should be able to do this without prejudice or fear of reprisal."

Q28: Does Al-Anon have a standard statement explaining what cross talk is? Is it appropriate for a group conscience to use language like this: "Cross talk is defined as talking directly <u>to</u>

or directly <u>about</u> another group member." What should our group bear in mind when taking a group conscience about this statement?

A28: There is not a standard definition. "Cross Talk" is not included in the Service Manual index. Occasionally, it is referred to in individual sharing in the Forum publication. If your group wants to use the statement you referenced, it can by group conscience, although the language may be more specific.

Q29: Is it acceptable within a meeting when someone is sharing to have a listener comment simultaneously, such as "that's right", etc. Would this be something that can or should be addressed by the GRs?

A29: This could be brought up at a group inventory. It is simply within the group's autonomy as to the conduct of its members.

Q30: Can a person who has admitted that they are alcoholic and says they no longer attend AA meetings be a Group Representative. Does the dual member policy that is in the Al-Anon/Alateen Service Manual have to be upheld by the District Rep.?

A30: The language in this section says that an Al-Anon/Alateen member who is *also* a member of AA is not eligible to serve as GR. Assuming that the person is working an honest Al-Anon program, it is up to that individual's conscience to make the decision as to whether or not (s)he qualifies to be a GR. Yes, in order to be an example of being of service, a DR adheres to the Service Manual's suggested policies to the best of his/her knowledge.

Other topics included:

—How to avoid the dreaded 'open topic' meetings by finding creative ways to have topics for discussion (e.g., topic jar, reading from daily reader, Alateen Talk, etc.)

—How to deal with tardy parents who are late in picking up their kids


—Younger children (under age 10) in groups that included teenagers
