New thinking! New Energy! and Abundant Outlook. Nuevas ideas – Nueve energia – Innumerables posibilidades!

What an incredible experience this 2nd Conference has been for me! Once again I cannot express the gratitude and awe that having the position of Delegate has given me. It is an honor beyond measure and my life, my thinking; my attitude will always be more significant due to this experience.

Thanks to all those Districts that sent "Love Gifts", they were a big hit. I really appreciated all the cards and notes from all of you. District 40 sent homemade white and dark chocolate butterflies that were quickly "gobbled" up. District 64 sent some great yarn pins and the Ventura area sent wonderful beaded key rings. **(SHOW)** Thanks to District 39 for helping assemble the votive candles with the Conference theme on them! I had some special gifts made for most of our Trustees and some staff and they really were happy to receive them. I gave Ric one of our pins from this year's AFG Convention. It is so wonderful to have such caring, giving people in our Area. Once again I have brought back many love gifts from other Areas to share with all of you.

They are on the back counter; please help yourself to one or two. I also have a binder of pictures and items that you might like to look through.

I would like to start with our "Rules" presentation. By now most of you are familiar with this but we will show it on the screen again for all of you to see and "use". (**PPT**)

In the interest of shared leadership, I will be giving information I received at the WSC to other members of the Board to share throughout the day. I hope you find this more exciting and interesting and that it helps to spread the enthusiasm that I felt at the Conference.

I have a PowerPoint presentation on **KBDM** that I would like to share briefly with you. (Knowledge Based Decision Making). I have handouts for all of you today regarding this process. Not everything will be in this format, we have to be flexible and use good judgment. The four essential elements for this process are:

1. Open communication between leadership and membership (talk to each other, reason things out).

2. Dialogue before deliberation. This is the opposite of Robert's Rules; we are able to discuss the information, questions and concerns before constructing a motion. Quite often thru discussion we really don't even need a motion, many times all we need is the discussion. 3. All decision makers will have common access to full information.

This can be confusing. Sometimes all members think they should have access to all information, whether they are part of the decision making body or not, we might think sometimes that everyone needs it too. However, Concept 4 "Participation is the Key to Harmony" does not say that all are invited to participate, only if it is our role as part of the decision making body, so we are better prepared to be a part of the discussion. With this comes trust.

4. We exist in a Culture of Trust. This principle is one of the first we experience when doing Al-Anon service. A belief that none of us would do anything, knowingly, to hurt Al-Anon. Our spiritual principles are applied to the decision making process.

PRESUME GOODWILL!!

Most all of the motions at the Conference were discussed prior to vote and we reached substantial unanimity on all of them. Several were our usual motions re seating, budget, etc. These were all presented in the form of a motion and voted on. Others that needed to be framed and discussed were done in the KBDM manner.

Whenever a motion was made to change the descriptive text (**Motion 7**) as in the Concepts text and the Service Manual (**Motion 10**), we had substantial discussion not only in the assigned committee meetings but also on the Conference floor. **Motion 12** was carried by a show of hands "To approve a major change to the book, "How Al-Anon Works for Families and Friends of Alcoholics (*B-22)" to move the Concepts to a prominent position in this book and **Motion 13** to add brief descriptions of the personal applications of each Tradition and Concept.

Motion 14 was the direct result of the Delegates getting together and presenting this motion re approval of the Alateen Traditions as written on page 43 and 44 of the Service Manual with the only change to text in Tradition Eleven from "TV and Films" to "Films and TV." HAPPY BIRTHDAY ALATEEN, YOU HAVE CONFERENCE APPROVED TRADITIONS AS WRITTEN! In addition, Sandie, our Alternate Delegate has a presentation from the Conference, which is a challenge for all of us!

One of the workshops discussed pyramid sponsorship. These are some of the comments:

Causes divisiveness. We need to protect our good name. No terms as babies, pigeons.

We should follow our legacies. WSO received two anonymous letters from persons afraid to give their name. Refer to pages 114-115 in the manual. Also Concepts 6, 7, 9 and Warranties 2 & 4. Al-Anon does not give advice, no idolization. We need to be concerned and protect from dilution. It is our responsibility to protect from infiltration. It also compromises the safety of members, pg. 197 of the manual violation of the Traditions; they are out-of-order. The principle is being distorted diverting from our spiritual aim. We need to strengthen our structure. We could pass out Bill and Lois' sponsorship talks. Refer to the Conference Summary from 1967, Sponsorshipwhat is and isn't. Use people with experience to pick speakers for your events. "Pushing against gives them more power." Find the solution in Al-Anon family groups not in pyramid sponsorship. LET IT BEGIN WITH ME.

We were presented with three Big Questions one each for the first three days of the Conference. They were:

 How do we create a future that is more responsive to the diverse needs of Al-Anon Family Groups?

omeone How can Al-Anon, formed by Traditionalist and re-energized by Baby Boomers apply new thinking, new energy and abundant outlook so that Gen X-ers and Millennials (Gen Y) will feel welcomed by us, and will want to join Al-Anon?

s t How can we maximize our abundant resources throughout the Al-Anon Family Groups structure allowing for flexibility in sugge meeting the needs of our fellowship at every level?

Hope these new ideas will stretch beyond where we are; we need to start where we are and look to the future.

We will handout a Big Question sheet to each of you so you ы 0 can come up with a Big Idea for the end of the day using the eer question you have from one of the above. We will try, if we have time, to read over some of them later this afternoon, if not volunt they will be published in the Bulletin. Remember, "Big Thinking" is like a kaleidoscope, ever changing but all the same parts, each beautiful. (Share from the mic some of these near end of the day)

I brought back several other Areas' newsletters to give to <u>с</u> our Bulletin Editor to look over. Also, I have one events calendar produced by the Minnesota So. Area, which might be something for us to think about and perhaps produce one of our own. ש

Davi Once again WSO has produced a new PSA (public service announcement) and we are happy to show this to you today. Amanda, our PI Coordinator, once again will be giving copies Contact of this to all of you that would like it. Amanda will show the new PSA.

I do have a copy of the new budget for 2007 and the 2006 Financial Statement. If anyone is interested, please see me during the lunch break. The WSO would like to remind all of you that as of this year taxpayers will be required to have a receipt for each cash contribution on their US income tax returns. The other item addressed by the WSO was the use of work e-mail addresses. If it is a work address, the WSO as well as our Area assumes that the employer has approved of the use of company e-mail for personal business. If not, then the Al-Anon member should not provide that address to anyone s t as it could lead to discipline or termination which could be far more serious for some than the issue of breach of anonymity. Each of us needs to consider this fact as well as whether it is a good idea to use our full names in e-mail addresses whether 0 C on a work computer or not, before providing it to other Al-Anon members or any service arm, including the WSO.

We set a goal at the 2006 Conference to see an increase in our participation on the WSO websites. Overall we had a sizable increase to all web sites. The WSO is still looking for sharings from all of us on the eCAL site, especially with different types of media; please think about submitting animation, music, etc to the site.

I also have some forms for the U.S. NWRSS in Minot, North Dakota. Several of our service Board members have chosen to go to this RSS since we will not be having one in our area. Martha M went to the U.S. SERSS in Charleston and she will be reporting on her experience there sometime today. There will be Board members attending Assemblies in other Areas of the Southwest Region also. They will include Northern California, Arizona, Colorado and Nevada. Not having a RSS

(Regional Service Seminar) for our Region has given this great opportunity to our service Board. There were some new ideas at the Conference as to whether to continue having RSS' or look into some other ideas, i.e., having WSO Trustees and employees come to our Area Assemblies as this might reach more members, just something to think about.

I was in Virginia Beach a few days early and my husband and I took a tour of the WSO. Joe, in Archives was so helpful and he gave us a copy of Lois' letter from May, 1951 asking for ideas and suggestions as to what to call ourselves and whether to adopt the AA 12 Steps. He also gave us the timeline for the first two years (from May, 1951 to February, 1953). For those of you interested in seeing these I have them at the back of the room in a binder near the "Love Gifts."

This year was the election of a new Chairperson of the Board. I am happy to report that Zelda R, who has been our Treasurer these past 3 years, was given substantial unanimity by the Conference and then elected by the Board of Trustees as their Chair.

Cynthia H, whom many of you know, is retiring this year. Cynthia has been Associate Director of Member Services-Conference, she has done an amazing job and her untiring ability will be greatly missed. I, for one, will miss all the communications and tireless answers to questions that she has provided to me over the past two years. I especially will miss her friendship and willingness to be of service. Her replacement will be Suzanne M who has been with the WSO for the past 10 years.

Finally, I would like to report on the 2013 International bid. Our Assembly voted to put in a bid for Anaheim and that we would be willing to provide enough support, 100 or more people to help with this international. I met with the Anaheim Convention Bureau person in March and they in turn, had their east coast representative meet with me to give our presentation on Friday, April 28th, the day after the Conference. We presented with the idea for the theme "WORLDWIDE RECOVERY: AL-ANON/ALATEEN IN 2013". The presentation went fairly well, but the AV equipment that the WSO provided did not work well with her laptop, but she was able to show her CD on Anaheim but not the Power point presentation, by that time it was in God's hands not ours. The selection committee had us wait in the hallway after our **10 minute** presentation in case they had any guestions after discussion. Some of the other Areas were called back in when it was their turn so we hoped we would be also. However, the rep had to leave to catch a plane to DC and so I waited. I was called back in and some questions were asked, for instance "What about the other conventions in your area?" I told them they didn't have to worry about other conventions and that perhaps the issue would be whether or not I had my annual 4th of July party at my house with 200 people and a band and I said I was willing to not have the party and could assure them of 200 people at the International (just joking!). It went well and I answered a few more questions and then my time was up. I am happy to report that WE have been chosen as one of the top three sites!!! In August this year, a Site Selection Committee will be visiting us here in Anaheim, as well as Denver, CO. and Vancouver, BC. The results will be decided at the October Board of Trustees meeting. I am truly excited that we were chosen!

David, the Chairperson, opened the meeting at approximately 10:05 am. Trish (D30) read the Traditions. David stated that we would roughly follow the agenda as printed in Feb 2007 Bulletin. Most of the morning will be spent on the Delegate's report, followed by a preview of old business and new business before lunch. Action committees will be grouped a little differently today, basically because we lost an action committee chairperson and due to the similarity of mission statements and goals. Group Services and Member Communications have been combined. Public Outreach remains the same. Alateens will serve lunch promptly at 12:30.

This panel has been challenging mainly because of the high volume of turnover. We are in need of a new Alateen Sponsor Coordinator - someone who has substantial time as an Alateen sponsor. Please talk to David today if anyone who is present is interested. If not, please make the announcement at your groups. It's a fearless and daunting commitment, as well as MOST rewarding. This position is responsible for conducting the Alateen workshops for the Area, visiting and speaking at Districts around the Area, etc. This position does **not** include the responsibility of processing the paperwork sugg involved in the certification process. This is the responsibility of the Area Alateen Process Person (AAPP), a position which is also open. The AAPP duties, are currently being backfilled by Sandie, our Alternate Delegate, until we can get this position filled. Thank you, Sandie for stepping up to the plate. Please announce the need for someone to fill this position too.

Treasurer Report: See the Bulletin for a complete report, including the Profit & Loss statement for the 1st quarter of 2007.

Delegate's Report: See the Bulletin for a complete report. Mary brought back love gifts from the Conference, please be sure to look over them and take what you want. Knowledge Based Decision Making (KBDM) was used at the Conference. A handout describing the process was available for those in attendance. Mary went over some slides describing the process. New bookmark on sponsorship should be available Davi by summer.

Sandie provided briefing about a "warm fuzzies" project in relation to Alateen.

A skit was presented by various members – the same skit that was done at the Conference pertaining to generating new ideas "outside" the box to address various generations and getting all to feel welcomed in Al-Anon.

Amanda provided the briefing about the new PSAs. Last year there were paid actors involved in the PSAs, and WSO received some "concerned" feedback on this practice. This year the PSAs have been done a little differently – the series is called "sketches". We were able to view a couple of the PSAs. If you're interested in getting copies of these PSAs, email Amanda with an address and she will order and send them.

Mary proposed the following theme (which may or may not be selected): "Worldwide recovery, Al-Anon, Alateen in 2013", for the 2013 International Convention. We submitted a bid for Anaheim, which has been chosen as one of the top three sites. In August 2007, the selection committee will travel to Anaheim, Denver and Vancouver to make their final selection. The final decision should be made at the October board meeting. Alternate Delegate: See the Bulletin for a complete report. The premium for our new liability insurance is about \$3500/ year. Our current provider will refund us for the unused portion of the prepayment. The new insurance company requires background checks. I have looked into another company to do the background checks, as there was a lot of concern voiced that the company we were previously considering required SSN. A form will be emailed or mailed to every certified sponsor. These forms MUST BE RETURNED TO SANDIE BY JUNE 15. This is a hard deadline because we have 60 days from the time the insurance in force in which to complete the background checks on approximately 400 people. Name, current address, maiden name, all aliases, DOB, place of birth

and cities you've lived in for the past 5 years. SSN is optional. The background company provides an on-line database that subscribes to the national crime and sex offender database. Cost is \$10/person, billed to the Area and paid by the Area. Sandie will be doing the checks against the database; therefore she will be the only person who has access to the personal information provided on the forms. The data will not be passed from one board member to another. No opt-out option. Forms are not ready today but will be on the website. If you are a current sponsor you will get this form via email.

Laurie requested that once Sandie conducts background checks, the SSN be blacked out on the form for those who optionally filled it in. Sandie stated that she would comply with this request.

Marlene asked if these forms should go directly to Sandie, and wanted to know what role the DR or District Alateen Liaison played in this process. Sandie stated that since the goal is to have the least amount of people involved in handling this personal information, forms will go directly to the Alateen sponsors from Sandie and should be returned directly to Sandie.

Brad (D27) asked how this fit in with our Tradition of anonymity. Response was that within the fellowship we are not anonymous. Names and other information are not going outside of our group. This has been discussed several times at previous Assemblies.

Kay asked what was covered for certified sponsors. Sandie stated that she did not have the exact information with her. This was also covered at previous Assemblies.

Bernadette (D63) offered assistance if anomalies found, such as two people with the same SSN, etc. She previously worked for an identity theft company.

Someone asked if they could opt to give just the last 4digits of SSN. Response – anything will assist. SSN is not required but if you list the last 4 digits, it would certainly assist with the background check.

Heidi (D24) asked if this activity superseded our previous vote regarding the Alateen Safety Requirements. Response: No. The Safety Requirements has words to the effect that "...a background check may be necessary..."

Holly (D21) stated that June 15 is 3 weeks away. Not confident that forms will be returned in time. Can hard copies be mailed and marked URGENT? What happens if not done by June 15? Response: Those who don't have email addresses will receive copy of form via US mail. On second thought, Sandie will send hard copy to all with self-addressed, postage paid envelope.

Ethel (D51) wants to be an Alateen sponsor and wants to know if she can be certified in time so that she can go to SCAC. Response: Sandie will do all she can to make that happen.

Mark (D66) asked how current the database was. Response: No idea – assume it is state of the art because it is acceptable to the insurance company. Sandie will conduct the background checks herself at this time so that the information is only available to Sandie. This does not mean that she won't need help later...remember, we're looking for someone to take over the APP job.

Alateen: Brown bag lunches are available today. Merchandise for SCAC is available for purchase in the back. Theme for SCAC is "Understanding New Hope". Chairperson is Shanna G. of Fountain Valley. Date of the conference is July 6-8, 2007

at the xxxx. The cost is \$110. Last chance to register is June 23rd at the Last Chance Picnic at xxxx, Long Beach. A \$5 donation is suggested to attend the Last Chance Picnic. SCAC registration forms will be available at the picnic.

<u>Minutes Secretary:</u> Cathy asked if anyone had any corrections to the Minutes for November 18th. Minutes were approved as written.

Records Secretary: Not sure why some of you are not getting your Forums, as Jayme stated she is getting three of them. All DR's, committee members and Intergroup Liaisons – please pick up your mail. Jayme received the list of meetings from WSO this week and she is looking for volunteers to help to go through and separate this list – maybe from District 57? With enough help the reports can be mailed out before our next meeting. If not, they will be available at the next meeting.

<u>Preview of Old and New Business</u> - Discussion of old and new business only – we are not here to argue one side or another, we are only discussing and asking clarifying questions.

Expansion of May Assembly Meetings: Proposal by board to expand the May Assembly by 2 hours. Start at 10 AM, have lunch between 1&2, have a break in the afternoon, and conclude no later than 6 PM. This expansion would allow more time to complete the business as the May Assembly also includes the Delegate's report from the WSO Conference. The rental cost for the additional time is \$55/hr, resulting in an additional \$110 rental for the Senior Center facility. Have already checked with facility and it is available for our use. If approved, the change will take effective May of 2008.

Q=Question; A=Answer; C=Comments

Q-Can we put a time limit on reports? **A**-Yes, we can. We already ask that everyone other than officers limit their reports to 2-3 minutes.

Q-Marilyn D72 – can we start earlier instead? **A**-This option was discussed previously and we can discuss again. Some Districts already have to leave 5 AM. Orientation begins at 9 AM...this would result at orientations beginning at 8.

C-Kay – there is a provision to help people who come a long way – hotel provisions.

Q-Why isn't there a time limit for officers? **A**-[Long, very long pause by David. He's thinking...and thinking.] That suggestion has been discussed in the past. The rationale as I understood it is because of the Delegate and Alt Delegate's reports, which contain a great deal of information. In addition, sometimes officers are filling more that one role and needs more time to communicate.

C-Kathy D75 – Agenda should be followed with time slots. **C**-Gloria D30 – Officers deserve to have the time they need to communicate and give reports.

Nomination of Regional Trustee: Nominations need to be submitted by August 2007. David read the qualifications for this position.

Q-Donna D66 – Is this a volunteer position without pay? **A**-Yes, volunteer w/o pay.

Q-Rose D30 – What does "authority under law" mean? **A**-Refers to Concept 7. Has fiduciary duty to support and build the organization of AI-Anon, a legal entity. Authority=Responsibility.

Q-Patricia: Are trips & hotel expenses reimbursed? **A**-Yes.

Int'l Convention in 2008: "Connecting People Around the World", in Pittsburgh. Area has previously sent the Delegate with airfare, hotel and meals. Will ask for a proposal this afternoon to send our Delegate.

When we return from lunch, we will go to break out sessions. Public Outreach will meet in Hospitality Room; Membership Communication and Group Services in main Assembly room. 7th Tradition passed around.

Adjourned for lunch at 12:35. Reconvene at 1:30 for breakout sessions.

Assembly reconvened at approximately 2:50 PM. Concepts read by Julie D/3.

Combined Communication: <u>Combined Group Services and Member</u> Communication Action Committees

For this Assembly May 2007, two ACTION committees were combined. They were Membership Communication and Group Services, which have similar Mission Statements including: to encourage participation and enthusiasm for carrying the service message in a timely and informative way and to create interaction between the groups, Southern California World Service (SCWS), and the World Service Office (WSO).

Per the Service Manual, the purpose of the Assembly is to elect a delegate and to receive and distribute reports on area and world service affairs, hence, to communicate. For this Assembly we focused on finding out how best we can communicate. We also had a PROJECT presentation by Lucia our SCWS Literature Coordinator (see her report for details). Based on the feedback forms fill out by attendees, they learned a lot and enjoyed the computer graphics, including viewing the new E-CAL format, as well as the pamphlet meeting ideas they heard and could take back to their groups.

The second half of the hour involved having SCWS Board members sit at the round tables and listen to the GRs and all attendees' ideas about communication. We tried to make sure that each person shared. We, the Board, listened and learned. Summaries of what we heard are included at the end of this report. The feedback response forms indicated that members definitely liked this. What they liked least were the long day and long reports (the lunch had multiple votes too and comments will be passed on to Alateen). All comments from the feedback forms along with summaries of the roundtable discussion are being shared with the ad hoc committee that is working on the restructure (we are now mid-way through a second 3-year trial using ACTION committees) and with the area board members. Thank you for your invaluable feedback. It helps us to find ways to serve you better so you can better serve your groups.

When we asked, "What could be the best way for us to communicate with you between Assemblies", <u>email</u> was chosen, overwhelmingly. The Bulletin was the second most popular and telephone was voted as least effective. We will begin a big push to get members emails, including asking DRs for their District's email lists (where one exists). You can sign up yourself (and update your preferences) at our SCWS website: scws-al-anon.org, or directly at <u>http://scws-al-anon.org/lists/?p=subscribe&id=3</u>.

The feedback forms also listed many ideas for improvement that the board will discuss and consider. Thank you for your suggestions.

At the round tables, we also discussed the following 2 *questions. Your responses will be shared with the SCWS Board and with the restructure ad hoc committee. A summary will also be included in the next Bulletin. *How can we (SCWS) get information to you and also help you share your service ideas with others? *What suggestions do you have on how

these Projects/Action Committees can enhance your service experience and can inspire and help you to carry the Al-Anon/ Alateen message?

FEEDBACK FORM COMMENTS included:

We also asked "Did anything at today's meeting encourage you to take an action idea (PROJECT) to your group and/or District? If so, what?" According to the feedback forms, the majority were encouraged by what they heard today and plan to take things back to their group such as: skit on Big Questions, magnetic meetings, Lucia's pamphlets (by far most common response), e-cal and online information (second most popular), Alateen and outreach (tied for 3rd) (keep in mind that Public Outreach was presented in a separate room, so more people were taking outreach ideas back to their group but the responses reported here are just from those who attended the combined May ACTION committee for Group Services and Membership Communication), others listed: getting more GRs, list District meeting in local directory, panels, getting information to meetings, Bulletin, attraction rather than promotion, Al-Anon business cards at gas pumps, moving district meeting locations, more feedback, video, utube, Al-Anon Declaration, involving younger members, putting website on phone list, suggestion to shorten reports, group topics.

(NOTE: I did proof read this after compiling it, but my sincere apology if I incorrectly typed something someone wrote or listed it under the wrong category.)

When asked about "the thing I liked most today," the most common response by far referred to breakout discussion (with specific comments like sharing, interaction, communication, small group participation, hearing from everyone, board listening at tables), other responses included: making a motion, Alt. Del information and Alateen report, Chair's organization and humor, Web report, Literature report, getting younger people involved, board commitment, board enthusiasm, looking forward with new ideas, lunch, pace of the meeting, being here, being a part of, everything, finding out what other groups are doing, GR orientation, positive attitude, receptiveness, enthusiasm, love gifts, problem solving (KBDM), trying skits (but please rehearse more), Gloria, visuals, and encouraging us to be of service. In addition, multiple responses were received for: fellowship, information, hospitality room, e-cal and Delegate's report (9).

The things listed as, what "I liked least today" included: lunch (as the most common answer with specifics listed as: not enough water, not enough diversity, white bread and cabbage on salad listed twice, unhealthy - prepared with bare hands), reports too long, thought of expanding 2 hours, morning session not focused enough, beginning introduction, no agenda, confusing schedule changes, don't understand terminology, waiting until late in day to vote, confused, redundant questions from members, no recycling bins, wasting time (repetition of what will be in Bulletin), Miriam's skit, morning too long before lunch, sitting, long drive to get here, crosstalk, small groups, skits, delegate's report, CD can only be used in computer (want it for car too), day to long, being at first Assembly, being talked at too long.

Suggestions for improvement included: greeter at the door, better lunch, good food I'd pay for - that was miserable, cater lunch (\$10), provide recycling, replenish toilet paper more, go outside, but the most suggestions were about reports.

Comments about Reports included: shorter presentations, cut down on verbiage, keep presentations shorter and to the point - highlight what's significant and important (1, shorten reports, focus agenda on what GRs need to bring back to their groups, more timely agenda, timed reports with more structure to agenda, topic driven reports with just what needs to go back to group, better lunch, more bullet times for shorter reporting, work more effectively - people must police themselves because their time at mic is really a form of dominating, more efficient presentations, time efficiency, time respect the crowd, synopsis of important points, schedule time slots for all reports so you're more efficient in use of everyone's time, be more professional in reports with less jokes to respect our time we took to come here, take less time, streamline get to the point because sometimes it's belabored until it is very dull, shorter reports, timed presentation for all, keep reports concise with a time limit (this was better about the schedule than before).

The <u>Agenda suggestions</u> were: send reminder letter about Assembly including agenda, address, etc, provide printed agenda copies since many of us didn't receive our first Bulletin yet, remind Alternates who don't get Bulletin that they can see it online, business in the morning and reports in the afternoon, spread microphones around the room, limit the number of questions, allocate sidebar time for answering specific questions like definition of "authority by law", add open microphone time, (don't let my negativity get you down, it's my problem, not yours), have lunch at noon and resume at 1 and end promptly at 4, time to share communication problems with district and share service ideas,

ACTION committee suggestions included: serve brown bags so we can work in ACTION committees during lunch, ACTION committee time with sack lunches with no hour lunch away from premise, let me participate in all 3 of the ACTION committee meetings, limit ACTION committees to 15 minutes and rotate 1/3 of us to each one so everyone gets to attend them all, use ACTION committees to develop agenda items for the following Assembly, have printed guidelines and agenda for small group discussion so time isn't wasted, don't have one person dominate the group,

General comments included: rotate Assembly location around area, rotation of Assembly location, print website address real big in the Bulletin, put links from Intergroup websites to SCWS-Al-Anon.org and WSO website, link to SCWS from all Intergroup sites and to other Intergroups, lets work together between Intergroup and District, coordinate information locally, have meeting address in the online bulletin, print Assembly address online, when updates are made to website then send out an email to registered participants (like Wikipeida), simple email breakdowns, compile all this feedback so it isn't gigantic and put it in Bulletin and on website, sell books at Assembly especially newer items, make group service attractive so more want to do it (attraction not promotion) and so we're more knowledgeable instead of just more people. keep up the good work, keep doing a great job - thank you for your service, thank you for your service, great overall balance between listening and participating, keep coming back, thank you

Public Outreach Questionnaire Summary

The following are responses to our Public Outreach Action Committee Evaluation & Questionnaire Forms. Most of the commentary is in direct relation to the specific areas of Public Outreach. Sorry for the delay in putting this together. The past couple of months have been busier than normal for me.

Public Outreach Action Committee Evaluation & Questionnaire Responses:

-Give guidelines for what we hope to accomplish in breakout groups.

-Robin's Note: Do we want to reconsider doing one specific project instead of giving ideas, inspiration and "how-to" guidance? If we decide to change direction and do a SCWS project, we could do (a) one project from each of our 3 areas or (b) only one under the heading of Public Outreach? We could also consider doing one per year - e.g., Institutions the 1st year, PI the 2nd and CPC the 3rd.

-If we do 3 separate projects - one for each of our 3 areas we should consider asking for "sub-chairs" to head each project and work with / report to the Action Cmtee Coordinator. This is being done in Colorado. It gives more people "hands-on" projects, lessens/distributes the workload and provides more ownership and enthusiasm of the project chosen.

-"Public Outreach should remain one large "organization" instead of 3 different Outreach areas."

-"Provide a list of all drug and alcohol rehab centers in my location." Robin's Note: This is one area where we could have a "sub-cmtee chairperson" for the different areas within SCWS boundaries.

-"Need definite definition of what this cmtee wants to do as a group. "Tell me what to do". "Give a specific "action" to be taken.'

-"Brainstorm & then encourage specific action items to work on. The Institutions Group did that. We voted on one of the 2 ideas, and were invited to contact Shirley to let her know what our ideas were on the 2nd idea which was 'prison outreach'."

-"The enthusiasm of the coordinators was the needed encouragement to take an action idea to their home group."

-Institute email & cell phone systems for "live chats to brainstorm ideas in lieu of in person cmtees".

-Keep the lunch break standard. This time our Outreach Breakout time was cut short.

-"Discuss how to get home group members to understand they can break their personal anonymity." Robin's Note: This can be a quick explanation at the very start of our breakout meeting.

Request a better "Mission Statement".

-Use our Area Assembly as a "clearing house" of information for Districts & Intergroups to use as they see fit in their individual areas.

-Give us the name & phone number of someone to call as a "personal mentor" for people new at this. Robin's Note: Continue

Greetings from Ventura County! Since we last reported in February, Ventura County has been oh, so busy with Al-Anon Information Service work...I'd like to share that with you today. •24/7 Al-Anon/Alateen answering service – 229 calls from family members or friends needing help – whether to obtain meeting information and/or reaching other members who make themselves available to speak with those who seek help.

•Al-Anon 's web site *www.alanonventura.org* – on average there are 18 "hits" every day, resulting in approximately 1,000 "hits" to our web site over the same two month period. A "hit" is someone/anyone accessing the information posted on the web site to include Meeting List, Intergroup Events, The Forum Magazine, Alateen and Young Members, District 12 Events, local Conventions and Round-Ups, Calendar, Spanish Information, Institutions and Professionals, Intergroup Scoop Newsletter, and lots, lots more.

 Intergroup Scoop Newsletter – We published approximately 220 newsletters with complementary newsletters for the Al-Anon and Alateen meeting groups (via IGRs), Southern California World Service, other Intergroups and Information Service Centers within Southern California, and the World Service Office. Our newsletter is filled with members' experience, strength, and hope and gads of local happenings and activities. It is your newsletter and is also available as a personal subscription at our cost of only \$7 per year.

•Public Information – We are looking into the effectiveness of paid advertising in the Verizon yellow pages and use of Public Service Announcements via TV, radio, and newspapers as suggested in our service manual pages 91 and 92.

Also under the purview of Public Information (but printed by the web site coordinator) we updated and printed over 1,000 directories and made them available to local meeting groups at our cost of \$5.00 for a packet of 25 directories – I think we all agree, newcomers should not leave a meeting without a directory and phone numbers.

Institutions – 2007 is turning out to be yet another banner year – Charlyn has new panels going into recovery homes, shelters, and the women's jail – we will share experience, strength, and hope and leave gads of conference approved literature at each event. Under her leadership we have five on-going panels and the willingness among Al-Anon members to participate in this great service work is awesome.

•Cooperating with the Professional Community (CPC) – We continue to distribute the special Forum magazine "Al-Anon Faces Alcoholism" to professionals (your doctor, chiropractor, dentists, and don't forget the hairdressers). Obtaining their business card and forwarding it to Kay D will get them on a distribution list for future contact and other conference approved literature – a great way to reach out to people (like you and me) who have been affected by the disease of alcoholism – wonderful and thank you!

It is the generous contributions of Ventura County Al-Anon members that allow this vital service work to happen...I am truly proud to be a part of Ventura County Al-Anon and Alateen Family Groups.

ALL REFERENCES TO PAGES REFER TO THE 2004-2006 AL-ANON/ALATEEN SERVICE MANUAL UNLESS OTHERWISE NOTED.

Q1: a.) Can District funds be used for purposes other than the District needs?

A1: a.) Page 126 talks about uses of District funds which are, but not necessarily limited to: DR's expenses to attend Area Assemblies and Committee meetings in addition to direct District expenses such as rent for District meeting space and reimbursement of expenses for District committee members in conducting their duties. Many Districts use their funds to pay for sending their DR and/or Alternate DR to special Al-Anon service conferences such as Regional Service Seminar (RSS) or other Al-Anon service related events. Many Districts put on their own events such as Alathons and Al-Anon service/ educational workshops. All these expenses are within the District's financial purview. Also refer to page 142.

Q1: b.) Can District funds be used for convention registrations? A2: b) No. Page 79 discusses "Gifts to Members". "Group funds" [and by extension, District or Area funds], "are used for group" [or District or Area] "purposes only, not for personal gifts to members." This guideline applies to all levels of service.

Q2: Are out-of-print Al-Anon books and pamphlets still "Conference Approved" and for use in meetings?

A2: See page 82. "Conference Approval" is the process for development of recovery literature (including recovery literature with a recovery focus) that reflects the group conscience of the Al-Anon Family Groups through actions taken by the World Service Conference are delegated to the WSO Literature committees for implementation. Each item, when completed, bears the Conference Approval seal." Because a book or piece of literature is out-of-print that does not mean that it has lost Conference Approval. Many times, the demand for a book (ie. First Steps) diminishes to where the point where it is no longer re-printed. Sometimes a new book revision replaces an older version and may be re-titled. It is within the group autonomy to decide which Conference Approved literature to use, however, using a publication that members cannot obtain for themselves may not be the best idea, and the newer edition should be used.

Q3: What is happening with the Spanish literature? There is no literature for the Spanish-speaking members.

A3: All Al-Anon literature is translated into Spanish and French and is available from the Southern California Spanish Service Center and directly from the WSO.

Q4: If someone is writing a book for publication and they want to use a common short phrase or slogan from Al-Anon literature in the general text of the book, must they use a footnote? A4: The procedure for receiving permission to reprint from Al-Anon publications is explained in depth on page 88. It does say, "When reprint permission is granted by the WSO, the appropriate credit line must accompany the excerpt." No one holds the copyright to our slogans.

Q5: I'm troubled that some members "rename" and then mistakenly refer to Al-Anon Mini Conventions, Share-a-Thons, Workshops or other get-togethers as "retreats". Retreats are described on page 99 of our <u>2004-2006 Al-Anon/Alateen World Service Manual</u> and do not belong in Al-Anon. Can we avoid future confusion or misrepresentation of legitimate Al-Anon functions by suggesting that members refer to page 72 of our current Al-Anon/Alateen World Service Manual? This gives several definitions of legitimate Al-Anon functions and promotes "knowledge-based decision making."

A5: Page 72 is an excellent reference. Page 99 clearly says that "the name 'retreat' often has religious connotations and could imply affiliation if used in connection with an Al-Anon/ Alateen event." Tradition Six applies here as well.

Aside from "service arms" sponsored Al-Anon events, such as those referred to in the above question, there are other events that are put on by members of Al-Anon for members of Al-Anon. Even though these events may enhance someone's growth in Al-Anon they are not to be publicized nor announced at Al-Anon meetings – before, during or after. This is because these type of events charge a fee, including or in addition to its registration fee, and are often **limited** to either men or women *only* and are **limited** in the number of those who may attends (usually also have a waiting list). Limited attendance thus does not open the event to all of Al-Anon which then makes such event an "outside entity" even though by and for members of Al-Anon.

Q6: What is Al-Anon's policy on workshops? Does page 72 of the service manual imply a change? Can workshops be announced at meetings? Will World Service accept cash contributions from workshops?

A6: There has not been a change in policy. These events are commonly held and supported by members. The key thing (<u>not</u> clearly stated) is that as the event is called an Al-Anon Workshop or "Share-A-Thon, etc. avoid the dilution of the program by using outside literature (any that is not Conference approved.) Certainly WSO would accept a donation from an <u>Al-Anon</u> workshop (however, not cash; it will accept a check, cashier's check or money order), etc., and yes, <u>Al-Anon</u> workshops may be announced at meetings.

Q7: How do you handle an over-bearing member who tries to input their opinions on the

group? **A7:** Tradition Two reminds us that the only authority is a loving God. Bo member has the right to monopolize or control a meeting. The "Three Obstacles to Success in Al-Anon" lists dominance as one of the obstacles that will detract us from our spiritual aim. The over-bearing member should be reminded of this, perhaps by a study of this Tradition or by discussing the problem in a group inventory meeting, or by speaking to the member directly. See also "Group Problems and Solutions" on page 52.

Q8: Does a District meeting have to close with the Al-Anon Declaration?

A8: Meetings may close in the manner acceptable to its group's conscience. Often, service meetings close with the "AI-Anon Declaration."

Q9: Why do we sometimes allow members to say "The Lord's Prayer" to end the meeting? This prayer is so closely related to one religion and may be upsetting for members of other religions. Does this not go against our being a spiritual, not a religious fellowship.

A9: The use of "The Lord's Prayer" to close a meeting was started by the early members of AA and many Al-Anon groups have adopted this. On pages 46-47, is the "Suggested Al-Anon/Alateen Closing." The words, "It is suggested that groups close in a manner that is agreeable to the group conscience." This can be discussed at a group inventory meeting. As referred to in the previous question - to alleviate closing with a prayer, meetings often close with the Al-Anon Declaration without chanting anything after it.

Q10: My meeting is concerned that all GRs within the District need to end their terms together in order to follow the 1/3 Area rotation. When did this come into effect? Has it always been the case that all GRs within the District are new together? When newcomers come into Al-Anon, they have a bunch of old timers (and a sponsor) walk them through the Steps and Traditions of the program. What will happen if all newcomers start a meeting together without any guidance and experience. It is the same with the GR commitment. It is nice to have older (in term) GRs to lead the way.

A10: The start and end time of the GR's 3-year commitment is up to the group's autonomy. The Area has established the 1/3 rotation plan so that some experience carries over from term to term and so that all DRs are not new at the same time. This rotation policy has not been mandated for the Districts.

Q11: Can a GR serve more than one term? After serving one term as GR, can I serve as treasurer without being a GR? **A11:** Many Districts have non-GRs who serve as DR, newsletter editor, etc. It is up to District autonomy as to fill their service commitments. Remember, however, only the GR has a vote.

Q12: If GRs represent their group's conscience at an Assembly and then receive more knowledge around "the issue" would it not be more democratic for the GR to take the new information back to the group—and **then** vote on the group's behalf? I understand we are to "follow our hearts" but we are trusted servants of our groups and represent them?

A12: The GR is a trusted servant elected by his/her group. The GR should be as informed as possible when getting the group's voting preferences on any issue. However, it can happen that there is additional information not previously considered by the group, or there is a clarification of a point not understood by the GR and thus not presented to the group accurately. Concept Three says "The right of decision makes effective leadership possible." As a trusted servant, you are expected to vote in a way that reflects the best for the group or Al-Anon as a whole.

Q13: How can we get our District GRs interested in coming to the Assembly? No one wanted to come today. Also, lots of people were going to the Tri-State conference in Laughlin this weekend.

omeone A13: This is a situation shared by many Districts in our Area. Page 109 describes the GR as "A member, preferably with a basic understanding of the Al-Anon program, who is elected, subject to the dual member policy, for a three-year term by his group. (Al-Anon or Alateen.) He attends Assembly and District s t meetings and acts as a contact between the group and the Φ sugg DR, and between the group and the Area World Service Committee." Motivation can be difficult sometimes but there are only 2 Assembly meetings per year and are always on the 3rd Saturday of May and November. It may help to coordinate ы 0 calendars at the start of the commitment. Experienced eer members can help by talking about the fact that the meetings are well worth their time, highly informative and enjoyable. It is volunt important not to let a group be un-represented.

Q14: What is the breakdown for donations to Intergroup, District, SCWS, WSO?

Q15: Where in the Service Manual does it list the suggested 0 4 percentages of the 7th Tradition to send to WSO, Area, District, and Central Office? If nothing is stated in the manual, can you р tell me approximately how many meetings send to the WSO and Area so we can calculate out percentages? סי

ק. ל A14 & 15: Pages 51 and 52 discuss a group's financial policy . מ stating that groups financially support the service arms, which Ã provide service to them. (That is, after group expenses are act met.) It makes sense that the largest amount be donated to the service arms that most closely serve the group, ie. Central Cont Office and District, and who have the fewest groups contributing to them. Southern California World Service and WSO have more groups supporting them and it might be appropriate to send a smaller amount to them. Many years ago there was a Å 0 pamphlet with suggested percentages of the group's donations Å to its service arms which since has been discontinued in order to grant the groups the opportunity to create its own σ artin percentages. (The suggestion back then was: have a reserve to cover at least two month's group expenses, thereafter, 60% to the local central office, 30% to the Area and 10% to the ы СТ WSO. However, since then, many groups are also donating to their District and taken 5-10% off the 60 %.)

Q16: Is it p meetings member? Q16: Is it proper to have AA members speak at AI-Anon speaker meetings? If so, shouldn't they speak with an Al-Anon

Q17: Our Program Chairperson frequently asks AA speakers without an Al-Anon speaker (AA only). Is that within the Traditions?

A16 & 17: Meeting ideas are offered on pages 36-37 and this is addressed in section 8. "An occasional talk by an AA member often presents insights into the disease of alcoholism."

Q18: An Al-Anon group is having a 12 Steps study with AA literature and the leader is an AA person. Can this be done? A18: This is not appropriate for a group to do as it clearly shifts the focus of the group away from the Al-Anon focus. Page 86 reminds us that "AA literature is written for and from **i** the viewpoint of alcoholics and is not Al-Anon/Alateen Conference Approved Literature. Reliance on opinions expressed in AA and other publications can distort the AlAnon approach, particularly for the newcomer. (See also 'Al-Anon Spoken Here' [P-53], 'Why Conference Approved Literature?' [P-35], and 'Alcoholism the Family Disease' [P-4]) According to Tradition 7, In keeping with being selfsupporting, a group that uses and promotes "outside literature", which the AA literature is, is not being self-supporting. Our Al-Anon CAL supports our fellowship as a whole, not outside publications - those promote another entity. Any literature outside of CAL, however useful, ought not be displayed nor promoted at any Al-Anon meeting or event. Members are welcome to use any other literature outside of Al-Anon meetings or events.

Q19: How do we establish an Al-Anon "on going" meeting in the cruise lines? Very often I am at sea and see AA meetings taking place every day at 5:00 p.m. (ship time.)

A19: The cruise lines realize that members of 12-Step groups go on cruises and make a meeting place and time available. The cruise line is not presenting the *meeting*, just offering time and space – you may choose to make arrangements for that directly with the cruise line. (Alternate Delegate's note: I have attended at-sea "Friends of Bill W." meetings and have always been allowed to participate in the meeting, per their group conscience. If there are other Al-Anons who desire a separate meeting, remember, "where 2 or 3 are gathered....)

Q20: Would it be possible to put the address and location and dates of our Assembly meetings and the agenda on our website?

A20: Of course. Thank you for that suggestion.

Q21: If a person who is an Alateen sponsor in your District says he/she is certified, and the DR was not the person to sign off, can Sandie be called and asked if the person is certified?

A21: Absolutely. The person who holds the position of Area Alateen Process Person (currently, Sandie) maintains the upto-date records of all registered Alateen meetings and Al-Anon Members Involved in Alateen Service. The AAPP's contact information is contained in the roster section of the Bulletin.

Q22: What is "cross talk"?

Q23: "Cross talk": what is it? Is there a definition written somewhere?

A22 & 23 "Cross talk" does not have an Al-Anon definition. However, there is some reference to it in past issues of the Forum and it has been defined in many different ways. Some describe it as: talking or whispering going on by one member to another, replying directly to a leader's or another's share rather than giving one's own share, conducting cross conversation without being called on or by talking out of turn. This is to be defined by the group conscience as to what is acceptable or not. Cross talk is adhered to by some meeting whereas others welcome it; it varies by state to state, meeting to meeting.

NOTE: Other questions submitted at the May Assembly not appearing here, will be answered in the next Bulletin (November).

Colorado Area State Assembly – JULY 13, 14 & 15, 2007

Colorado has 3 annual State Assemblies held in rotating locations and 24 Districts. T location as the AA Assembly. Colorado allots 2 hours for locations and 24 Districts. They're at the same time and

Colorado allots 2 hours for their Delegate's report of the Spring Conference. Their Assemblies are longer than ours, include 3 Assemblies annually and have fewer attendees. Nonetheless, we might still consider the importance of allowing more time for our Delegate's report.

Registration began Friday at 4 p.m. with general Host Group sharing from 7 - 8 p.m. 8:15 - 9 p.m. had a workshop on general questions/info of Who's Who, How it Works, Groups, Districts, Area, WSO. It was a general information meeting with group participation. A number of us were given prepared questions on a card for the general assembly to contemplate and answer - e.g., "can an individual group have babysitting paid for out of their own 7th Tradition Funds?" - An Ask-It Basket type meeting.

The Saturday meetings began at 8:00 a.m. and continued till 9 p.m. with a break for lunch and another for dinner.

After roll call, approval of Spring Assembly minutes, etc., they addressed their continued research of Director's and Officer's insurance to be discussed at the next Assembly. This discussion included their plan to bond their Treasurer – currently not bonded.

They have just purchased 3 lap top computers with Microsoft Office '07 software, along with 2 laser printers for a total of \$3,783.37.

Colorado is in its early stages of exploring translation for its Spanish speaking groups and has, thus far, had limited attendance from that population ... (no wonder!). Their research revealed a cost of \$40 per hour for translation.

The vote to make their still trial Action Committees permanent was postponed to their next Assembly.

10:15 - Noon was devoted to Action Committees. Their structure includes 4 Action Committees:

1. Public Outreach

2. Fellowship Communication

- 3. Membership
- 4. Group Services
- **Public Outreach:**

This is the group I attended. It includes (1) CPC, (2) PI, and (3) Institutions. It is further broken into four sub-committees each with its own cmtee chair: (a) HHS (Health, Human Services), (b) Spanish, (c) AA and (d) Treatment Centers. They are considering adding a 5th one of "Prisons".

Currently, our SCWS focus is supplying enthusiasm, ideas, "how-to" information, literature, maintaining a base directory of people willing to participate in panels, etc. CO's process of breaking into sub-divisions with additional chairs (who remain a part of either CPC, PI or Institutions) might offer gree opportunity for a specific "action" to work on as a group. a part of either CPC, PI or Institutions) might offer greater

At our last 2 Assemblies, we've broken CPC, PI and Institutions into 3 separate groups so members could focus on the specific area they believe their District (groups) would best benefit from.

Colorado's PO Action Cmtee stayed together for the entire breakout – as we have done in the past. Their considerably smaller number of attendees makes it possible for more interaction. There are benefits to both ways and I'd like feedback from Amanda, Sandra & Shirley on this. Interestingly, their PO Coordinator told me later they are now considering breaking into separate groups as we do. Is the grass always greener?

The potential "Prison Outreach Sub-Cmtee was viewed with enthusiasm for working with AA in this area. AA in CO has expressed an interest in working with Al-Anon and Al-Anon viewed this as an opportunity to build on resources already in place.

They are considering whether or not they want to be a presence in drug court.

Public Outreach/Institutions has formed a Treatment Center sub-committee, which is assembling a base of all treatment centers, with name, address and phone numbers. Their goal is to include the entire state.

Fellowship Communication:

A major project of this cmtee is converting their "Tape Library" to digital as many of the older tapes are starting to disintegrate. This group includes a literature coordinator who provides literature for sale at the Area Assembly. They are responsible for the "Butterfly" which is their State Bulletin. This includes a "Records Coordinator" who keeps the data base of (1) Group contacts, (2) tracking all AWSC members, and (3) Butterfly subscriptions. Their Butterfly subscription is a "donation" only and those who cannot afford the subscription cost are given free subscriptions.

Membership Action Committee:

This cmtee presents the new GR orientation meeting. It also sponsors the DIA "Day in Al-Anon" which is a service-oriented workshop similar to our SOS. In connection with AA, all Alateens are being given free registration at their State Convention.

Group Services:

They are responsible for all technical support including audio/ visual equipment and translation equipment and any needs of individual groups. They are currently assessing District boundaries.

Saturday, the Conference began at 8 AM with a lunch break (food for purchase by AA) from Noon to 1:25 p.m. The assembly continued until 5 p.m. After a dinner break from 5 – 7 p.m., there was a joint meeting of AA and Al-Anon ending at 9 p.m. Their previous format was a speaker meeting with one AA and one Al-Anon speaker.

There was a Finance Committee meeting held in a nearby home during the dinner break Saturday evening. I had been asked previously to join their PO Action Cmtee Chair for dinner for one-on-one time to share PO thoughts, so I missed the Finance Cmtee meeting.

They have a pamphlet jam-packed with info for new attendees titled "What are Assemblies All About? - or - What Am I Doing Here?" I have a copy to share with you at our Board Meeting, along with other handouts.

Report to Assembly-SERSS in West Virginia-March 16, 17 & 18, 2007

My name is Martha M. I chose as my educational experience to attend the South East Regional Service Seminar (SERSS) in West Virginia. I believe my Higher Power guided to me this function rather than another because I had become arrogant in the belief that I had attended enough Regional Service Seminars. Of course my Higher Power knew this and sent me all the way to West Virginia to make me realize it. I shared a room with a long time friend who moved to Kentucky, and who also was attending the Service Seminar. The love and fellowship I experienced not only at the RSS but in everyone I met along my journey was a promise kept to me by the Al-Anon Program. I was never alone, people were always there to help, and no matter where I go in this world the hand of Al-Anon and Alateen are always there.

On Friday night, as in all the other Regional Seminars I have attended, every person received a badge and a bag full of materials. In the meeting room, the area delegate Mary S. asked for the hands of other delegates in the room. There were 18 other delegates from around the U.S. present. From World Service Virginia Beach-Judy, Chairperson of the Board; Barbara, Alateen Coordinator; Rick, Executive Director; as well as Pat, Amy and Mary staff and Volunteers. Judy told us her personal story. Barbara O. informed us that this would be Judy's last RSS as Chairperson. Her term had come to an end. We were joined by the Alateen Advisory Committee and Trustee, Doris.

After the break we went into Breakout Sessions. In the breakout sessions some ideas passed on were: share the information; you may not like all of us, but you will love us in a very special way; conflict is good as long as we trust the process; the value of the minority opinion; motions are sent to area committee meetings not assembly; growth in action committees; and my personal favorite, you can have the best Chairperson, coordinators & officers as well as delegate-BUT-if the DR's & GR's do not come—it is all for nothing.

Because our Area is looking into expanding our May Assembly I took notes on several states practices in their assemblies. Pennsylvania, Virginia, Alabama, Florida, Arizona, Tennessee, and Kentucky were some of the ones that have 2day assemblies. In all of them the common factor is they make them fun, there are skits, workshops, and sharing meetings besides the reports and discussion that usually goes on. Accommodation and some meals are paid for by first the groups, then the Districts and the balance by the area.

On Saturday, after breakfast at 7:30am, we came together in the meeting room once more. After the Traditions were read, Rick gave his "famous" slide show presentation. He explained that WSO website has a new feature-Lois's voice explaining some history of Al-Anon. He also reminded us that WSO does not resolve conflicts. We need to reason it out amongst ourselves. Rick quoted Mirna E., the past executive director before him, in saying "suggestions are enforced by being willing to be obedient to them."

We then went into workshops. I went first to the Leadership workshop. This workshop was based on Concept 9-The qualities of leadership: responsibility, tolerance, stability, flexibility, judgment and vision. Step 10 + Concept 9 = goal of our fellowship to bring Al-Anon's message of hope to all who can benefit from it.

Next I went to the Anonymity Workshop. Anonymity contains 3 elements:

- 1. Outside Al-Anon
- 2. Within Al-Anon
- 3. In our personal growth

Anonymity- OUTSIDE Al-anon at the Public Level: Tradition 11-pg. 73 of the Service Manual, pg. 121 "How Al-Anon Works", pg. 48 Service Manual, mentions "internet".

Anonymity-IS NOT...a secret society, reveal identity and the groups advertisement. We are anonymous to Radio, T.V. and Films. We are Not anonymous to our fellowship.

Anonymity-WITHIN Al-Anon: Pg. 74 Service Manual-members choose to use their full names OR not. Besides our personal choice-we do not identify each other to anyone. Pg. 121 "How Al-Anon Works" we must also protect the anonymity of all A.A. members, that is why we tell OUR story and not anyone else's.

Anonymity-IN PERSONAL GROWTH: pg. 39 of "How Al-Anon Works" talks about calling someone else. Using mail for Seminars, conventions, etc. We share as equals. Pg. 340 "How Al-Anon Works". To sum it up, we must work on all our sides of the triangle: RECOVERY through the Steps-UNITY through the Traditions-SERVICE through the Concepts.

Public Outreach is the next workshop I attended with Public Outreach director Clair R. We are in a unique position to offer the "before" and "after". The "lucky lottery Service Manual pages.. 73, 89, 90, & 91. These pages tell us how to maintain Tradition 11 and promote and carry the message. The magazine "Al-Anon Faces Alcoholism" is great for leaving at professionals' offices. It is a way for the potential member to find Al-Anon for recovery. Each of us have to access our position on anonymity to be able to carry the message through public outreach. WSO is begging for stories of recovery. Our photos have to be blurred in media appearances. For me personally Al-Anon Recovery makes me

- 1. Live a better life.
- 2. Be a better employee
- 3 Taught me how to have faith.

Outside clubs or organizations like rotary, Kiwanis, etc., are not included in the definition of media like radio, T.V. and Films. E-Cal. WSO needs our summations for E-Cal. We need to invite more people to participate. Any Al-non/Alateen member can submit writings to be published in E-Cal after approval from Delegates, staff, conference and executive director.

We then heard Rick's elevator story. If you have not heard it, you need to attend a RSS. It is a good story on how I was good enough.

The last workshop for today is the CONCEPT WORKSHOP. It is my opinion that this workshop is the best one of all. So much information and learning and sharing.

We heard more on Knowledge based Decision Making. Rick summed up the Concepts into one word for each.


