First of all I want to say thank you for the honor of being your Delegate. Attending the WS Conference was the most spiritual experience of all my 32 years in Al-Anon. To be a part of the largest group conscience of the worldwide fellowship of Al-Anon and to all join hands and say together the Al-Anon Declaration was amazing. I spent most of the week with a lump in my throat. I was told by many of the past Delegates that the WS Conference would change my life. Yes, it has already. I have been entrusted with the gift of your confidence.

Sunday is devoted to the new Delegates and helping to make the new Delegate a success. Everyone wants you to succeed and everything is done to assist in that effort. Orientation for the new conference members (delegates) is three hours. Everything is covered at that orientation from conduct at the Conference, protocol, the voting procedures and many other topics. After the New Delegate Orientation we join all the Delegates and share Area Highlights. Each Delegate is given one minute to share. You must include one success and one challenge of your Area in that minute. It is amazing how quick one minute goes by! A gong goes off after one minute! It is your cue that you are finished sharing! It was such fun.

There were three Skill Building Workshops held throughout the week for the Delegates. They were: 1) How to deal with difficult situations, 2) How to engage audiences and 3) How to overcome fear. What great topics for Workshops! They were helpful, engaging and work! I loved it!

TASK FORCE

I have been assigned to a Task Force which will present to the Board of Trustees in September. My Task Force is to develop a Workshop on the Importance of CAL in Meetings. There are six other Delegates on this Task Force. I am the only newbie.

Sunday night was an opening dinner and each new Delegate is presented with their Conference Pin by their assigned Mentor. Yes, each new Delegate is assigned a mentor. That person is there to assist you throughout the entire week. My mentor was from Alabama!

Everyone is seated in assigned seats and that is your seat for the entire WS Conference. You are seated directly next to your Conference Mentor. I was lucky enough to be in the front row! Wow, did I like that!

ELECTRONIC VOTING

Monday morning was spent with orientation of the Electronic Voting! There were 96 voting members. Yes, we had electronic voting and it was wonderful! The results were instantaneous. What more can I add to that? Process is so quick that it is streamlined to perfection!

FINANCIAL DISCUSSIONS

We were presented with the 2011 Auditor's Report, 2011 Annual Report and the 2012 Proposed Budget. I have all of that information if anyone is interested in having a copy. Please let me know. 25% of our income comes from 58.8% of our groups. 6463 Groups do not contribute yet WSO provides services to all Groups. If each Group gave \$13.00 more per year WSO would meet the 1.5M needed in Contributions. We have never met the \$1.5M in Contributions. If each Group gave an additional \$26.00 more we would meet our Budget expenses. We are at a deficit of \$216,000. If each member gave \$17.00 per year per person we would have over 3 million in contributions.

1. CONTRIBUTIONS Our Spiritual Journey – we get as we

give. Four Primary Ideas:

We are powerless over the problem of alcoholism

- 2. We can turn our lives over to a power greater than ourselves.
- 3. We need to change both our attitude and our actions.

4. We keep Al-Anon's gifts by sharing them with others.

How do we share it? We can make a monthly contribution on the website through our checking accounts. The form is on the member's website and it can be downloaded and filled out and mailed to the WSO. What about this? Some Areas have decided that instead of sending love gifts to the Delegate their Group makes an extra contribution to the WSO. For me it is about changing the culture here in CA(S). Many of the groups in CA(S) were angry because of the purchase of the property and withheld donations to WSO. We get as we give. We want AFG to grow ~ I want to be a part of the solution in changing the culture of giving in this Area. Remember our Fourth Tradition that each Group is autonomous except in matters affecting Al-Anon or AA as a whole. Not giving to the WSO and even SCWS affects AFG growing as a whole. It is about everyone giving something. We are self supporting and each of us giving one dollar at our meetings is what they did in the 1950s!

There are 15,000 groups in the U.S and Canada; our Area has over 1142 Groups! Think about how much change we can make as an Area for AFG!

ELECTRONIC LITERATURE

The discussion of Electronic Literature began with the impact on the AISs/LDCs, WSO and the structures outside the WSO (International). Each Delegate was encouraged to share about the impact it would have first on their AISs/LDCs. The discussion began on the results of what their Area's level of interest in electronic literature is. What percentage of revenue is from book sales, what are other revenue sources, what additional roles do/could the LDCs/AISs provide in the Area? Do they sell on line? Do they use credit cards? How many members would purchase the same literature you have in book form on line in e book form?

After polling our LDCs and AISs in CA(S): San Diego, Los Angeles, Orange County, D42 in the Desert which is an LDC and Inland Empire it was apparent that all of them received over 50% of their revenue from the sale of literature! How would our LDCs and AISs still be self supporting if 50% of their revenue is lost? The impact of e-literature on the WSO offers a wide range of implications. Hazelden sees decrease in hard copy but electronic has helped them to make up difference. In 2011 WSO did more book sales than Hazelden.

-E-books would bypass the AIS and the LDCs. -It could make Al-Anon more accessible Costs are much lower for e-literature and could adversely affect the WSO. Our low cost of literature barely sustains the WSO now for functioning as Al-Anon as a whole.

It is easy to say we should have more contributions but the last time the contributions were more than the literature sales was 1954! It is impossible to predict if the lower cost of books would increase volume of books sold. The AIS and LDCs would lose revenue stream and they might close than place a larger burden on the WSO to provide the services.

How would the WSO handle the licensing of digital rights management if other entities, GSOs, AIS/LDCs, or bookstores also wanted to sell digital versions? How would the fellowship maintain services if the digital sales adversely impact the WSO's revenue stream? What other issues should the Board of Trustees consider in reaching these decisions?

60% of AA income comes from contributions 65% of Al-Anon income comes from literature sales.

We have been forced to become a publishing house because we are not supporting ourselves through our contributions.

Electronic literature's impact on the International Structures of Al-Anon. There are 34 GSOs (General Service Offices).

WSO licenses the countries to print or reprint CAL. WSO owns the copyright license.
 WSO Service Structure is tri-lingual.

3. 18 countries would be affected by the decision. These countries would also lose revenue.

4. Their structures may not be able to withstand the financial impact.

What protections or safeguards do we want the Board of Trustees to consider as they develop the e-literature policy, as it relates to the structures outside the WS Conference structure?

New Zealand presented at the WS Conference and the Delegate told us that their literature is only 20% of their revenue. The remainder of their revenue is contributions. They are very eager for e-literature! They are an anomaly.

Lois understood that the Groups needed to focus on their meetings. She created a Board of Trustees to run the business and they are to protect the literature from which the fellowship supports itself. The model Lois created was not that the GSOs would depend on the United States, but it is easier for them to buy from the U.S.

It will take approximately \$35,000 to \$100,000 to get the licenses started. WSO has thought of all the questions, it is very complicated and they are considering all aspects of the discussions. WSO has to protect the copyright, digital apps management is a form of a copyright even though it is a distribution mechanism.

The two pieces of literature being considered to go electronic first is: "Having Had a Spiritual Awakening", because it is out of print. The "Forum" magazine because it is not sold through the LDCs or AISs. It is a subscription.

PUBLIC OUTREACH/POSTER CAMPAIGN

Public Outreach can be a "Let It Begin With Me". A new Service Tool is on the members' website called "The Best Of Public Outreach". It is a "how to do it service tool for Public Outreach". There are many different types of scripts to speak to television and radio stations to run a PSA. There are sample letters also. I will be playing the new PSA at the Assembly and then I will give it to Richard. Anyone who is nervous about doing Public Information this is a safe way to begin and to utilize the service tool. Go on the web and check out the possibilities. WSO would like feedback from the PI Coordinator on the DVD. The DVD is in English, Spanish and French.

In the last two years Al-Anon has played to one billion. Nielsen has regularly placed Al-Anon's PSAs in the top 5%. The bad news is that there are still important markets in the USA and Canada that have NOT played the PSAs. Namely Los Angeles. We want to encourage our Public Outreach Coordinator to make use of the tool on the Member's Website.

Regarding the Al-Anon Faces Alcoholism (AFA) the fellowship sets sale records each year with the PO tool, but the bad news is only 10% of AFG is actually using them.

A new Poster Campaign has been launched. "Is someone else's drinking tearing you apart"? WSO would like to see a multitude of posters using that tag line. The poster should have the WSO 888 number plus you will be able to use your own local number and information on it. The idea is to empower the fellowship to produce their own posters. The design for the poster needs to be sent via the Delegate. The person also needs to sign off that they own the image.

After 60 years Al-Anon is still not well known. How can we get Al-Anon out of the closet? Bill Wilson said that Al-Anon would be bigger than AA someday and it is not.

SOCIAL NETWORKS

How does the WSO see social networks, such as FB and You Tube as a way to attract & retain new members to our fellowship? Ask a newcomer "how did you find us"? We are on FB and Twitter. AFA is also a pdf that can be downloaded to your iPad. The Service Manual can be downloaded to your iPhone or iPad. I have already done it.

If Lois can conquer the television and move forward we can too. She never resisted change.

ABUSE PHAMPHLET

Tom Coffey, Literature of WSO asked the question should WSO pursue a new pamphlet on abuse. Do we want the literature committee to bring a motion to develop a piece on abuse? Lively discussion on this topic among the Conference. A consensus vote was taken and the Conference voted no to not pursue a new pamphlet on abuse, but the discussions will continue.

INTERNATIONAL CONVENTION

International Convention 2013 in Vancouver. The registration packets will be out in the Fall of 2012. On Tuesday, July 4 a special day of service will be held. There will be a website for International Convention. Registration will be \$115 if paid by December 31, 2012, \$140 if paid before May 31, 2013 and after June 1 registration will be \$165 which includes onsite registration too. Any lost badges there will be a fee of \$25.00.

TRUSTEE SELECTION

Trustee Selection. We voted for Trustees for Regional and Trustee at Large. I have the application package for anyone interested in applying for Trustee.

STEPPING STONES

On Wednesday, we were bused to Bedford, NY to the home of Bill and Lois Wilson. Once every three years the Delegates are taken to this historical site. When that happens the Conference location is in CT and not Virginia Beach. It was an amazing spiritual experience. Their home left a profound feeling of gratitude. As I browsed through their home, office, collections and grounds I knew it was sacred. It was amazing to me that something as large as Alcoholics Anonymous and Al-Anon grew from these two individuals. It is a lovely cozy place. I sat at the kitchen table where Ebby first carried the message of hope to Bill W. It was such an awesome feeling. Bill's office is named "Wit's End" and it is at the top of a hilly rise on the property. There was the desk that Bill wrote AA's Twelve Steps and Twelve Traditions.

CONFERENCE STRUCTURE

Conference Structure! In 1982 the Conference said that a state may only divide once. We were told to look at our Area and that we had the freedom, vision and no holds barred for structural changes. We could formulate and implement a structure in our geographical area or combination of geographical areas for a trial period that would enable our groups to have

communication, participation and representation affect policy on pages 75 to 121 of the Service Manual. We need approval on what will affect the Conference. Envision a structure that would help Al-Anon grow. What would our cofounders do? The trial period would go for 6 or more years. For example, if we would decide to annex the northern part of CA(S) with the southern part of CA(N) and make a Central Area the person we send as the Delegate would have no voice and no vote and all expenses and costs are the burden of the Area. What does this mean for CA(S)? This needs to be discussed at the SCWS Board level, SCWS Area Committee level, Assembly level and ask the Groups what they envision and where they want to go with this. Is it an opportunity to grow? Change is hard, yes, but first my suggestion would be that perhaps we need a Thought Force and maybe one teamed with Northern California.

DO NOT REFER

This was discussed at length and the question is "what are the principles that are behind what is taking place"? We were told to take this back to our Areas and ask if it is still necessary to talk about? WSO does not have a policy and is not mandating any Area to have a policy. It is entirely up to each individual Area.

TEAM EVENTS

Because of International Convention in July 2013 there will be no TEAM Events in 2013 until October of 2013. There is already one scheduled in October and three other Areas have already requested the remainder of the year. We will have to discuss 2014 quickly to get a date in to reserve!

TIDBITS

End of every day we ended with a section on "Unanswered questions and Reflections". It was so valuable. You had the opportunity to say what might have been on your mind or ask a question that you might have thought of after a particular session. It was great. I would love to see us have the time to do something like that at our Assembly!

Alternate Delegate Report 5/19/12

SCWS Assembly May 19, 2012

Alternate Delegate's Report

First of all, I'd like to thank all the new Group Representatives who attended the New GRs orientation this morning. Welcome! I'd like to thank Chris Crawford, who spoke to the GRs about group records, Cathy Satter, who talked to them about group finances and contributions to Central Offices, their districts, the California South Area and World Service and Sandie Ethridge, our past Delegate who talked about the responsibilities of a GR. Thanks for your help.

On March 9-11 Jayme Crisafi, Truck Smith, Sandie Ethridge and I represented California South at the 37th Annual Southwest Regional Delegates Meeting at Aptos, California. Kathi Launius and our past Delegate Mary Morrison also attended at their own expense. The purpose of this meeting, known as SWRDM, is for all the Delegates in Al-Anon's Southwest Region to meet and prepare for the 2012 World Service Conference, discuss area problems and share experience, strength and hope. There are 8 Areas in the Southwest Region: Arizona, California North, California South, Colorado, Hawaii, Nevada, New Mexico and Utah. About 50 people attended.

Three new Delegates were introduced: Tom N. from Hawaii, Patrick B. from California North and our own Jayme Crisafi from California South. Most areas also send their Chairperson, past Delegate and Alternate Delegate, just as California South does. Each area presented Area Highlights. Three outgoing Delegates spoke about their experiences as Delegates over the past three years. Karen R., our Southwest Regional Trustee, gave an update on the Al-Anon Board of Trustees activities. Many of the concerns she spoke about, such as the migration of books and literature to electronic formats, the use of knowledge-based decision-making at the Conference, and member contributions, were themes for the Conference. Jayme will go into more detail about these subjects.

New Mexico, March 8-10, 2013.

One of my duties as Alternate Delegate is to promote subscriptions to Al-Anon's monthly magazine The Forum. We will pass the basket this morning and invite people to donate money for Forum subscriptions. Be sure to put in your name and address and we will award several subscriptions later today.

We will also pass the Ask-It-Basket at this time. Please place any questions you have about Al-Anon policies, traditions or issues. We will address these questions this afternoon if we have time. If not, the questions and answers will appear in the next Bulletin and on our web site.

Every GR should be receiving a copy of The Forum each month. If not, you should check with Chris Crawford, our records coordinator. It may be that your group is not registered, or not registered correctly, or someone else is listed as the Group's mailing address. Since our last Assembly, Forum subscriptions are down slightly. Currently subscriptions in California are also down slightly. Unfortunately World Service does not break out subscriptions by area but only by state. We have 1,606 meetings in California, about two thirds of those in California South and 2,609 Forum subscription. This averages about 1.6 subscriptions per meeting. This is better than the national average—1.46. However, there are 6 areas that average over two copies per meeting and I believe this would be a good preliminary goal for California South.

We distributed Forum subscription forms at the New GR Orientation and I also put copies of the form in each DR's packet. Please take these forms to your meetings and urge people to sign up. Some people think of The Forum as a lending library item. However, there's nothing wrong with encouraging people to put themselves first and get their own subscription coming to their own home.

There is one more order of business I would like to bring up at our Assembly today and this concerns our annual Sharing of Service Workshop, which has traditionally been held on the third Saturday in January in the same facility where our Assembly meets. About four years ago, when our

Southern California World Service Assembly was meeting in Fullerton, districts in the northern part of the California South Area complained that it was a hardship traveling all the way to Orange County for the Sharing of Service Workshop. We voted to hold a second Sharing of Service (SOS) workshop in the northern part of the Area and we have since had two—one in Atascadero and one in Ventura.

Since that vote we have moved our Assembly meeting to Glendale, which is more centrally located within the area. It now takes roughly the same amount of time to travel to the Assembly, and the SOS held here in January, from San Diego, Palm Springs and Bakersfield. In addition, the Sharing of Service events cost the Area money, so we incur even more expenses by have two SOS's.

During our New Business session this afternoon we will entertain the following motion: That Southern California World Service once again hold one Sharing of Service Event annually on the third Saturday in January at the same location where the Assembly meets.

I continue to be honored and grateful to be your Area Chair. One of the items on my gratitude list is that I get to see that God is in charge. Whether it's Area business or my life, I don't always understand the reasons, but I can accept what is and move forward with less anxiety and resentment.

Concept One is, "The ultimate responsibility and authority for Al-Anon world services belongs to the Al-Anon groups." That means every group and Group Representative. Progress not perfection. The Task Force will continue to identify and recommend amendments to the Requirements to take into account all of the good comments we have received so far.

- Mileage for GRs and DRs. Up to first 100 miles round trip is reimbursed by your meeting, then whatever is >100 miles round trip is reimbursed by SCWS. If you take the train, then you get reimbursed for the train fare, not for the mileage.

News about Alateen Sponsor Applicant's Training

Ask It Basket from May 19 Assembly

Q. Does the Forum come in Spanish?

A. The Forum is published monthly in English but it is not published in Spanish. However, there is a publication available in Spanish 6 times a year called Al-Anon y Alateen en Accion. This publication features sharings from The Forum translated into Spanish. The cost in the US is \$10 a year and you can order a subscription from World Service by sending a check to:

There is an order form online which you can download if you want to pay by credit card. You can fill out the form and either mail it or you can fax it to: 757-563-1655. Google Al-Anon y Alateen en Accion to find the form.

Q. Is it possible to start "mixed meetings" with Al-Anon and AA participation? Is there guidance for a format?

A. There are mixed meetings in Southern California at which both Al-Anon and AA members share. However, these meetings are not sanctioned either by Al-Anon or AA and they are not listed in either organization's meeting directories. There are Al-Anon members who find these meetings of value. However, we do not promote these meetings because they will give a newcomer to Al-Anon the wrong impression about what goes on at an Al-Anon meeting. In many cases, newcomers to Al-Anon would be uncomfortable sharing in a meeting with members of the AA fellowship. More experienced Al-Anon members can get an undiluted AA experience by attending open AA meetings. Al-Anon does not have a suggested format for these hybrid meetings.

Q. Would using song lyrics to lead a meeting be considered as outside non-Conference *Approved Literature (CAL?)*

A. According to the Service Manual (page 101): "To keep Al-Anon's message in focus and encourage unity, only Al-Anon/Alateen Conference Approved Literature . . . are used at Al-Anon and Alateen meetings. . . . Al-Anon does not recommend anything other than Al-Anon materials." A song lyric is not CAL.

Q. An Al-Anon Group I attend uses A.A. medallions for Al-Anon birthdays. Is this okay?

A. As cited above on page 101 of the Service Manual, only CAL and Al-Anon materials should be used at meetings. Meetings should not use A.A. literature or other materials.

Q. Some members take notes during a meeting to remember comments, slogans, etc. or to jot notes in the book used for personal reminders. Is this okay? Some members in the meeting felt it is a breach of anonymity if a name is noted. Should this be prohibited, or a suggestion made not to include names? Another comment was that a newcomer might think that a person was taking minutes, or that it was okay to take notes for other than personal reference. Having arrived from Northern California to Southern California four years ago, I started doing this to become familiar with who the other members were, but my notes never left my car. What is acceptable? At another meeting no one cared that I took notes. Is this really an issue?
A. On page 51 of the Service Manual, under "Group Problems and Solutions" it says that at a meeting a "member should be able to feel confident that nothing said in the meeting will be repeated." According to Tradition 12, "Anonymity is the spiritual foundation of all our Traditions." It is

A. On page 51 of the Service Manual, under "Group Problems and Solutions" it says that at a meeting a "member should be able to feel confident that nothing said in the meeting will be repeated." According to Tradition 12, "Anonymity is the spiritual foundation of all our Traditions." It is understandable that members would be concerned if someone is writing their names down. Many groups distribute a phone list. This might be a better way to remember names. Ultimately if several group members are uncomfortable with someone's note-taking, a group conscience would be a good way to decide this matter.

Q. I am a registered GR. I am concerned that four to five people from my District who were sent by their group to vote at the 5/19/12 Assembly had our District Representative tell them that they could not vote because they were not registered. When did the Assembly vote for this rule? Where was this deadline published?

It is stated in the Southern California World Service by-laws, Article 3, Section 2 "Determination and rights of members" that at our Assembly "All members have voice, only registered Group Representatives or their Alternate, shall have a vote."

Over the years various Group Records Coordinators accepted GR registrations at the Assembly. But the By-laws state that GRs should be registered when they arrive at the Assembly and the current Board is asking that we once again respect this rule.

Because of the importance of the Alateen Sponsorship Guidelines discussion and vote, the May 19, 2011 Assembly voted to allow all GRs, including those who turned in their registration at the Assembly, to vote .

Q. On page 78 of the Service Manual it states that "Al-Anon/Alateen members who are also A.A. members do not hold office beyond the group level." What if a person is a member of Narcotics Anonymous and Al-Anon? Would he or she be eligible for service above the group level? What 12-Step programs are excluded from service above the group level?

A. Alcoholics Anonymous is the only 12-Step program covered by this policy

Q. Why does our literature about what Al-Anon "is not" say that Al-Anon is not for loved ones of drug users? If we abide by that we would lose half our membership.

A. Tradition 3 states that the "only requirement for membership is that there be a problem of alcoholism in a relative or friend." Tradition 5 says "Each Al-Anon group has but one purpose: to help families of alcoholics. . ." There is no mention of other addictions. On page 118 of the Service Manual there is a paragraph entitled "Drugs/Narcotics/Prescription Medications" which states: "A symptom of alcoholism in the home may be the abuse of drugs by family members. Occasional discussion of this topic is acceptable at an Al-Anon or Alateen meeting as it may be one of the results of living with alcoholism. However, our responsibility is to ensure Al-Anon's survival as a resource for families and friends of alcoholics. By focusing on these drug-related problems, we risk being diverted from Al-Anon's primary aim.

Q. Have any groups or districts considered placing Alateen posters with cell phone scans and *QR* codes that allow you to download a meeting list or a pamphlet? A group in Ohio has done this.

A. Several Districts in Southern California have bought billboard or bus shelter advertisements with numbers to call to get meeting information. District 27 recently paid to place Al-Anon public service announcements on Metro buses in Los Angeles. Alateen posters with downloadable information codes sounds like a great idea. We just need to protect member anonymity in the information provided.

Q. Is the \$216,000 WSO budget shortfall on track for the year, based on history? Does WSO expect to be in the black by the end of the year?

A. The \$216,000 budget shortfall for the year 2012 was because a new roof was required and installed on the building at the World Service Office in Virginia Beach, VA. WSO estimates that overall expense is budgeted to increase from last year's actual due to more staff becoming eligible for the retirement plan and cost of living and merit increases effective June 1, 2012. WSO estimates that income from literature sales will be less than last year and Forum subscription income to be less also. WSO is budgeting contributions to be a little more than last year's actual. 58.8% of our Groups in the United States and Canada contribute to WSO. 6463 Groups do not contribute yet WSO provides services to all Groups. If each Group contributed \$13.00 more per Group WSO would meet the \$1.5M needed in contributions. Our Conference theme this year is "Our Spiritual Journey ~ we get as we give". We can all help Al-Anon Family Groups to grow each in our on way whether it is to give our time, talent, or financially.

Q. Is using an outdated version of CAL (1974) approved current CAL?

A. It is always important to use the most current literature in meetings, so it depends on the piece of literature you to which you are referring. The Service Manual is revised periodically and when a new version comes out it replaces the previous one. Outdated Service Manuals should not be used at all because new versions contain changes in policy, and other actions which have received Conference Approval. It's important to have the most current policies. If you are referring to an old, perhaps discontinued publication which has been replaced by another publication, such as Al-Anon Family Groups which was replaced by How Al-Anon Works, while a precious archive, the old book is, as you say, "outdated." Our pamphlets and service materials are revised from time to time and the new version should be used. The Service Manual, on page 101, states "To keep Al-Anon's message in focus and encourage unity, only Al-Anon/Alateen Conference Approved Literature (CAL) and Al-Anon service tools are displayed, distributed and used at Al-Anon and Alateen meetings , including meetings at conferences and conventions. These items reflect the informed group conscience of the Al-Anon Family Groups as expressed by its World Service Conference."

Q. Recently we have had guests attend our District Meeting. The guest was not a GR. The guest was very disruptive, monopolizing the discussion and insisting on their point of view. Consequently, nothing was accomplished. How do we prevent this in the future?

Ask-It-Basket

A. Tradition One guides us in acceptable behavior in our meetings by saying, "Our common welfare should come first; personal progress for the greatest number depends upon unity." This is our official policy per our adherence to the Traditions. So if there is dilution, distraction, domination or disruption in our meetings, including District meetings, the common welfare and the unity of the members is compromised. The reading, Three Obstacles to Success," (appearing on page 24 of the Service Manual), one of which is Dominance, reminds us that "Our leaders are trusted servants, they do not govern. No member of Al-Anon should direct, assume authority, or give advice . Our program is based on suggestion, interchange of experience and rotation of leadership. We progress in our own way and pace. Any attempt to manage or direct is likely to have disastrous consequences for group harmony." Please also refer to page 51, Group Problems and Solutions. The disruptive member should be talked to about appropriate behavior in your District meetings, it may be appropriate to discuss this disruption with the entire group. If this inappropriate behavior continues the disruptive person may be asked to leave. Even if a GR disrupts the District meeting in this way, the district can choose not to seat that person and the meeting they represented can be asked to elect a different GR.

I have been coordinating with all of the districts and conventions to conduct Alateen Sponsor Workshops. The plan is to have one workshop each month in different regions of the Southern California. Currently, the schedule is filled through

expedite new AMIAS applications and have been testing a web training program. So far, it has proved to be very successful and can accommodate the needs of the Area. If the trial period of this program continues to be successful and is approved by the Area Board, then Alateen Sponsor Trainings can be provided to new applicants in the comfort of their home or at the library if they do not have a computer. More will be revealed! Regardless of what transpires, workshops will still be mandatory for re-certifications.

(3) **Procedures for the May 2012 Area Safety & Behavior Requirements**

The unexpected motion in May which resulted in the passing of the new AMIAS packet has definitely created a lot of work for me that I wasn't planning on, but I agreed to take on the task of creating and implementing procedures for Al-Anon Members interested in being of service to the Alateens. I started by answering the various questions that were asked by Al-Anon & Alateen members with the help of a committee of Alateen Sponsors and used those to create Procedures. This document will be reviewed by Area Board members and then presented at the Area Committee meeting in August.

(4) Role of the District Alateen Liaison (DAL)

I have had many questions from DAL's asking what they are supposed to do. I could not find anything in the Service Manual so I contacted WSO and was informed that each Area provides their own Guidelines for this position. Our Area never created these guidelines which means that DAL's have had to "figure it out as they go". I plan to work with all of the DAL's in our Area to come up with a consensus about what their role should be. I hope to incorporate District AMIAS Get-Togethers so Alateen Sponsors can discuss problems that arise in the Alateen meetings.

(5) Alateen GR's

In conversations with Alateens, many perceive Alateen as being separate from Al-Anon and do notcontinued next page...

June 2013. I am researching ways to

understand that they have a voice and a vote at District and Area meetings. I will continue to urge DAL's to encourage Alateens to have representation for their Alateen meeting so they can become informed about Al-Anon *as a whole* and the various issues that are discussed.

(6) Future Projects

Several Alateens have commented that they have difficulty finding Alateen meetings that are convenient for them to attend, so my future goal is to work with each district in a public outreach effort to have Alateen meetings in different regions of Southern California and on days/times that are convenient for Alateens.

Group Records Report Group Records Report

My name is Chris Crawford and I am the Group Records Coordinator.

With reference to the Assembly Meeting in May, we had a total of 202 Group Representatives in attendance.

I would like to remind everyone that when you are working above the Group Level as a Group Representative you are registered with the WSO in Virginia Beach. When completing your updated. I would like to encourage everyone to go to the

send mtg record updates.php to update your meeting or to register a new meeting. Going online to update information or to add a meeting is the quickest and easiest way to update the information. When completing the Information form, please make sure to add your full name and address. This information is very important, in that the database can only assign you to one meeting. I have had to spend many hours making phone calls and sending emails just to find out the Group Representative full name and address.

I take this commitment to my heart and want to do the best job I can. However, when I only receive half of the information I need, it is very frustrating on my end in that I cannot complete my job.

Effective March 28, 2012, District Representatives have read-only access to view the Al-Anon groups information in their district and run reports for those groups. This new tool will help DR's keep their group's information up-to-date in their district. It will allow them to notify the Group Records Coordinator of any discrepancy between the Area and WSO Records. The WSO has notified the DR's on e-Communities and provided instructions to access the application. Since only 1/3 of the DR's have accessed e-communities to date the WSO is asking you to pass this information to all DR's so that they can benefit from this new tool.

I have discovered that the most important issue is that each and every meeting needs to be registered through World Service Office and not just your local Intergroup Central Office or Service Center. I am discovering that some meetings that thought they were registered, actually were not registered with WSO. Also, once you receive your WSO ID number, please contact your local Service Center or Central Office to let them know of your new meeting. During a telephone conference with other group coordinators, it was strongly suggested by the WSO that all groups update their records, even if the information has not changed.

Verification of e-mail addresses has become essential and should be accomplished on a regular basis since the WSO and Areas are increasingly communicating electronically with the groups. WSO has requested that members not use their work email address for their group. It was suggested during a recent telephone conference with other Group Records Coordinator that a group can have their own email address through gmail.com or yahoo.com. If a birthdate is needed for the application of the email address, it was suggested to use Lois birthdate of March 4th and the year 1951 for year Al-Anon started, ie, the birthdate would be 3/4/1951.

Please make sure that your Current Mailing Address (CMA) for your meeting is updated. The CMA receives all mail from WSO as well as the "Forum".

We have currently updated our records and are working from only one database through World Service Office.


