

DELEGATE'S REPORT May 2014

Greetings CA(S), Area 04! I attended my third and final World Service Conference in April. It is hard to believe that almost three years have gone by since I was elected. In November we will elect a new Delegate, Alternate Delegate, Area Chair, Secretary and Treasurer. Serving as your Delegate has been a spiritual journey that has enhanced my life and my recovery. I am grateful for the opportunity to serve you the fellowship of Southern California Al-Anon.

World Service Conference

The Conference theme this year was: "World Service Conference: Our Spiritual Principles in Action." This year's Conference was held in Virginia Beach, VA. Thank you all for the love gifts, cards and flowers that were sent to me. I was overwhelmed and touched. I received so many Love Gifts from various Districts and Groups! I was happy to share all the love gifts with the various Areas.

The first presentation that we saw at the WS Conference was a skit on the relationship between Al-Anon Family Groups (the fellowship) and Al-Anon Family Groups, Incorporated (the corporation). Al-Anon is both a fellowship and an organization, with Traditions and legal responsibilities. Al-Anon Family Groups (the fellowship) is the Traditional arm, while AFG, Inc. (the organization) is the legal arm. The decisions we make at the World Service Conference are Traditional. The Board of Trustees votes on any of our decisions that need to be made legal, such as election of Board members and officers, to make them legal.

New Daily Reader

In March of 2012 the Literature Committee began discussing a suggestion for a new daily reader. It takes three to five years to develop a daily reader. A reader addressing the many voices of Al-Anon could bring forward all the conversations about diversity that have taken place at recent World Service Conferences and throughout our fellowship. The WS Conference gave conceptual approval to develop a new daily reader that reflects the diversity of our fellowship. A Task Force will be formed to develop ideas for the daily reader. The Literature Committee felt that a new daily reader could provide an opportunity for all members to express what Al-Anon is today, with topics that are pertinent to them now.

New Conflict Resolution Booklet

A new booklet has been released entitled Talk to Each Other - Resolving Conflicts within Al-Anon. Sections include resolving conflicts in a Group, District, AIS, LDC and Area. There are many helpful tips on how to prepare for the discussion, setting ground rules, during the discussion and closing the discussion.

Forum Magazine

The Forum is Al-Anon's most effective means of communicating. 12% of our members receive it! 33,600 copies are distributed each month. Subscriptions have been declining in the last 7 years. The Forum magazine is approved in concept as CAL and can be used in meetings. Each issue contains an "instant" meeting. Don't forget that part of the role of a Group Representative is to be the group's Forum liaison, letting members know about the magazine and how they can subscribe. Is your meeting receiving The Forum and using it as a "lending library" or is it sitting at the bottom of a box? Encourage members to purchase the Forum and remind our fellowship that you can also receive it on line! Are you receiving The Forum?

Contributions

Members need to understand their connection to the WSO and the services that the Groups receive whether they are contributing to the WSO or not. There are 16,000 Groups in the U.S. and Canada. Only 9,400 of those Groups contribute to the WSO, which is 61.8%. 1954 was the last time our contributions to the WSO exceeded literature sales. If each Group contributed \$260 annually WSO would meet their budget. How much is your Group contributing?

Policy Update - Dual Member

A motion to amend the text of the "Dual Membership in Al-Anon/Alateen and A.A." subsection of the Service Manual was approved at the WS Conference. This is not a policy change but a clarification. The text was changed to reflect the alignment of our spiritual principles. In the new language, you will see an intention to move away from "Dual Member" and "Double Winner" as these seem like labels and detract from the fact that we are all members of Al-Anon. The new language clarifies that Districts and Areas have autonomy in terms of determining what service positions are policymaking or affect other groups, or Al-Anon as a whole.

Tradition Four grants autonomy to Groups and Areas except in matters that affect MORE THAN ONE GROUP. This policy change does NOT change anything for CA(S). All of the SCWS Board and Committee positions are voting positions that affect more than one Group. All District and Intergroup positions are voting positions that affect more than one Group.

The new Policy text is now available in the on-line versions of the English, French and Spanish Service Manuals. The pages with the new text are also available for download so that members can access, trim to size, and insert the current pages into their copy of the 2014-2017 Al-Anon/Alateen Service Manual. This is the new policy that was discussed and presented at the Area Assembly on May 17, 2014. At every World Service Conference, two Chosen Agenda Items (CAI) are discussed. Delegates submit topics that they would like to be a CAI and then the conference members vote on their top two. The first CAI we discussed this year was how to inspire Al-Anon members to get involved in service.

The second Chosen Agenda Item (CAI) was dealing with dominance of members in service. There was a lot of conversation about conflict resolution and typical steps to address this issue. As the conversation progressed, people started sharing about tougher situations, ones in which there is more unreasonableness, bullying and situations that could require outside intervention. In terms of solutions, here are some suggestions:

Be proactive Role playing Tradition studies Get all the facts Get help/support from a service sponsor or friend Escalate within the service structure Talk to those affected Encourage people to have a voice

Treatment Facilities Outreach Project

Southern California World Service (SCWS) is hosting a pilot for an exciting new World Service Office (WSO) program - "Treatment Facility Outreach". This is ahead of the official roll out. It will be held on Sunday, August 24 at 12:30PM at the Hoag Hospital Conference Center. This is a free workshop. May 2014 Assembly

Again, we encountered the fact that the Area does not have enough time to complete the work that is necessary. The Coordinator reports were not given; in addition, a Thought Force on "Groups Whose Activities Do Not Consider Al-Anon as a Whole" did not report to the Assembly. Perhaps it is time to start the discussion regarding a longer Assembly. Was there less business to conduct in past panels? There were Action Committees, Workshops and Hot Topics. Currently the Area now uses Thought Forces and Task Forces with lots of information and data to report. There are various ways to extend the Assembly. We could extend the day, or a two day Assembly or a third Assembly. Is it time to begin the conversation?

To the new Group Representative who commented at the Assembly that he wished he could have discussed the cost of the clickers for the electronic voting with his Group prior to the Assembly. I am reminded of Concept Three "The Right of Decision Makes Effective Leader-ship Possible". In the book Paths to Recovery on page 263 it states: "In our service structure the right of decision belongs to the trusted servants at every level of leadership – from the individual groups, districts, AISs, Intergroups, LDCs, Area Assemblies to the World Service Conference (WSC), trustees and WSO. Without the freedom to decide when and how to proceed, nothing could be done; everything, no matter how great or trivial it might be, would have to be referred to the groups. Our trustees, employees, and delegates would not be trusted servants, but merely messengers, continually soliciting the input of thousands of groups. For all levels of Al-Anon service, from the group to the Conference, the authority and ability to make decisions for the good of Al-Anon as a whole is found in Concept Three.

Decision-making authority is important for our leaders to be able to serve us effectively." I wish this could have been told to the new Group Representatives at the Assembly. We will try to do a better job of informing next time.

Alternate Delegate's Report

Southern California World Service Assembly May 17, 2014

Delegate Jayme C., Area Chairman Truck S., Immediate Past Delegate Sandie E. and Alternate Delegate Tim P. represented SCWS at the 39th Southwest Regional Delegates' Meeting (SWRDM) March 14-16, 2014 which was held in Tucson, Arizona. The Southwest Region includes California North and South, Nevada, Arizona, New Mex-ico-El Paso, Colorado, Utah and Hawaii. The purpose of SWRDM is to help the Delegates prepare for their work at the World Service Conference. Three additional SCWS Board members attended. Richard R. attended in order to satisfy his World Service travel commitment. Minutes Secretary Elizabeth Kau and Hospitality Coordinator CB Schultz attended at their own personal expense.

Our delegate Jayme C. was one of the three delegates who were preparing for their third and final World Service Conference. The other two outgoing Delegates were Patrick B. from California North and Tom N. from Hawaii. SWRDM welcomed three incoming Delegates who would be attending the World Service Conference for the first time: Janice B from Nevada, Jud L. from New Mexico-El Paso and Patrick M. from Utah.

One of the purposes of SWRDM is to discuss topics that will be discussed at the World Service Conference. I won't go into details on those topics because our delegate Jayme C will report on what actually ended up being discussed at the Conference.

Karen R., our Southwest Regional Trustee, gave her report from the point of view of the Board of Trustees. This was her last SWRDM as Southwest Regional Trustee. We heard that Joyce B. from Utah would be nominated as the next Southwest Regional Trustee at the next Board of Trustees meeting. Next year's SWRDM will be held in Salt Lake City, Utah on March 13-15.

Thank you to the Board Members who helped with the Group Representative Orientation this morning. And welcome to all our new GRs. As mentioned during orientation, one of our duties as GRs is to encourage members at our meeting to subscribe to the Forum or the Spanish version *Al-Anon y Alateen en Accion*. Our Trustee reported at SWRDM that subscriptions to the Forum are down 4.5%. It's up to each of us to help reverse this decline. According to *Many Voices, One Journey, The Forum* has been published since 1954—60 years! We've distributed copies of order forms in English and in Spanish at all the tables and hope you'll copy them and take copies to your meetings. Please encourage individual members to take out their own subscriptions. We're going to pass around the Forum can now and we hope you'll put in a dollar and fill out one of the forms and we'll have a drawing late in the afternoon and give away several subscriptions. Incidentally, when we list winners in the Bulletin, we will only use your last initial, not your last name. But for the subscription, we need your full last name.

I wanted to report that I will travel on May 30 through June 1 to the New Mexico-El Paso Area Assembly in Santa Fe, New Mexico. I chose to make this trip because about a third of their meetings are primarily for Spanish-speakers. Apparently they handle translation into English and Spanish at their Assembly differently from the way we do. Hopefully I will come back with new ideas on how we might handle translation at our own Assembly. I look forward to reporting on what I find out.

Finally, we will now pass around the Ask-It Basket. We've gotten some fantastic questions at our last Assembly and Committee Meetings and it's been a good exercise seeking answers to your questions using the new 2014-17 Service Manual. We'll try to answer some of your questions this afternoon if time allows. But we will also publish all your questions and answers in the next SCWS Bulletin..

Treasurer Report

I want to continue to thank all the groups that are consistently sending in group contributions to Southern California World Service. Your group contributions allow SCWS to carry the message of Al-Anon Family Groups throughout Southern California.

Our 2014 contributions are up by 12% compared with June 2013 YTD group contributions. Our total expenses are down by 7.5%.

The May 2014 Assembly approved an operating budget of \$65,000 and we also voted to send WSO \$2,500. We will again revisit our financials at the November Assembly regarding sending an additional contribution to WSO. The Officer's agreed to increase our reserve by \$5,000. Therefore, we opened a new CD for \$5,000, giving us a reserve of \$30,000.

Reminder to all DRs & GRs: If you are driving over 100 miles to attend the Assembly, your meeting or district will reimburse you for the first 100 miles and SCWS reimburses you for miles exceeding 100 miles at forty cents a mile. All reimbursements are processed through our bank's bill pay system where the bank sends the reimbursement directly to the DR or GR at no cost to SCWS. Note the checks are only good for 90 days.

****Reminder to Group Treasurers: When sending in your contributions to SCWS, please use the same Group ID assigned by WSO, versus the old numbering system. If you are not sure of your Group ID, contact our Group Records Coordinator, Chris Crawford. I have created a group contribution form, where the treasurer can download on to their computer and type directly on the form versus having to hand write the form. The form is also located on our SCWS website under "Forms."

Reminder: SCWS is no longer mailing receipts for Group Contributions. We are only sending them via e-mail. If your Treasurer is unable to provide an e-mail address, please have someone else be the recipient or create an free e-mail account for your meeting.



The May Assembly corrects/approves the minutes from their previous Assembly meeting (Nov), and the August Committee corrects/approves the minutes from their previous Committee meeting (Feb). At today's Assembly meeting, we will correct/ approve the minutes from the November 2013 Assembly. All present at the Nov 2013 Assembly have had the chance to read those minutes in the November Bulletin, whether in print or online (NOT the Feb Bulletin). No one has yet submitted any corrections to the Secretary. Feel free to read through those minutes again during lunch today to see if you find any corrections.

Delegate's Report – Jayme C.

Mammoth Lakes Group in d11 wants to move to Nevada Area from CA(s) Area since it is only 2 hrs away from them, compared to being 6-8 hours away from Glendale. They already have approval from the Nevada Assembly and they are seeking approval from the CA(S) Assembly, to be affirmed today in New Business. D64 is the only overlay Spanish-speaking district in CA(S), approved in 1991 by Assembly for 3-year trial period. We forgot to go back and look at it at the end of 3 years. D64 kept growing. D48 has become a Spanish-speaking district, but they are not an overlay Spanish-speaking district. The GRs at the Assembly would need to approve any additional Spanish-speaking overlay districts.

A **Task Force (TF) on d64** was recently formed. In May 2013, the Thought Force (ThF) on d64 had 3 recommendations: keep it as is, disburse into geographical districts they belong to, or form more overlay districts. Will we have 2 or more overlay districts? None? The TF will come up with recommendations, then it will be up to you, the GRs in the Assembly, to decide what to do.

District 51 has 12 registered groups, 8 in English and 4 in Spanish, and has had the same DR for 2 terms, having

issues with not being able to get a new DR and so the DR has been reporting a desire to disband. In April a plan was formulated to see if they can stay together. Elizabeth K. wrote a template with material from the Service Manual for the current GRs to choose from as they visit the groups, informing the groups that we need more GRs so as to hold this district together or we need to disband. In June they will see if they have attracted new GRs to come forward, and, hopefully, a current or past GR to be elected as the new DR.

District 17 has 4 groups in Agoura that want to move to D12. That can be part of the current Redistricting Thought Force (ThF) and/or the Area Restructuring ThF. What do we need to do? The ThF will bring recommendations to the Nov 2014 Assembly. If you have issues bring them to the table so these ThF's and TF's will know what's going on. ThFs and TFs will come to you, the Assembly, to make the decisions. When it comes to area restructuring, it's the GRs who make that decision.

The **decision about moving between districts** comes from the Assembly. Mammoth Lakes went through the right process to go from one Area to another. We do everything with KBDM, starting with discussion, not starting a motion from the floor.

KBDM. Brief summary of Knowledge-Based Decision Making. Quick reference is on SCWS website.

We will review KBDM at each Assembly since there are always new GRs at the Assembly and just the letters "KBDM" means nothing to them. The Assembly voted to use KBDM. Jayme collaborated with two DRs, a member at large and a Trustee to make a quick reference tool. KBDM means having open communication between all members. Ask questions, gather info, everyone has access to the same info, dialogue before deliberation and decision. Sometimes it takes more than one business meeting, and may span several meetings, with several discussions. It is not about hurry up and make a decision. Dialogue and discuss it first. It is amazing how it diffuses things. Someone can say, "I think we need to talk about this more because I don't think we're ready to make a decision." Thoroughly explore the topic before deciding. We have printed material, Service Manual, archives, together we answer 5 KBDM questions or it can be assigned to a ThF. Additional questions may be asked. Summarize discussion. Make a decision. Sometimes further ThF may be needed. We exist in a culture of trust. Don't rush. Use the guide that's now in front of you.

May 2013 the **Alateen Task Force** (TF) came back with a **requirements document** that the Assembly approved. There are **3 more things** that were overlooked in that document. A new TF is being formed to look at these.

- 1. Background checks. Should they be more stringent?
- 2. Age of Alateen in CA(S). The Service Manual says they age-out once they turn 20 years of age, but in the SCWS document it's 21.
- 3. Overnight events. We are the only Area that has overnighters. In addition to SCAC, they have overnight weekend events throughout the year.

SCAC website. 1. Safety issue. The Area has told the SCAC committee that we want to educate and inform you that Area has safety concerns related to Anonymity for minors. The G-40 guideline says Alateen names, email and phone #s never should be on a website.

SCAC website. 2. Using Alateen name without permission. Legally, a website must be linked to WSO in order to use the Alateen name. We asked the SCAC committee to look at it and tell us what they want to do about the SCAC website. SCAC can be on the SCWS website. The Guide-lines G-16, G-34, G-40 all state something about this. Guidelines all are available on the WSO website and are free, and you can reprint them as much as you want.

We know SCAC is an emotional issue for all of us. We've not been in compliance. This was overlooked because we weren't aware of it. We are an Area that's becoming more educated and informed every day. For example, the Area had to say we have to have oversight if you are going to get funding from the groups. This is what all other Areas do, but we just hadn't been doing it. Now we are.

The recommendation is to bring the SCAC website under the SCWS website for the safety of our kids. **Newcomer packets**. WSO includes an order form to order literature directly from WSO. This is a hot button for someone in L.A. County. WSO wants members to order their literature locally – at your local group and literature center, but they include the order form for those members who cannot get to an LDC for some reason. There are groups around the country who do not have a nearby office, and there are areas with inclement weather that prevents them from going to the LDC or ordering them by mail from the LDC. Consider Tradition 1, unity. The groups that are upset about this probably don't have a GR here at the Assembly.

Picture the lady who fills 1000 newcomer packets per day at WSO. What if L.A. County decided ...don't mean to pick on them but it's coming only form them. If L.A. County decides that they want WSO to take it out from the packets sent to L.A. County, how is this lady supposed to keep track of which packets are going to go to L.A. County? The delegate from North Dakota told Jayme that the whole state of ND has one LDC and it is in a lady's garage. If she is sick and cannot fill orders, then the groups HAVE to order from WSO. You can bring back to the groups that are voting to take it out, ...what if there is a newcomer who never came

back to a meeting and found the WSO order form and therefore was able to order literature.

A DAL (District Alateen Liaison) went to microphone, but is not a GR, so does not have voice.

GR. Ventura has an LDC now. Can they put a sticker on that order form for the local LDC? Yes. All the other LDCs do that.

GR. 2 questions. 1. Looking at TF for SCAC cmtee, why no past transitioned Alateens to Al-Anon on that committee? 2. About the sleepover situation, where are we going to draw the line between this is my personal life and none of your business, and this is an Al-Anon event and it IS your business. For q1, thank you for this question. If you want to be on the TF, let the Area chair know. The TF hasn't been formed yet. For q2, we are not referring to a sleepover for a personal event between friends. We are talking about the SCAC committee weekend, which needs AMIAS so they can have their sleepover. It's about when they are using the Alateen name under the auspices of the SCAC committee. In the past, when they have a sleepover, they plan the fundraiser at some point, and the sleepover is usually right after the fundraiser.

Be informed that we consider these types of questions a lot. If you want to be part of the decision-making process, let Truck know. We take Alateen safety as being very important. The Alateen TF will continue. GR. Not familiar with Spanish overlay districts. What is an overlay district? Is it possible to have more than one or are we limited to just one? In 1991, this Assembly said that if you were a Spanish-speaking group, you had your choice of either going into the geographic district that you were located in, or going into d64. Any meeting in the entire CA (S) Area could be in d64 rather than being in the district of the meeting's geographical location (San Diego or La Canada or Orange County or Ventura, etc.). They meet in Baldwin Park, but you could be driving from Ventura. There is a district in Bell Gardens, Compton, Cudahy, Downey, Huntington Park, Los Angeles, Lynwood, Signal Hill, and South Gate that used to be English and became a Spanish district, d48. There are no more English-speaking groups in that district, maybe one. D48 was under the impression that

Spanish-speaking groups could register in d48 instead of d64 but this isn't correct. The decision of a second Spanish overlay district has not been made. It is up to the TF to make recommendations to the Assembly, and then all the GRs get to vote at the Assembly on what to do. The d64 Spanish overlay district was a creation of this Assembly and we're looking at it now. The original intent for d64 was to better serve Spanish-speaking Al-Anons.

Lunch, fundraiser served by SCAC Alateens, will be delayed. Do some reports in the meantime.

Roll call. 214 GRs present.

Truck. We are doing KBDM at the Assembly, still a work in progress. Make certain everyone has all the information. Discuss issue first, move to a motion when we are ready, then have the Motion process.

Motion, Mammoth Lakes. Jayme. Groups in d11 requested to move to Nevada because it is closer to them. Their request has been affirmed by Nevada. South Lake Tahoe and Truckee both moved to Nevada in 1990s with approval

from both Assemblies and from WSO. For this discussion, we skipped the framing document because Jayme felt that what she said was enough. Any discussion?

Motion that we affirm Mammoth Lakes' move to Nevada. Motion made by Allen d27, Second by Nona d27. Unanimous with one abstention.

2014 Budget. Cathy S. In 2013, had \$60k budget, spent \$70k and had \$70k in contributions. Let's be more conservative this year and go with \$65,000 budget. This budget does not include

contribution to WSO, which is surplus money. **Motion** to accept budget as presented. Motion made by Danielle GR d24. Second by Laurie AGR d24. Passed. 1 opposed, several abstained.

Contribution to WSO. Cathy S. In 2012 we sent \$10,000 because the donation approved in previous year wasn't sent by that treasurer. In 2013 SCWS sent \$7500. Propose sending \$2500 now, for 2014.

GR. Budget was \$65k last year, gave \$7500, had only \$500 surplus. It seems prudent to give money at the end of the year instead of at the front. Why not wait until we know we have the money?

GR. It's about the cash we have on hand, not about the loss. We have the money in the checking account.

If we were to send money now and we don't get enough contributions, what would happen? Would we go to our reserve? Yes. We suggest contributing \$2500 right now because we are running under budget right now.

GR. It's easy to hear a big number and get scared about money. We are the largest Area in the conference, 1255 meetings. WSO functions by these contributions. This really isn't that huge of an amount for the largest Area in the World Service Conference (WSC).

GR. Cash flow at WSO is a concern 365 days a year. If we can contribute a nominal amount now then we should.

GR. Does WSO really need it? Yes. Only 40% of their income comes from contributions. Literature sales comprise the other 60% of the WSO income, but that is turned around from what is desirable. For AA the numbers are reversed, 75-80% comes from income, only 20-25% comes from literature sales.

GR. Are we donating money when potentially we need to dip into prudent reserve? We have not had to dip into the reserve in the last many years. Jayme. We are a 501c(3), a nonprofit corporation, and so we cannot make a profit. There is nothing we can do with excess money but to contribute to WSO. She goes to districts and hears about thousands of dollars that districts are not donating. If each group gives \$260 per year then WSO will meet their budget, but the average annual group contribution is only \$112, and only 61.8% of the groups

contribute.

Out of the 16,000 groups, only 9,400 contributed in 2013. Members need to understand the connection between the WSO and the services their group receives. How much does your group contribute annually?

We have \$53,000 in cash, so we added \$5,000 to the reserve. We have \$24,000 in cash accumulated over many years, SEPARATE from the reserve.

DR. Donations went up and we're spending less.

GR. Concerned that we might divide CA into a third Area and that we would have to pay for that. Are we going to save money for when we find out if we are going to split into another Area? Jayme. We are many years away from deciding and we wouldn't want to do anything without participation of CA(N).

DR. We've learned so much today, hearing a lot of comments that seem fear based. Donate to WSO now. I'm told to trust the Higher Power.

Cathy S. Under budget right now by \$26k.

Motion to send \$2.5k to WSO now. Motion made by Judith GR d12, second by Brad GR d57. 4 abstain. Passed.

Hotel reimbursement. Cathy S. Framing document distributed. Used to get up at 4am to be here by 9am. Area needs to be sensitive to those who drive >200 miles round trip. Those who drive that far have not sub mitted reimbursement requests in the past 2 years.

AGR d24. How many might it be? Estimate? Cathy. It could be 17 people who drive over 200 miles and need mileage / hotel reimbursement. If they share hotel rooms, it could be about \$850, but a lot of people go home the same day. It would be nice to have a choice.

GR. Other Areas have 3-day assemblies and the groups pay. In CA(N) they move the Assembly around, but here we always come to Glendale. Is there a way to equalize the cost for meetings?

DR. Round trip is 258 miles, 2.5 hours one way on a good day. Driving home while tired is not safe. Common welfare should come first.

GR. Had been doubting whether she would come back, meeting has only 8 people, might get people in her group willing to take a service position if they knew they would be reimbursed. GR. Understands that groups are to put aside money for their GR's expenses. Had been a GR a couple of times for CA(N), would have a meeting in the car, have something planned for those who came early the night before.

Mary M. past delegate, voice not vote. Past treasurer for SCWS. The most we ever had perhaps was 6 people in a year.

Motion to approve \$100 for one hotel night stay for person driving over 200 miles round trip to Assembly or Committee meetings. Motion made by Chris C. GR d40 Second by Danielle GR d24. 7 abstentions. Passed.

 - KBDM: learn candidates' qualifications

- 3. Pre-Registration date for new GRs and AGRs
 - 1st Saturday of Assembly month (May, Nov)

4. Electronic Voting

- Email system doesn't work since not all GRs can use or access email from Assembly location
- Use Personal Response Devices? ("clickers")

No-cost test today of voting with 30 personal response devices, ...1 clicker per district. We took several test votes: 1 vote per clicker, 3 votes per clicker, 5 votes per clicker, 10 votes per clicker. Results were displayed in a graph as soon as the poll was closed, without delay.

GR. This fast, really easy to use. Concerned about sharing clickers, that if you can vote more times than # of people in the group, that someone would use up the votes.

GR. Totally fast and easy, same concern that it will happen and will be abused. We all have cell phones and there ought to be some free apps out there.

We presume good will among the GRs at the Assembly. We exist in a culture of trust.

GR. The results bar in the slide gives the percentage of the vote. Can we put the actual number of votes instead? Yes, it toggles back and forth between # and %.

GR. Could we vote with email?

We tested that previously. Some GRs do not use email. All voters must be able to vote readily.

GR. Great system, good exercise. I did my own test during this test, and purposely clicked many times to see what would happen. The feedback on the clicker is the same either way, it doesn't indicate that the maximum number of votes for the clicker has been reached or exceeded. Can we control the software?

GR. We will use paper ballots if we don't vote to use clickers. DRs would give out, collect paper ballots and give them to past delegates to do the counting.

DR. Easy for someone to vote twice.

We are running out of time today. Shall we stay past 4:00 today? GRs voted no. Shall we have the DRs vote on this at the August Committee meeting? Consensus: No. It took many minutes to conduct

the hand-counted votes, including starting the count over. If everyone could vote by clicker, we would have had the result in moments.

Motion to rent 300 personal response devices (clickers) for one-time use at the Nov 2014 Election Assembly at a cost not to exceed \$4,000. **Motion** by Marlee, second by Nina. Passed.

Meeting adjourned at 3:59 p.m.



DELEGATE'S JOB DESCRIPTION

Introduction: The elected officers of Southern California World Service, Inc., are the board members of SCWS, Inc., a legal 501(c)(3) Not-For-Profit Corporation. The officers act in accordance with the spiritual principles of Al-Anon Family Groups while conducting the prudent management of the Area. The officers accept additional demands on their time and possess some special skills relevant to their position. Members of Al-Anon in SCWS who also are members of A.A. are ineligible to hold any office beyond the group level.

1. <u>ELIGIBILITY / QUALIFICATIONS</u> – Has served as a District Representative. Has thorough knowledge of and experience using Twelve Traditions, Twelve Concepts and current *Service Manual*. Is accessible, available, responsive, and flexible. Is able to communicate effective-ly, prepare written documents and meet deadlines. Does not hold concurrently any other position in Al-Anon service.

2. **OFFICIAL DUTIES / RESPONSIBILITIES** – Attends all SCWS Area Assembly and Committee meetings, and board and officer meetings, as called by Area Chairman. As a member of the World Service Conference (WSC), represents Al-Anon as a whole, brings the Area's view-point, and communicates to the Area the broader perspective, views and spirit of Al-Anon world-wide. Fully participates in all sessions of the annual WSC, including serving on select WSC committees, Thought Forces (ThF) and/or Task Forces (TF), and in Regional Trustee selection process. Is able to understand, question and learn facts and figures from financial and other reports, and gains vision of great movement in action. Serves as the channel through which information flows and as the bridge of understanding that links groups in the Area with world Al-Anon. Gives Conference report to the Area, explaining financial and other reports, and Conference decisions. Is the liaison between the Area and the World Service Office, sometimes providing Area DR and GR opinions on urgent matters. Should have strong working relation-ship with and support other officers and DRs, and collaborate with them to resolve conflicts within the Area. Is part of Alateen Task Force. Serves on any Area ThF or TF as requested by Area Chairman. Each year attends Southwest Region Delegates' Meeting (SWRDM) and the Area Sharing of Service (SOS) workshop, and supports Area activities and events. Attends International Convention of Al-Anon or of AA, whichever occurs during the Delegate's term. See p. 72, 134, 160-161 of 2014-2017 *Service Manual* for other details.

3. <u>BASIC SKILLS / PERSONAL QUALITIES / EXPERIENCE NEEDED</u> – Effective written, oral and electronic communication skills, time management, strong organizational skills. Proficient in using spreadsheet, word processing, and presentation software, accessing and navigating Web sites, downloading web documents, and using email with attachments. Strong sense of responsibility, able to prioritize, meet deadlines while managing high priority tasks and work independently or as a team member. Able to allot appropriate time to position and all it entails, including assignments from Area, WSC and WSO. Has thorough working knowledge of KBDM (Knowledge-Based Decision Making). Able to separate opinion from fact and to support and effectively communicate Area and WSC decisions and their implementation objectively, even if not in personal agreement with the group conscience. Having served on the Area Board, while not required, provides useful perspective on current Area policies and procedures.

4. **<u>ADDITIONAL SKILLS NEEDED</u>** – Has critical and creative thinking, objectivity, flexibility, listening and analysis skills.

5. <u>EQUIPMENT / TECHNOLOGY NEEDED</u> – Access to computer, printer, Internet connection. Participates in conference calls and online meetings.

6. <u>REALISTIC TIME COMMITMENT OF THIS POSITION</u> – Minimum of 25 – 30 hours per week on writing reports, responding to large volume of emails and phone calls, conflict resolution meetings, travel to make presentations at District, Intergroup and Area meetings, and preparing for WSC.

Supports Area activities and events. Conducts GR and DR orientations at Area Meetings. Should have strong working relationship with and support other officers and DRs, and collaborate with them to resolve conflicts within the Area. In case of Delegate's absence, attends WSC (World Service Conference) and keeps those dates available annually. Automatically becomes Delegate for balance of Delegate's term if Delegate cannot complete the 3-year term (p. 151 of 2014-2017 *Service Manual* (SM)). See p. 161-163 of SM for other details.

3. <u>BASIC SKILLS / PERSONAL QUALITIES / EXPERIENCE NEEDED</u> – Effective written, oral and electronic communication skills, time management, strong organizational skills. Proficient in using spreadsheet, word processing, and presentation software, accessing and navigating Web sites, downloading web documents, and using email with attachments. Works toward team building and encourages initiative and productivity of Board members. Works with Area Alateen Sponsor Coordinator on matters related to SCAC (Southern California Alateen Conference). Reviews monthly SCWS financial statements. Selects qualified auditors to ensure that annual audit will take place, and reviews final audit. Able to understand, question and learn facts and figures from financial and other reports. Ensures that Area has proper insurance in force. Reviews and authorizes material prior to posting on SCWS website. Works with Immediate Past Delegate to appoint Area Thought Forces or Task Forces (ThF or TF). Attends annual Area Sharing of Service (SOS) workshop, and supports Area activities and events. 3. <u>BASIC SKILLS / PERSONAL QUALITIES / EXPERIENCE NEEDED</u> – Effective electronic, written and oral communication skills, strong organizational skills, time and meeting management skills (responds to communications in a timely manner, keeps meetings running smoothly and on time). Proficient in using spreadsheet, and word processing software, accessing and navigating Web sites, downloading web documents, and using email with attachments. Strong sense of responsibility, able to prioritize, meet deadlines while managing high priority tasks and work independently or as a team member. Able to allot the appropriate time to the position and all that it entails. Has thorough working knowledge of KBDM (Knowledge-Based Decision Making). Able to separate personal opinion from fact. Able to support WSC (World Service Conference) and Area decisions and their implementation objectively without reflecting personal opinion. Having served on the Area Board, while not required, provides useful perspective on current Area policies and procedures.

4. ADDITIONAL SKILLS NEEDED – Has critical and creative thinking, objectivity, flexibility, listening and analysis skills.

5. <u>EQUIPMENT / TECHNOLOGY NEEDED</u> – Access to computer, printer, Internet connection. Participates in conference calls and online meetings.

6. <u>**REALISTIC TIME COMMITMENT OF THIS POSITION**</u> – Minimum of 15-20 hours per week on preparation and follow up, responding to large volume of emails and phone calls, travel to conflict resolution and other meetings and to make presentations at District, Intergroup and Area meetings.

7. **PREPARATION** – Writes Agenda for Area Meetings. Reserves rooms annually and designs layout for all meetings and Area events, coordinating with facility contact.

8. <u>TRAVEL</u> – Must be able to attend meetings in all parts of Area. Attends annual Southwest Region Delegates' Meeting (SWRDM) and one service event outside SCWS Area during 3-year term. Makes own travel arrangements, within budget guidelines.

9. <u>OTHER</u> – Chaiman's duties are assumed by Immediate Past Delegate in Chairman's absence (Bylaws). Chairman must be willing to support the group conscience of the Area, *Service Manual*, WSC or Board of Trustees' decisions even if not in personal agreement, and does so with the help of the Traditions and/or Concepts of Service. SECRETARY'S JOB DESCRIPTION

Introduction: The elected officers of Southern California World Service, Inc., are the board members of SCWS, Inc., a legal 501(c)(3) Not-For-Profit Corporation. The officers act in accordance with the spiritual principles of Al-Anon Family Groups while conducting the prudent management of the Area. The officers accept additional demands on their time and possess some special skills relevant to their position. Members of Al-Anon in SCWS who also are members of A.A. are ineligible to hold any office beyond the group level.

1. <u>ELIGIBILITY / QUALIFICATIONS</u> – Current or past District Representative. Has thorough knowledge of and experience using Twelve Traditions, Twelve Concepts and current *Service Manual*. Is accessible, available, responsive, and flexible. Is able to communicate effective-ly, prepare written documents and meet deadlines.

2. OFFICIAL DUTIES / RESPONSIBILITIES – Attends and records minutes at all SCWS Area Assembly and Committee meetings, and board and officer meetings, as called by Area Chairman. Minutes record which reports are given and some detail of discussions, and are published in Bulletin in lieu of oral reading at subsequent meeting. Corrections/additions to minutes are requested by Chairman, who declares them to be approved as read/corrected (no motion required). Maintains possession of and uses corporate seal embossing stamp to certify such approval. Maintains official record of all minutes in permanent minutes book. Maintains and updates record of motions in permanent motions book, submits updates to website coordinator. Uses list serve to send notices of Area meetings as requested by Chairman. Meetings may include special Assembly meetings, bylaw revision meetings, Election Assembly, etc. Obtains form for Notice of Election and Coordinator Appointments from Delegate and sends information to Associate Director of Member Services – Conference at the WSO. Has primary responsibility for continuity and maintenance of Area post office box, including notifying PO Box manager of new Treasurer's mailing address. See p. 159 of 2014-2017 *Service Manual* and Article IV of SCWS bylaws for other details. On call for additional duties or special projects as requested by Chairman.

3. <u>BASIC SKILLS / PERSONAL QUALITIES / EXPERIENCE NEEDED</u> – Effective written, oral and electronic communication skills, time management and multi-tasking skills, detail oriented, able to listen carefully and record the proceedings of Area meetings in some detail. Proficient in using spreadsheet, word processing and presentation software, accessing and navigating Web sites, downloading web documents, using email with attachments. Strong sense of responsibility, able to prioritize, meet deadlines and work independently or as a team member. Able to allot appropriate time to position and all it entails. Has thorough working knowledge of KBDM (Knowledge-Based Decision Making). Able to separate opinion from fact and to support and effectively communicate Area and WSC decisions and their implementation objectively, even if not in personal agreement with the group conscience. TREASURER'S JOB DESCRIPTION

Introduction: The elected officers of Southern California World Service, Inc., are the board members of SCWS, Inc., a legal 501(c)(3) Not-For-Profit Corporation. The officers act in accordance with the spiritual principles of Al-Anon Family Groups while conducting the prudent management of the Area. The officers accept additional demands on their time and possess some special skills relevant to their position. Members of Al-Anon in SCWS who also are members of A.A. are ineligible to hold any office beyond the group level.

1. <u>ELIGIBILITY / QUALIFICATIONS</u> – Past or current District Representative. Must have advanced or professional accounting experience and/or skills. Must have knowledge of professional accounting software (currently QuickBooks). Must be able to understand, prepare and explain budgets and financial reports, and make educated financial recommendations.

2. <u>OFFICIAL DUTIES / RESPONSIBILITIES</u> – Deposits and posts contributions and emails receipts weekly. Researches unidentified group sending contribution. Responsible for accounts payable. Processes expense reports/requests, issues checks and posts into checkbook as processed, weekly. These duties are necessary weekly to maintain accurate, current financial status. Reconciles bank statements monthly. Prepares monthly financial reports, submitted to officers within 7 days of month-closing. Reports include but not limited to Balance Sheet, Profit & Loss, Prior Year Comparison Profit & Loss, Bank Account Reconciliations and Prepaid Account Reconciliations. Produces other reports as needed. Submits listing of Group contributions and other reports to Bulletin quarterly. Facilitates annual audit by providing requested documentation and records to auditors. Attends all SCWS Area Assembly and Committee meetings, and board and officer meetings, as called by Area Chairman. Is an Officer of SCAC Board (Southern California Alateen Conference), has oversight of SCAC bank account and is part of Alateen Task Force (TF).

- 1. Q. We have a 4th Step (Blueprints for Progress) meeting in a very small location. When newcomers come we welcome them; yet it is difficult to have them return. Can you suggest what we can do to keep them coming back and also to reach out to the Community?
- The 4th Step is: "Made a searching and fearless moral inventory of ourselves." It is not surprising that newcomers are intimidated by your meeting. Without having mastered the first 3 Steps admitting powerlessness over alcohol, believing that a Power greater than ourselves can restore us to sanity and making a decision to turn our will and our lives over to the care of Godhow could a newcomer be ready to begin a searching and fearless moral inventory? Many newcomers to Al-Anon come to the program believing that all their unhappiness has been caused by the problem drinker/s in their lives. They are not ready to look at their part in the family disease of alcoholism. Often it takes members a while to get up the courage to ask someone to be their sponsor. Often it takes them much longer to get the courage to work Step 4. According to the bookmark "Sponsorship—Working Together to Recover," sponsorship is " a confidential relationship between two Al-Anon members who benefit from sharing experience, strength and hope. The intimate details exchanged strengthen the bonds of compassion, acceptance, and understanding." Some of these details might be too private to be shared in a meeting. If we look at the 5th Step, we admit "to God, to ourselves, and to another human being the exact nature of our wrongs." Often this other human being is our sponsor. Working the 4th Step is something most of us do one-on-one, not in a group. There are Step and Tradition Study meetings that focus on all the steps and traditions, perhaps a different one each week. In that context it would be appropriate to reflect during a share on a particular experience we had while working any step, including Step 4. Perhaps your meeting will be more inviting to newcomers if you broaden your Study to include all the Steps and Traditions.
- 2.. At a Group meeting I wanted to use a small recorder to take notes. One member complained and we spent a lot of the meeting discussing the matter. I could not find anything in the Service Manual about this. I have difficulty writing due to arthritis and thought I could use the recording as my notes. Was I wrong? If so, what do handicapped people do, especially the visually impaired?
- On page 54 of the 2014-17 Service Manual it states: "Groups are within their autonomy to establish group behavioral guidelines in a manner that reflects their group conscience and abides by the Traditions. . . . Each member should be able to feel confident that nothing said in the meeting will be repeated, by a Sponsor or other members." It is easy to imagine that Al-Anon members might be concerned about having their shares recorded. On page 42 of the Manual we read: "The principle of anonymity is essential during meetings to assure the confidentiality of who is present and what is shared at the meetings." The issue of taking notes or recording shares can be taken up during a Group conscience



- If the Group decides they don't want recording of shares, Concept 5 tells us that members have the right of appeal. However, if you appeal and the Group still votes against recording or note-taking, you will need to accept the group conscience. It is worth remembering that Al-Anon has produced an extensive catalogue of Conference-approved literature. There is plenty of material for you to read on a daily basis without recording shares at your meeting..
- 3. Q. How do we handle a situation when a member shares that they carry a gun?

You don't stipulate that the member has brought the gun to a meeting, but if that it is case, it is not appropriate and may be illegal. On page 54 of the Service Manual we read: "Al-Anon members expect a safe and pleasant environment when they attend a meeting, and when one member causes unrest due to inappropriate or intimidating behavior, the entire group can be affected. Groups are within their autonomy to establish group behavioral guidelines in a manner that reflects their group conscience and abides by the Traditions." A footnote on that page states: "It is important to remember that Al-Anon/Alateen meetings are not above the law. Members need to exercise care in sharing information that could require outside reporting to local, state, provincial, and national authorities." This gun-carrying member may be breaking the law. The third paragraph on this page says: "When the behavior of any member impacts the group, members apply the Traditions to the problem, and determine how best to approach the individual(s) involved, to ask the member to change the behavior in question."

- 4.Q. I think it's confusing to members attending Assembly when members identify other members by their last names. It might be a good idea to read to the Assembly from page 93 of the Service Manual regarding "Anonymity in Service."
- The reading you are proposing be read from page 93 is intended for open Al-Anon meetings, conventions or workshops where non-members may be present: "There may be some who are not familiar with our Tradition of personal anonymity in any form of press, radio, films, TV, Internet and other electronic media. If so, we respectfully ask that no Al-Anon, Alateen or A.A. speaker or member be identified by full name or picture in published, broadcast, or Web-posted reports of our meeting." The disclaimer is not appropriate at an Assembly because all attendees are presumably Al-Anon or Alateen members. However, you are correct in pointing out that on page 92 it states: "Members use their full names within the fellowship when they wish. The degree of anonymity a member chooses (first name, pseudonym, or full name) is not subject to criticism. Each member has the right to decide." We agree with you that we should not be calling other members by their last names at any Al-Anon meeting or function.
- 5.Q. When I present Assembly or WSO announcements about chanting or non-Conferenceapproved phrases to members of the Group I represent, they propose a group conscience and then claim their right to autonomy. How would you suggest I handle this?



A.There is no official policy regarding chants; how groups close their meetings is the decision of an informed group conscience. The only reference to the closing at the end of a meeting in the $Al\Box$ Anon/Alateen Service Manual is the **Suggested** $Al\Box$ Anon/Alateen Closing on page 22 of the new Service Manual. It also states at the end of the **Suggested** Closing: "It is suggested that groups close in a manner that is agreeable to the group conscience. Many groups say the Al-Anon Declaration after their closing."

Some additional things to think about regarding "chants":

Chants are not part of Al-Anon and came into the program from treatment centers and other 12 Step programs.
When looking at the faces of newcomers when members are chanting and pumping their arms, they are clearly left out of the process.
Such chants and behaviors may reinforce the idea that Al-Anon is a cult when we know that it isn't nor do we want it to be perceived to be.

- 6.Q. Does every Al-Anon member who attends a district meeting have voice and vote? Or only GRs or alternate GRs? Votes might include purchases, workshops, sending someone to a Conference and covering their expenses.
- In the section of the Service Manual entitled "Terms Used in Al-Anon" (page 132) a "district meeting" is defined as "a meeting of GRs held as necessary in a central location within a district to elect a District Representative, to hear his reports, and to discuss district matters." Later we read the definition of a District Representative (DR) as "an incoming, outgoing, or active past GR who is elected by the other GRs in his district either in his home district or at an Assembly. He assists the Delegate in passing on information about World Service Office activities and Conference decisions to the GRs in his district. He is a member of the Area World Service Committee." Perhaps if other Al-Anon members attend a district meeting, or volunteer for one of its service projects, these attendees may be allowed to have a voice at the meeting. But on matters of policy within the district, only the Group Representatives (GRs) or their Alternate GR (AGR) if the GR is unable to attend, should be able to vote.
- 7.Q. Most of the groups I attend bring up any suggestions they have at the meeting and then take a group conscience. Only one Group which I attend has business meetings. This group, which has lots of Al-Anon members who are also members of A.A., has disorganized business meeting so most members don't attend. So the same small group makes decisions for the entire meeting. How can we improve this situation?



On page 52-53 of the Service Manual there is a section called "Group Business Meetings." It might be useful to read all 7 paragraphs at a meeting to give the full membership an excellent idea of what a good Group Meeting looks like. It states in the 2nd paragraph: "Groups are within their autonomy to determine how to conduct their group business and how to reach a group conscience." If the decisions reached at this Group's meetings truly do not represent the will of the majority of members, it is possible that the group could take a group conscience and decide not to hold business meetings. Given how few members attend the current Group Business Meeting, it appears that the members are not happy with how the business of the group is currently being conducted.

8.Q. Can an Al-Anon member be a District Representative (DR) and a Group Representative (GR) at the same time?

Yes. As long as the Al-Anon member is not also a member of A.A. he or she can be both a GR and a DR at the same time. A DR has to be either an incoming, outgoing or active past GR in order to be elected DR. (See page 132 of the Service Manual.)

- 9.Q. We have a few meetings in our District that have decided not to make contributions to the service arms such as our District, Southern California World Service and the World Service Office. Is this something our District Representative should address, and if so, how?
- On page 57 of the Service Manual under "Group Fiances/Budget" it states: "The group supports Al-Anon/Alateen financially at all levels of service by contributing to: Their district, Al-Anon Information Service (AIS/Intergroup), and World Service Area structure that serves the group. The World Service Office, which serves all Groups. If an Al-Anon group feels so alienated from the worldwide fellowship of Al-Anon that they officially declare they will not support the very organization that makes their group possible, and provides them with the literature with which they work their program, communication has clearly broken down. While it's unlikely that such a group would have a GR, if they did, that member would be in an ideal situation to share with the members of the group his or her experiences working with the District, the Area and with World Service. If the group has no GR who can act as a link to the worldwide fellowship of Al-Anon Family Groups, the DR could visit that meeting and offer to share with the Group his or her experience of World Service. It may be that by listening carefully to group members, the DR will hear problems or misconceptions that members have about World Service and may be able to reassure members that all Al-Anon service arms exist, as we read in Concept 1, to serve members: "The ultimate responsibility and authority for Al-Anon world services belongs to the Al-Anon groups." It would be helpful for the DR to bring members copies of the Al-Anon pamphlet "Seventh Tradition" which does a great job of showing members how our monetary contributions support the links of service. (Pamphlet S-21) The quote on the back page from Al-Anon co-founder Anne B. describes eloquently the rationale for donating to World Service: "If you have received help, and you no doubt have, why not give to further the cause for the peace and serenity of future members."



10. Q. The subject of Al-Anon owning its own building in Virginia Beach has been questioned as being contrary to our traditions (Tradition 6.) Is this true?

Al-Anon members have been talking for 20 years now about the fact that Al-Anon owns its Group Headquarters. In fact, the mortgage for the building has now been paid off and the Al-Anon Family Groups own the building free and clear. If you'd like more information on the discussions and debates that went on before and after Al-Anon made the decision to buy its headquarters, you can look through the various Conference Summaries since 1994 on the Al-Anon Members web site. Another source for information on this subject is our Al-Anon Family Groups history Many Voices, One Journey. You will find several entries in the index under "Relocation of World Service Office."

11. Q. Can an Al-Anon member who is also a member of A. A. vote on a Task Force that is trying to combine AIS (Al-Anon Information Service) and a LDC (Literature Distribution Center?)

In the replacement policy page for page 82 of the 2014-2017 Al-Anon Alateen Service Manual, we read: "Al-Anon members who are also members of A.A. participate fully in all group activities, including group conscience decisions. However, they do not hold Al-Anon service positions that vote in matters affecting another group or Al-Anon or A.A. as a whole." Since Intergroup organizations vote on matters that affect all the Al-Anon groups they serve, Al-Anon members 12.who are also members of A.A. do not serve as Intergroup representatives for their groups.

Q. Can the Forum start (or re-start) listing regional conferences and roundups in the magazine? WSO discontinued Regional Service Seminars, in which all the Areas in a particular region met together, several years ago. In their place they instituted TEAM events (Together Empowering Al-Anon Members)—a partnership between an Area and the World Service Office with the aim of providing an opportunity for Al-Anon members to learn more about service and the Al-Anon program. The Forum is a national publication. It would not make sense to publicize these local Area events in the magazine. However, it is possible to look up upcoming TEAM events on the Al-Anon member web site.

13. Q. In the current Forum magazine there are photos showing people's faces. Isn't this a conflict with anonymity?

The photographs that appear in the Forum are not those of Al-Anon members. They are models who are not actually Al-Anon members. You are correct that it would be a violation of member anonymity if we showed photographs of Al-Anon members in a nationally-distributed magazine. On the inside cover of all Forum Magazines it states: "In keeping with Tradition Eleven and Twelve, The Forum respects the anonymity of all Al-Anon and Alateen members. When any full face image is published in this magazine, the person in that image is not an Al-Anon or Alateen member."



14. Q. Is it okay for Alateen groups to buy C.A.L. (Conference-Approved Literature) used books on Amazon.com?

A. When you purchase on Amazon many times you are not purchasing from Amazon directly. You are purchasing from other vendors who get the books used somewhere. Amazon cannot undersell the WSO. That is their agreement with WSO. Also, the intention of WSO placing the books on Amazon is not for members but for the general public to find out about Al-Anon.

There is no rule that compels Al-Anon and Alateen members to buy literature from their local Literature Distribution Center (LDC) or Al-Anon Information Service (AIS/Intergroups.) However, it is important to keep in mind that our Intergroups do much more than sell literature. According to the Service Manual, they may also keep a list of local meetings, have telephone lines and answer requests for information, promote local public outreach services, produce their own local newsletters and may maintain a web site for the groups they serve. Although local groups support these offices with direct contributions, the sale of literature is a major source of revenue to keep these offices operating. In an Area like California South, where most of our groups are reasonably close to their Intergroup office, it makes sense to support these offices by buying our literature there.

- *15.* Q. Because of the number of new GRs, can SCWS speakers give us e-mail addresses or a web address or other contact information when a speaker asks us to contact them or forward information to them?
- Given our tradition of anonymity, we do not publish members' e-mail addresses or phone numbers in the Bulletin because the Bulletin is published on the SCWS web site: scws-al-anon.org. However, every board member and coordinator has a SCWS e-mail address with their service function. For example, you can write our Delegate at <u>delegate@scws-al-anon.org</u> or our Group Records Coordinator at <u>grouprecords@scws-al-anon.org</u>. Unfortunately we cannot list District Representatives' e-mail addresses in the Bulletin because our web site is public.
- *16.* Q. How can a group encourage a trusted servant who doesn't fulfill their responsibilities to "step up to the plate?"
- As we read in Tradition 2, "Our leaders are but trusted servants—they do not govern." Rather than have a Group's Secretary or GR, who are also trusted servants, speak to the member who is not fulfilling his or her commitment, a Group might choose to have a group conscience to discuss whether a member chooses to keep their commitment and make more of an effort to carry it out or perhaps instead chooses to give up the responsibility, in which case the group can ask if another member is willing to "step up to the plate." WSO has recently published a new booklet titled: Talk to Each Other. This booklet is a great resource for Groups, Areas, Districts and Intergroups to assist in such situations.



- 17. Q. My Group wants to know why the World Service Office is acting in a role of governance instead of as service leadership.
- Perhaps your Group might consider studying the 12 Concepts of Service. On page 80 of the current Service Manual it states: The WSO is composed of executives, staff members, and selected committees supervised by the legally empowered Board of Trustees and its Executive Committee. It functions as a clearinghouse, providing service to the fellowship and spreading Al-Anon's message worldwide. Also, on page 131 of the Service Manual under Introduction it explains how Al-Anon is held together worldwide. It would be a great benefit for the Group to read and understand.
- Concept 1 tells us: "The ultimate responsibility and authority for Al-Anon world services belongs to the Al-Anon groups." However, Concept 2 goes on to add: "The Al-Anon Family Groups have delegated complete administrative and operational authority to their Conference and its service arms." It is our individual groups that allow our Conference and our service arms to operate. In Concept 12 we learn that "the spiritual foundation for Al-Anon's world services is contained in the General Warranties of the Conference, Article 12 of the Charter." Warranty 5 addresses your Group's particular concerns: "though the Conference serves Al-Anon it shall never perform any act of government; and that like the fellowship of Al-Anon Family Groups which it serves, it shall always remain democratic in thought and action." The best source you have for reassuring your group that World Service exists only to serve the Al-Anon 's democratic, service-oriented traditions in action.

18. Q. Can a District Representative serve a second term if no one else wants to do this service?

According to the "Three Obstacles to Success in Al-Anon" which is reprinted on page 24 of the Service Manual, "Our program is based on suggestion, interchange of experience, and rotation of leadership." There is no rule that says that an Al-Anon member cannot hold the same service role two times consecutively. However, to do so does not respect the tradition of "rotation of leadership." SCWS recently worked with District 51, which had very few groups and was having trouble finding a replacement for their current DR. Working with the various groups in the District, the GRs in that district were able to find a fellow GR who was willing to take on the DR role. In any situation in which a group, a district or an area is unable to find new leaders, it might be a good idea to call a business meeting to discuss the challenge and to reason out options on how to encourage more members to step up to service.



- 19. Q. There is a member of Al-Anon who attends as a guest at an A. A. group meeting. This member invites the families of alcoholics to attend meetings which he sets up himself. He hands out flyers stating: "If you are a family with an alcoholic, come and join us to learn about the disease of alcoholism" He does this before and after the A. A. meetings to get contributions to help the A. A. group pay their rent. How could we address this issue?
- A. On page 56 of the Service Manual it states: It is important that only Al-Anon events are announced in our meetings.....but at an Al-Anon meetings or meeting location, groups do not announce or discuss activities of other Twelve Step Programs. Publicizing events of other organizations creates an appearance of affiliation, even if the event is composed primarily of Al-Anon or Alateen members.
- Also on page 123 and 124 of the Service Manual it refers to "Outside the Fellowship". Al-Anon does not affiliate with other organizations; This applies when most or even all of the participants are members of Al-Anon. Otherwise there could be a misunderstanding of Al-Anon's purpose and function. It is important to keep promotion of such events outside of Al-Anon meetings and meeting locations.
- We learn in Al-Anon that we are powerless over other people, places and things. However, we also learn in Al-Anon how to build healthy boundaries. The boundary here is that this man may not say that he is representing Al-Anon, nor should he use his Al-Anon membership as a qualification for any advice which he gives to people who come to his meeting. You have not said if there is an Al-Anon meeting associated with the A. A. meeting. If there is, it would be appropriate to have the group secretary or the group GR talk to this man to be sure he is not speaking for Al-Anon or giving people to whom he talks the impression that he is representing Al-Anon. Since he is giving advice to people, and acting in a dominant position, it would not be appropriate for him to attempt to register his group as an Al-Anon group. If you know people who have attended his group, you would be doing them a service to invite them to a healthy Al-Anon group meeting.
- 20. Q. My group has not had a Group Representative (GR) for many years so no one remembers hearing a GR share SCWS information. Now that I am the new GR, should I present this information during announcements?

It is up to each group conscience to decide when during their meeting they want to hear Al-Anon related announcements. This is the ideal time to share what you have learned at SCWS assemblies. We suggest that you keep these reports fairly short. If you have too much information to share in a minute or two, perhaps you can report on the most important matters first and then continue with more information at meetings in the next week or two. In the Al-Anon Guideline (G-11) Group Representative it provides all of the information you would need to be a Group Representative.



It provides tips on reporting back to your Group, Duties, Information You Need To Know, Helpful Tools. The Guidelines can be downloaded from the Members' site: <u>www.al-anon.alateen.org/members</u> and you are permitted to make copies.

21. Q. Can the SCWS Assembly Powerpoint slides be made available on the SCWS web site so that GRs and other attendees can print them out prior to the Assembly meeting?

The SCWS Board has made a concerted cost saving effort to put more information on the web site 4 to 6 weeks before each Assembly and each Committee meetings so that GRs and DRs will know ahead of time what topics and issues will be discussed and voted on. Now that SCWS has moved to Knowledge-Based Decision-Making, it is important for us to publish framing documents ahead of time for all the major subjects we will be voting on. In addition, we will publish summaries for all Thought Force and Task Force reports before they are presented at Assemblies and Committee meetings.

- Can we have a blog on the SCWS web site for GRs to share information and resources on "what works," ie, Alateen meetings in high schools, Institutions meetings, etc.?
- This would be a good thing to bring up at your District meeting or to bring to the SCWS Board. A good Board member to communicate with would be <u>webmaster@scws-al-anon.org</u>. Before doing so, it might be a good idea to spend some time on the Al-Anon/Alateen members web site to get an idea of the wealth of information and inspiration that's already available for GRs and other Al-Anon members. Once you've had a look at some of their suggestions on public outreach, Alateen service and other areas of Al-Anon service, why not bring this information to your next District meeting and discuss what you might be able to organize at the District level?
- 22.Q. In Tradition 12, Al-Anon changed one word from the A. A. version, "before" personalities to "above" personalities. Why?
- In the A. A. book Twelve Steps and Twelves Traditions, the chapter on Tradition 12 states: "We simply couldn't afford to take the chance of letting self-appointed members present themselves as messiahs representing A. A. before the whole public. . . . Here, principles would have to come before personalities, without exception." This use of the word "before" has the suggestion of A. A. members speaking before groups of people interested in the A. A. message. There was huge interest in A. A. in its early days and lots of members eager to carry the word to others. In the general wording of the A. A. step, members are told to place "principles before personalities" which also has a sense of having principles first, and having them be more important than our personalities. In the book Al-Anon's Twelve Steps & Twelve Traditions, we read in the chapter on Tradition 12: "Our spiritual growth through humility has its roots in the principle of anonymity." In the "Thinking It Over" section of the chapter we read: "Placing principles above personalities, as Tradition Twelve suggests, presents a paradox. . . . This surely means thinking of myself a great deal. Won't this make me self-centered? As long as I remember the principles I am asked to follow in Al-Anon and use them as a yardstick in what I do and how I relate to others, this will not happen."





Therefore, the Al-Anon version "principles above personalities" means literally not just that principles should come first, but that they are actually "above," IE, more important than, personalities. Thank you for pointing out this fascinating distinction. In our opinion, the Al-Anon formulation is a powerful refinement of the original A. A. version.

23. Q. Are we going to have the Conflict Resolution kit in Spanish as well as English? According to the World Service Office, the Conflict Resolution "kit" is comprised of S-71 "Loving Interchange," S-72 the Conflict "ring cards" and S-73, the booklet on Resolving Conflict Within Al-Anon. At this time only S-72, the Conflict "ring cards" are available in Spanish. The other two components of the kit are not scheduled for translation into Spanish at this time.

24. Q. Has there been any more discussion about breaking up the California South area into smaller groups? The current size of Area 4 is cumbersome.

- A. After the presentation of the conference structure thought force at the Assembly in November 2013, there was no decision by the group representatives to further pursue the issue at this time. The District Representatives were asked to take back to their Districts and discuss two questions: "Is your Group well served and What does a well-served Group look like?" At the TEAM event in January 2014, there was an opportunity to discuss this further, but it did not receive enough votes to be placed on the discussion agenda. There doesn't seem to be sufficient interest in this matter to move forward. The Area currently has a Thought Force on "Redistricting" which will report in at the November 2014 Assembly. This could be the beginning of another conversation on Conference Structure.
- 25. Q. Can we set up a tracking mechanism to follow up on topics such as the status of District 64 or the breakup of SCWS or moving our Assembly to a location with more room?
 - A. The Area makes every attempt to follow up on topics. There is currently a District 64 Task Force which will begin working on the three recommended options from the District 64 Thought Force. Remember that the Area may not be reporting on topics continually but in the background the work is being done. When Thought Forces and Task Forces are ready to present they go forward as long as time permits at the Assemblies. The second part of your question is answered above. If members are interested in moving the Assembly for more room it can be addressed through the Area Chairman.

. Q. Did Long Beach make it to the finals for the WSO Trustees summer Meet and Greet? How did the Board of Trustees decide where to have it?

A. Thirty-one Areas submitted a bid for the event. The Board of Trustees' made sure all the bids met the listed requirements. They then put all the Areas who met those criteria in a hat. A first choice, second choice and third choice was pulled from the hat. Of course, the first choice was St. John's Newfoundland. The District Reps will be asked once again to decide in August at the SCWS Committee Meeting if the Area should again bid for the 2015 "Meet the Board". If the Area is interested we will again have to re-submit the paperwork. We do not know which Areas met the listed requirements and were among those who were placed in the hat.



27. Q. According to the Service Manual, Intergroup is not a designated or appropriate part of al-Anon to "deal with" groups or to address or create policy. (Page 64 of the 2013 Manual) Why are they being given this power? Since the purpose of the Intergroup is to provide literature, why do they have a say in which meetings can or cannot be listed in the meeting directory? This is not mentioned as their responsibility in the Service Manual. It appears that there is double-headed leadership regarding "Do Not Refer" meetings. Orange County Intergroup currently adheres to this policy, while SCWS does not/will not. This appears inconsistent and confusing, creating disunity. (These are 3 different questions we have grouped together.)

A. On pages 63-64 of the 2014-2017 Service Manual it states that Intergroups are establishedd and maintained for easy access and communication of its groups. Its usual functions are listed on page 64 of which is updating, publishing and distributing lists of group meetings. This is covered under the fourth bullet. It does not say that they publish a list of all meetings in their Area. As long as they are not making policy for Al-Anon as a whole it is within the autonomy of the Area information service/intergroup to set certain "rules or standards" by which they conduct their business.

Page 81 in the Service Manual refers to the registration of groups. It states: "the WSO will register any group designating itself as an Al-Anon family group with the understanding that it will abide by the Traditions and that meetings will be open to any Al-Anon member.

If it becomes known that a group within the Intergroup's geographical area is incorporating practices that are not consistent with Al-Anon's Twelve Traditions and principles, the intergroup service board may remove the meeting information from the directory and not refer it to newcomers. The meeting must be notified of this action and given specific demonstrable ways to remediate the problem and regain their listing.

This question mentions that while Orange County Intergroup follows this policy and SCWS does not and will not. This statement is correct. At this time the Area does not have a written policy. A special Thought Force has been studying this issue for over one year. They will make their report and discuss its proposed strategies at the November 2014 Assembly. At that time the Group Representatives will decide how to go forward.

28. Q. This question is for the Delegate, Area Chair and Hispanic Coordinator: Why are the Al-Anon Guidelines in Spanish not up to date? Can you petition the WSO to make sure all English guidelines are also up to date in Spanish?



- A. It is my understanding that the WSO translates every piece of literature into Spanish. Unfortunately, it takes longer to release than the English literature. If you can be more specific and provide the exact piece of literature you are referring to we can ask the question to the WSO regarding the specific piece.
- 29. Q. If our District is low on funds, can we use Alateen donations to meet current obligations?

A. No, if the District cannot meet their current obligations they cannot use Alateen (or SCAC) money that has been donated voluntarily by members to the District for Alateen (SCAC). When members make a voluntary contribution or second basket for SCAC then those funds must be donated to SCAC. If the District is setting aside funds from their Treasury and earmarking those funds for SCAC and therefore cannot meet their current obligations perhaps the District needs to take another look at their priorities and budget. The real question is "why can't the District meet their current obligations". Maybe a discussion is needed with the Group Representatives on Group Finances/Budget. It states clearly on page 57 of the Service Manual that groups support Al-Anon financially at all levels of service by contributing to their district, Al-Anon Information Service (AIS/Intergroup), and World Service Area (SCWS) and WSO. Also, the District can look into fundraising.

30. Q. Why did we change Understanding Ourselves and Understanding Alcoholism when the original wording was so lovely and poetic? Was the change made by the World Service Conference? Did the Groups have a vote, or did our Delegate vote as our representative or was it strictly a World Service Literature Committee change? I've heard many people say they love and miss the original wording? Jayme, this is me wondering if World Service cares if groups use earlier versions of CAL?

A. The World Service Conference did not change Understanding Ourselves and Understanding Alcoholism. The Groups do not vote on any changes to our CAL. New material and major revisions of existing material are brought to the WS Conference for recommendation and approv-

al. CAL is updated and edited as the need arises. Using outdated CAL is not recommended.
31. Q. The Service Manual. Bill and Lois had both said that the 3rd generation will screw up AA and Al-Anon. There have been too many changes. If it works, why fix it?

A. Al-Anon's purpose and philosophy has never changed. It is necessary at times to make changes like updating our CAL according to the diversity of our fellowship and changing our thinking to be inclusive of everyone. For example, the daily reader One Day at A Time was released in 1966 and written primarily for the wives of alcoholics. Today we have a broad view of our CAL. Our daily reader Hope for Today is written for the child of an alcoholic. At the WS Conference this year the Conference gave conceptual approval for a new daily reader which would focus on the diversity of Al-Anon. If Al-Anon is to survive we need to change and grow in certain respects. We cannot speak for Alcoholics Anonymous.



32. Q. We have our Al-Anon meeting at a church. AA has a meeting there also. Our rent is based on how much we take in for the month, and then we give the money to the AAs to turn in. Should we be doing this?

A. No. On page 58 of the Service Manual it states "A group may need to periodically review its budget as changes to meeting expenses occur, such as rent increase, a change in attendance, a drop in member donations, funding a group public outreach activity, etc. Al-Anon groups are not responsible to support a club house, other than paying rent." If a Group cannot support the Al-Anon service structures at all levels because the rent is too high or in this case the A.A. 's are basing the rent on how much is taken in for the month, we would recommend looking for a new location where the rent is reasonable and the service arms can be supported.

33. Q. What happened to this motion from the August 2011 Committee Meeting: Discussion of selling a limited amount of literature at Assembly meetings from the Intergroups or the Literature Distribution Centers ensured. Decided to go back and discuss with Intergroups and LDCs and would also discuss with their boards.

A. An email was sent in late 2013 from the Literature Coordinator to all Intergroups asking if any of the Intergroups were interested in selling Service Manuals and Groups at Work at the May 2014 Assembly. Orange County Intergroup was the only Intergroup who responded with interest. At the May 2014 Assembly Orange County Intergroup was present. The Los Angeles Intergroup has agreed to handle the November 2014 Assembly. They are the only two Intergroups that have come forward to participate in this endeavor.

34. Q. What happened to this motion from the August 2008 Committee Meeting? Motion made to present the idea of holding a North/South Convention in the middle part of California in the next panel.

A. That motion referred to an SOS (Sharing of Service Workshop). The North and South SOS were held twice. Because of the current location of the Assembly to Glendale it was decided by a motion (which has not been posted on the website yet) that only one SOS would be held each year.

35. Q. Our SCWS website has a FAQs page that does not have facts about the site.

Can this be addressed by our coordinator?

A. The SCWS Website Coordinator has stated that any question to the website will be answered. The most frequently asked question on the website is for meeting information. In those cases, individuals are referred to the closest Information Service Center. Please provide more detailed information as to what you would FAQ you would like to see on the website.



36. Q. How does Service by the form of entertainment conflict with Tradition 6? Is it considered part of Al-Anon service?

A. Tradition Six states: Our Family Groups ought never endorse, finance or lend our name to any outside enterprise, lest problems of money, property and prestige divert us from our primary spiritual aim. Although a separate entity, we should always co-operate with Alcoholics Anonymous.

In the conflict resolution service tool (S-72) "Conflict Resolution Using Our Twelve Traditions", it states: "It is important that we not let anything distract us from the commonality we share in Al-Anon. Conflict can sidetrack us from the reason we are here –it separates us and pits member against member. Aligning, Al-Anon with outside entities threatens our unity....."

Currently, there is nothing in the Service Manual or CAL that refers to entertainment being a form of service. Entertainment by Al-Anon members is just that entertainment!

Entertainment by Al-Anon members would conflict with Tradition Six if the entertainment is causing problems of "money, property and prestige" and is diverting members from their primary spiritual aim. Aligning Al-Anon with an outside entity whether it is a form of religion or even entertainment threatens our unity. Cooperating with one another without sacrificing our integrity is part of Tradition Six.

37. Q. What is a member-at-large? How does one become one? What do they do?

A. A member-at-large could be someone who attends the Assembly and is not a Group Representative, District Representative or member of the SCWS Board. It could be just someone who would like to observe the Assembly. It could also be someone serving on an Area Thought Force or Task Force. That person would not hold an office, board position or Area position, but a member-at-large.

At the WSO level, it is an individual who serves on a Selected Committee, Work Group, Thought Force, Task Force, Forum Editorial Advisory Committee, Public Outreach Committee, Literature Committee, or Alateen Work Group Committee.

At the Area level one could inform the Area Chair of their desire to serve on a Thought or Task Force. At the WSO level the Delegate informs the Area of any and all positions available. Resume application forms are available from the Delegate.



38. Q. To our Area Chairman, and other board members: If you reference Higher Power at an Assembly, please invoke/reference "Higher Power" instead of "god" for the many of us for whom "Higher Power" is not god. Thanks.

We don't mean to offend. Steps 3, 5, 6 and 11 use the word "God." Tradition 2 says the only authority for Al-Anon is God. Steps 3 and 11 specifically say "as we understood him," with the implication that God is different for everyone and each of us is free to define what we mean by God. Many of us began our Al-Anon journey using the term Higher Power and then later used the term God. But others will continue to use the expression Higher Power.

39. Q. We received two irate notes about the Alateen lunch being late. Alateen operates under the same guidelines as Al-Anon. When our agenda says lunch is at 12:00, why do we not hold them accountable by not allowing them to move lunch to 1 pm? Having the lunch be late inconveniences Assembly voting members and officers/coordinators by postponing discussion and voting. We are trying to be more efficient. May we please explore having a working lunch and taking bids on a catered lunch with an on-time provider? This is an Alateen fundraiser, not an Alateen right.

A. We understand your frustration and apologize. The Alateens had never been that late before and we weren't prepared for it. The SCWS Board will explore alternatives—a working lunch, a catered lunch and/or extending the hours of the Assembly. We will not let this happen again.

40. Q. Table assignments at Assembly are somewhat cut-throat. How can we make this lottery system gentler?

A. Tables are not assigned. Some districts arrive early and place signs on tables as a way to let their members know where to be and to keep the district together. We try to practice courtesy and presume good will in finding space for every district and group representative. We would be glad to explore alternatives.

41. Q. I haven't heard anything from SCWS about taking KBDM to our groups. We still use Roberts Rules at my home meeting when we have a business meeting. I assume autonomy allows each group to decide if we want to use KBDM or Roberts Rules. Is that correct?

Knowledge-Based Decision-making (KBDM) was adopted by the World Service Conference starting in 2006-2009. KBDM is a process to reach an informed group conscience. KBDM has four essential elements: 1. Open communications between leadership and membership, 2. Dialogue before deliberation and decision, 3. Everyone has access to full information, 4. We exist in a culture of trust. A very spirited and necessary conversation took place at SCWS Committee Meeting in February 2013.



The Committee discussed using KBDM emulating the Conference versus using Roberts Rules. At the end of the conversation a vote was taken for the Area to go completely with KBDM starting at the May Assembly of 2013. All motions must come after a discussion. We may continue to struggle with the learning curve but once again our Higher Power has spoken through our group conscience. The Delegate has been discussing KBDM with districts, Intergroups and groups. The process is nothing more than an "informed group conscience" which is what we have always practiced but usually with a motion on the floor. With KBDM the motion comes after the complete discussion when everyone is ready to vote because they understand the information presented. The Area will be providing reviews of KBDM at each Assembly. The purpose is to inform GRs, DRs and all participants so the process can be used in place of Roberts Rules.

42. Q. Many groups give to SCAC (Southern California Alateen Conference) and don't make the kids responsible for paying their own way. Some Alateens go to SCAC but don't go to meetings. Wouldn't it be wise to have kids learn about Tradition 7 and earn some of their own costs?

A. It is difficult to answer this question without giving a personal opinion that is not based on any Al-Anon literature. However, the Al-Anon concept of "for fun and for free" might be of value here. No group is required to collect money for scholarships to SCAC. If it causes resentment, don't give. The 7th Tradition is: "Every group ought to be fully self-supporting, declining outside contributions." However, SCAC is not a group, it is a Conference. A SCAC scholarship is a gift from another Al-Anon member so it is not an outside contribution. But neither is it a requirement.

43. Q. Are districts responsible for sending an Alateen member to SCAC every year?

No. Districts should not be using their funds to send Alateens to SCAC. SCAC donations are collected from the Al-Anon groups in their district (that choose to collect for SCAC.) The district allocates those funds to the Alateens in their district. Each district decides how to allocate those funds to SCAC (based on the discussion with the GR's at the District meeting.)

44. Q. In the new Alateen Guidelines there is a restriction on sponsorship between AMIAS (Al-Anon members in Alateen service) sponsors of the meeting and Alateens within the meeting. Why?

A. On page 49 of the Service Manual we read under the heading Alateen Personal Sponsors: "Alateen personal Sponsors are fellow Alateen members who can discuss personal problems or questions with those they sponsor. Personal Sponsors willingly share the experience, strength and hope of the Alateen program. Al-Anon members do not sponsor individual Alateens." The Service Manual states on page 89: Alateen Group Sponsors and other Al-Anon members do not serve as personal Sponsors to individual Alateens. Alateen members are encouraged to sponsor each other in a peer-to-peer relationship." Peer-to-peer is the important concept here and it has been in the Service Manual for years. It is not possible for an adult Al-Anon member and an Alateen to have a peer-to-peer relationship. For more information on this subject, please see the "Alateen Safety Guidelines" (G-34.)



45. Q. Why did we change to contribution to WSO twice a year? Was there a group conscience?

There was never a precedent set where we send in an annual contribution to WSO once a year. Based on a suggestion from our financial auditors, we currently are contributing a portion, then waiting to see where we are at the end of year.

Budget available before the Assembly to review...yes, it can be posted to our website.

46. Q. Can we get an Actual vs. Budget to be reviewed prior to the Assembly before voting for the contributions to the WSO?

Yes, but the Treasurer would need to coordinate with the Webmaster so that they send out an e-mail regarding the proposed budget prior to the Assembly. Actuals vs. Budget before sending in the contribution to WSO can be done, but keep in mind we do not forecast the contribution to WSO.

47. Q. May we please have the prior Area minutes in the current Bulletin? This would be helpful for the new GRS to not have to look back two Bulletins.

A.P lease see the minutes in this May 2014 Bulletin (Bulletin Vol. 56 No. 2) for a reminder of the following sequence. The minutes and reports for each Area meeting are printed in the Bulletin that contains the proceedings of that Area meeting. The minutes and reports from the November Assembly are printed in the November Bulletin (Bulletin No. 4 each year), and the minutes are corrected/ approved at the next meeting of that body, which is the May Assembly. Likewise, the minutes from the May Assembly are printed in the May Bulletin (Bulletin No. 2) and are corrected/approved at the November Assembly. Similarly, the minutes and reports from the February Committee meeting are printed in the February Bulletin (Bulletin No. 1) and the minutes are corrected/approved at the next meeting of that body, which is the August Committee meeting. Also, the minutes from the August Committee meeting are printed in the August Bulletin (Bulletin *No. 3) and are corrected/approved at the February Committee meeting. It would be a duplication of effort and expense to reprint the minutes from the November* Assembly in the February Bulletin. A reminder of this sequence, which is stated at the microphone, will be included in the printed minutes. New GRs could be informed of this sequence at the district meeting that precedes the Assembly.

WSO- Tips on how KBDM works

Knowledge-Based Decision-Making KBDM Quick Reference Tool

The essential elements of the KBDM process are:

- Open communication between all members
- Ask questions & gather information
- All decision-makers have common access to full information
- Dialogue *before* deliberation and decision
- Process can take more than one session. It may span over several meetings,
 Assemblies or other gatherings with discussions and questions continuing until everyone has the information they need to move forward.
- We exist in a culture of trust.

How It Works (What do we actually *do*?)

The issue is first "framed" or introduced by someone familiar with the topic. Then we thoroughly explore the topic *prior* to deciding what to do about it.

- 1. Information Exchange—everyone has access to the same:
 - Printed material (e.g. *Service Manual*, past motions, archives from meeting, etc.), and

Together, we answer the 5 KBDM questions (below) (or this can be assigned to a Thought Force)

2. Discussion

Discussion and opinions are based on information and on experience. Additional questions may be asked at this time.

- 3. *Summarize* the discussion—assure that information, concerns, and opinions have been aired and heard, including minority opinions.
- 4. Make a Decision (3 possibilities)
 - a. Further research may be needed about the issue.
 - b. Suggestion/Motion may be made (e.g. informal show of hands, or motion/second, if large group)
 - C. Status Quo (leave as is).

(After our best efforts to answer these questions, and through listening with open minds and hearts, we make a decision and trust in ourselves and our Higher Power.)

WSO- Tips on how KBDM works

Five KBDM Questions

The answers to the questions below can provide a basis for discussion. They provide common information so everyone can be on the same page.

- Gather information to these questions
- Everyone can add to them
- Opinions are backed up by experience, principles or knowledge.
- 1. What do we know about our members' (and prospective members') needs, wants and preferences that relate to this issue?

(What purpose would this serve? Is it necessary? Is it helpful?)

2. What do we know about the resources and our vision for Al-Anon and our meetings that are relevant to this issue?

(What are our resources? Can we afford it? Do we have enough volunteers to make it happen? Do we have any background information in our archives that can help us answer this question?)

3. What do we know about our "culture" and "environment" that is relevant to this discussion? What are the implications of our choices: the pros and cons?

(How would this affect our meeting? How would this affect our fellowship? Newcomers? Al-Anon(and A.A.) as a whole? The advantages of this change might be... The disadvantages might be...)

4. What are the ethical implications of our choices? In other words--Will our decision be consistent with our spiritual principles, policies, and the Twelve Steps, Traditions, and Concepts?

(What are the ethical implications of our choices? Is our decision legal? Are our decisions within our spiritual principles, policies, and legacies? Does our Service Manual provide any guidance about this issue? Will our decisions help us fulfill our primary purpose? If we decide to take an action, will it be the "right" thing to do?)

5. What do we wish we knew, but don't?

(We might need to do some additional work or research to help us make a sound decision.)

(After our best efforts to answer these questions, and through listening with open minds and hearts, we make a decision and trust in ourselves and our Higher Power.)

G-34 Support the action of your Alateen Group Sponsors

Who are responsible for the Alateen in the meeting room. To the best of their ability, Alateen Group Sponsors must maintain a sense of safety and trust in order for recovery to take place and to protect the Alateen members from physical and emotional harm. Whenever appropriate, Alateen Group Sponsors have aa right to ask a member who is displaying inappropriate behavior to leave the meeting.

Safety and Anonymity

The Eleventh Tradition states that members should"...always maintain personal anonymity at the level of press, radio, films., and TV." The internet is considered a form of media, just as TV, radio, and films are, and members should not be identified by full name or pictured on the web. Pages 73-74 and 91 in the Al-Anon/Alateen *Service Manual* address anonymity in all forms of media.

G-40 Setting up an Al-Anon website

If your website includes a calendar section, be sure to follow your area's Alateen requirements regarding posting of Alateen event information. Alateen names, e-mail address, and phone numbers should never be posted as contacts.


Those individuals will need to be certified again. That means attend a new 90 minute certification training (usually online) and resubmitting all three forms through their district to be approved again.

"Have you ever wondered if it does any good to carry the message of Al-Anon to just one person? At the Festival of Books in April, I struck up a conversation with a social worker who approached our booth. She said she would take some pamphlets back to her supervisor and I gave her my contact information. To my surprise, her supervisor contacted me recently requesting a presentation about Al-Anon. I suggested we bring a panel to their facility - the Child Signature Program (via Children's Hospital of Orange County) and Help Me Grow. They work with low income families that have children in various state preschools in Orange County, Their focus is to provide resources and referrals to families and children in those preschools. Domestic Violence, Mental Health and Substance Abuse needs are recurring themes they are dealing with, with a focus on Spanish families. Our panel is all set up and ready to go consisting of an Al-Anon member who speaks fluent Spanish , an Alateen, and two Al-Anon members. This Supervisor supervises 20 Family Support Specialists and each FSS has about 30 families on their caseload so by reaching out to one person, there is the potential to reach 600 families in Orange County!"

My name is Chris C. and I am the Group Records Coordinator.

We currently have 1226 Active Groups in Southern California. There are 37 groups listed with "No Mail" as their addresses are not current and they are not receiving "The Forum" magazine or group information via mail or email updates as well. I have 4 meetings in the process of being registered as of today.

All of the Intergroup offices have agreed that each meeting needs to be registered with WSO prior to being listed in the local directory.

With reference to the 37 "no mail" meetings, I have given each DR a copy of the meetings in their district that are not receiving any information from WSO or SCWS.

Please note that it is the responsibility of the Group Representative to update the Group Records Coordinator with the current information. I would like to encourage everyone to go to the SCWS website http://scws-al-anon.org/send_mtg record updates.php to update your meeting or to register a new meeting. This way you save yourself the cost of the stamp and the WSO Office in Virginia Beach is updated as well, so there is no longer a need to notify WSO in Virginia Beach, VA as we work on the same database Going online to update information or to add a meeting is the quickest and easiest way to.

When completing the Information form, please make sure to add your **full name and address including your zip code**.

This information is very important, in that the database can only assign you to one meeting as a Group Representative. I

have had to spend many hours making phone calls and sending emails just to find out the Group Representative full name and address.

I take this commitment to my heart and want to do the best job I can. However, when I only receive half of the information I need, it is very frustrating on my end in that I cannot complete my job. If I do call you and leave a message via voice mail or email, please be courteous enough to return my call or email.

During a telephone conference with other group coordinators, it was strongly suggested by the WSO that all groups update their records, even if the information has not changed.

Verification of e-mail addresses has become essential and should be accomplished on a regular basis since the WSO and Areas are increasingly communicating electronically with the groups. WSO has requested that members **not** use their work email address for their group. It was suggested during a recent telephone conference with other Group Records Coordinators that a group can have their own email address through gmail.com or yahoo.com. If a birthdate is needed for the application of the email address, it was suggested to use Lois birthdate of March 4th and the year 1951 for year Al-Anon started, ie, the birthdate would be 3/4/1951.

Please make sure that your Current Mailing Address (CMA) for your meeting is updated. The CMA receives all mail from WSO as well as the "Forum".

5/17/2014 Assembly Report – Institutions

Hello everyone,

I'm sitting here in the cool of the early morning trying to organize my thoughts about what I can report to you on Institutions service. At the Sharing of Service I shared about getting into service that is connected to my Al-Anon story.

I'm a graduate of the Kaiser Sunset Addiction Medicine department program for family members. I went back to the annual reunion last fall and brought copies of Al-Anon Faces Alcoholism (AFA) in English and Spanish for the staff to distribute in the program. I met the head of the family program and discussed ways we can be of service to them. They were very appreciative of the AFAs and we talked about possibilities for an Al-Anon panel as part of their program and an Al-Anon meeting in their facility after their Saturday morning family program.

Recently, I got a call from a member of the program who has been signing up on lists to be of service and never receives a call back. With rotation of service positions, those volunteer lists often go unused and this member was frustrated. I discussed opportunities for service and suggested that if you don't hear back after volunteering, you can spearhead a service project yourself. She was excited by the idea of spearheading the Al-Anon panels at Kaiser and/or starting the meeting there that the program requested. She has since spoken with the staff and is coordinating with them to begin that service. If you're looking to make newcomers aware of our program, think about doing this at a program near you.

I brought up the idea at the District of providing meeting directories to the Kaiser program and we took up that service as a District. When I delivered the directories, I got an opportunity to sit down with the counselor for the Spanish speaking programs and heard how helpful the Spanish AFAs were to her program that has limited resources. Those are some of the ways you can get into Institutions service in your area and make newcomers aware of Al-Anon.

As part of my commitment as Institutions Coordinator, I serve as the Al-Anon Co-Chair to the AA Hospitals and Institutions Conference. The Conference took place in April. The Al-Anon luncheon speaker was Rafael M. from Santa Ana. Rafael became a member of Al-Anon because Al-Anon members in Northern California do service by bringing Al-Anon meetings into the prisons. Rafael was introduced to the program while an inmate and then started Spanish meetings on his own in the prison. He has since been paroled and found his home meeting with us on the outside. He was an awesome speaker and an awesome example of using the principles of the program to help make life meaningful inside as well as adjusting to living with active alcoholism in his family when he returned to the community. I felt honored to meet him and was so grateful that he was suggested to me as a speaker. He had the opportunity at the conference to meet again with some of the Al-Anon members who made the "inside" meetings possible and they were able to discuss aspects of that service that they were not able to discuss at the time due some of the restrictions associated with service inside the prisons. Thank you also to Natalie T. and Gloria S. for speaking on the Al-Anon panel with Rafael about dealing with a family member incarcerated and about bringing a panel to a women's shelter.

While at the H&I, I learned that, after years of being told it could not be done, AA now has meetings inside Men's Central Jail in Los Angeles. This was due to a member of the Grand Jury who happens to be an Al-Anon member, who noticed that the deputy/manager she was interviewing was wearing a symbol of the other program, told her the jail really needed daily AA meetings and it was done after years of inaction.

If anyone is interested in trying to bring the Al-Anon program in also, please see me or call or email me and I will give you a contact and some information on getting cleared to do that service. It may take persistence, but if you have patience and persistence, and the desire to do that service, it can happen.

At the Sharing of Service in January, I collected names of members who'd like to help with a project distributing AFAs at the waiting rooms for visitors at the various LA County jail facilities. The Area provided AFAs this year for that service, the AFAs have arrived, and I will be contacting the volunteers shortly. If you are interested in helping, please contact me. I also tapped my own story for the idea of providing literature to the Victim's Assistance Family Violence program in LA County and will be contacting them soon. Please consider this as another way you can participate in Institutions service.

I'd love to hear about what you are doing in your areas and provide whatever support or ideas I can to help you out. I'm in my last year of this commitment and it has been very rewarding. Please think about being willing to be of service as a coordinator at the Area level in the next panel.

Would you like to help World Service by attending a workshop they are developing on "Treatment Facility Outreach"? They would like feedback from our Area on the public outreach training materials they are creating. It will be held Sunday, August 24,2014 at 12:30 pm at Hoag Conference Center (Main Hospital Campus) 1 Hoag Drive, Newport Beach. You can be part of helping to create WSO programs!

The focus was on how to facilitate a group business meeting using the KBDM process. Included in the handouts were a KBDM Quick Reference Tool and a Rationale Document that gave background information on why KBDM is a preferred method for holding an Al-Anon group business meeting to reach an informed group conscience. Over 35 participants attended and they practiced the KBDM process using situations that have often been brought to group business meetings all throughout our Districts/Area. A free lunch was included! Thank you to the committee that worked so well together and to District 21 who shared in this endeavor.

Public Outreach: Our project to place Al-Anon literature in all of the libraries in our district was successfully completed. Amy O., who organized this endeavor, personally contacted a librarian at each of the 10 libraries. In addition, some of the librarians asked for Alateen literature. *Courage to Be Me* could not be donated to the branches until it was added to the library database so Amy worked with the Central Library to get it added so that the local branches could accept copies. Once it was in the database, we had five volunteers take the books to each of the libraries. This was truly a successful "we" project!

Hospitals and Institutions: We donated 200 English and 200 Spanish *Al-Anon Faces Alcoholism* pamphlets to Kaiser-Permanent's Social Services Department for distribution to their members. Several departments will be giving out *AFA*: the Emergency Room, Psychiatry, Substance Abuse Treatment Center, and Domestic Violence workers. In addition, the social worker who runs the Panorama City Teen Medicine Center specifically asked for Alateen literature—which we were happy to provide.

Workshops: We co-hosted, with District 17, a successful Knowledge-Based Decision-Making (KBDM) workshop on May 10 from noon to 3pm. Thirty-five members participated in this workshop which combined some background on KBDM along with time for the participants to role-play facilitating a group conscience, using KBDM. The participants found that the more "hot" the topic, the more challenging it was to stay on task—just as in "real life" when we discuss emotionally charged issues at group consciences. Nonetheless, most of the participants agreed that KBDM is a way of structuring group discussions that is more aligned with our Steps, Traditions, and Concepts than is Robert's Rules.

Our next step is to hold two workshops, one on a Saturday, the other on a weeknight, so that more people can be educated about what KBDM is and how to use it in their groups. The participants in the workshops are becoming the "facilitators" of the KBDM process and are slowly teaching our district members how to use KBDM to "discuss before deciding."

Alateen:

Our district meetings really stepped up and generously contributed \$2100 for SCAC. We have 7 Alateens (perhaps two more) and two group sponsors attending SCAC this year. And we will be contributing toward the cost of the buses because they provide transportation for teens who would otherwise not be able to get to SCAC. Thank you to our members for their generosity!

Tina, our D.A.L., is continuing to collect empty bottles and cans from our members so that the Alateens can go with her to the recycling center and do the "dirty work" of changing cans into cash. They have earned \$70 to date—a big help for some of the teens whose families don't have the funds to contribute to their SCAC registration fees. They are "doing for themselves" in this creative way.

Love gifts:

For the first time in many years, our district contributed a "love gift" to the WSO Conference. One of our talented members, Frankie A., created beautiful bookmarks imprinted with the Serenity Prayer on both sides, and with the message "with love from District 21 Southern California." In this way, we got to be a part of the Conference without being there physically.

Our district treasurer, Mary Ellen R., died Tuesday, May 14, after an intense battle with cancer. She was a shining example of the Al-Anon program and gave back so much through her service to the district.

We continue to support our public outreach effort by ordering 1000 of the 2015 Al-Anon Faces Alcoholism in English and Spanish for the second half of the year.


