

Secretary, Sandy P. - Approval of Minutes 11/19/16. Marley asked to add her comment at the assembly to the Minutes under "Task Force on Groups That Do Not Consider Al-Anon as a Whole" presentation. Text to be added: "After the vote was taken to vote on this new policy, in response to some sounds in the room, Marley asked if we wanted to delay voting on the policy. That suggestion was shouted down." Motion made by Chris C., D40, seconded by Enid, D17 to approve Minutes as amended. Clicker testing, then final vote approved amended Minutes.

Open mic re questions and comments:

Questions:

Question re Event Plan: too bureaucratic; what is status of SCAC today?

Answer: SCAC is still in suspension; suspension will be lifted when the Alateen Restructuring Committee finishes the guide-lines. When that is finished it goes to Officers and when approved, suspension will be lifted.

Question: Why was there a recent Alateen fundraiser for SCAC?

Answer: This was not a SCAC fundraiser. Young Al-Anons got together and formed a fundraiser for their own Al-Anon meeting. (See also answer to next question.)

Question: How can this be stopped?

Answer: This was done by Young Al-Anons, ages 18-30, who were misinformed.

Question: What does "high risk" children mean?

Answer: Children who are affected by alcoholism.

Question: What did the Delegate say about 7th Tradition and SCAC?

Answer: Members choose whether to contribute to SCAC, which is why a separate basket is passed in meetings and not taken out of the 7th Tradition. District treasury comes from 7th Tradition money sent by groups, which therefore also is not available to be sent to SCAC. Districts hold the money for group that they collected in a separate basket, and that is the money that is sent to SCAC. See page 57 of the Service Manual.

Question: What can GRs say to their groups about restructuring committee.

Answer: Trust your trusted servants.

Comments:

- · Comment about ratio of AMIAS (10 teens to 1 AMIAS);
- Comment encouraging restructuring with flexibility and speeding up guidelines;
- Clarification that SCAC is not Alateen; it's a conference.
 Alateens, a part of Al-Anon, have Alateen meetings and Al-Anon have Al-Anon meetings.
- Isn't it double-headed management that the Officers have to approve the decision of the Restructuring Committee?
- Why does the Board have to approve the plan after the Resolution Committee has approved the Restructuring Committee? Jayme said the Resolution Committee has not approved the restructuring of SCAC.
- For point of clarification, Immediate Past Delegate asks Alateen Sponsor Coordinator if the document has been completed. Alateen Sponsor Coordinator said the document has not been completed.
- Al-Anon member shares all four of his children went to SCAC. His personal experience has been that SCAC has been a big part of the success in his children's lives. We have a legal and moral right to protect Alateens. Do whatever you can to get this done and set egos aside.
- Alateen shares that there are no rules in Al-Anon. Thank you for your continuing financial support with SCAC. Feels oppressed by our hierarchy and people sitting above in the podium.
- Al-Anon member says Alateen saved her life. Thinks we need to revisit ratios and event plans.
- Al-Anon member says he grew up fast in an alcoholic home and understands the questionable decisions of Alateens because he was one once. This is the 60th year in Alateen and it has grown into an incredible group. There are conse-

quences. Applauds what the Board is doing. AMIAS is important to help prevent predators.

- Al-Anon member relates to what everyone is saying and says that Board is trying to do the best job they can to make sure the kids are safe.
- Al-Anon member loves Alateen. Didn't know how to do anything before Al-Anon. Is eternally grateful for everyone on every board to keep our children safe.
- Alateen Sponsor Coordinator shared all the members of the committee believe that SCAC needs to be restructured.
- Al-Anon member says this topic should have been put on the agenda sooner and wasn't on purpose. Why?
- Al-Anon member talked about having a shorter one-day SCAC
- Al-Anon member feels the safety of our Alateens is of the utmost importance. Please continue to take care of our children.
- · "It takes what it takes."

Jayme added that SCAC traditionally happens in June, however this would be impossible this year because it's already May. Maybe it will happen in the next month or the month after that. We need to finish the document and take it one step at a time. We want to make the next SCAC as safe as it can be.

Welcome to the new and returning Group Representatives!!

You are the link between your group and other groups worldwide.

The links of service give us a mechanism for observing Traditions One and Four, Unity and being careful not to make decisions in an Al-Anon group that affect Al-Anon as a whole.

Those decisions are made at the World Service Conference (WSC). I returned only 3 weeks ago from the 2017 WSC in Virginia, which met Mon – Fri Apr 24-28. Thank you for the opportunity to carry your voice to the Conference, as we at the Conference made decisions that do affect Al-Anon as a whole.

Monday is a pre-Conference day, with an 8am Orientation for new Conference members (new Delegates, new Trustees, new WSO Staff). Each Conference member met with the Thought Force, Task Force or Committee that each requested and was assigned to. In the Sharing Area Highlights session, groups of Delegates discussed topics, with the other Conference members invited to listen. Only the Delegates have voice at this session, which is put on by and for the Delegates. The Delegates brought our Area perspective and our experience as Trusted Servants.

WSO Reorganized

Under the direction of the Interim Executive Director, and with input from the entire staff, the World Service Office was reorganized to make the composition less top heavy and to allow for more communication and cooperation between departments and individual staff members. There is an excellent description of this in the Annual Report in the 2017 Conference Summary.

In-House Technology

A Digital Strategy Manager and a Webmaster have been hired. It has become apparent that for Al-Anon Family Groups to remain relevant, it needed to focus on technology. To that end, instead of relying as much on contracted vendors to handle the technology the decision was made to hire these two new positions. Watch for some very exciting things to be rolling out of the World Service Office, as a result of these hires.

Tour of the WSO

Tuesday afternoon, Delegates and Guests went to the World Service Office for a tour. The Trustees were there waiting at the front entrance to 'Welcome Us Home!' After warm greetings from Mary G., Interim Executive Director, the tours began. The Al-Anon logo is used in the architecture and accessories throughout the building. Although 20 years old or so, the building is so well cared for that it looks and feels like it is brand new.

We visited all the staff members in their offices. Great care was taken to design the building with plentiful views of the natural beauty outside for every staff member. Artwork created by members around the world lined the corridors. Meeting rooms are filled with artwork showing our Legacies and slogans.

Group Services

Sue P., Associate Director – Groups asks that we please verify the information on the WSO Public Website to be sure it reflects our local meeting lists. Just go to the Al-Anon website, and Click on '<u>Find a Meeting</u>', and put in either the state, county or a zip code. Your meeting time & location should come up, when it does check that your meeting information is correct. If it is not correct please notify our Area Group Records Coordinator, Donna E.

FYI – this feature only worked from my desktop computer, not on tablets or phones!

Please make sure that your specific meeting can be easily found by someone new, by placing signs around the location

to guide others who may not be so familiar with your meeting room!

<u>Alateen</u> is 60 years 'young' !!!! Members are encouraged to send U.S. postal and electronic "Happy Anniversary" cards for a special display to commemorate Alateen this year.

Sue reminded us that according to our policy on "Membership Eligibility" (pg. 81) in our *Service Manual,* "Where there is no Alateen meeting available, young people are encouraged to attend Al-Anon meetings.

Service Manual. Next January, in 2018, the new Service Manual will be available as a free download with interactive links on the members website. Hard copies of the Service Manual will be available for \$5, Groups at Work for just \$1, same prices we have now.

It is my hope that all of our meetings in CA-S will purchase a hardcopy from their LDC Literature Distribution Center or at the Assembly when they are available next year.

We met Valerie S., Group Records Coordinator, who also usually is the one to answer Alateen questions. She also answers questions from French-speaking members and helps with translation into French. Valerie shared meeting statistics:

Total mtgs Worldwide: 24,919 U.S. Al-Anon: 12,786 (242 fewer) U.S. Alateen: 866 (40 fewer) Electronic meetings: 157 Online: 51 Phone: 106

Reported Not Meeting

This is a new meeting status in the database. It allows the WSO to stop directing people to groups that are not meeting. The flagged meetings are temporarily removed from the WSO listings, until the status of the meeting can be verified.

43% (or 20 meetings) of those reported actually were meeting. It was revealed that the meetings didn't have signage throughout the building to direct people to the meeting room, or location instructions on their group records, or had moved to another location.

26% no longer meeting

31% still being verified. Valerie notifies Donna, the Area Group Records Coordinator. She emails the CMA Current Mailing Address of the meeting to try to confirm what's going on with that meeting. The DR is copied on the email, and is welcome to follow up with the CMA. If Donna does not hear back from the CMA, that means Valerie does not hear back from Donna, and so then the Delegate is notified of the Reported Not Meeting status two months after the original email was sent to Donna. The Delegate will contact the DR to see if someone in the District can try to attend the meeting to determine what is the status. Please ask the CMA of your group to be alert for emails from the Area Group Records Coordinator.

Communication Services

Claire R., Associate Director of Communication – Professionals answers questions about Public Outreach or how to carry Al-Anon's message to the Professional Community, Claire was the person that you would have talked to. She has been with the WSO for many years—even when the WSO was in NY.

Claire came to our TEAM event when it was in Fullerton. The most striking thing I remember her saying that day is that she had been dead set against the purchase of the property at first, until someone mentioned the 7th Tradition, and how we must take care with the contributions sent so lovingly by members. Sending those contributions to pay higher and higher rent wasn't a prudent use of member contributions, nor of the WSO staff time every time they had to relocate. It was these thoughts about the Seventh Tradition that made her a full supporter of the purchase of the property, which has saved us many millions in rent, whether in New York or in Virginia.

Claire reported the recap of 2016 website digital postcard inquiries from professionals. The tally reaffirms the three primary and largest sources of professional inquiries: 38% mental health counselors, therapists and social workers 19% addiction facilities counselors 18% middle and high school educators 25% other

Challenge to members: increase awareness of Al-Anon among smaller audiences such as Medical, Clergy and Employee Assistance/Human Resources professionals.

Al-Anon Group Contacts at correctional facilities are distributing *a new* <u>Writer's Guide for Incarcerated Al-Anon Members</u>.

This *Guide* is an invitation to share and gives incarcerated members a voice. To date, 4 *Forum* sharings for have been received. Claire said besides submitting stories for *The Forum*, our hope is to explore the development of a Public Outreach service tool by using quotes from the incarcerated members' sharings.

<u>AFA Al-Anon Faces Alcoholism 2017</u>: 184,625 copies ordered by members by Feb deadline, record set for second printing. This is 19% more than last year, breaks previous record set in 2012.

Redesigned cover of AFA 2018

- A new masthead, "Help and Hope for Families and Friends of Alcoholics", focuses on Al-Anon's purpose and the content of the magazine.
- The title and year of the magazine is now positioned in the lower portion of the cover with less prominence placed upon the year of the publication.
- The bottom right-hand corner features a small block of text to let the reader know that the AFA magazine is FREE and can be taken home.

<u>2018 Membership Survey</u>: It is important for members of all ages and backgrounds to participate in the survey. Taking the survey is a way for the general fellowship to be of service to Al-Anon. Are we truly mainly Caucasian women with an average

age of 67? ...or does this reflect only the members who take the surveys?

Public Outreach Media

Pat Q., Associate Director of Communication – Media, provided the Delegates with copies of the current PSAs.

Social Media - In the first quarter of 2017, Social Media Channels reached a combined Audience of 3.3 Million.

65,000 "engagements" means people liked, shared, or posted comments 65,000 times on Facebook, Twitter and Instagram during the first quarter of 2017.

PSA - Preliminary reports on television Public Service Announcements show an estimated audience of 52 million people that saw the new Al-Anon PSAs during the first two months of 2017.

New Electronic Distribution for TV and Radio PSAs

It is as simple as making contact with the right person at your local station. Then meeting that person, accessing your smartphone, tablet or laptop on your visit to show them the PSA and then have the WSO set it up electronically with the contact person you visited at the station. The PSA will be supplied in any format requested, at no charge.

Conference Approved Literature

Tom C., Associate Director of Communication – Literature, oversees the Forum publication and is the Staff liaison to the Literature Committee of Delegates and At-Large members who review of our literature.

Delegates are asked their preference for the Opportunity to Serve. We meet with their Thought Force, Task Force or Committee at the Conference after having worked together all year by email and telephone conference calls.

Some Delegates chose the Literature Committee. Their first real 'reading' assignment in 2017 has come with the reading of the first Draft of <u>Parents & Grandparents of Young Problem Drink-</u><u>ers</u>. If progress stays on track, it may be released by Conference time next year.

The Intimacy Book has gone to editor/writer and those on the Literature Committee were told to expect a first draft of the entire book to be ready for review in May. (They will have a busy summer of reading!) After the process of reading and reviewing, they hope it may be available in English at the 2018 Al-Anon International Convention in Baltimore.

The new <u>Daily Reader</u> is still accepting sharings. To help clarify the difference for the fellowship between a daily reader sharing and a *Forum* sharing, an article was published in the January 2017 Forum magazine. No deadline has been set for either submitting sharings, or the proposed publication date.

Member Services

Kerri K. (R) is the new Associate Director Member Services -International. She assists all International service entities with Al-Anon business and will visit many different countries in this position.

<u>Reprint Permission</u>: For the first time, permission was granted to an Al-Anon Information Service (AIS) office located in Poprad, Slovakia for the translation of *Al-Anon's Twelve Steps & Traditions* (B-8).

<u>Translation</u>: The WSO has been busy working on translation of over two dozen publications since the beginning of the year, including Pamphlets, Newsletters, Order Forms, and Magazines. They are also preparing to undertake translation of the updated website and the revised *Al-Anon/Alateen Service Manual*.

The display cases at the WSO showed books translated into Swedish, Norwegian, Finnish, Japanese, Portuguese, Polish, German, Icelandic, French, and Italianamong other languages

<u>Fellowship Communication</u>: Since January, the International Section has had verbal or written correspondence with 41 different countries.

TEAM Event

Suzanne M. will be with us at the TEAM event on Sept 16, right here in Glendale. Also with us at the TEAM event will be Debbie G., Trustee, Regional Trustee from the U.S. North Central, Chairperson of the Board of Trustees (COB of the BOT Board of Trustees); Paula B., Member at Large of the Executive Committee, immediate past COB; Marilyn M., Trustee, Regional Trustee from Canada West.

We will get to hear each of them share their Al-Anon story, and to make presentation from the WSO and 3 joint presentations with members of the Area. Be sure to come to the TEAM Event. Marcia, Alternate Delegate CA(S), has arranged 3 excellent topics from the suggestions she received from the Feb AWSC meeting.

Member Services, Digital Strategy

Scot P. is the new Digital Strategy Manager, his background is in Marketing and technology for a Fortune 100 company. Scot and his team are moving the WSO further forward into technology.

At this year's Conference the team introduced an App called 'guidebook' that attendees could use on their Smartphones. With this App we had access to agendas, maps, meeting room locations, and each other. This was a test for possible use at the 2018 Al-Anon International Convention in Baltimore.

One could not help but notice the lack of papers in his office. Everything is digital !

Archives

Joe T. is the Archives Coordinator. He loves the history of Al-Anon and treats every piece of paper as gold, keeping all of the archives clean and well protected.

WSO Restructured: Two Directors

<u>Director of Programs</u>: Marsha W. supervises all of the positions just listed, ...and more. Marsha has served the WSO for a long-time. With the restructuring of the WSO, Marsha was promoted to Director of Programs, becoming one of the key people providing leadership at the WSO.

Director of Finance: Niketa B. (required to be non-member) supervises all of the positions related to handling the input and output of money. Niketa provides all of the financial data for the creation and review of the annual budget, and provides the documentation for the annual audit. Niketa knew nothing about Al-Anon when she first applied for the position. She shared with us how impressed she was with our Board's Vision & Mission statement, our office staff, and that she had never worked in a corporate position where people give you hugs at work! "It's so different here!" she exclaimed during her presentation.

Both of these positions report directly to the Executive Director. Either position may substitute for the Executive Director in her absence.

Financials

The WSO budget for 2016 projected a \$184,000 shortfall that would be taken from the reserves to pay for expenses. The budget included \$1.8 million in contributions.

Great news: because of your contributions 'we' turned things around!

\$15 at a time, **we contributed \$2.1 million in 2016**. Thank you!!

There was a net increase of \$88,153 and this was used to pay back the reserve fund toward the previous transfers.

Jennie M. also informed us that the severely lowered level of literature purchases indeed continued in 2016, therefore the increased contributions continue to be needed. Please continue your increased contributions. Thank you. Expenses, 2016 vs 2017 Look at the very bottom line that says 'Net Increase (decrease):

To arrive at these circled numbers, Total Expense is subtracted from Total Estimated Revenue.

If Revenues exceed Expenses, it results in a surplus, which is a desirable thing and there will <u>not</u> be parentheses around the number.

If you look at the 2016 Revised budget, (middle column) Total Expense (\$4,998,000) is greater than Total Estimated Revenue (\$4,873,000) so we were projecting a deficit budget of \$125,000 for 2016. Notice that this number is in parentheses to indicate the net decrease (more going out than coming in).

If you look again at the 12/31/2016 Audited Actual, you will see that we actually ended the year with a surplus of \$88,153.

2017 Preliminary Budget and 12/31/16 Audited Actual are surpluses, \$10,500 for 2017 Preliminary Budget and \$88,153 for 12/31/2016.

<u>Operating Expenses</u> are budgeted to increase 4.4% in 2017 (below):

2016 was a transition, and ultimately some staff positions remained vacant as the office was reorganized and priorities and needs were evaluated. The increase in expenses would not have been as large if the office had been fully staffed in 2016, of course, because we weren't paying salaries or benefits while the positions were vacant. Happily, not only are those vacancies filled but we hired a webmaster which means that long-awaited web redesign is close to reality.

Outreach in 3 different ways, by means of:

TEAM events Road Trip – You and Your Board Connect, Zonal meetings (international) all these ways have a significant cost but the benefits of such meetings justify the cost and then some.

The Trustees and WSO staff are confident that wherever they have suggested cuts to the budget, it will not have a significant impact on the purpose and priorities of the World Service Office.

They feel that this budget goes a long way toward providing the services the membership needs and requests.

2016 Revenue vs Expenses

Literature sales were down and Forum sales were up slightly, and the big news is that the contributions received from our groups made up for that deficit (below):

In addition, 2016 was a better year: our investments increased.

Also, there was a \$408,000 increase in Program Services expenses, offset by a \$272,000 decrease in General Administration expenses. These numbers are shown in the first and third lines under FUNCTIONAL EXPENSES.

This means that more services are being provided to our fellowship.

2017 WSO Budget

The 2017 WSO budget was approved at the World Service Conference with a \$10,500 projected income. <u>This assumes the same</u> <u>level of contributions and literature sales, and increased investment income</u>. Expenses are slightly higher due to salaries (additional staff to support technology advances).

The expense increase is offset by multiple decreases: by decreases in postage (due to elimination of free Forum subscriptions to the groups), decreases in legal expenses, decreases in general services meeting, savings in PSA campaigns (we're re-issuing the 2016 campaign) and other miscellaneous decreases in expenses.

SCHEDULE 1

Travel Expenses

We are budgeting an increase of about \$38,000 in Travel and Meetings, mostly due to the Zonal meetings this year in Germany, Guatemala, & Ecuador. Zonal meetings occur in the odd -numbered years.

There will also be nine TEAM events, each event includes one staff member, one Trustee, and either the Executive Director, Chairperson of the Board or Chairperson of the Executive Committee. One of them will be in CA(S) on Sept 16!

The Executive and Finance Committee typically meet face-toface ten months out of the year and two months by conference call. The Board of Trustees meets quarterly. One of those quarterly meetings is the "Road Trip: You and Your Board Connect". The 2017 Road Trip will be in Aurora, Colorado on Oct 21 & 22. The purpose is to take the Board of Trustees and Executive Committee members to a local Area, hold its meeting there and then on the day after the Board meeting meet with local members. This event is an opportunity for your Trustees and Executive Committee members to share their personal recovery and their current service roles in an intimate setting with you. It is also an opportunity for members to learn more about how the World Service Office (WSO) serves the fellowship.

Staff attend conferences dedicated to understanding alcoholism and its treatment. Al-Anon's attendance is crucial in making the professional community aware of what a valuable resource our program is to family recovery.

Income, 4 sources

There are four sources of income: Forum magazine subscriptions 4%, member contributions 40%, literature sales (CAL) 51% and investment income 5%.

Literature : Contributions used to be 2:1

Now it is 1.25 : 1 51/40 = 1.25

Contributions used to be 1/3 and now it is 40%. Great work! Let's keep up with the contributions and maybe contributions can get closer to 2/3 of the income.

Great! That means the members are contributing more to make up for not buying as much literature.

When many of us do a little, it adds up to a lot.

The increased contributions in 2016 are:

Mainly from \$15 contributions

Very little is from bequests

If this continues, then in 2017 we might not have to transfer money from the reserve fund.

<u>Reserve fund goal</u>: have 12 months of expenses on hand, recommended for not-for-profit organizations.

Thanks to member contributions, we have an 8-month reserve at this time.

2016 WSC Task Forces

Three new tools were developed by 2016 WSC Task Forces and presented to the Delegates at this year's Conference.

Chosen Agenda Items (CAI)

Delegates voted on a single topic to be discussed on the conference floor. This year's topic related to <u>Barriers of Attracting</u> <u>and Maintaining Members</u>. These are only a few of the ideas shared with the conference by the Delegates. The Delegates' feedback falls into 4 categories.

1. Supporting Families and others

Babysitting; Multi-Addiction Issues; Offering Sponsorship; Friendly New Member Welcome; Follow up Calls

2. Technology

Whatsup app; Bitmoji; Text; Email; Electronic Meetings; Phone Meetings

3. <u>Alateen</u>

Is it social or is it recovery based? Transitioning to Young Al-Anon Member Meetings; Involve Alateen on Service Committees; Updating Alateen Literature; Ask an Alateen to Share at an Al-Anon meeting; What happened to Alateen Focus month

4. Meeting types

On Campus meeting; Co-locating with AA; Invite to come early /stay late; New Member Beginner Meeting Format (G-2); "God" can be scary, Try "Good Orderly Direction"

Breakout groups, CAI

1. Cooperating with AA

Open meetings, opportunities at conventions to share or make presentation; Provide an Al-Anon description of what our program is, to be read at AA Conventions; Combined Social Events; Speaker exchange at Assemblies; Supply meeting lists to AA Information Service Office; Exchange contact info at District/Area level; Providing convention Speaking, Al-Anon guidelines to AA Liaison

2. Staying true to our Legacies

...when families with loved ones who have drug addiction come to Al-Anon meetings. WSO Research says, among those in treatment: 21% only alcoholism, 20% only drug addiction, 50% treatment for both. We can't ignore these facts. Tradition Two - I'm not an authority and I'm not supposed to judge. Be gentler with drug-addicted family members when they show up in Al-Anon

3. Service Commitments & Service Sponsorship

-Are we making service fun? TSA: Trusted Service Announcements – In the lull of a service meeting, give short announcements of what you do for your service position. Warning Sign Checklist for Service Commitments; Phone calls to stay in touch vs. emails; "The group recognized your growth and think you might do this well." Encourage the encourager to continue. Ask personally instead of announcing "we need." The word 'service' is avoided when attracting – stress that it's part of the triangle; Alternate positions or shared leadership is stressed to be successful. Media Café?? Set up different computers to different web sites to look at different things on the WSO Members Web Page- help members know what's there & how to navigate

Warning Sign Checklist for Service Commitments: Are you getting burned out? Do you see someone else getting burned out?

Trustee Boot Camp

The Panel 55 Delegates met in the Board room at the WSO and we had several opportunities over the week to hear about the continued benefits of Service as a Trustee. I have to admit sometimes it felt like a hard sell, but they are all Al-Anon Members and they see things in us that we may not see in ourselves. For me seeing where they meet and being shown an example of the schedule they keep was an insight into how much they do as Trusted Servants for Al-Anon.

Prayer for Today

After two floor discussions at last year's WSC, the Delegates were asked to bring this topic back to their Areas to get a better understanding of how the fellowship felt about the inclusion of this Prayer on our Just for Today Bookmark.

This year, Delegates were able to bring the voice of their Areas back to the WSC. However, after a lengthy discussion on the floor, it was clear that there was no consensus to either keep or remove the prayer.

The group conscience of the Conference agreed to pause the conversation at this time and do nothing unless or until new information comes forward. If you have any <u>new</u> ideas or information about the prayer, you can send it directly to the Delegate.

There was also a discussion about turning a recent Forum article, "Just for Tonight" into a bookmark. The suggestion was sent to the Literature Committee for further consideration.

Open and Closed Meetings

The Policy Committee asked the Conference to consider the history of the terms "Open" and "Closed," the feedback from the Delegates, and what, if any, direction the Policy Committee should take.

The goal was to reach consensus upon a course of present or future action or inaction.

After much discussion, the Conference took a consensus vote.

1) Confusing to Both New and Existing Members as Well as Professionals

2) Most Areas agreed that Website designation of 'closed' meetings should be removed.

3) Consensus that further discussion by the Policy Committee is needed to consider the terminology and alternate wording appropriate for modern times, while upholding anonymity, confidentiality and safety of all Al-Anon members.

Open Policy Committee Meeting

Thursday Evening, the Delegates attended an Open Policy Committee Meeting. This was a very interesting meeting. Here are a few examples from their discussion that I want to share with you;

1. <u>Group autonomy</u> considering the principles contained in Tradition 4 and Warranty 4

Who gets to decide? Reasoning it out vs. interrupting a meeting. Unity, understanding, patience, compassion, not self-righteous. Conversation after the meeting. Solving problem together via business meeting and group conscious.

This is exactly what our Area Policy stresses in CA(S).

The Policy committee voted to continue the conversation.

 <u>Electronic Meetings</u> – How to in include & support them in the spirit of Tradition One; How could we include them in our Service Structure; 6000 members in electronic meetings in 1990s to 13,000 today; Could they be a virtual "Area?" Request made for yearly contributions by these groups

Policy committee will do KDBM to further explore this topic.

Service Manual Updates

1. "Financial Matters" section

Motion 6: To amend the text on **pages 95-99** in the "**Financial Matters"** section of the 2014-2017 Service Manual in the "Policy" Section.

The new text incorporates our Spiritual Principles in the text and cleaned up verbiage to make it more consistent with current practices. (There is a new section for workplace combined-giving donations, which Al-Anon members can partake in. However, matching employer donations cannot be accepted.)

-Language to reflect Spiritual Principles of giving and receiving.

-Self-support - why we do what we do.

-Using services offered to not-for profit organizations.

-Updated for technological changes.

We took a vote after the Conference was asked:

Is it accurate? Does it provide clarity? Can I live with it?

Motion 6 passed unanimously.

2. "Membership and Group Meetings/Conventions" section Motion 7: To amend the text on pages 85-86 and 123-124 in the "Membership and Group Meetings/ Conventions" section in the "Digest of Al-Anon and Alateen Policies" section of the Service Manual (P-24/27)

The new text was created by the Policy Committee to clarify several issues that have come up in regard to what could be announced at meetings, and event flyers being distributed at meetings when the event does not abide by Al-Anon's Traditions.

-Core spiritual principles that characterize Al-Anon and Alateen events

-The philosophy and criteria for identifying events and activities as Al-Anon and Alateen

We took a vote after the Conference was asked:

Is it accurate? Does it provide clarity? Can I live with it?

Motion 7 passed unanimously.

3. "World Service Handbook" section

The WSC amended the text on pages 131-165 of the World Service Handbook section of the Service Manual to reorganize information and make it easier to find, as well as to clean up text and reflect current activities for various service positions. Changes were made to several service positions, including the Group and District Reps. The same clean up process was applied to the section for Assembly information, Elections, Finances, the World Service Conference and the WSO activities. It is important to note that the changes were related to clean up and not to procedures.

We took a vote after the Conference was asked:

Is it accurate? Does it provide clarity? Can I live with it? Motion 5 passed (1 no vote).

Report for May 20, 2017 Assembly

(Information regarding specific incidents have been removed from this report).

The first step in the Knowledge Based Decision Making process is to "frame" a topic and then present the history of the topic so that everyone has access to the same information.

I am a grateful member of the world-wide fellowship of Al-Anon and Alateen. I am humbled to have been asked to provide this report/document of the history of Alateen and of SCAC then and now. I will try to paint a brief picture for you of where we have been and where we are today.

I was asked to provide this information to you because I have been involved with SCWS for the past 18 years: three years as a Group Rep, three years as a District Rep, three years as your Area Group Records Coordinator, three years as your Area Chair, three years as your Delegate and now three years as your Immediate Past Delegate.

I asked my Higher Power to guide my thoughts and words while writing this report. I also asked that members would read this information with the understanding that it was written from my heart, having the upmost love and respect for the Al-Anon/Alateen fellowship.

Southern California World Service Area Bulletin-May 20, 2017

You will read things in this report that may give you pause. I am writing about the elephant in the room because we know, as people affected by the disease of alcoholism, that we are "as sick as our secrets." And as the decision-making body of Southern California, it is critical that you are informed about where we were, and where we are now.

In order to provide the big picture I need to take you back to 2003. Prior to 2003 there weren't any requirements for Alateen safety in place for any Area. Our Area was torn apart by the WSO's Board of Trustees motion that each Area must have Safety and Behavioral Requirements for Alateen and <u>Al-Anon Members Involved in Alateen Service (AMIAS) in place by December 31, 2004. Let there be no misconception about the AFG Board of Trustees (BOTs) motion. The motion cannot be overturned by a vote of the Conference or an Area; it can only be changed by a new motion by the Trustees. This was a legal action of the Board of Trustees. The requirement of having all adults in the presence of Alateens certified is not going to change.</u>

Anything that goes through the Board of Trustees comes from the Al-Anon Groups. The Trustees are our trusted servants. *Concept One: The ultimate responsibility and authority for Al-Anon World Services belongs to the Al-Anon groups.* The whole point of the 2003 motion is that the Area acts as the agent for AFG, Inc. on Alateen issues and safety.

The Area was not completely aware of the years that this issue had been discussed at the WS Conference. Or it's more accurate to say that we were informed, but this was during the years when the Delegate read her/his report and many members missed the importance of this information. In addition, very few members read our Conference Summaries.

The motion was brought back to the Area from the WS Conference in 2004. It was communicated to the members, and needless to say, it caused tremendous division and controversy.

In October of 2004 a Special Assembly was held to discuss and vote on the Board of Trustees motion. That motion stated that each Area must have Safety and Behavioral Requirements in place by December 2004. The Special Assembly was very contentious and heated. Those of us present remember how extremely difficult this Special Assembly was.

Eventually a motion was made and a vote was taken. The motion was that SCWS would accept the WSO Minimum Alateen Safety and Behavioral Requirements. The motion failed to pass by a few votes! After the vote, some members believed that the Special Assembly was over and left for the day!

Then at the 11th hour a mother of an Alateen went to the microphone and described the situation her daughter went through at the hands of an Alateen Sponsor. Some members booed her, saying don't bring that emotional stuff to manipulate us. This courageous mother gave the painful truth about what happened to her daughter.

The members who were left at that Special Assembly raised the question, "What happens now?" More discussion ensued, and

the Special Assembly was reminded that if the Area did not have something in place by December 2004, our Alateen Groups would not be registered with WSO and therefore could not meet. Immediately, another motion to accept the Safety and Behavioral Requirements was offered and seconded. The ballots were counted and the motion passed by a two-thirds vote!

This didn't end the controversy. The members who had left early were angry and upset. There was gossip, dissension and criticism of the WSO and SCWS. The Area has been trudging uphill ever since.

The specific policies and procedures for implementing the Requirements took several years to formulate and then carry out. These kinds of policies and procedures are very complex, and had to be phased in-over time. There were several aspects of the members' decision that were <u>not</u> immediately implemented. Two examples were (1) Certification and Recertification Workshops for AMIASs each year (which took several years to create and implement) and (2) the requirement of Event Plans for all Alateen Events (which we began to address in earnest about 3 years ago).

As the Area has worked hard to conform to the Requirements. Each time a new safety measure is implemented and introduced by the Area (and that should have been in place since 2004), the Alateen Sponsor Coordinator, Area Alateen Process Person, and the officers of the SCWS Board hear from a few irate members with objections. There has been a lot of pushback to the legal requirements. Al-Anon is not above the law, as stated twice in our Service Manual, pages 42 and 54. It is about the protection of other people's minor children and we are legally and morally obligated to protect them. We must meet the same standards as the rest of society. Al-Anon is no different than any other organization who deals with other people's minor children. Anyone who has worked in child services understands this.

We have come a long way. The paradigm is shifting and many members are getting on board and understand how this process is working.

The History of Alateen

We are proud of the fact that Alateen was started in Pasadena, in September 1957. Our Area Al-Anon members have been extremely supportive of Alateen members and Alateen groups from the beginning. That being said, there were some factors in how Alateen evolved in Southern California that have contributed to why implementing the Event Plans has been so contentious.

The history of the Alateen culture has been one of resistance to the requirements set by WSO and our Area. There have been Alateens stating:

- "We are in charge, and you, the Al-Anon adults, are our guests but you will not have any decision making power," and
- "This is the way we have always done it," and

This situation, in which Alateens were given almost complete and sole autonomy for their decision-making without "interference" from adult Al-Anon members, has led to the endangerment of some Alateens. In an effort to maintain anonymity and confidentiality, many situations with Alateens or AMIASs were kept from you, our members. The situations that have occurred involved the safety of the Alateens.

One of our ongoing dilemmas had been the "aging out of Alateens who then became Group Sponsors or AMIAS' at age 21. One day a 20-year-old is an Alateen and the next day a 21-year- old AMIAS. We expected them to act as adults and not as Alateens. Many former Alateens were unable to make that transition—nor should we expect them to. Hence, the reason it is now necessary for an AMIAS to be 25 years old in Southern California. The Alateens need that break to mature and get involved in Al-Anon and identify as Al-Anon members, rather than as Alateens, in order to become an AMIAS.

Since having these safeguards with the Area Alateen Safety and Behavioral Requirements in place, these endangering incidents have dropped significantly.

SCAC

SCAC is the Southern California Alateen Conference. It is a conference for the Alateens and not to be confused with Alateen. SCAC is NOT Alateen. It is simply a conference like any other AA or Al-Anon Conference. SCAC is not a "right"; it is a "privilege", just as it is for any Al-Anon member who wishes to attend a convention/conference. Yet, historically, Southern California has lumped the two together as if SCAC were Alateen and vice versa.

SCAC has been in existence for approximately 46 years. Both of my daughters, who are now adults in their 40's were Alateens and attended SCAC for many years. I am very familiar with SCAC as a parent and as a member.

SCAC should be congratulated and receive praise for providing years of fellowship and support for many of the Alateens that have attended it. Nonetheless, there have been numerous instances when our Twelve Traditions and the safety of our teenagers have been disregarded.

The Alateen Coordinators and SCWS CA(S) Board members have been informed about wide ranging problems at SCAC, and we have asked the SCAC Committee to correct them in the past. Our part in this ongoing problem was that we were asking the Alateens (minor children) to correct their own behavior. Many of our requests were brushed aside and ignored. The culture of SCAC was that the Alateens were in charge of SCAC. And while the teens who organized SCAC often did a good job of creating a positive experience for most SCAC attendees, we were permitting the Alateens to be in charge of their safety themselves.

It is not appropriate due to anonymity and confidentiality, to list all of the concerns and potentially harmful situations that have occurred during previous SCAC events. However these issues have increased over the years. Suffice to say, that there have been problems such as teens leaving their assigned rooms at night, inappropriate sexual conduct, and use of illegal drugs which seriously impacted the safety of our Alateens.

SCAC Financial Information:

In 2010, there was a large financial shortfall of about \$8,000 for Southern California Alateen Conference (SCAC) because the contract was read incorrectly! The 2010-2011 SCAC Committee came to the Area and requested help. The Area responded by requesting the groups of SCWS voluntarily contribute money for the shortfall. SCAC's financial viability was saved.

Then in late 2011, it was the discovered that there had been a theft of the money from the SCAC bank account of \$23,000. The theft was not committed by an Alateen; it was an AMIAS. However, if the Area Safety and Behavioral Requirements had been in place this may not have happened. Again the Al-Anon groups of SCWS came through with their voluntary contributions to help defray the shortfall. The Groups have always come through. Again, SCAC's financial viability was saved.

The end result is that the SCWS now has oversight of the SCAC bank account which the Alateens themselves put into the SCAC Bylaws by a 100% unanimous vote of the Alateens at 2013. For example, if there is a withdrawal from the account, the SCWS Treasurer is notified from the bank via email. The SCWS Treasurer and the Area Alateen Sponsor Coordinator both serve on the SCAC Board of Directors.

All of these financial improprieties have resulted in an improved relationship between the Area and SCAC. There is a trust and an understanding and that has never existed before. In the past, when any questions were asked to the SCAC Committee about financial matters, even how much SCAC was paying for the Conference, the reply from the SCAC Committee was "it is none of your business". This occurred even while the Al-Anon groups were contributing \$65,000 annually to SCAC by their voluntary contributions. Well, financially we have come a long way from those days!

Groups understand that their contributions to SCAC are voluntary meaning, that a second basket is passed for SCAC. SCAC contributions cannot come from the 7th Tradition money, including from district treasuries.

Some ideas/questions to ponder:

- We need to move to a point where "the need for safety" is a reality for every member of Al-Anon and Alateen.
- We need to change our Area's understanding of SCAC so that we view it as an adjunct to the Alateen program, but it is not Alateen. It is an event planned for the benefit of Alateens in the Alateen program.
- The understanding of the role of AMIAS' at SCAC has to be clear to all AMIAS and to the teens attending SCAC. That is, the adults are legally and ethically responsible for the safety and security of the teens, and their authority has to be respected.

- Any serious problems, issues, and situations that occur at SCAC must be confronted, discussed and resolved and not "swept under the rug." This is necessary so that these situations do not reoccur.
- The SCAC Committee should understand that they will be held to the same expectations and standards as other Alateens.
- It's legitimate to address and discuss the issue of appropriate and inappropriate clothing at SCAC and other Alateen events.

In closing, I want to assure you that I have given this report based on a principle that is the very foundation of KBDM: to share information as honestly and truthfully as possible, so that all of our members have access to the information we need to assure an informed group conscience.

Please presume good will, as I attempt to do every day....the miracles happen when we least expect them and most need them!

Ask-it-Basket

Ask-it-Basket?s/Answers

1. Q Can the WSO or our Local Service Center offer Literature Gift Certificates; to help boost Literature sales?

A: What a great idea! You could send an email to WSO with your idea. The San Diego Information Service Office/Literature Distribution Center were contacted, and a discussion is beginning about the possibility of having a Literature Gift Certificate.

2. Q a. Now that we own property, can we be sued? If so, is it WSO or the fellowship that would be sued? Is there a fire-wall? I ask because some groups or members use property as the reason for not donating.

A. WSO was contacted and the short response could be that anyone can be sued, including WSO. And yes they have insurance. (More information on this question will be added in the next Bulletin.) This question may be part of a bigger concern regarding the ownership of property. A full Historic Overview of WSO Property is available on our Members website at www.al-anon.org/members. Go to the query box and type in that title and four documents can be found. The 2004 World Service Conference Summary also accessible on the Members website has the full text of Motion #12 and the preceding World Service Conference Discussion. The Motion to establish the Executive Committee for Real Property Management (ECRPM) and the next 15 years of reports of the ECRPM can be read as well. The ECRPM was set up to separate the management of the building from the spiritual work of the WSO and to examine whether that separation was successful for each year for 15 years to determine that our Traditions weren't violated. The 15 year trial period was evaluated and ECRPM found that the separation was successful and the Traditions were not violated. After the mortgage was paid off, the World Service Conference voted (2011) to maintain the ownership of the property. WSO continually saves money by owning the property and not leasing.

Q b. What kind of Al-Anon events cannot be announced at meetings?

A. Service Manual, p. 9 "announcement of local Al-Anon events", p. 56 "It is important that only Al-Anon/Alateen events are announced in our meetings. Because of our special relationship with A.A., A.A. events with Al-Anon and Alateen participation can be announced, but at an Al-Anon meeting or meeting location, groups do not announce or discuss activities of other Twelve Step programs. Publicizing events of other organizations creates an appearance of affiliation, even if the event is composed primarily of Al-Anon or Alateen members." "The Sixth Tradition suggests that there be no promotion or endorsement of any outside therapies. At an Al-Anon/Alateen meeting, in keeping with the Al-Anon/Alateen focus, the groups do not announce or discuss activities of other anonymous Twelve Step programs. Al-Anon/Alateen Area newsletters and local bulletins may publicize activities of Al-Anon/Alateen groups and those A.A. activities with Al-Anon participation. Publicizing other organizations' activities creates an appearance of affiliation. (Service Manual, p. 124)

3. Q: Why do some people add "keep coming back" and pump hands after saying closing prayer? Is there a policy from WSO?

A: Chants are not part of Al-Anon and came into the program from treatment centers and other 12 Step programs. Newcomers can feel confused and left out of the closing process when members are chanting and pumping their arms. Some groups are choosing to close with the Al-Anon/Alateen Declaration which helps replace the chants. Members are reminded that our cofounder, Lois W., said, "It doesn't matter what [prayer] we close with, but we close with a spiritual moment." However there is no official WSO policy regarding chants. How groups close their meetings is the decision of an informed group conscience. The only reference to the closing at the end of a meeting in the Service Manual is the **Suggested Al-Anon/ Alateen Closing** p.22 "It is suggested that groups close in a manner that is agreeable to the group conscience."

4. Q: Can the Public Outreach share on a local radio station info about Al-Anon ?

A. Service Manual, p. 51 "Many groups participate in public outreach activities coordinated by their district, Area, and/or local Al-Anon Information Service (AIS). Local media outreach (TV, radio, print media, posters/ other printed materials, and the Internet) is handled by the district, Area, or AIS. Additional ideas for outreach projects are posted on the Members' Web site, under "Public Outreach," including service Guidelines and The Best of Public Outreach. (See also the "Public Outreach" section of the "Digest of Al-Anon and Alateen Policies" for information on outreach by individuals and groups; "Outreach to the Public" Guidelines, G-10). "When speaking or writing as an Al-Anon/Alateen member in any form of press, radio, films, TV, Internet, or other evolving public media, members use only their first names and last initial or pseudonyms. Members can also speak without identifying themselves or sign articles "Anonymous." (Service Manual, p. 91)

5. Q: Our group name is "1935". We registered this group in New York Office 25 years ago. We recently renewed the registration with the same name, "1935" 6 months ago. Is there a problem with our Al-Anon name being "1935"? A member in our group asked this question & referred to the Service Manual regarding group names.

A: The member was referring to the Service Manual, p. 35. "A group's name should not imply a affiliation with any other or-

ganization, including A.A. or any Twelve Step group, self-help group, commercial venture, agency, religious or rehabilitation facility, philosophy, religious principle or belief, or any outside literature or enterprise. "1935" was likely referring to the date A.A. began. However the World Service Office is the entity that approves a group's name, and they officially registered this group as "1935 GFA".

6. Q: My group's CMA doesn't share quarterly appeal letters and Forums with the group. Can I be the CMA since I am the GR?

A. CMA: Current Mailing Address; Service Manual, p. 34 "The CMA is a member who agrees to accept and deliver the group's mail (postal and electronic), anticipates keeping the same address for at least a year, and who attends the group's meeting regularly. The CMA may be, but does not have to be, the Group Representative (GR) or another group officer. "This could be a topic of your next group's business meeting.

Once/If the group votes on changing the CMA to the current GR, changing the CMA information can easily be done on the SCWS website, scws-al-anon.org, menu bar "Get Forms", then "Registration/Group Records Change- On-line".

7. Q: What is the best approach to asking someone who is texting throughout the entire meeting? (? To stop?)

A: This issue could be approached & discussed in your group's business meeting without referring to a specific member(s). You may want to start by asking questions to gather information. Such as, Is this happening with several members, and/ or with newcomers? Is it happening during most meetings? Is this a big distraction, or does it fall under "How important is it?" Some groups add a sentence in their weekly opening that addresses cell phone use, like "our group conscious requests that cell phones be turned off during the meeting to minimize distractions."

8. Q: What is thought around selling a cookbook by GRs at group meeting (CAL lit only). This is a fundraiser by Al-Anons for an AA convention. Cookbook recipes are to be donated by membership and outside fellowship & it is to be sold to all. Not just Al-Anon members. Is this outside contribution? Would this be able to be sold at work place?

A: Creating a "cookbook" to sell as a fundraiser could have several challenges. A SCWS Al-Anon member clarified that the So Cal AA Convention with Al-Anon participation is hosting fundraisers throughout the Area. This is the Al-Anon portion of the convention. The desert area has decided to do a cookbook. The recipes are ONLY coming from Al-Anon members. The quotes in the cookbook are coming from Conference Approved Literature (CAL) ONLY. The Delegate provided the quotes approved by the WSO for such use in 2017. The cookbooks will only be sold to Al-Anon members and not sold to the general public. "Fund-raising activities such as potluck suppers, dances, or other social events are conducted only within the fellowship and in agreement with the groups directly involved. (Service Manual p. 97)

And continuing in this section of the Service Manual, regarding

raffling at meetings "...to avoid commercialism in the fellowship, it is suggested that these items relate in some way to our spiritual principles. Note: The cookbook would not relate to our 'spiritual principles', though adding CAL quotes helps. The Guideline G-7 helps answer questions regarding Al-Anon participation in A.A. conventions, including financial commitments. "When A.A. invites Al-Anon to participate with its own program, A.A. provides Al-Anon with meeting space and a budgeted amount for specific expenses (speakers, publicity, volunteer sign-up, etc.). A.A. keeps all income from registrations. A.A. retains any excess income and is responsible for any losses that may occur. When A.A. offers to share a portion of any excess income with Al-Anon, it is within the Traditions for Al-Anon to accept the funds as long as it is in proportion to the Al-Anon participation."

9. Q: Is there a conference approved Al-Anon meeting signs for directions to meeting to place at meeting site?

A: No there are no Conference Approved meeting signs available from WSO. However this is a great idea & the suggestion could be sent to WSO. (Marcia M. has pdfs of Al-Anon meeting signs with the Al-Anon symbol. Email Marcia if you would like a copy sent. mountainpineslvr@cox.net)

10. Q: Always crosstalk from the same longtimers at our meeting. A longtimer is the secretary and does not say anything or ask that people raise their hand(s) to be called upon to speak. I make a voice of crosstalk going on and some of these longtimers give me mean looks and have even told me to shut up. What else can I say during this meeting and at the business meeting? This topic has been a topic several times at the business meeting.

A: Members have a variety of strong opinions regarding "crosstalk". Some groups use "crosstalk" as a meeting topic, reading the information presented in the December 2004 Forum, "Al-Anon BC—Before 'Crosstalk'" &/or the Sept. 2007 Forum "Crosstalk—or loving interchange?" Following open discussion and increased understanding/awareness, the group could make an 'informed group conscience' regarding "crosstalk". Sometimes groups add additional wording regarding "crosstalk", cell phone use, etc., to their opening. "At this point in the meeting, many groups have the Chairperson say if the group meeting has a special format (Step-study, speakers, or discussion group), has a specific routine for calling on members, asks members of other anonymous fellowships to remain anonymous and focus on the Al-Anon program, and clarifies if the meeting is open or closed. (Service Manual p. 11) There is suggested wording about "crosstalk" in Inside Al-Anon, December/January 1988-89, Vol 12, No.1. "The (Place Name of meeting here) meeting discourages cross talk: Talking out of turn; Advice giving; Questioning the person who is sharing; Holding private conversations; Having an individual comment on everyone's sharing; And being discourteous and intimidating. If you want to speak on what you hear, speak of your own recovery only, addressing a topic with "I" instead of "you"." However if a member is uncomfortable with the group's decision, they may choose to seek out another meeting.

11. Q: Unsolicited group text message concerned a group member & group emails- data for this person obtained from meeting phone list. What is SCWS response?

A. Some of these concerns could be addressed by reminding members about our anonymity. Service Manual, p. 23 "Members use their full names within the fellowship when they wish. The degree of anonymity a member chooses (first name, pseudonym, or full name) is not subject to criticism. Each member has the right to decide. Regardless of our personal choice, we guard the anonymity of everyone else in the fellowship, Al-Anon/Alateen and A.A., this means not revealing to anyone-even to relatives, friends, and other members—whom we see and what we hear at a meeting. Anonymity goes well beyond mere names. All of us need to feel secure in the knowledge that nothing seen or heard at a meeting will be revealed. We feel free to express ourselves among our fellow Al-Anons because we can be sure that what we say will be held in confidence." This concern could be brought up at the group's business meeting. An extra written note could be added to the phone list about "unsolicited group text messages". As well as directly speaking with the member who may not understand what the phone list is for.

12. Q: In keeping with the 7th Tradition, can individuals be self-supporting in providing their own drinking water and/or non-disposable water bottle? Rather than forcing people to haul heavy, expensive and trash-generating individual-portion bottled water? Is this something that should be decided by area group conscience? Can it be an area policy?

A: Districts and the Area provide water bottles as a kind courtesy. Hopefully Al-Anon members bringing in a case of water bottles will feel free to ask another member for help if they need assistance. Members are always free to bring their own bottles if they wish. The Church also has a cart that members can us to bring their case of water into the building. (Coming in thru the back close to the kitchen)

13. Q: I would like to know in what case one group of Al-Anon couldn't be in the list of *take out (?)* of Al-Anon?

A: Would the member who wrote this question please provide clarification for this question. If the member was referring to the information presented by the "Task Force for Resolving Group and Member Concerns", please see the SCWS website (scws-al-anon.org), under "Assembly and Committee Meeting Presentations". Scroll to the bottom of the page where the files from the "Task Force for Resolving Group and Member Concerns" are located. The files from the Nov. 19, 2016 Assembly include: "Final Southern California Policy for Resolving Group and Member Concerns"; "Final Presentation: Groups That Do Not Consider Al-Anon as a Whole"; "Final Evaluation Process Chart..."; "Possible Questions Regarding Southern California Policy...". They are in both English and Spanish.

14. Q: In the Nov '16 Area Assembly minutes Questions/ Comments, one section-Patricia D-72 asks about GRs being required. The answer is GRs are required for a meeting to register. In Ask it Basket Q & A's Q-10 asks what happens when group doesn't want to have GR? Answer is that groups don't have to have GR, which is in Service Manual, p.39. The answers seem to conflict.

A. There was a detail in the question that Patricia, D72 asked, contained in the minutes, that was left out of this AIB question.. The minutes in the Nov. Bulletin read: "What happens if a group decides that they don't want a GR? Can Al-Anons have a regular meeting with AA and call themselves an Al-Anon meeting?" The key words are "regular meeting with AA". Service Manual p. 31: "Joint meetings for Al-Anon and A.A. members, meetings comprised of only A.A. members, and groups that practice specific therapies, such as guided meditation, are not in keeping with Al-Anon group."

15. Q: Why can't a District's written minority opinion be attached to Assembly minutes?

A: The Assembly minutes contain information that was presented orally during the Assembly. This includes opinions questions and answers that are presented at the mic. Additional information, writing, etc., not presented at the mic during the Assembly would not be part of the minutes.

16. Q: Manual p. 187 "The right of decision should never be used as an excuse for failing to render....or for repeatedly failing to consult those who are entitled to be consulted before an important decision or action is taken." How do we register complaints about the rushed voting with voting on decision to delist meetings per task force recommendation?

A: Your question will be written in the Ask-it-Basket section of the Bulletin that all members have access to. It was recorded in the Minutes from the November 2016 Assembly that GRs were asked "if they were ready to vote". The question was not to vote on the policy, but whether they are ready to vote regarding the policy." (Please see Minutes in Nov. 2016 Bulletin) Out of the 177 GRs present, 64% believed that they were ready to vote, which required only a simple majority vote of 50% plus 1. Following that there was discussion at the mic from 21 SCWS members, including some members who expressed their desire to bring this topic back to their meeting prior to voting. Our Area Chair asked a second time if the Assembly wished to vote (again) about being ready to vote, and there was a very resounding "no" yelled out by many of the GRs. At that point a Motion was presented "that we approve the SCWS policy for resolving group and members concerns, effective immediately. The motion passed with GRs voting 146 "yes" (78%), with 125 "yes" votes to reach the 2/3 majority.

One of the dilemmas of Task Force presentations is that they need to be verbally presented to the whole Assembly at the same time. That way all GRs hear the same information directly from the Task Force members. They also were given time at the mic to ask questions and present opinions that all members present could hear. If the GRs voted that they were <u>not ready</u> to make a motion and take a vote, further discussion would have been tabled until the May Assembly. However there are always new GRs at each Assembly. These new GRs would not have heard the presentation and discussion. It is also unlikely that all new GRs attending the May Assembly would read the Minutes from the Nov. Assembly, so they would not be appropriately informed and ready to vote.

The GR's desire to bring information from the Assembly to their groups before participating in a vote is noted. That is why GRs are elected by a group they attend on a regular basis. There is the understanding that they are their group's "trusted servant" and represent their group's opinions as best they can. The GRs vote is based not only on what they believe their group would want, but also weighing & considering the new information that they are presented with at that time.

17. Q: Elections: "how are DRs (and former DRs) currently asked about their "willingness to serve?" Electronic means? How are former DRs contacted?

A: Current District Representatives are present at the Assembly and Area World Service Committee meetings where rotation of leadership and upcoming November elections are discussed. Stepping up to new Service Positions is encouraged throughout the SCWS meetings, as well as directly one-to-one. Former DRs should be aware of the process already and will remember that they too are eligible to submit resumes.

18. Q: How can the diversity of underrepresented populations be better reflected on the SCWS Board?

A: The SCWS Board 'diversity' depends on which members are willing to submit a resume and stand for the officer positions, as well as the coordinator positions. For the SCWS officers, this in turn depended on their willingness to stand and serve in a district as a District Representative. Unfortunately the general population in our Southern California area is more diverse than is represented in our Al-Anon meetings.

19. Q: Please produce a bookmark or statement as to why we discourage use of the term "qualifier" in our program when referring to people whose drinking brought us to Al-Anon.

A: The term "Qualifier" is not a word used in Conference Approved Literature (CAL). The term came from outside therapy/ treatment facilities and is used in those facilities to refer to the person who is the alcoholic in their life. In our Service Manual (pg. 124) there is reference to "Labels" Focus on the Al-Anon interpretation of our program is strengthened when we avoid using professional terms and labels since they may confuse members by implying affiliation with certain persons or specific therapies."

As we grow in Al-Anon we gradually learn to shift the focus off of the alcoholic in our life, and focus on ourselves. In the meantime a member might refer to the person as the alcoholic in my life, or that they came to Al-Anon because their (friend, wife, son, etc.) has a drinking problem. Some members have said that their husband/mother, etc., was the person 'motivating' them to come to Al-Anon. We cannot control what words other members use while sharing, however some may choose to change their vocabulary with education. The June 2014 Forum has further discussion in the "Talk to Each Other, Members respond" section, pg. 16-18. **20. Q:** A group rep. represents their home group at Assembly. They attend several meetings and serve as alternate GR for another meeting. According to the Service Manual each group gets one vote at Assembly. Does this GR get one clicker for each group they represent? (GR + AGR = 2 clickers)?

A: A member cannot be a Group Representative for one group and be an Alternate GR for another group because a Group Representative (GR) cannot represent two groups at the same time. Service Manual p. 141 "Each GR is chosen by members of the group and may serve as GR in no more than one group at a time." This means only one vote per GR, & only one clicker per GR. (please refer to Al-Anon Guidelines G-11 for Group Representatives)

21. Q: Why would the Area Chair chant "Principles above Personalities" at the mic when the Traditions are being read? I thought trying to educate members about chanting was a goal for SCWS?

A: This error was unintentional. Unfortunately, slipping into previous habits may occur even at Assembly. Yes, repeating phrases or "chanting" is not a part of the Al-Anon program. (Please refer to question 3 regarding "chanting".)

22. Q: Are groups still going to get the Forum every month?

A: The WSO discontinued sending complementary Forums monthly due to the expense and the fact that many Current Mailing Addresses (CMA) were incorrect so groups were not receiving their copies. Most groups decided to purchase their own copy or multiple copies. Newly registered groups still receive a complementary one year subscription. Note: WSO barely breaks even with the price of the Forum vs cost of printing/mailing.

23. Q: What is the Blue Bulletin's website address. Can we see it?

A. The Southern California World Service Bulletin can be found at: scws-al-anon.org, click on "Bulletins" in the left menu. The Bulletin is also available by regular mail subscription, with subscription form found on the Bulletin website page.

24. Q: Que puedo hacer si, se de un grupo quienen 20 anos solo a tenido una R. G.?

What can I do if I know about one group that has had only one GR in 20 years?

A. Lead a meeting on the "Three Obstacles to Success" and Rotation of Leadership. Discuss how members can support & encourage each other to step up to new/different service positions and have the current GR invite members interested in becoming a GR to the next District meeting. Southern California World Service rotates service positions every three years. Al-Anon Guidelines, G-11 "GRs are elected by the group, generally for a three-year term." Service Manual, p. 47 (GR)"Is elected for a three-year term." **R.** Tener una reunión sobre los "Tres Obstáculos al Éxito" y la Rotación del Servicio. Discutan cómo los miembros pueden apoyarse y alentarse mutuamente para avanzar hacia posiciones de servicio nuevas y/o diferentes y que el presente RG invite a los miembros interesados en proponerse para RG en la próxima reunión del Distrito. Southern California World Service rota los puestos de servicio cada tres años. Guías a seguir de Al-Anon, G-11 "Los RG son elegidos por el grupo, generalmente por un término de tres años". Manual de Servicio, pág. 47 (RG) "Se elige por un período de tres años."

25. Q: Que puedo hacer si, asisto a una junta de Al-Anon que tiene literature de A.A.?

What can I do if I attend an AFG meeting that uses AA literature?

A: Although Al-Anon's roots are based in A.A., the A.A. "big book" is not and never has been Al-Anon Conference Approved Literature (CAL). In the very early days of Al-Anon, A.A. materials were used at meetings because we had very little material of our own. When our cofounder Lois W. wrote The Al-Anon Family Groups (B-5) in 1955 with the help of other pioneers and the support of her husband Bill, she intended it as our big book. Bill had not allowed her to write any part of the A.A. big book—even the chapters to the wife or the family—because his book was from the perspective and experience of alcoholics.

"Conference Approved Literature" came about from discussions held at Al-Anon's very first World Service Conference in 1961. The first few Conferences developed a process to give conceptual approval for the development of Al-Anon literature, and it was the will of the Conference to recommend exclusive use of CAL in Al-Anon meetings. Although the Conference grandfathered-in several existing Al-Anon pieces, in keeping with Traditions One, Three, Five, and Six, the A.A. big book was not among them.

The exclusive use of CAL in Al-Anon meetings supports Al-Anon's First Tradition: that personal progress for the greatest number depends upon unity. Al-Anon's Third Tradition states that as a group we have no other affiliation. According to our Fifth Tradition, our one purpose is to help families of alcoholics. Our Sixth Tradition states we are a separate entity that should always cooperate with A.A. Service Manual, pg. 104: "To keep Al-Anon's message in focus and encourage unity, only Al-Anon/Alateen Conference Approved Literature (CAL) and Al-Anon/Alateen service tools are displayed, distributed, and used at Al-Anon and Alateen meetings, including meetings at conferences and conventions. These items reflect the informed group conscience of the Al-Anon Family Groups as expressed by its World Service Conference since 1961..... A.A. literature is not used at Al-Anon meetings because it is written for and from the viewpoint of alcoholics and is not Al-Anon/Alateen Conference Approved Literature. Reliance on opinions expressed in A.A. and other outside materials can distort the Al-Anon approach." This group may not have been thinking of the second half of Tradition Four when they voted to use A.A. literature. Tradition Four grants auto-

nomy to groups "except in matters affecting another group or Al-Anon or AA as a whole." (Service Manual, pg.15)

R: Aunque las raíces de Al-Anon están basadas en A.A., el "Libro grande" de A.A. no es y nunca ha sido Literatura Aprobada por la Conferencia (LAC) de Al-Anon. En los primeros días de Al-Anon, los materiales de A.A. se usaban en las reuniones porque teníamos muy poco material propio. En 1955 Cuando nuestra cofundadora Lois W. escribió el libro "Grupos de Familia Ala-Anon(B-5) con la ayuda de otros pioneros y el apoyo de su esposo Bill, intento que este fuera nuestro "Libro Grande". Bill no le había permitido reproducir ninguna parte del libro grande de A.A. Un gran libro. Ni tan siquiera los capítulos de la esposa o la familia porque su libro fue escrito desde la perspectiva y la experiencia de los alcohólicos.

La "Literatura Aprobada por la Conferencia" surgió en las discusiones celebradas en la Primera Conferencia de Servicio Mundial de Al-Anon en 1961. De las primeras pocas Conferencias se desarrolló un proceso para dar aprobación conceptual de la literatura de Al-Anon y fue la voluntad de la Conferencia el recomendar el uso exclusivo de LAC en las reuniones de Al-Anon. Y aunque la Conferencia se apoyó en varias piezas existentes de Al-Anon, de acuerdo con las Tradiciones Uno, Tres, Cinco y Seis, el libro grande de A.A. no estaba entre ellas.

El uso exclusivo de LAC en las reuniones de Al-Anon apoya la Primera Tradición de Al Anon: El progreso personal para el mayor número depende de la unión. La Tercera Tradición de Al Anon afirma que como grupo no tenemos ninguna otra afiliación. Según nuestra Quinta Tradición, nuestro único propósito es ayudar a los familiares de los alcohólicos

Nuestra sexta tradición afirma que somos una entidad separada que siempre debe cooperar con A.A. Nuestro Manual de servicio en la página 106 dice: "Para mantener el enfoque del mensaje de Al-Anon y estimular la unidad, únicamente se exhiben, distribuyen o utilizan las publicaciones de la Literatura Aprobada por la Conferencia (LAC) y los instrumentos de servicio de Al-Anon y Alateen en las reuniones, incluidas las reuniones que se realizan en conferencias y congresos de Al-Anon y Alateen".

Estos elementos reflejan la conciencia de grupo informada de los GFA de la manera en que fue expresada por su Conferencia Mundial de Servicio de 1961... La literatura de AA no se utiliza en las reuniones de Al-Anon porque está escrita para y desde el punto de vista de los alcohólicos y no es literatura aprobada por la Conferencia de Al-Anon/Alateen.

El depender de las opiniones expresadas en A.A. y de otros materiales externos pueden distorsionar el enfoque de Al-Anon. "Este grupo que se menciona probablemente no pensó en la segunda mitad de la Cuarta Tradición cuando votaron para usar literatura de AA. La Cuarta Tradición otorga autonomía a <u>grupos "excepto en asuntos que afectan a otros grupos o</u> <u>Al-Anon y Alateen o AA en su totalidad"</u>. (Manual de Servicio, pág.17)

26. Q: Como se puede habla con una persona que abre un grupo de Al-Anon en un local de Gobierno y el Pago del local es

comprar el pan para todo el edificio y es un miembro antiguo. Que sabe de tradiciones!

What can I tell a person that opened an Al-Anon Family Group meeting in a Government building and the rent payment is to buy bread for the whole personnel of the building. This person is an old member that knows about our Traditions.

A: Al-Anon groups typically pay rent for a meeting place. "... according to the Seventh Tradition, Al-Anon/Alateen groups ought to be fully self-supporting through members' voluntary contributions. The basket is passed to cover group expenses, including rent, purchase of literature, and support of trusted servants and Al-Anon's service arms." (Service Manual, p. 9) And "Our Tradition of self-support suggests that the expenses for the group's operation such as rent, literature, insurance, supplies, post office box rental, Group Representative, and Information Service Representative expenses be met first. Remaining funds may be used to support local and Area structures and the World Service Office. At locations where rent may not be accepted, a supply of Al-Anon/ Alateen Conference Approved Literature and local meeting schedules may be provided to the facility as an appropriate alternative." (Service Manual, p. 99)The specific amount for rent is usually agreed upon by both the meeting location and the group. Where meeting locations do not ask for/require "rent", groups often donate CAL literature in its place. After the rent payment is given to the location, what they do with this rent would be their decision.

R. Los grupos de Al-Anon suelen pagar renta por un lugar para su reunión.

"De acuerdo con nuestra Séptima Tradición, los grupos de Al-Anon y Alateen han de ser económicamente autosuficientes por medio de nuestras propias contribuciones voluntarias. Pasamos la cesta para cubrir los gastos del grupo tales como: compra de literatura y apoyo a nuestros fieles servidores y a las ramas de servicio de Al-Anon. (Manual de Servicio pg. 21)

Nuestra Tradición de ser económicamente autosuficientes sugiere que los gastos de funcionamiento de los grupos tales como el alquiler, las publicaciones, el seguro, los suministros, el alquiler de un apartado de correos, los gastos del Representante de Grupo y el Representante de los Servicios de Información tienen prioridad. Los fondos restantes pueden utilizarse para ayudar a las estructuras locales y de Zona y a la Oficina de Servicio Mundial. En los lugares donde no se acepte el pago de alquiler por el local, se podrá ofrecer un surtido de publicaciones de la Literatura Aprobada por la Conferencia de Al[®]Anon y Alateen y la lista de las reuniones locales como alternativa (Manual de Servicio pg. 101).

El monto específico para el alquiler es generalmente acordado tanto por el lugar de la reunión como por el grupo. Cuando los lugares de reunión no piden / requieren "pago de renta", los grupos suelen donar literatura aprobada por la Conferencia en su lugar. Después de que el pago del alquiler se da al arrendador, lo que haga con este pago es su propia decisión.

27. Q: None of the AIS Liaisons were present at the Assembly. Why? Who on the Board is responsible to be the link to those Liaisons? Area Chair? Delegate? Alternate Delegate?

A: There were 3 AIS Liaisons at the Assembly: Inland Empire, Orange County, and Los Angelus. The Area Chair sends an email reminder sent to the AIS Liaisons before upcoming Assemblies and Area World Service Committee meetings.

28. Q-a: The process of today's agenda is very excruciating. I don't think we needed several tutorials on the clickers. We wasted so much valuable time. Why does the Delegate have a 50+ page presentation? I do not have enough recovery for this.

Q-b: The clicker training took way too long. Can there be a faster way, less time consuming, less repetitions?

A: A more efficient way to assist new GRs with Clicker training is being discussed and will be implemented at the next Assembly. "See also the answer to Q-29 below."

29. Q: Can presentation be put on the website sooner? Why can't the Delegate's report be shortened? Can the Delegate's report be put on the website and that's all we need to hear it? We hear it over and over.

A: Our World Service Delegate "is the primary communication link between the groups and the World Service Office." (Service Manual p. 72.) The Delegate is our elected trusted servant. Many areas allow a full day for presenting the Delegate's report. "The Area World Service Committee may also schedule interim Assemblies, which are called by the Chairman at such other times as it is deemed necessary. One such Assembly could be held to hear the Delegate's post-Conference report." (Service Manual pg. 149) "The Delegate gives his Conference report to the Area World Service Committee and GRs to carry back to their groups." (Service Manual, p. 161) The Delegate "brings the views and the spirit of worldwide Al-Anon back to his Area." (Service Manual p. 134).

Our Delegate condenses her presentation at the Assembly from her notes taken from 5 days of World Service Conference (WSC), at 12 hours per day. There is not sufficient time between the April WSC and May Assembly to prepare the Delegate's report and place it on the SCWS website before the Assembly. The Delegate's report is not brief because Members expect to hear about the annual budget and annual audit information, as well as information about the Task Forces, Thought Forces, discussions and votes at the World Service Conference. The information brought from the WSC may appear to repeat "over and over", however it is new/updated each year. In addition, one-third of the GRs are new every year and have not heard the previous Delegate presentations.

30. Q: I think there is more that we can do to make the Area Assemblies more comfortable, more enjoyable, more engaging & less triggering. Who would I share this request with? Many new GRs aren't inspired to do more service because of this. If we could remove some of the unnecessary sections or stick to highlights this might help. But even more, is the need for fellowship for lunch and a comfortable place to do it. I believe funds should be allocated for attending members to have a catered but simple lunch provided. Perhaps a space that also has a large lunch area (maybe a hotel conference space?)

There is way too much attempt to control & manage the voting, and that is time consuming and sometimes frustrating. On the whole, I would love to see business meeting sections kept concise, and other sections (like the breakout group sessions) done away with or replaced with an Al-Anon meeting time. I believe this would inspire more GRs & DRs to take their service up to the next level, instead of fizzing out. Many GRs traveled very far to be here, providing breakfast & lunch should take care of them, perhaps we can find funds for it since our Region is very abundant!

A: Your suggestions/requests will be shared with the current SCWS Board members and passed on to the next Board. The Assembly venue at Glendale was chosen because of location, availability and cost. Another central location could be investigated for the 2018-2020 SCWS Assembly & Area World Service Committee meetings. In the Service Manual on p. 65 it states, "The Area Assembly is the business meeting where the groups send their representatives to express a voice and vote on behalf of the group. During an Assembly, the Delegate reports the activities of the World Service Conference. An Assembly can meet at least one or two times a year, or a minimum of once every three years. Many meet more often." The Assembly is "A meeting of the Group Representatives (GRs) for the purpose of electing a Delegate to the annual World Service Conference, an Alternate Delegate, and Assembly officers. The Assembly also meets between elections to receive and distribute reports on Area and world service affairs. It reviews and approves interim reports of the Area World Service Committee." (Service Manual, p. 132) SCWS area has only 2 Assemblies per year, with the average amount of Assembly days in other Areas being 3 or more days each year. There is a lot of information that needs to be disseminated, and a lot of business to be conducted during our short time together, making it difficult to have extra time for more socializing. Other areas that have speakers, breakout group sessions, regular Al-Anon meetings (etc.) are Areas that hold 2- or 3- day Assemblies. The topic of extending the Assembly or adding another day has been voted down each time it has come to the floor for a vote.

31. Q: We can't vote on minutes if we don't have a copy of the minutes. Same with the budget.

A: The Minutes from the Nov. Assembly are contained in the Nov. Bulletin, which was published and posted on the SCWS website months ago. DRs and GRs are encouraged to read the Bulletin online, or purchase their own copy. There were copies of the Nov. Minutes available at the May Assembly. There were also copies of the Budget and financial information. It is difficult to predict how many copies will be needed at the Assembly. In an effort to conserve on printing costs there may not always be enough copies available. We will remind members to pick up their copies at a specified location, and encourage members to share copies when needed. Perhaps DRs could remind GRs to read the May Assembly minutes prior to the November Assembly and vise-versa, and to bring a copy of the minutes with them.

32. Q: I was under the belief that the 2/3rds vote was derived by counting the abstentions as well as the "yes" + "nos". This is not the case?

A: Abstentions are not counted in the total vote because they are not considered a "vote". Collins English Dictionary defines abstention as "a formal act of not voting either for or against a proposal". Merriam-Webster's dictionary's definition: "a formal refusal to vote on something". Dictionary.com: "withholding of a vote". Cambridge English Dictionary "the fact of not voting in favor of or against someone or something." We can only count those who have actually expressed a vote. The World Service Conference also does not count the abstentions, which is specifically listed in the Conference Procedures Manual. (Please contact the Delegate if you wish to view this manual.)

33. Q-a: Will there be a SCAC 2017? If no, why not?

Q-b: The Delegate is not a person who makes decisions for Alateen. Why is the Delegate preventing approval for SCAC 2017?

Q-c: Why are we getting in the way of program by not allowing our Alateens to be self supporting by not allowing them to raise monies for SCAC General Fund?

A. SCAC is still under suspension. The Alateen Resolution Committee has been meeting on a weekly basis (plus sometimes twice a week), The seriousness of the safety issues that have occurred at previous SCACs made it crucial for this committee to write a safety procedures document that is thorough and well thought through. This is necessary for the protection of our Alateens, as well as the AMIASs that lovingly donate their time to SCAC. SCAC, and all SCAC-related activities (such as fund raising) will remain suspended until the SCAC Procedural Document is completed and approved. First and foremost we need and want our Alateens to be safe. Please Note: The votes on this committee of 6 members require a 2/3 vote to pass. It is not possible for one single member of this committee to prevent approval. The document has not been approved because the committee is still discussing many remaining questions.

#4 FAQs

There are still many members who don't know what the *Cur*rent Mailing Address is. This is a person who is willing to receive the postal and electronic communications for the group—and who can be relied on to take that information to the group. In order to be considered Active (and have prospective newcomers directed to the group by the WSO via their call center), a group must have an active CMA. In groups with a GR, the GR is often also the CMA.

Groups do *not* have to have a GR in order to remain *Active*, only a CMA. So it is crucial that every group that is actively meeting have a CMA with an up-to-date postal and email address.

In some cases, the group itself is the CMA. The group might provide a post office box; members rotate the responsibility to deliver the mail to the group. In some instances, the group might receive mail at the meeting's facility. This must be arranged with the facility prior to making this change in the group's records.

<u>Cooperating with the Professional</u> <u>Community (CPC)</u>

I am busy getting up to speed with the work this panel has done and together, with Public Information and Institutions, I will carry the message to Professionals and others as "we strive for name recognition and credibility as a community resource." (Guidelines G29)

I participated in the Al-Anon Panel at the 36th Annual H & I AA Conference with Al-Anon Participation on April 7, 8, 9 2017. I was able to find, and hopefully add to, the enthusiasm which I believe is the starting place in Public Outreach.

Some of the points discussed:

- 2015 WSO Membership Survey: professional referrals accounted for ½ newcomers; 40% referred because of drugs. Of them, 85% stayed as they were affected by alcoholism.
- Nielsen Ratings: our PSAs in top 1-2% in quality; possible 500 million in viewing audience
- \cdot WSO estimates 1/3 of viewers affected by alcoholism
- Obstacles to Public Outreach in our Area: So Cal Area 56,000 square miles, Al-Anon name recognition lags behind AA; working in isolation; Area needs such as infrastructure, education and budget; turnover in service positions; AIS waiting lists for panels requested.
- Solutions for Growth in Public Outreach in our Area: availability and visibility of outreach materials; communicating what works and doesn't with local level; need for Public Outreach workshops for members; use of technology such as conference calling to discuss successes/needs of local outreach.

On 5/2/17 Email sent to DRs: Highlighted outreach materials Facts for Professionals and Judicial System as free downloads; details about the AFAs from WSO, 2018 order form due by July for September shipping, Public Outreach podcast; encouraged discussion on outreach and offered my services

BANKING---District 60 has found a way to solve a problem that has confronted many meetings and Districts---setting up a bank account despite new banking regulations that make it hard for non-profits without formal structures and property to do so.

We have set up a business savings account that enables us to separate District funds from those in our treasurer's personal account. The account makes funds accessible to two other trusted servants in the event that the treasurer is out-of-town, ill or incapacitated. Funds are withdrawn and deposited in the treasurer's personal account when checks need to be written. We have online access to account activity.

Setting up of the account resulted when we took a look at the need to set up procedures that can be followed term to term, instead of having new DRs and other District leaders start from square one when they begin their terms. We added the position of budget and banking assistant, which is filled by Barbara S-P., who laid the groundwork for opening the account. She also is using her banking and bookkeeping experience to help us set up a first-time budget.

Here are the steps involved in setting up the account:

- 1. Barbara began by talking to the manager of the bank branch at which our AIS (Intergroup) keeps its account, knowing that the manager would have an understanding of what Al-Anon is and how it operates.
- 2. We learned that a business savings account was the best option available to us.
- We obtained the EIN (Employer Identification Number) needed to set up an account. CAUTION: Be certain to go to the <u>government-run Web site for EINs</u>, not to Web sites of businesses that will charge you to fill in and submit the form you can do yourself.

- 4. We met with a bank representative to see what next steps the branch required.
- 5. We created a letter informing the bank branch that the District wanted to set up an account. The letter named the persons who would have deposit and withdrawal privileges.
- 6. Members who were to have access to the account filled out personal information forms and, as a group, met with the bank branch representative.

PROCEDURES---We do not have bylaws---(yet)---but we are beginning to document in minutes our procedures and processes. Nothing other than minutes individual GRs/AGRs keep themselves has been handed down when leadership teams have changed. The need for continuity and procedures became clear when we found that all members did not understand the need to get approval for actions and expenses that might result from their assignments. We are discussing the best way to pass the benefits of our experience to future leadership teams: documents in a notebook?, documents on our Web site?, a thumbdrive?. or documents in the cloud?.

GETTING INFORMED---We are learning together through 15minute study sessions on the Service Manual at each meeting. Our new ADR, Belinda H., and our treasurer, Andy S., have charge of this study.

EDUCATION---For the seventh consecutive year, we presented a spring workshop designed to enhance and expand members' understanding of the Al-Anon program. (We were mindful of the finding by a Thought Force on "Groups That Do Not Consider Al-Anon as a Whole" that most group problems stem from a need for education.). Steve. F. chaired the event that focused on "How Al-Anon Works in All Our Affairs." A skit by District 60 players illustrated the theme, which also was covered by speakers and literature study topics at each table.



DELEGATE'S JOB DESCRIPTION

Introduction: The elected officers of Southern California World Service, Inc., are the board members of SCWS, Inc., a legal 501(c) (3) Not-For-Profit Corporation. The officers act in accordance with the spiritual principles of Al-Anon Family Groups while conducting the prudent management of the Area. The officers accept additional demands on their time and possess some special skills relevant to their position. Members of Al-Anon in SCWS who also are members of A.A. are ineligible to hold any office beyond the group level.

1. <u>ELIGIBILITY / QUALIFICATIONS</u> – Has served as a District Representative. Has thorough knowledge of and experience using Twelve Traditions, Twelve Concepts and current *Service Manual*. Is accessible, available, responsive, and flexible. Is able to communicate effectively, prepare written documents and meet deadlines. Does not hold concurrently any other position in Al-Anon service.

2. <u>OFFICIAL DUTIES / RESPONSIBILITIES</u> – Attends all SCWS Area Assembly and Committee meetings, and board and officer meetings, as called by Area Chairperson. As a member of the World Service Conference (WSC), represents Al-Anon as a whole, brings the Area's viewpoint, and communicates to the Area the broader perspective, views and spirit of Al-Anon world-wide. Fully participates in all sessions of the annual WSC, including serving on select WSC committees, Thought Forces (ThF) and/or Task Forces (TF), and in Regional Trustee selection process. Is able to understand, question and learn facts and figures from financial and other reports, and gains vision of great movement in action. Serves as the channel through which information flows and as the bridge of understanding that links groups in the Area with world Al-Anon. Gives Conference report to the Area, explaining financial and other reports, and Conference decisions. Is the liaison between the Area and the World Service Office, sometimes providing Area DR and GR opinions on urgent matters. Should have strong working relationship with and support other officers and DRs, and collaborate with them to resolve conflicts within the Area. Is part of Alateen Task Force. Serves on any Area ThF or TF as requested by Area Chairman. Each year attends Southwest Regional Delegates' Meeting (SWRDM) and the Area Sharing of Service (SOS) workshop, and supports Area activities and events. Attends International Convention of Al-Anon or of AA, whichever occurs during the Delegate's term. See p. 72, 134, 160-161 of 2014-2017 *Service Manual* for other details.

3. **BASIC SKILLS / PERSONAL QUALITIES / EXPERIENCE NEEDED** – Effective written, oral and electronic communication skills, time management, strong organizational skills. Proficient in using spreadsheet, word processing, and presentation software, accessing and navigating Web sites, downloading web documents, and using email with attachments. Strong sense of responsibility, able to prioritize, meet deadlines while managing high priority tasks and work independently or as a team member. Able to allot appropriate time to position and all it entails, including assignments from Area, WSC and the WSO. Has thorough working knowledge of KBDM (Knowledge-Based Decision Making). Able to separate opinion from fact and to support and effectively communicate Area and WSC decisions and their implementation objectively, even if not in personal agreement with the group conscience. 
