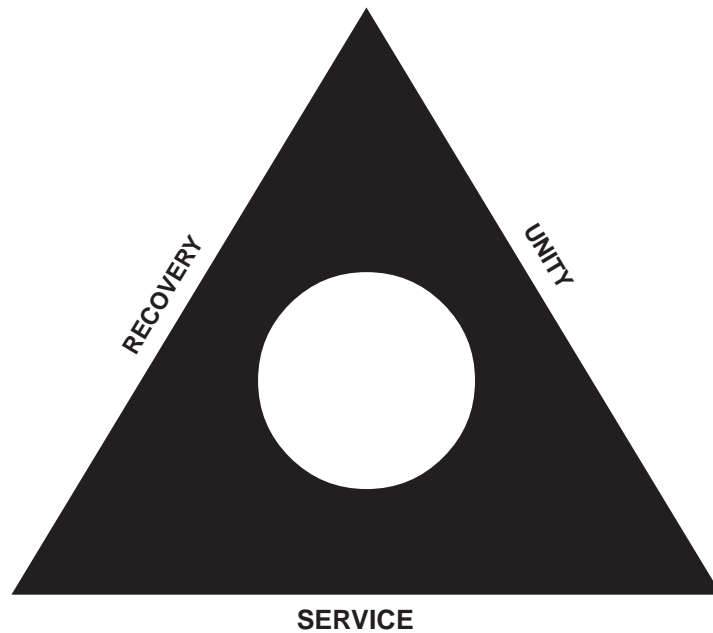

Officers' Reports

Delegate

Greetings Southern California Al-Anons and Alateens.

I have several things to report to you from Al-Anon World Services and several requests for information and assistance that I'd like from you. As Concept 1 explains, "The Ultimate responsibility and authority for Al-Anon world services belongs to the Al-Anon groups." Thank YOU to each of you GRs who are representing your group. You are the vital link of information between your group's members and Al-Anon World Services (WSO).

The tables at the Assembly are decorated with some stylish shoes. These are to help us remember that **we have to fill the shoes of our Al-Anon pioneers** and take the steps necessary to help the Al-Anon fellowship to continue, **including our 12th Step** " . . . to carry the message to others . . ."

The WSO has asked our Area to **participate in a special project to translate some of the guidelines into Spanish**. I have asked Lucia and Miguel to be part of the committee and am looking for perhaps 2 more members who can translate the Al-Anon ideas in our guidelines, from English into Spanish. This is no easy task and WSO has given us a very short timeline. An exciting aspect of this project is that we will be working with the Area of Puerto Rico. They will translate 4 and we will translate 4 and then share our work with each other to come up with a final product by Jan 15. The guidelines will include a note that the translation was done by volunteers from Southern California and Puerto Rico. This is an exciting opportunity for us to build some friendships with Al-Anons and Alateens in Puerto Rico and learn and share from each other. Let me know if you feel that you have the skills to help with this project.

Surveys were randomly sent out from WSO to 3 % of English speaking groups, 10% of Alateen groups, and 10 % of Spanish and French speaking groups. I heard from Christine in Malibu that their group received surveys. **Did anyone else get a survey from WSO?**

The next time we meet will be in May, right after the annual World Service Conference (WSC) in Virginia Beach. As your Delegate, I attend WSC, representing you. Now is the time that I need the questions you'd like to be discussed at the WSC. Al-Anon is you, the groups. So **if there are things you'd like discussed at WSC, I need your questions by New Year's Day**. One of the concerns I'm considering submitting is how to better represent the interest of Alateen on the Board of Trustees. At the WSC, each Delegate is assigned to a Committee and I'm on the Committee that reviews the resumes of Trustees. I noticed that 2/3 of the resumes never mentioned Alateen.

The **WSO wants feedback about the annual Service Plans** they prepared for us and whether to continue them. This year's plan is the District Game Plan and had a map showing places for public outreach, churches, treatment centers, schools, police, children in our own homes. Send a note to the WSO if you found it helpful and if you want an annual Service Plan to continue to be prepared.

As our Concepts explain, Trustees have the primary administrative responsibility for World Services. Our Trustees are also volunteers. Resumes are accepted annually by August 15 for Trustee-at-large. Next year we'll vote here on a nominee for our Region's Trustee. If you've got questions, as we say, **"the answer is in the book."** **The Service Manual explains a lot about our service** structure and you can also ask question of me and others and we can find the answers together.

The expense of the annual World Service Conference (WSC) is equally divided between the areas. There are 67 Areas, therefore 67 Delegates - about one from each state and from each providence in Canada, but some big states like CA are divided into 2 Areas, hence, our Area is: Southern CA World Service (SCWS). We are fortunate to have more members and more money than many areas so we have traditionally paid the full expense, not just the equalized expense and we will ask you to vote on that today (to send \$1,556, not just \$1,000.) I also want to make a correction to your copy of the budget (in the last Bulletin) which show \$700 for Delegate expense for next year. Several years ago our Area voted to put \$500 extra in our budget for our Delegate's expenses. We're all new (did you realize that B this is only our second assembly as your new officers B we were elected here last year in Nov). Some of my expenses that were not related to the Conference got included in the Treasurer's account column for the Delegate's Conference budget and therefore Tom thought we needed more money for that line item for next year, but we don't. The \$500 is more than enough.

Mark your calendars for July 4-6, 2008, when the fourth annual Al-Anon International Convention will be in Pittsburgh, PA. Before then we have lots more area event coming up in 2004. We have a flyer today that you can take back to your groups. SOS in January, PRAASA in March in Irvine, and Institutions Conference in April in Irvine. These are all Al-Anon service events. We encourage you to **get some friends together to attend the events on the flyer, have fun and learn ways to fill the pioneer's shoes and work your 12th Step through service**.

We've been talking about Alateen safety and have formed a committee that hopes to propose some guidelines for you to consider next year. The WSC, our Board of Trustees and your DRs have been **discussing Alateen safety** and a question came from our Area in August regarding our legal liability. I wrote to the WSO and want to share the response I received:

When the Alateen name is used (meetings, events), liability attaches to Al-Anon. If we fail to acknowledge our responsibility to provide control and oversight, we may increase the possibility of a child being harmed and also strengthen the basis of a lawsuit against Al-Anon (including against our Area or Intergroup).

This poses many things to consider. One is our 1st Step, we know that we don't have control over things outside ourselves, but yet, most likely as adults we all acknowledge our responsibility for the safety of children. We also know that we don't want outside influences (lawsuits) to divert us from our primary spiritual aim (Tradition 10). Issues like these are part of what I love about Al-Anon service. I get to continue to grow and learn to use these principles in all my affairs (Step 12). Together, talking thing over and reasoning things out, we each grow personally, as well as Al-Anon/Alateen growing together as a whole. And just like our pioneers, we get to take steps to work through the issues and continue to carry the message of hope to the families and friends of alcoholics. And we grow B and we have fun too!

There is a LOT of information on Alateen safety included in my report that is in the Bulletin you received in October. Some of you will get to discuss more this afternoon in the ACTION Committee that includes Alateen, which is called the "Group Services ACTION Committee."

The theme for next year's WSC is "Dynamic Groups Today: Building Block for Tomorrow." This year we are still working under the theme "Change! Create new possibilities." I love change and I'm grateful to be a part of the changes we are making here for our Assemblies. I hope you enjoy today's special guests and our ACTION Committees this afternoon.

I've heard that **service is gratitude in action**. By coming together as an Assembly we hope to share with you some ways that you can be of service, and information that you can share with the members of your groups so that they are aware of more ways to serve too. Our pioneers did a great job of getting Al-Anon and Alateen going. Now its up to us to fill their shoes and share our program with others.

Minutes So. California World Service Assembly Meeting November 15, 2003

Twelve Traditions were read by Chuck, District 27.

Chairperson Kary L. called meeting to order with the Serenity Prayer at 10:00 A.M. followed by introduction of our World Service Office guests: Mary Lou M., Associate Director of Public Outreach-Media and Lynda Earls, Trustee-at-Large. A special greeting was extended to our guests from Ensenada, Baja, California, all new Group Representatives, and Past Delegates. Kary reviewed who has Voice and Vote.

Minutes Secretary, Shirley M., in order to allow more time for WSO guests' presentation, moved that minutes not be read, but be approved as printed in the August 2003 bulletin. Ora, District 12 seconded the motion. Motion passed by majority show of hands.

Alternate Delegate Sue P. announced Ask It Basket and Forum Can. Those answering Ask It Basket questions were asked to write down page and section from the Service Manual referencing their answer. She had past Conference Summaries available as another Ask It Basket resource. Forum subscriptions will be drawn at the end of the day. To participate, put a quarter in the can and write name, address, and telephone number on a slip of paper inside the can.

Sue announced upcoming SOS on January 17th. Thanked Lydia for the program, Roxanne for the flyers, Andee for taking charge of SOS potluck, and Maria P. for registration. Everyone was encouraged to see Maria in the back to register early and avoid the crunch. To enjoy the fun and fellowship of working in the kitchen, call Andee 323-664-9285.

Reminder: All new District Reps are invited to an Orientation at 9:00 A.M. one hour before the February 21st Committee Meeting. Intergroup Liaisons and Convention Reps are welcome, also.

Treasurer Tom E. announced two upcoming votes: the budget (referred GRs to pp. 35 in the bulletin) and a proposal to move \$25,000 reserve dollars from CDs to Treasury Bills due to low CD interest rates. The past treasurer is still receiving half of So. Ca. World Service donations. Her post office box will be closed December 31st with no forwarding address. GRs were asked to pick up correct donation form and deliver to their meeting treasurers. (For correct Address, see back of bulletin also.)

Delegate Miriam M. directed attention to the tiny shoes on each table - a reminder that the ultimate responsibility for Al-Anon lies with the groups and it is our job to fill the shoes of our pioneers. Al-Anon's fourth annual international convention will be held July 4-6, 2008 in Pittsburgh, PA. The theme is "Dynamic Groups: Building Blocks for Tomorrow". Our Area's Spanish meetings will be working with Puerto Rico's Al-Anons and World Service to help translate guidelines. Miriam asked for a show of hands of those groups who received Al-Anon's latest survey which is due in this month. Miriam needs any questions for April World Service Conference by December 31. WSO wants to know how many groups used the plan and if groups would like them to do one next year. Miriam reviewed process which led to the selection of Southern California's Outreach proposal being accepted and turned the meeting over to Lee T., CPC Coordinator.

CPC Coordinator Leo T. thanked volunteers for passing out materials; his committee Kay D. Chairman, Lil S., Public Information, and Denise L., Institutions; and Kary and Miriam for their support. Went over what the Group Representatives and District Representatives received. Reminded everyone that service is gratitude in action. Reviewed project which is an outreach to spiritual leaders in our area. In the past counselors, therapists, and treatment centers have been targeted. It is hoped that targeting spiritual leaders will reach more members of Southern California's diverse population.

Approaches:

- Individual members give information to someone they know
- Groups, Districts, Intergroups can use funds to purchase packets for distribution/mailling
- Articles submitted to Religious Newsletters/Publications
- Booths or Speakers at Religious Conventions/Gatherings
- Insert information with monthly rent check to facility

We are committed to submitting a project evaluation to WSO. Groups are asked to return Project Evaluation which is last sheet in Project Packet to Lee. Contact Lee if you have any questions or need additional materials.

Mary Lou M. and Lynda E. each shared her Al-Anon story and gave a presentation entitled "WSO's Resources". Each person present received a pocket portfolio with presentation information and each District Representative received a PSA (Public Service Announcement) video. Mary Lou asked what resource the groups felt was the most useful. The number one response was the Group Inventory.

Break 15-minutes: A Sack Lunch Fundraiser was served by SCAC Committee for a working lunch time.

Action Committees met until 2:00 P.M.

Chairperson Kari L. reconvened the General Assembly at 2:15 P.M. after a fifteen minute break.

Concepts were read by Martha, Hospitality Coordinator, and **7th Tradition** collection was taken.

Past Delegate Kay D., reminded everyone that members will stay on assigned Action Committee until 2005 to provide continuity and consistency to committees. Asked everyone to note summary from August 2003 Area Committee Meeting Action Committees and to fill out colored evaluation form and return to Shirley M., Minutes Secretary. Thanked District 12 for asking her to share about the "Trial Restructure in Southern California World Service".

Delegate Miriam M. shared that the September Issue of the Forum can be purchased 3/\$1 or 5/\$15 to be used in Outreach effort. Reported that in reviewing resumes for the Trustee Committee, she noted that two-thirds of candidates did not mention Alateen. She plans to bring this to WSO's attention.

New Business:

1. Hospitality Coordinator Martha M., thanked kitchen helpers.

Requested Districts 3, 6, 12, 40, 42, 48, 51, 60, 75, and 78 bring refreshments for Feb. 21 Committee Meeting.

2. Treasurer Tom E. presided. Jim, Dist. 72, moved the budget for 2003-2004 be approved as presented. Joyce, Dist. 75 seconded motion. **Motion carried with 185 yes, 3 no, and 1 abstention.**

3. Treasurer Tom E. presented proposal to transfer \$25,000 reserve money from CDs to Treasury Bills. Chuck, Dist. 27 moved that the treasurer move \$25,000 from CDs to Treasury Bills. Hester B., Dist. 17 seconded Motion.

Motion failed with 135 no, 46 yes, and 8 abstentions.

4. **Delegate's Equalized Expense for World Service Conference.** Billie Kai, Dist. 75, moved that So. Ca. World Service be given ongoing authorization to pay the Delegate's expenses to the WSO conference based on the WSO's yearly recommendation. Sandra, Dist. 27 seconded motion. **Motion passed with 141 yes, 27 no and 14 abstentions**

5. **Records Secretary Marie L.** presented a proposal to eliminate the Southern California ID number and use the WSO ID number for records and donations. Robin J., Dist. 66, moved that the proposal be tabled until next Assembly Meeting. Vangie R., Dist. 17, seconded the motion. **Motion failed with 82 no, 31, yes, and 12 abstentions.**

6. **Chuck, Dist. 27** moved that Southern California World Service use only the WSO ID number for records and donations. Ellie, Dist. 75 seconded motion.

Motion passed with 89 yes, 16 no, and 14 abstentions..

Alternate Delegate called for Ask-It Basket Questions and Answers.

Five names were drawn for new Forum subscriptions.

Action Committee Reports were given by Willie W., Group Services, and Kay D., Public Outreach. Barbara W., Membership Communications chose not to give a report in order for the meeting to end on time - report will be in the Bulletin.

7th Tradition was \$413.46. \$393.46 went to Treasury and a \$20.00 tip to the Center worker.

Intergroup Liaisons' Reports were not presented due to time and will be in the Bulletin.

Meeting adjourned at 4:30 p.m. with the AI-Anon Declaration.

Coordinators' Reports

Alateen Sponsor

Hi, this is Kathi, your Alateen Sponsor Coordinator. The overwhelmed feelings are getting better. But there are still some areas that get me. I'm still working on the communication between meetings, districts and area. Hopefully as each district gets an Alateen Liaison, this will get better.

We are willing to present Alateen Sponsor Workshops. If your district would like to host a workshop, you can contact me at and I will coordinate with them to set it up. I need to know the date or dates you are considering.

Our first Alateen Newsletter (for this panel) went out in October. It was sent to every registered Sponsor, Alateen Liaison, DR, Intergroup Liaison, and Intergroup Alateen Coordinator. I've brought a stack of them here with me today, if you haven't received one, please come get one.

I'm happy to say we haven't had any really big issues in the Alateen arena these last few months.

I have put together a Guidelines Committee. I have packets of material with me for them and for others who may be interested. We are looking at what is needed for Southern California in the Areas of Alateen Safety Issues, guidelines for selecting and keeping Alateen Sponsors, and guidelines regarding Alateen Conferences and their connection to the Area's World Service Assembly. My materials include guidelines that are already in place or have been proposed here as well as SCAC's bylaws and their existing behavior guidelines.

At the Area committee meeting I asked what our top three issues were for Alateen you said:

1. The decrease in Alateen members and Alateen meetings. This included meetings that die out and going away totally, even older established meetings and how we are reaching out both to existing Alateens, and new ones.
2. Sponsor guidelines, this concern included the lack of Al-Anons willing to sponsor, will guidelines make it more difficult; the need for a sponsor job description; how to deal with controversial issues with sponsors; and how would guidelines be enforced?
3. Communication. This concern included communication between meetings and their districts (Alateens and sponsors), their district, their area, and WSO; communication regarding Alateen events in So. Cal. Timely notice; and Communication between the Alateen groups themselves.

Thank you for allowing me to be of service. Alateen continues to be very near and dear to my heart and I feel very privileged to be able to serve in this capacity.

Ask It Basket

Q: We need guidelines for people that come to Al-Anon meetings needing a court card signed. These cards are given to people by courts and/or therapists.

A: *Each group is autonomous and the group's response should be a result of a group conscience.*

Q: How many times can you attend Al-Anon meetings per week?

A: *There is no rule but the manual suggests, on page 67, that members may be attending several groups per week.*

Q: Is the opening prayer read at some Al-Anon meetings Al-Anon (Conference) approved literature?

A: *The opening prayer referenced in our literature is the Serenity Prayer. Also, page 82 of the Service Manual under "Use of Material" section talks about reflecting an "informed group conscience".*

Q: This questions was asked in my group – Why are there so few of us? I think we are lacking in attraction and motivation. Before there were many of us. Why don't they come anymore? This group is three years old.

A: *Page 50 in the Service Manual – Group Problems and Solutions was referenced. Also consider using the Guideline for Group Inventory G-8 at your meeting.*

Q: I was at a meeting where everyone there voted not to be there on Thanksgiving. They said it was an autonomous group and they could do that. I felt like it could affect others that came. What if no one was there?

A: *Tradition One talks about unity and how we work together. Tradition Four says the group can make a decision like this but what about the person who shows up to a meeting that is not being held because of a holiday? Assume a newcomer shows up and his or her first experience with Al-Anon is that no one is there. What does that say about our program, is it attractive?*

Q: Are there benefits to having by-laws for service arms such as districts/information centers? Is the service manual enough?

A: *The manual is used but sometimes is not specific enough. Concept Ten may help when we need help defining responsibility and authority.*

Q: I believe it would be better to change the hours (of assembly/committee meetings) to 9-3 or 10-3. Thank you.

A: *It would be impossible to finish our business in less than six hours with lunch. We used to go later!*

Q: Can we not make a big deal out of the district table signs and focus on our primary purpose? Most of us are creative and competitive, and while it's not out of hand yet, I see it getting there, i.e.: bigger, better and showier like a few that were here today. One was in front of me and it was blocking the person at the microphone. I am sure it was blocking the head table for others. If we must do it, can you please ask people to keep them low or take them down after people have found their table? Thank you for listening.

A: *The purpose of the signs is to help locate the tables and let everyone easily see the (district) number so we can visit and communicate with others and to promote interaction. Suggestions might be 1) make all signs the same by the hosting committee, 2) require that there be no visual blocking (keep under 12"). Alternate Delegate's note: We can discuss this at our January Board meeting and give you feedback in February.*

Q: "Can we have the presentations limited to facts and not indulge in long winded personal anecdotes?"

A: *The short answer is "yes". In matters of assembly procedure, we defer to our leaders, who have the right of decision, according to Concept Three. If you object to a procedure, make your voice known to your leaders. The SCWC directory in the back of the bulletin lists their contact information. This is a gray area, however, because the right to share is fundamental to Al-Anon's primary purpose (Tradition Five and page 46 of the Service Manual). Also, page 164 of the Service Manual, in talking about Concept Five says, "In Al-Anon groups, individual freedom is of enormous importance." Page 34 of the Service Manual says, regarding speakers: "Not every speaker has a significant message for every listener, but there is sure to be one thought a newcomer can identify with." Page 163 of the manual, talking about Concept Five, reminds us that anyone in Al-Anon can appeal and petition any procedure. Finally, the group always has the right to elect different leaders.*

Q: A Group Rep in our district also volunteers for hospitality at assembly, and is therefore, not available fro representing her meeting by vote and voice or to bring information back to the meeting. Can a member take both of these service commitments?

A: *Please reference Concept 1 and Concept 9. Without voice or vote, this group has lost it's participation in World Service if there is no alternate and no opportunity fro someone else to fill the GR position.*

WSO Alateen Advisory Committee Motion

Important Information Regarding Al-Anon/Alateen

The following information is in response to a letter the Delegates and Alateen Coordinators received from the World Service Office (WSO) in December 2003. The WSO announced that the Board of Trustees passed a motion on Dec. 8 regarding requirements for Area Alateen Guidelines. The motion is attached. It introduces significant changes to our program that we will want to talk about. We will discuss it at the Southern California World Service (SCWS) Committee meeting Feb. 24 and at our May and November Assemblies too.

Please read the attached information from the WSO. You may share it with your groups and please share it with all Alateen Liaisons and Alateen meetings in your District/Intergroup. This motion may prompt many questions and discussion. This can be good. Let's use our Service Manuals, Guidelines and our Higher Power to help us learn and grow through this situation. No doubt, we will not all agree in our initial responses to the motion, or in the next steps we should take. Use our program; talk to each other; reason things out.

The first meeting of our Area Alateen Guidelines Committee was held Jan. 10. If you or other members (who had not already signed up to be part of the Guidelines Committee) want to participate on the committee, please call our Alateen Sponsor Coordinator, Kathi at 714-841-6966. Our Area Alateen Guideline Committee was set up as a result of our Aug. and Nov. SCWS meetings so that the committee could make guideline recommendations to our Area. This motion affects our Area and Al-Anon/Alateen as a whole and we will be discussing it together at the upcoming SCWS Committee and Assembly meetings, and hearing suggestions from the Guideline Committee. Our Higher Power will help us make the decisions that are needed.

December 10, 2003

Dear Conference Members,

For the past several years, the issue of safety for Alateens and Al-Anon members involved in Alateen service has been very much in the forefront of discussions. The Alateen Advisory Committee and Group Services Committee have had lengthy discussions on the subject. At the 2002 WSC, it surfaced as one of the most important issues facing Al-Anon. At the 2003 WSC, the entire session of "Talking to the Delegates" was devoted to Alateen. The Policy Committee has been constantly examining current policies and guidelines as they relate to Alateen, and the Board of Trustees has discussed this issue in depth at its quarterly meetings.

It became apparent that it was time to do more. The time has come for all areas to have safety and behavioral requirements that meet minimum requirements for Alateens and Al-Anon members involved in Alateen service. WSO registration procedures and policies will support the requirements developed by each area.

On December 8, 2003, the Board of Trustees met by conference call and passed the attached motion. The motion explains the Board's thinking; what the Board now expects from the areas; and what the areas can expect from the WSO. While this is quite a step forward for Al-Anon, I am sure you will all agree that it is a necessary one. Our common goal is what is best for our Alateens and Al-Anon members involved in Alateen service. The Board's motion speaks to that goal.

Please feel free to distribute my letter together with the Board's motion and minimum requirements, as you deem necessary.

Also attached is a memo from the Executive Director dealing with the impact of this motion on existing literature.

MOTION

The Alateen Advisory Committee, the Group Services Committee, the World Service Office Policy Committee, and the Board of Trustees of Al-Anon Family Group Headquarters, Inc. have studied the issues concerning the safety and behavior of Alateen members and individuals involved with Alateen service. The Board has reviewed the documents and actions of previous Conferences, previous Committees, and the World Service Office correspondence with legal counsel, individual members, Alateen Sponsors, Coordinators, as well as area and district officers.

The Board of Trustees has determined:

- Not all areas have written safety or behavioral requirements for Alateens and individuals involved with Alateen service.
- The WSO registration procedures and policies should support areas that have developed safety and behavioral requirements.
- The Al-Anon fellowship should take all necessary steps to provide a safe environment for Alateens and the Al-Anons involved with Alateen service.

As Tradition Four states, "Each group should be autonomous, except in matters affecting another group or Al-Anon or AA as a whole." The Board of Trustees has determined that issues of safety and behavior by Alateens and individuals involved with Alateen service do affect every group and Al-Anon as a whole.

The Board of Trustees, under Concept Seven and Warranty Four, is entrusted with the authority and responsibility to protect the Al-Anon and Alateen names and the organizational identity.

Now, therefore, the Board of Trustees resolves:

1. As soon as possible, but in any event, no later than December 31, 2004, if an area within the World Service Conference Structure uses the Al-Anon or Alateen name in conjunction with any meeting(s), group(s), convention(s), or any other gathering(s) in the area where Alateen participation is offered, the area must have safety and behavioral requirements for all Alateen members and Al-Anon members involved in Alateen service. These safety and behavioral requirements must meet the minimum requirements of Al-Anon Family Group Headquarters, Inc.
2. Al-Anon members involved in Alateen service and all Alateen members must adhere to the area's safety and behavioral requirements, or the area will notify the WSO that those members are prohibited from participating in Alateen service.
3. As soon as possible, but in any event, no later than December 31, 2004, and for each succeeding year, each area must have a process to certify, and must so certify to the WSO annually, that each Al-Anon member involved with Alateen service has met the area's safety and behavioral requirements and has agreed to abide by them.
4. The World Service Office will register only those Alateen groups whose registration it receives through the area's registration process. The WSO will remove from its registration list any Alateen group that the area determines does not comply with area safety and behavioral requirements. The area's request for removal of an Alateen group must be stated in writing to the Associate Director/Alateen. This applies to all Alateen groups, whether currently registered or not.
5. If the area states in writing to the Associate Director/Alateen that a group, meeting, convention, or gathering is failing to meet the area's safety and behavioral requirements, prior registration or interaction with the World Service Office shall not constitute any continuing right to use the Al-Anon or Alateen name.

Minimum Safety and Behavioral Requirements

1. Every Al-Anon member involved with Alateen service must:
 - a. be an Al-Anon member regularly attending Al-Anon meetings.
 - b. be at least 21 years old.

- c. have at least two years in Al-Anon in addition to any time spent in Alateen.
 - d. not have been convicted of a felony, and not have been charged with child abuse or any other inappropriate sexual behavior, and not have demonstrated emotional problems which could result in harm to Alateen members.
2. There must be at least one Alateen sponsor at every Alateen meeting.
3. The area requirements must prohibit overt or covert sexual interaction between any adult and Alateen member.
4. The area requirements must prohibit conduct contrary to applicable laws.
5. The area requirements must contain procedures for parental permission and medical care when applicable.
6. The area requirements must be reviewed by local counsel.

Other points for the areas to think about in developing their requirements:

- Requiring two Alateen sponsors at every Alateen meeting.
- Having background checks.
- Considering behavior before, during, and after any Alateen meeting or activity of Alateens and adults involved with Alateen service.
- Connecting Alateen conferences to the area structure.
- Forming an Alateen meeting that meets at the same time and place as the Al-Anon meeting.
- Being gender conscious.
- Avoiding one-on-one interactions.
- Having an appropriate ratio of adults to Alateens at all times.
- Transporting Alateens to and from events.
- Educational training and awareness programs.

RE: Moratorium on sale/distribution of specific Alateen books, pamphlets, booklets, and other service material.

On December 8, 2003, the Board of Trustees passed a motion requiring areas to create area safety and behavioral requirements that meet minimum requirements set by the Board. A copy of this motion was mailed to all Conference members. I have placed certain materials listed below on a 30-day hold. During the hold, the World Service Office will not sell, ship, or distribute any of the identified materials. Concurrently, the World Service Office will check the identified pieces to be sure that they do not contain information that would contradict the Board's policy. As soon as each piece can be cleared, we will restore it into the order/entry system and the on-line shopping cart, and notify you. By the end of the holding period, those pieces that are identified as requiring revision will be kept on hold and will be revised on a priority schedule.

During this period and in the spirit of cooperation and unity, I am asking all members and distribution arms of the fellowship not to sell, give, or distribute any of the following pieces in English, French, and Spanish:
