

# Officers'

Just as they did, by working Step 12 we get to carry the message, plus, we get extra opportunities to practice these principles. Thank you for allowing me to have served as your Delegate. Service has always GIVEN ME big doses of growth. I encourage each of you to consider being willing to serve as Delegate today, or some day in the future. As our pioneers did, open yourself to the growth that comes by serving others.

The following are the World Service Office (WSO) updates:

- Conference Summaries from the 2005 World Service
  Conference (WSC) are available and provide an overview
  of the week's events. They have a lot of good information
  and spiritual sharings too. About 150 topics were submitted
  to WSC for discussion. Time doesn't permit discussing
  them all during the Conference so most are answered by
  the WSO staff in the Conference Summary's Ask-It-Basket
  section. The questions submitted from our Area (SCWS)
  are numbers 7, 8, 12, 75, (part of) 87, 100, 132 and 145. If
  you have questions you'd like considered at WSC 2006,
  please submit them to your new Delegate by early January.
- Topics submitted to WSC that receive the most interest (votes) are discussed during WSC. One was a question submitted by SCWS regarding "high pressure groups." A brief summary of the discussion is on page 41 in the Summary. As a result, the WSO, with help from Group Services Committee, is now working on a bookmark about Sponsorship. I hope that SCWS will also have future discussion on this topic.
- The WSO website has a new look with lots of information in English, Spanish and French. You can find Conference Summaries, the Service Manual, Inside Al-Anon XTRA, Area Highlights, Guidelines and much more. These are posted on the <u>MEMBERS PAGE</u>. To access it, use the WSO web address
- http://www.al-anon.alateen.org/members, but notice that as shown here you must add "/members" at the end. Then go to Publications.
- Remember that Al-Anon/Alateen is a worldwide fellowship.
   WSO is working with Cuban contacts that were initiated
   by our Spanish speaking members in SCWS. Hooray for
   us reaching out to share our experience, strength and
   hope! "Hope for Today," (B27) will be available soon
   in Spanish and French. India has formed a trial national
   committee to further discuss creating a service structure
   there. See WSC Summary page 81 for more worldwide
   notes.
- The updated Service Manual is due out soon (hopefully in Dec.). A copy will be sent to each registered group and it will be available on the Member's Page of the WSO website.

- The Oct. Board of Trustees meeting reported an anticipated loss for the year of about \$100,000. Don't be alarmed. This is generally in line with the negative (deficit) budget presented and approved at WSC. Operating Expenses increased and literature and Forum sales decreased. The WSO revised budget for 2005 includes expenses of about \$4,500,000. Our reserve fund is in excess of \$5,000,000 (total assets are around \$10 million).
- The WSO Policy Committee is continuing discussions regarding potential significant revisions to the structure and contents of the Policy Digest section of the Service Manual. They are also reconsidering the policy of anonymity stating that WSO staff cannot appear full face and name in the media. Your next Delegate will have information on this for you in the future.
- The Alateen Traditions have never been Conference Approved and will be discussed by the next WSC.
- The 2006 WSC theme is "Shared Leadership—Moving Forward with Confidence, Collaboration, and Clarity" (in Spanish) "El liderazgo compartido—Avanzando con seguridad, colaboración y claridad.
- Did you know that you could be selected to serve on a
   WSO Committee? Resumes for volunteers for WSO
   Advisory Committees positions are due by April 15 (prior
   to WSC sooner is better). The WSO forms can be
   downloaded from our SCWS website, scws-al-anon.org.
   The positions include Alateen, Forum, International,
   Literature, Public Outreach, and Outreach to Professionals.
   (Resumes for Trustee-At-Large and Executive Committee
   for Real Property Management are due annually by Aug.
   15).

Be certain that you know who in your group is the CMA receiving the mail so all the information can be shared with the group's members. Be aware that you need to register with WSO, with Margie our Group Records person here today for SCWS, with your District and Intergroup. We want you to be informed! Be sure to use the newest forms. Forms can be downloaded from our SCWS website (<a href="http://scws-al-anon.org">http://scws-al-anon.org</a>). Note that there are separate forms for Al-Anon and Alateen groups and they are in English and Spanish. Information is also available online at the WSO website on the Members page (see information above). The WSO is looking for better ways to communicate and to have more direct contact with members.

 Alateen group registration forms and our SCWS Alateen safety requirements forms (both in English and Spanish) are on our website, <a href="http://scws-al-anon.org">http://scws-al-anon.org</a> - under "Forms" and/or Alateen. You can also download WSO group registration forms from our SCWS website. There is also a map that links directly to Intergroup and District web pages to provide meeting information all over California. For Alateen, only those meetings that are registered under the new requirements should be listed.

# of Area Assembly Meeting

## Minutes of Southern California World Service Assembly

Saturday, November 19, 2005

Fullerton Senior Service Center, Fullerton, California

Chairperson Kary L opened the meeting at 10:00 a.m. with the Serenity Prayer and welcomed all new GRs and DRs. She told them that guidelines for their positions could be found at www.al-anon.alateen.org/members. [further instructions deleted for website version].

Past Delegates present were Kary L. Panel 34, Kay D. Panel 40, and Willie W. Panel 37.

The traditions were read by Mary D. Dist. 6.

Alternate Delegate Suzanne P. gave both the Delegate and Alternate Delegate reports. See Bulletin for reports. She announced that sign-ups for SOS were being taken at the back of the room. She started the Ask-It Basket and Forum Can.

Minutes Secretary Shirley M moved that the May Assembly minutes be approved as printed in the Bulletin. Celeste M. seconded the motion. Motion passed with three abstentions.

Carole L., Chairman for the Al-Anon portion of PRAASA and her husband Jack, AA Hotel Chair invited the area Al-Anon members to participate in the service assembly, which will be held at the Warner Center Marriott, March 3-6.

**Records Secretary Margie L** announced that the new directories/lists were out and asked that DRs check their list and report back any errors. She then took roll. Voting members present :19 [Editor's note, # was in the 190's, not 19.]

#### **OLD BUSINESS:**

Item 1 PRAASA.

Heidi T., GR, Dist. 24 moved that the SCWS Area continue to participate in the Pacific Regional Alcoholics Anonymous Service Assembly (PRAASA) as they have in the past by sending the Board members as our representatives until such time as an appropriate alternate can be fully discussed by an ad hoc committee, the SCWS Area Committee, and subsequently presented to the SCWS Assembly for consideration and vote. Judith R., Dist. 12 seconded the motion.

Chairperson **Kary L** answered a question regarding the PRAASA tabled motion from the May Assembly saying that she had checked and a tabled motion does not have to be brought back. A new motion can supersede it.

Kary called for the vote. The motion passed by a majority count.

Item 2 Report Back from SWRSS.

Bulletin Editor **Elizabeth K** reported back for those who attended the SWRSS in Hawaii. Written report in Bulletin.

Item 3 Liability Insurance Research

CPC Coordinator **Lee T** gave an update on the Liability insurance research. He is presently in contact with a company that insures other non profits. The company has requested more information. Lee did say that it is clear that we would need to fingerprint for this company¹s coverage.

#### **NEW BUSINESS:**

Item 1 By Law Amendment

Past Delegate Kay D submitted an amendment proposal from the By-Law Committee recommending that the Minutes Secretary position become an elected position and the Records Secretary position become an appointed one. Heidi T., Dist. 24 moved that the recommendation be implemented. Danielle, Dist. 27 seconded the motion. The motion passed with 3 abstentions.

Item 2 Election of Area Officers

Chairperson Kary L explained the election process for the Area Officers. The Assembly wanted to have the votes tallied in another room and the final count placed on a white board with business continuing during the tallying. Kary opened the election by calling for nominations for Delegate.

**Records Secretary Margie L** reported the new voting count of 209.

**Delegate Election**: Mary M., Sandie E., Suzanne P., and Shirley M. stood for Delegate. Voting went to the hat and **Mary M.** was selected as Delegate.

Item 3 Treasurer's Report and Proposed Budget

Treasurer Tom E presented the Treasurer's report and proposed budget during the tally. After a short discussion and question and answer period, **Danielle O.**, **Dist. 27** moved that the proposed budget be adopted. **Barbara B.**, **Dist. 29** 

seconded the motion. The motion passed with 5 opposed and 2 abstentions. See Bulletin for full report and budget.

**Alternate Delegate Election**: Shirley M., Sandie E., and Sandra W. stood for Alternate Delegate. **Sandie E**. was elected on the third ballot.

Past Delegate Kay D presented a farewell recovery report as she stepped down after years of service to the Board. She will be working on a project for the WSO.

Lunch break - SCAC Committee provided lunch.

**Chairperson Kary L** called the meeting back to order at 1:00 p.m.

Concepts were read by Cindy R., Dist. 60.

Hospitality Chairperson Martha M announced the following districts to serve as Brunch Hosts and provide volunteers for the February Committee Meeting: 17, 27, 33, 36, 42, 45, 66, and 78.

Elections continued.

**Chairperson Election**: David B., Suzanne P., and Shirley M. stood for Chairperson. **David B.** was elected.

**Treasurer Election**: Amanda and Suzanne P. stood for Treasurer. **Suzanne P.** was elected.

Minutes Secretary Election: Marge V. stood unopposed for Minutes Secretary and was elected.

#### SOUTHERN CALIFORNIA WORLD SERVICE 2003 PROPOSED BUDGET

#### For Discussion and Approval at the November 16, 2002 Area Assembly

Budgets are "guestimates" based on history, projections and planning. The following are explanations of unusual or large proposed budget items for the 2006 SCWS Budget. The 2006 Budget requires the approval of the Group Representatives at the November 2005 Area Assembly. Please consider the following proposals offered by the Treasurer, based on input from the Officers and Coordinators:

Line 5) Group Donations: This amount equals the approximate amount of actual donations received in 2005.

Line 18) Alateen Coordinator Expense: Background checks on all participants in the Alateen program for the Area have largely been completed, but on-going Sponsor Workshops will be needed in the coming year to inform Alateen Sponsors and other Al-Anons (DRs, GRs, Event Coordinators, etc.) of their duties and rights under the Alateen Area requirements.

Line 28) Delegate Equalizer Fund: A letter was received from the WSO indicating the "full cost" for WSC 2005 at \$1,818; the "equalized cost" is \$1,100. The 2006 budget is for the estimated "full cost" for the 2005 WSC. SCWS pays the "full cost" for a delegate to attend the week long World Service Conference, including airfare (1993 November Assembly). (See the Service Manual pg 115 for a further explanation)

Line 31) SWRSS/SW Reg. Service Seminar: The RSS took place in Hawaii in 2005 and the Area incurred extra expenses for airfare and hotel. This is not a budget item for next year because RSS is every three years.

Line 43) Liability Insurance: The cost of insurance has continued to escalate. A modest increase is provided in the 2006 budget for our "slip and fall" coverage. The may also need to provide insurance against the possibility that the Area might be sued by someone injured by a sexual predator. This expense is unknown and not included in this budget.

Line 50) Rent - Committee/Asembly: There were a number of extraordinary Board Meetings in 2005. We anticipate a normal Committee/Assembly expense in 2006.

Line 56) Surplus Before Contribution to WSO: We did not make a contribution to WSO in 2004 or in 2005. The Assembly voted to retain those funds to determine what the requirements would be in fulfilling our Alateen commitments. Since we can only retain a \$25,000 prudent reserve, I believe we should continue our long-standing tradition of donating all funds above the prudent reserve to WSO in the event that this year runs a surplus above the funds required to serve Area 4.

# Ask-It Basket

Ask It Basket November 19, 2005 Area Assembly

- Q1. How do you handle a mentally ill person who is disruptive during a meeting?
- A1. Please refer to the CAL pamphlet P-17, "Twelve Steps & Twelve Traditions." In it, Tradition One specifically addresses this situation. If a group has trouble retaining members because of a disruptive person, the group unity is sacrificed. After several attempts of loving boundary setting, any disruptive person may be asked not to return, but only as a last resort. (See pamphlet P-17.)
- Q2. Why do we have a retail station at our Assembly? Fundraising for our conventions is getting way overboard.
- A2. Refer to p. 75, paragraph 4 of the Service Manual. "Fund raising activities such as potluck suppers, dances or other social events are considered only within the fellowship and in agreement with the groups directly involved."
- Q3. I am aware that more than one of the SCWS Board members did not attend the RSS. Did SCWS pay for them (air-hotel-seminar) and if so, are they expected to reimburse SCWS?
- A3. From our SCWS Treasurer "I do not advance funds, but SCWS was reimbursed by the members who received reimbursement from the WSO."
- Q4. Re: Lee's talk on insurance coverage for sexual abuse -Currently District Representatives sign the Alateen Registration forms asserting that to their knowledge the sponsor is of good character. Will the DR be covered under area insurance? And if not, will they continue to be required to sign the sponsorship registration forms?
- A4. Lee's response "I don't' know. I hope that they would be covered, but I cannot provide a definitive answer until we discuss it with insurance carrier."

Actually, the Certification Form reads as follows- "The person above is known to me and, to the best of my knowledge, these statements are true." It can be signed by the District's designated Alateen Coordinator, as well.

- Q5. The 2005 WSC Summary stated that the Southwest Regional Trustee nominees did not receive traditional approval from the Trustees. Will you please explain how or why the nominee did not receive traditional approval after receiving approval from all other committees involved in the process?
- A5. Part 1 Traditional approval is all Conference members, not just the Trustees.
- Part 2 The SW region voted for the nominee from their area, which was not approved on the Conference floor. See p. 23 in the 2005 Conference Summary, resumes will go to all Conference members before the Conference for their perusal.
- **Q6.** If our meeting lasts one and one half hours, is it OK to run over? Out of respect for the meeting location and our 7th Tradition, we have paid for one and one half hours.
- A6. Please refer to Traditions One and Four. This is up to the group conscience. Each group is autonomous. If you have only paid for one and one half hours, the it should be said at the beginning of the meeting and the Chairperson has the responsibility to kindly remind others to be out of the room on time.
- Q7. Would it be possible to add the SCWS web site address on the agenda, in the Bulletin?
- A7. There is no reason why this couldn't happen, will pass on to the new Minutes Secretary.
- Q8. It's always read, "We do not discuss members or others, and especially not the alcoholic", or something like that. We (or most people) usually do talk about, refer to, or otherwise discuss alcoholics. I don't get it.
- A8. Please refer to Traditions 11 & 12 regarding anonymity and "placing principles above personalities". More food for thought - Sponsorship is a tool for sharing my personal experience. Steps 4 & 5 are also an avenue for healing & sharing with a sponsor or a trusted friend. Higher Powers are great at listening. Look within-would I want someone to be sharing about what I did?
- Q9. Do I have to register to be an Alateen Sponsor to transport Alateens to meetings, conventions, workshops, etc.?
- A9. Yes, this is not in the current manual since the requirement is so new. But the certification forms are for any Al-Anon member involved in Alateen service. That includes sponsoring a meeting, driving Alateens to meetings and events, or attending SCAC (Southern California Alateen Conference). There are also permission forms that can be signed by the parent or guardian giving you permission to transport the Alateen. This will provide extra protection to you and provides medical/insurance information for you in case of an emergency.
- **Q10.** The treasurer of our meeting asks us to put folding money only in the basket – no change – for his convenience. Your comments, please.
- A10. Interesting! If this bothers you or anyone else, you might want to suggest bringing it up at a group conscience. What a wonderful discussion about the 7th Tradition that would be!

## Regional Service Seminar

This report was provided by Cathy W, DR for d45

#### Friday, September 16, Opening Session

- —2005 Conference Summary how to use this book. There is a lot of good information contained in this book. Many Ask-It-Basket questions and answers. Tom W. and Claire R. did a skit called "It's in the Conference Summary," pointing out that the 2005 version has a discussion on the revisions of Concept Eleven and of the World Service Handbook, ask-it-basket questions, chosen agenda items (Delegates vote on which items to put onto the agenda), a section called Sharing Ourselves which are personal sharings from the Panel 43 Delegates (including Miriam M.), and a Clearing the Air section for comments or concerns about anything from the previous year's Conference.
- —Service Manuals all Group Representatives should have one it's a "How to..." book. Should be used by everyone there's a lot of good stuff contained in the manual. Do not have to be a person serving beyond the Group level to use it. There was panel discussion on the topic of Demystifying the Service Manual.
- °Do all the GR's in District 45 have a manual?
- —Tom C. (WSO Associate Director of Fellowship Communication) and Cynthia H. (Associate Director of Membership Outreach) both shared their personal stories and their growth in service.
- —Evening Breakout Sessions:
- °AWSC Officers: Serving with Aloha
- °GR's: My Home Group The best Aloha spirit around!
- °Alateen: Moving Ahead with Aloha!
- °Delegates/Past Delegates: What Now? Brining Aloha to my Area
- °Web Sites and Web Masters: The Front Lines of Aloha!
- °Public Outreach: How Can We Make Al-Anon a Household Word in the 21st Century?
- °AIS/LDS's: Service with Aloha!

I was pulled into the <u>Web Sites and Web Masters session</u>. It was very interesting. There is no Web Coordinator position in our Service Manual. In Hawaii, this position is a voting member of their Area board. In So.Cal, this position is not. In Hawaii, there is a policy committee and they rely on Tradition 6. They have set up permanent email accounts for the positions of Delegate, Alternate Delegate, etc., so that there is no transition needed when change occurs in the person holding the position, thus maintaining anonymity. Northern California web site seems to be very much more advanced than other areas. So.Cal following in its footsteps.

Elizabeth K. went to the <u>Alateen session</u>. Part of the responsibilities of the Alateen Coordinator is to ask people to be a sponsor. It plants a seed. Look for someone who knows the Steps, Traditions, etc. People are more willing to step up to be a sponsor when there are guidelines and a list of boundaries – sponsor's responsibilities and the alateen's responsibilities. The sponsor training workshop in the Washington area covers what to expect, what a meeting is like, what is the

certification process, what the responsibilities are, problems sponsors have had. They have a panel with 2 alateens, 2 sponsors and a Q&A session. Talking about scenarios helps. In California North, all their meetings have 3 sponsors. It is suggested not to sponsor a meeting where your own child (or grandchild) is an alateen, and not to sponsor a meeting opposite a meeting you attend because the alateens are inhibited when you know their parents. Bringing an alateen panel to Al-Anon meetings helps the Al-Anons to understand what Alateen is about. One district took an inventory and asked "how can we generate interest in Alateen sponsorship?" Someone shared a response, then 4 people started the certification process. Educate: do you realize that Alateen IS Al-Anon? The Al-Anons don't have to "approve" of Alateens coming to a meeting. ... but Alateens vote on whether to allow an adult (who is not the group's Sponsor) to visit their meeting.

#### Saturday, September 17

- —Introduction of Ric B. (WSO Executive Director). He shared his personal story and how he became involved in service. He also shared a slide presentation regarding our history, along with pictures of those who work at the WSO. He talked about the 1996 beginning of the 15 year trial period of owning property. Occupancy costs had gone up so much that in 1996 they went to Virginia because it was less expensive to operate.
- —Many of the operators at WSO speak at least two languages, some speak three. The primary languages are English, Spanish and French. There are 55 members and volunteers at WSO.
- —There was some discussion around anonymity. Al-Anon is not anonymous, the people are anonymous. Just because you work at WSO, where there is a sign in front of the building doesn't mean you're in Al-Anon, it just means you work there
- —The new Service Manual will be available in November.
- °Spanish and French version will probably be available in December.
- °Manual index is being changed to be topical versus a word index.
- °Tabs will be 4 different shades of one color (less expensive)
- °Front cover will include portions of the manual.
- °Too expensive to have a spiral binding. In addition, spiral bindings are prohibited in some institutions.
- —Archives WSO is in the process of electronic storage for easy search capability.
- °20 million<sup>th</sup> AA Big Book is displayed in the Archives. This book was given to Al-Anon for their participation in AA's success. (A picture of this display was part of the slide presentation that Ric gave.)
- —Alateen there are now over 2500+ certified Al-Anon members involved in Alateen service.
- —There were 152,000 Forums shipped in September this is the largest historical mailing order.
- —Finances:
- °We are one of two organizations who do not accept money from outside of our fellowship.
- °Source of WSO Income
- -64% Literature (Literature sales exceed contributions.)
- -7% Forum
- -4% Interest

- -25% Contributions
- °Passed the \$1million mark

- °Claire gave an outstanding presentation on Anonymity and the confusion surrounding it.
- -Anonymity < > Secrecy (Pg 189 of Lois Remembers)
- -Al-Anon name of the WSO Bldg does not mean that all WSO Staff are Al-Anon members.
- -We make it difficult to let people find us.
- See page 71-72 in the Service Manual regarding the three components of Anonymity, pages 87-88 regarding Public Relations, page 89-90 How-to's.
- -We have not had any growth in the # of registered groups between 1978 and now.
- °Affiliation? Al-Anon message printed on one side of grocery bags. We can take advantages of services offered to all non-profit organizations. No strings attached – the grocery store offered to print as part of their outreach program. (We shouldn't ASK them to print it, but they may offer to do it. We had asked them to put leaflets into their grocery bags and they said they'd prefer to print the leaflet message onto the bags.)
- -Workshop on Using the Concepts in your Personal Life -Ric. We have 36 principles, not 12 or 24.
- °Concept 1 Can't have authority and responsibility if you don't exercise it. If groups don't have a GR, they don't have a group.
- -Must sent GR's to events to get information
- -Must pay the way for trusted servants
- -To keep power, you must give it away Trust
- -If groups want a voice, must give the power to the GR

- -Isolated groups can have and keep all the power they want but they will have no voice unless they give it away (to the GR)
- °Concept 2 Links of Service.
- If links are broken then communication is broken. If we have trust, we give up control. Delegate responsibility. Trust
- °Concept 3 When we give authority, give enough to make decisions.
  - -Need to know requirements/guidelines but don't have to control.
- Give enough trust to make decisions
- -Must have information consult with others
- -Trust leaders to make good decisions and believe that they won't do so without enough information
- -Sometimes we bring the decision back to the groups w/o the discussion. When this happens, groups don't trust. Need to give information regarding the discussion so that groups know what was considered. Our responsibility is to carry the decision. Don't need to tell about our own vote - just the decision.
- °Concept 4 Mutual respect.
- -Give the respect that others are able to do the job.
- °Concept 5 Some time in the past this concept was changed w/o a vote. Conference voted to go back to its original text.
- -Appeal affects Al-Anon as a whole
- -Petition affects individuals
- -Right to be heard < > right to be right or get your way.
- -Some think the decision is wrong so they will appeal, then appeal, and appeal,...
- §We have no parliamentary model in Al-Anon
- §See the warranties
- §If the Board makes a decision, Conference is not the Supreme Court. Do not appeal to Conference - must go back to the Board. No hierarchy. If we don't like decision, must go back to the decision maker. If minority view was heard and decision still is to go with original view, then we agree to go with spiritual principle.
- §Not about the result but about the process and access to the process.
- °Concept 6 Groups Conference Trustees
- -Farther away from the groups, the less being delegated -Conference did not give up all of its authority
- -Need to acknowledge who has responsibility and link responsibility to the job.
- -Trustees job is to keep the train on the track not run the train
- -Balance of leadership
- -Trustees meet quarterly Conference meets annually
- -Not everyone does the same job
- °Concept 7 Conference can't elect Board but it can dissolve it.
- -Outgoing Board elects the new Board.
- Practical authority versus ultimate authority.
- -Practical: to accomplish job
- -Ultimate : Legal
- -Each has different strengths and weaknesses.
- °Concept 8 More delegation
  - -Trustees meet quarterly è Executive Committee meets monthly
- -Board still the legal entity so must affirm (or not) decisions

- -Delegates routine tasks to someone else share the load
- -What are we good at? Delegation to others who are good at what we are not.
- -We all have different strengths and weaknesses. We can each celebrate our strengths and ask for help.
- °Concept 9 We have leaders at all levels.
- -Bill's essay on leadership see pages 173-175 in our Service Manual.
- Open access to information needed to make decisions not all information is necessary to make all decisions.
- -Shared leadership:
  - Discussion on shared information in determining what information is needed
  - Watch out for the people who irritate us because they always have something to teach us.
  - Each of us can be a success and demonstrate leadership qualities
  - -Listen to negative criticism
  - -Being willing to adjust the plan
- °Concept 10 Every job needs to be defined and needs to spell out responsibility and authority.
- -Can't give someone a job but not the authority to carry it out if this happens then we set ourselves up for failure.
- -Some people complain that we can't get people to do the job but we don't tell them what the job is.
- -We lose good leaders because of how we treat them.
- -Some times we give the authority then beat them up for exercising it.
- °Concept 11 Wording was changed w/o approval in the past. Will be resorted to original text.
  - -Dedication to common goal.
  - -Co-operation and unity to achieve goal
  - -WSO is run like a business because it is a business.
  - °Concept 12 Not sure why I didn't write anything down but I'm sure the discussion was good. Sorry.

#### Sunday, September 18 – Ask-it-Basket

- —Literature < > Policy; policy manual = policy.
- "They were not sure where "no rules" came from in the manual; received a request from someone (??) to take it out. Because of research resulting in not knowing where it came from, they decided to take it out.
- —AFG <> Hurricane (etc.) Relief efforts
- °Group funds/activities should not be used to restore houses,
- °We do help restore/replenish literature CAL-outreach
- —WSO supports supporting our local LDC (Literature Distributions Centers). Unless we support them (order our books from them versus going directly to WSO), there will be no LDCs

Many more questions and answers – I did not write them all down. Many had to do with looking things up in our Service Manual.

## **Regional Service Seminar**

This report was provided by Jay P, DR for d36

When we got there we were presented with a Hawaiian bag with different items for the weekend.

#### Friday night RSS began at 7:00p.m.. Sept. 16, 2005

Two main people Judy [Trustee, lives in Hawaii] & Doreen [not sure of spelling] from North Carolina. They talked about the Conference Summary book for 2005. [How to use the book to help others] – ideas. Business meeting. If anyone is interested, it costs \$3.00.

So. CA tipped the scale on attendance at this RSS. *Like 2/3rds*. Look at the map and you'll see what I mean.

Different groups were asked to stand up from their Districts. They forgot to ask how many DR's there were but we were recognized. Sure gave me chills watching groups stand and what states they were from...

Service Manual should be used by not only the DRs, GRs or Area Reps but to be used by anyone. Every member of Al-Anon/Alateen is encouraged to own & study the manual. Check out last page of Paths to Recovery.

Cross talk – it's a comment on something someone was just talking about or talking to someone next to you.

Introduced Tom [Inside Al-Anon] talked about his job as Editor and what it entailed. Tom did a skit with Cora [WSO worker] about the Conference Summary book. There's LOTS of good info in there!

Kary L [our chairperson for SCWS] was in charge of a group after the closing. She asked me to take minutes for group. Went through over 10 questions and had responses from group. Not sure what happened with notes from all the groups. If we get copies I will make sure you received copies.

**Sept. 17**<sup>th</sup> after breakfast we met at 9:00. Judy introduced Ric who is Executive Director at WSO.

We were told we could use camera as long as we got permission from people. Ric told us that he went to Diamond Head Crater and passed out and had to be put on a helicopter and ended up on TV station but laughing said, I didn't break anyone's anonymity. He had just had a heart operation and did too much.

Judy told her story about how she came into the program and how she became a delegate for Hawaii. She is a member of the Heart to Heart Sat. night meeting. She talked about always looking out "that special window" waiting for her husband to come home. She always had a special window everywhere they went. *I do too...* 

They had a WSO slideshow. Showed from the beginning of Al-Anon, who works at WSO.

In the first office there were a stack of three boxes. Top one – *First Things First* – [do first] *Easy Does It* – [wait awhile] and - [Let them cool down]

They have a reserve fund – need 1-year reserve for operating expenses (includes rent). Landlord/banker thought this is not enough security for them, so we lost our lease. Occupancy costs went up so much that in 1996 they went to Virginia because it was less expensive to operate. Showed a chart of difference. [Example – in 1997 it went from \$600,000 in New York to \$300,000 in Virginia] You can go on the web to see more information about how it has grown. Will be 55 years old in 2006.

Most operators can speak three languages. Have about 55 members and volunteers that run WSO. Have sign in front of building and some people were upset about people who aren't Al-Anon being there. One person shared that if she hadn't seen the sign her life wouldn't be the same as it is today.

Talked about giving charity or willing something to Al-Anon, which can't be more than 50% of your income per year. Please don't quote me on that one per wording. I will check it out but these are in my notes for now. Can't be for profit – not lost Tax-deductible status exempt. DR 39 brought up about profits since Al-Anon is a non-profit organization.

Literature exceeds contribution – non-profit printing on bags outside issue [a market wanted to put our literature *in their* bags to help promote Al-Anon] were told they couldn't (it would take too much time) so the store asked if they could put something about Al-Anon **onto** the bags. That was okay since it was *community outreach that the store would provide to any non-profit*.

Tom talked about newsletter communication. Wish more members would write articles sharing their experience, strength and hope. It takes about 5 or 6 years to make up the book. There was something about cross talk. You can copy newsletter articles [In-Al-Anon] [would be appreciated if you would let people know where you got information] but you do need to get permission for copyright from The Forum. If you check out website for the month The Forum comes out – it will be there.

36 principles in Al-Anon = 12 steps, 12 traditions and 12 concepts. Concept 1 = group is on top and GR is needed to not only give info to group but votes for group. Develop trust...

Conference (WSC) committee says what goes in Service Manual and to change back to original writings.

Look for new Al-Anon/Alateen Service Manual in November. There will be a change in Tradition 11. Somehow it was changed. Also changing index in front / topical index & Duties.

2,500 applied and were certified as Alateen meetings. Over 152,000 forums for Health area, etc. shipped in Sept. There were over 500,000 bookmarks sent out, new item M76 in English and SM76 in Spanish (and FM76 in French).

They will be making up forms like a prescription for Al-Anon just like prescription for Doctors to go with patients to get the word out.

2008 International Convention in Pittsburgh, PA.

**Sept 18**<sup>th</sup> after breakfast 9:00 - Opening was read in French, Spanish and English [our own Elizabeth K. – SCWS Bulletin Editor]

#### Suggestions / Evaluations

Ask-it-basket – conducted by Kay SCWS past delegate Chants and prayers after meeting check page 21 in Service Manual

When doing a workshop – suggested doing two columns – [to do / not to do] take the best and do a workshop.

If there isn't an officer or registered meeting – shouldn't be in Directory or mentioned at meetings.

P-86 pamphlet no longer available for Alateen – will be updated with new one, will replace soon.

There are no rules – don't know when it got in there so volunteer delegates took it out.

Average members per group = 13 Al-Anon/Alateen 156,813 x 13 USA and 1,000 x  $13 \text{ Canada} = 169,842 \text{ members [not sure because of anonymity] see Service Manual 2004.$ 

Pg. 93 Service Manual – Al-Anon works together [participation] Pg. 94 guidelines [digest] 1970 to co-operate - AA and Al-Anon There is a Service tool pamphlet which is free

Talked about Blacks – Spiritual before Disease and Caucasians – Disease before Spiritual. Native American literature is mixed.

Participation mentioned in Convention flyers [coming together – not affiliation] co-operate with event is main concern.

Panels – should not be mixed = AA & Al-Anon rather OR

Pg. 88 & 89 attraction and promotion when we cooperate with others... physically be present and cooperate with AA and/or Al-Anon.

CAL literature – old can be used [not up to date] but best to use current print.

Define cross talk – up to autonomy in group – conference 3/04/05 service manual – check The Forum for info.

Talked about action committees at assemblies – break out sections were said that they take up to much time.

Re-print [group binder] has a lot of up to date info. Each Group should have one. Gives your group number also.

Pg. 73 – 75 Service Manual talks about Bill W. concept 9.

Dual member Al-Anon/AA pg.67-68 service manual – holding office not above group level

When a GR goes to District meeting or Assemblies [vote] there is a reason. Groups should be given respect and time to report what happened [if you need to – spread report over a few meetings but don't talk and talk about info]

Pg. 118 – Service Manual – Area Officers – vote as GR

AA no longer an AA for a long time can't be a GR – Pg 65 BUT there again, group autonomy

Rick said – "MIS-INFORMED INFORMATION REPEATED OVER AND OVER IS STILL MIS-INFORMATION"

RSS is in 2009 instead of 2008 because of the International Al-Anon Convention.

AIS – rebuild due to hurricanes – Al-Anon not about relief support EXCEPT to replace literature [CAL outreach service center – literature only]

Think with your hearts – need to think about **Anonymity** – **DISCUSSED AT LENGTH** 

WSO is in process of changing database – use FORMS

Support local literature service centers – some are going to Mexico because it is cheaper. Literature sales keeps service centers open – that's what they are mainly for – also be of 12-step service through phone.

Al-Anon group – not registered – can be BUT they have no vote at assemblies unless registered...

Page 202 - We might be confronted...

Alateen Pg 12 - Traditions #3 and #4 – we don't do anything that affects....

[if group not registered]

Alateen traditions were never approved – conference has to okay.

Read all readings from the Service Manual – NOT COPIES – Newcomers should see the Service Manual read from since that is our main source of information that has ALL the information not from copies.

Pg. 212 protection of AA's names Anonymity was talked about in length at end of Saturday.

Renting or owning property. Meetings can't own their own property. [What meeting has that much money was asked] Property has to be owned and a name on it...Tradition #9 Person can't own property.

There is such a secret about Al-Anon concerning Anonymity that people don't know where some of the meetings are. People caught up not talking about Al-Anon. What would happen if there weren't anyone there when you arrived...welcome newcomers.

Another slide show after Cora talked. She also presented slide show. TALS – Trustees At Large – 9 Regional Trustees - 6 in USA and 3 in Canada [please see web for additional information - to much info.]

Pg. 172 - check out "Quote"

Judy/Doreen/Ric/Tom/Cora and another person I didn't get name of were on Ask-it-basket panel. Mayor of Hawaii wrote down questions and took notes. She didn't care about her anonymity being broken.

Doreen talked and introduced speaker. Ooooopppps! Didn't write down her name...

I had an ocean view on the  $25^{\text{th}}$  floor it was fantastic. Different items were place on the table for breakfast, lunch, dinner and breakfast on Sunday. Met a lot of wonderful new friends.

The Delegate reports news from the WSO and reports on the conference and other items of interest to our area (believe me I get lots of news both in the mail and on email).


