I am a very grateful member of the World Wide Fellowship of the Al-Anon and Alateen Family Groups. It has been a privilege to serve as your Southern California World Service Delegate. It has been an honor and a gift from my Higher Power to serve the fellowship of Southern California.

I would like to review with you what has occurred while serving as your Delegate.

Immediately following the election of November 2011, we were presented with the situation of the theft of the money from SCAC. It was a very large amount -- \$23,000. Can you believe that was three years ago? We thought we would never forget it and now it is just a faded memory. Well out of the seemingly bad comes the seemingly good. The Alateen Task Force which will become a Work Group has been very instrumental in building bridges between SCWS and SCAC. It will continue into the next Panel. During that time the Area again helped the Alateen Conference financially. The end result was that SCAC agreed to always follow the Area's Safety and Behavioral Requirements and SCWS now has oversight of the finances. Each Assembly you are presented the SCAC financial balance sheet by our Area Treasurer. SCAC is financially transparent to you the fellowship, the very individuals who support the Conference.

It was a moment of complete spirituality attending SCAC 2013 and watching the Alateens vote unanimously to pass the Bylaws that required that the Area have oversight of the Conference and that they follow the Area's Safety and Behavioral Requirements! I was in awe! The Alateens now understand the need for Event Plans for all Alateen Events. SCAC understood that their web site needed to be under the auspices of the Area. The new SCAC web site is up and running under the SCWS web page. It is password protected. Another one of God's miracles: when the SCAC registration forms are released they will be using the SCWS address from now on instead of one of Alateen's address. All SCAC mail will go to the SCWS address!

The Area is in the process of taking positive measures to educate and inform all Intergroups in CA(S) to understand the procedure of confirming that an Alateen Meeting is registered with SCWS and WSO prior to listing on a Web site or in a Directory listing. An Alateen Meeting MUST be registered and have valid AMIAS(s) prior to any listing. Any District or Intergroup can confirm this information with the Area Alateen Process Person (AAPP).

Discussions and accomplishments of the Area during the last three years are below:

My visit to Stepping Stones with all the Delegates during my first year at the World Service Conference was another moment of complete love and spirituality. Being present at the home of Lois and Bill W. where so much of our beloved program has been documented was amazing.

I was a member of the CCT (Conference Committee on Trustee Selection) for two years. I participated in a Shared Leadership Workshop as one of the facilitators at the Conference in 2013.

Last year, in 2014, the WS Conference Committee requested that I present a workshop for new Delegates on how to give a presentation to their Area when they return from Conference.

There are many things yet to accomplish and conversations to continue in the next three years. A few are listed below:





Task Force on Groups Who Don't Follow Traditions (Do Not Refer). The participants are yet to be determined.

Task Force on the Age of Alateen in the Area and Overnighters. The participants are yet to be determined.

Task Force on District 64. This Task Force is already in process and will report to the Assembly when they are ready.

In December I celebrated 35 years in Al-Anon. I have come a long way from the survival mode I was in when I got here. I don't ever want to forget where I came from and I love these words, "We who live, or have lived, with the problem of alcoholism understand as perhaps few others can" and these words, "without such spiritual help, living with an alcoholic is too much for most of us".

At my first meeting I knew immediately that I belonged and that I was in the right place. I wasn't the only one so busy taking care of an alcoholic, that I was void of feelings except for rage. Yet I was devoid of spirit and desperate. I had lost a brother and had never shed a tear. I learned I wasn't the only one too busy taking care of my parents during their loss to grieve myself. My brother was killed after he returned from Vietnam and I stuffed all those feelings. When I got here I couldn't stop the tears. You told me that tears build character.

So this crazy person was thrown into service early. I was told to just be willing, to follow direction and to get in the car. Half the time I didn't know where I was going. It was long before we ever had over 1200 meetings in So Cal. Initially, I served at the Group level and then in Convention service work. In 1998 I served as the AFG Chairman. And I dabbled in World Service now and then.

In 2000 I attended an Assembly as a Group Rep. in District 57. When roll call was taken I noticed that I was the only GR in the room from D57. The District did not have a District Rep and there weren't any other GRs present. Afterwards, I was approached by a Coordinator from the SCWS Board and he asked me to consider assisting others to help D57 become a viable District again. That was all I needed. You wanted me to help! My father's words came back to me: "If you are going to do it, do it right, or don't do it at all.

On page 2 of "When I Got Busy I Got Better" it states: "Service and recovery, are not independent of each other. Both are part of the spiritual awakening that continues to guide us. The more willing we become to practice all of this program, the more progress we can make in recovering from the effects of another's alcoholism and in living our lives more fully".

And I got busy. After serving as the Group Rep and then the District Rep of D57 I served as the Group Records Coordinator for the Area. Then I served as the Area Chair, and now Area Delegate.

Service gives me many opportunities to work on my character defects. It requires me to grow in ways I never knew possible. It has challenged me to learn new things. Most of all it has made me realize that it is not about my opinion or about defending my right to be right.





The most important thing is to support the group conscience even when we don't agree. We agree to disagree. It has challenged and forced me to apply the Traditions and Concepts in all my actions and emails too! Those spiritual principles will keep Al-Anon alive and the Traditions and Concepts will hold us together.


I came to Al-Anon not being enough and never measuring up. I looked like an over achiever but inside I felt insecure and inadequate. Today Al-Anon and my Higher Power tell me yes you are enough and I'll help you! Standing before you and serving as your Delegate I am proud to say that my life and my recovery has been enhanced and expanded. If I don't bring my recovery with me I cannot share it with you.

When I was elected I had a past Delegate tell me to remember one thing: "You are not there to change Al-Anon, Al-Anon is there to change you"! Boy do I need to remember that sometimes when I am reading emails, listening on phone calls in helping to solve problems.

Other past Delegates told me "just remember it will change your life". Yes, it has changed my life but in many ways I think what they meant is that it would change my heart!

In November of 2011 when I stood before you as a candidate for Delegate and this journey began, I told you that I had the energy and the willingness and that I would allow God to use me to be of service to you the fellowship. I promised to give the position of Delegate 100%. I said that there were no restrictions on my availability and that I would always be accessible.

I promised I would serve the Area every day with integrity and a strong work ethic. I stated I was devoted to the spiritual principles of the program and that I live according to those principles. I had never expected to be standing as a potential candidate for Delegate and worthy of your trust. I said I am ready and prepared for the responsibility to be your trusted servant as Delegate. I asked you to vote for me and that I would work really hard for you. That it would be an honor and a privilege to be your Delegate. I can only hope that I carried out that promise to all of you! A Trustee at Large told me recently: You have given it your all.


The Al-Anon Focus/Declaration Table card will also be available in French and Spanish. Spanish speaking groups will be sent the table card with the December mailing en Accion.

SCWS Alternate Delegate's report 11.15.14

I took advantage of my once-a-panel SCWS Area-sponsored World Service travel opportunity to spend the weekend of May 30-June 1, 2014 to attend the New Mexico-El Paso, TX Area General Assembly in Santa Fe, NM. This was the first time I attended an area assembly outside of California South and it was fascinating to see how other Areas organize their Assembly which in their case took two and a half days. Having served as coordinator of this panel's Thought Force on District 64, and continuing to serve on our current Task Force on District 64 with co-chairs Elizabeth and Lorena, I was curious to see how New Mexico-El Paso serves its Spanish -speaking meetings, both with the organization of its Districts and how they handle English and Spanish presentations at their weekend-long Assembly. I will report in more detail to the District 64 Task Force but here are a few highlights.

New Mexico has about the same percentage of Spanish-speaking meetings as we do in California South. However, at their Assembly everyone wears headphones, and I listened to several presentations that we made in Spanish and translated for me into English. It was an interesting experience wearing headphones at an Assembly. I felt I got to walk in our Spanish-speaking members' shoes for the first time. They also translated almost every document shared at the Assembly—even the financial reports! They have been working on creating more unity within their fellowship for about a decade so it made me excited for what we can do here in Southern California. In fact, you'll notice when we pass the Forum can and the Ask-It Basket around this afternoon that they're now bi-lingual. We added Al-Anon en Accion to the Forum can and the Ask-It Basket is now also labeled the Cesta de Respuesta—the Answer Basket.

You'll notice there are lots of flyers on the tables about our SCWS Sharing of Service day we are planning for Saturday, January 17, 2015. It's going to be a fun day of fellowship and service. Our Al-Anon Trustee-at-Large from Nevada Judy Kirby will be our keynote speaker. We will also have workshops on Knowledge-based Decision-making (KBDM) that Al-Anon members can use with their groups or on service assignments beyond the group level. In addition, there will be a workshop on Conflict Resolution, using our new Conferenceapproved literature on that subject. If you didn't have a chance to pre-register before the Assembly today, you can do so during lunch. Please distribute the flyers at all the meetings you attend.

Thank you for all your Ask-It-Basket questions from the last Assembly. We had more than 50 questions and we hope lots of members have read these Questions and Answers in the Bulletin.

Thanks to all you GRs for their generosity during the Forum and Al-Anon y Alateen en Accion collection during the Assembly. We were able to give away 8 subscriptions to the Forum to GRs who were present. One of our important responsibilities as GRs is to promote subscriptions to these Al-Anon magazines. There are order forms in English and Spanish on all the tables.

Because of the election this morning, we will not pass the Forum can and the Ask-It Basket around until after lunch.

This is a 'we' program.

We have done that this panel: we reached unity on the Alateen Safety Requirements, we made progress (not perfection) on KBDM, and today we are going to try some new election procedures: resumes and electronic voting.

I'm actually more excited about resumes, but I can understand the appeal of electronic voting. With the computer counting the votes it should go faster.

'Should'. We're not supposed to say 'should'. Expectations are premeditated resentments. We've done everything we can to make using the clickers run smoothly, but computers and people are involved so if there are issues bear with us.

I hope the election runs smoothly at because I want time for the coordinators and for the thought force on - to give the full title - *How Can Southern California World Service Support Districts and Intergroups in Dealing with Groups Whose Activities Do Not Consider Al-Anon as a Whole.*

Both are important: the coordinators because their job is to encourage and share ways your groups can get involved and the thought force because this is one of the hardest issues I know of in Al-Anon.

I want to thank the Area and Assembly for the honor and privilege it has been to be your Chair.

Treasurer

Treasurer Report

December 2014

I want to continue to thank all the groups that are consistently sending in group contributions to Southern California World Service. Your group contributions allow SCWS to carry the message of Al-Anon Family Groups throughout Southern California.

The Assembly voted last month to send \$7,500 to WSO, totaling our contribution to \$10,000 for 2014. (We sent \$2,500 to WSO in May 2014).

As you can see in my financial reports we received \$63,474.01 in Group Contributions, \$1,396.59 in Convention Contributions and \$1,589.19 from District Contributions. We had \$72,338.12 in expenses (including the \$10,000 we sent to WSO in May and November 2014).

My term as Area Treasurer has come to an end and I want everyone to know our new Treasurer Eva A., is prepared and excited about this commitment.

Looking back, I processed over 5,044 receipts for incoming contributions for the last three years; averaging 140 receipts a month (versus the 800 to 900 originally reported).

Reminder to all DRs & GRs: If you are driving over 100 miles to attend the Assembly, your meeting or district will reimburse you for the first 100 miles and SCWS reimburses you for miles exceeding 100 miles at forty cents a mile. All reimbursements are processed through our bank's bill pay system where the bank sends the reimbursement directly to the DR or GR at no cost to SCWS. Note the checks are only good for 90 days.

Reminder to Group Treasurers: When sending in your contributions to SCWS, please use the same Group ID assigned by WSO, versus the old numbering system. If you are not sure of your Group ID, contact our Group Records Coordinator. I have created a group contribution form, where the treasurer can download on to their computer and type directly on the form versus having to hand write the form. The form is also located on our SCWS website under "Forms."

Reminder: SCWS is no longer mailing receipts for Group Contributions. We are only sending them via e-mail. If your Treasurer is unable to provide an e-mail address, please have someone else be the recipient or create a free e-mail account for your meeting. WSO has updated their database to add a "Group E-Mail Address."

Once again, thank you for allowing me to be of service to Southern California AFG.

Approval of minutes. Addended minutes from Nov 2013 Assembly were distributed by email via a link to the SCWS website. Addended minutes from Nov 2013 follow the current minutes in this Nov 2014 Bulletin, p. 17-21 Addended, with GR vote tallied using clicker input. Minutes of May 2014 Assembly were approved with no corrections, vote tallied using clicker input.

Election of SCWS Officers 2015-2017

Confirm morning roll call numbers, with each DR calling out increase/decrease/no change to roll call for that district. Once the corrected total was determined, this number was confirmed by a single clicker vote from the GRs present, answering the Yes/No question, "I am a registered GR in SCWS."

Election chairman is immediate past delegate since Area chairman is a candidate in the election (SCWS Bylaws, Service Manual). Election procedures were approved (see p. xx of this Bulletin), with the vote taken electronically, with clicker input taken as the form of written ballot.

Delegate: Elizabeth K.. First ballot 3 candidates, one candidate withdrew, second and third ballots did not get a 2/3 vote for either candidate, so the election went to the hat with the top 2 candidates.

Alternate Delegate: Kathi M. First ballot 2 candidates, did not get a 2/3 vote of roll call count, second ballot did.

Secretary: Sandy P. single candidate affirmed

Treasurer: Eva A. single candidate affirmed

Coordinator Reports.

AAPP, Alateen, Alateen Sponsor, Archives, Bulletin, CPC, Hospitality, Institutions, Public Outreach, Website. Absent: Literature. Vacant: Spanish coordinator.

Convention reports.

Thought Force Presentation. Sandie E., ThF chair made the presentation, see SCWS website. How can SCWS support districts and intergroups in dealing with groups whose groups activities do not consider Al-Anon as a whole. Charge.

Discussion.

Served as intergroup officer. Info was brought to that intergroup with regard to some groups in a different intergroup, info was over 4 years old. Would the ThF or TF address the idea that people change, groups change, things change over time. That didn't help us. Did you address the 4-year-old business? Sandie. Yes. At the time the area didn't have a policy with which to address it.

Our meeting does reading from CAL that we no longer can buy. Is that still considered CAL? Sandie. Yes. Literature never loses conference approval.

How many districts have come to SCWS to ask for support for groups that do not consider Al-Anon as a whole. Delegate, Jayme. It usually is intergroups that are seeking help rather than the districts. Several intergroups have come to the delegate over this issue. The intergroup is the body that does the directory. The districts usually are not the ones that produce the directory. D42 is an entity of itself with an LDC. There is one intergroup in particular that would like us to come up with a policy.

SCWS has no authority over intergroups. How many intergroups have asked you for help? How would the solution be applied even if it is found? Sandie. Intergroups are a separate entity, but we still all follow the guidelines of the WSO. Intergroups are not policy makers. Intergroup liaisons come to this meeting so they can hear directly what is coming from the WSO.

How would the results of this TF be applicable to the intergroup? Sandie. The TF would come up with how to remedy a problem, such as Delisting vs deregister/close, with plan in place for reunification

Why is a TF needed? Doesn't see intergroups as a part of the service triangle. None of them indicate that any of them have any authority with regard to dealing with groups. Since there isn't ultimate or delegated authority, why would they be dealing with the groups? Wouldn't that go back to the districts? Sandie. The TF would develop an overall guideline to deal with how conflict would be resolved. Look at Al-Anon principles strictly, recommended procedure put forth through the WSO. This is a World Service Conference-level problem. No one is supervising anything, this is a guideline. There is autonomy in the intergroup to list or not list. Intergroups are not required to list. It's about unity and protection of our fellowship. Is delisting a part of it? The framing says supporting districts and intergroups. Is that double-headed management? Sandie. There are districts who provide information to intergroups. District is the first level of contact. We have looked very thoroughly at this, we don't want to parse words.

The ThF (Thought Force) identified needs as to the prevalence of such groups. Checked with Barry in L.A. Intergroup and with the district.

We never were contacted about the prevalence of these groups. Sounds like this is more of an isolated issue, so how did you determine this is a So Cal issue and not an isolated issue? Sandie. It is a So Cal issue. The members of the ThF represented all of So Cal. It also is a WSC type of issue. There was ambivalence as to how to deal with some things that came up, because we were without a policy direction/guideline to help us do that to be consistent and transparent, not cover up, not avoid. This is the primary strategy that we are presenting.

Truck. It's 4:00, we are supposed to be out of here. I would like to ask a consensus of this group if you would support the officers in appointing a TF group to draft a policy. This would be your conceptual approval to have a TF formed that will work on drafting a potential policy to study this further. It is not approving the policy, only the work to get there.

Consensus: yes.

Thank you for letting me be your Chair the past 3 years.

ELECTION PROCEDURES

Introduction: The following functions and procedures are new in concept and specifically designed in the spirit of KBDM to have the most informed and prepared voters, candidates who are the most qualified for the 5 Officer positions, and to ensure consistency, efficiency and speed of voting, utilizing electronic voting equipment. **Trial** of new procedures for 2014 Election Assembly (requiring candidate resumes, due date is Aug Committee meeting, publishing resumes after Aug Committee meeting, GR/AGR registration deadline of 1st Saturday of Assembly month,

- 1. The Area Chairman serves as the "Election Chairman." In the event that the Area Chairman is participating in the election, the entire election will be conducted by the Immediate Past Delegate as the Election Chairman.
- 2. Current or Past District Representatives who have submitted a completed resume (form on SCWS website) by the posted deadline will be considered to be candidates for the election of Officers when they stand for a position at the Election Assembly, revealing position(s) sought by standing at Election Assembly. Submitting a resume is not binding: a candidate may withdraw simply by not standing at the Election Assembly. Candidates also may inform Immediate Past Delegate of their withdrawal prior to the Election.
- 3. The Election Chairman reviews the proposed election procedures, given below. It is important that everyone understands the method agreed upon for the election of Area Officers.
- 4. The Election Chairman asks for a vote of acceptance of the proposed method of election, below. If another method is considered, it should be clearly understood and agreed upon by 2/3 vote of the Assembly. [SM, p. 150*]
- 5. Election Chairman invites candidates who believe they are prepared and willing and who have submitted a resume to come to the dais, starting with candidates for Delegate. Each candidate will be given 2 minutes at the microphone to answer the following specific question from the resume form in their own words: "Describe why you would be an asset as an SCWS officer."
- 6. At the time the vote is called, voters will indicate their choice by clicking the appropriate button on their electronic 10-key voting device. During the voting period, no one may enter or leave the room until the vote result is declared by Election Chairman.

Proposed Election Procedure

- 1. <u>Confirming count of voters</u>. Group Records Coordinator takes roll call to obtain manual count. This number is confirmed by taking electronic count, where voters click on their electronic device to indicate their participation in the election.
- 2. Election of Delegate, requires 2/3 vote
 - A first ballot is taken. The candidate receiving 2/3 vote is elected Delegate. [SM, p. 151*]
 - If first ballot does not elect the Delegate, the Election Chairman may ask candidates receiving the lowest votes to withdraw. If two candidates each receive at least 40% of the total vote, the Election Chairman may ask those two candidates to remain and the others to withdraw.

Whether or not names are withdrawn, a second ballot is taken.

If still no election occurs, a third ballot is taken between the two candidates receiving the most votes.

If 2/3 vote still is not reached, the Delegate is selected by lot. The first name drawn becomes the Delegate.

3. Election of Alternate Delegate

Follows same procedure as for Delegate.

4. Election of Chairman, requires Majority vote

Majority is 50% + 1 vote [Oxford Dictionary, 2014; Merriam-Webster Dictionary, 2014, etc.]

A first ballot is taken. The candidate receiving majority vote is elected Chairman. [SM, p. 152*]

If first ballot does not elect the Chairman, the Election Chairman may ask candidates receiving the lowest votes to withdraw. If two candidates each receive at least 40% of the total vote, the Election Chairman may ask those two candidates to remain and the others to withdraw.

Whether or not names are withdrawn, a second ballot is taken.

If still no election occurs, a third ballot is taken between the two candidates receiving the most votes. The candidate receiving the most votes on the third ballot is elected Chairman.

5. Election of Secretary and Treasurer

Follows same procedure as for Chairman.

Concepts read by Sam S., co-chair SCAC 2014.

Truck. Details of expenses for Alateen Coordinator.

Certification start-up costs are large, and it is money that was well spent. We are doing orders of magnitude of more work than ever was done before. We passed the updated safety requirements two years ago, reaffirmed them one year ago. We need to have certified AMIAS's, which means that they need to be certified, which means we need to do AMIAS workshops and it is an annual requirement. Area needs: sponsors for Alateen meetings, drivers and helpers at events. We need many people to attend those events who are not Alateen sponsors in order to provide the safety underpinning for the event. We need a larger number of AMIAS's to be of service in these other ways in addition to having sponsors. The workshops bring people up to speed with the new safety requirements, and it gives sponsors a chance to network. We had to produce training materials of our own, which generated printing costs; we also bought a lot of literature. Tarisa did every workshop for the first year and a half. Now we have additional trainers, each with their own projector. For the workshops themselves, SCWS paid a portion of the rent for the district, travel to the events, mileage and hotel expenses. In the first 2 years, we held 28 workshops with 273 attendees, 30 recertification workshops with 714 attendees. We have done a lot of work on this.

Now that new trainers are distributed around the area, mileage and hotel expenses will be smaller. We already have done the initial costs, so now it only would be the replenishment costs each year.

We've spent \$11,492 getting started with the whole process. Literature and copies are the biggest expenditures and they will go down. We saved \$10,000 by having the Bulletin go electronic. Opinion: this is money well spent, but the Assembly needs to know about the amount.

Cathy Satter. Contribution to WSO. SCWS already has contributed \$2500 this year, we are proposing to send an additional \$5000. We don't have any major expenses coming at the end of this year, we've already paid for the Delegate's equalized expense, and insurance was paid a few weeks ago. We wanted to propose \$7500, but will wait till May to propose a larger amount. \$22,000 in checking and \$25,000 in CDs.

GR. How will we pay for some of these changes we are hearing about in the ThFs? Response: SCWS does not help meetings – that is not the function of what SCWS does as a corporation. For conference structure, we are only just starting to discuss it, and the conversation is going to take a long time.

Part of the ThF discussion will be about how possible Area restructuring would be financed.

<u>Motion</u> to send \$5000 to WSO. Motion made by Arlene, AGR d27. Second by Nancy R., GR d60.

Roll call first. 283 voting members. <u>Motion carries</u> by show of hands.

Kathi M. participation in the **SW regional TEAM event Thought Force**. <u>Motion</u> that the Area would participate in the SW region's TEAM event if and when it happens. Motion by Paula GR d27. Second by Danielle GR d24.

Discussion.

GR: concerned about unknown costs for this future event.

Delegate: we discussed this at the officer level and board level. It's only a ThF, the SW region hasn't even decided that they're going to do the event yet, it's just being discussed. Reminder that expenditures are limited without needing to go to the Assembly to approve the expenditure.

GR: would the SW Regional TEAM event replace the Jan TEAM event? No, and it would be years down the road.

GR: If our Area can have its own TEAM event, why do we need to plan an expensive trip to participate in a TEAM event in another Area in the region, possibly out of state?

GR: concerned that it would be replacing our Area TEAM event.

Motion to table Bill GR d69. Second by Dina d17. Motion to table carried.

Hotel reimbursement for those traveling more than 200 miles round trip. Affects only 2 or 3 people. Current reimbursement is \$50.

Motion to increase hotel reimbursement to \$100. Motion made by Danielle GR d24. Second made by Karen GR, d21.

Discussion.

Who are the ones affected by this? Committee members for assembly meetings and committee meetings. For GRs it only would be for Assembly meetings.

GR. By how much would this affect the budget?

Past delegate. Some people drive >200 miles, but they don't stay overnight in a hotel.

Amendment: to revisit it every 3 years.

GR. Who are the people who would be reimbursed for the hotel expense? This is

available to anyone who drives >200 miles round trip who is required to attend the Assembly or required to attend the Committee meeting. Currently two of the people who travel >200 miles round trip request hotel reimbursement one is Treasurer, the other is the Records Coordinator. Both drive round trip about 300 miles. When they share a room, the expense is covered, but if only one were at the Area meeting, \$50 is not enough to cover the hotel room. Hotel costs have gone up since the original motion was made.

Past delegate. Speaks with voice today but not vote. What about people from Santa Barbara, Atascadero, San Diego. Our motion might not be clear enough. Let us see it in a written form so that we can be clear about it. [To repeat, this is for all who travel >200 miles round trip.]

Past delegate. If we are not ready to vote yet on hotel reimbursement, then we do not vote. We have three ThF and TF to report today, this motion is a sensible one, but perhaps we need to move on in order to complete the agenda.

Truck. Explanation about KBDM, which ends up with a motion after the discussion. For simple issues, such as the contribution to WSO, we use an abbreviated form of KBDM, mentioning it in the morning and then making a motion in the afternoon. We will take this motion about hotel reimbursement off the table for now, with some information sent out in upcoming weeks.

ThF/TF Presentations,

ThF on Conf Structure. Presentation. Jayme C.. Is the current Area structure providing the spiritual bridge we need to meet the needs of members?

A Thought Force is a temporary unit of people to brainstorm ideas and develop strategies on a single issue.

Many past delegates from many Areas have said that they need help with Area structure and so the Board of Trustees spent years trying to come up with a plan that would work for every Area but they couldn't come up with a plan to work for every Area, so they brought it back to the Areas.

3 things to consider: Communication, Participation, Representation.

1963 Helen W., lives in Arroyo Grande, 95 years old, is the delegate who brought the request

to the World Service Conference for California to split: 69 mtgs in CA(N) and 149 in CA(S).

In 2009 the delegates from CA(N) and CA(S) (now 800 and 1250, respectively) requested that the Trustees come up with a plan and now the Trustees have brought it back to the Areas.

No structure change is off-limits, provided it does not change anything within p. 75-121 of current Service Manual, must be submitted by Dec 15 of any year and the Area would pay for any costs during the 6-year trial period.

The "pseudo" delegate would go to the WS Conference with no voice and no vote, and there would be no equalized expense – the Area would pay the full expense, p. 137 of SM.

What do we know about our members' needs?

Question to ask your group: Is my group being served?

CA(N) is asking their DRs to ask the GRs, is your group being well served:

What does a well-served group look like to you?

What are the top 3 challenges of your group?

If you are thinking about splitting because of lack of participation, is that really going to help with lack of participation?

HW: Ask your meetings these 3 questions, and let's talk about it at the next Assembly, in May.

Presume good will.

Discussion.

Past delegate, voice but no vote. In that 6-year trial, who would carry their vote if they had a pseudo delegate? The Delegate for the original Area would carry their voice/vote.

GR. The people in this new Area would have representation by the delegate from the Area, but would they truly have representation?

Past delegate. If we had a trial Area, then that Area doesn't yet have a separate voice and a vote, but those from that trial Area that originally were represented by CA (N) still would be represented by CA(N), and those originally represented by CA(S) still would be represented by CA(S) during the trial period.

CA(N) is doing the same thing – talking about it with their groups. The main point is that every group still will be represented.

During the trial period, the expenses would be absorbed between the two original areas (N and S). After the 6-year trial period, it still would have to be approved by WSC, "yes, CA can break into 10 different Areas." It is the structure of the WSC that would be changing – the complexity of it.

GR. Did the ThF consider going cyber? The ThF does not come up with solutions, they come up with information.

AGR. How many groups does a typical Area delegate represent? PA 400-500 mtgs. Can split if >400 mtgs. We have way more than 400. The lowest, VT has 50 meetings. CA(S) has 1200 groups, CA(N) has 800.

Past Delegate, the question is about equal representation. It's not only about us splitting. Some small Areas also are looking at combining with other Areas. 6 years is a long way to go if the answer might be "no".

Delegate. The small states are not planning to merge. They are staying small.

GR. There was very little conversation, and most people would like some examples of what it means.

AGR. Is this always about geography? Could this entity could be a non-geographical entity? Could it be a Spanish-speaking Area?

Another possibility is that Area restructuring could be about having an additional Assembly or a longer Assembly in order to get all of the work done that is brought to each Assembly. Please go back to your group and ask those questions.

Go back to your groups and talk about it. Do we need a TF to see where it's going? Do we need a breakout session at an Assembly to talk about this?

The conversation will continue.

GR. Go to the district first and discuss it, and then go to your group to discuss it.

2. ThF on d64. D64 has been with us for a long time. Too easy to get into an us vs. them conversation. Remember that it is all us.

Tim P., chair of ThF. Slide show was given at May Assembly, today will summarize that presentation. Half on the ThF were Spanish-speaking and attend Spanish-speaking meetings, half were Englishspeaking.

130 groups in d64. One group might meet many days or every day of the week. It was supposed to be a 3year trial, but it never was re-evaluated. Now it's 22 years later, and we are doing that re-evaluation that is long overdue. About half of the Spanish-speaking groups belong to the district in which they are geographically based. D48 is all Spanish-speaking meetings within a small geographical area.

Sometimes you start thinking that something is so complicated and hard to imagine getting resolved, in the end, after talking and talking, it doesn't seem too complicated after all.

ThF concluded we could choose 1 of 3 things:

- 1. Decide that d64 should stay the way it is.
- 2. Combine all of the Spanish-speaking meetings into the geographical district in which they are located.
- 3. Make smaller, more manageable districts from 2 to maybe 6 or 8 districts, that no longer would overlay all of So Cal in one single district.

Discussion.

GR. Presentation in May was very well put, seemed it was a no-brainer that the next step would be to have a TF. Survey for the Spanish-speaking groups? Would that be the charge of the TF?

GR. For us to have equal representation, it makes sense to break up into several districts. To meet fairness across the board, having additional DRs would be good.

GR. Group records coordinator for d27 identified 11 Spanish-speaking groups in d27, now is reaching out to them, inviting them to come to the d27 meetings. Home Boys has asked them to come and do an Alateen meeting. Working in jails, looking at having people to come who can speak Spanish. Oscar and Gerardo have offered to translate, but also would like to have people speaking their own story in Spanish.

Past delegate, reminder: don't applaud or give loud emotional displays when someone has said something that you agree or disagree with ...it is disrespectful.

Past delegate. A number of the Area officers have attended d64 meetings, Sandie is becoming more comfortable speaking in Spanish. Reasoning things out, talking with Spanish-speaking members. In spite of the fact that d64 does meet some of the needs of the Spanish -speaking meetings, there also is a different perspective from some Spanish-speaking members. One member said there isn't much training about service structure and Al-Anon itself, ... that she feels the need to go to Englishspeaking meetings to learn about what Al-Anon is. There is a segregated group out there that is not necessarily part of the English-speaking meetings. There are lots of things going on in Spanish-speaking groups that do not follow the Traditions. The very best thing that could happen would be that we would dissolve d64 and encourage the GRs to attend the geographical districts in which their meetings exist.

GR. The Spanish-speaking meetings were from Mexico. The whole idea behind d64 was to serve the Spanish-speaking groups. When the district was formed, the idea was to have more than 10 people (only were 4 at the time). Look how many there are now. When the district was formed, the whole idea, the spiritual idea was about harmony and unity. It's important to understand that the Spanish groups have the option to participate in their geographical district or in d64. Want to work in unity but also understand that we need to work together.

GR, part of the ThF. According to the Service Manual, a district only has 15-20 groups, but we have >130. It is mathematically impossible.

New DR for d64, starts in January. This has been a very growing experience, spoke with past delegate at the int'l convention. There are a lot of issues that need to be resolved, proper representation and also service. D64 does have a lot of groups and was looking at the whole enchilada. He has a work plan for d64, everyone is bilingual, he is from Mexico, others grew up in CA, they understand the program, have studied the Service Manual, worked the concepts, have the tools to better serve the 130 groups.

GR in d48 shared some of her personal story.

Show of hands: <u>how many would like to see us form</u> <u>a TF on this? Yes, by show of hands</u>.

TF on Elections and Voting. Elizabeth K, TF chair gave a TF presentation, including summary of the 5 Questions of KBDM. The presentation and the TF answers to the 5 Questions will be posted on SCWS website. **SEE end of these minutes for addended material.

Discussion.

How long does the tallying take? It's instant. As soon as any member present in the Assembly submits a vote, it shows up in the tally. After all votes are submitted, the vote can be projected instantly.

Does the ballot get emailed? No, each person present at the Assembly gets an email with a link "click here to vote," that brings you to the online ballot. The link can be used only once. Each person voting must have their own email address, even if they use someone else's device (cell phone, tablet, laptop, etc.) to access their own email. GR. When we use KBDM, we can know more about the candidates, and the better off we are. I have experience with several other organizations that have gone to voting online from home. It reduces the actual number of people who vote.

...but this voting cannot be done from home. Only those present at the Assembly can vote (as it always has been) because only those present at the Assembly will get the email with the link to the site.

**<u>Addendum to minutes for section on ThF on Elections and</u> <u>Voting</u>.

The following material is from the TF Presentation (see SCWS website)...

History/Background. After the Nov 2011 Election, Assembly members asked for a more efficient election process and to be better informed about candidates (KBDM). We now have much more business to conduct during Assemblies with ThF and TF presentations for the KBDM process, we currently distribute and hand-count paper ballots for every election vote (can be 3-4 separate votes

during Assemblies with ThF and TF presentations for the KBDM process, we currently distribute and hand-count paper ballots for every election vote (can be 3-4 separate votes

per officer position), and new GRs may not know what the Area elected officer positions entail.

Five KBDM questions. The TF consisted of 5 past delegates, 1 Group Representative and 1 officer. The TF met weekly from June to Nov to thoroughly discuss and consider the multiple aspects of this issue. The 5 questions of KBDM were answered. These answers and possible strategies were discussed at length and in great detail in weekly conference calls.

Strategies to try. To have job descriptions and candidates' resumes available prior to the Election Assembly for Group Representatives to review, To set a final date for groups to register Group Representatives AND Alternate Group Representatives prior to the Assembly, To develop a different, more efficient voting method.

Strategy One: Officer Job Descriptions

More comprehensive. Includes duties, responsibilities, realistic time commitment, skills/technology, talents and/or other relevant experience needed (computer, email with attachments, accounting for Treasurer, leadership, etc.). Reasons: provides voters and candidates with information of what is required of Area officers; allows candidates to ask do I have the skills, experience, availability; provides membership with better understanding of service structure and selecting the most qualified candidate for each Area officer position.

Strategy Two: Officer Resume Form

Develop standardized form for officer candidates, brief, to be posted on SCWS website. Reasons: KBDM, all voters have equal information prior to vote, equal comparison of candidates. During one's two minutes at the mic, candidates can refer to their resume.

Strategy Three: Electronic Voting

More efficient, user-friendly, results given in numbers and in percentages immediately after poll is closed, is a written ballot (digital vs. show of hands) and thus is consistent with Service Manual. Electronic voting with rented clickers was used at World Service Conference in 2013. Total election time is greatly reduced by eliminating multiple **Recommendation of TF**

1. GRs review **Job Descriptions** and **Service Resumes** of candidates prior to Election Assembly

2. Groups to **register GR and AGR** with records coordinator <u>including email address</u> by first Saturday of Assembly month (currently May and Nov)

3. Try electronic voting

Can we live with these new ideas and try them for the Nov 2014 Election Assembly?

Consensus vote: yes, by show of hands.

Ask-It-Basket

1. Q. Is it necessary for Board members to continually congratulate themselves for everything they do? It is a "We" program and it might be nice to acknowledge your helpers.

A. The 2014 November Assembly was the last Assembly for the entire SCWS Board. If Board members were mentioning accomplishments it was meant as what <u>the Area</u> accomplished and not what one person accomplished. Yes, it is a we program and we strive to remember that, one day at a time. On page 137 of *Many Voices, One Journey* (B-31), it states "The beginning of your great task of repair starts with your-selves.....And so the curious paradox—the divine paradox---comes into view, little by little.....The giving of yourself, without demands for return has a chance—as a magnificent example---of inspiring your partner to try to "practice these principles in all his or her affairs." When we give service, we receive recovery.

2. Q. What authority do Intergroups have over Groups regarding listing meetings and referring calls? A second question asked what authority SCWS has over Intergroups.

A. Referring to the Service Manual pages 63-64, "An Al-Anon Information Service, also known as an Intergroup, is a local service established and maintained by one or more districts or by groups located close enough to one another for easy access and communication." On page 64 there is a long list of services which an Intergroup can perform. These services include maintaining and publishing group meetings in their local area and receiving phone inquiries and forwarding them to the appropriate group.

Intergroups in Southern California have made an administrative and organizational decision to only list Groups that have a WSO number. It is an administrative policy to assure that meetings can be accurately identified.

Southern California World Service (SCWS) has no authority over the different Intergroup offices in our Area although they often consult with the Delegate on various matters and they send a Liaison to SCWS Committee meetings and Assemblies. The Intergroup Liaison is the link between the Intergroup and the Area. In the case of Alateen, all Intergroups must adhere to the Area's Alateen Safety and Behavioral Requirements. There are no exceptions in matters concerning Alateen. Some Intergroups have delisted Groups who are not following the 12 Traditions and have refused to list these meetings in their directory or refer callers to these meetings. At the November Assembly there was a Thought Force Presentation on "How can SCWS support districts and intergroups in dealing with groups whose activities do not consider Al-Anon as a whole." After the presentation and discussion the Assembly voted to support a Task Force to draft a potential policy to study this further.

3. Q. Can we consider using a Consent Calendar or a Consent Agenda for our SCWS Committee Meetings and Assemblies so we can combine some issues for a vote? If someone wants to pull an item from the Calendar for discussion, they may do so.

A. Consent Calendars or Agendas are used by some non-profit organizations in order to tell members ahead of time what issues have already been decided. If additional information comes to light or new facts become known, attendees can discuss the matter in more detail. In a sense, the Minutes in our Bulletin provide a kind of Consent Agenda, telling GRs and DRs what was discussed at the last Committee Meeting or Assembly. The Agenda for the current meeting thus becomes new items which were not discussed or decided at the last Committee Meeting or Assembly.

Having just decided in the past couple of years to conduct our Committee Meetings and Assemblies using Knowledge-Based Decision-Making (KBDM), we are inviting all Al-Anon GRs and DRs at these meetings to participate fully in every discussion. No decisions will be made until everyone has had a chance to investigate the matter at hand from every angle and all opinions, including the minority opinion, are heard. SCWS Committee Meetings and Assemblies have embraced KBDM enthusiastically.

4. Q. Why do we start with District 6? Was there ever a District 1, 2, 3, 4?

A. In the early years of the structuring of the districts in Southern California it was decided that the districts would not go in sequential order. The reason for that is because there needs to be open numbers available to add more districts for growth purposes.

5. Q. Will the World Service Office be adding more structure to the sections of the Service Manual about how to welcome newcomers? Our Group finds the Manual vague and has had difficulty deciding how to welcome our newcomers.

A. On page 37 of the Service Manual there is a section entitled "Beginners' Meetings." They describe several ways that Groups can welcome newcomers, ranging from having separate Beginners' Meetings to having occasional special beginners' meetings to provide newcomers with a simple introduction to Al-Anon. However, even meetings that do not have separate newcomers' meetings can do many things to make newcomers feel welcome. The "Suggested Al-Anon Welcome" on pages 10-11 is written as if addressing newcomers. "We urge you to try our program." And the "Suggested Al-Anon Closing" on page 22 is equally welcoming: "A few special words to those of you who haven't been with us long." We actually tell new members that "we already love you." Using the suggested Al-Anon format, having a greeter outside meetings to welcome new members, offering New Member Information Packets to newcomers are all ways that we can make newcomers feel welcome. Some Groups even give newcomers a paperback version of "How Al-Anon Works." We can also encourage the Group members to be sure to speak to newcomers after the meeting. Offering them a phone list and encouraging them to use it is another way to make them feel welcome. Some meetings have a time for newcomers to share near the end of the meeting. You may get more ideas looking at the pamphlet "This is Al-Anon" (P-32)

6. Q. SCWS is so large. When can it be split into two or three areas?

A. In 2012 the question asked at the WS Conference (WSC) was "Is the current WSC model providing the spiritual bridge we need to expand into the future in order to meet the needs of the fellowship (your area)." The Board offered every Area the following plan: Formulate and implement a structure in your geographical Area or combination of geographical Areas for a trial period that would enable your groups to have full communication, participation and representation. No structure was off limits provided it did not affect Policy (pages 75-121 of the *2010-2013 Al-Anon/Alateen Service Manual*) or our Legacies. A Thought Force was tasked to look at the possibilities for Southern California. After the Thought Force presented, the Assembly was asked if they wanted to set up a Task Force on this issue and overwhelmingly the vast majority of GRs did not feel a pressing need to move forward.

7. Q. Is there a need to have someone at a meeting to do signing for the deaf and hard of hearing? How would we accommodate this?

A. A Group could choose to have someone sign for members if they take a Group conscience and that is the will of the Group. We know of one Group who paid for the services of a professional. However, it was so expensive that eventually they decided they could not afford it. A group is not required to provide services for any handicapped person. They may do so if they wish. There are actually many Al-Anon meetings

8. Q. Can the proceedings and shares at a meeting be put on CD or podcast for people to listen to who cannot get to the meeting?

A. On page 43 of the Service Manual we read: "The assurance of anonymity is essential to our efforts to help other families of alcoholics, and our Tradition of anonymity reminds us to place Al-Anon and Alateen principles above personalities." On page 92 there is information about electronic communication outside of Al-Anon. About podcasts we read: "Members who use this type of communication outlet must maintain their personal anonymity and that of any Al-Anon/Alateen or AA member, as the Internet is a form of media." Later on page 92 it is written: "All of us need to feel secure in the knowledge that nothing seen or heard at a meeting will be revealed." We would not have that assurance if a member recorded shares at a meeting to be disseminated on a CD or podcast.

9. Q. What can our Group do to attract new members and take service positions within the Group?

A. There are many ways a Group can carry the message to others and attract new members. The most important first step is to check with the SCWS Records Coordinator to make sure that your Group is registered with the World Service Office. Intergroups in California South have now agreed that they will not list Groups in their directories and on their web sites unless the Groups are registered correctly with World Service. So being correctly registered is the best way to insure that prospective Al-Anon members can learn about your meeting, whether they call the national World Service number or your local Intergroup. Once you are registered, the Group can consider putting up flyers in the local area near their meeting. Perhaps local churches will put a notice about the meeting in their bulletin. Remember not to put anyone's full name on a flyer. You could also reach out to local professionals—doctors, psychologists, teachers, police stations and youth organizations if you have an Alateen meeting. One of the best ways to insure a steady stream of newcomers is to urge current members to invite other family members and friends who are suffering because of someone's drinking. If your meeting has any relationship with a nearby AA meeting, perhaps they can urge their members to check out the Al-Anon meeting.

10. Q. What is WSO's take on the suggestion to "try 6 meetings before you decide whether Al-Anon will work for you." Is this newcomer reading from Conference Approved Literature?

A. If you go to Al-Anon's web site <u>www.al-anon.alateen.org</u>, you will see a section called "What can I expect at an Al-Anon meeting?" One of the bullet points in this section states: "Every meeting is different. Each meeting has the autonomy to be run as its members choose, within guidelines designed to promote Al-Anon unity. Al-Anon recommends that you try at least six different meetings before you decide if Al-Anon will be helpful to you."

11. Q. Why did the Area permit and then elect a candidate who has lied and been dishonest throughout her years of service? Why did you permit candidate to stand for election? In doing so the SCWS has tarnished Area level service and more of Al-Anon. My only wish is that the Area measure the consequences of its actions for three years. My and our prayers are with your dishonesty approbation.

A. Concept Twelve, Warranty Four: That no Conference (Area) action ever be personally punitive or an incitement to public controversy. The current process does not allow for anyone to raise issues about a candidate. It might be something that the Area could take a look at. This is the process that the Assembly adopted and it does not provide for the review or disqualification prior to the election. In prior elections the process was the same. The only process that changed was that a resume was to be submitted by a given date. The resume form did not require that you submit what you were running for and furthermore the resume specifically stated not to include which job position a candidate was standing for

12. *Q.* Why not have all directories of Al-Anon meetings in California South state that "all meetings in this directory have agreed to abide by the Al-Anon 12 Traditions?"

- A. On page 31 of the 2014-2017 Al-Anon Alateen Service Manual it states: "The WSO will register a group with the understanding that the group will abide by the Al-Anon Traditions and not affiliate with or endorse any outside entity or practice. Joint meetings for Al-Anon and A.A. members, meetings comprised of only A.A. members, and groups that practice specific therapies, such as guided meditation, are not in keeping with Al-Anon principles and do not qualify to be registered as an Al-Anon group. Once the WSO reviews the completed GR-1, it assigns a group ID number and sends a packet containing introductory materials to the Group's current Mailing Address (CMA). After the WSO registration process is completed, the group is encouraged to connect with their Area Group Records Coordinator or local district to find out the process for inclusion in the local meeting directory and on the Area Web site."
- 13. Q. During the election at the last Assembly, why were all last names added in the candidates list without asking the candidates? Last names were deleted from the resumes. I understand that sometimes it is necessary in service beyond the Group level not to be anonymous when doing service outside of Al-Anon. Since resumes are anonymous, we need to think further on breaking anonymity. When is it OK and when is it not? If it's important, we should verbally emphasize the reasons why it's important to give up anonymity in service beyond the Group level. Otherwise, this is confusing for newer members. Let's be careful and consistent.
 - A. It is an excellent reminder to make sure new GRs understand the principles of anonymity at the Area level. On page 92 of the Service Manual we read: "Members use their full names within the fellowship when they wish. The degree of anonymity a member chooses (first name, pseudonym, or full name) is not subject to criticism. Each member has the right to decide." Candidates were aware that their last names would be used at the election. In service at the Area level it is necessary to use your last name. The only reason last names, email addresses and phone numbers were removed from the resumes is because they were posted on the website. Copies that were brought to the Assembly were printed from the website. On page 91 of the Service Manual it states: "On any Web site accessible to the public, whether an Al-Anon site or not, full names, phone numbers, or other identifying information are not posted, If they are identified as belonging to an Al-Anon/Alateen member." Also on page 93 it states: "In Al-Anon/Alateen service positions (Group Representatives, District Representatives, Coordinators, World Service Conference members, etc.), it is practical to use full names and addresses to facilitate communication."

14. Q. How and why do we reimburse over \$10,000 in mileage reimbursement a year?

A. According to our SCWS treasurer: It was voted by the Assembly in November 2006 here are details:

We have GRs and DRs that travel over 250 miles to attend the Area Assembly, Committee Meetings. The GR's meeting reimburses for the first 100 miles and

the Assembly reimburses for the remaining mileage. The Board members are also reimbursed for mileage. We are one of the few Areas that reimburse for

the mileage. In most Areas the Groups are responsible for the entire reimbursement including at times air fare and hotels.

15. Q. Why is there a line for giving \$ to the Intergroup--from SCWS to Intergroups? Why are we not sending that money to World Service in Virginia Beach?

A. Here is our SCWS Treasurer's answer to this question:

SCWS has received \$1,339.19 in contributions from Districts/Intergroups through October. The contributions this year so far are from various Districts and Intergroups throughout Southern California. The \$1,339.19 we received comes from contributions "to" SCWS and not "from" SCWS.

16. Q. Is our treasurer bonded?

A. The Treasurer is not bonded, however based on the Area's past experience we have a series of checks and balances in place for the past three years. All Area Officers and the Immediate Past Delegate receive a full financial report each month. Reports are made quarterly to the AWSC (Area World Service Committee) and semi-annually to the Assembly. An audit of the SCWS treasurer's books is made annually by two outside individuals. This audit is then signed and given to the Area Chair and read at the February SCWS Committee Meeting. This is a current topic of discussion in an online arena among the current and past delegates from all Areas that are represented at the World Service Conference (WSC).

17. Q. My Group is very large (80-100 members per meeting.) We have a Group Conscience roughly once a quarter or as needed. They seem to go very long and cause angst. Is it recommended to have a quarterly business meeting where concerns can be addressed or should Group Consciences be called as they are needed? We also had a second question about Group business meetings wanting to know how a Group that hadn't had a business meeting in four years could start having them again.

A. On page 51 of the Service Manual a section begins on "Group Business." There are subsections on Group Business Meetings, Group Conscience, Group Inventory and Group Problems and Solutions. On page 52 we read: "Groups are within their autonomy to determine how to conduct their group business and how to reach a group conscience. Some groups schedule business meetings on a regular basis and others hold them as needed. Business meetings can be held before, after, or during the group meeting." Pages 51-59 will tell your Group everything you need to know about the business of running your Group. Please attend the Sharing of Service Workshop on January 17 where you can attend the workshop on using KBDM (Knowledge-Based Decision Making) and how to reach an informed group conscience. It could be something to bring back to your Group!

18. Q. (Translated from Spanish.) Can a Group's Group Representative attend a District meeting that is not the District within which the Group is located? Can the Group have a Group Conscience and decide to join a different District? Could they talk to the Delegate about moving to a different District? Could another District accept a Group that is not located within the geographical boundaries of its District?

A. Interestingly, even though this question was submitted in Spanish, the question does not ask just about Spanishspeaking Groups. However, let's look at Spanish-speaking groups first. A Spanish-speaking Group in any part of California South (SCWS) has two options: They can join District 64, which is the District of Spanish-speaking meetings which covers all of Southern California, or they can join the geographical District in which their Group is located. They may not join another District in which they are not located. The rule of thumb is simpler for Englishspeaking meetings: They belong to the District in which their Group is located.

19. Q. Can you please remind Board members, as well as those making reports at Assemblies, not to talk so fast, to facilitate the full translation for the Spanish-speaking members?

A. This is an excellent suggestion and we will remind all speakers at upcoming Assemblies and the Sharing of Service event on January 17, 2015.

20. Q. What is the process to create a Thought Force on moving to gender-neutral language in the Service Manual and other Al-Anon literature?

A. Since this is a question of changing Conference Approved Literature, it would have to be taken up with the World Service Conference. It would certainly be worth sharing your thoughts on this subject with our SCWS Delegate. Perhaps she could discuss the subject with other Delegates at the World Service Conference. The procedure for creating Conference Approved Literature is outlined on pages 102-108 of the Service Manual. It's an elaborate process and the changes you are suggesting could not happen overnight.

21. Q. We had two questions about social media and Al-Anon. One member asked if we can give our full name on You Tube on a video with an Al-Anon theme. Another member asked if we can discuss our Al-Anon membership on Facebook or if this violates our principles and traditions.

Questions about anonymity and the Internet are considered on page 116 of the Service Manual. We read: "Blogs, profiles, social networks, or other forms of social media are appropriate for public outreach. Members maintain the principle of anonymity and do not appear to speak for Al-Anon as a whole. They avoid actions, behaviors, or commentary that could draw Al-Anon into public controversy or harm Al-Anon's name and public outreach message." Under a section called "The Internet" we read: "Al-Anon members guard with care their own and others' anonymity." On page 91 of the Service Manual under the subject of anonymity, members are advised: "On any web site accessible to the public, whether an Al-Anon site or not, full names, phone numbers, or other identifying information are not posted, if they are identified as belonging to an Al-Anon/Alateen member." Facebook and YouTube are web sites so they would come under this requirement. Finally, on page 91 it states: "It is Al-Anon/Alateen policy to interpret Tradition Eleven to include the Internet as well as all forms of evolving public media."

22. Q. Why can't we have all of our literature available as E books? Many of our members travel and would love to take our meditation books along; also we'd have them wherever we go. I would still buy hardcover books as my books have writing all over them!

According to the last World Service Conference Report, almost three-quarters of AFG, Inc.'s revenue comes from the sale of Conference Approved Literature. In the same way, most of our Al-Anon Information Service offices (AIS/Intergroups) support themselves through the sale of literature to the groups in their local areas. Group contributions only account for a small percentage of the revenue for both WSO and local Intergroups. The transition from print to electronic formats has been incredibly disruptive in the book, newspaper and magazine publishing business and all of those industries have seen declines in revenue as they migrate from the printed to the electronic word. Therefore, AFG, Inc. must take its time in transitioning from print to electronically and the Service Manual is also available on the Al-Anon/Alateen member web site. Al-Anon recognizes its members' appetite for electronic books and is addressing this transition carefully.

23. Q. How can new GRs work on Thought Forces or Task Forces?


If a new GR hears at an Assembly of a Thought Force or Task Force that is being organized, he or she can talk to the Chairperson of that Force or to the Delegate or Area Chairperson to see if they might be able to participate on that Force. Likewise, if one of the SCWS Board coordinators is working in an area that interests you—for example, public outreach to professionals or literature—you could approach that Coordinator and offer to help him or her with the various projects they are involved in. There are countless ways to get involved in service at the Area level. Thank you for your interest!

24. Q. We had two comments in the Ask-It Basket that don't require answers. However, we wanted to share these comments. First, a member asked if in putting together the agenda for Assemblies, could we put Thought Force and Task Force reports ahead of Coordinator, Liaison and District reports? Our recently elected Area Chair can certainly take a look at this.

The second comment was in response to our earlier discussion about Districts sending DRs to the Al-Anon Worldwide Convention in Vancouver in 2013. This GR said that their District did not cover expenses to send their DR because the Convention was recovery-based. The Al-Anon International Convention did have an entire day dedicated to workshops and was not totally recovery based. Districts are within their autonomy to send their District Rep to service oriented workshops or conventions. This is of course as long as the group conscience of the district warrants that vote.

It's amazing to realize that this is my last ASSEMBLY as AAPP. So many things have happened in this last three years. On a personal note, when I started this position I was single and a stay at home mom. Since then I've gotten married and gone back to work full time. So rather than leisurely work on Alateen records during the day, I've been working late into the night trying to get all the records processed. This has been especially difficult during the recertification of all Area AMIAS's. As a result of that, I initiated a trial run of having six assistants to help process the records by splitting the district up into 6 groups. That has not really worked as the extra work for the AAPP negated the benefits. So it is my suggestion that for the next panel we appoint an AAPP AND an assistant or two. That way the work can be distributed on an ongoing basis, and more than one person will know the position.

During this panel we approved the Area Alateen Safety and Behavioral Requirements which initiated the requirement of an annual workshop for AMIAS's to be recertified. We also approved the amended Area Alateen Safety and Behavioral Requirements (unanimously or almost unanimously) which required new AMIAS's to attend a certification training. There have certainly been some growing pains with the new requirements. After each recertification, we have lost a number of AMIAS's. However, in the course of a year our numbers increased back to, or greater, than those we lost.

Another area we have been working on is background checks. Currently we are using a company called Trak 1. Costs range anywhere from \$17 to \$50 depending on what area the individual is from and whether or not they provided a social security number. We are moving in the direction of using LIVESCAN which uses electronic fingerprinting. The information gathered and the recommendation to move forward with LIVESCAN will be passed on to the next panel. And finally I would just like to say that as always being of service to Al-Anon and Alateen keeps my program alive. I am extremely grateful that I was given this opportunity to grow. Thank you.

11/15/2014 Assembly report - Institutions

August 24, the other two Public Outreach Coordinators, Richard R. and Sandy P. and myself, with Jayme's help, presented WSO's four modules of Al-Anon Outreach to Treatment Facilities at Hoag Hospital in Irvine. The purpose was to help World Service with feedback on the modules they had prepared. We had a good turnout of members who attended and provided very honest and direct feedback to WSO. If you are interested in seeing the modules, they are online on WSO's website. The modules suggest an organized approach to reaching out to Institutions and Treatment Facilities that may provide a very organized framework for a committee interested in organizing Institutions service. Having done the Institutions commitment for the area for three years now, and facing difficulties coordinating with Intergroups and Districts, I think the idea of approaching service with a committee comprised of District and Intergroup representatives might help prevent duplication of efforts and create better opportunities for volunteers. On the other hand, as much of the feedback noted, too much organization and evaluation could get in the way of just getting out there and doing service. Based on the feedback from the Southern California attendees, which was quite mixed, I would say, take what you like and leave the rest.

In California, we have most of the population in Southern California and most of the prison population in Northern California. Gratefully, Northern California World Service has been very persistent and has started Al-Anon meetings in several of the prisons in Northern California. I reported in my August Committee report about helping an inmate transferred to Ironwood State Prison in Blythe with materials to start a meeting in the prison.

Since then, I heard from David B., the Institutions Coordinator in Northern California, that two Al-Anon members from Solano State Prison in Vacaville are now at a halfway house in Los Angeles in the MacArthur park area in Los Angeles and wanted to start an Al-Anon meeting at the halfway house. The residents are restricted from going to outside meetings unless they have a group all interested in going together. Therefore, they wanted to introduce Al-Anon to their fellow residents. Northern California World Service sent a box of literature and District 27 in Southern California provided a service manual, multiple copies of Al-Anon Alateen Groups at Work and newcomer packets for the members. That meeting is now on-going and has a good group of new members. Yvonne de G., the incoming delegate from NCWS and David B. visited and were speakers at the meeting. Unfortunately, I was out of town then and could not join them.

With the holiday season starting and many families seriously affected by alcoholism at this time of year, it is an opportunity to reach out at a time of trouble. I have brought boxes of our outreach tool, Al-Anon Faces Alcoholism in English and Spanish. Please take them and distribute them where they can be of help during the holiday period. County Jail and Police and Sheriff station waiting rooms (although LAPD does not allow literature in waiting rooms). Hospital and Mental Health facilities waiting rooms. Domestic Violence programs, Treatment Programs with family components, religious facilities, therapists, judges and MDs you may know. Wherever families in crisis may go for help.

This service has provided an inspiring opportunity to practice Step Twelve and "carry our message to others". Please consider putting in a resume to volunteer for this position or one of the other area coordinator positions before December 31. Your ideas and energy can make a difference to those still suffering. Remember whatever helped get you here. You can carry that forward.

When completing the Information form, please make sure to add your **full name and address including your zip code**. This information is very important, in that the database can only assign you to one meeting as a Group Representative. I have had to spend many hours making phone calls and sending emails just to find out the Group Representative full name and address.

Please make sure that your Current Mailing Address (CMA) for your meeting is updated. The CMA receives all mail from WSO as well as the "Forum".

Report to Southern California Area Assembly, November 15, 2014

Because a number of meetings are being asked to provide proof of insurance to churches and other facilities at which they meet---or want to meet---the Intergroup Board has started investigating the possibility that there might be a way to help groups get coverage. The study is just in preliminary stages and is expected to take some time.

The Intergroup office has started taking online literature orders that can be paid for and picked up during the early part of Intergroup meetings. The idea is to accommodate members who cannot get to the office during daytime business hours.

As requested by the Area Records Coordinator, the Intergroup office staff is working with both new meetings and established ones to ensure that all groups become registered with the Area and with the World Service Office.

Districts within the Intergroup service area continue to be very involved in public outreach. District 63 is working with the WSO to develop some posters that will be distributed initially to courts. Posters will include both WSO and Orange County Intergroup contact information, as will literature packets that the District will distribute in coming months. District 60 has an ongoing program of distributing information with WSO and District contact information to community organizations and professionals who come in contact with people who may need Al-Anon. And at District 57 meetings, GRs and AGRs prepare literature packets that they take back to their meetings for members to distribute in the community.

District 57 has made a purchase that will help it reduce the cost of duplicating material for members: a computer printer. The District found that even with the cost of ink cartridges and paper it is cheaper not only to run multiple copies of an original document off a computer printer, but also to duplicate material the District does not originate by scanning and printing it on a printer. The District is now researching a sound system to be used at their events. The process used to research and purchase both items is a good example of Knowledge Based Decision Making in action. In addition, District 57 continues to seek out and distribute packets of CAL to numerous locations.
