

Let me start by apologizing for the absence of my report from the last Bulletin. At my very, very best, I do this service, as I do my entire life; imperfectly.

That being said, we're well into our preparations for the Northern part of Southern California World Service's SOS (Sharing of Service). The Speaker will be Helen W. of Atascadero. Helen has been in Al-Anon since before it was called Al-Anon. When Helen came into program, I believe it was still called "Non Alcoholics Anonymous". She's a wonderful speaker, and we're lucky to have her.

The Forum Challenge is going forward. You will recall that the extremely dignified members of the SCWS Board have promised to put on a musical show for the district that can bring in the most Forum subscriptions within the year.

It is early days yet, but the first reports I have from district are that 57 new subscriptions have come in as a result of the drive. District 33 has the most of all the districts, with 25 new subscriptions. We had a drive about 15 years ago, and we brought in 907 new subscriptions as a result of that drive, so we do have a way to go to match that. This isn't over until May of 2010, so there is plenty of time.

I would encourage all the DRs to get your numbers together for the November Assembly.

It has come to my attention that the primarily Spanish speaking Districts are at a bit of a disadvantage in this, because the Forum isn't available in Spanish. However, they have informed me that there is a Spanish language periodical called "En Accion". En Accion is widely read, but also costs significantly less than the Forum. This information caused quite a conundrum at the Committee meeting. After consultation with the Board members who, after all, are the ones whose dignity is one the line in the show that will cap this drive, I made an executive decision. (No, not a group conscience. Remember the Third Concept; "The right of decision makes effective leadership possible.")

That decision was; The Board will put on two performances: one for the District that brings in the most Forum subscriptions, another for the District that brings in the most subscriptions of any other Al-Anon periodical.

Please remember; the deadline for this two-pronged drive is the May Assembly, 2010.

I look forward to seeing as many as possible of you at the Northern SOS, on Saturday, October 24, at St. John's Church, 959 Valley Road, in the beautiful town of Arroyo Grande.

We could compile a series of questions on what DRs and GRs think and feedback on they want at our meetings and how they rate our meetings. (note: this is not a new idea, Northern California uses an evaluation sheet at their service meetings.)

I am looking forward to the results of today's meeting and the topics that the entire Committee decides to have discussed at the next Assembly.

Welcome to all new DRs and I hope that you were able to attend the orientation today prior to today's meeting. Hester and I started these orientations several years ago and have found them to be "sound and wise."

Once again, as I did at the Assembly Meeting in May, we'll see how all of you remember the "Rules". We now have 11 "Rules" and I would like to have11 DRs come up and we will quiz the rest of the Committee. I know we enjoy (or, should I say I enjoy) doing this and they do clarify our participation in our service meetings. If you

Ask It Basket

- Q) It says in the Service Manual that a GR should have 2 years in Al-Anon. Is this just a suggestion or can somebody with less time hold this position? Also, can they hold a position on the District Board like Treasurer or Secretary?
- A) The Service Manual does not specify any time requirement. It does say that the GR should have a basic knowledge of Al-Anon and Alateen Traditions and Concepts of Service and how they work. P. 44, 62, 79, 141-143.
- Q) We are having an Alathon. We will be providing child care. An Adult will be in this room. If a teenager/Alateen member wants to help is this okay without.an Alateen Sponsor present?
- A) p.35 When there are no certified Al-Anon members to be of service to the Alateen group, the Alateens should join the Al-Anon meeting.
 - Q) Why is Praasa considered an outside event?
 - A)PRAASA is in no way funded by SCWS.
 - The area covered by PRAASA is different than the area covered by SCWS.
 - The only events that are SCWS events are events with the same geographic area.
- *Q)* Does the Service Manual specifically address the issue of non Al-Anon celebrations at group meetings?
- A) The Service Manual does not specifically address this issue, but Tradition 5, 6, 10 would all seem to apply. Tradition 5 suggests that we have but one purpose, to help families of alcoholics by practicing the twelve steps. Tradition 6 says; "...Family Groups ought never endorse, finance or lend our name to any outside enterprise..." Tradition 10 says that we have no opinion on outside issues.
 - O) Can we attract members for Al-Anon or AA meetings? How?
- A) The Service Manual defines attraction as "to draw by other than physical influence; to invite; to draw to; to cause to approach. It defines promotion as; "to push forward; to further advance, as in a business venture (implies "hard sell," advancement for profit)

It goes on to say; "Al-Anon is attracting when it tells people why we are, what we are, what we do and how; we let them know that we are available if and when help is needed."

Attraction to an AA meeting is best left to members of AA.

- Q) Can Professionals or students attend Alateen meetings for study? They are not certified.
- A) p.37 All Alateen group meetings are closed, so, no.
- Q) What does an Alateen Sponsor do if a teen says they are suicidal? Should it be reported? To whom?
- A) This led to a lengthy and spirited discussion at which several options were discussed. The possibility of reporting the possibly suicidal teen was certainly put forward, and there were pros and cons given on that option. The pros centered around the idea that the teen would be likely to receive the help they need; the cons were that it would likely erode he trust that the teens need to have that what they say in the meeting remains confidential.

The possibility of a one-to-one conversation at which the teen is encouraged to seek help was also suggested, as were larger discussion in which sponsors and group members address their concerns with that teen.

There were no ultimate conclusions reached, but the need for the sponsor to reach out to others in the program for experience, strength and hope on the subject was mentioned.

Treasurer's Report

Welcome to all the district representatives that have come to the August Committee Meeting. There are mileage reimbursement forms and check request forms on the side counter. Also, there are group contribution forms, please take a number of these forms back to your districts for distribution to your group representatives. It makes processing the group contributions much easier if the group treasurer's submit their checks with the contribution form. Group treasurer's should be shown what the correct group identification number is and not still using the old Southern California World Service group identification numbers. The group identification numbers are being printed above the address portion on the back of the Bulletin.

District and group treasurer's should be reminded that all checks need to be made out to SCWS or Southern California World Service. Checks should not include any other name or payee such as treasurer, a specific name or Al-Anon. Simply just SCWS is the best. Please do not send checks to me for anything but Southern California World Service group contributions. Any and all other checks will either be forwarded to World Service Office in Virginia Beach or one of the service offices or will be returned to the sender, depending on who the check is made to. Checks for donations for other areas of service, such as Alateen will also be returned to the sender. Southern California World Service is a separate entity from SCAC and does not support SCAC financially. For those meetings that I receive checks for and cannot easily identify because the group has not registered with Southern California World Service or has provided the incorrect group identification number such as the old SCWS numbers or has not provided enough information in identifying the group, a letter will be sent to the maker of the check and additional information is requested. This may delay the processing of that particular's groups contribution. Only two requests will be made for the information before the check is dumped into the Unknown Meeting listing on the group contribution report.

If anyone is interested in being of service, I could always use some help in opening envelopes and sorting checks. Being of service in Al-Anon does not mean that we have to do things alone anymore. For anyone that is interested, I do live in the Santa Clarita Valley and we would be meeting at my home.

My sponsor and I were having a discussion about giving to the 7th tradition. She reminded me that it has been suggested that when I give my donation to a meeting I give the most to my home group in order to better support the group's efforts in providing funds for all the expenses of my meeting. To the other meetings that I attend during the week, I give the standard amount in the basket. In Southern California we strongly believe that being of service should not be at the expense of the individual member. So to remind everyone, the 7th tradition that a district representative or a group representative submits at either an Assembly or a Committee Meeting should be reimbursed by your meeting or your district appropriately. The same is true for any other expenses like mileage and/or food donation for hosting the Assemblies or Committee Meetings, your group and/or district should be reimbursing you.

So far I have received from District 45, District 24 and District 9 their contact and donation information. I am still looking for other districts to submit their information so that I can have a complete list of to whom and where to send contributions for each district. With this information I hope to create a generic group treasurer's reference sheet and from there a generic and one complete form for submission of group contributions to the various service arms for each meeting. Please submit your district contribution information to me at your earliest convenience with this information so that I can work more on this project.

For the second quarter of 2009, which are the months of April, May and June the overall profit was two hundred fifteen dollars and thirty-seven cents (\$215.37). Please see the Profit and Loss report in the Bulletin for complete details on the income and expenses for the 2nd quarter of 2009. Compared to last year for the same time period, we are ahead in that last year there was a loss of seven hundred four dollars and sixty cents (-\$704.60). You will also find in the Bulletin the Budget vs. the Actual Year to date. At the November Assembly, I will be presenting the Budget for 2010. If anyone has any sugges-

tions in regards to the next years budget feel free to contact me. Thank you to all the groups that submitted contributions during the second quarter. Southern California World Service is grateful for them and the profit and loss reports are detailed information on what those contributions were used for.

The co-ordinator's expenses for the quarter totaled three thousand, five hundred eighty-four dollars and ninety-seven cents (\$3,584.97), the officer's expenses totaled four thousand, four hundred six dollars and fifty nine cents (\$4,406.59) and all other Assembly and Committee members had a total expense of nine hundred ninety-three dollars and thirty-seven cents (\$993.37). To date there are still one hundred and two dollars and seventy-five cents (\$102.75) in checks from 2008 that have not been cashed. Before, clearing out these checks I am attempting to research what the checks were for and weather they need replacing or voiding. So far I have cleared a total of two hundred eighty-five dollars and fifteen cents (\$285.15) from checks that have not cleared from prior years.

The current balances as of July 31, 2009 are as follows:

- A. The operating account had a beginning balance of \$10,751.80. There were fifteen checks that cleared on the July bank statement for a total of \$2,439.74 and five deposits totaling \$7,9782.94 from the same bank statement, leaving a bank statement cleared balance of \$16,295.00. There are an additional fifteen checks that have not cleared the bank statement for a total of \$2,439.74 and one bank deposit made on July 31, 2009 for a total of \$595.31. Leaving a register balance of \$12,062.14 as of July 31, 2009.
- B. For the CD account ending in 00624, the beginning balance for the period ending June 30, 2009 was \$5,728.71. The interest earned on this account for July was \$13.20, leaving a register balance of \$5,741.91 for the period ending July 31, 2009.
- C. For the CD account ending in 00560, the beginning balance for the period ending June 30, 2009 was \$13,633.15. The interest earned on this account for July was \$14.36, leaving a register balance of \$13,647.51 for the period ending July 31, 2009.
- D. For the CD account ending in 01222, the beginning balance for the period ending June 30, 2009 was \$5,771.75. The interest earned on this account for July was \$12.12, leaving a register balance of \$5,783.87 for the period ending July 31, 2009.
- E. Total of all the bank balances as of July 31, 2009 is \$37,235.43. After our prudent reserve balance of \$25,000.00 the total amount of liquid funds is \$12,235.43.

As of August 14, 2009, we have 89 fully qualified and certified meetings in our area and 5 either pending or inactive. We have 543 certified sponsors.

I invite you to contact me to set up dates for sponsor workshops. I know it is hard for us to get together here so I have been arranging local workshops. We had one on June 20 in San Marcos and there were 16 attendees. We had one in North Hollywood in July18th and had 25 attendees. There is a sharing from a California Alateen in the issue. Please encourage your sponsors to subscreibe to this useful publication. It is appropriate for both Alateen and young Alateen.

It is critical to register your meeting and to update WSO with changes in information-date, time, location. WSO uses this info to direct newcomers to your meeting. It is so important to keep this information current so a newcomer doesn't miss a meeting by going to the wrong place, at the wrong time, driving miles to get to a meeting that has changed its day, time or meeting place. There are still thousands of kids out there affected by the disease who need our help. Let's make it easier for them to find us! Please check with each meeting in your district to make sure of its registration status and the certification of its sponsors.

There is no further information about the Alateen chat room but I heard from the Group Services coordinators recently and WSO is working hard to get it up and running.
