I also have been very busy with "Delegate work" which includes serving on the Conference Thought Force titled, "How can we support the Areas in dealing with groups whose activities fail to consider Al-Anon and Alateen as a whole." The members of this Thought Force have continued to have discussions and conference calls where we have brainstormed, suggested strategies, pros and cons and have refined the question, taken out any unnecessary language and our chairperson has prepared a presentation to go before the Board of Trustees. We will continue to work on this until we are satisfied there is no more to do. This is using the full Knowledge Based Decision Making (KBDM) process, not just voting procedure.

If you are planning to or are even thinking about going, see me re the rates and all info. The participants will be all Past and Current Delegates from our Southwest Region. SWRDM is to prepare the new delegates in our region for the World Service Conference and because of this, the regional meeting is aligned somewhat with how the conference is setup and

Alateen Sponsor Coordinator

As of August 20, 2009, we have 98 fully qualified and certified meetings in our area and 1 pending. We have 671 certified sponsors. Lists of each district's sponsors are in your district file along with a copy of the AMIAS form to be used for recertification, a copy of the Registration/Change form, GR3, and instructions for filling out the form. The packet for certification of new sponsors can be downloaded from our website: <http://scws-al-anon.org>. Both English and Spanish translations are there.

Also included in your file is a copy of GR34, Alateen Safety Guidelines. This is a comprehensive discussion of the responsibilities of Alateens, Sponsors, Al-Anon members, the Area and WSO toward the Alateen program. In addition is a discussion of the legal and traditional responsibilities we need to consider as sponsors and supporters of Alateen. The guideline usually includes medical release and legal release forms but in the interest of the cost of copying, I left them out. When you order the form or download it from the website, it will include these release forms. You can download any of the Guidelines from the WSO website www.al-anon.org

On September 25, there will be an Alateen Sponsor training in Los Angeles put on by District 64. Flyers have been sent to all of you who have email. (did 64 bring some flyers?) The meeting will be bilingual as we have the translation equipment available. I don't speak much Spanish but we will have Spanish literature and guidelines. WSO is interested in how this works out so I hope we have a good turnout. Anita Schettini is in charge of the meeting (Is Anita here?)

We have a chat room but a time and day have not been set for the meeting. Gerry and Irv from District 12 have volunteered to sponsor the meeting but summer vacations have interrupted the process so we should have a meeting set up soon. When that happens, we will advise the process for Alateens to register to attend.
