

### Officer's Reports

### Delegate

This has been such a great time in my life--the honor of serving and representing you as your Delegate for the 2009-2011 Panel 49.

I have really appreciated the fact that we all hold in our hands the future of the Al-Anon Family Groups with the responsibility to see that our precious program is not damaged, diluted or diminished; that just as the Board of Trustees has the mission of seeing that Al-Anon will survive long into the future and their primary function is to assure that the means for this to happen will be there, that is also our responsibility. We will be adapting to new ways of communicating with each other; new technology, always advancing, will be used to connect distant meetings with larger concentrations of membership; new ideas and the visions of our purpose will fly in ways our founding members never imagined.

Those who choose service beyond the group level, will find themselves in such a world. And just as the members of the Board of Trustees are searching for vital members who possess not only willingness, but experiences, talents, skills and abilities to fill board positions, so we, too, will be asking more of our Trusted Servants. This is an exciting time for all of us who choose service. As the world changes, so do we.

I never expected to participate in ecommunities, lightning-fast communication and the challenges of searching for the best possible avenue for bringing Al-Anon into this new age as quickly as possible, while watching out for and protecting our 36 Legacies (our Steps, Traditions and Concepts of Service.) The gift I have been given is to have been an active part of just that as your Delegate. During the 3 Conferences I attended, I participated in the creation of a book which tells of the creation of our Service, took steps to protect the Alateen Traditions from changes by a Charter revision which gives the same status as the Steps, Traditions and Concepts of Service. I participated in the revision of the Policy section of our Service Manual where the policies relative to Alateen were assembled in one place. I took part in the Thought Force that looked into the needs of Areas where some groups do not

follow the Traditions or Al-Anon principles, where readings of material which has not been approved by the Conference is part of a meeting, where individual members of Al-Anon have found themselves elevated to a false status of authority and who use the program for personal and/or financial gain for example. And I have been a part of the vote that ended the trial period of ownership of the World Service Office, and affirmed the continued ownership of the beautiful permanent home of Al-Anon Family Groups, Inc.

It has all changed the person who I am.

Some information since we last met: The new Chairman of the Board of Trustees, Karen R. (our SW Regional Trustee) has sent out the quarterly letter to Conference Members. In it, she shares the work and progress of the Board. Highlights include:

Filling Board positions--there will be 4 Regional Trustee (RT) and 4 Trustee at Large (TAL) positions open. Using the new interactive resume form on the WSO website, applicants will have submitted their qualifications by Aug 15. (If you recall, at the May Assembly I talked about the TAL opening, asking anyone who was interested to see me for the resume form. No one did.) They are also in need of candidates to fill a three-year term on the Exec. Committee for Real Property Management (ECRPM).

Next year's Conference theme will be "Our Spiritual Journey--we get as we give"

A new Current Mailing Address (CMA) electronic newsletter was sent in July

Literature sales increased 17.9%, contributions rose 4.6%, and the Forum subscription income decreased .1%.

The Policy Committee is continuing to review draft language to the "Public Relations" section of the "Digest of Al-Anon and Alateen Policies." The 2010 World Service Conference suggested that wording to this section needed revision in light of emergence of new technology and local service arms that are producing "Visual Media" and "Printed Media."

Based on discussion of memorial contributions from the 2011 World Service Conference, the Policy Committee agreed to a Thought Force to explore the possibility of family member memorial contributions in light

of Tradition Five and "giving comfort to families of alcoholics" during times of bereavement.

The Policy Chairperson will appoint a Thought Force to further explore the "Do Not Refer" issue, to determine what the WSO should do when an Area and a group in that Area are in disagreement over whether the group is adhering to the Twelve Traditions. One proposal under consideration was for the WSO to create a "Do Not Refer" list so that operators on the toll-free meeting line would not refer newcomers to groups that Areas have determined are in violation of the Traditions. Delegates shared their experiences with this issue at the 2011 World Service Conference.

The Policy Committee approved a proposal by the Literature Committee to change the name of To the Mother and Father of an Alcoholic (P-16). The Literature Committee determined that this title could be interpreted as non-inclusive and limited to only members who belonged to families with both a mother and a father. Following the

cally and this process has been translated into Eng- Literature Committee's recommendation, the new name for P-16 will be: To Parents of Alcoholics.

> By consensus, the Policy Committee agreed to make available to members of the fellowship a document, "Procedure regarding collaboration with outside researchers." This document explains the internal policies that govern the World Service Office's interactions with researchers examining family recovery from the effects of alcoholism.

> The Policy Committee discussed the safety of baby-sitting services at meetings and agreed that wording about this is more appropriate in "Groups at Work" and so the idea was referred to Group Services.

are eligible to apply.

I have information and sharing sheets for the piece of literature (which was approved at the 2011 Conference) that has the working title of "Intimacy in Alcoholic Relationships." As our literature is written by members' sharings, many responses are needed. Please see Juan or me for more information.

I want to thank Districts 33, 42, 36,12, 17, 24 and 30 for inviting me to visit them. It has been great meeting members and having great conversations and lively Q and A sessions. I'm still looking for invites from Districts 6, 10, 27, 45, 51, 54, 63, 66 and 69 before my term ends in December.

There is an area of concern that I would like to address as an Intergroup and some districts have recently had a situation where funds that belong to these service arms, intended to provide services to our members and groups have been taken by treasurers. There is a misconception in the understanding of Warranty 4 of the Conference Charter relat-

ing to recourse when this unfortunately happens. Concept 12 states that the Warranties remind the CONFERENCE of its spiritual foundation. Warranty 4 says, "that no CONFERENCE action ever be personally punitive, or an incitement to public controversy;" (Caps are mine for clarity). This protects our fellowship from being governed by the Conference. The CONFERENCE may not take punitive actions. This can be a guide for our meetings as well. This does not refer to our service arms, however, many of which are non -profit (legal) organizations. Please read more on Warranty 4 beginning on page 213 of the current Service Manual. Page 39 in the Service Manual states: "Anonymity is a spiritual principle and cannot be used as a legal basis to shield criminal behavior, past or current. It is wise to remember that Al-Anon and Alateen meetings are not above the law." I spoke with Barbara O. from the World Service Office regarding the actions available to our service arms and it was reaffirmed that appropriate recourse could be taken. If all attempts to recover the funds fail, or arrangements for repayment are not kept, or because a crime (embezzlement) was committed, legal action may appropriate. This would not be personally punitive as the consequence would be the same if anyone embezzled money. It is asked that the name "Al-Anon" not be used and that individual members, as individuals, of a board or officers file the legal report.

One element of this process which was demonstrated by the Hispanic Intergroup when this happened very recently, was transparency and truth. When the theft was discovered, facts were

too much.

obtained, a meeting of the Officers was held, the treasurer was confronted and admitted her actions. A special

meeting of their board was held to tell the members what happened, and immediately afterward, a special meeting of the Intergroup Representatives was held where the matter was revealed and explained and *everyone* in attendance had the opportunity to ask questions, or have their voices heard.

We were given a very descriptive presentation report which sometimes took work over severa on the distinction and relationship between our spiritual program and the legal entities which serve ranged from 7-8 hours each. There were times

our fellowship at our TEAM event last January by members of the Board of Trustees. This helped many understand the function of the two entities-the Al-Anon groups and the service arms (legal entities) which provide necessary services to them.

One last thing: As we look forward to electing our next panel of officers, I want to again say how important it is for those eligible to stand for these positions to look inside to see what they can bring to the table. Willingness is key, however there are certain skills and other attributes which come into play here as we, like the Board of Trustees, would encourage qualified candidates. I'd like to share my experiences in serving in the Delegate position which was not covered in the job description previously published contained. Time commit*ment:* While not consistent, many weeks I put in 10 to 20 hours in related activities (fielding telephone calls, reading and responding to emails, visiting meetings and districts, working on special Area projects or Thought Force assignments, participating in Conference-related assignments and conference calls, reading lots and lots of material sent by WSO, etc.) Travel: Each year I arranged my own travel to attended a service training event, the Southwest Regional Delegates' Meeting (SWRDM), and the World Service Conference...at least 12 to 15 days of travel. Visiting meetings and districts requires, at times, long car trips. Conference preparation: It was imperative to arrive at the Conference prepared to work. This meant that I had to be familiar with background information, refreshed on continuing agenda items, ready with Thought/ Force assignments, issues of relevance to SCWS, and prepare for the Area

> Highlights session and the leadership workshops. The Conference days were long (some 9-12 hour days) with

preparation for the next day's session at the end of these long days. *Meetings:* As Delegate, I attended a minimum of 4 Board meetings devoting 4 -6 hours each. At each I was expected to present a report. I attended 2 Area Committee and 2 Area Assemblies which required report preparation. For one Assembly each year, I prepared the Delegate's report which sometimes took work over several days to develop. Time spent at these meetings ranged from 7-8 hours each. There were times

Legal responsibilities: As an elected officer of the non-profit organization of Southern California World Services of Al-Anon Family Groups, Inc. the Delegate is party to making legal decisions which effect the organization and its activities. As SCWS does not carry Directors and Officers insurance coverage, there is some legal exposure. *Attitude*: As Delegate, I had to learn that I was not in charge of anything, that I was to listen and report. It was imperative to realize that I needed to be impartial, keeping my opinion out of my reporting, staying factual only. As members of the Conference, Delegates are asked to support and effectively communicate the group conscience of the Conference, even if we were not in agreement with it. Willingness: I needed to be willing to do whatever was indicated without limitation, but willingness to admit when I was physically unable to do so, with the knowledge that I was but a servant of the fellowship which I love and to which I owe a debt of ultimate gratitude for returning my life to me.

What I wrote about in the paragraph above isn't intended to discourage anyone from aspiring to the Delegate position, but I wanted to be truthful about what this commitment entails over and above the specific duties listed. I've learned through this that it was my Higher Power's nudge that opened the door to this service for me, that it was the right time in my life to do this, and I have been forever changed by this experience.

### **Ask-It Basket Questions**

(All references to page numbers, refer to the 2010-2013 Al-Anon Alateen Service Manual.)

- Q: Are member contributions tax deductible?
- A: Page 110, Al-Anon Service Manual states, "contributions to AFG Headquarters Inc. may qualify as a charitable deduction, but the WSO makes no judgement as to the specific deductibility of a contribution by any member."
  - Q: Is it a "have to" to have a service sponsor?
- A: No, it is a personal choice, but many people who give service beyond the group level find a service sponsor helpful. Refer to page 47. For more information on service sponsorship read pamphlet in P-88.
  - Q: Are birthday contributions okay for a district to request?
  - A: Yes. See page 92.
  - Q:. Do employees at the WSO that answer questions respond using their name and position?
- A: Employees at WSO who respond using their name and position but do not serve in a policy-making position. See page 98.
  - A: All decisions do consider preserving the legacies and wishes of our founders.
  - Q: Are the Board of Trustees paid a salary?
- A: Trustees are not paid a salary. They are Al-Anon volunteers and are reimbursed for their expenses only.
  - Q: . Is the Forum going to continue to be printed?
  - A: The *Forum* magazine will continue as long as it is being supported by subscriptions.
  - Q: Where is information on Crosstalk to take back to our groups?
- A: There is no official policy or definition of "crosstalk". You can go online to WSO website under *Forum* magazine and do a search as there was an article a few years ago. This article represents an individual interpretation, and is not policy.
  - Q: What is an Intergroup liaison? Who are they liaisons to?
- A: A member (usually a Board member of an Intergroup) holds the position of Intergroup Liaison. They attend the Area Assembly and Committee meetings to make a report of their respective Intergroup's activities. More importantly, they bring information regarding Al-Anon as reported at these meetings back to the Intergroup so they have current and correct information.
- A: For questions on group conscience, see page 49 under group business, as well as the section on "Group Problems." Also refer to the Al-Anon website and download a free copy of the "Group Inventory" document.

### **Coordinator Reports**

### Alateen Sponsor

Greetings everyone. I am a very grateful member of the World Wide Fellowship of the Al-Anon Family Groups and I am also your Panel 49, SCWS Chairman for California South and your Acting Area Alateen Sponsor Coordinator.

I am privileged to serve the Area in this capacity until the end of the Panel. The Work Force has been presenting the draft of the Area Safety & Behavioral Requirements document throughout Southern California. We are scheduled with many districts, Intergroups and in some cases districts have combined to have the Work Force present the draft and the Questions and Answers.

We are eager to go wherever we are invited to provide details of the draft document. It is important that all Group Representatives come to the Assembly with an informed group conscience. We will be discussing the document as New Business at our November Assembly. The more we are informed the better it is in making a decision when voting.

I attended an Alateen Sponsor Workshop on Saturday, September 18 in Tarzana given by District 21. It was very well attended and the individuals were enthusiastic.

One question that comes up repeatedly is "what about certified Alateen Sponsors that are mandated reporters"? What should they do if they are in an Alateen Meeting and something is shared regarding child abuse? Please refer to the Alateen Safety Guidelines (G-34) which can be downloaded from the WSO website and also see below the last paragraph of the last page of G-34:

Taken from G-34 Alateen Safety Guidelines:

LEGAL AND TRADITIONAL RESPONSIBIL-ITY OF AL-ANON MEMBERS INVOLVED IN ALATEEN SERVICE, INCLUDING SPONSORS:

Al-Anon Members Involved in Alateen Service may become aware of instances of child abuse. A dilemma then arises on how

to deal with the problem. If in an effort to protect the Alateen member from further harm, an incident is reported, is the Tradition

of anonymity or confidentiality violated?

The first action is to seek legal advice regard-

ing area requirements and existing state/provincial laws. Child abuse laws relating

to mandatory disclosure usually refer to individuals performing in a professional capacity, and not as volunteers. It is advisable

that the laws in each state/province/country be investigated because they do vary from place to place. Where reporting is required,

there is no choice but to comply with the law. In most localities, an Alateen Sponsor is not legally required to report instances of

suspected child abuse. Yet, as a Sponsor, we may question what is truly right for the Alateen member in the long run. Sponsors

and Al-Anon Members Involved in Alateen Service that are required by law to report cases of suspected child abuse should let the

Alateens know, up front before sharing begins, that they will disclose incidents that are discussed at the meeting or event.

Sponsors and Al-Anon Members Involved in Alateen Service who feel a moral responsibility or are compelled by law to report

cases of suspected child abuse to the authorities should contact their area Alateen Coordinator, District Representative, or other

area designated trusted servant prior to reporting. It is important to reason things out through the area process before disclosure,

keeping in mind the Traditions and the Alateen member's anonymity.

Prior to reporting to the authorities, the Sponsor or Al-Anon Member Involved in Alateen Service should also discuss their

intentions with the Alateen member to avoid placing the member in danger and to maintain confidence and trust in the Sponsor/

Al-Anon Member Involved in Alateen Service and the Alateen program. It is important to follow the advice of your local legal

counsel in keeping the identity of the alleged abuser anonymous, since accusations of child abuse are defamatory and could lead

to claims of libel and slander. In order to keep the Alateen fellowship from public controversy, any reporting is done on a personal

basis rather than as an Alateen Sponsor or Al-Anon Member Involved in Alateen Service. I thank you for the opportunity and for the confidence to allow me to serve as your Area Chairman and also as the Acting Area Alateen Sponsor Coordinator.


Hard to believe this panel is coming to an end.... I will both miss this job and be glad I don't have to do it anymore.


