



Oh, my gosh! This is really happening!! I must really be the Delegate, because I'm getting the Delegate's mail. What an awesome honor you have given me and I will do my very best to be our representative with the thought of what is best for Al-Anon as a whole. What a wonderful 3 years we will all have, being a part of the world wide fellowship of Al-Anon and be witness to its growth, renewal, outreach and good works.

I have made travel and lodging arrangements for Virginia Beach, I've connected with my Conference Mentor, and I have been reading and studying everything coming in my mail. World Service Office (WSO) has an on-line Community group for Delegates and sends us reminders and news and communications and correspondences. My service sponsor gave me the assignment of writing a Mission Statement (which I'll share with you), and the assignment of really studying past Conference Summaries. The whole Conference experience, getting in a state of readiness (knowledge, history, arrangements, signing up for a committee and/or Task Force, even getting the wardrobe right [you know me, that's important also] only adds to the hugeness of this.

CONFERENCE THEME: "Embracing the Legacies: Our Spiritual Bridges to Expand the Future"

CONFERENCE DATES: April 19-23, 2009

CHOSEN AGENDA ITEM: We get an opportunity to vote to have topics added to the Conference agenda. I submitted "Division/Consolidation of Areas" as one as I know Mary (Immediate Past Delegate) has been working on this and will take more conference time to resolve. Since our Area has over 1,100 meetings and Northern California has over 900, this is going to be an important issue for two reasons: 1) More fair representation for meetings, and 2) Geographical logic. This will make more sense when we consider that some Areas (whole states) may have only 35-50 meetings total.

A special welcome to all the new District Rep-

resentatives and the new Alternate District Representatives that are attending their first committee meeting today. Welcome to all the continuing District Representatives and the Alternate District Representatives that here today too. What an honor it is for me to serve as your treasurer for the Southern California World Service Board.

For those of you that don't know me because I was unable to attend the Assembly in November, let me tell you a little bit about myself. I have been a member of Al-Anon for over 34 years. My first meeting was an Alateen, at a meeting in Glendale on Tuesday Night at what has now become the Windsor Club back in 1974. One of the first things I was taught in Al-Anon was to get in the car and be of service. My sponsor was the Alateen Coordinator for SCWS back then and I got to be of service with her by traveling all over Southern California and talking about Alateen at all kinds of different meetings from District Meetings to regular Al-Anon and AA meetings. At my meetings I have served as a group officer in all capacities and continue to do so. Being of service to Al-Anon and it's members is an important part of my program and allows me to attempt to give back what was so freely given to me. Not to mention the many benefits I get from being of service. My personal belief is that the 12 steps allow me to live within my skin, the 12 traditions allow me to live and love within my own family and the 12 concepts allow me to work and live within my community. It's because of these principles that I went from life in a maze to an amazing life. Currently, I am one of the Alateen sponsors at the Thursday Night Outsiders Alateen meeting in Valencia, I am one of the Alateen sponsors for the Santa Clarita Valley AA Convention with Al-Anon and Alateen participation, I am the District Representative for District 24 and the Alternate Group Representative for Friday Night 8:30PM Al-Anon Meeting at the Windsor Club. Professionally, I have been employed as a Bookkeeper for many years. My experience in bookkeeping has a wide range. Currently, I am the finance department for a small manufacturer in Valencia, CA. We make specialized products for the audio/video industry and have very little competition. We are a multi million dollar company and I am responsible for all the financial aspects of this company. I also have a number of personal clients that I keep books for from a sole owner con-

tractor to an individual who has financial difficulties. When I lived in Lake Havasu City, AZ I worked for an accounting office and handled a wide variety of clients from a home owners association, a dental office, a charter school and a number of retail business'. I have experience in all aspects of accounting including cost accounting and cash management.

It has been my understanding that we are all volunteers when we do service at any level and those that are of service attempt to do what they think is best and handle their commitment to the best of their ability. Thus it makes it hard for me to provide you all with a report on the 4th quarter year ending 2008 financials as presented to the Committee Meeting. The auditor has completed his report and will provide better details on the financials for last year. What I can tell you is that there is \$3,761.00 in prepaid rent for the year 2009 to the City of Fullerton for SCWS turn over meeting, 2 committee meetings and 2 assemblies in the November 2008 expenses. There is \$768.00 in prepaid rent for the storage unit used by SCWS in the December 2008 expenses. There is also about \$2,500.00 of Delegate's expenses reported in the December 2008 expenses. These are all necessary expenses but as they are for future events, they are not being reported in the correct month. SCWS has a contract with the City of Fullerton and in order to retain the necessary dates, payment was due to the City of Fullerton for the entire year of 2009. On the storage unit if a full year is prepaid, the 13th month is free, which is a \$60.00 cost savings to SCWS. For the delegate's expenses that have already been paid they are in relation to the delegate being able to attend the World Service Conference later this year. From the electronic data that I have received from the previous treasurer, it appears that the 4th quarter resulted in a loss of \$734.47. However, when the previously mentioned expenses are removed from the Profit and Loss statement, this brings the profit of SCWS for the 4th quarter to just over \$6,200.00. Again, the auditor will have further details on the financials for 2008.

The actual budget for 2008 has been accounted for. The proposed budget estimated that the income for 2008 would be \$38,850.00. The final total in income received for 2008 was \$47,858.17. The estimated total of expenses for 2008 was \$38,850.00 and the actual total of ex-

penses for 2008 was \$36,911.27. Leaving a surplus before the contribution to WSO at \$10,946.90. The full and final budget for 2008 will be printed in the Bulletin.

As for the current balances as of January 31, 2009:

The checking account which will now be referred to as the Operating Account had a beginning balance of \$13,115.00. There were 17 checks that were cleared on the bank statement for a total of \$ 3,791.29 and 2 deposits that were cleared on the bank statement for a total of \$ 2,654.00 leaving a bank statement cleared balance of \$11,977.71. There are an additional 8 checks that were written in January or before January that did not clear for a total of \$ 549.09 and one deposit made in made in January that did not clear the bank statement because it was made on January 31, 2009 for a total of \$1,768.92. Leaving a register balance of \$13,197.54

CD account ending 00624 had a beginning balance of \$5,652.24. The interest earned for January was \$13.02. Leaving a register and cleared balance of \$5,665.26.

CD account ending in 01222 had a beginning balance of \$5,701.49. The interest earned for January was \$11.97. Leaving a register and cleared balance of \$5,713.46

CD account ending in 00560 had a beginning balance of \$13,542.69. The interest earned for January was \$18.30. Leaving a register and cleared balance of \$13,560.99

The total interest earned in January on all accounts was \$43.29. The total group contributions received and deposited in January was \$1,768.92 and the total deposit made from SOS was \$2,654.00. For a total of \$4,466.21 in income for January. Total expenditures for January was \$2,074.99.

The SOS was held in January and what a great job Sandie and her committee did. The SOS made a profit of \$891.86. The total number of participants was 271 not including those that were part of the program. The total income from the SOS was \$2,654.00 and the total in expenditures for the SOS was \$1,762.14. From the November Assembly, there were 28 people that registered at the special rate of \$8.00 per person.

Thank you, once again, for allowing me to be of service to the Area. My hope is that I represent to you the most comprehensive and detailed fi-

nancials what SCWS does overall.

Our Membership Survey indicates that about

36% of Al-Anon and Alateen members attended their first meeting because of a professional referral. Counselors/therapists, clergy, mental health professionals, employee assistance programs, medical and judicial professionals, and others who work with the public are all in the position to identify and refer potential newcomers to Al-Anon and Alateen. Remember, outreach via the media also reaches professionals and lends credibility to our program.

We reach professionals in their places of work such as domestic violence agencies, medical facilities, health organizations, employee assistance programs, probation and parole offices, social work agencies, alcoholism clinics/treatment centers, churches and ministerial staff, federal, state, and local alcoholism agencies, government offices, law enforcement agencies, universities, public and private schools, and business and professional organizations.

My sources are Al-Anon Guidelines 38 and 29. I look forward to working with districts and Intergroups to make our fellowship known to professionals.

PI - Public Information

I'm very excited to take on the role of Public Information Coordinator.

We have an up-to-date list of District Representatives for Southern California World Service. The DRs will be the primary conduit for information about Public Service back to their GRs and their Groups.

I would like to e-mail the DRs every month or so and ask for success stories on public outreach. It is not necessary to have public relations training in order to spread the word about Al-Anon. Every member can become a PR expert for Al-Anon. I would like to use e-mail as a way of sharing successes that different districts and groups have had spreading the word about Al-Anon. For example, I know that there is a District which rented a billboard and put up a sign about Al-Anon.

We have a portable display which we can ship to a district or group for use at Public Health fairs. I know that District 27, my home district, is planning to participate in a community health fair this year. I need to get the display back from our past

public information coordinator. I will let you know when I have it. A couple of people have suggested that the word "Alcoholism" in the display may put some people off and make them reluctant to talk with a volunteer. They have suggested that we use the term "drinking problem" instead. I'll take a look once I have received the display.

Here are two examples of public outreach which I did this week. There is a talk show on KLSX radio on Sunday called "Parenting the Addict Child." I found out the host's email address and wrote to suggest that I would be willing to come on the show, using my first name only, or a pseudonym, to talk about Al-Anon and the parent-focused meetings in Los Angeles. I will let you know when I hear back from her.

I also have a friend who teaches at Loyola Marymount who has developed an award winning anti-drinking campaign for the students on campus. He and I are going to have lunch to see whether I might be able to talk to a group of students about Al-Anon.

All of us can engage in these kinds of activities. We don't have to designate certain people who we think are better with words than we are. We just have to spread the word about Al-Anon with all the enthusiasm we have for the program.

I would love to come to some District meetings and talk about public information. I'm also eager to work with my fellow coordinators who communicate with the Professional Community and with Institutions. We are all working to achieve the same goal—Public Outreach.

I inherited two boxes of pamphlets which I brought with me today. I hope you'll take these back to your District meetings and distribute this literature to your meetings.

The median age of Al-Anon members is 55 and 85 percent of the organization are women. Only 5% of our membership is under 35. We need to get the word out about the life-saving benefits of Al-Anon as well to potential Alateen members and younger adults. There are lots of exciting ways to do that: TV, radio, the internet, blogs, newsletters, speaking engagements. We can all carry the message to others who have not yet found Al-Anon.

Records

I was involved in a conference call with the World Service Office regarding submitting updates. When submitting an update it is asked whether the meeting is an open or closed meeting. An open meeting means that the meeting is open to anyone wishing to attend an Al-Anon meeting, while a closed meeting is for Al-Anon member's only. Also on the registration form if there is no information filled in for the "Current Mailing Address" (CMA) section the World Service Office will NOT register the meeting until a CMA is received.

If the meeting has mail returned it will be placed on a "no mail" list. The District Representatives will receive a list from the Record's Secretary at every Committee and Assembly meeting. They should carefully check to see if any of their meetings have been placed on the "no mail" list. If they have, the WSO will place them "inactive" for two years and then that meeting will no longer have an active WSO identification number and will have to reapply for a new number.

Regarding group applications for new meetings, or meetings changing their names, please see pages 33 and 78 of the Service Manual regarding naming your group. Groups will NOT be registered if the name of their group includes a church's name, or the name of something that is copyrighted...

In the case of groups that have multiple meetings, it is no longer possible for the WSO to register a group with more than 3 meetings. The group will have to have a group registration for each group of 3 meetings. Separate group number, separate GR's.

Ad Hoc Committee for Recommendations on the Continuance of Action Committees

Our SCWS service board has assigned some of us to this committee to look into different approaches in how to provide information to all of you through an alternate view of member participation at Assembly Meetings. We feel that it would be more effective to have some other kind of involvement in lieu of Action Committees so that more members are involved in the discussions. The following is a few suggestions we hope will encourage all members to share at our meetings.

We would like to ask all DRs today what "Hot Topics" they feel their GRs would like to discuss and interact with, have you (the DRs) give suggestions on topics today (i.e. Alateen, Service Manual, Concepts, Website, etc.) and how you would like to see these presented in a way that would attract more members to service, perhaps the presentation could be a skit, a game (Jeopardy, hangman, simple crossword puzzle) or a report with specific questions or ????. The SCWS Committee will decide today if we want to try this approach. If so, then choose which topics to discuss at the Assembly, for example, if we choose 4 topics the presenters could be 2 Coordinators and 2 DRs. We will ask that these topics be what you would like to see presented in May.

This new method of communication will be presented at the Assembly meeting in the time usually allocated for Action Committees. Our suggestion is to have 2 to 4 topics and that the participants take 3-5 minutes to present their topic. After the presentation, members will breakup into small groups to share in the discussion that interests them. All groups will meet for approximately one hour and then return to the main room for Old/New Business. The size of the individual groups will depend on the interest of members to specific topics.

The intent of this suggestion (Hot Topics) is to increase participation by all members without continuing with Action Committees.

PS: It should be noted the WSO does not interact with Action Committee Chairs as was the original intent. Chairs receive no communication from WSO.

ALL REFERENCES TO PAGES REFER TO THE 2004-2006 AL-ANON/ALATEEN SERVICE MANUAL UNLESS OTHERWISE NOTED.

Q #1. Is it breaking anonymity if “Al-Anon” is written on a check that is processed through the bank?

A #1. Pages 50 and 51 suggest that anonymity is a personal choice made by each and every member. If you are not comfortable putting a check through your bank, feel free to find some other way to contribute, or purchase literature. However, Al-Anon is not a secret society, we do not hide our very existence. So there is no shame in writing a check, or acknowledging our personal membership in this program. The Eleventh Tradition simply suggests that we “maintain personal anonymity at the level of press, radio, films and TV.” It says nothing about banks.

Q #2. Can “Double Winners” be members of service committees above the group level?

A #2. The footnote on page 44 says “Al-Anon and Alateen members who are also members of A.A. may not serve as GR or Alternate GR.” This question is addressed again on page 79, where it states that “Dual Members” are eligible to hold office within their Al-Anon or Alateen groups, and as Alateen Sponsors by virtue of their Al-anon membership. It goes on to say that Al-Anon/Alateen members who are also A.A. members do not hold office beyond the group level, as these positions could lead to membership in the World Service Conference. The WSC has made the decision not to seat Al-Anon/Alateen members who are also members of A.A.

Q #3 May a GR also serve as an Alternate Intergroup Rep?

A #3 Yes. Page 133.

Q #4 What is the average time for a service report?

A #4 There is no specific time suggested. Page

142 does suggest that the GR should be allowed “regular time” at group meetings. The amount of time allowed is certainly a matter for group autonomy, and should be decided by the group. If a report is overlong, and tends to monopolize the group’s precious time, any group or service entity is within its rights to decide by group conscience what the appropriate time allowance should be.

Q #5 May a group register in two districts?

A #5 No. In Area #4 we do have an overlay, in that District 64, our Spanish language district, covers the entire area. However, each group must decide whether it will register in District 64, or the geographical district in which it is located.

Q #6 Is it appropriate to exhibit “The Promises” at our meeting?

A #6 No. Page 92 clearly states; “To keep Al-Anon’s message in focus, it is suggested that only Al-Anon/Alateen Conference Approved Literature and Al-Anon/Alateen service tools be displayed, distributed and used at Al-Anon/Alateen meeting, conferences and conventions. These items reflect an informed group conscience.”

Q #7 I have been disturbed to see our group constantly contributing to Alateen. Is this a violation of their need to be self-sufficient?

A #7 Alateen is Al-Anon, it is not a separate program, therefore contributions by an Al-Anon group to support Alateen are within our Seventh Tradition of being self-supporting


