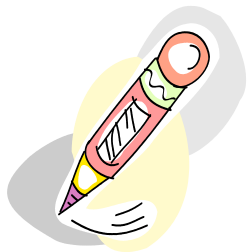

Treasurer's Report, November 21, 2009

What a pleasure it has been to serve as your area treasurer this year. Thank you all for allowing me to be of service. I would like to say a special thank you to the members of Glendale Friday Night 8:30 PM Group because they have been so helpful in helping fold and stuff envelopes with me. When I remember I bring with me the contribution receipts to the meeting and there are always willing volunteers to help prepare the envelopes for mailing. One of the great gifts of Al-Anon is learning that I don't have to do anything by myself. If anyone else is interested in being of service in this area of service, please do not hesitate to contact me at any time, I can always use the help.

Forms for reimbursement are on the side counters under the cabinets. Please be sure to use the correct form for the correct reimbursement. There is a special form for mileage and a separate form for other reimbursements related to any Assembly related costs for those that have been asked to provide some material, copy or other items. Please remember that in order to be reimbursed for mileage you must have traveled over two hundred miles round trip. SCWS has approved a mileage reimbursement of \$.40 a mile after the first 100 miles. As group representatives, you should be charging your meetings for reimbursement of mileage not coming from SCWS. District representatives should be getting their reimbursements from the district. In Southern California we truly believe it should not cost you to be of service to Al-Anon. The mentioned reimbursements from the various meetings that you represent as a group representative is also your donation for the 7th tradition basket at the assembly.

Also, on the counter are group contribution forms. These forms have been created in order to make the job of matching a groups contribution to the right group easier. There are a lot of forms and I would appreciate any assistance I can get in getting these forms out to the various group treasurers. The forms clearly let the treasurers know how to make out the checks and where to send them. They also ask for specific information from each of the treasurers about their meetings so that all I have to do is follow the form to be sure that I am crediting the right group without having to run extra reports, look at other reports or attempting to make a guess. The books are set up in QuickBooks and the format of the meeting list is by city and group name. In the data base for the meeting list I have the district information and group identification number as back up. Listing just your group identification number on the check without a contribution form slows down the process of that particular check. Listing the group name on the check causes a lot problems if I don't know what city the group is, i.e. a treasurer listed that the check was for a Tuesday 4th step study group in District 17. Guess what, there are four 4th step study meetings in District 17 and all of them on Tuesdays. There is no way of matching that check to a specific meeting and therefore the contribution was credited to the general unknown meeting. Using the old district number city and day combination of group identification numbers that SCWS used to use to identify groups does not really help me either as I really don't understand that system not to mention that a lot of that information is no longer part of the group records report. Bottom line, please have your treasurer's submit the group contribution form with their contributions.

It has also come to my attention that some of your meetings treasurer's are a little zealous in getting their checks processed. Please inform your treasurer's to allow at least 6 to 8 weeks for their checks to clear. If they are concerned about whether their check has been received by SCWS, they can always contact me for confirmation. It costs SCWS \$6.00 for every check that is returned for non payment no matter what the circumstance is. Not to mention that in today's economy banks are being more particular about returned checks and this could affect our customer status with our current financial institution. According to the by-laws of SCWS it is only required that a pick up of the post office box is done a minimum of two times a month. SCWS voted to have a permanent address and therefore the post office box was obtained a number of years ago. However, I live a distance from the where the post office is that houses the post office box and that particular post office closes the entire building down by 6:00 PM Monday through Friday and is currently only open till 1:00 PM on Saturdays. I do attempt to make a pick up more than two times a month but this is not always possible. Once the pick up is made there is a process of sorting out the envelopes for treasurer, records secretary and other members of the

board. It is for this reason that Lea, our Alateen coordinator has requested that all mail for Alateen be sent to her directly. The mail for other board members is then forwarded to that particular person. The mail for the treasurer is then sorted again for contributions, bills and reimbursement requests. The bills are handled first because we want to remain current with our current vendors. The reimbursement requests are handled second in order to get the funds disbursed to the requestor to prevent them from any hardships for being of service and lastly the largest of the mail is the contributions. As I have already explained there is a lengthy process of handling each contribution. There are about three hundred or so checks that I am processing through the system and each check takes some time to get processed. Once the checks from that pick up have been processed a deposit still has to be accounted and copied and gotten to the bank. I am in no way complaining but trying to let everyone know how it works and to please have some patience with the process and just a reminder that I am a volunteer here and still need to have a way of providing for my family, be an Alateen sponsor, attend Al-Anon meetings regularly and have a life. I love what I get to do for Al-Anon and Alateen and in no way would what to be anything but the best I can be for service but I am not perfect. Your understanding in this matter is greatly appreciated and I would also appreciate it if you could remind your treasurer's of this fact.

The contribution report is printed in the Bulletin each quarter. The 2nd quarter's report in the current Bulletin is really the master report and was the one that I accidentally sent to the Bulletin editor, I apologize for my error and promise to be a little more careful in the future. If anyone has any questions about their meetings contributions, please feel free to contact me at any time.

The budget for 2010 has been compiled and is being presented to the assembly for approval today. Budgets are guesstimates based on history, projections and planning. Everyone should have a copy of the actual costs history for conducting business for Southern California World Service from the years ending 2000 through 2006, a copy of the Preliminary Budget for 2010 which includes the history of actual costs for years ending 2007, 2008 and the year to date of October 2009. The history of the actual costs is for each of you to have a little history of what the actual expenditures for SCWS have been over the years.

The approved budget for 2007 was for a total of \$38,200.00 for both income and expense. The actual expenditures for 2007 was a total \$46,260.00 with an actual income amount of \$47,257.00. The budget accepted for 2008 was for a total \$38,850.00 and the actual expenses for 2008 were a total of \$36,832.40 and an income total of \$47,756.20. Please note that the actual numbers for 2007 and 2008 have been rounded off by the previous treasurer for simplified reporting. The major changes that I propose for the 2010 budget are as follows:

Line item 14 - Group Services A/C Chair - should be removed from the budget as this position is no longer a valid position on the current board.

Line item 18 - Membership Comm A/C Chair - should be removed from the budget as this position

For the third quarter of 2009, which are the months of July, August and September the overall profit was \$3,127.46. Please see the Profit and Loss report for complete details on the income and expenses for the 3rd quarter of 2009. With the Profit and Loss report for the 3rd quarter I have included the year to date totals up through the end of the 3rd quarter for your review. We are pretty much on budget for the year and as I start to prepare for the closing of 2009 I don't anticipate any additional large expenses. Thank you to all the groups that submitted contributions during the third quarter. Southern California World Service is grateful for them and the profit and loss report is the detailed information on what those contributions were used for.

The current balances as of October 31, 2009 are as follows:

A. The operating account had a beginning balance of \$14,544.95. There were twelve checks that cleared on the October bank statement for a total of \$4,028.15 and three deposits totaling \$4,039.37 from the same bank statement, leaving a bank statement cleared balance of \$14,556.17. There are an additional sixteen checks that have not cleared the current bank statement for a total of \$3,161.98 and one deposit made on October 31, 2009 for a total of \$2,713.44. Leaving a register balance of \$14,107.63 as of October 31, 2009.

B. For the CD account ending in 01222, the beginning balance for the period ending October 31, 2009 was \$5,799.11. The interest earned on this account for October was \$3.20, leaving a register balance of \$5,802.31 for the period ending October 31, 2009.

C. For the CD account ending in 00560, the beginning balance for the period ending October 31, 2009 was \$13,668.85. The interest earned on this account for October was \$8.71, leaving a register balance of \$13,677.56 for the period ending October 31, 2009.

D. For the CD account ending in 00624 the beginning balance for the period ending October 31, 2009 was \$5,767.97. The interest earned on this account for October was \$13.29, leaving a register balance of \$5,781.26.

E. The total of all bank balances as of October 31, 2009 is \$39,368.76. After our prudent reserve balance of \$25,000.00 the amount of liquid funds is \$14,368.76.

A final reminder that all reimbursement requests should be presented to me no later than 2:30 PM for disbursement today. Any reimbursement requests received after 2:30PM will be mailed to the requestor during the following week. This will allow me to participate and clean up in a timely manner.

Coordinator's Reports

Alateen Sponsors

As of August 14, 2009, we have 97 fully qualified and certified meetings in our area and 5 pending. We have 590 certified and pending sponsors.

On September 26th WSO held a conference call for AAPP's (Area Alateen Process Persons) and Area Alateen Coordinators.

We discussed the definition of an Area Alateen Process, its elements and their definitions, requirements and their definitions, construction of a process, and responsibility. (Who is responsible?)

Some specifics that were brought up were training, accountability, confidentiality, communication, problem sponsors, identification and re-certification, sponsoring across geographic boundaries, and e-communication.

Issues that I thought we should address in our Area are:

Training. I feel we should institute training as a requirement. There is a lot of misunderstanding about what a sponsor does and does not do in a meeting, what their legal responsibilities are, how to handle disruptive members, financial questions, etc. We have much good guidance in our literature. Alateen, whether it is an older teen meeting or a young Alateen meeting, are Al-Anon meetings and must be conducted as such as far as is possible. ("Preteen" is a misnomer. Nowhere in our manual or literature is this classification used. WSO does not recognize it and meetings that register this way are asked to change it.)

References. When signing off on a potential sponsor's application, the DR or Alateen Coordinator should be the designated signer and if that person does not know the applicant, it should be made a part of the record who gave us the reference, whether it was someone's Al-Anon sponsor, another Alateen sponsor, etc.

Communication. Each district should have an Alateen Coordinator who would be responsible for status checks and who can visit the meetings and provide training. DRs and Alateen Coordinators should be aware of who the sponsors are in their districts and maintain contact with the meetings. The Alateens should be able to contact the DR or Coordinator if they feel there is something questionable going on in the meetings.

?

Geographic boundaries. We have a boundary with Nevada and the Al-Anons in Bishop and other cities close to the border are a part of the Nevada Area and attend their Assembly. We should have a guideline concerning this.

Identification. We need to come up with a method of identifying sponsors and certifying their annual re-certification that does not involve the WSO number. The WSO number is just a number WSO gives to everyone who contacts them, whether it is to order literature, register a meeting, or notify them of the certification of a sponsor.

A discussion board is in the works to allow Process Persons to communicate with each other and problem-solve.

At the SOS North, we had an Alateen Sponsor workshop attended by about 12 members. There was a good mix of new sponsors, long-time sponsors and those interested in sponsoring. A lot of information was shared and it was a very productive meeting. We discussed membership, the difference between young Alateen and Alateen meetings, attracting and keeping members, working with PI coordinators to reach new members, maintaining order and dealing with disruptive members.

PI—Public Information

Records

I am continuing on with the challenge that is group records. So many times it is like solving a puzzle... It is really helpful when an update continues all of the information needed about a group, i.e. The group name, where and when it meets, including the name and address of the location (such and such Church). If the GR is also the CMA (Current Mailing Address) then only one name and address is needed on the registration form. If your group has a separate CMA, then both names and addresses are needed on the registration form. It works better to have the GR or a long time member of a group be the CMA so that we aren't changing the CMA every 6 months or so.

It is also very important to submit a change form when a group is no longer meeting. Our database has many meetings that no longer exist. We will, in turn, notify WSO that a particular meeting is disbanded.

You may submit a change either by completing the change form and mailing it to the address listed on it; by submitting the change on line through the SCWS website, or by emailing the information to me. We are continuing to use the new single form to make for SCWS and WSO. I have brought more copies with me. Please help yourself to them. Please remember if you send a change to SCWS you DO NOT need to submit it to WSO.

It is possible for me to figure out what district you group is in, and even what number your group has, but it takes me time, so if you could have that information on your change forms (hard copy or electronic) it would be very helpful and save me some time.

I put together a list that shows how many meetings and how many GR's are in each district. Because I happen to like numbers, the list also shows the percentage of GR's in each district. We continue to have a few districts that have a lot more meetings in them than others.

I want to take this opportunity to thank District 42 and District 9 for the thorough job they did of going through the meeting list I have and updating it according to their records.

Hot Topics

Disruptive Members

Our breakout session had about 150 or so attendees. The first item discussed was what a disruptive member is. A handout was distributed and the following list was compiled from the breakout committee, as well as suggestions from attendees at the assembly:

A mentally (or physically) ill person who is unable to control his or her actions.

A loud, hostile, or controlling person who does not engage in loving interchange. (These disruptive members can literally "hold a meeting hostage" because other members are afraid to make waves; some members are shy and it is easier to let someone rock the boat than to do something about it.)

Someone who brings a dog (guide dogs excluded), knitting, or other outside issues with them to the meeting. Someone who lets their child's behavior disrupt a meeting. A man dressed as a woman.

A member who interrupts the meeting with jokes or comments, or comments on another person's share or addresses another member personally during the meeting.

Someone who is sexually inappropriate toward one or more members of a meeting.

Someone who out yells/talks and won't let a meeting begin.

Are these items listed above a disruptive member, or just disruptive behaviors? In the 12th Tradition it says "Anonymity is the spiritual foundation of all our Traditions, ever reminding us to place principles above personalities." A previous delegate Bob Lahann suggested what if the 12th Tradition was listed first; would we consider disruptive members differently? As each meeting is autonomous, groups will need to review all of the principles of the program (12 Steps, 12 Traditions and the 12 Concepts) and see how or if the group needs to address the disruptive member. [Stress Knowledge-Based Decision Making based on the principles of the programs, not on personalities or opinions.]

Talk to each other, reason things out with someone else, but let there be no gossip or criticism of one another. Instead let the understanding, love, and peace of the program grow in you one day at a time.

The breakout session then worked in groups using pamphlets *The Concepts Al-Anon's Best Kept Secret? (P-57)*, *Al-Anon's Twelve Traditions Illustrated (P-60)* or the Al-Anon Service Manual. Groups discussed how the principles could be used to address a disruptive member. An additional handout was given discussing solutions for working with a disruptive member. Members then shared what worked in their meetings and also disruptive members shared some of their experiences.

SUGGESTED SOLUTIONS FOR WORKING WITH CONTROLLING/DOMINATING/DISRUPTIVE MEMBERS

From the 2007 World Conference Summary, page 36:

Suggestions for working with controlling, dominating members:

Chair a meeting with a topic that focuses on whatever principle is being violated.

Start another meeting – my program opened up and the new members who came got involved in service.

Learn ways to focus on the principles of the program so as not to give power to domineering and disruptive members in our meetings.

Review the index of the *Service Manual* to shed light on some solutions.

Study the Traditions and our abundant literature for answers to most questions and problems.

Visit problem meetings and participate in presenting solutions.

Use the District Representative and Delegate as sources of information. However, the group must resolve its own problems.

Give them a job with clearly defined authority.

Other Suggestions:

Chair a meeting using "The Al-Anon Focus" pamphlet.

Chair a meeting on Tradition One.

Establish principle-based guidelines for meeting conduct. This helps maintain principles above personalities and promotes a unified and harmonious environment. Chair a meeting on Knowledge-Based Decision Making and business meetings.

Chair a meeting on Tradition Two using the "Paths To Recovery" pages 145-147 for example.

Chair a meeting on Concept Nine – "Good personal leadership at all service levels is a necessity....."

Have a meeting on the Traditions (Pamphlet P-17); or have a meeting using the book "The Al-Anon Family Groups" Classic Edition (Copyright 2000), pg. 165, Chapter 24 "Application of the Twelve Traditions to Group Problems" written by Lois W.

Children running around - Start a Preteen or an Alateen meeting at the same time.

Take a Group Inventory G-8.

Dual Member Issues - One group reads at every meeting "*What an Al-Anon Member is and What an Al-Anon Member isn't.*"

Invite a SCWS Board Member to come to your meeting.

Miembros de punta

Nuestra reunión paralela había alrededor de 150 o más asistentes. El primer tema discutido fue lo que un miembro de punta es. Un folleto fue distribuido y la siguiente lista fue compilada por el Comité de ruptura, así como las sugerencias de los asistentes a la asamblea:

A mentales (o física) persona enferma que es incapaz de controlar sus acciones.

Una persona fuerte, hostil, o controlar que no se involucra en el intercambio de amor. (Estos miembros perjudicial puede, literalmente, "celebrar una reunión de los rehenes" porque los otros miembros tienen miedo de hacer olas, y algunos miembros son tímidos y es más fácil dejar que el barco de rock alguien que hacer algo al respecto.)

Alguien que lleva un perro (los perros guía no incluidos), tejido, u otros temas fuera con ellos a la reunión. Alguien que permite el comportamiento de su hijo interrumpir una reunión. Un hombre vestido como mujer.

Un miembro que interrumpe la reunión con los chistes o comentarios, o comentarios sobre la participación de otra persona o dirección de otro miembro personalmente durante la reunión.

Alguien que sea sexualmente inapropiado hacia uno o más miembros de una reunión.

Alguien que grita fuera / conversaciones y no permitirá que comience una reunión.

¿Son estos temas que figuran por encima de un miembro perturbadores, o simplemente las conductas perturbadoras? En la Tradición 12 dice "El anonimato es la base espiritual de todas nuestras tradiciones, recordándonos siempre anteponer los principios por encima de personalidades." Un delegado de los anteriores Bob Lahann sugirió lo que si se incluyó la Tradición 12 de primera, que se considera miembros de la punta de manera diferente? En cada reunión es autónoma, los grupos tendrán que revisar todos los principios del programa (12 pasos, 12 tradiciones y los 12 conceptos) y ver cómo o si el grupo necesita para hacer frente a los miembros de punta. [Estrés basada en el conocimiento de decisión basado en los principios de los programas, no en personalidades u opiniones.]

La reunión paralela se trabajó en grupos utilizando folletos La Conceptos Al-Anon's Best Kept Secret? (P-57), Al-Anon Doce Tradiciones Ilustradas (P-60) o el de Al-Anon manual de servicio. Alateen sponsors have responsibilities to themselves and their groups:

Work your Al-Anon program by attending meetings regularly, having a sponsor, educating yourself, staying in contact with other sponsors, your district and the Area for support. Contact your DR or myself to schedule training workshops.

Make sure your meeting is registered, help the Alateen members take responsibility for the affairs of the group, observing the Traditions and Concepts, and provide a safe meeting.

Remember: Alateens are capable of conducting their own meeting; the meeting is not a place for the sponsor to work out his/her childhood issues; we are not professionals.

Alateens talk about: their lives and problems which are a result of living with the disease. As sponsors we bring the focus back to the principles of the program. We listen, listen, listen.

Electronic Bulletin Distribution

I would like to thank all the attendees for their contribution to the discussion. We had about 20 people in attendance, all of whom were passionate about the subject. The reasons for and against electronic distribution were discussed with members giving their personal take on the issues.

Email distribution has its pros and cons; it is faster and simpler in some ways, but there could be limits due to anti-spam restrictions on the part of some internet service providers and the size of the file could be a problem for downloading on slower connections. Not everyone has an email address or can easily get email. One member has to go to the library to access email where long download and or print would not be acceptable. The cost for SCWS would be lower, with some offset because groups would print the bulletin themselves.

The paper bulletin has advantages for several members, including easy reference with or without a computer and the phone numbers and addresses of members. At least one member

Anonymity is an issue with any form of electronic distribution. Perhaps this could be solved with regular mail distribution of the SCWS directory; since it doesn't change much, it also could be mailed less frequently.

Several members present volunteered to be on a committee to help the Bulletin Coordinator with a plan to move to electronic distribution. However, we would retain regular mail distribution for all those who either do not want or can't receive electronic distribution.

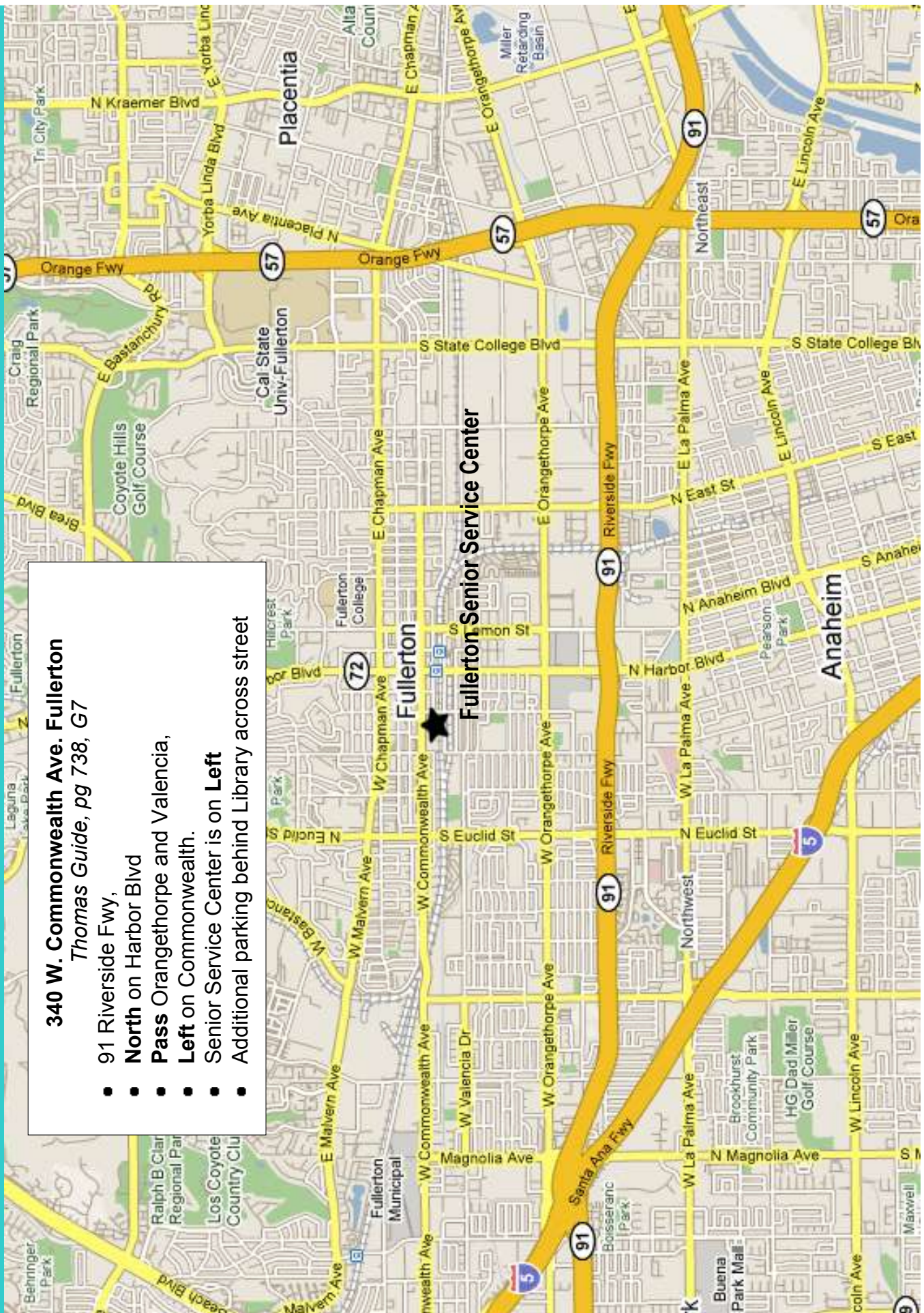
