Officer's Reports

(Editors Note: these reports are from the officers as of November 2011.)

Delegate

Where to begin? My Higher Power opened a very special door to me in 2008, when I was elected to serve you for the term of 2009-2011 as your Area Delegate. There was no way I could know then what that truly meant, and being a Trusted Servant took on new significance. You chose me to represent you at the World Service Conference. What an honor.

WHAT YOU ASKED OF ME: The Conference experience is beyond anything I can describe and its effects and the things I learned will last my whole lifetime. There were times of self-doubt, when I was thinking, "can I do this?" and I remembered you said I could, as did my Higher Power, and so you were with me when I went to the microphone to speak for my 2 minutes and I wasn't afraid. You have trusted me to be respectful, yet pointed and truthful with my voice on issues which concern our Area. You allowed me to speak truthfully about systemic problems which impact Al-Anon Family Groups as a whole, (highpressure groups, dilution of our program from the inside out by those who would infuse outside literature and therapies into our meetings, or those who feel it necessary to degrade our Twelve Steps, Twelve Traditions and Twelve Concepts by attempts to insert the gender of their Higher Power into our readings.) On the Conference floor I participated in many, many discussions and conversations ranging from:

our spiritual generosity by observing the Seventh Tradition not only with our money but with our time

the principle of Abundance in our resources, our thinking, our attitudes, our actions

the reasons to publish a piece on intimacy in alcoholic relationships

the ending of the trial period required before the purchase of our World Service Office building was finalized

cultural and linguistic diversity (examining my

own attitudes)

how can the Conference structure change to provide representation for the largest number of our members

support to Areas dealing with groups whose activities fail to consider Al-Anon and Alateen as a whole

electronic media

possible policy related to "Do Not Refer" listing

updating and revising parts of the Digest of Al-Anon and Alateen Policies in the current 2010-2013 Service Manual, including the consolidation of Alateen policies

protection of Alateen's Twelve Traditions by way of a Conference Charter revision

active listening

conflict resolution

memorial contributions

The Forum

ways in which dual members may serve beyond the group level without changing Al-Anon's policies

understanding the difference between our two entities: Al-Anon, the organization and Al-Anon, the fellowship

Together Empowering Al-Anon Members (TEAM) Events

WSO financial policy public outreach materials and many more

These are really just a few of the discussions held over the past three years. Any member can reference the "Conference Summary" for more indepth information with highlights of all discussions, either on the WSO website or hard copy an a minimal charge for shipping.

WHAT I ASKED OF ME: Being delegate has required me to be prepared, to learn all the facts about an issue upon which I would vote, to remove my opinion in my reporting to you, to act with the best interests of worldwide Al-Anon as a whole, to project in my behavior and appearance a positive message of recovery through Al-Anon, be openminded to different ideas, respect and support the group conscience without negativity or prejudice.

When I began my term, my service sponsor asked me to write a "Mission Statement" which would be a guide for my attitude and conduct. Ironically, not intentionally, there were <u>twelve</u> points, listed below:

To fairly represent Southern California Al-Anon at the World Service Conference, clearly and without my personal opinion influencing my presentations (I changed this to "decisions" as I am allowed to state my opinions during Conference discussions, but just consider facts when voting.)

To fairly represent Al-Anon World Services to Southern California

To exemplify the intended nature of "Trusted Servant" in thoughts, words, actions and attitudes through guidance from a loving Higher Power

To carry the message of hope and recovery

To always convey the importance of our place in World Services as it relates to each group, district, our area and myself

To place into perspective the wide range of Al-Anon membership around the world with that of Southern California and to focus on gratitude for our bountiful meetings and resources

To portray service to Al-Anon as honorable activity, which is an enjoyable and educational endeavor, with personal curiosity and enthusiasm

To be positive in sharing that all facets of Al-Anon are spiritual and that we all, personally, must Area structure and be able to articulate Assembly protect its principles

To be organized, dedicated and excited about this service and to listen and be responsive and accessible (I wish I were more organized, but I was extremely dedicated and excited, and I was

responsive and accessible)

To be open to and listen carefully to another's point of view (I tried my best and used what I learned in "Active Listening" workshops at the *WSC* to help with my shortcomings in this

area) To be open to and supportive of the vision for Al-Anon and be a creative part of its legacy

Start my day in prayer and reflection and show gratitude to my Higher Power and stay respectfully on this path of service, upon which I have been directed

WHAT THE CONFERENCE ASKED OF ME: As a member of the World Service Conference it was assumed that I (and all delegates)

would to come prepared, enthusiastic, informed, inquisitive, knowledgeable, open-minded, respectful, presuming goodwill, experienced, able and available. I was asked to be willing to participate in discussions and votes, participate in Thought-Task Force assignments which occur outside the Conference, and willing to communicate Conference actions and decisions in a positive way. Below are the Conference Goals:

Conference members will understand the purpose of the Conference, relationships within the structure and be able to articulate Conference decisions

The spiritual tone of the World Service Conference will prevail by the demonstration of mutual respect and acceptable conduct by its members

Knowing that our Higher Power is present in the expression of our group conscience, Conference members will presume good will.

COULD WE ADAPT THESE GOALS FOR **OUR ASSEMBLY'S USE?**

Assembly members will understand the purpose of the Assembly, relationships within the decisions.

The spiritual tone of the Southern California World Service Area Assembly will prevail by the demonstration of mutual respect and acceptable conduct by its members.

that invited me to come and share about delegate things. Thank you to all the other districts and Intergroups that invited the AMIAS policy Task Force to bring information to them as part of Knowledge-Based Decision Making.

The Sharing of Service Workshop/60th Anniversary Celebration in Camarillo was a resounding success with over 200 attendees enjoying a day of service and celebration, which was highlighted by the visit and talk on the Twelve Concepts by Ric

Buchanan, WSO's Executive Director. I think the lights came on in many peoples' eyes. Thank you, also to many of our Board members *and* Ric for participating in the musical comedy performance which was promised to District 12 for winning the <u>Forum</u> subscription challenge in 2010.

The Chairman of the Board's quarterly letter was just received with information on Board of Trustees' (BOT) activities which includes:

a site visit to Vancouver, British Columbia, where the 2013 Al-Anon International Convention will be held

the invitation to any interested member to attend the Annual Board of Trustees meeting on the day after the Conference

continuing the awareness and work of the Board's and membership's cultural competency. The Board chose the three values that we felt were most important in the fellowship—serenity, helping people, and integrity. Next, we examined our policies, our structures, our practices, our behaviors, and our attitudes to determine if the above values were exhibited in these elements of our fellowship. This conversation will continue, as we support and encourage the membership in their desire to reach out to diverse populations using our values and our principles.

three Skill-Building Leadership Sessions will be held at the 2010 Conference. The topics will include: how to deal with difficult situations, how to engage audiences using multiple strategies and techniques, and how to overcome fear and build self-confidence, empowering one to be a success as a leader/trusted servant.

the Conference structure has been a topic at Conferences since 2008, first as part of the Admissions/Handbook Task Force report, and then through two presentations given by two different Thought Forces. At this Board meeting, all of the information that was presented since the beginning was considered as the Board discussed the next steps that might be implemented in decisions about revising or changing the structure. All of the concerns that were brought forward were taken into account and addressed by the Board. After an indepth conversation, it was decided that the Board will present ideas at the 2012 Conference that will address the next steps for the Areas. (This is in direct response to the 2008 CA(S) petition to the Board of Trustees authored by our past delegate, Mary Morrison.

it was affirmed that the WSO's role in this discussion of a possible "Do Not Refer" policy is to determine how we can support Area decisions and adhere to our spiritual principles, a "talking points" presentation will be made available

the BOT will spend an entire day at the January meeting discussing where to go from here, so they can begin the execution of its Strategic Plan. They have learned to be flexible and nimble when it comes to the Strategic Plan, which has enabled us to make the best decisions for Al-Anon Family Groups as a whole.:

The Policy Committee's "Do Not Refer" Thought Force completed the KBDM questions and began preparing a list of principles for discussion at the 2012 WSC. These principles will shape the Conference discussion, and provide a basis for the Delegates to bring this discussion to their Areas.

The Policy Committee's "Dual Member"
Thought Force completed the KBDM questions and outlined the spiritual principles behind the current policy on "Dual Membership in Al Anon/Alateen and A.A.," on pages 78-79 of the "Digest of Al-Anon/Alateen Policies." A Task Force has been given the charge to clarify the current policy wording, using these spiritual principles.

The Policy Committee's "Memorial Contributions" Thought Force completed the KBDM questions and developed a list of spiritual principles related to Tradition Five. The Thought Force will further explore these principles in light of all the Legacies.

The BOT Treasurer reported: Income: Literature sales were \$3,364,800 this year compared to \$2,970,900 last year, an increase of 13.3%. Gross profits on literature sales were \$2,682,100 (79.7% of sales), compared to \$2,327,500 (78.3% of sales) last year. Contributions were \$905,600 this year, compared to \$883,100 last year—an increase of 2.5%. Forum subscription income was \$205,500 this year, compared to \$209,300 last year—a decrease of 1.8%.

Expenses: expenses were \$3,641,000 this year, compared to \$3,422,600 last year. The increase was primarily due to the cost of printing the Spanish and French Service Manuals, travel to TEAM events, repairs to the HVAC system, and depreciation on the new roof. Overall, expenses are in line with the budgeted amounts.

Reserve Fund: The fair value of investments in

the Reserve Fund totaled \$4,448,000 at September 30, 2011. This amount includes an unrealized gain of \$204,000. In compliance with a Board of Trustees' motion, 4% of the average balance of the Reserve Fund over the prior 36 months will be transferred to the General Fund.

us as those who love Al-Anon and Alateen. I have seen and participated in heated discussions in all service levels where passions flared, but in the end peace and reason resumed and after allowing all those who were invited to take part (those with vote and voice) to speak, after considering all the facts and after considering the minority voice, a decision could then be reached based on its effect on Al-Anon as a whole. However, I have also seen our members engage in shouting matches and behave in ways they would never allow in meetings or in the presence of newcomers and other fellow members. It is my hope that we all grow as we learn how to be of service and honor our program by demonstrating our respect.

I have also learned the importance and the imperative we, as members, have of selecting leaders who bring the highest qualifications for certain service positions where just being willing is no longer the only consideration. We are reminded of able people on the committee, doing esteemable this by an excerpt of Concept Nine: "Good personal leadership at all service levels is a necessity...." (Al-Anon Alateen Service Manual, 2010-2013, page 190-194.) As our world grows at an exponential pace, so are our challenges and our vision.

I now understand what Willie Williams meant when he said this would change my life. This has been a transformative time and I am grateful for the knowledge gained and the trust given. Even when I was not at my best, you gave me your love and support, for which I thank you.

New Business

SCWS Board recommends Assembly establish Board Coordinator Position for Area Alateen Process Person (AAPP).

Discussion: Technically it would be three positions on the board, Alateen, Alateen Sponsor Coordinator, Alateen Area Process Person. DRs have to be informed how much responsibility and who the Alateen Sponsors are in their District. The DRs do have to know who they are. The DRs really saw how vital the that position is. The DR has to pass that familiarity on to the next DR. That position needs to keep the board aware of issues and the board needs to be transparent. The current AAPP person spoke and believes that the position takes about 15 hours per week and that it is overwhelming. (Polled DRs, Liaisons & Convention Chairs, and the motion will be an Assembly New Business Item).

SCWS Board recommends Area Safety & Behavioral Requirements Document be presented to Special Assembly. (Some Friday nights are available to have Special Assemblies in October, November & December – DRs voted. Motion did not pass - no Special Assembly).

SCWS Board recommends Thought Force continue looking at redistricting of Area to include evaluation of District 64.

For the Hot Topic the DRs decided for all GRs at the Assembly will be the Area Safety and Behavioral Requirements for Alateen Groups, Alateen Sponsors, and Al-Anon Members Involved in Alateen Service (AMIAS).

Open Discussion

-Paula DR 27 – GRs' lack of information from the Delegate, ("Officers are leaders and trusted servants who perform their

duties, yet they have no authority over the group"), Pg 61 – Al-Anon Alateen Service Manual 2010 – 2013, and wants the Delegate to have more transparency. She would have preferred to have bullet points in the Delegate's report vs. having a long story about her emotions. Delegate's report from today would have been better if that was the report given in May. Melissa DR 39 – Do remember overhead report Delegate did and she did a good job. Tina DR 21 – How about doing a Group Inventory for the Assembly? I think that doing service is very important.

- Jennifer DR 45 – Survey of newcomers, did the Board know about it? Did the World Service Office know about it?

Amanda – Min. Secretary – When the Delegates are new to the World Service Conference, they have a current Delegate that has been there a year or so mentor them. Can we pass a sheet to have outgoing or current DRs that are willing to be mentors for new incoming DRs? A sheet was passed and given to the Chair, Jayme.

I thank you for the opportunity and for the confidence to allow me to serve as your Area Chairman and also as the Acting Area Alateen Sponsor Coordinator.



Group number if you have it. If you don't have it, it is not necessary to call me to get it. I will figure it out when I get your form.

And please include the district number.

You may submit a change either by completing the change form and mailing it to the address listed on it; by submitting the change on line through the SCWS website, or by emailing the information to the group records coordinator. Emails are much easier than phone calls.

We are continuing to use the new single form to make changes for SCWS and WSO. I have brought more copies with me. Please help yourself to them. Please remember if you send a change to SCWS you DO NOT need to submit it to WSO.

We have **607 registered GRs.** The most GRs we have seen at an Assembly during this three year panel is **267** and that was in November. It really pays to have hot issues at the assembly. This is how many Gr's each district had present at the last Assembly


