ELECTRONIC LITERATURE

- Electronic literature could make Al-Anon literature more readily available throughout the world.
- WSO moving forward with Pilot Program to sell *The Forum* in electronic formats and *Having Had A Spiritual Awakening* (B-25) which is out of print. This is a trial basis.
- No status on when the Forum will be available electronically. Vendor problems not WSO. Forum will continue to be sold in hard copy.
- Pilot programs will have no financial impact on AISs, LDCs and GSOs.

ALATEEN TASK FORCE

- Articles of Incorporation sent to State of California. Form 1023 has been filed with the IRS for 501(3)C as non-profit. Still waiting for confirmation.
- Revised SCAC Bylaws now reflect needs of Corporation.
- SCAC Bylaws were voted on and accepted at SCAC 2013. SCAC is in compliance with SCWS Area Behavioral and Requirements.
