History

- SCWS made no contribution to WSO in 2018
- SCWS donated \$20,000 to WSO in 2017
- Ample reserve is currently at \$35,000
- February 2020 AWSC recommended to request a contribution of \$12,641.09 be on the Agenda for May 2020 Assembly.
- Total contributions from Conventions, Districts and Groups were \$73,311.56; this represents 88% of our income.
- SCWS donated \$2,504.30 to WSO in May 2019, this represents 3.4% of contributions received in 2019

Moving Forward

- For 2018 and 2019, SCWS has received \$148,757 in contributions from Groups,
 Conventions & Districts.
- As of today, SCWS has only contributed 1.7% of contributions to WSO.
- Finance Committee recommends SCWS contribute \$12,641.09 to WSO for 2019
- Increase Ample Reserve to \$71,000 (this covers our total expenses for 12 months).
