• Approval of November 21, 2020 Assembly Minutes ■ Yes: 168 (79%) ■ No: 0%

Area Election- Chairperson, Jayme

- Candidate: Martha Z. shared her background in Al-Anon service and read response from her Resumé to the question: Why would you be an asset to the SCWS Area as the Chairperson?
- Short PowerPoint presentation regarding Area Chair position and GR's decision today to:

 vote for candidate to be the new Chairperson, suspending for today our Area election procedures [which require 60 days notice of resume] or
 have the current Acting Chair appoint the candidate as Interim Chair and hold an election for Chair at the November Assembly.
- Vote #1: the GRs voted on whether to hold Chair election today or in November:
 - Yes: 142 No: 52 GRs voted to hold the election today.
- Vote #2: Yes or No to elect Martha Z. as Area Chair
 - Yes: 183 (77%) No: 4 (2%)

Martha Z. elected new Area Chair for the rest of this panel, which ends December 31, 2023.

Delegate's Report (Part 1) Tim P.

- Attended the 61st World Service Conference (WSC) April 12-16.
- Discussions at WSC about Electronic Meetings. Electronic Meetings document on SCWS website: https://www.scws-al-anon.org/wp-content/uploads/2021/05/SCWS-WSC-Transforming-Electronic-Meetings-to-AFGs-A-Guide-for-Geographically-Based-Areas-Apr-2021.pdf
- The WSC voted to allow Al-Anon's almost 500 permanent electronic meetings to form a nongeographic Area with Districts and Group Representatives (GRs) for these meetings. Process described in the Service Manual for forming a new Area. Board of Trustees and WSC hope that the application for this new "Electronic" Area will be approved at the 2022 WSC.
- SCWS will host a virtual workshop, Reasoning Things Out: In-Person, Electronic and Hybrid
 Meetings on June 26 from 10:00am to 1:00pm. Topics: considerations for Groups returning to faceto-face meetings; structuring Hybrid meetings virtually for best Al-Anon experience; meetings that
 decided to split--some members meeting in person, others electronically.
- World Service Office (WSO) sources of revenue: Contributions = 60%, Literature Sales = 34%,
 Magazine sales = 5%, Investment Income = 1%. AFG Headquarters operating budget = \$5,391,510
- WSC completed a 3-year trial and approved providing interpreters for Spanish and French speaking Delegates. No longer necessary to be fluent in English to become a Delegate to the WSC.
- Every 3 years, Al-Anon conducts a Member Survey on WSO website. Survey: June 16-July 27, 2021.
- The WSC approved Al-Anon's first Longitudinal Study. Members who complete this year's survey are invited to sign up for a 5-year annual study which will look at the effects that continued membership in

- Al-Anon has on member's health and well-being. The hope is that the results may provide "scientific" evidence to the professional community on the benefits of membership in Al-Anon
- Classic versions of the One Day at a Time reader and The Dilemma of the Alcoholic Marriage will be
 updated with prefaces that will point out their historical context and perspective. They are still "gems".
- Electronic Welcome Newcomer kit (EK-10) will soon be available for \$1.40.
- Online Al-Anon store to be updated in July for ordering in French and Spanish as well as in English.
- The Alateen "preamble" will be rewritten to be more similar to the Al-Anon preamble
- There will be a *Just for Tonight* bookmark soon for Alateen members
- How can we make our Board of Trustees more diverse? This is something they are working on.

 many variables involved, the Area will create a Work Group of interested members to discuss the
 many issues involved in including PEMs as Area Groups.

Old Business:

- Area Insurance for Groups Task Force (Update): Laura H. D69: Task Force will present recommendation at August Area World Service Committee (AWSC) meeting and then at the Assembly in November.
- **AIS/LDC Coordinator:** We will extend the three-year trial period for this position. GRs will vote to make the position permanent (or not) in 3 years.
- Spanish Coordinator: Voting today to make this position permanent. Need someone to fill this

position for the rest of this 3-year term. Peggy, D40 made a motion to make this a permanent Board position. Maria N., D42 seconded it. Number of voting members: 187 at 1:18 p.m.

Vote: ■ **Yes: 172** (81%) ■ No: 0 (2%) Motion passed.

- **District 64** (Spanish Overlay District): Tim P., our Delegate, reviewed the history of D64 as an "overlay" district.
- Alateen: Southern California Alateen Conference (SCAC) Task Force: Bear:
 - SCAC procedures, policies, behavior requirements are being defined and refined. There are two issues:
 - Recommendations revising SCAC Bylaws and
 - Agreement for fiscal sponsorship (by SCWS) of TF will be reviewed by Officers, then Board, Committee, and Assembly. Both were reviewed by a pro bono attorney.
 - Believes (hopes!) they might be able to have the next event in June 2022.
- SWRDM (Southwest Regional Delegates Meeting) -- Jayme C., Past Delegate. The purpose is to bring Delegates together in the Southwest regions to prepare for the WSC each year. Next year SWRDM will be held in Tucson, AZ. the second weekend in March. It is open to guests; a huge learning opportunity for members.
