

SCWS Delegate's Report Assembly, November 19, 2022

#### **Electronic Groups**

- ► The World Service Office is now capable of registering Electronic Groups once Areas have voted to accept these Al-Anon Family Groups and have developed policies and procedures to support them.
- About 25% of AFG's Areas have already voted to admit EGs and have developed procedures for welcoming and registering Electronic Groups. The WSO does not need to approve these procedures. However, they will be involved in listing these new groups on the Al-Anon.org website.
- By the time I deliver this report today, Southern California World Service will have decided whether to welcome Electronic Groups into our area, and we will have voted on policies necessary for an Electronic Group to join our Area.

This is in addition to SCWS contributions to WSO.






### October was a busy month

- While Al-Anon's deficit is smaller than the revised budget at the end of our third quarter, we had two major (and expensive) events in October that will affect our 2022 yearend budget substantially..
- ► The bi-annual International Al-Anon General Services Meeting (IAGSM) in London
- ► The quarterly Board meeting in Cleveland, followed by Road Trip! You and Your Board Connect at the end of October. About 150 members attended.
- ➤ A budget note: This is the 3<sup>rd</sup> year in a row during the pandemic when Member Contributions have brought in more revenue than Literature Sales.

# **Envisioned Future Work Group (EFWG)**

- At the October meeting of the Al-Anon Board of Trustees, the EFWG led a discussion regarding diversity and inclusivity. They identified five variables that contribute to diversity: Socioeconomic, Cultural/Geographic, Disability, Race, Gender.
- ► The Board decided to hire an outside consultant to present a workshop on diversity at the January 2023 Board Meeting.

#### **News from WSO**

- Al-Anon's latest Daily Reader—A Little Time for Myself: A Collection of Al-Anon Personal Experiences—will be introduced at the 2023 Al-Anon International Convention beginning July 29.
- ➤ The Al-Anon Family Groups Mobile App—launched just over two years ago—is currently home to 37 Al-Anon Family Groups holding 101 meetings each week. We now have more than 120,000 registered members.
- ► The World Service Office in Virginia Beach, VA, is once again opening its doors for guests. Tours need to be scheduled at al-anon.org/tourwso.

#### More news...

- On September 10 WSO's first Spanish-speaking member interview aired on YouTube. The interview was later dubbed into English as well! AFG has a large presence on YouTube.
- SCWS did not have any member submit a resume to stand for Southwest Regional Trustee. Resumes were due August 15.
- ► The 48<sup>th</sup> Annual Southwest Regional Delegate's Meeting will be held in Salt Lake City on March 10, 11, and 12 2023. The SCWS Delegate, Chairperson, Alternate Delegate, and Immediate Past Delegate attend this meeting to help prepare current and new Southwest Region Area Delegates for the 2023 World Service Conference. Other Board members and guests also attend SWRDM.

- Version 2 is at the printer. WSO anticipates that the print versions of the Service Manual will be available before the end of the year.

- Chosen Agenda Item (CAI) discussions have been taking place at Al-Anon's Annual World Service Conferences since 1976. The purpose of the CAIs is to give all Conference members an opportunity to submit and select topics and issues of concern that affect Al-Anon groups and members worldwide for discussion at Conference.
- Following an invitation to evaluate the Chosen Agenda Items Process, one of the suggestions from the 2018 World Service Conference members was to create a Chosen Agenda Items Index.

# Al-Anon literature prices increased on August 1

- Al-Anon literature prices have not increased since 2013.
- Price increases are due primarily to soaring costs of paper, production, and shipping.

# Al-Anon Longitudinal Study

- Every three years Al-Anon conducts a Member Survey on the Al-Anon website. The latest Survey took place last summer from June 16 to July 27, 2021. We had a recordbreaking response from over 16,000 members, a 28% increase from the previous survey.
- The 2021 WSC approved Al-Anon's first Longitudinal Study. Many members who completed last year's Member Survey indicated their willingness to participate in the 5-year annual study which will look at the effects which continued membership in Al-Anon has on members' health and well-being. The first survey took place this summer.
- The results may provide "scientific" evidence to the professional community on the benefits of Al-Anon membership

## A Road Trip to Southern California in 2023?

- The October 2023 meeting of the Board of Trustees will include a Road Trip! You and Your Board Connect event.
- SCWS GRs at the May Assembly indicated their willingness for SCWS to apply. If our Area application is accepted as the 2023 destination, the Board of Trustees will sponsor an all-day event on Saturday, October 28, 2023 for up to 150 Al-Anon members in our Area! The WSO will handle negotiations with a local hotel and provide registration forms for local invitations. SCWS costs would be minimal.
- SCWS applied in September. We are waiting to hear if we are one of the finalist sites. We will be notified of final Board selection in February 2023.

#### 2023 World Service Conference April 20-23, 2023

- The 2023 World Service Conference will be held in Virginia Beach, VA, from April 20-April 23, 2023. The WSC will include a tour of the World Service Office.
- As reported in the 2021 World Service Office Annual Report, the Board of Trustees passed a motion to approve reducing Conference Week to four days effective in 2023 on a three-year trial basis.
