#### 5. Old Business:

- Electronic Groups Task Force (EGTF) Presentation:
  - Does our Area wish to welcome Electronic Groups (EGs) into our service structure?.
  - Two presentations were posted on the SCWS website several weeks before the Assembly.
  - Zoom Etiquette\*\* review

**Sandra L. D69:** Reviewed Glossary of terms: EGs, Hybrid meetings, TEMs, Districts, Overlay District. Reviewed background Information: some TEMs split, some are floating without an attachment.

**Terri P D33:** Reviewed What was the first task for this task force? Reviewed what were the significant findings of the task force? Some TEMs want to be connected with SCWS, don't anticipate additional expenses. Reviewed what we know: to be consistent with our Vision for Al-Anon.

**Tim Delegate:** Reviewed choices of staying with Global Electronic area or our SCWS area. Reviewed Principles, Policies and Legacies apply to this question? Tradition 1, Tradition 3, Tradition 5

**Teresa GRC:** Reviewed Concept 4, and what we don't know as well as are you still wondering about the main differences between an Electronic Group being registered in the Global Electronic Area or being registered in the SCWS geographic Area?

**Sally L D17:** Reviewed if Electronic Groups were welcomed and registered in the SCWS area, Task force summary.

#### Questions:

Laurie D54: Would GR need to be physically located in the District?

**Jaymie:** If a group is located in the SCWS area, that GR would need to be able to physically go to the District meetings in that District.

Carol D60: This seems fuzzy.

**Teresa GRC:** We have 2 kinds of groups: Physical and Electronic.

**Nick D17:** Some members came to his meetings from other areas pushing their agenda, it took a toll on their unity. Young people prefer Zoom meetings. How would that be taken care of?

**Marcia:** Some feel they do not have a home base. If they are a Permanent electronic meeting means that they are registered with WSO and it is listed on their website. They are only listed by their physical location where they used to meet.

**Tim:** Yes, there are going to be residency requirements. We are going to vote on that as a standard.

Kelly D45: What are the downsides of doing this? other concerns?

Marcia: The task force could not come up with any down sides.

**Teresa GRC:** The group gets to decide.

**Tim:** We have 3 separate votes. Maybe we should show them the criteria now.

**Sabina D30:** If we accept electronic meetings, where would they be listed?

**Teresa GRC:** WSO is figuring out how to list them. You would be listed if you connected with a district on a local side. It's confusing but they are listed where they are connected.

**Newt D12:** Is it true younger people want to connect on Zoom?

Tim: It's an assumption that was made.

**Terri D33:** From their experience, they notice a lot of younger people are attending. There is no hard evidence because of anonymity.

**Rubi D27:** Disturbed how it's become about fears, instability of internet, what happened? What are we talking about now?

Lydia D45: Would electronic groups have a WSO ID#? How would we know if their group is doing what?

**Teresa GRC:** Every group gets a number. we are jumping so far ahead, the group will decide.

Miriam D66: How do we phrase this to newcomers? Do groups have to decide?

**Donna:** Yes, temporary groups cannot exist forever. Eventually they'll need to decide.

**Nick D17:** Maybe we could talk about this at the end after everything is presented?

**Sally D17** This is not about breaking up groups.

Jayme: The GRs get to decide.

Luana D66: Asked where presentation is.

Jon: It is on the website.

**Dasha D21:** Can we see the rest of the presentation? Also, can there be someone who fields the question so questions can get answered?

#### Continuing on with presentation

Sally D12: Reviewed if our GRs vote, how soon could EGs register in our Area?

Jayme: Task force Proposal One:

1. The TF proposes to welcome all Electronic Groups that have formed in our Area with the same criteria that would apply if they were a physical group. This is because...

- a. We want members of these groups to feel connected and a part of our Area.
- b. We want to welcome these members to participate in our Area service structure

#### **Task Force Proposal Two:**

- 1. The TF proposes that the Area form a "SCWS Electronic District" available for Electronic Groups (registered in our SCWS Area) to have an option to join. Proposal is to form the SCWS Electronic District on a three-year trial basis.
- 2. Why is the TF Proposing adding an Electronic District?
- a. Some groups have no connection to one Geographic District/city or county, but still have a connection to SCWS.
- b. Some groups contain a higher number of members who are spread across Southern California instead of being in one District. This would allow more members to step up for service beyond the group level.
- 3. How would the Electronic District be formed? If our GRs agree to forming this District, the EG Task Force will continue to work out these details and support the initial stages of forming the new District. 23 Task Force Proposal Two, continued. What District would the SCWS Electronic Group join?
- 4. The Electronic Group would have the autonomy to choose to belong to a "geographic" District (like D-8, D-27, D-60), our Spanish Overlay District (D-64), or the new Area "SCWS Electronic District."
- a. If the EG chooses to be registered in a geographic District, their GR would need to be able to attend a face- to-face District meeting if applicable.
- b. If the EG registers in the Electronic District, the GR can reside anywhere in the SCWS Area and will attend a virtual District meeting.
- 5. The Task Force encourages Electronic Groups to have a Business Meeting(s) to discuss their District options and take the time needed before taking a group conscience.

#### Questions:

**Terri D33:** There are 3 choices: just your district, all of SCWS, or global, or stay hybrid.

Laurie D54: Attends a meeting, asked if the group will take a group conscience?

Marcia: Yes, we hope you ask some KBDM guestions.

Jane D54: Is there a block they are put in with WSO? Would we use that with our area?

Tim: Global area has a delegate and an assembly and they will come to WSC every year.

Cherie D60: If they want to become part of a district even if it is SCWS?

**Teresa:** Where does the group connect? It cannot ping pong.

**Terri D57:** Do we want to give groups the option? Is that what we are asking? Stay with WSO? SCWS? or attach to a district?

Marcia: Yes

**Holly D66:** Would the other members get a voice and vote.

**Jayme:** Yes, they would at the business meeting. The group needs to decide if they want to be with SCWS or the global area.

**Toni D66:** To not use reside but to use the word principle residence.

Marcia: Need to attend a Face to face if applicable.

Elodia D75: Would it be like D64?

Donna: Yes

Kelly D45: Can a district say we don't want to have electronic meetings?

Marcia: No, this is an area decision. As long as the district knows. We welcome all groups.

**Jayme:** The district doesn't have that type of autonomy. How would you rotate leadership?

**Terri D33**: Gave an example of her meetings, went electronic, but now some want to meet in person so there might be a split.

Mary D66: How would you help newcomers get sponsors, etc.

Donna: Same as you have been doing.

Sherry D72: If a split occurs, do they get a new WSO ID #?

Teresa GRC: It would be a group update, yes you would.

Gloria D30: Is it possible for them to register right now or do they have to wait? They have no voice right now?

Teresa GRC: If it is a yes vote, Tim will notify WSO.

**Tim:** Most likely by December 1st. WSO is not pressuring us.

**Nick D17:** What is the consideration for Rotation of leadership.

Marcia: The CMA needs to be in our area.

Josefa: Do we have a GR for TEM?

**Teresa GRC:** Most of the meetings are TEMs, attached to a physical location. It depends on the circumstance of the group.

Ruth D33: The district meeting should be hybrid so they can attend electronically.

Teresa: It's up to district autonomy, you would be listed differently.

Carolyn D3: Do we have to get rid of hybrid?

Tim: That will always be ok, but it will be attached to a physical location. From now on we will.

**Jayme:** Need representation, participation, and communication are needed to thrive.

#### 6. Concepts read by: Marcia District 30

Marcia announced there will be a town hall meeting February 11th to answer questions about Electronic Meetings.

#### Questions continued:

**D66 Norma Jean:** Made a suggestion to put all questions go into the chat, then the tech person would let us know and we could answer it accordingly.

**Kelly D45:** Do we want EG to join the district? Is that the way it has to be? Just do the overlay and forget about the districts?

**Marcia:** Yes, it is confusing. If the answer is yes to the first question, then we go on to the criteria of what they would need to be registered with SCWS. If they want that, then the third part is the district part. The group would get to choose the SCWS area or do we want to be more Global?

**Kelly D45:** Why be part of a district? Why not be part of the electronic district?

**Teresa:** Many are attached to their local AIS. The groups have to either feel a connection or not.

**Tim:** About one-third of Areas have completed the process. We have had the benefit of looking at their guidelines.

**Rubi D27:** Do they still have right of appeal in this assembly? We don't know how any of this is going to work. If it doesn't work out in the long run, can we change our mind?

**Marcia:** Yes, the idea of an overlay district is a 3-year trial basis. At the end of the 3 years, we will check in to see if it is working and make the decision then. Anytime we have an issue, and new information comes up, we can always bring that information to the assembly so we are not doing a knee jerk reaction.

**Tim:** Whatever our vote, we are not disbanding our task force. The task force will help make these adjustments. We will have a report and keep everyone up to date at the next AWSC meeting in February.

**Luana D66:** Is there a location of how to become a virtual or hybrid meeting?

Marcia: We have had presentations in the past.

**Barb D66**: Why is the district proposing the overlay district? Teresa: It's that connection.

**Pete D66:** Thinks we need to vote. Marcia: We are voting on policy, criteria.

**Sue D60:** Are there any other pros or cons we need to know about at this point? Marcia: No, task force will be looking at this.

**Nick D17:** Are we doing KBDM before doing the vote? Marcia: Exactly

#### Comments:

**Lynne D75:** We need to move on. If the area made the decision, it would be more efficient. GRs would make it permanent in 3 years.

**Sean D6:** It could be a wider range for us to discuss things, it is nice to go to other meetings.

Andy D66: Has a lot of young members asking for face to face meetings. Why aren't DRs giving reports?

**Marcia:** We don't have enough time today.

**Jayme:** Before everyone votes, the February 11th town hall meeting is information only, no voting will occur. This is the place to vote right now.

Tim: What does our number need to be for substantial unanimity?

**Marcia:** That means it needs to be a  $\frac{2}{3}$  majority, we will check in with Teresa for verification of numbers.

**Teresa:** We have 194 voting members.

Budget Overview: Christy R. 71,300 of expenses planned, therefore we have 71,300 income planned. Asking for approval of 2023 budget.

#### Questions:

**Tony D66:** Why are there a lot of little CDs?

Christy: Because they mature at different

times.

**Tony D66:** She was wondering why not keep it in a money market account since the interest rates are higher there.

Christy: A safety issue, don't want them easily accessible.

**Tony D66**: Where is our physical equipment?

**Christy:** Some of it is computers, we used hand-held clickers to use at physical assemblies. We have storage, but no assets are there. The clickers are with Roxane. There is also translation equipment.

\$105,278.23 total bank accounts

\$111,458.06 total fixed assets

Suzanne: How many attended SWRDM in 2022? Noticed an increase in mileage.

**Christy:** Need to be in contact with Roxane. Mileage we were anticipating if we met face to face or a hybrid/face to face

**Cathy:** The registration for SWRDM was \$780.

Andrea D42: Is there a line item for Delegate to go to International?

**Jayme:** There was a motion that the Delegate would be sent during a panel. Our delegate Tim will go with his expenses paid. There is also a motion that the Delegate, Alt. Delegate, Past Delegate, and Chair will have their expenses paid to attend SWRDM each year.

Char D42: Why do we have storage?

**Christy:** We have financial records, we have hospitality items, and some archives. Our Archives is in a temperature-controlled area. It is in Glendale near where we were meeting Face to Face.

Char D42: Why can't we make them electronic?

**Christy:** They need to be available for 7 years per the IRS.

Newt D12: How was a budget formed? was curious about the process.

**Christy:** We looked at our expenses and then matched income to match it. We do look at it year after year what our expenses and income have been.

Yoly: What is SWRDM?

**Christy:** Southwest Regional Delegate Meeting, it moves from area to area.

**Jane D54:** When you say 7th tradition, was there a physical basket that went around? Why aren't we doing that in an electronic format?

Christy: Yes.

Marcia: It is on the SCWS website to do an electronic contribution? Truck showed it on the website.

**Ruby D27:** We have had a loss of meetings in our area from 500 to 300. **Christy**: it has been decreasing some but we are ok.

**Ruby D27:** Sounds like we are doing really well, seems like there is an underlying assumption that face to face brings about more prosperity.

Elaine D75: Where would be the money for members of the board to go to events?

Christy: Some is in SWRDM and some is in Travel.

**Teresa:** She is working with AISs to get the numbers to be more accurate.

**Kelly D60:** Why do travel expense trips go up from August to November?

Christy: We were anticipating face to face.

**Tim:** There are significant travel expenses that took place in October but won't show until November and December. Al-Anon has a reserve fund. Yes, some is invested in stocks and bonds and it does fluctuate. it is a reserve fund, it doesn't come out of revenue.

**Ann D39:** Why is it such a huge deficit? travel expenses? or is that on top of that? It sounds like SCWS is a big donor to WSO.

**Cathy:** WSO did not sell a lot of literature during covid, they had to lay off a lot of employees. We need to pass it on.

**Tim:** Did include a graph in his report, can see it on the website. Unsure with time if we will get to that today.

**Jayme:** The trustees were unable to travel for 3 years, now they are able to. We also had to

become a book publishing company because the contributions were not sufficient.

**Marcia:** All of their information is on the WSO website. From her personal experience, we pay it forward to further public outreach.

**Newt:** Is that deficit for the current year? Do they need the money now?

**Cathy:** It's always worked itself out. A few years ago we did not make any contributions. We need to presume good will.

**Tim:** Can I give the delegate report? It addresses how WSO uses our Area contribution.

Marcia: Yes, let's do it.

#2: Our On-Line Registration/Group Records Change Form: Most of our members are updating their groups using our "One Stop Shop" SCWS-al-anon.org "Al-Anon New Group Registration / Group Update. This includes the direct links on our Al-Anon Information Services (AIS), Literature Distribution Centers (LDC) and District websites. Keep educating our members to please use our form. The purpose is to provide all groups one place to go to provide all of their group information/changes.

#3: Reported Not Meeting, Bounced Emails (emails no longer working or incorrect) and No Mail (CMA's US mailing address is getting returned to WSO) are being better managed. It has improved due to the newer time constraint that after 94-days of Reported Not Meeting groups then go inactive as they are presumed disbanded. This is a great motivation to find out where and if that group is meeting. I work with the DR's and AIS Offices to reconcile regularly. \*The "No Mail" # is split based on group/meeting — as some groups meet more than 1x a week.

**#4: Working in Cooperation:** I have had great success working together with the Al-Anon Information Service Offices, Literature Distribution Centers and Districts that maintain their own meeting schedules because they do not have an AIS/LDC. We all have the same goal – wanting newcomers and members to find the right

information to find the group they are looking for on an approved Al-Anon website.

On al-anon.org "Find an Al-Anon Meeting," Hybrid groups show as "Meeting in person and electronic component also available--(with the information listed as the group requests). All Temporary Electronic Meetings show as "Not meeting in person" at the front of the listing. Groups that have identified they have returned to "Meeting in person," are listed as such.

\*We still have 259 groups that we have not received an update from on how/if they are meeting.

The BIGGEST news to share, as I amended this part of my report after the November 19<sup>th</sup> Assembly: **Our Area now welcomes Electronic Groups!** We will be having an **Electronic Town Hall Meeting on February 11, 2023, on Zoom** -- if you need help navigating through some of these changes and finding it challenging, please plan to attend – all members are welcome and will be heard.

Our SCWS **Group Records** Forms have been updated and they are new and IMPROVED. One form is for NEW AL-ANON GROUP REGISTRATION submittals, and the other is for AL-ANON GROUP CHANGES.

Please keep doing your part in checking to see if your listed meeting information is correct. All registered Al-Anon Family Groups (AFG) that are in active published status are listed on the World Service Office (WSO) "find an Al-Anon Meeting" online directory at al-anon.org. The WSO maintains other information on registered groups, but **the meeting directory listing** is important as the WSO website is typically the first place a newcomer finds a group. In addition, your group is listed on your local Al-Anon Information Service (AIS), Literature Distribution or District Website – but we are all in agreement – we want that information to be the same and to be accurate! We all want newcomers to find your groups!

If you don't know who the CMA is of your group, your group needs to find out – perhaps they no longer attend your group – if that is the case, your group needs to find someone to 'get the postal and electronic mail.'

In recent decades election requires a two-thirds vote of GRs. For the 2023 election only, GRs in May will be given a choice: Vote to continue the two-thirds procedure or elect by simple majority.

In the 2018 Manual key pages for review include pp. 152-3, 220-21, 187, 194. In the current 2022 Manual, the pages are 156-7, 225-6, 192, 199.
