

District number (space) **GR** (space) **First name, last initial Example**: *03 GR Mary M.* (Members of Districts 03, 06, 08, and 09: identify District with two digits)

Alternate Group Representatives (AGR):

If you're **attending** *in place of your GR and voting for your group,* start with your District number (space) "AGR" (space) then first name and last initial. **Example:** *72 AGR Della D.* If GR is attending, you attend as a "**Guest**"*

District Representatives (DR):

District number (space), **DR** (space) **First name, last initial Example:** *72 DR Della D* If are *also* a **registered GR voting for your group,** then you would put both designations: "GR/DR" **Example:** *12 GR/DR Marie*

4. Delegate's Report -- Tim P.

- Went to World Service Conference in April for 4 days.
- Love, Laugh and Grow Together was the theme.
- First WSC was 1961.
- "Alanon is a program of love, and love is the primary motive in all our activities" Lois said in Many Voices, One Journey.
- Road Trip coming October 28th to Southern CA. It will be all day at the LAX Hilton Hotel. All of the Board members will be there. Vicki will chair the Welcome committee. We have reserved a block of rooms. This information is on the website, and it will be translated into Spanish.

- International Convention will be 6/29-7/2: Registration is \$250, additional charges for special events. The virtual program is \$145.
- Electronic Meetings become Al-Anon Family Groups Review.
- 2 Kinds of Al-Anon Family Groups:
 - Physical group belonging to a geographic area, may allow an electronic window.
 - Electronic group: not attached to a physical location.
- Transforming Electronic Groups Project:
 - Global Electronic Meeting search is now available.
 - Registration and change forms can only be submitted online.
 - WSO staff are working now to create the Geographic Electronic Meeting Search list.
- Alateen Electronic Group Feasibility:
 - The goal is to make Electronic groups available for all.
 - Alateen members who wish to participate, ensuring the safety of Alateen and AMIAS members.
- Potential solution for Electronic Alateen Groups:
 - o minimum safety requirements appropriate for the global nature of EGs involving minors.
 - o Global EASB.
 - o AMIASs would be mandated reporters and would have to pass a background check.
- Al-Anon Family Groups Copyright and Trademark Protection: Understanding the new world reality and how members can help protect Al-Anon's name.
- Permission to use:
 - Traditional vs. Explicit.
 - Traditional: service arm flyers, registered service arm websites and social media pages, Al-Anon Guidelines, photocopies created by members, groups.
 - Explicit: Excerpts from CAL, CAL in meetings.
- New CAL: Daily Reader: A Little Time for Myself which will be available after the International Convention. They are creating a comprehensive piece on sponsorship and service sponsorship using personal stories from AI- Anon members.
- Trustee Affirmation Process: Past delegate Jayme, Cindy M. is doing her second 3 year term as the Southwest Regional Trustee.
- Delegate Chose Agenda Items:
 - Rebuilding Alateen Meetings after the Pandemic
 - o Open discussion on attracting members into Service
- AFG Inc. Finances: 2022: Revenue: \$4,211,517, Expenses \$5,589,860 Change in net assets: 1,378,343
 Contributions: 2022 was a record year.
 - Contributions come from: Appeal, bequest, group, individual, memorial, other, birthday, PayPal app. literature sales.
- Program Services: register new groups, supports international structures, maintains and updates meeting locations, produces exciting new literature, prepares program and staffs the WSC, maintains our website, mobile app, enhances communications, and develops PSAs, attends professional conferences to share the AI- Anon message.
- 2023 projects: electronic meeting transformation, mobile app upgrade, international structures meetings, international convention
- The power of \$1: 1952 moral of the story: think abundantly
- Interpretation into Spanish and French at WSC.
- Al-Anon Longitudinal Study is a 5-year study, it shows how there is a benefit to members' health and well-being.

- International Service meeting: coordinated by WSO, held on even years, for national structures, zonal meetings.
- Stepping Stones and WSC in New York. WSC discussed whether to continue to have WSC in New York every 3rd year so Delegates can visit Stepping Stones. It is more expensive there.
- Diversity, Equity, Inclusion Workshop: Debby Irving, an author, did a 3-hour session with her. This is the first of many discussions. Want to attract more to our membership.
- 2022 Annual report: will be published this summer and available on Al-anon.org.
- A Visit to the WSO in Virginia Beach: this was Panel 61, all Al-Anon members are welcome to tour the WSO.
- 2024 World Service Conference will be April 18-21, 2024.

Comments:

Vicki thanked him for his thorough report, it opened up a large opportunity for the Spanish speaking community to become delegates. She wants to invite some of them to join her on the Welcoming committee for the Road Trip in October.

Questions:

Kristen D66: Are they looking into different investment opportunities? They can't seem to separate the global and regional meetings?

Tim: Yes, they are. There are 4 different investment groups, there is a conservative approach. We need to think abundantly.

Josefa D64: Will the meetings be hybrid for international?

Tim: Will only get some of the big meetings, some of it will be translated.

Nick D17: Would like to talk to Tim to help get participation from younger members. His meeting has a lot of diversity.

Tim: Maybe with the SOS, we could have a workshop on it. Let's talk to Donna about it.

Ruby D27: Is confused about the role of GRs in global communities. Service Manual does not address that. What was concluded from the workshop that she can take forward?

Tim: They do have their own Assemblies, they are still working on it.

Terri D33: Has a question about copyright. Some meetings have added "social media." Can we add that? Can we have an Al-Anon Facebook page?

Tim: Encouraged her to look at the slides on presentation since it is a more thorough answer to her question, to look at the app, need to be careful with anonymity. Can email WSO as well.

Eileen D57: Sometimes her meeting screen shares. Should we include something with script re: not taking screenshots?

Tim: We can briefly show CAL, encouraging her to look at all 9 slides.

Kathleen D17: Language: interested in increasing language accessibility? She is willing to help with that. Stock Market investments: how do we know what we are investing in? How do we make sure it's not controversial?

Tim: It is on the website.

Teresa: Geographic Electronic groups can be found separately in mid Fall. It will be searchable.

Marce: About sharing CAL?

Vicki: There were some guidelines, can screenshare, need to add verbiage that it came from a specific piece of literature.

Elaine D27: Do they need to be registered to be listed? Many of her meetings do not have a GR.

Tim: Yes, need to be registered to be listed.

Vicki: Suggested she contact Teresa so they can work on it.

Nate D27: Can they pick the district they want to be part of? area?

Tim: His meeting began in D27 and will remain in D27 even though members have voted to become an Electronic group. You can be in global or a specific geographic area.

Jonathan D66: Still unclear about the investments.

Tim: We have an ample reserve for 9 months, we could have 1 year.

Jonathan D66: Wanted to know how money is being invested.

Tim: It is a conservative approach, they do not play the stock market.

Laurie D54: Re: app, are they considering other phones or just iPhone?

Tim: Working on it, constantly updating and making it user friendly. The App works on both iPhone and Android. He will check and get back to her.

Lydia D45: Where are 9 slides he's referring to?

Tim: It's under Copyright and Trademark.

Jon: Will work on getting it on the website.

Vicki: Chat is for clarification purposes, not to comment or give advice.

Conna D15: Do I need to buy literature from WSO vs. Amazon? Our meeting is now in person, there is another one that downloaded app on Samsung and it came up perfectly.

Tim: They are working on it, need to change registration information with Teresa.

Micheila: She is working with Jon on how to handle CAL and online meetings, they will send out on a Listserv. Had a meeting with John Coffey from WSO with other literature coordinators. Please support local AIS/LDCs to get literature.

Peter D45: Has he seen hesitancy re: electronic transfer of money?

Tim: I think people are getting more creative. Anonymity is an issue with personal Venmo accounts.

Tim: Trustee Kathy Maggio will be the chair for WSC, Jayme will be the co-chair. Road trip: Jayme and Cindy Medford are on that committee as well.

5. Concepts Read by:

6. Delegate Election Procedures -- Marcia M, Miriam M. and Willie W. Past Delegate

- The minority voice was asking for more information on the process.
- In our area, it's the same for the Delegate and Alternate Delegate.
- It is on the website.
- Chairperson is the Election Chairman.
- A ²/₃ vote by GRs indicates acceptance of the Election procedures.
- First ballot: Candidate receiving $\frac{2}{3}$ vote is elected delegate.
- Second ballot if no names are withdrawn.
- "By lot" then it is taken from a hat.
- Willie: Out of 15 panels: 9 were elected "by lot," 4 were elected by ⅔ majority, 2 delegates were only candidates standing. Service Manual 156-157, 229, 139-140, 199; Paths to Recovery p. 303
- Surveyed other areas on AFG Connects. 19 other areas responded. 9 areas use "by lot" if there is not a ²/₃ majority after several ballots, 4 areas responded they follow the service manual, 3 use simple majority if there is not a ²/₃ majority. 1 area, last 3 panels have only one candidate. 2 outlined different procedures. 2 final choices of simple majority or by lot, they vote that day which they would prefer to do.
- We are discussing this because we have an election assembly in November.

Questions:

Bobby D21: How are officers elected?

Marcia: Reviewed the process of sending in ahead of time, they are put on the website for members to look at. They don't know until that day what position they are running for.

CB D54: The numbers to reflect abstentions in the votes. Also she'd like to hear from Tim if he'd share when he ran for a position and didn't get it because of the by lot procedure.

Jon: How would we do "by lot" on Zoom?

Marcia: We would watch the person online how they do it.

Rick G. D66: Are descriptions for these officer positions in the Service Manual?

Marcia: Yes, in Service Manual and there are job descriptions on the website.

Ruby D27: How would using this process help or hurt the minority opinion?

Willie: It allows someone to bring forth their point of view that may change the opinion of someone who voted in the majority, would have the vote again. Concept 5 helps avoid the tyranny of a decision.

Kristin D66: Do DRs get to vote?

Marcia: Only if they are a GR at the assembly, DRs can vote at committee.

Bernadette: Who does the By Lot procedure?

Marcia: In the past, it has been a past delegate, someone who has no stake in the outcome.

Bernadette: What if they are a GR for a delisted meeting, can they run for delegate?

Marcia: They are still an Al-Anon member.

Peter D45: What is expected of a candidate? Where do you get an application?

Marcia: It is on the website.

Christy D54: Trying to navigate these forms online, they don't seem up to date.

Marcia: Said they need to be updated.

Lydia D45: Does the resume only entail just service in Al-Anon? Could you add volunteer and work experience if it relates to the officer position?

Vicki: Said it's more of a questionnaire.

Kathleen D17: Numbers would be different if doing a vote vs. by lot.

Willie: If one of the naysayers has a voice, they will be heard. It could change the way the vote goes, then the group would have to vote again.

Miriam: We vote again but candidates don't speak more or give more statements.

Tim: Twice he was in the hat to be delegate and was not chosen. The 3rd time he was selected he was unopposed. It has spiritual roots. It is turning it over to a power greater than ourselves. He thinks there is a bias in the term simple majority.

Marcia: We don't need comments today, just questions since we are not voting.

Eileen D57: Not understanding what we would be voting on?

Marcia: Said we would vote on whether or not to vote that way each time or make a vote in general for all to follow.

Jon: Don't hesitate to go through the resume to see what's on it, don't have to submit until the very end.

Teresa: Wouldn't it make more people unhappy if we do simple majority? 51 would be happy, 49 would be unhappy.

Marcia: We want to make sure we are clear and transparent.

Caitlin D54: Where can I find this information after the meeting?

Marcia: This information is already on the website. It has been translated into Spanish.

Tina D21: Is there a short version of this to share at a meeting?

Marcia: No, you could print resumes and have the group discuss the candidates. The day of the election the candidates get 3 minutes to speak.

Willie: We talk about the right of decision. They elected you as the GR, so you get to make the decision as the trusted servant. Is Concept 3.

Denise D9: How are candidates elected?

Marcia: Officers are a simple majority vote, only Delegate and Alternate delegate are ²/₃ majority.

Miriam: There is a Higher Power. We are blessed to have so many qualified people.

Jon: Showed the website where to submit the resume, area election information, resume instructions.

Marcia: They will update the Quick Reference Guide on the website under when you click on election information. If you search election procedures, election procedures document comes up.

Ruby D27: Who is the delegate accountable to?

Tim: GRs are accountable to their group. Concept 1: GRS, DRs, Officers, Coordinators are accountable to the groups.

Marcia: Delegate is the voice for the area when he goes to WSC. Then he reports back here at the assembly under Delegate's report.

Rob D40: Will the candidates be able to speak and introduce themselves?

Marcia: Yes

Peter D43: Are we tweaking election procedures a bit?

Marcia: If after several ballots cannot come to a consensus, we go to "By lot." There are some members who are not happy with that piece. This is just a consideration. It is up to the GRs. It will be based off of the November GRs.

Norma Jean: Referenced Service Manual p. 154-157.

Tim: We really do listen to the rights and appeals of the minority.

Tannis D63: Someone abstaining might be someone who doesn't have enough information. She's seen it done where they ask the person why they are abstaining.

Cathy: This donation was contributions. This is what we do in Al-Anon. We usually have more operating costs. We cannot hold onto any money.

Conna D15: Her group sends money, we thought this was for CA operating funds.

Vicki: We keep an ample reserve; if it goes over, we send it to our service arms.

Cathy: We haven't made any contributions in 2023 for 2022.

Elaine: Could we do more advertising?

Miriam: Every year we do contribute anything that is over the prudent reserve. The GRs did vote on it.

Erika D21: Was wondering if we could show what SCWS does just like what we showed what WSO does?

Willie: We don't need to vote on it, she is showing what historically happened. If any changes need to be made, then we vote on it.

Teresa: 180 registered voters

Conna D15: Does need to be voted on, we have not met in office since the pandemic so that explains why we have more money.

Donna: We have a PO box but not a physical location/office.

Tim: At the WSC, we do accept the report for the 2022 audit. We are just voting that we saw it, discussed it.

Marcia: We only approve what is coming up, not what has already happened. We want to keep it to just questions right now so it doesn't get confusing.

Kathleen D17: Thinks we should wait until the Spanish group can see report.

Jon: It has been fixed.

VOTE: Laurie D54: Moved to accept report as provided. Rob D40 seconded Yes: 82% 141 + 5 spanish No: 1% Not a voting member: 16%

Donna: Explained who has voice and vote at the assembly.

Cathy: Reminded groups to put their WSO ID#. It is very helpful. Please include email so she can email back a receipt. Please do not send cash, only check or money orders if mailing.

Vicki: Said one member in her home group uses their personal credit card, the group reimburses her so she can make the payment.

Cathy: We've told our coordinators if they have a project, to let the treasurer know. But everything has been different since Covid.

Archives

Do you have a home group? Did you regularly attend a meeting or meetings until you made a connection? Did any longtimer suggest you choose a meeting when you were new that would be one meeting you regularly attended? A home group. That this is a good way to begin to learn about you they might have said! Listen to the shares in the meeting and identify! Listen for the similarities and not the differences!? For many of us, this was our path. Those in the meeting who came before us, giving us experience, strength and hope as we began our journey.

Archives are very important for most organizations. How did it start? Who were the founding members? What was the mission? For us, Al-Anon's main archives are with the WSO in Virginia Beach. Those are for the entire fellowship of meetings worldwide. Locally, in Area 4 of California South we have historical records that go back to the early 50's. 1951 was officially when Al-Anon organized as one organization. Within our area we had Alcoholics meeting since the 1930's and their families began to meet in church basements and rooms beyond the AA meetings. I believe many of you would have loved to be in those early meetings. They did not have email, chat messages or phone access like we do. Sharing what was going on in the home could only happen in a few ways. These opportunities opened a door. All of those women and men met and began what is now a worldwide fellowship. As the current archives coordinator, I am continuing on to collect the meeting histories of our Area. Those early meetings? We have some histories in our archives, but nowhere near the 1200 plus meetings in our area. It will take so many more of you to assist with this project. The more time passes, the less we remember. Just over 70 years of history. Meetings are meetings, but the internet and electronic components have changed meetings and that history is important.

Next it is about you, the members. Tell us a bit about your first meetings and why you kept coming back. First name and last initials. Historical recording of how our members came to find Al-Anon and what kept them coming back. Those members are you. There is a fillable form for that as well. The DRs will get the forms. We have a number of histories, yet just a fraction. Every one of us is important. Every voice. Every story.

It is also time to hold our 2023 Longtimers meeting. It will likely occur in late October or early November. #2: Our on-line Registration/Group Records Change Form

Our members continue to use our forms and all the AIS/LDC/District sites link to it. Some members are still using the WSO Group Records change form on the WSO website, which does not offer submitting information for other group positions. The WSO form still gets forwarded to your Area Group Records Coordinator (AGRC) to update your group.

#3: Reported Not Meeting, Bounced emails (CMA emails no longer working or incorrect) and No Mail (CMA's US mailing address is getting returned to WSO) are an on-going issue that has greatly improved due to the newer time constraint that after 94-days of Reported Not Meeting groups with groups then going inactive. Reported not meeting means a newcomer attempted to go to your group and found no one there. It is a great motivation to find out where and if that group is meeting. I continue working with the DR's and AIS Offices to reconcile regularly.

#4. Groups that have resumed" Meeting in person," has confirmed information for this and shows "Meeting in person" at the front of their location instructions. Groups who have not updated may not show information as we don't know how/if they are meeting. More groups are updating with SCWS so this is getting to be less and less of an issue. We want the same information.

#5 Electronic Groups/Meetings Update: We currently have 73 Electronic Meetings (NOT TEMs) – this is included in the Active meetings # above. Please continue to do your part to check and see if your listed meeting information is correct. If your group doesn't need a mask/Covid reference, GRs/CMAs just email me with your WSO ID#, group name, day, and time it meets and the information – to grouprecords@scws-al-anon.org

All registered Al-Anon Family Groups (AFG) in active published status are listed on the World Service Office (WSO) "find an Al-Anon Meeting" online directory at al-anon.org. The WSO maintains other information on registered groups, but the meeting directory listing is very important, as the WSO website is typically the first place a newcomer finds a group. In addition, your group is listed on your local Al-Anon Information Service (AIS), Literature Distribution or District Website. We all can agree – we want that information to be the same and to be accurate. We are now listing our Area's Electronic Groups (NOT physical groups meeting temporary electronic, but Electronic) on the Southern California World Service website under "Find a Meeting." We will continue to do this until our WSO can list geographic electronic groups. They aren't able to give us a date, but it should be no later than sometime this Fall. They are working on it.

Visit the WSO website at https://al-anon.org/al-anonmeetings/find-an-al-anon-meeting/ and see if your physical group listing is up to date – or temporarily at scws-al-anon.org under "Find a Meeting" – if your group is Electronic. Note: The Group Representative (GR) or Current Mailing Address (CMA) member, if different than the GR, should be providing the updates for your group.

A special note to District meetings and/or events! There is no insurance coverage for any District meetings or District events, even if there is a meeting at the location. Any meeting that is having an event, i.e. Anniversary, etc. on the same day as the meeting, the insurance will cover and we can provide a Certificate.

So, if you are looking for a new location for District meetings and/or events, check with the location first to see if they need a insurance Certificate. It will cost your District approximately \$100 and I can offer the information for the company to acquire the Certificate (it is not the Al-Anon insurance Company) - do not hesitate to contact me 619 254 3432!

Reminder that any group not officially registered with WSO are NOT covered by our insurance. BUT, if you are a registered group and are meeting in a location that does NOT request a Certificate you are covered by the Al-Anon insurance.

And finally, I have thought that some groups and/or districts are still using their own insurance. Remember our insurance covers all meetings registered with WSO and we do not charge for any Certificates, if required. I'd be happy to get you the Certificate you need.

- **AGRC**: Area Group Records Coordinator. Keeping group information up to date is vital to assuring that the most accurate meeting information is provided to persons seeking help in the AI-Anon and Alateen fellowship. Accurate records also keep communication flowing between the group and the WSO, and the group and local service arms (pg. 46). It is essential that groups promptly report changes in their meeting location, meeting day, time, Current Mailing Address (CMA), Group Representative (GR), or phone contacts to their AGRC...(they) serve as a link between the WSO and local trusted servants (pg. 67). The AGRC can provide group reports to verify that the information on file is current (pg. 46).
- AIS: Al-Anon Information Service. A local service established and maintained by one or more Districts or by groups located close enough geographically or connected by language to one another for easy access and communication. Holds periodic meetings attended by all the Information Service Representatives where activity reports, including a financial update, are made and matters regarding the groups are discussed (pg. 65).
- **Area**: Areas are comprised of groups and Districts in a determined location that can be geographically or nongeographically defined. Every group in the Area has a voice and a vote in Area business through their Group Representative (GR). The Area Assembly is the business meeting where the groups send their representatives to express a voice and vote on behalf of the group. During an Assembly, the Delegate reports the activities of the World Service Conference (pg. 67).
- **CMA:** Current Mailing Address. The CMA is a member of the group who attends the group's meeting regularly, agrees to accept and deliver the group's mail, and anticipates keeping the same contact information for at least a year. The CMA may be, but does not have to be, the Group Representative (GR) or another group officer. Each group needs to have someone who is willing to receive communications and share them with the group, as it is essential to be able to contact the group (pg. 31).

Definitions (continued)

- **District**: The District is the first link from the groups to the Area, the WSO, and the World Service Conference. Districts are comprised of a number of groups within a geographical or non-geographical part of an Area that meet as needed (pg. 64).
 - **DR**: **D**istrict **R**epresentative. Is elected by the GR's from within their District. The DR chairs the District meetings, represents the groups in their District at Area World Service Committee meetings, and serves as a resource and information source for the groups (pg. 74). The term of office is three years. (pg. 153)
 - **ISR:** Information Service Representative. Attends meetings of the Al-Anon Information Service (AIS/Intergroup). Acts as liaison between the group and the AIS. Reports AIS activities to the group (pg. 59).
 - **GR*: G**roup **R**epresentative. Acts as liaison between the group and the District, and between the group and the Area Assembly. Represents the group's concerns and wishes at the District and Area, as well as informing the group of what is happening in Al-Anon in the District, Area, and worldwide. GR 's are entrusted with the Right of Decision to vote on behalf of the group according to their conscience and the good of Al-Anon as a whole (pg. 64). The term of office for a Group Representative is recommended to be three years. (pg.152)

It is suggested that the Alternate Group Representative (AGR)* serve as the Information Service Representative (ISR) and the GR* serve as the Alternate Information Service Representative (AISR) (pg. 66).

* Al-Anon and Alateen members who are also members of A.A. may not serve as GR or Alternate GR. 86-87)

WSO: World Service Office. As the principal service center of the fellowship, the WSO acts in conformity with the wishes of the Conference. It publishes all Conference Approved Literature (CAL). Many functions and activities of the fellowship circulate through this office. It is the center, not the head; it serves, but does not control or direct. The relationship of the WSO to the groups is fully explained in "Al-Anon's Twelve Concepts of Service" (pg. 69).

- **CRGA:** Coordinador de Registros de Grupos del Área. Mantener la información del grupo al día es esencial, garantizando que la información más precisa se les brinda a las personas que buscan ayuda en la hermandad de Al-Anon y Alateen. Los registros precisos también mantienen la comunicación fluyendo entre el grupo y la OSM, y entre el grupo y las ramas de servicio locales. (Pág. 46). Es esencial que los grupos les informen con prontitud sobre cambios en su reunión, ubicación, día y hora de reunión, Dirección Postal Actual (DPA), Representante de Grupo (RG) o contactos telefónicos al Coordinador de Registros de Grupo de la Zona (pág. 46). Los Coordinadores de Zona sirven de enlace entre la Oficina de Servicio Mundial y los fieles servidores de la localidad (pág. 66). El Coordinador de Registros de Grupo de la Zona puede brindar informes de grupo para verificar que la información en archivo esté al día. (Pág. 46).
- SIA: Servicio de Información Al-Anon. son centros de servicio local establecidos por uno o más Distritos o por grupos localizados suficientemente cerca geográficamente o conectados por el idioma entre sí para facilitar el acceso y la comunicación. (pág. 64). Celebra reuniones periódicamente con la asistencia de todos los Representantes de Servicio de Información donde se hacen los informes de las actividades, que incluyen una actualización sobre finanzas, y se discuten asuntos concernientes a los grupos. (pág. 65).
- **Área:** Las Áreas (Zonas) están constituidas de grupos y Distritos en una ubicación determinada que puede estar definida geográficamente o no. Cada grupo en la Zona tiene voz y voto en asuntos de la Zona por medio de su Representante de Grupo (RG) (pág. 66). La Asamblea de Zona es la reunión de asuntos de grupo a la que los grupos envían sus representantes para expresar con voz y voto en nombre de su grupo. Durante una Asamblea, el delegado informa sobre las actividades de la Conferencia de Servicio Mundial (pág. 67).
- **DPA:** Dirección Postal Actual. El encargado de la DPA es un miembro del grupo que asiste a las reuniones del grupo por manera regular, está de acuerdo en aceptar y entregar la correspondencia y sabe de antemano que mantendrá la misma información de contacto por lo menos durante un año. El encargado de la DPA puede ser, aunque no tiene que ser, el Representante de Grupo (RG). Cada grupo necesita tener una persona que esté dispuesta a recibir comunicaciones y compartirlas con el grupo, ya que es esencial comunicarse con el grupo (pág. 31).

- **Distrito:** El Distrito es el primer enlace de los grupos con la Zona, la OSM y la Conferencia de Servicio Mundial. Los Distritos comprenden un número de grupos dentro de un área geográfica o no geográfica de una Zona, que se reúnen según sea necesario (pág. 64)
 - **RD: R**epresentante de **D**istrito: Es elegido por los RG dentro de su Distrito. El RD dirige las reuniones de Distrito, representa a los grupos de su Distrito en reuniones del Comité de Servicio Mundial de la Zona, y sirve como fuente de ayuda y de información a los grupos (pág. 74). Este cargo es por un periodo de tres años (pág. 153)
 - **RSI**: Representante de Servicio de Información. Asiste a las reuniones del Servicio de Información de Al-Anon (SIA/ Intergrupal). Sirve de enlace entre el grupo y el SIA. Informa al grupo sobre las actividades del SIA (pág. 59)
 - **RG: R**epresentante de **G**rupo. Es el enlace entre el Grupo y el Distrito. Representa las inquietudes y deseos del grupo en el Distrito y la Zona, así como también informa al grupo de lo que sucede en Al-Anon en el Distrito, en la Zona y en todo el mundo. A los RG se les confía el «derecho de decisión» para que voten a nombre del grupo de acuerdo con la conciencia de los miembros y el bien de Al-Anon como un todo (pág. 63). Se recomienda que el periodo de servicio de un Representante de Grupo sea de tres años (pág. 153)

Se sugiere que el Representante de Grupo Suplente* sirva de Representante de Servicio de Información (RSI) y que el RG* sirva de Representante de Servicio de Información Suplente.

*Los miembros de Al-Anon y Alateen que también sean miembros de AA no pueden desempeñar los cargos de RG ni de RG suplente (ver págs. 86-87)

OSM: Oficina de **S**ervicio **M**undial. Como la OSM es el principal centro de servicio de la hermandad, actúa de conformidad con los deseos de la Conferencia. La OSM publica toda la Literatura Aprobada por la Conferencia (LAC). Muchas de las funciones y actividades de la hermandad se realizan a través de esta oficina. Es el centro, no la cabeza; sirve, pero no controla ni dirige. La relación de la OSM con los grupos se explica con más detalle en los «Doce Conceptos de Servicio de Al-Anon» (pág. 69).
