

#### 2. Twelve Traditions (5) Read by: Norma Jean W. District # 66

One of the DRs asked why the Bylaws Update vote was not included on today's Agenda as the Area World Service Committee (AWSC) members had voted in February to include it. Chair explained that a decision had been made at the AWSC to put the Bylaws on today's Agenda: the Minutes for that meeting are in the Bulletin, <a href="https://www.scws-al-anon.org/bulletin/">https://www.scws-al-anon.org/bulletin/</a>. She referenced an email that she'd written to the AWSC members on May 16 in which she explained that subsequent to the AWSC meeting, a Board meeting was held at which some members expressed concerns about whether the Bylaws Updates were ready to be voted on. Also there was no Knowledge-Based Decision-Making (KBDM) presentation. Therefore, the Chair decided not to put the Bylaws Update discussion and vote on today's Agenda.

4. <u>Secretary's Report</u> - <u>secretary@scws-al-anon.org</u> Donna E.

Approval: November 2023 Assembly Minutes (15)

Donna noted that there are two versions of the November Assembly Draft Minutes posted on the scws-alanon.org website: "Draft Minutes" and "Amended Draft Minutes". In the future, the first Draft will be posted on the website and members are asked to contact the Secretary prior to the Assembly if they have corrections to that Draft. Those changes will be incorporated into an Amended Draft (with changes highlighted for clarity) so that all members can see the amended version prior to the vote to accept the Minutes. Changes to the Minutes will also be requested at the Assembly.

Gene L., GR72, moved to approve the Minutes. Mykel M, D27 seconded.

Donna gave a Secretary's Report (which will be published in the *Bulletin*, and is included as an Addendum at the end of these Minutes). Her Report addressed today's Agenda and the absence of the two Agenda items that had been voted on by the February Area World Service Conference (AWSC) members, who set the Agenda for the Assembly. A third item, the results of the Annual Financial Review, was also not on the Agenda. She requested that the Chair revise today's Agenda to include those items.

- Micheila: Talked about her process of being a new Chair. She thought that many Group Representatives (GRs) were unfamiliar with KBDM and she wanted to ensure that our GRs understand how it works. She has balanced sharing information with our members with avoiding public controversy, and has attempted to behave in the spirit of our principles, fostering loving interchange and working together in unity.
- Chair asked for members to raise their hands to speak: 41 members asked questions and/or made comments.
- Members were reminded to raise their hands, to be called on by the Chair.
- Several members expressed concern that the request for changing the Agenda was out of order, and
  that it's the Chair's prerogative to set the Assembly Agenda. Some members viewed this as an issue of
  respecting the Chair's autonomy in the context of Concept 3: "The right of decision makes effective
  leadership possible." There were also concerns expressed about double-headed management.

- Several members expressed concern that the AWSC group conscience vote was ignored; they supported
  altering today's Agenda to include discussion and vote on the Bylaws Updates, thus honoring the vote of
  the AWSC members.
- -Two Officers brought up the following conflicts among the Officers that have interfered with their ability to meet and make decisions as an elected body.
  - a. The Officers voted not to affirm the candidate for Interim Treasurer based on two concerns: 1) she had not been a DR, a requirement for the position, and 2) at an Officer's meeting, she acknowledged having misappropriated funds from the District for which she'd been the Treasurer a number of years ago. The Officers discussed this twice. After the second discussion, three Officers and the Immediate Past Delegate voted not to affirm the candidate. The Chair subsequently appointed her as Interim Treasurer. The Officers did not recognize that as a valid appointment as it was not consistent with the group conscience vote. Subsequently, a number of treasury processes were affected by this disagreement—among them, the former Treasurer, Cathy S., continued to deposit checks into the SCWS accounts so that our member's' contributions were deposited in a timely manner.
  - b. There have been some financial irregularities that have concerned the Officers. Expenditures below \$500 may be approved by the Treasurer; expenditures over \$500 and below \$2,000 are to be approved by the Board of Directors (Officers). The Interim Treasurer approved several expenditures above \$500 without consulting with the Officers. Our Chair took out a cash advance of \$1,100 without consulting with the Officers or subsequently responding to the Officer's request for an explanation of the use of the funds. Although a portion of the cash advance was spent on expenses for the Southwest Regional Delegates Meetings (SWRDM), the Officers had questions about some of the expenditures which were not answered. The Officers have fiduciary responsibility for the 501(c)(3) and have an obligation to ensure that our finances are handled properly.
- Several members noted that comments in the "Chat" are out of order. Members asked that participants maintain decorum and respect for one another.
- One member, who performed the annual financial review, expressed concerns about the financial review not having been included on today's Agenda. She expressed concerns about misappropriation of funds that need to be addressed specifically and in a timely manner. She also requested that we give Cathy S. "voice" at this meeting so that she could talk about the Area's finances. No vote was taken.
- A member made a motion (and it was seconded) to vote on the Alternate Agenda. The Chair explained that within the KBDM process, motions are the result of discussions, and unlike in Robert's Rules of Order they come at the end of the discussion.
- Some members were appreciative of the group for addressing these concerns publicly while others
  expressed the desire for the Officers to address their conflicts through a conflict resolution process apart
  from public meetings.
- It was noted that both the Board of Trustees of AFG, Inc., and other Areas have faced similar challenges
  and conflicts and have availed themselves of conflict resolution processes, provided by the World Service
  Office staff, to resolve internal conflicts.
- 12:26pm: Chair asked the members if they felt that they had enough information to vote on whether to have the Bylaws discussion after lunch. There was not enough clarity about the issue to hold a vote before lunch; it was decided to hold a vote after lunch.

12:40: <u>Lunch Break</u> (30 mins)

1:10pm - meeting resumed

#### VOTE: Would you like to have the Bylaws added to our afternoon Agenda?

Prior to the vote, one of the members of the Bylaws Committee noted that the Bylaws are intended to demonstrate that we comply with the laws of the State of California. In addition to the Bylaws, we should have an Area Procedures Manual that would contain many more details (than the Bylaws).

#### Questions:

- There were a number of questions about financial procedures:
  - Who oversees the finances and ensures that spending is done properly and accurately?
    - The Chair, Treasurer, other Officers and Finance Committee
  - Who oversees the oversight of disbursement of funds?
    - In most organizations, one group disburses the funds and another group oversees that disbursement. The Area has had a Finance Committee in the past; the Committee has not met since January.
    - The Chair announced that a "Board Governance Committee" was going to be formed.
    - The Chair is required to oversee the checking accounts.
- We have Financial Guidelines. The Treasurer can write a check for up to \$500, anything above that needs to be approved by the Officers (Board of Directors). All expenditures over \$2,000 must be approved in advance by the Assembly. (This motion was approved at 11-19-1994 Assembly.)
- One of the members who performed the audit noted that she had emailed the Chair asking about the financial statements and why they're not on today's Agenda. She noted that she did not receive a response to her questions:
  - When was the Interim Treasurer appointed and where are the Minutes that document that appointment?
  - When will the financial statements be provided?
- Some concerns were expressed regarding the process for choosing a Treasurer and the qualifications required for that position.
- Several members noted that the financial report did not provide the details regarding income and expenses that have typically been included in the financials at Assemblies.
- One of the Area's Certificates of Deposit (CDs) for \$5,200 matured and was re-invested. Only the Chair is currently listed on the CD. The new Treasurer or other Officer will be added to the CD after today's election
- When will more specific financial information be available?
  - o Once the new Treasurer comes on board, s/he will provide it on the website.
- What is the status of the Finance Committee? First, elect the new Treasurer. Then reconstitute the Finance

Committee. One of the Finance Committee members has attempted to contact the Interim Treasurer and Chairperson and has not had a response.

- One member requested that people who are answering questions answer succinctly.
- Does the Finance Committee oversee the financials? A GR from 69 with a background in finance volunteered to help.
- Several members thanked the Interim Treasurer for taking on that role.

#### 7. Area Elections: Alternate Delegate & Area Treasurer (30) - Chairperson Micheila L.

- A. Candidates: Each has 2 minutes at the Zoom mic to share their background in Al-Anon service and read the response from their Service Resumé to the question: Why would you be an asset to the SCWS Area?

- C. Vote is either: **YES / NO / ABSTAIN / NOT A VOTING MEMBER**Reminder: For Voting members choosing to abstain: abstentions are not counted.
- Chair-read presentation regarding the recent history of the elections
- One person asked that the former Treasurer, Cathy S., be given a voice so that she could speak to the kinds of skills that a prospective Treasurer would need to have.
- How do we know who is standing for what positions? We find out the day of the election.
- The Chair noted that there had been some problems with our Area's listserv message process, and a number of emails had gone into members' spam folders. We will be reviewing our email processes so that our emails get through more reliably. One DR wanted to submit her resume for the Treasurer position after the deadline for submission. The Board members participated in an online discussion about this and agreed not to accept the resume.
- Being/having been a DR is one of the qualifications of the members standing for an Officer position.

The Chair began by reading the *Election Procedures*.

Secretary's Report

Good morning, everyone.

As your Secretary, I don't usually give a Secretary's Report. This morning is an exception—because we've had some exceptional things happening in our Area that I want to address before going back to taking the Minutes. This report will be published in the *Bulletin*, in its entirety.

As the Area Secretary, it is my duty and responsibility to ensure that accurate Minutes are taken at every Officer's, Board, Area World Service Committee (AWSC) meeting and Assembly.

For those of you who are new to service at the Area level, there are

- five elected Officers (legally the "Board of Directors"), and
- an additional 17 Coordinator positions, which comprise our **Board**.
- The AWSC or "Committee" is made up of those 22 members above plus
  - 29 District Representatives,
  - 4 Area-Recognized Convention Chairs,
  - o 7 Liaisons from Al-Anon Information Service Offices, and often
  - 4 Past Delegates,

for a total of around 66 people. The Committee meets "between Assemblies **to plan the Assembly agenda** and deal with other Area Business, as needed." (*Service Manual*, pg. 75)

• The **Assembly** consists of all of the above plus as many GRs as possible. When we met in person (in Glendale, pre-pandemic) we would have 350 attendees. All of the above members have a voice at the Assembly but *only GRs vote*.

At our February AWSC meeting, the attending members held several votes. The relevant ones are:

Poll: Bylaws to be discussed and voted on at May Assembly: 30 Yays; 6 Nays; 5 Abstentions

**Poll:** Meet virtually for the May Assembly and at that Assembly, ask the GRs what they would like to do as far as **meeting either hybrid or virtually only.** (Task Force to present venue options for consideration at that time.)

Yays = 33. Nays = 0 Abstentions = 2

One of my duties as Secretary is to follow up on significant items at previous meetings to ensure that they are not "lost" or forgotten and that subsequent Agendas accurately reflect—and follow up on—important items in the Minutes of those previous meetings. As your Secretary (and as an Officer), I am concerned that these items

were not included on today's Agenda as that does not accurately reflect the will (the **votes**) of the February Committee members.

#### Why the Bylaws Update is not included in today's Agenda

Two nights ago, our Chair sent out an email to the AWSC members explaining her rationale for not including the Bylaws discussion and vote on today's Assembly Agenda. (She did not mention the second issue, regarding the hybrid or virtual-only Assembly.) Per that email, the following were her reasons for not including the Bylaws discussion and **vote** on today's Agenda.

- She explained that at a Board meeting subsequent to the February AWSC meeting, there was a discussion regarding the Bylaws Updates and that some Board members had "doubts and concerns" about whether the Bylaws were ready to be voted on. As your Minutes Secretary (and a former Chair), I do not agree that that is a valid reason to ignore the issue today.
  - The Board members had already participated in a discussion and voted at the AWSC meeting in February. Their votes still "stood."
  - If there are Board members who have serious concerns about the Bylaws, then it is proper order for them to bring those up during the questions and comments period, before voting.
     Concern or doubts are not a reason to not have the discussion and vote—they become a part of the discussion. Those concerns are the reason why some people vote no rather than yes.
- Our Chair explained that there wasn't enough time on the Agenda for a proper discussion of the Bylaws. It must be noted that there is a 45-minute KBDM/Conflict Resolution presentation by Ann H. on the current Agenda. While I love and admire Ann H.--and enjoyed working with her to develop our Area's KBDM Quick Reference Tool years ago—my opinion is that that is a lot of time to spend on the Agenda when we have more pressing business. That addition guarantees that there would be "no remaining time" for the Bylaw Updates discussion and vote. We could ask Ann to give a short, 5-minute overview of KBDM—which would free up 40 minutes in this morning's session.
- The Chair removed the Revised Bylaws document from the website with no discussion or vote, in order to "allay any confusion."
  - o It has since been re-posted so that everyone can read it at any time.
  - This document has been on the website for many months and we have had no evidence that our members have been "confused" by it.
- The Chair noted that a KBDM presentation had not been presented to the Committee.
  - Of course there wasn't a KBDM presentation. The issues that go into the Bylaw Updates have already been discussed and voted on (after sometimes multiple KBDM presentations). The inclusion of material to the Bylaws is simply "routine housekeeping" – an inclusion of relevant items into that document.
  - o If anyone has any questions or concerns about the Bylaws, they get to voice those during the "comments" period prior to voting.

The discussion/vote on holding either hybrid or virtual-only Assemblies is not on the Agenda. In addition to the Bylaw Updates issue, the Committee members voted to ask the GRs whether they want us to pursue holding hybrid Assemblies in the future—partly because the cost could be considerably more than the \$2,000 limit that the Board can approve. I don't know why it isn't on the Agenda; it should be.

#### The results of the "annual financial review" are not on the Agenda

Our former Treasurer, Cathy S., updated the AWSC on the progress of the team that would be performing our annual financial review (previously referred to as our annual audit). That review was performed and a document was authored by the two members who participated in it, Toni N., a retired CPA, and Eva B., former Area Treasurer. Both people signed the review document and one of them prepared and signed the Observations and Recommendations, which are important for our members to read. As far as I can tell, the results of the review are not specified as one of the items under the Treasurer's Report. Perhaps this document will be presented as the "Finance Committee Update." I hope that is the case. If it is not there, it should be.

Finally, as an elected Officer of our 501(c)(3), I (along with all of the Officers) have both traditional and legal responsibility to ensure that our membership is being served in accordance with our Legacies and the laws of the state of California.

<u>I believe that our Officers (and Board/AWSC/GRs) are obligated to honor the group conscience vote.</u>
Why do we meet as a Committee, discuss and vote on items for the Agenda, if another body or individual can disregard that vote? That is not how Al-Anon works.

Because of that, I am proposing that an alternate Agenda for today (below) be discussed and adopted by the GRs–an Agenda that is based on the group conscience vote of the February AWSC and that includes the three items that are missing from the first Agenda.

As many of you know, I've had the privilege of being of service at the Area level for 9 years. As your Area Chair, I learned that the three most important things for the Chair to do are:

- model neutrality about issues before the Assembly,
- run all of my decisions by trusted others (especially my fellow Officers) before taking action and to be transparent about that process and how I came to a decision *and*
- abide by the group conscience vote <u>in every matter</u>-regardless of how I personally felt about the issue.

My objection to the way today's Agenda has been composed is not personal. This is about the integrity of our program and whether or not we, as a body, insist that *all* of our trusted leaders abide by the Second Warranty, "that all decisions be reached by discussion, vote and whenever possible by unanimity" and whether we truly believe and practice that there is "but one authority—a loving God as he may express Himself *in our group conscience*. Our leaders are but trusted servants—they do not govern."

In that spirit, I respectfully request that we discuss this, as a body, and that the GRs who are present **vote** on whether you want to follow an Agenda based on the group conscience of the AWSC (that is, it would include the three items noted above, which are highlighted below) or an Agenda that, at multiple points, does not.

If you vote for the alternate Agenda, it will then conform to the Minutes from the AWSC, as it properly should.

**Your vote** will determine what we will do. Every one of us. You are the decision-makers; we are your servants. When we follow your lead, we earn your trust.

#### **Officer Reports**

#### **Delegate**

The World Service Conference (WSC) held April 18-21, 2024, in Virginia Beach was an amazing experience. It was four days filled with spiritual experiences and information-packed business meetings. overwhelmed, and entranced by the respect and love all the members offered each other. I never realized that there were spiritual principles of the etiquette we practice, staying on topic, limiting our time at the microphone, and actively listening to each other. The days were exhausting and exhilarating with so much to learn. If I could – I would do it again next week! The theme of the Conference this year was Our Path toward Grace, Unity, and Understanding. Something we get to practice one day at a time. The slogan our panel chose – "Panel 64, In Service We Soar."

Attending the WSC as your Delegate was, as we say in at new Group Representative (GR) orientations, like drinking water from a fire hose. So much is presented that it would be impossible to share it all in a few hours. We are all part of a worldwide fellowship, and I am so grateful for what I get to bring back from the Conference and share.

One activity that started the Conference was presented by Panel 62, in their "Sharing Area Highlights." The lights were dimmed, and half the Delegates sat in a circle of chairs, the other half stood behind them. Those standing each received one card that had a quote taken from some of our CAL literature, credited of course. Those standing read their quote in the ear of the Delegate before them with hands placed on their shoulder - some examples were "If we do not change our direction, we are likely to end up where we are headed," Courage to Change, page 17, "It is good to know service is recovery," A Little Time For Myself, page 37. Then we switched and those that stood sat and vice versa. I have to say that tears were streaming down many faces, including mine – it set the spiritual tone for the Conference. I hope we will similarly repeat that exercise in the future as we work in our Area towards unity.

In looking through much of our CAL, I found this explanation of the WSC that shares it quite effectively: from al-anon.org/for-members/world-service-conference-wsc/ "Al-Anon's Tradition Two states: "For our group purpose there is but one authority—a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants—they do not govern."

The World Service Conference makes the group conscience available and effective for all Al-Anon. It is the practical means by which the group conscience can speak; it is the voice of world Al-Anon and the guarantee that our world services shall continue to carry on under all conditions.

The Conference protects Al-Anon and Alateen against a service breakdown; it makes for unity and enables our fellowship to act as a whole upon important matters. This makes it the principal guarantor of Al-Anon and Alateen's harmony and survival." Our SCWS Area has shared over many years that we take great pride in modeling ourselves historically after the WSC, let us all remember that, and I know we will direct ourselves accordingly. Let us as they say at the Conference, 'Continue the Conversation...'

I will report on different portions of the Conference at different times as well as come to visit Districts, separately or as clusters, both in-person or electronically - and we will have a Delegates Corner webpage section on our scws-al-anon.org with new/current information available as it is received.

Some attendee facts: there were 68 Delegates from the United States, Canada, Bermuda, and Puerto Rico. There were also the Board of Trustees, The Executive Committee, and some of the World Service Office Staff, for a total of 90 voting members this year.

<u>NOTE</u>: On Saturday, 9 a.m. – 11 a.m. on July 20, please attend my Delegate's Report Zoom Meeting, look for the information on our scws-al-anon.org website (*flyer also included at the end of this Bulletin*). We will have a Spanish-language interpreter available.

A few miscellaneous highlights to entice you –

• A new Conference Approved Literature (CAL) booklet will be coming out this Fall called Healing Within Our Alcoholic Relationships – A

Collection of Insights From Our Shared Journey, P-95. It is being translated now into Spanish and French. Watch for it! The anticipated cost for purchase will be \$4.00.

- A new piece of literature, possibly a pamphlet or booklet, "Finances in Al-Anon Recovery" received conceptual approval by motion and vote. Although the topics of personal and group finances are discussed throughout Al-Anon's Three Legacies, Al-Anon does not have a single piece of CAL exploring our relationship with finances in recovery. Financial responsibility may not be taught in alcoholic homes, but it can be learned.
- Our new Daily reader, <u>A Little Time For Myself</u>

   A Collection of Al-Anon Personal Experiences
   (B-34), had sales of over \$908,000 in the first six months the highest-grossing year selling piece of literature we have ever had thus far. Income for 2024 is estimated to be lower than in 2023 but has still increased over previous years.
- Next Generation AFG Records. Although it will take time, now anticipated to be up to two years, this will be a huge database improvement and will assist in keeping group information current and findable.
- Al-anon.org had its millionth session on February 24, 2024, reaching this milestone two days earlier than in 2023. That means we are on pace to exceed six million sessions again this year!
- There are five new skits available for Districts and Areas on Sponsorship and Service Sponsorship, from a 30-minute suggested Agenda, a half-day Agenda, to a full day-long suggested Agenda. Contact me if interested!

I am humbled and grateful to serve as your Area Delegate; this service position is making me grow in ways I never quite imagined. Every new and returning service position should make us feel this way. We can also all feel confident in knowing that the worldwide fellowship of Al-Anon Family Groups, which includes Alateen, is alive and well. May we all continue to carry the message of working together in unity to help families and friends of alcoholics.

#### Treasurer

First, let me express my appreciation for the opportunity to serve as Interim-Treasurer from January to May 2024. As a member of our spiritual program, I have the understanding that from my sponsor that when I change my poor behavior and make amends for my poor behavior, the God of my understanding has forgiven me. Forgiveness is the key to recovery, not shaming or name calling for past behaviors. Why do we still bring up the past repeatedly?

Despite the challenges I faced during my transition, it shocked me. Truly, I expected a more supportive atmosphere during business meetings, unfortunately, outbursts from a few members made my transition exceedingly difficult. I did not receive the necessary tools to transition properly to the interim which I found very stressful position, disrespectful. I agreed to be service for an interim position; not a permanent one. Nevertheless, I am grateful to have contributed to a program that has played a significant role in my recovery journey for 34 years. Here is what transpired during my Interim-Treasurer position.

## Southern California World Service (SCWS) January to May 2024 Treasury Summary Summary of Some Key Events and Information

- 1. We have four CDs. One matured in April. We closed it out and opened a new one (8 month term at 4% interest).
- 2. Our taxes were filed on time.
- 3. We have newly refiled DBAs so that members may make contributions payable to SCWS, SCAC and Southern California Alateen Conference in

- compliance with legal and federal banking regulations.
- 4. The Annual Financial Review was in April. Team designated: Eva B., Patty B., and Toni N. Team at review: Eva B. and Toni N. More information will be shared about the Financial Review in the future.
- 5. A major purchase of headsets for interpretation for our Spanish-Speaking members for the October 2023 Road Trip was not disclosed last year, nor in the 2024 Financial Review report. This was shared at the February 2024 AWSC and in the Bulletin: Purchase Overage "August 2023 of Area Translation Equipment—spent \$2,283.74 including tax on the equipment. Our Area hosted the Board of Trustees "Road Trip" in October of 2023, when we discovered that the translation equipment that we bought for our Spanish members many years ago was inoperable. We bought new equipment that exceeded the \$2,000 limit for expenditures without GR approval. Will report this to the GRs at May Assembly." https://www.scws-al-anon.org/wpcontent/uploads/2024/04/Bulletin-Feb2024-

Final.pdf. This was an overage above the Motion made by GRs at the 1994 November Assembly (https://www.scws-al-anon.org/motions-by-subject/):

That the Board of Directors of SCWS of AFG, Inc. be authorized to expend up to \$2000 per transaction for the needs of SCWS between assembly meetings. Such expenditures to be reported to the Area at the next subsequent assembly. The authorization for such expenditures by the board be conducted by phone poll with the treasurer to keep a record of the votes on such poll. All expenditures over \$2000 must be approved in advance by the assembly.

- 6. Contributions made to the Area have not been placed in QuickBooks, and the Area is 5 months behind. The Treasury did not fully transition so there were limited things I as Interim Treasurer could do. The email, computer, checks nor mail forwarding was transferred to me. No accounting has been done in QuickBooks by anyone. As of today, the signers on our Accounts are our Area Chairperson, Interim Treasurer, Delegate and Area Secretary.
- 7. After our new Treasurer is elected to serve for the remainder of this Panel and our Area can regain spiritual, emotional and financial serenity, Finance Committee meetings will have a better climate to operate in.

8. The balances in the accounts are shown in the financial report at the end of this Bulletin.

#### **Coordinator Reports**

#### **Archives**

Welcome to the GRs and Drs in our Area and the entire Area Board!

I am the SCWS Archive Coordinator for Panel 2024-2027. So you ask, "What are archives?" Definition: *archives (plural noun)* 

A collection of historical documents or records providing information about a place, institution, or group of people.

Our Al-Anon Area has had meetings since the early 1950's. Al-Anon published a book called *Many Voices*, *One Journey* in 2011. When you read it, you will see how our area has been part of all the growth of Al-Anon through the decades starting in the 50's. Looking at our early history, I could visualize the large AA groups and the future Al-Anon members meeting near the AA meetings to chat and serve coffee and sweets to the AA meeting members. Long Beach and San Pedro are where our early history has documentation. San Pedro is mentioned in the book, *Many Voices-One Journey*. The book is a treasure of information on the beginning of Al-Anon and every decade that has passed. A worldwide fellowship guided by our three legacies and our members. We are and always will be the voice of the

fellowship. In our area we start in Atascadero and head south to San Diego. We have history to document.

From the official Al-Anon Guideline G30—Area Archives, what material do we have in our area archives? Here are some items I have taken from the Guideline that suggest what we "might" keep.

Possible categories are: • Minutes of the Assembly and District Meetings (List the motions separately for quick reference) • Reports - Committees, Coordinators, and Delegates • Group Histories • Longtime member interviews or recordings • Directories—world, Area, and local • Editions of Area and Local Newsletters • Group, Assembly, Convention, or Event Flyer. There are more besides these.

Area Archives as covered on the Guideline G-30 Area Guidelines—It is stated that we do not keep worldwide archives, but focus more on our area. So, for that, we currently have a number of items from our early history, but we need current happenings. Info from the districts such as meeting histories! That is area archive material. Flyers, newsletters and items like that from the districts. Archive material!

Our papers from our early days were typed or handwritten by our members. Flyers were created by drawing!! Now most items are created on computers and are digital. At any time, you find items listed for your district events, please send to <a href="mailto:archives@scws-al-anon.org">archives@scws-al-anon.org</a>. They will be saved in an archive file I have started for each district.

Look for an email from me in the coming months. I have histories of meetings and a previous Archive Coordinator Charlene, completed a number of oral histories of members. Those need to be transcribed to be accessible to members. I am going to ask districts to help get meeting histories. I know some have been working on this project. I will check my email for flyers to save and check district and area AIS websites, too. I want to connect with all their archive coordinators. Decades from now, our area will show how our fellowship has grown by the outreach, service and love we have freely given to our Al-Anon program.

In gratitude for the members who got here before me and stayed and those who have continued to attend meetings. We are here for those who have not found us yet.

Our members continue to use our forms and all the AIS/LDC/District sites link to it. Some members are still using the WSO Group Records change form on the WSO website, which does not offer the ability to submit for other group positions. The WSO form still gets forwarded to your Area Group Records Coordinator (AGRC) to change your group.

#3: Reported Not Meeting, Bounced emails (CMA emails no longer working or incorrect) and No Mail (CMA's US mailing address is getting returned to WSO) are ongoing issues that have greatly improved due to the newer time constraints that after 94 days of Reported Not Meeting groups with groups then going inactive. Reported not meeting means a newcomer attempted to go to your group and found no one there. Finding where and if that group is meeting is a great motivation. I continue working with the DRs and AIS Offices to reconcile regularly.

#4: Groups that have identified themselves as <u>In</u> <u>person</u>," have confirmed this and show "In person" at the front of their location instructions. Groups who have not updated in ages may not show information as we don't know how/if they are meeting. More groups are updating with SCWS, so this is getting to be less and less of an issue.

**#5:** Electronic Groups/Meetings Update: We currently have (as of 5/17/2024) **234** Electronic Meetings (NOT TEMs) included in the Active meetings # above.

**#6: Registered Group Representatives (GRs).** 58.4% of our groups have registered GRs. We have 1,030 groups/1,234 meetings (95 groups meet multiple times per week).

Please continue to do your part to check and <u>see if your listed meeting information is correct</u>. Email <u>grouprecords@scws-al-anon.org</u> for corrections or submit changes via <u>www.scws-al-anon.org/grouprecords/al-anon-group-change-form/</u>

All registered Al-Anon Family Groups (AFG) in active published status are listed on the World Service Office (WSO) "<u>find an Al-Anon Meeting</u>" online directory at al-anon.org. The WSO maintains other information on registered groups, but the <u>meeting directory listing</u> is very important, as the WSO website is typically the first place a newcomer finds a meeting. In addition, your group is listed on your local Al-Anon Information Service (AIS), Literature Distribution, or District Website. We want the information to be the same and to be <u>accurate</u>.

Visit the WSO website at <a href="https://al-anon.org/al-anon-meetings/find-an-al-anon-meeting/">https://al-anon.org/al-anon-meetings/find-an-al-anon-meeting/</a> and see if your group listing is up to date – under "Find an Al-Anon Meeting" Note: The Group Representative (GR) or Current Mailing Address (CMA) member, if different than the GR, should be providing the updates for your group.

Remember: Every Group needs to have a Current Mailing Address (CMA) who actually attends your group to be <u>connected</u> to our WSO and SCWS. Don't let your group be disconnected!

#### **IMPORTANT:**

If your group is a *Temporary Electronic Meeting* (*TEM*), it's time to conduct a group conscience as to whether the group will return to in-person or become an electronic (California South) group. We still have 46 meetings in this status. All groups should be categorized as either an In-person (with or without Electronic access) or an Electronic group. Geographic Electronic Groups can easily go back to an in-person meeting in the future if the group decides to do so. If your prior meeting facility is no longer available and you can't find a new location, please change your meeting to an Electronic group.

#### **Institutions**

I was contacted recently by a healthcare educator at Mount Saint Mary's College which is in District 27. She would like to start a meeting on campus for students affected by their parent's substance abuse. I will be working with WSO and this academic setting to start a

new Al Anon Meeting.

Heather, the Associate Director of Communications for WSO, contacted the public information coordinators and delegate for SCWS regarding an event in June in San Diego. The Association of Recovery in Higher Education Conference is happening at the Hyatt Regency at Aventine in La Jolla, CA from 6/29/24 to 7/3/24. Heather will be in attendance and requested participation from the area.

There was a request for two speaker panels at a recovery center in Torrance in District 54. The Thelma MacMillan Recovery Center has an adolescent and an adult residential treatment program. Both divisions requested speaker panels. The speaker panels are happening once a month. The adult division is in the process of starting a new Al-Anon meeting that is closed to the public. It is for those affiliated with the recovery center only.

There is also a new meeting starting at the Beacon House in San Pedro in District 54. It is a men's residential treatment center for substance abuse. I am unclear if this meeting will be open to the public or for those affiliated with the treatment center only.

There were some concerns about the Al-Anon meeting in the Women's County Jail in Los Angeles. There were concerns about funding and literature for this meeting. I received clarification from WSO, G-14, our service manual, our delegate and two prior institutions coordinators. Funding is the responsibility of the district that the meeting is located. Surrounding districts can be asked to help support the meeting, fundraisers can be done to raise money, and individual members and groups can donate funds or literature. The area is not responsible for the funding for this meeting.

#### <u>Please note: A certificate is only needed if required</u> <u>by the meeting facility.</u>

Which meetings are eligible? Al-Anon/Alateen/District meetings that are:

- Registered with the World Service Office (WSO)
- "Active" status in the WSO database (must have valid CMA ~ Certified Mailing Address)
- Published on al-anon.org
- District Meetings are now covered.
- In some cases "special events" can be covered. Contact the Insurance Coordinator for more info!

#### #1: Is your meeting's information up to date?

It is very important that *your* meeting details match *our* records (in the WSO database).

To find your meeting's WSO identification number and see if its information is current at WSO, click here: <a href="https://www.scws-al-anon.org/how-to-find-a-meetings-wso-id-number/">https://www.scws-al-anon.org/how-to-find-a-meetings-wso-id-number/</a>

If your meeting changes locations, *YOU MUST* use the Southern California World Service (SCWS) Al-Anon Group Records Change form to make the change: <a href="https://www.scws-al-anon.org/group-records/">https://www.scws-al-anon.org/group-records/</a>. This form goes to our Area's Group Records Coordinator (GRC), who updates our Area's records in the WSO database. If you have any questions, please use the "Comments" box at the bottom of the form and either our Group Records Coordinator or the Insurance Coordinator will get back to you.

#2: Where to find the application for insurance?
To apply for the Certificate of Insurance you must go to the following link: <a href="https://www.scws-al-anon.org/insurance/">https://www.scws-al-anon.org/insurance/</a>

If you change locations, you will need to update your address in the database at <a href="https://www.scws-alanon.org/group-records/">https://www.scws-alanon.org/group-records/</a> and if the new location requires a Certificate of Insurance, use the following form within 30 days of the move: <a href="https://www.scws-alanon.org/insurance/">https://www.scws-alanon.org/insurance/</a>

Again, you must keep your meeting location info updated no matter what! We don't want to take the chance of the insurance company not approving a claim because of a new, different location of a meeting. If the

new location requires a Certificate of Insurance, we must have that information, as your previous Certificate will not work for the new location.

Once a meeting place receives a certificate, it automatically renews each year and is sent via "snail mail" to the meeting place, not original requester.

Hello from District 54 South Bay. We are swimming and surfing "Waves of Gratitude" here in the South Bay which is also our theme for our Alathon June 1<sup>st</sup> where we are hoping for a 150+ in attendance.

District 54 GRs - and regular Al-Anon members - are an enterprising group. On their own, with District support, GRs and members have begun outreach to the professional community attending workshops and providing CAL. They have visited social service offices, chatted with staffers at job development sites and provided CAL to better educate them on how family members can recover too.

We also developed an email with all the links necessary to find a meeting locally (no matter where they are) and stuffed it chock full of links to WSO's free downloadable literature. (I'm happy to share that email for those who don't want to start from scratch.)

Another of our members contacted a local treatment center and with his sponsor (a GR), and District support, is now sending a weekly panel of 3-4 Al-Anons to introduce the program to patients' families AND a

monthly panel for the "adult" side. He's also working with one of our area's largest recovery homes to start a panel for their family members.

Another member (and our DAL) arranged to start an Alateen meeting at a local high school with District support for CAL as well. They are codifying that process so we can duplicate that effort on other local campuses. Our long standing Alateen meeting is also back and thriving. It is timed with an Al-Anon meeting which provides free babysitting for those 6 and under.

At our March district meeting we did a KBDM on our donations to the Area, and we voted to support our Area with donations timed to Committee meetings and Assemblies. (I can also share that document.)

At our May meeting we considered a proposal from two of our GRs asking our District to provide "seed" literature to new meetings and new members of existing meetings. (The most likely piece is B-32 How Al-Anon Works.) After some discussion, they decided to work on the proposal some more and re-present in July.

Not everything is smooth surfing though. After 4 months in this position, I learned that our District has been left out of many official area-wide mailings. I only learned this because I happened to run into our Area Chair, Micheila, at AFG and I asked when we'd be getting the emails for the Assembly. She graciously took the time to look at my email history and found - in fact - my District email had been missed. (Since then I have learned at least half of my GRs were also missed.) Our Chair is working to resolve that glitch with the appropriate volunteers. However, without that notice, no one in our district knew when to stand for any open board positions or received the appropriate assembly links. But I must remember – that even in this – God has a plan and it's not personal. I trust our Area board (trusted servants) will sort out the glitches and work toward a solution in good faith. In the meantime, I received the essential emails from our Chair directly and distributed them to our District GRs so we had time to at least review by-laws and resumes prior to the assembly.

In the meantime, we now know to be more proactive in surfing the SCWS site and keep swimming the Waves of Gratitude for our District GRs and all trusted servants who carry Al-Anon's message of help and hope for those who suffer in and out of our lovely program.
